FIG. 4 is right side elevation view thereof;

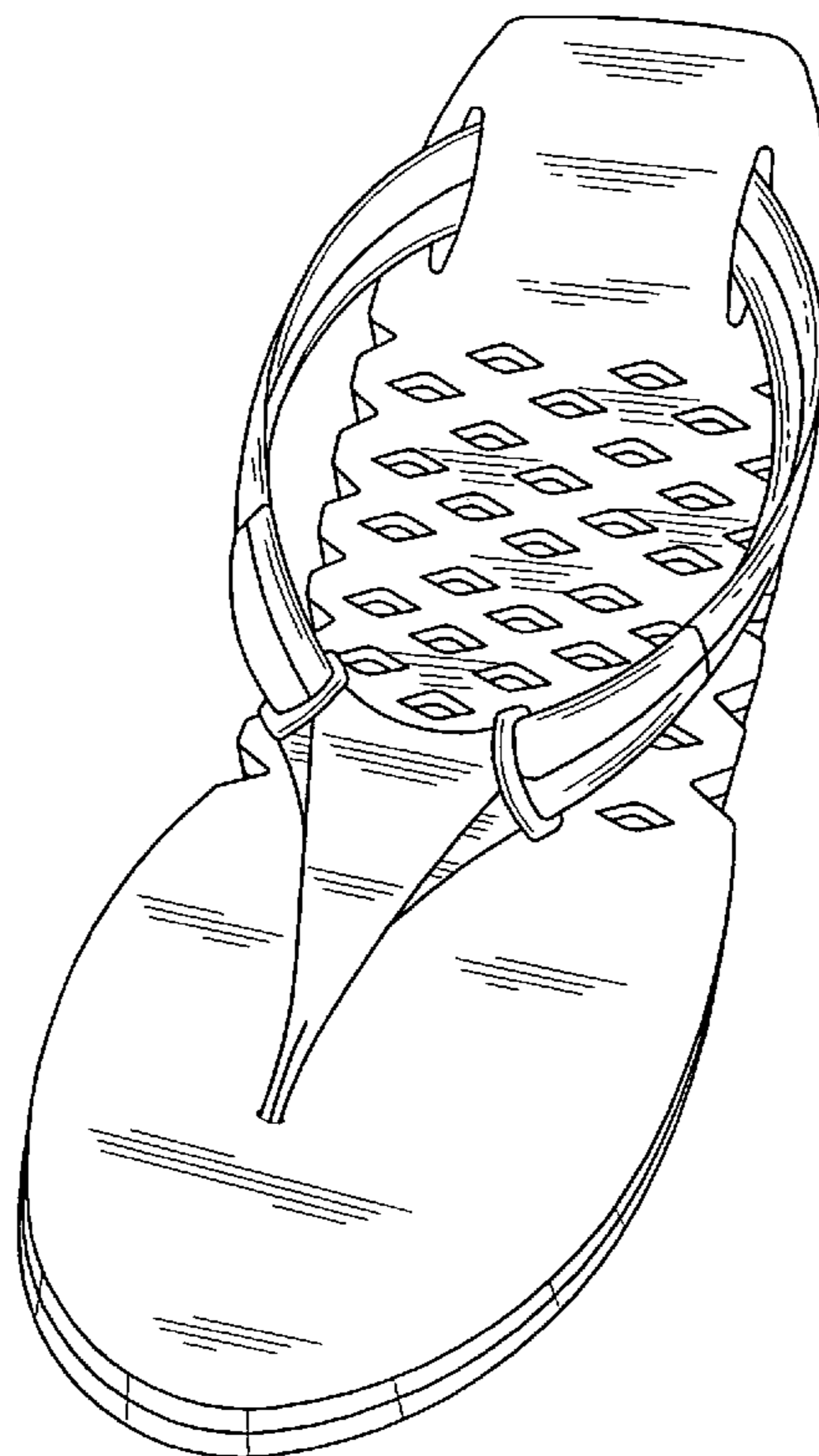
FIG. 5 is a left side elevation thereof;

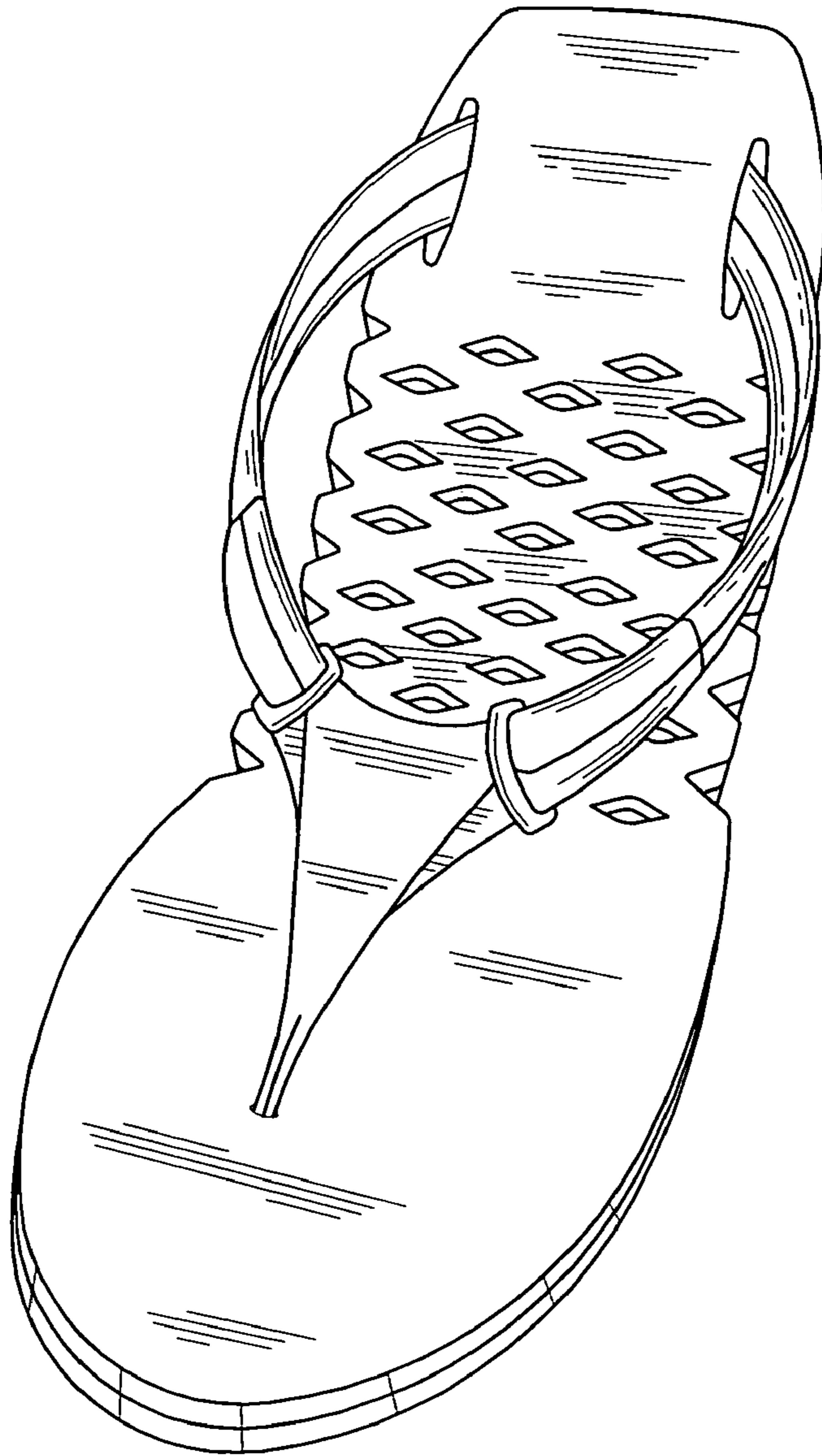

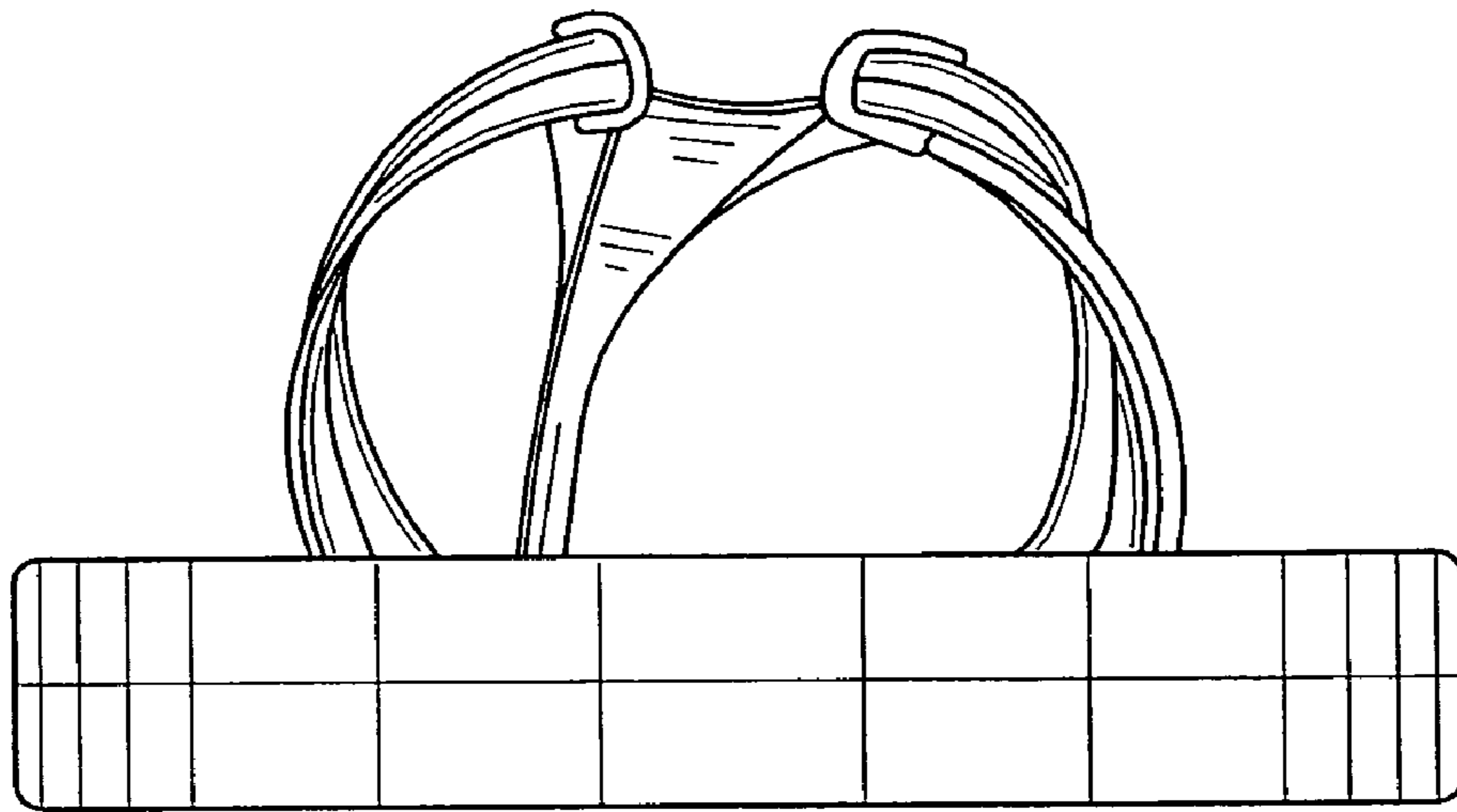

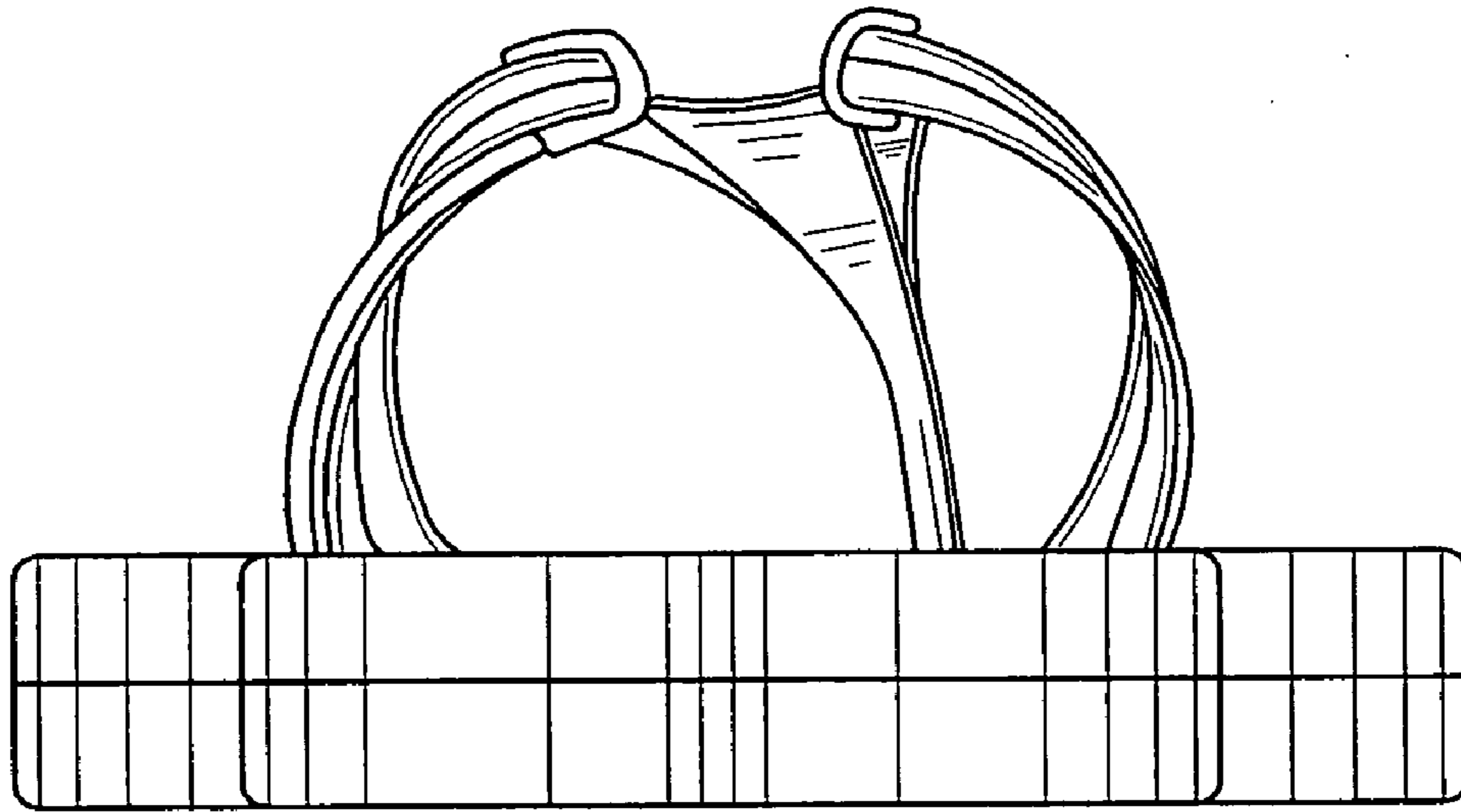

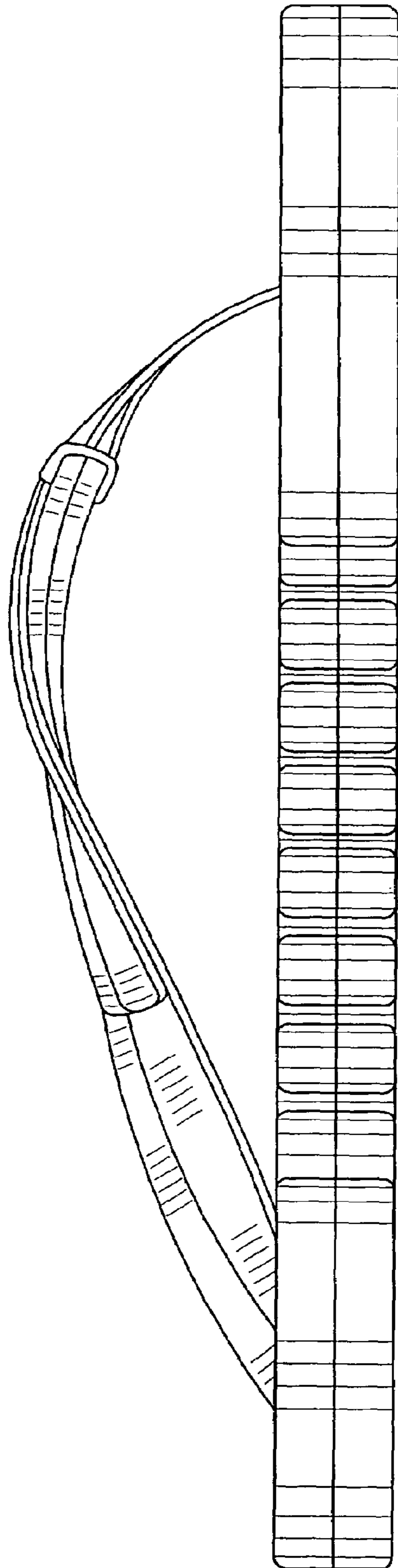

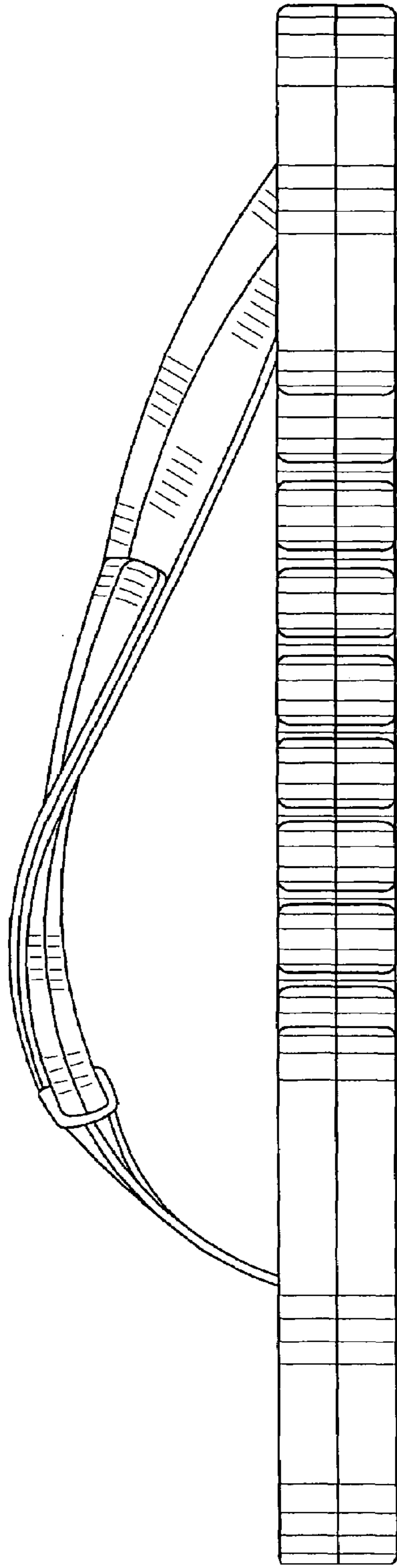

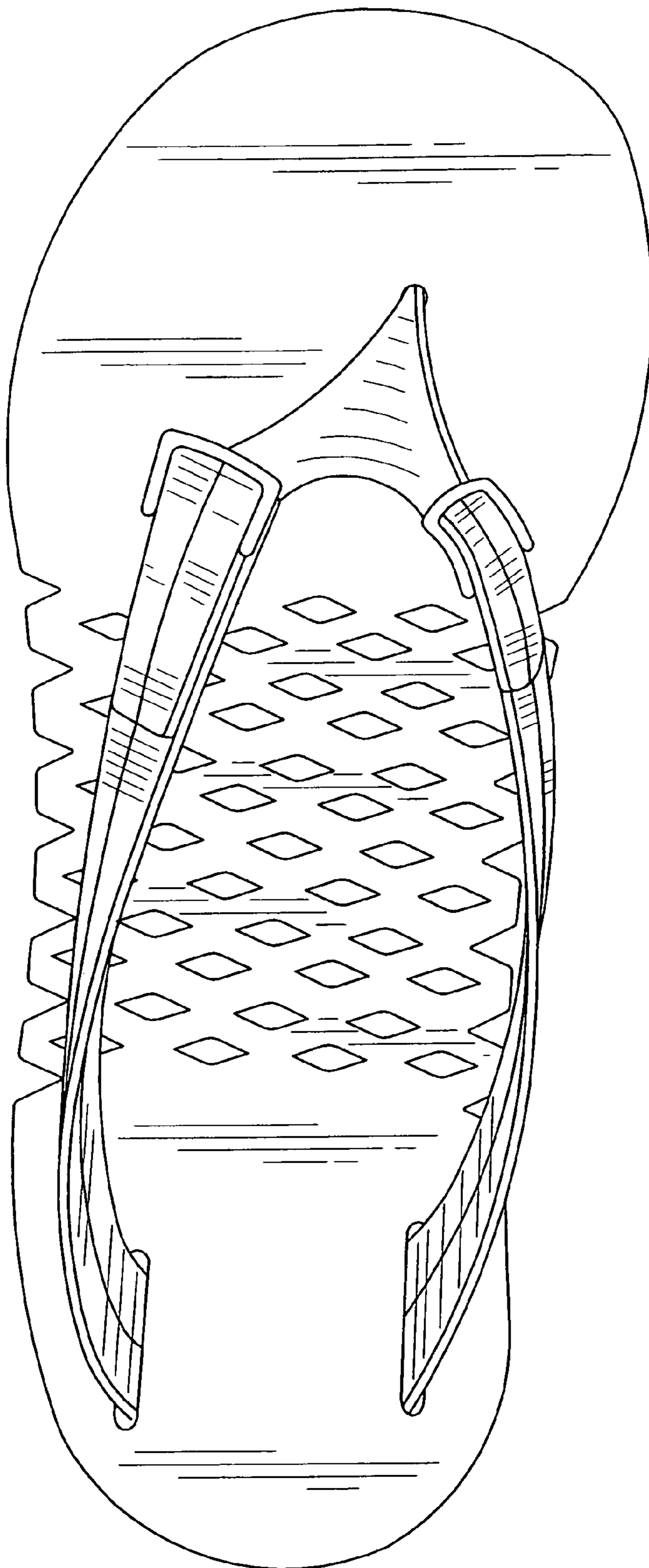

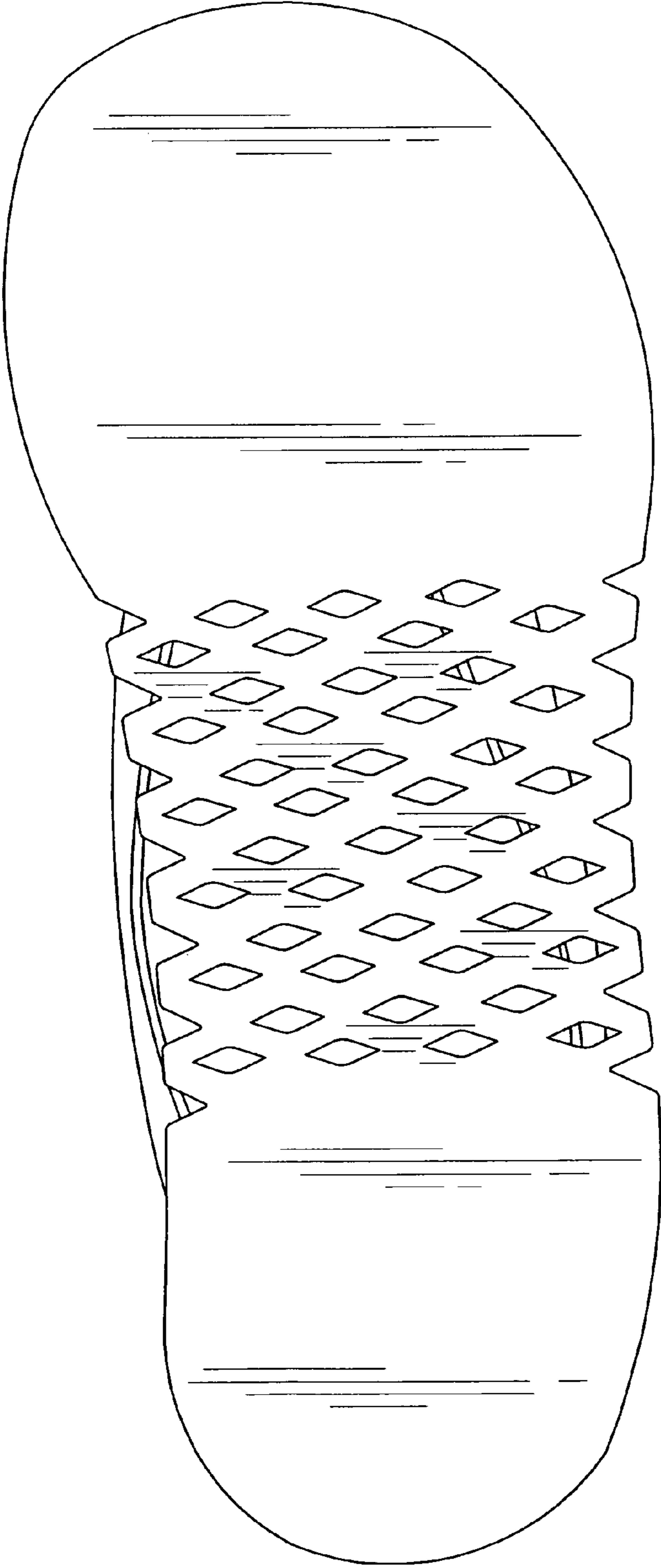

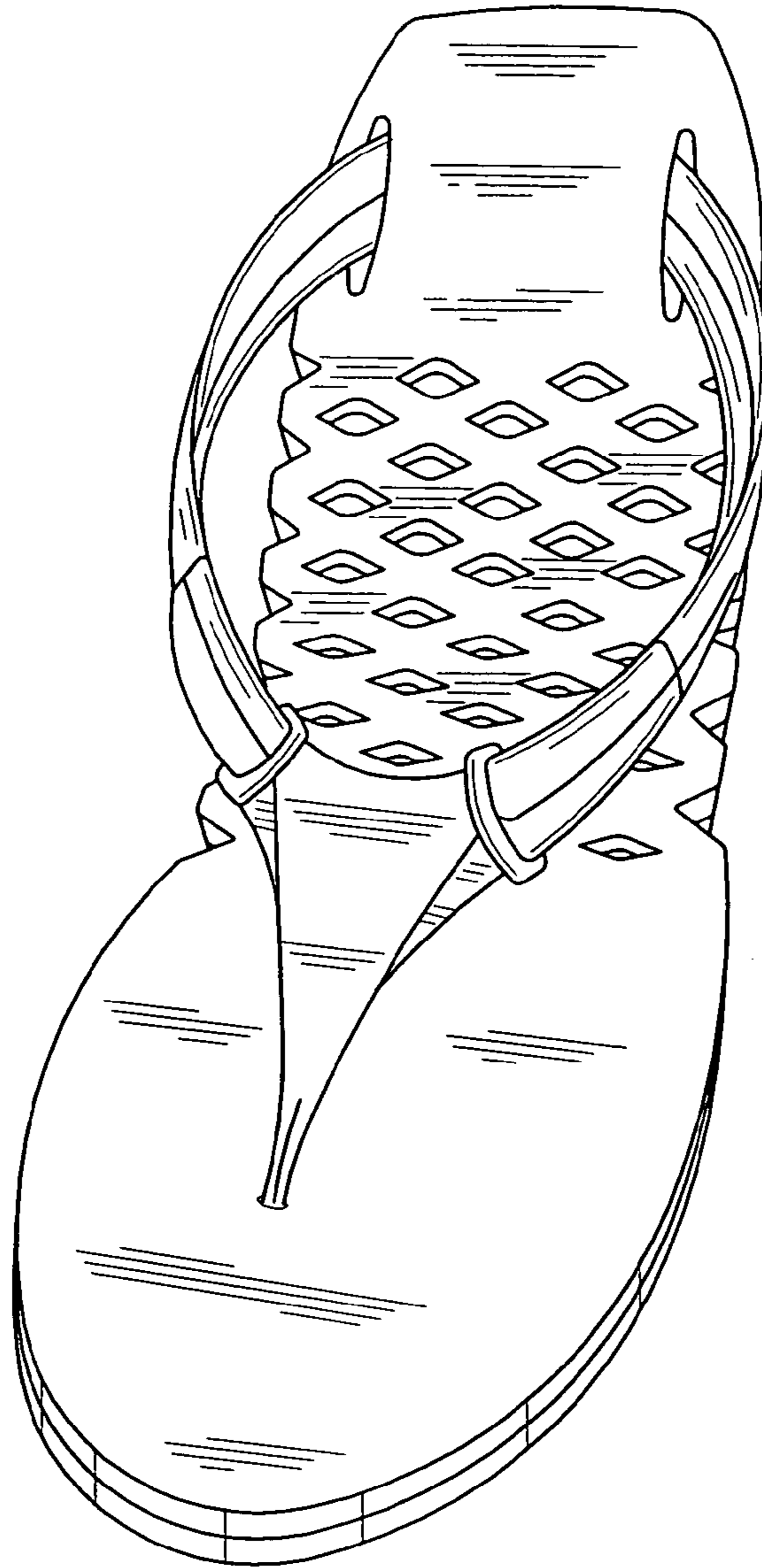
