The ornamental design for heel for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a heel showing my heel design;

FIG. 2 is a left side view of the heel shown in FIG. 1;

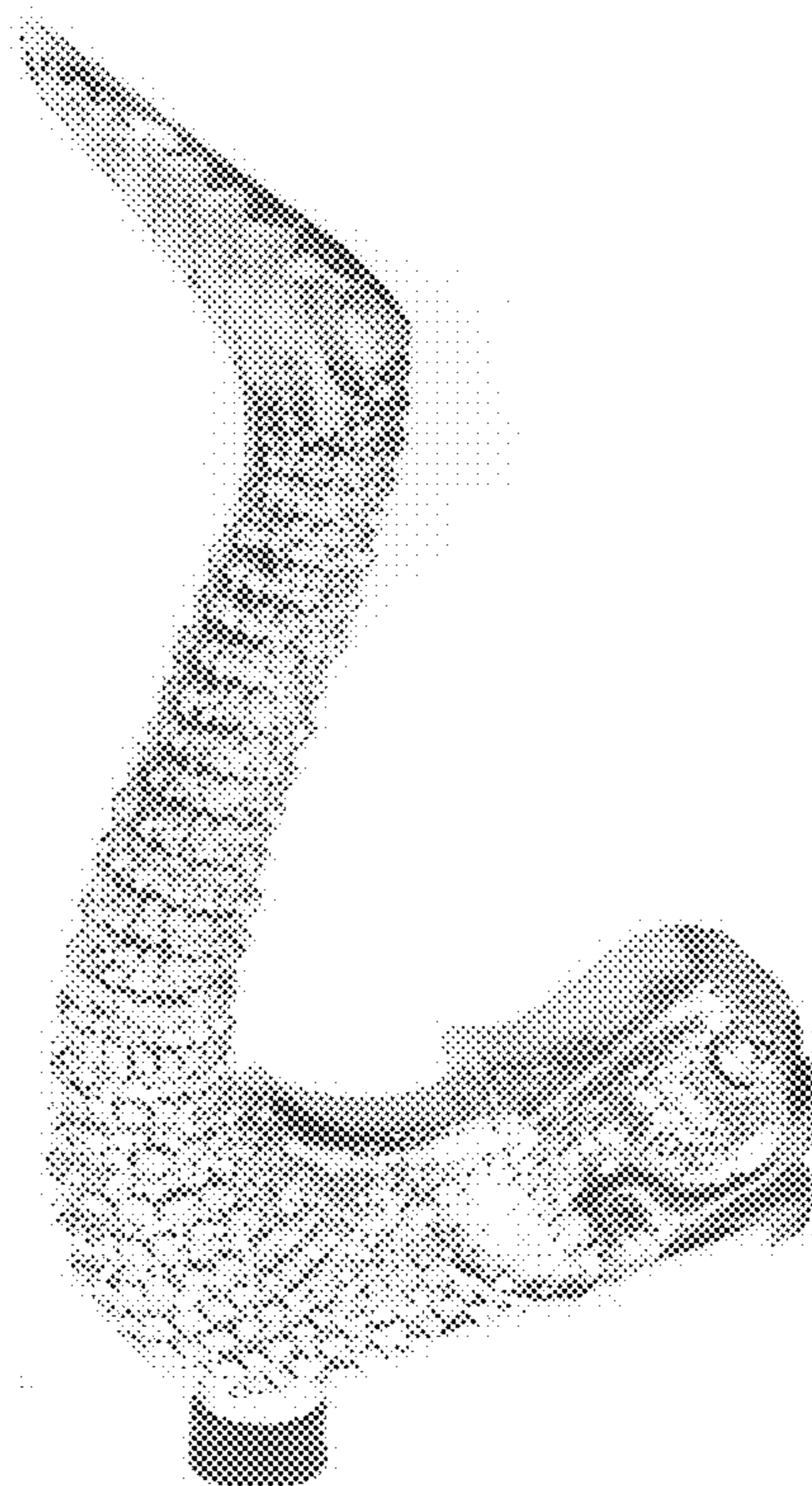
FIG. 3 is a right side view of the heel shown in FIG. 1;

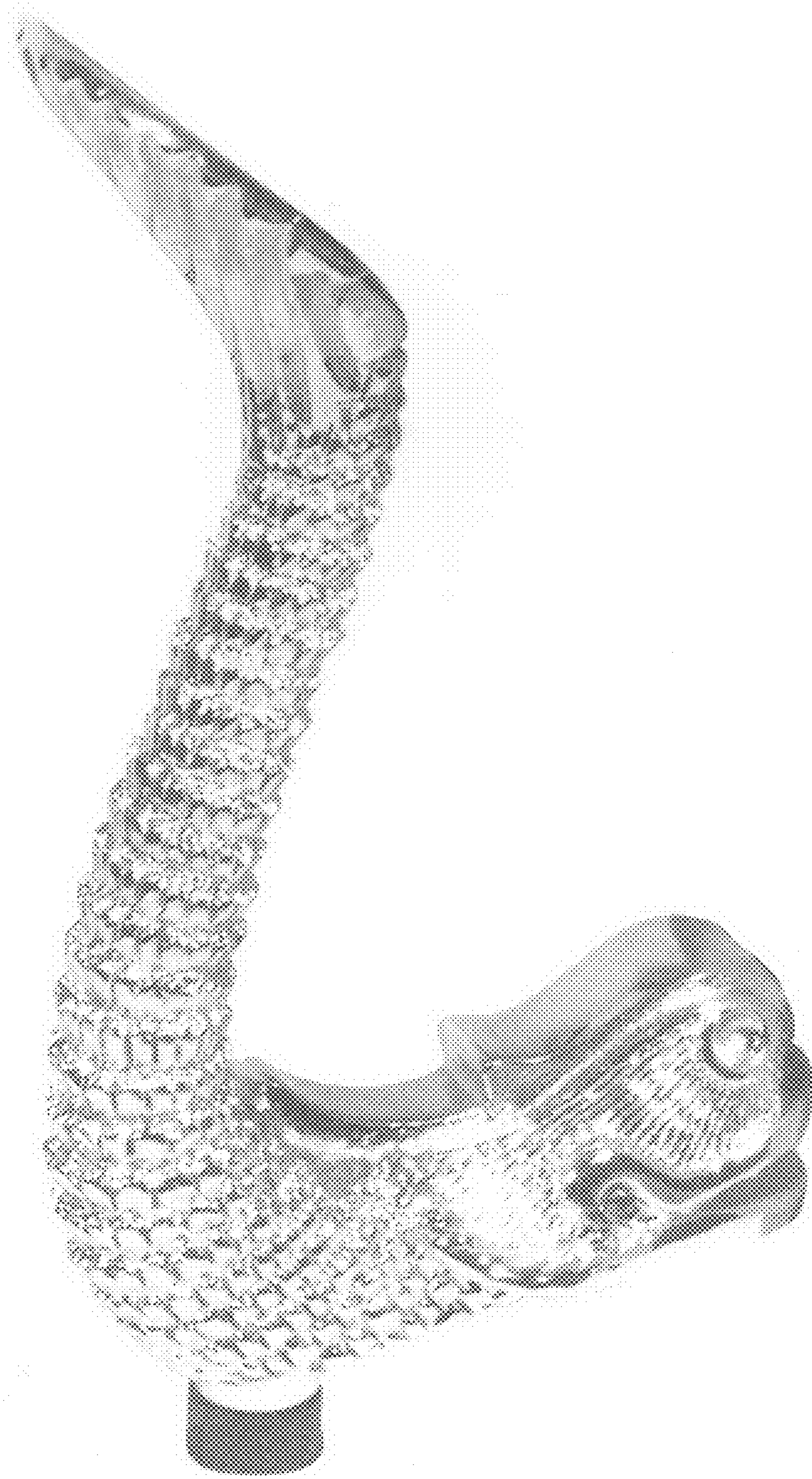

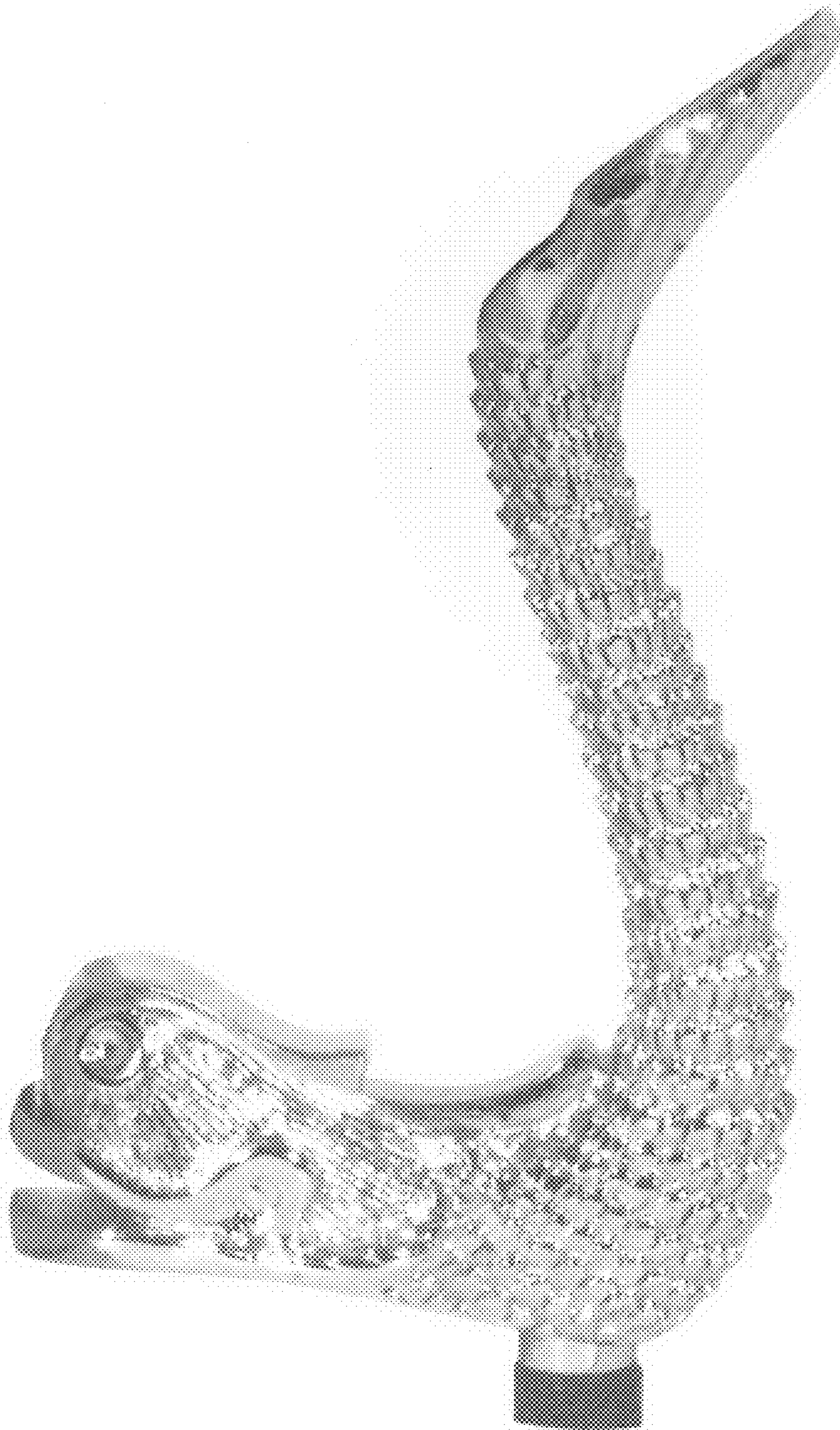

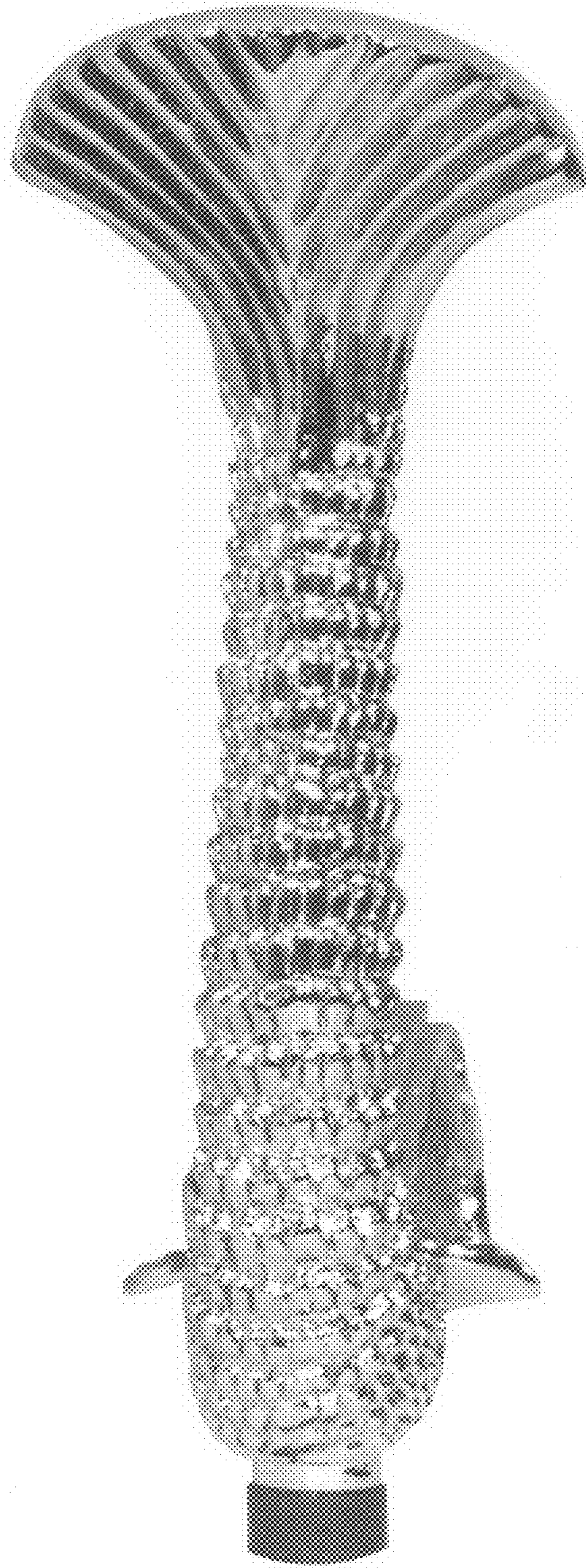

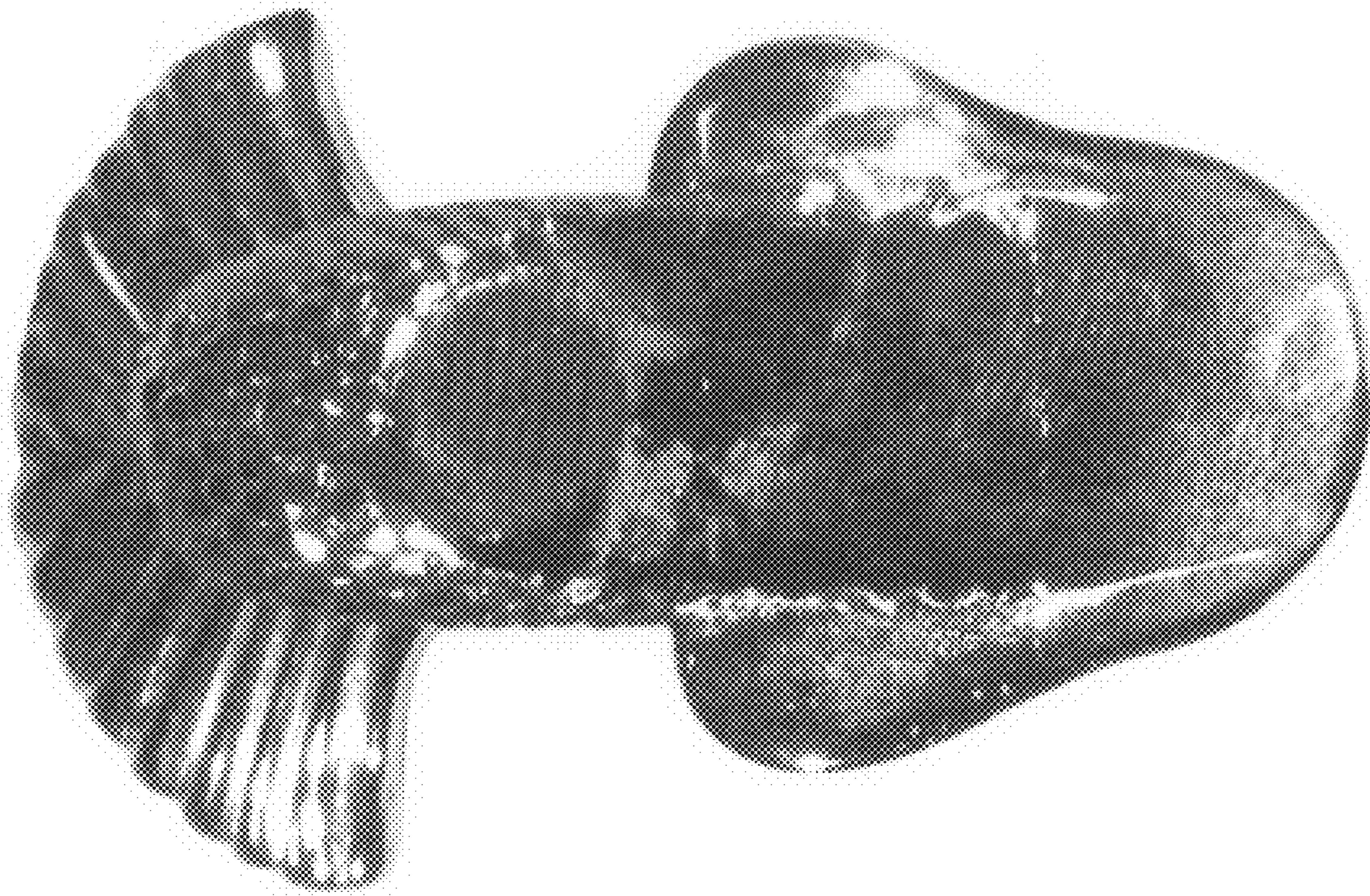
