FIG. 3 is back view of the lunch bag.

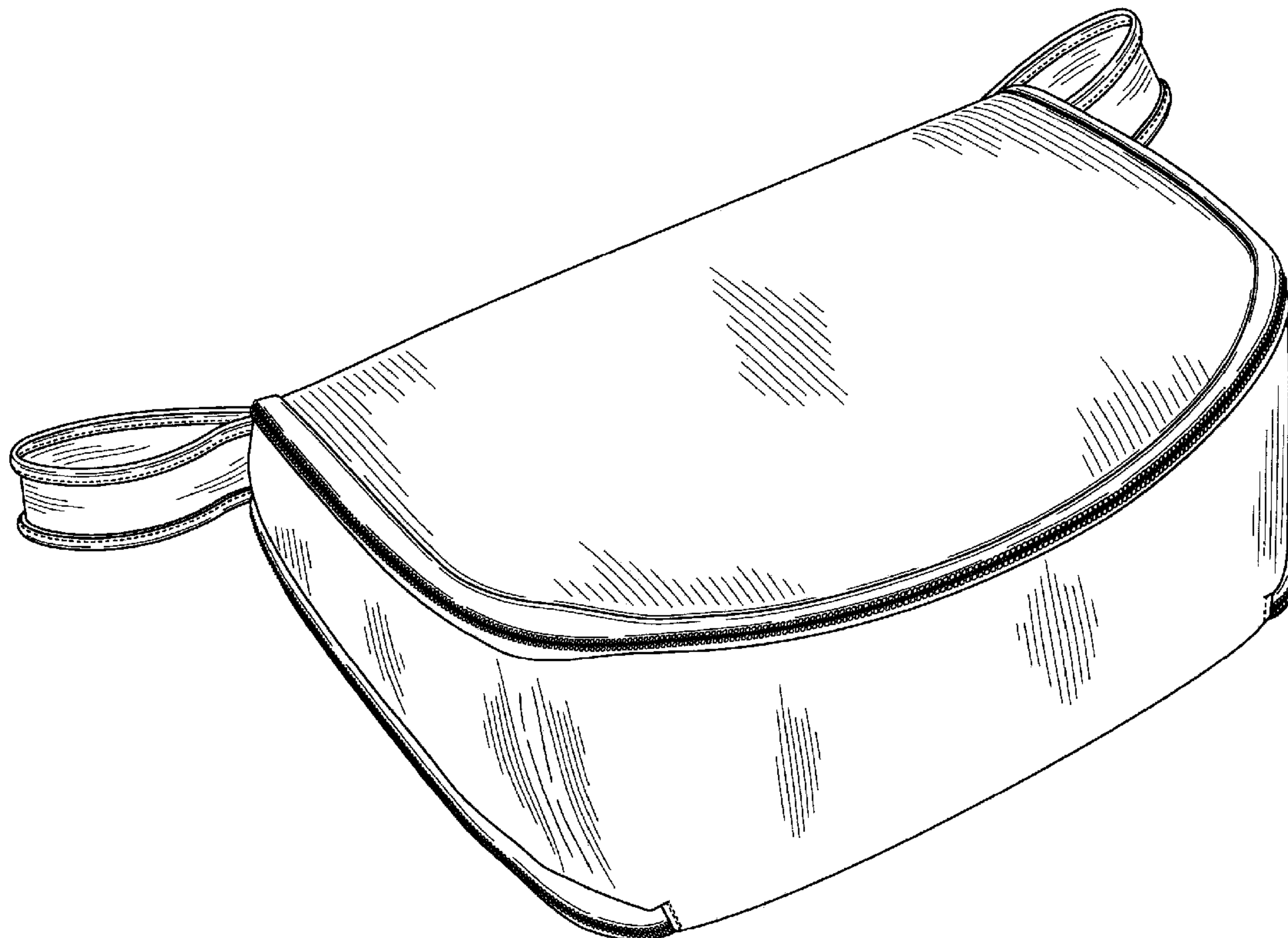
FIG. 4 a left view of the lunch bag.

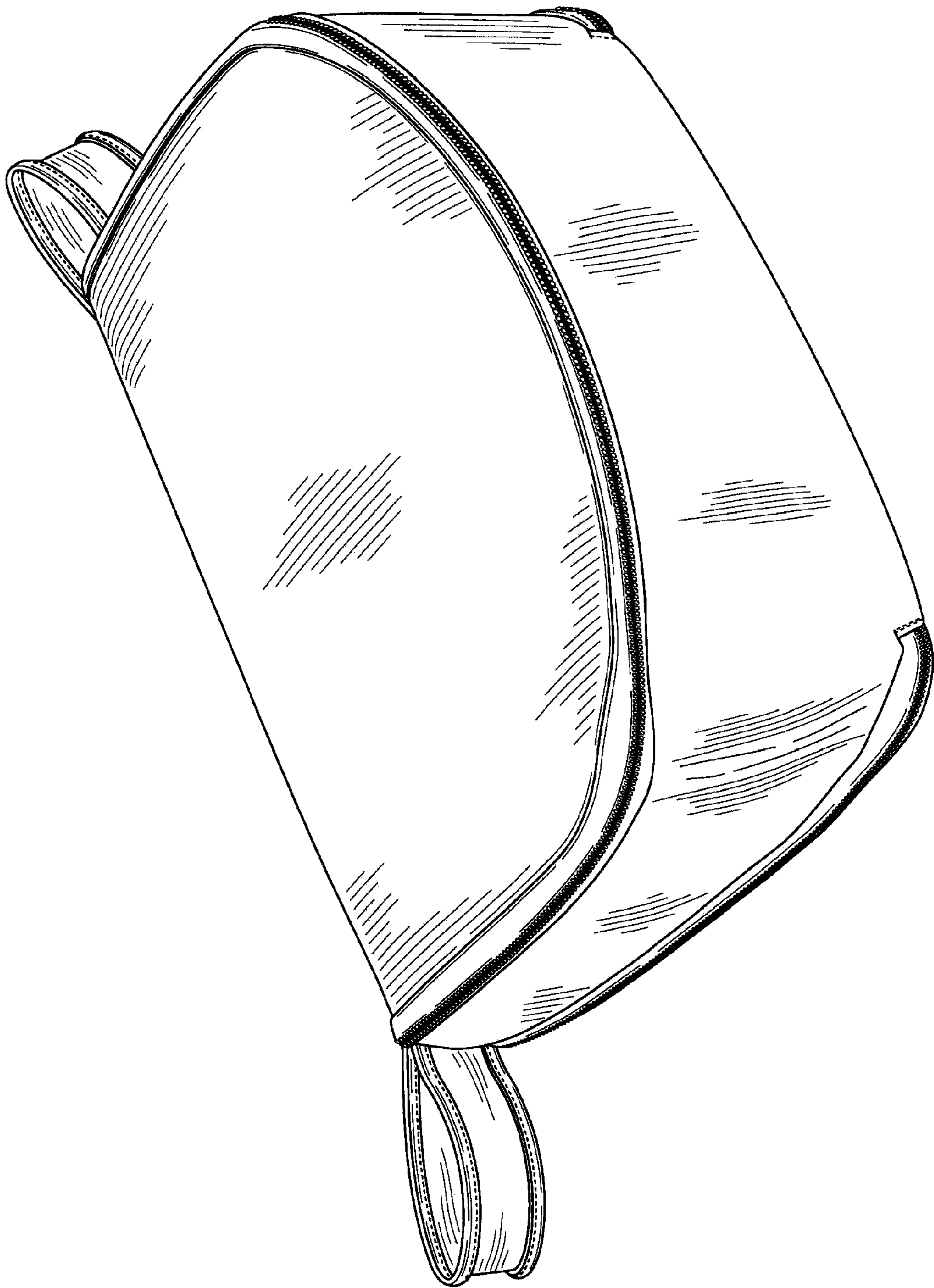

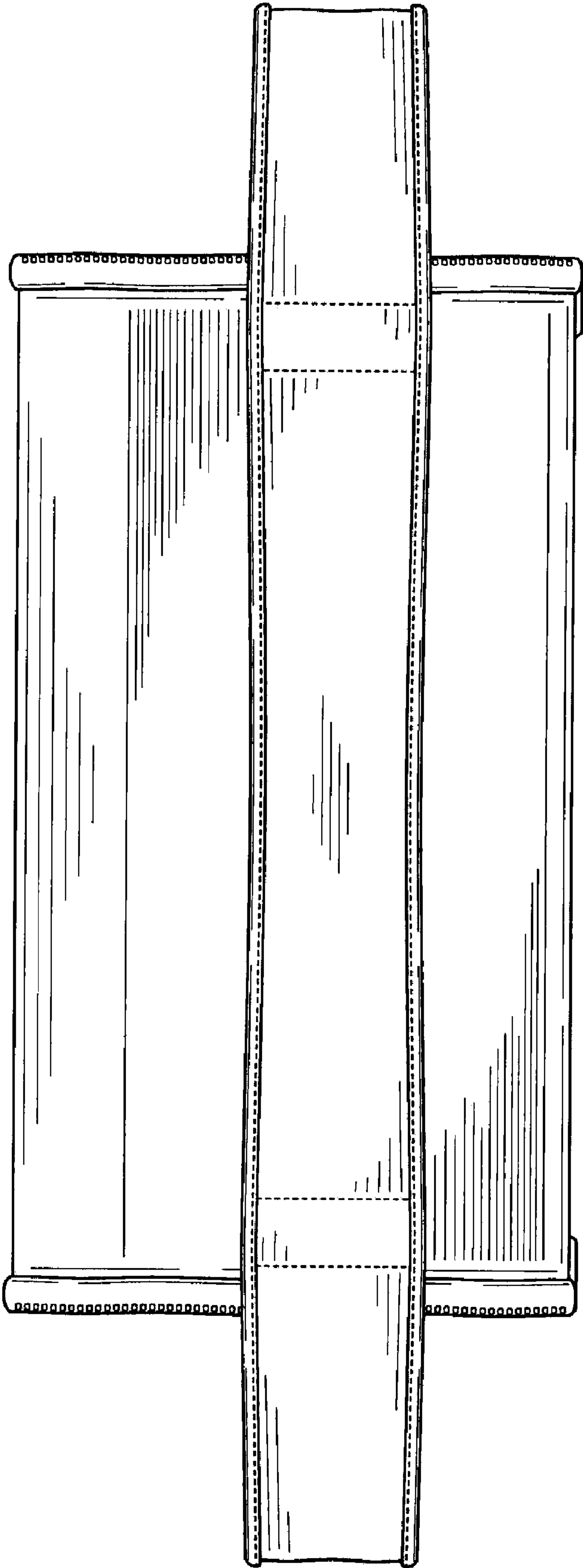

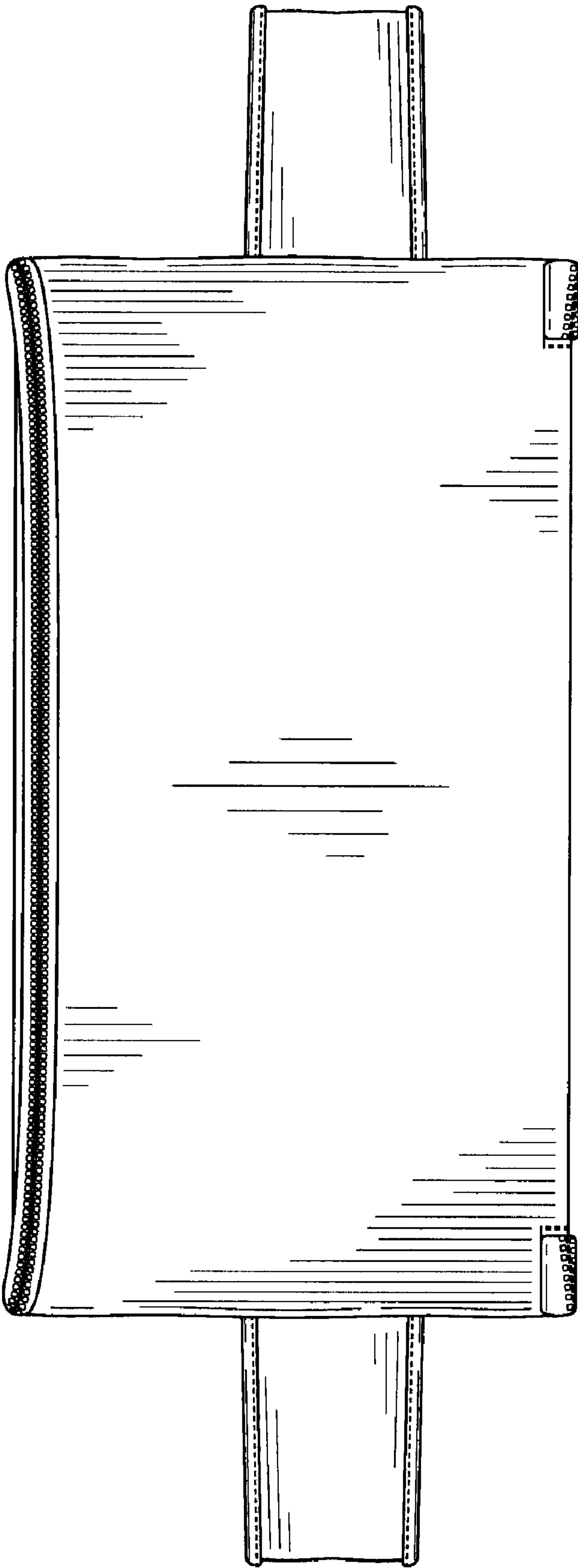

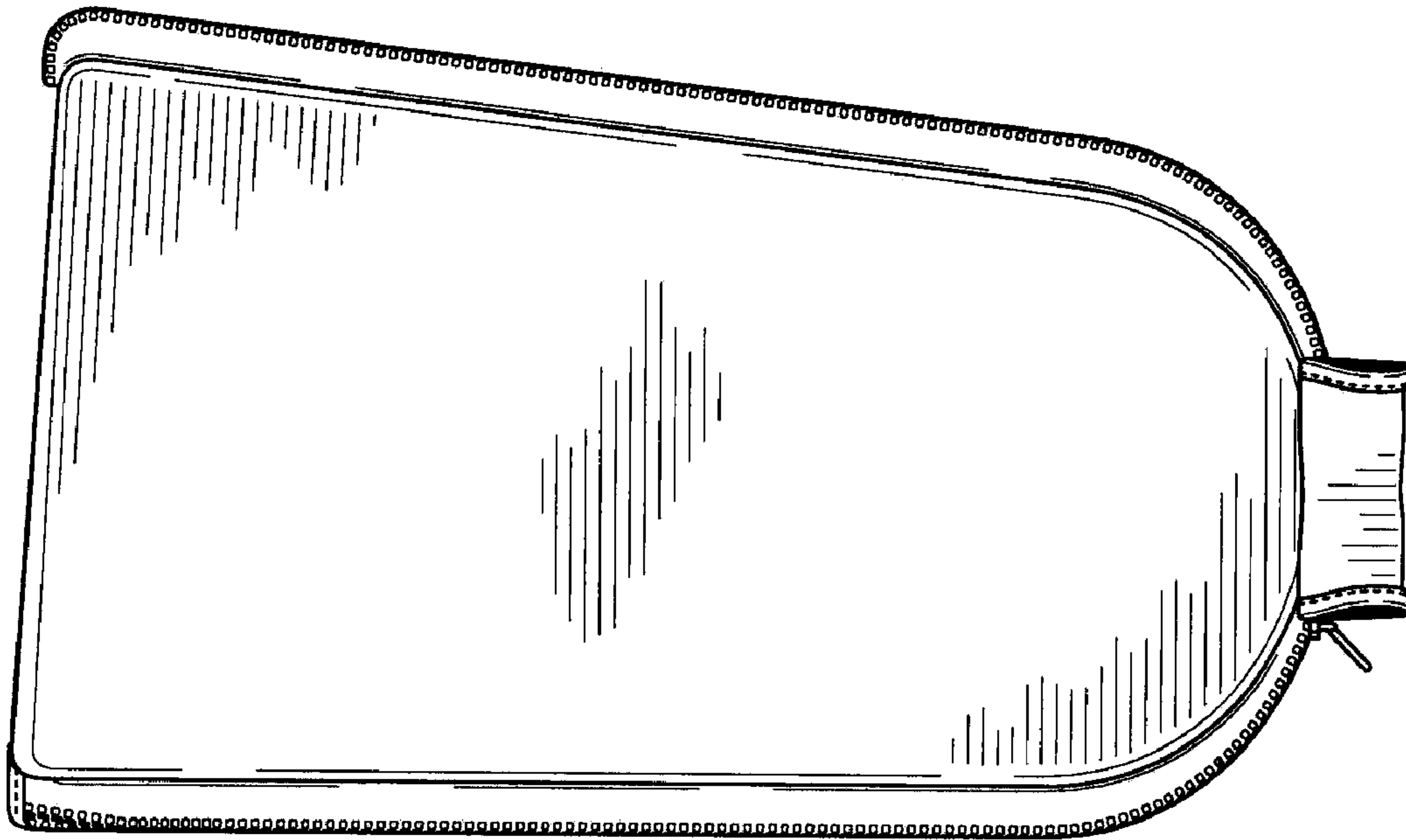

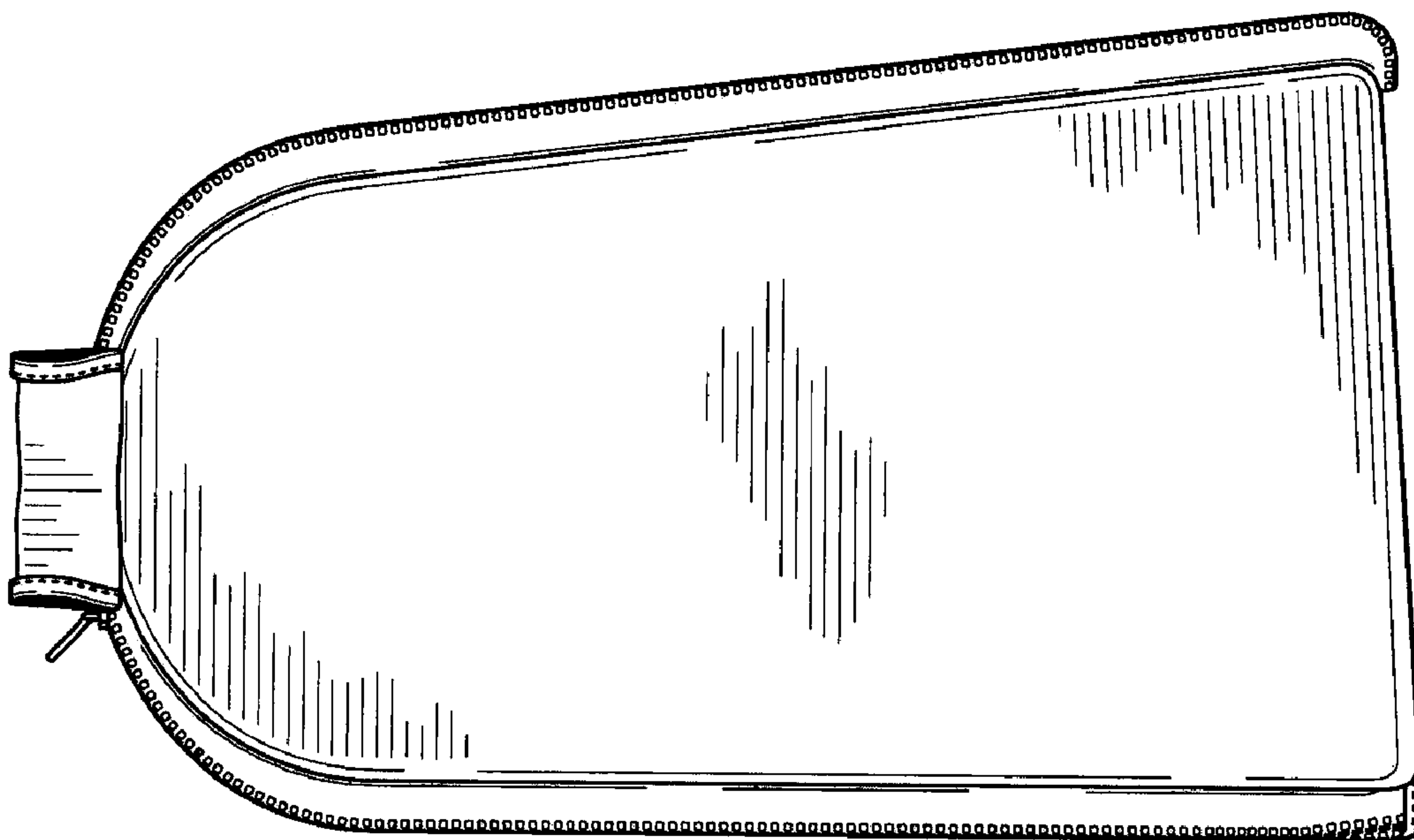

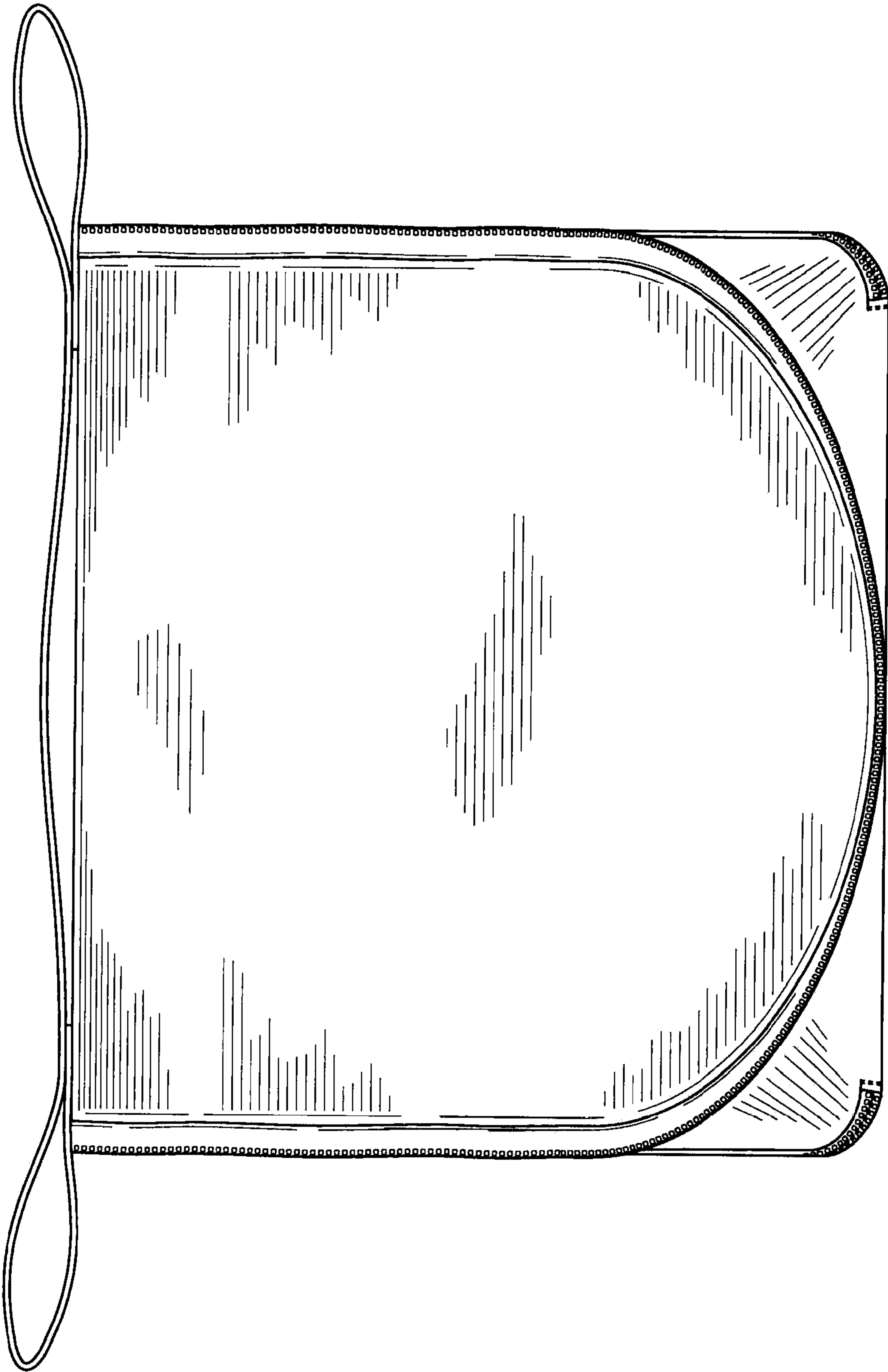

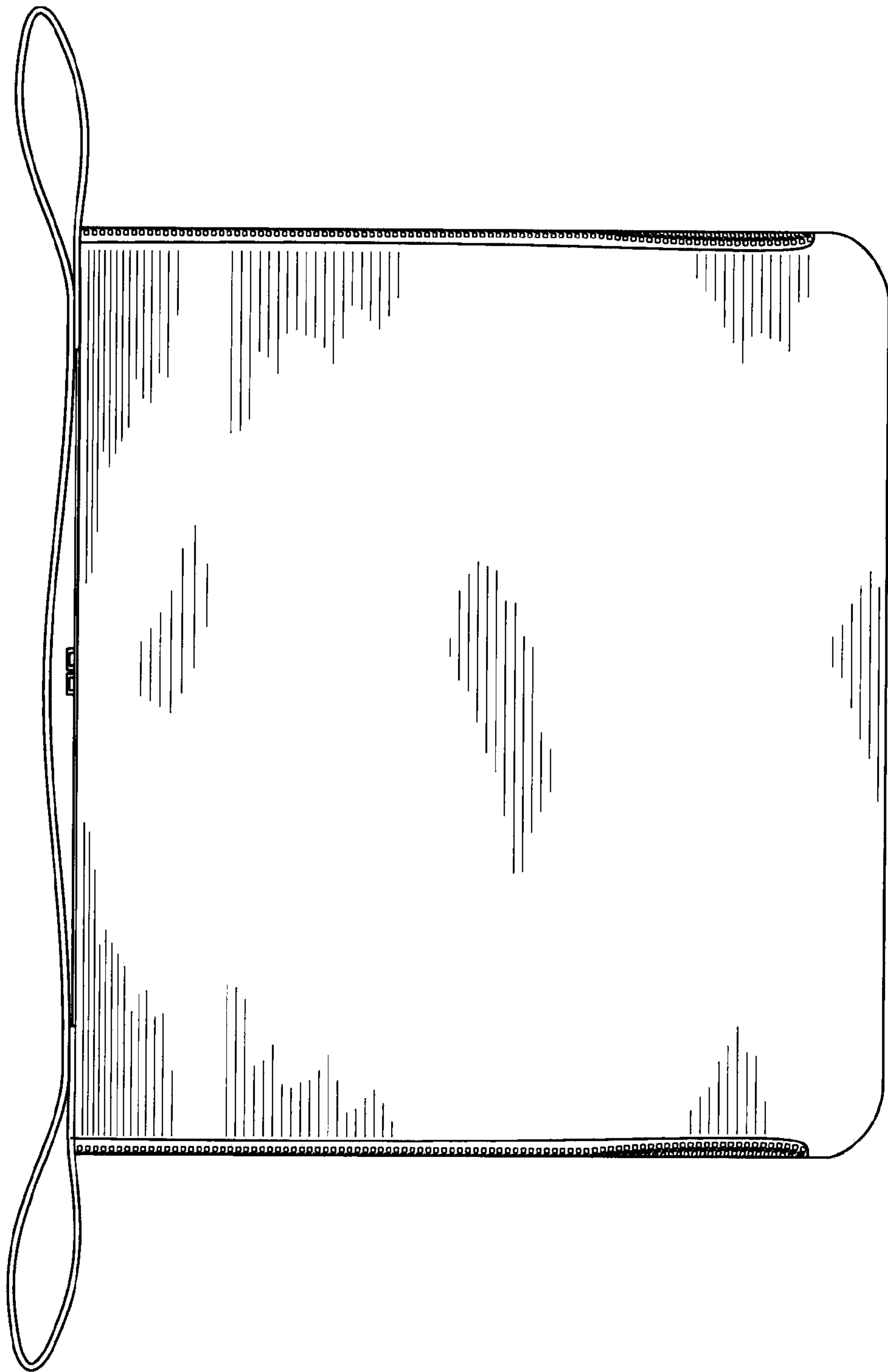
