The ornamental design for a tape tool, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a tape tool, showing my new design;

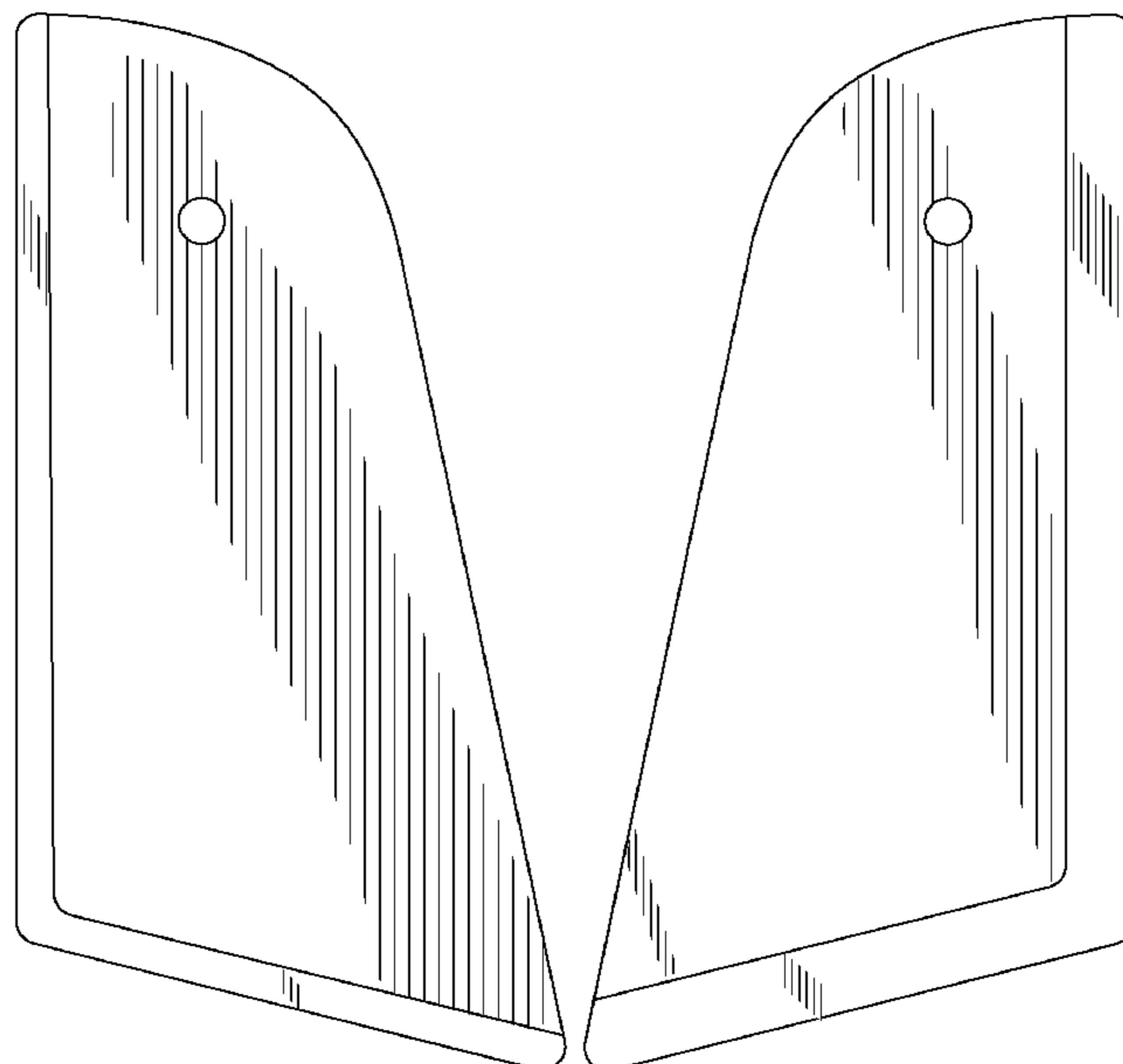

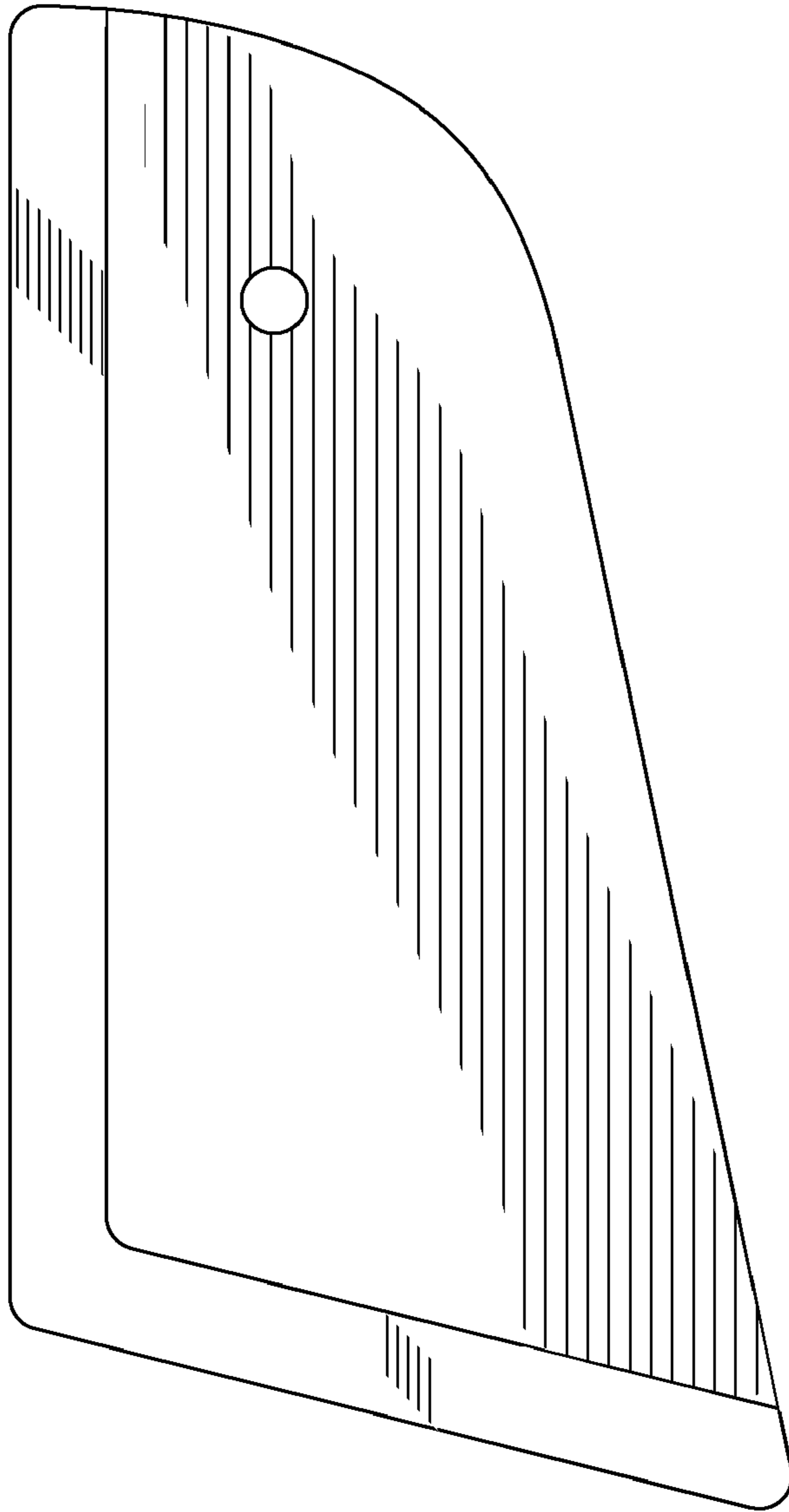

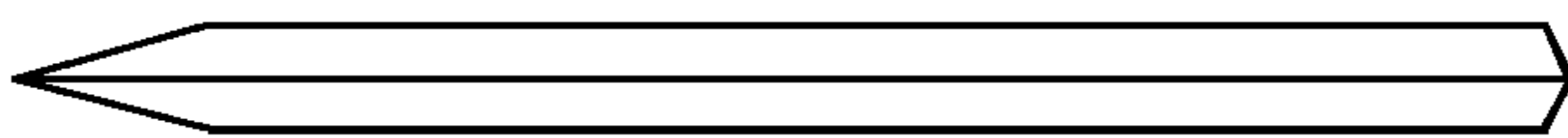

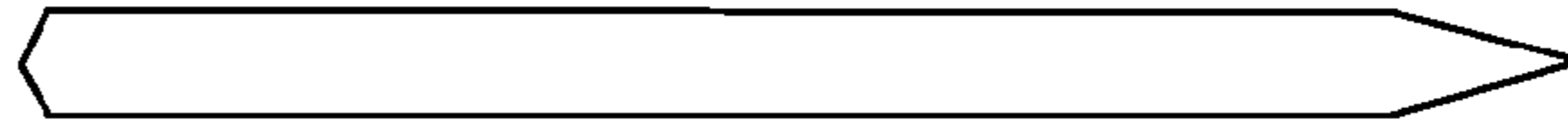

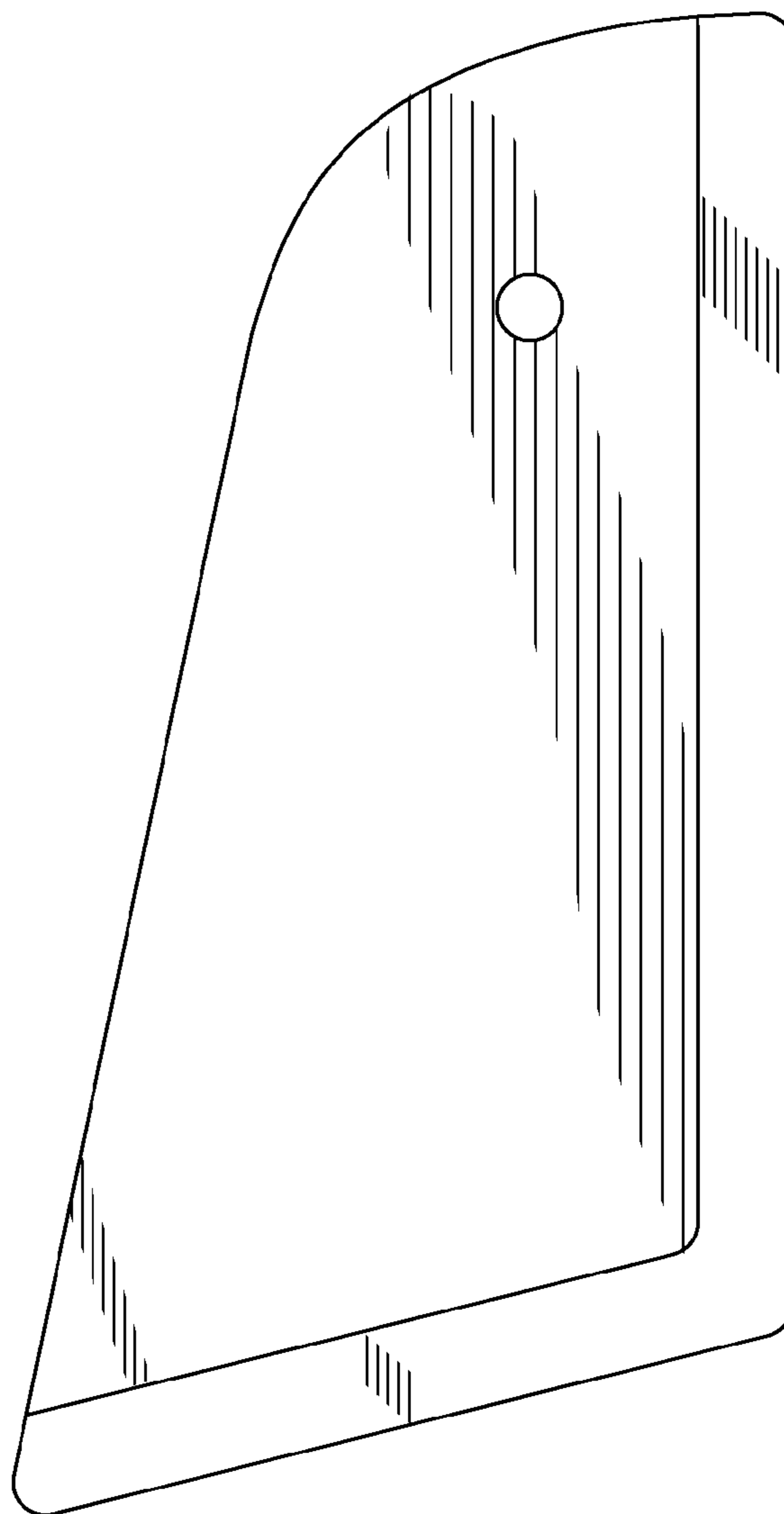

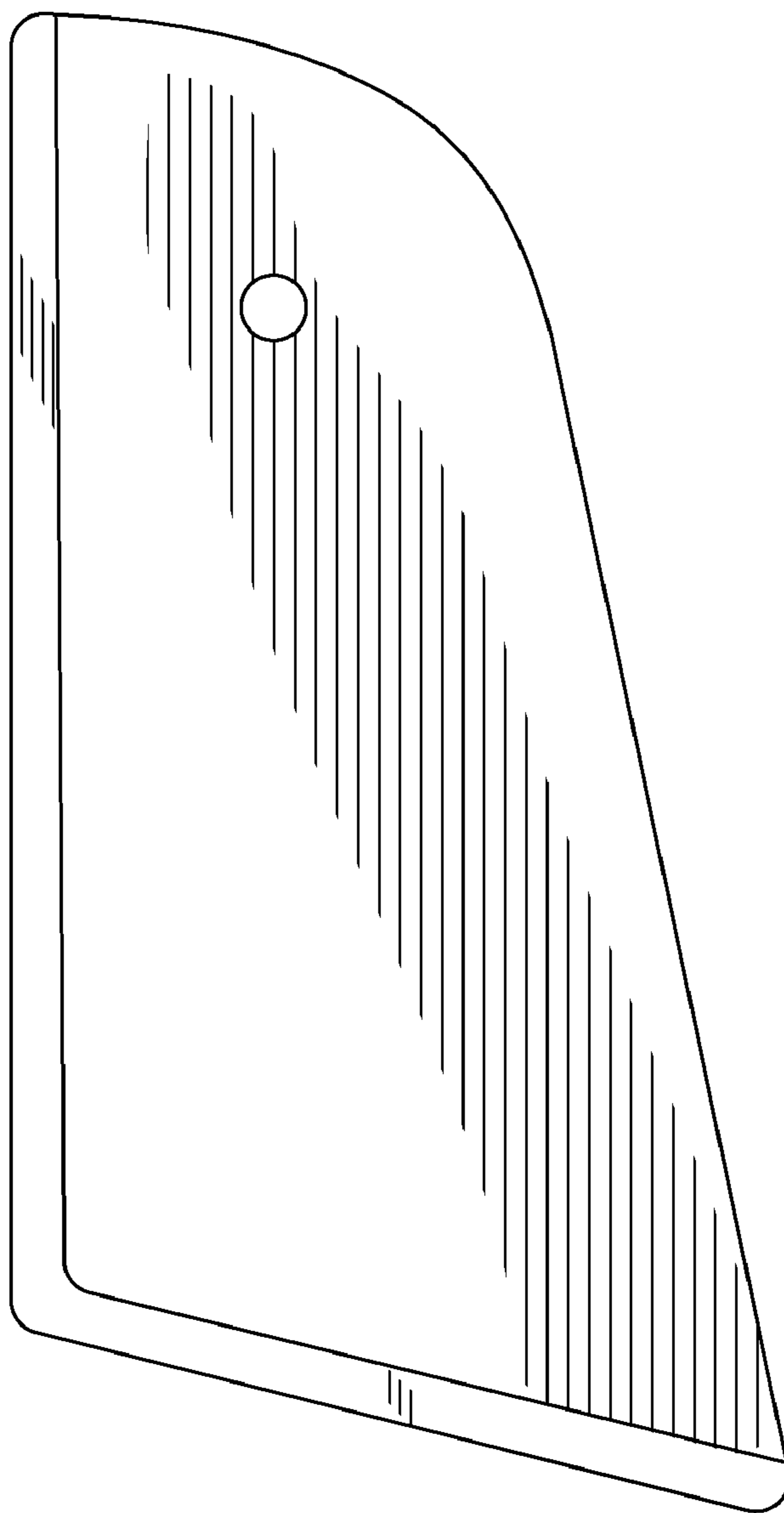

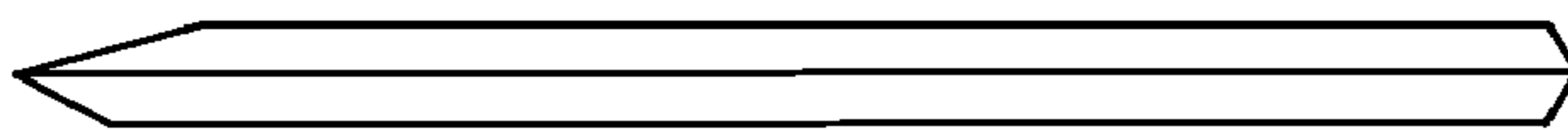

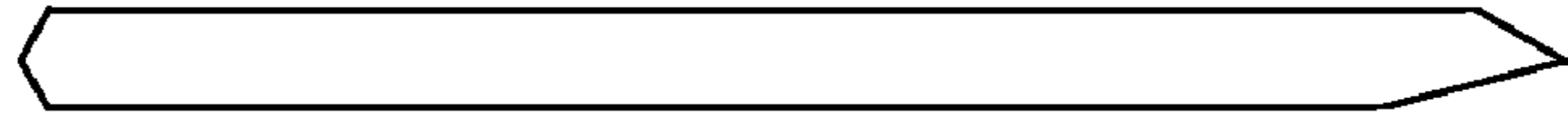

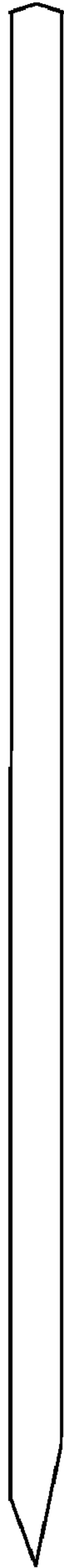

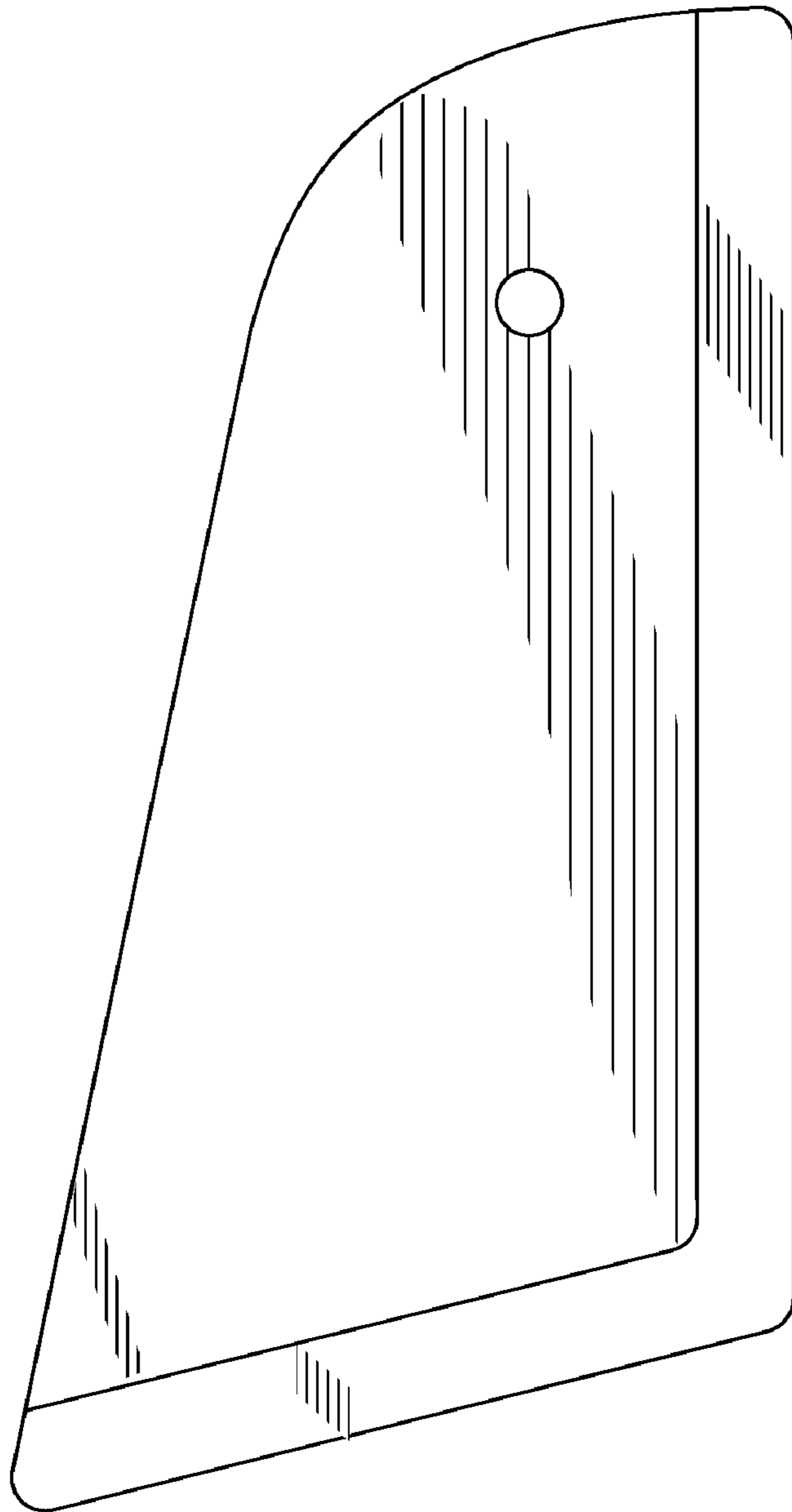

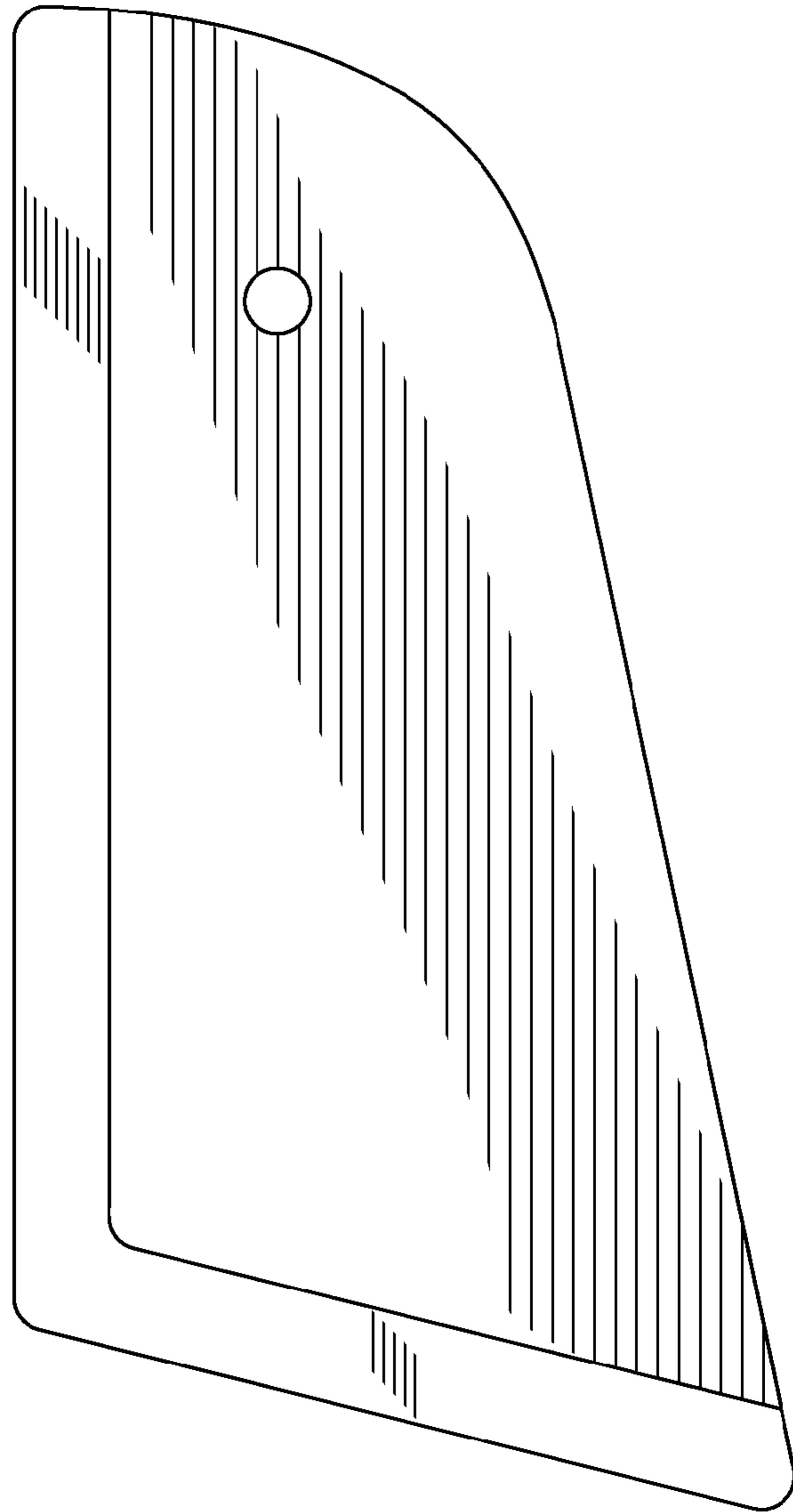

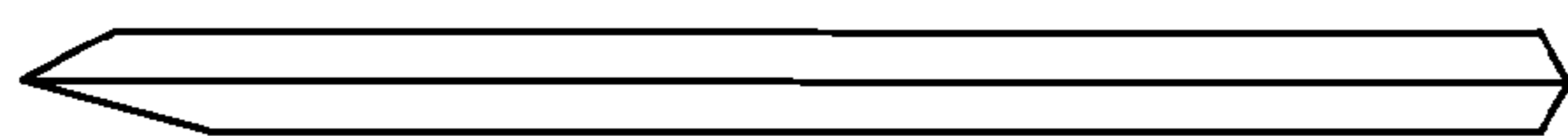

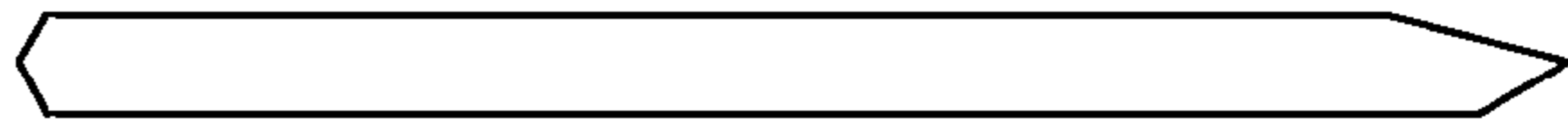

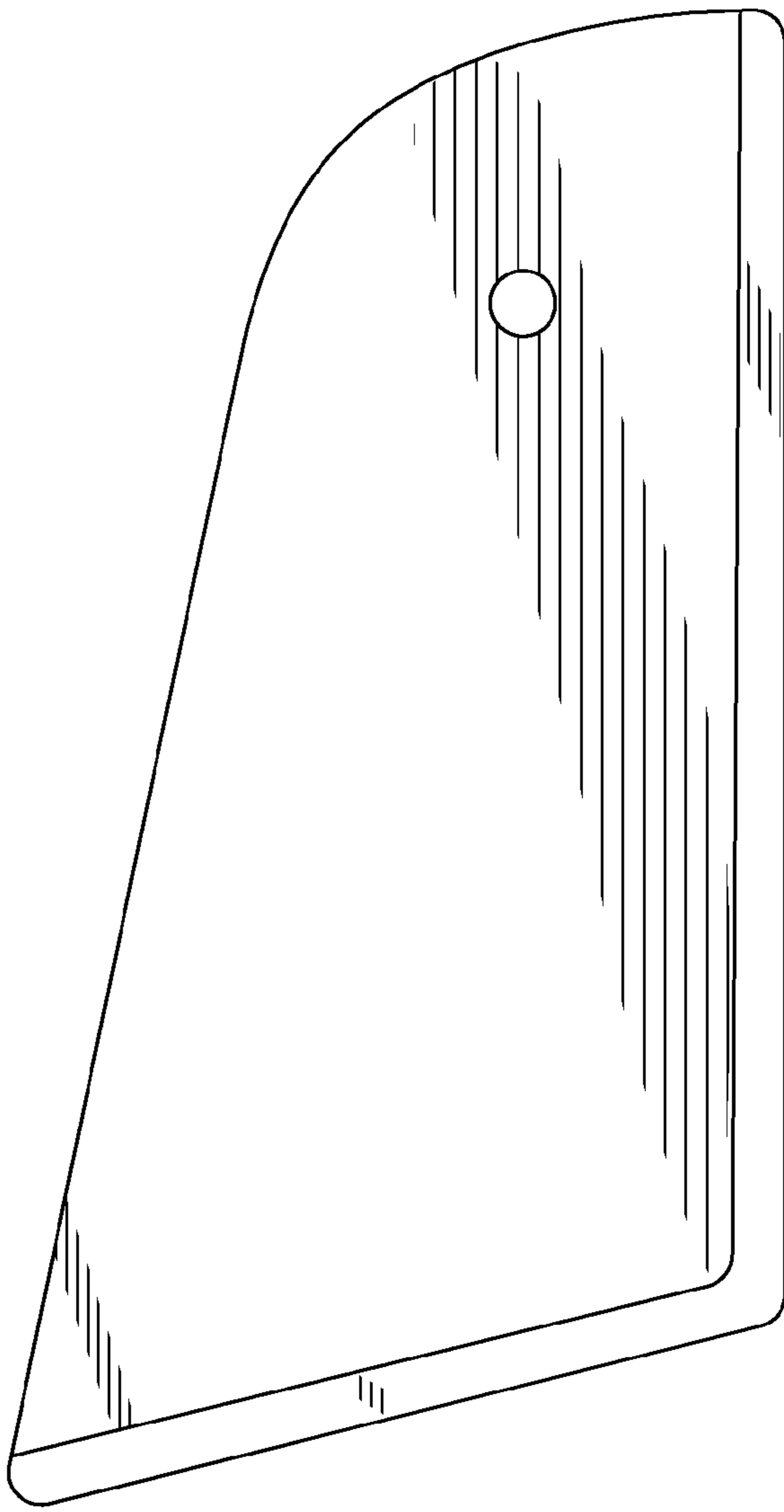
