The ornamental design for a razor storage case, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view as seen from the top, front, and right side of a razor storage case showing our design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

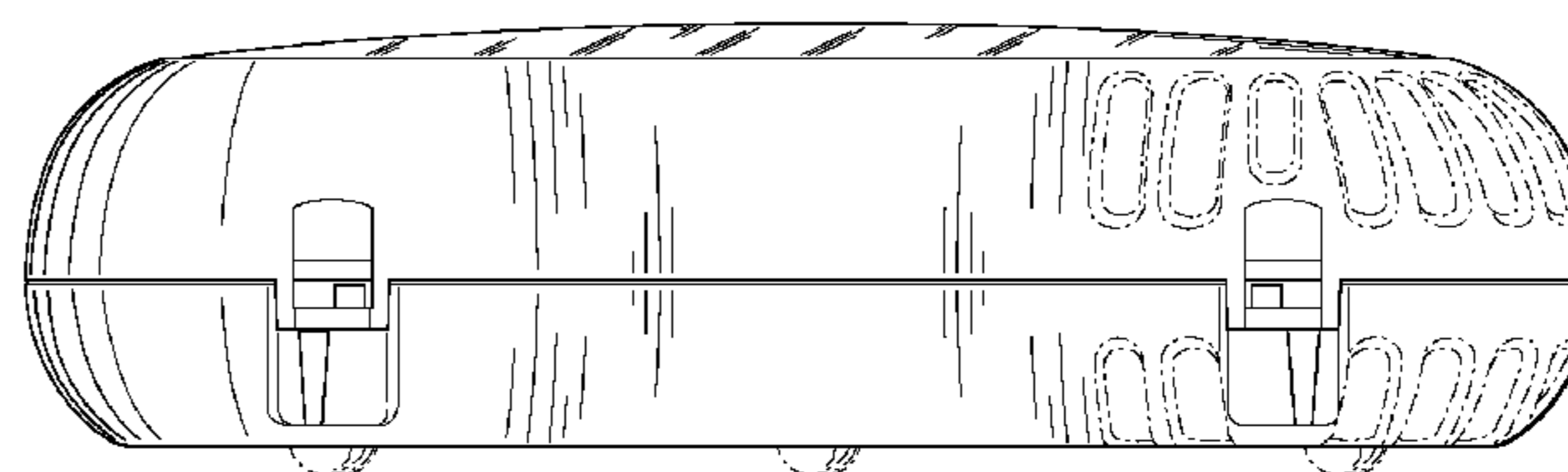
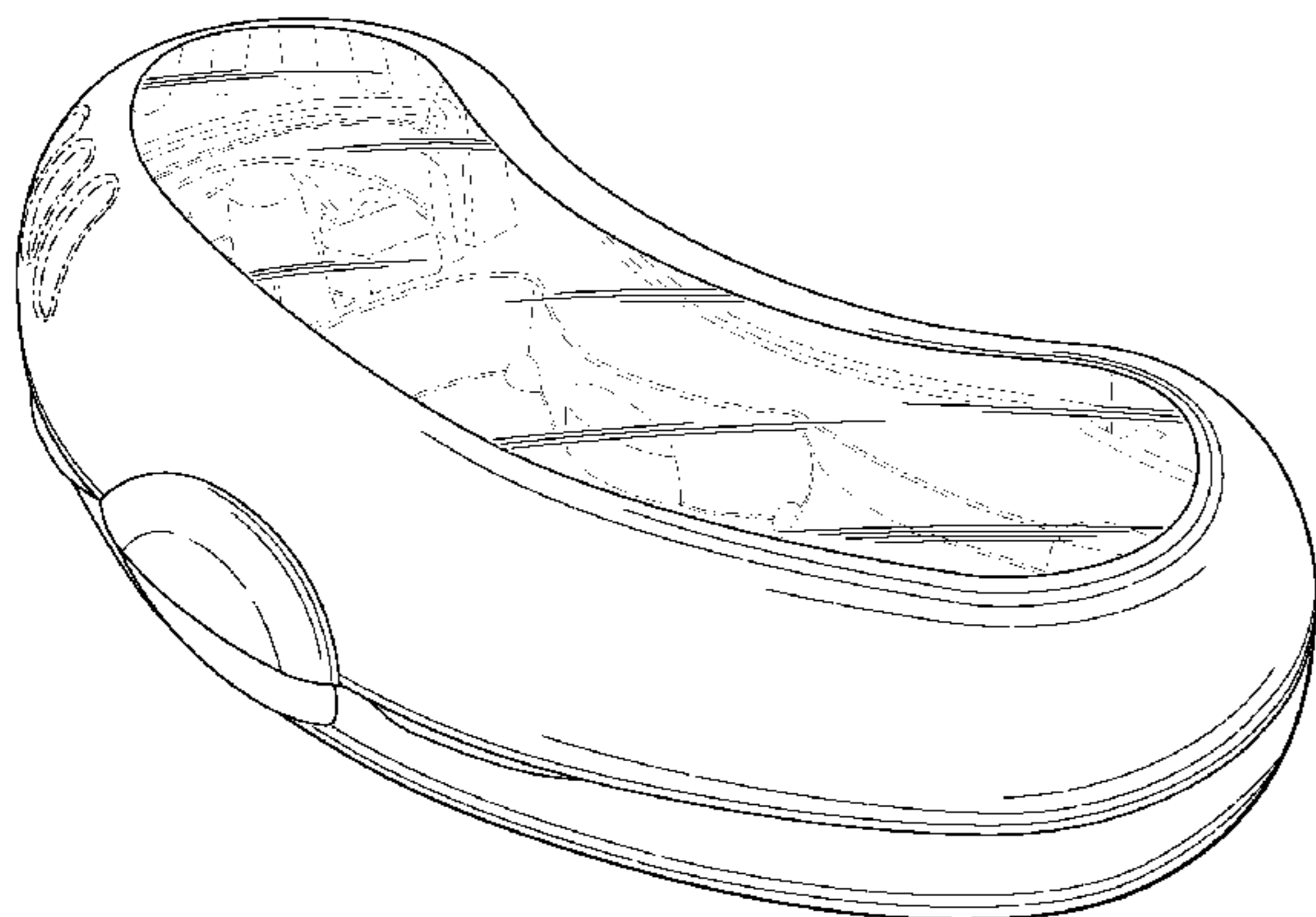
FIG. 6 is a right elevational view thereof;

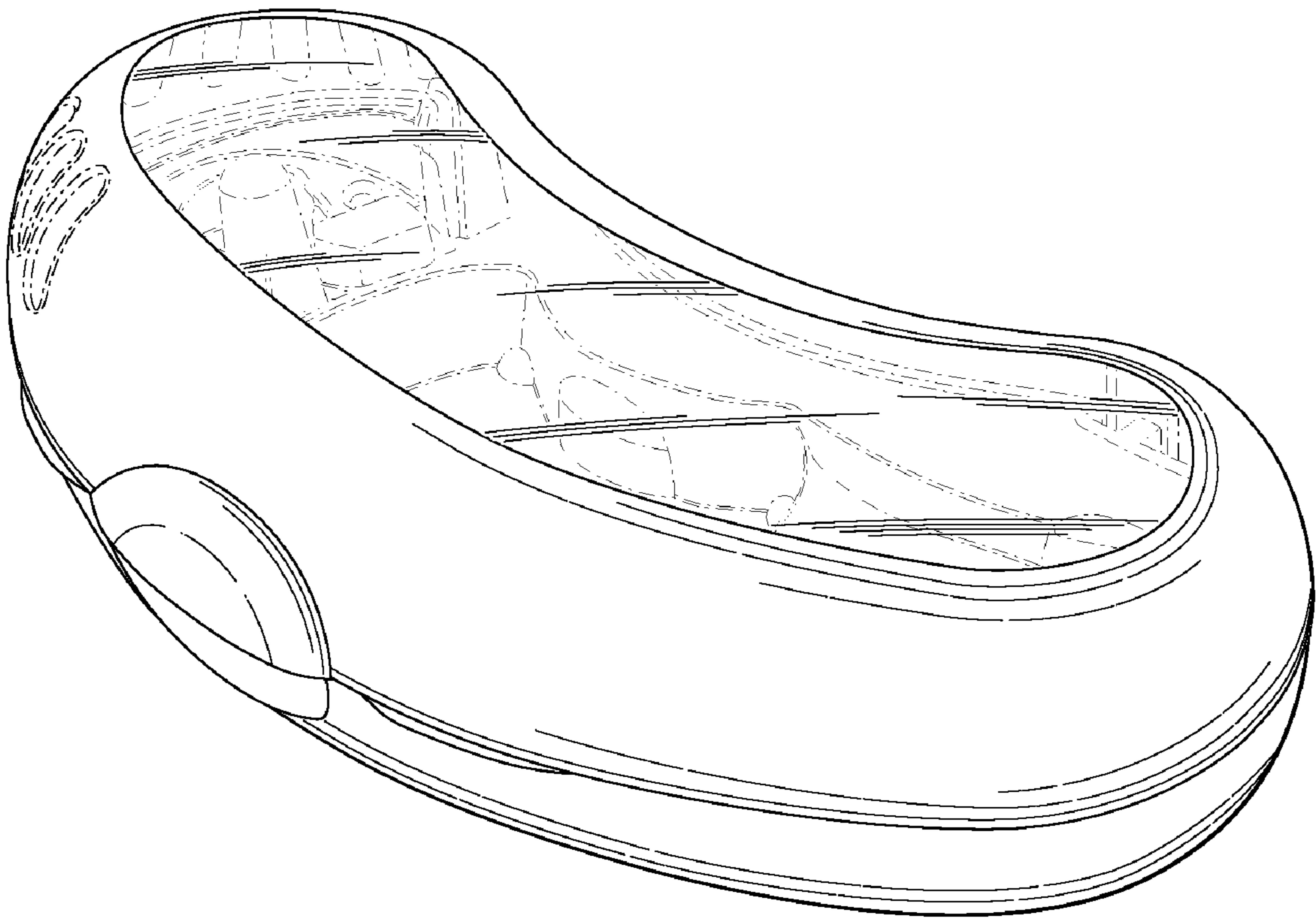

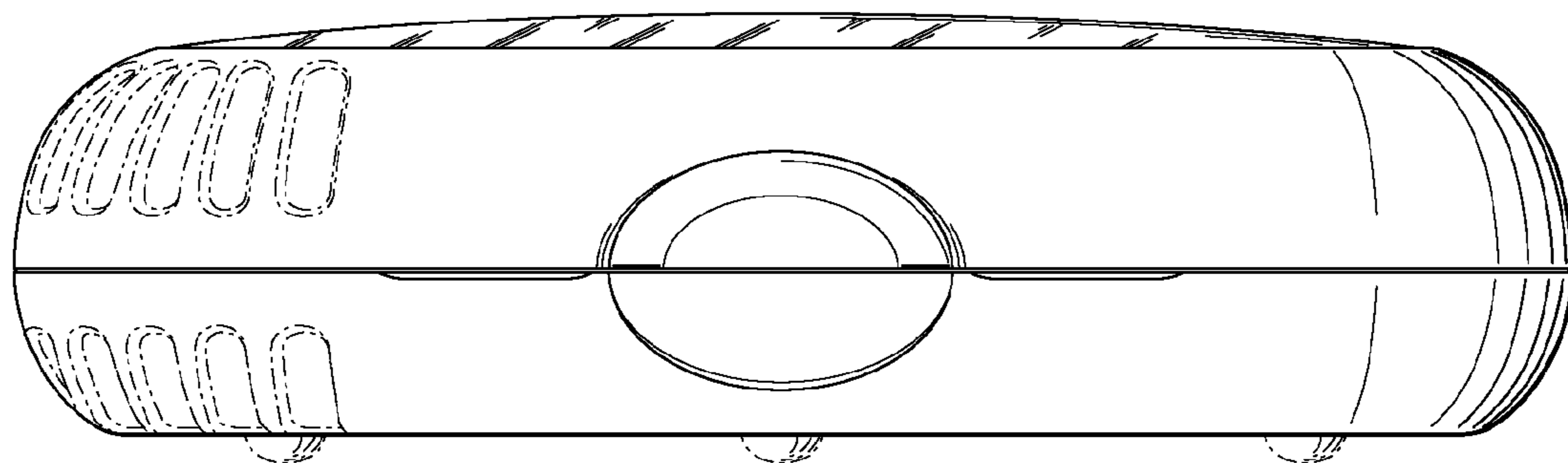

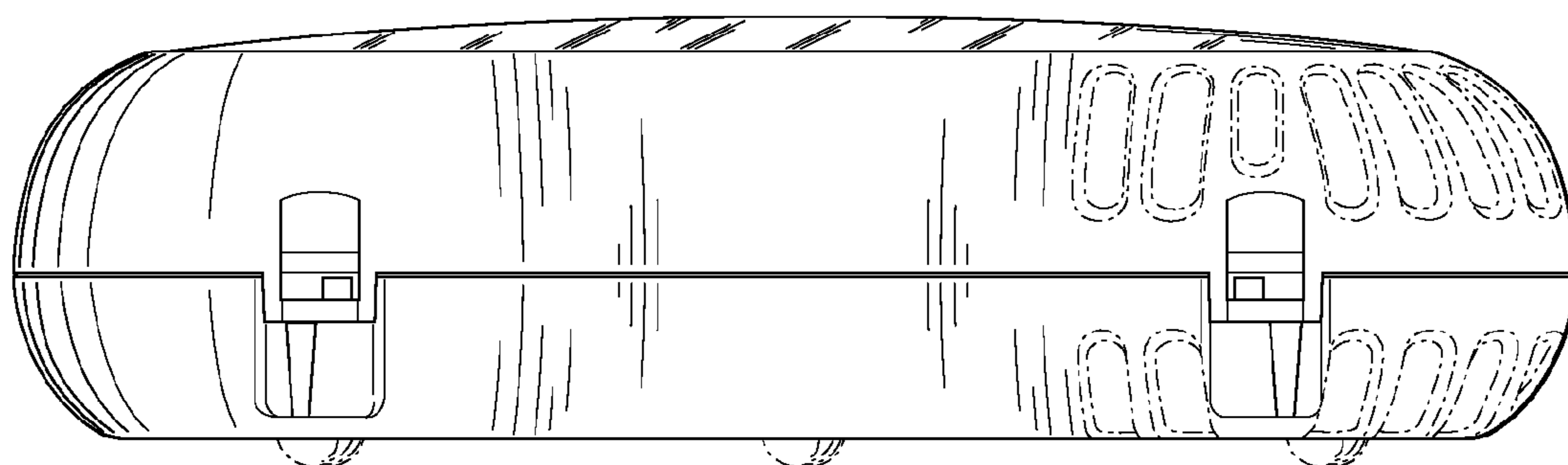

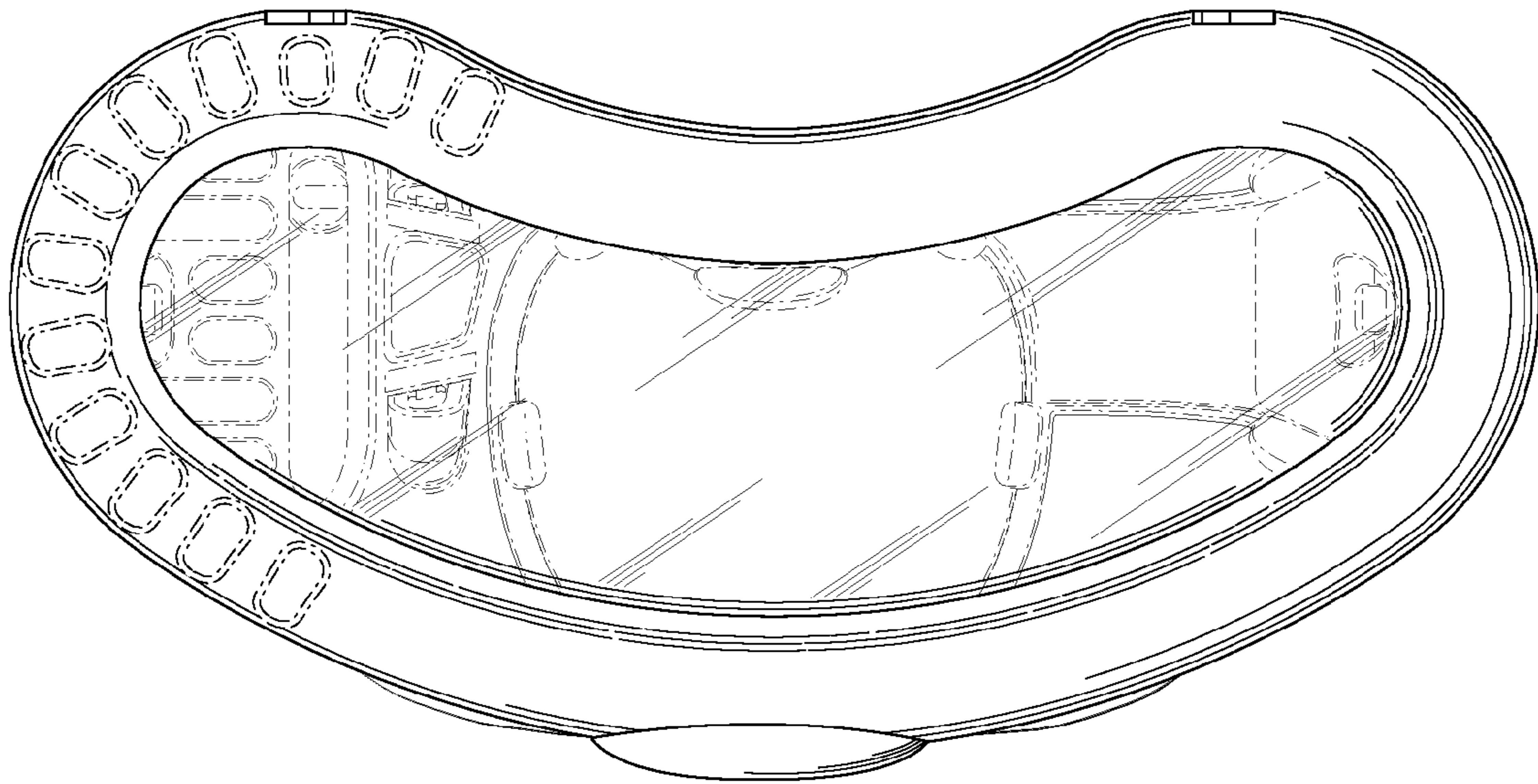

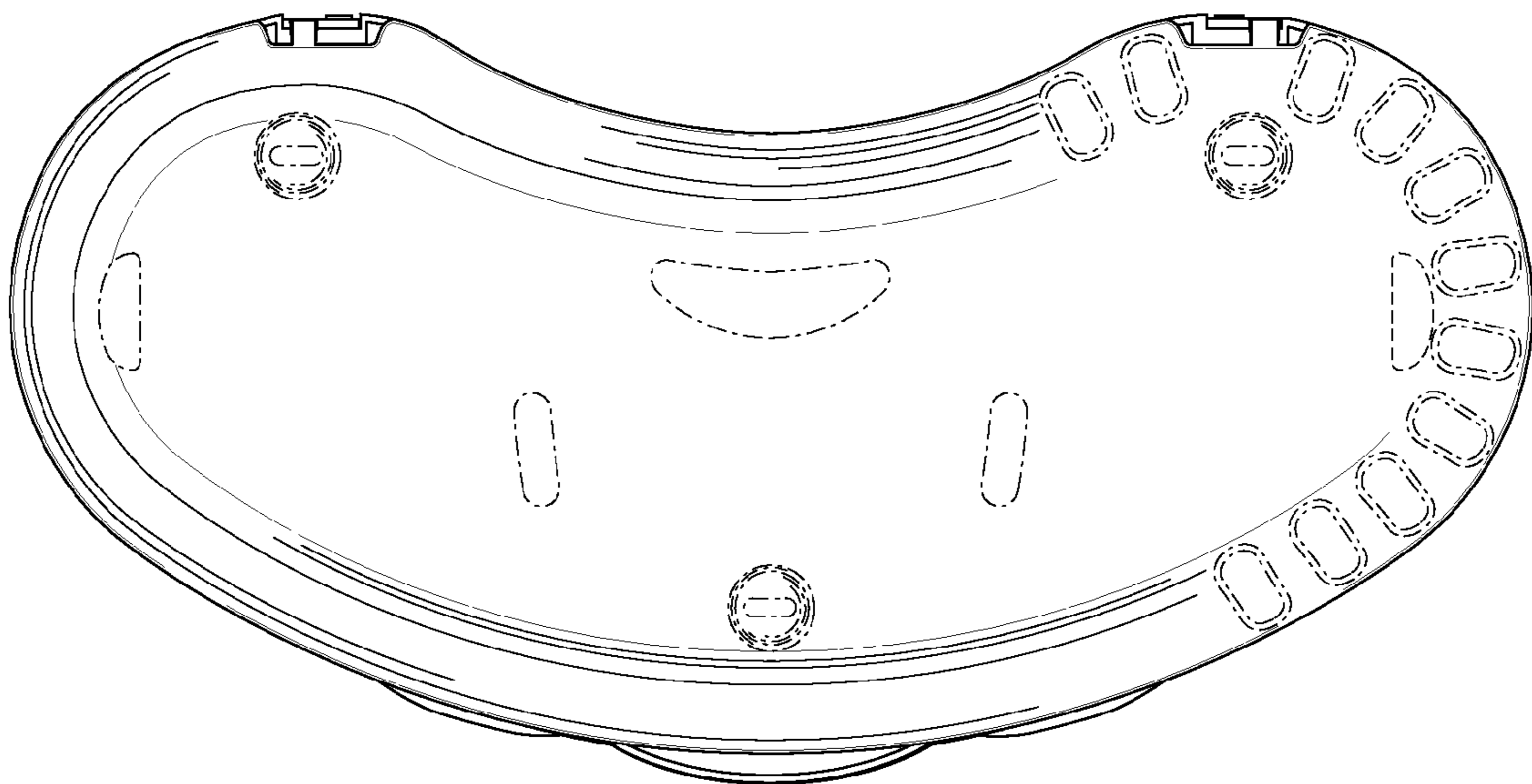

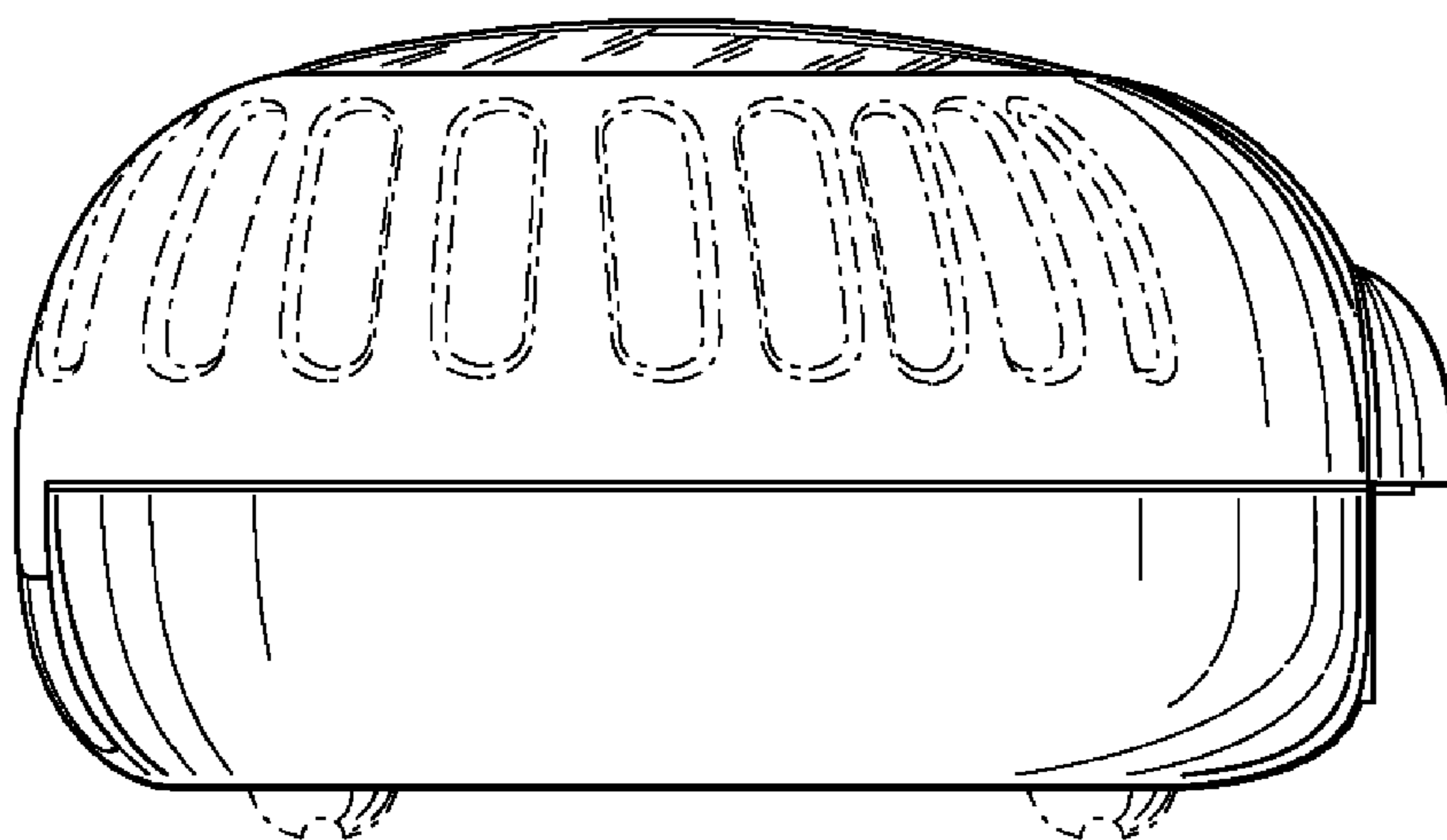

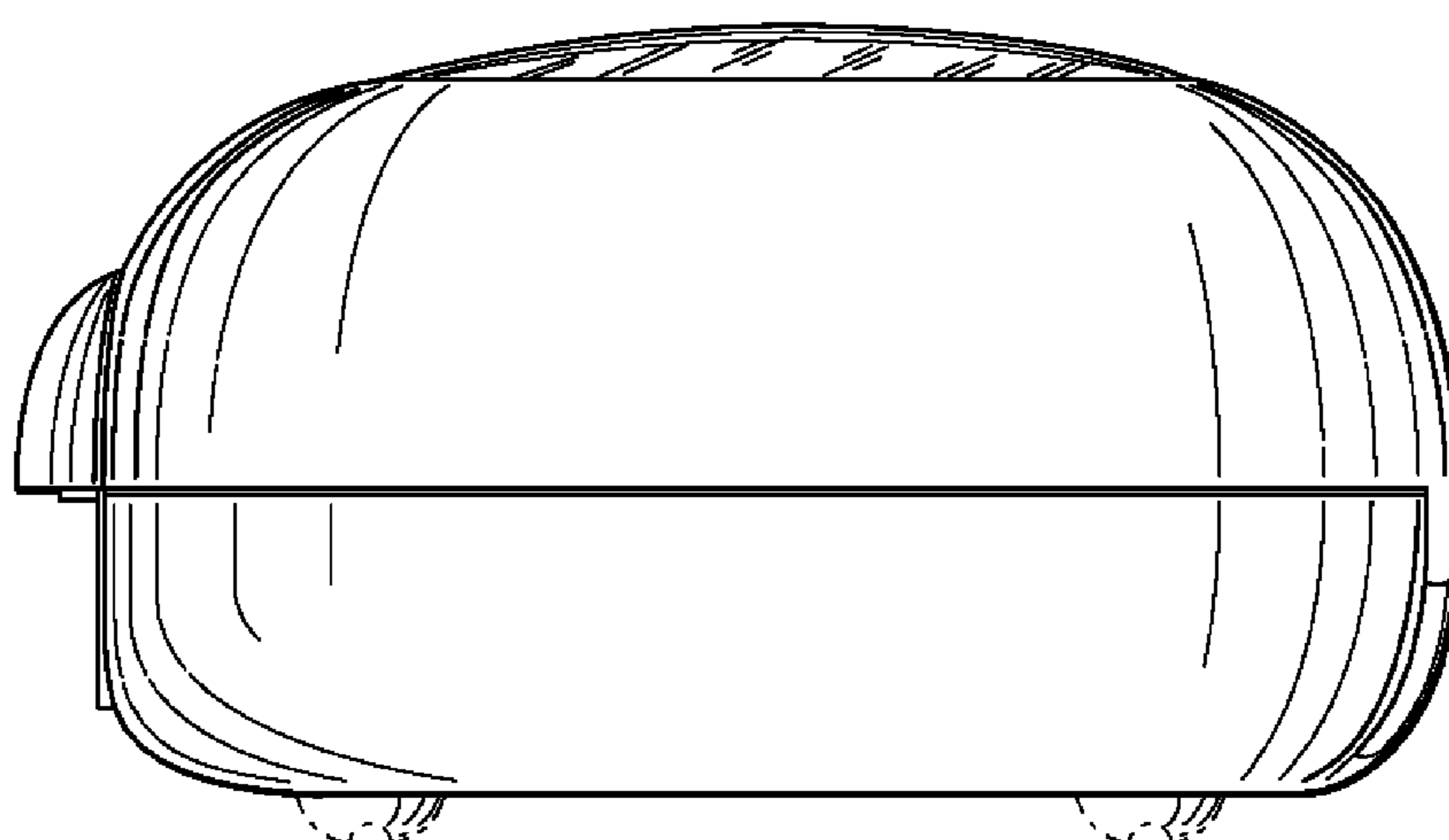

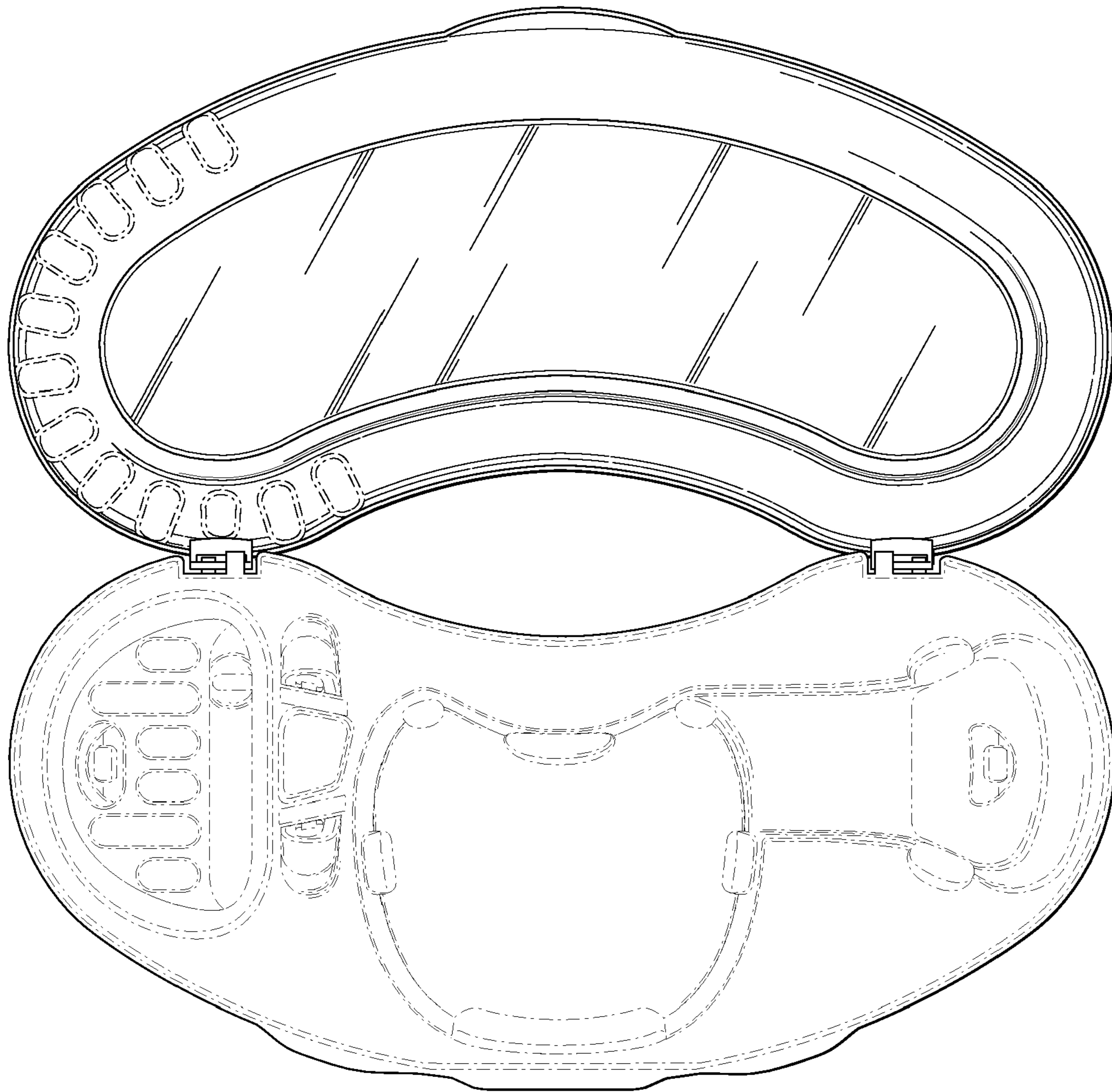
