DESCRIPTION

FIG. 1 is a top perspective view of a ring clasp and sizer showing my new design, the broken lines represent unclaimed portions of the design and form no part thereof;

FIG. 3 is a side view thereof;

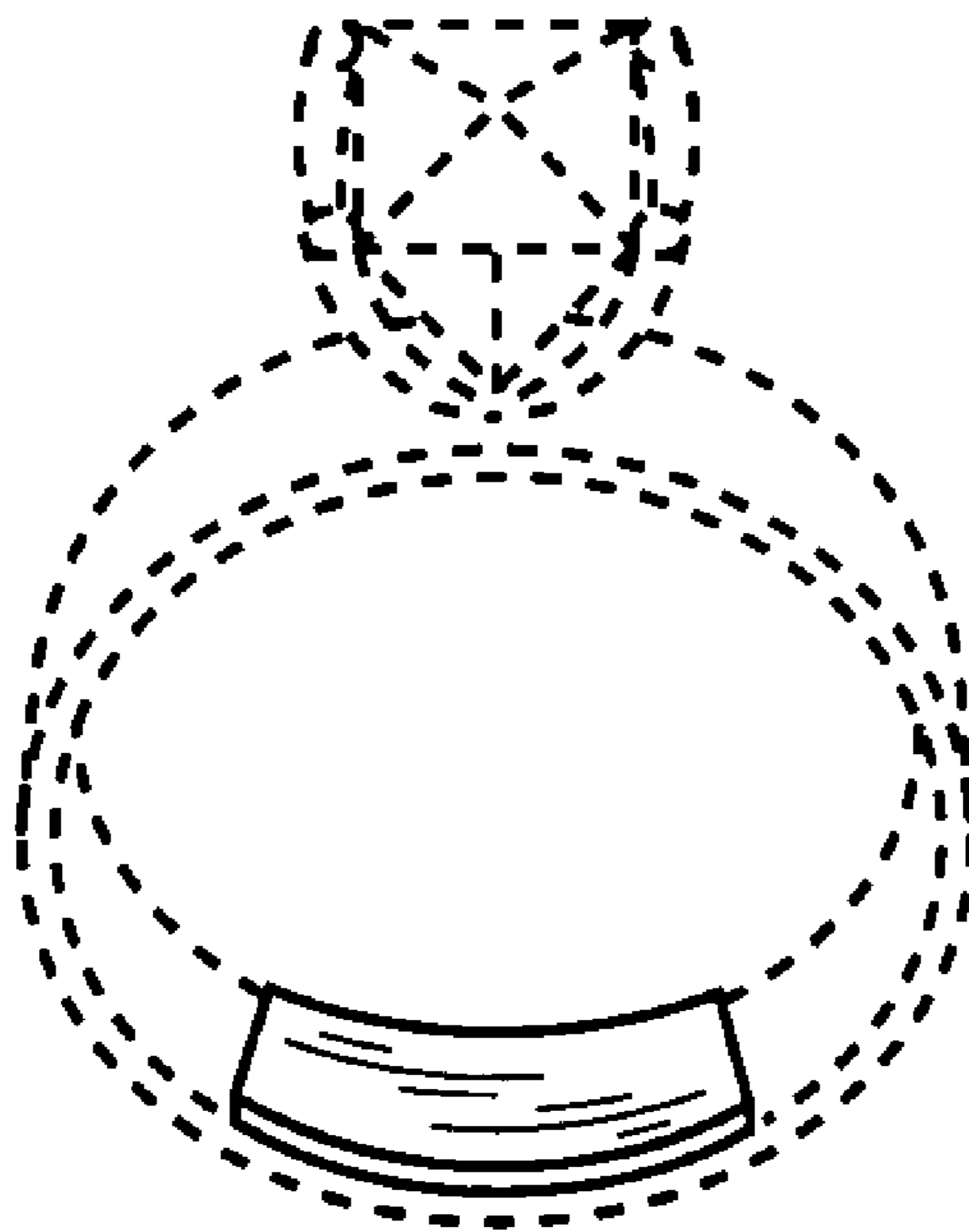
FIG. 4 is an opposing side view of FIG. 3;

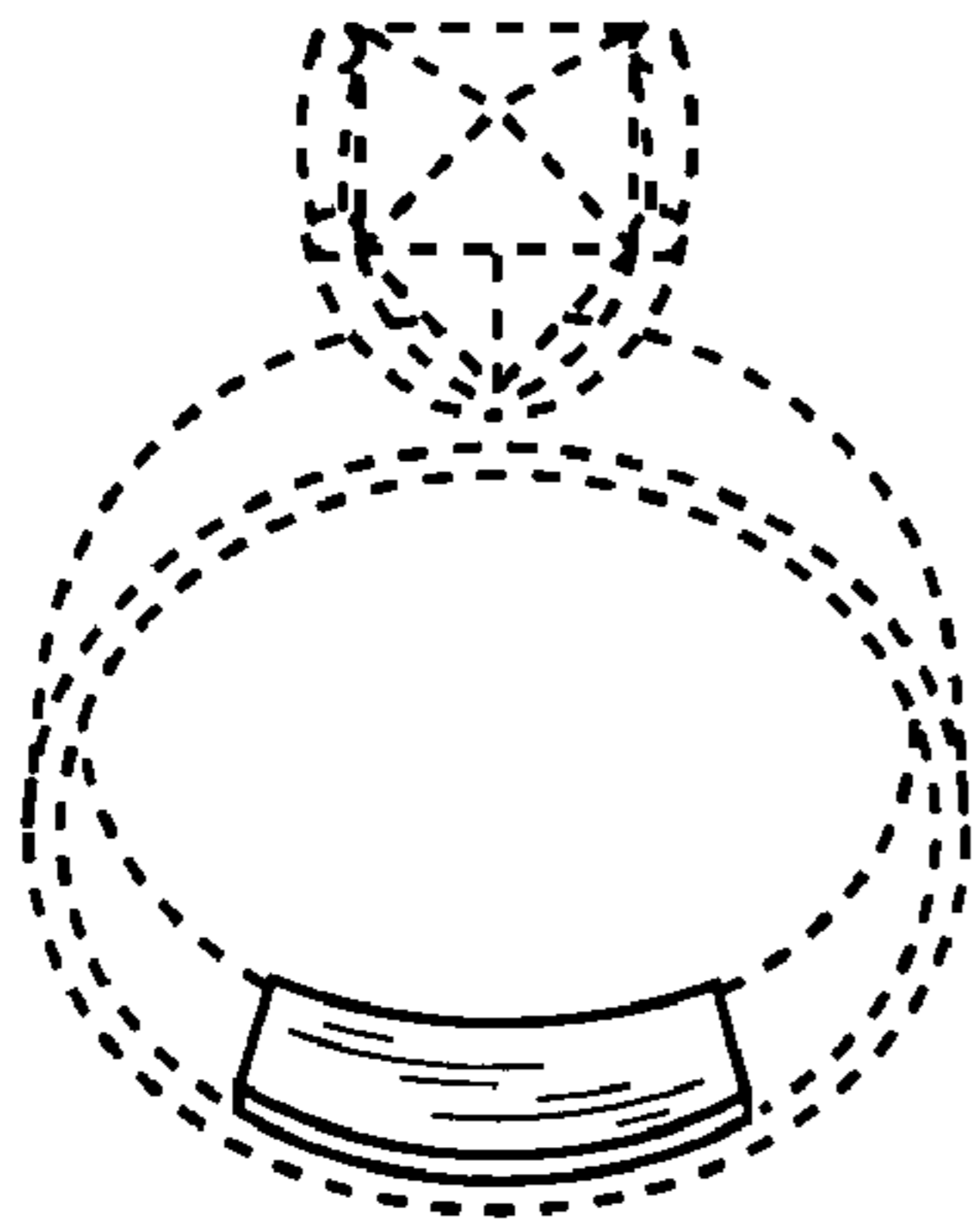

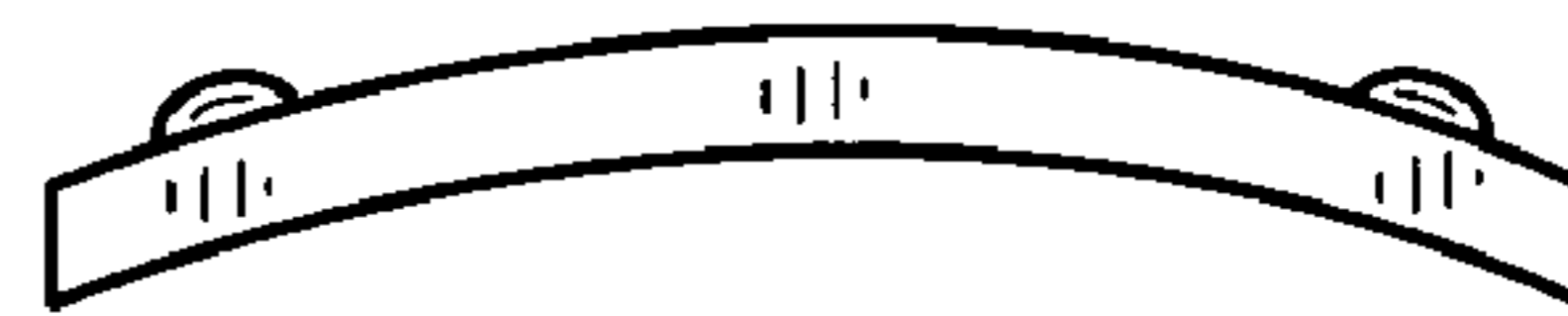

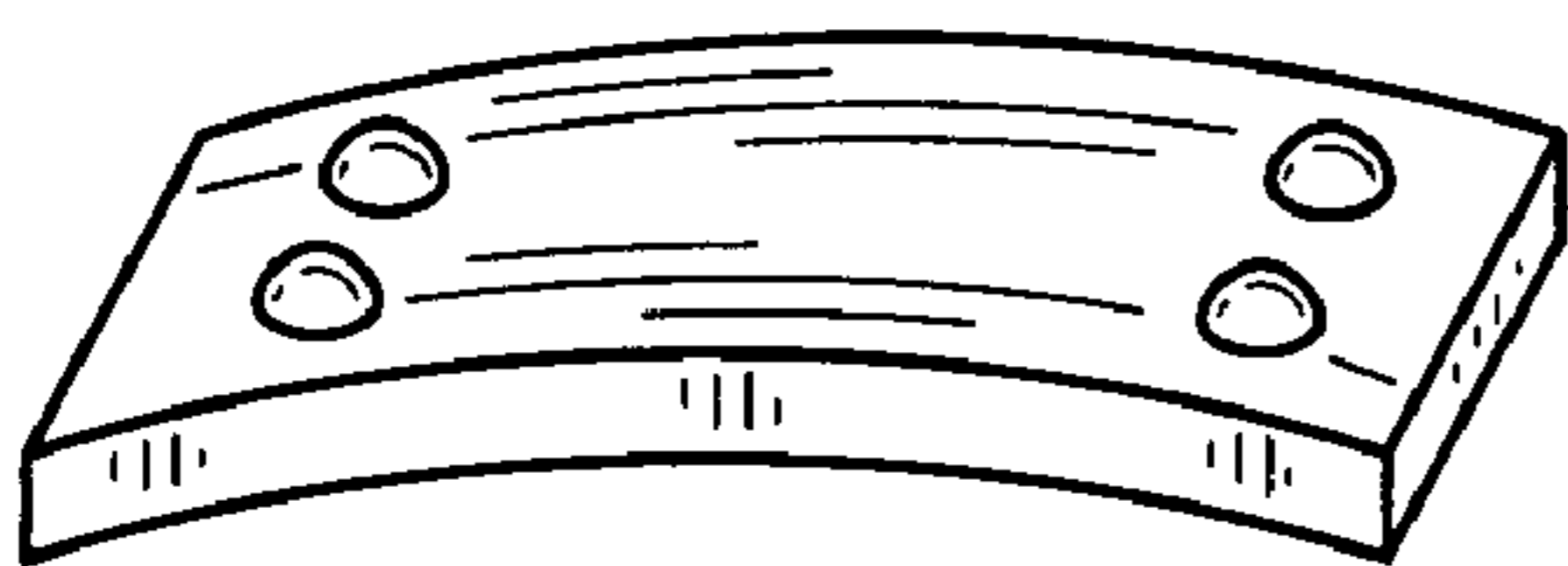

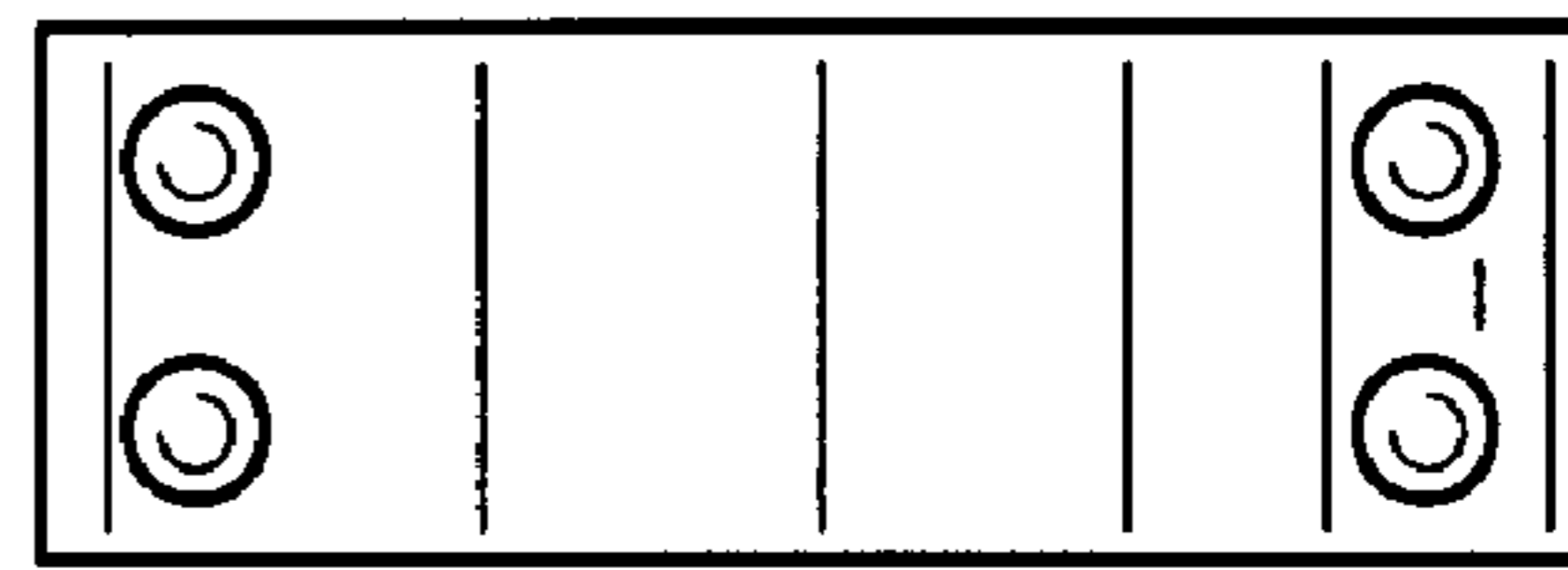
