object made of glass according to a first embodiment.

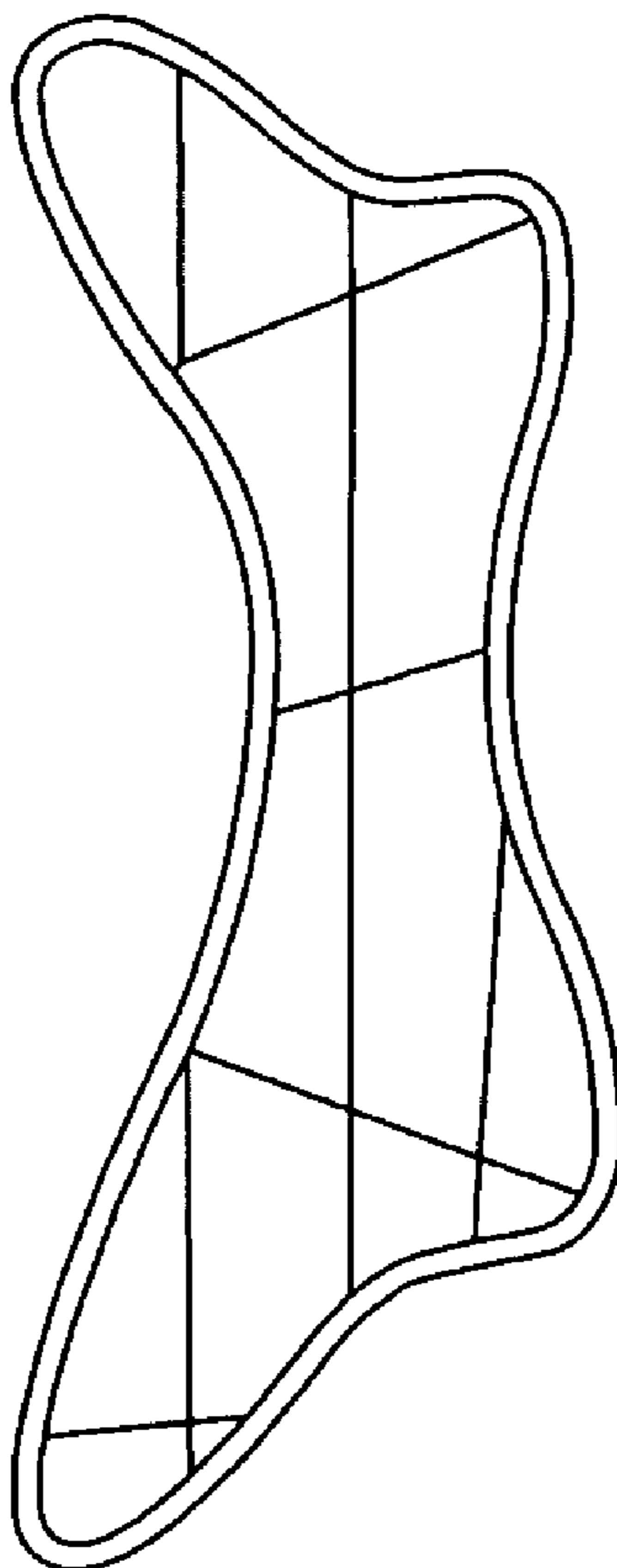

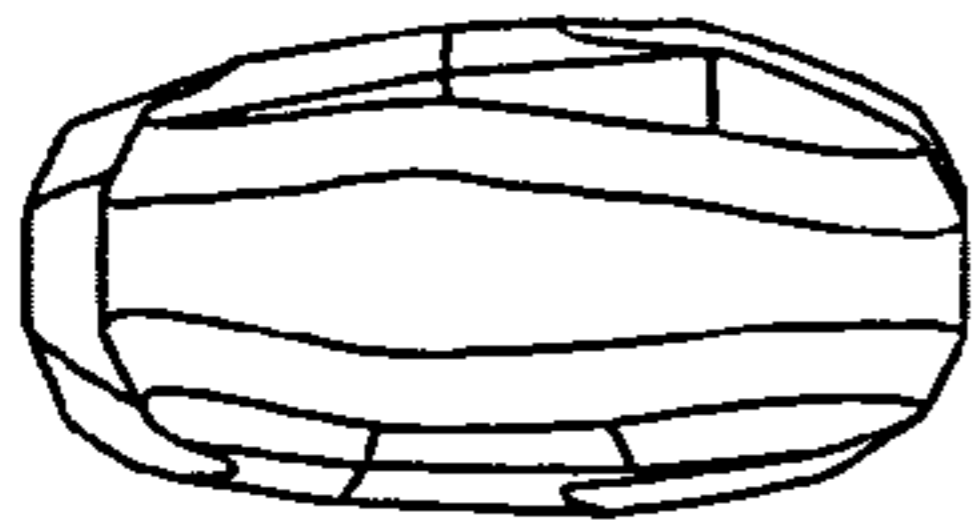

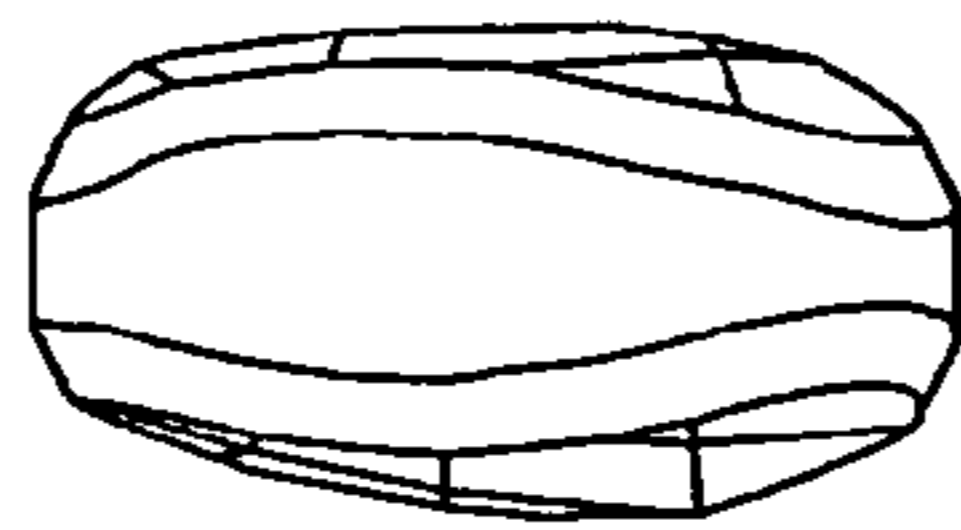

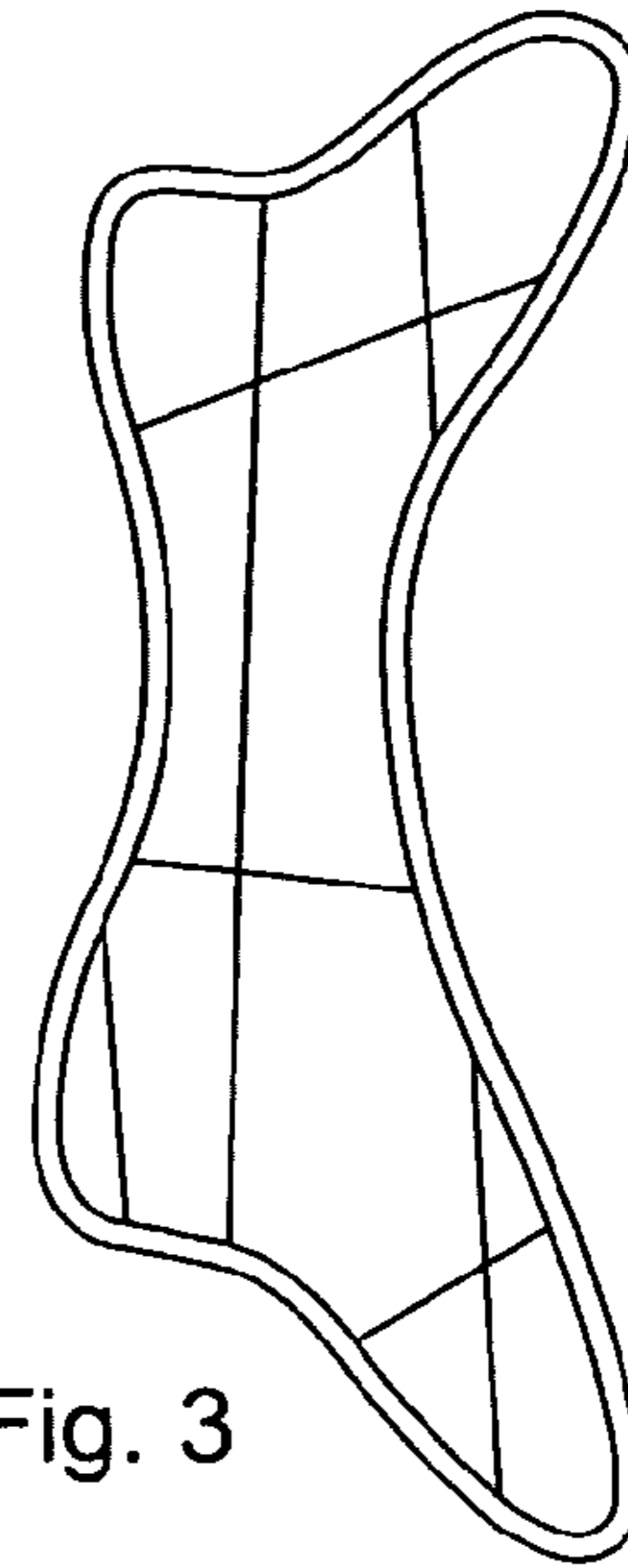

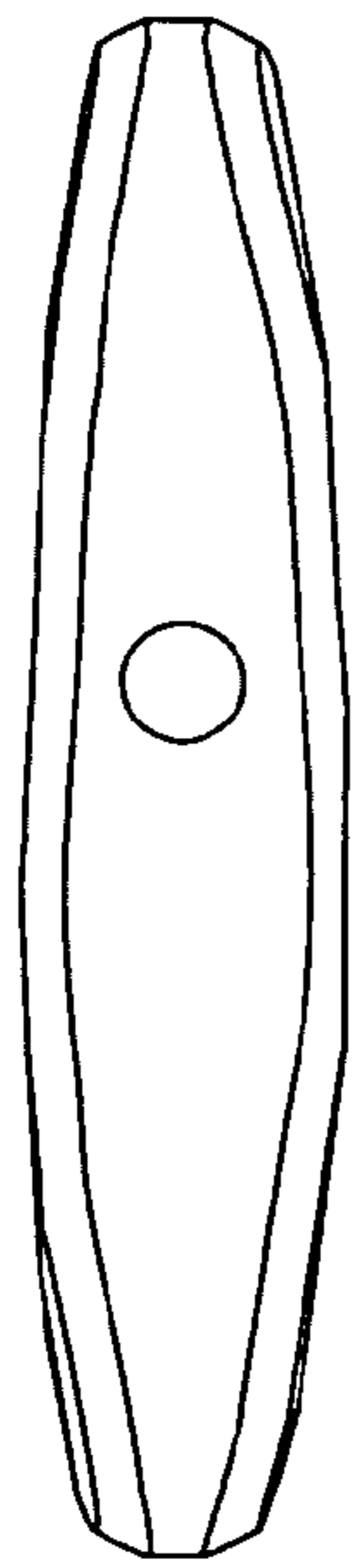

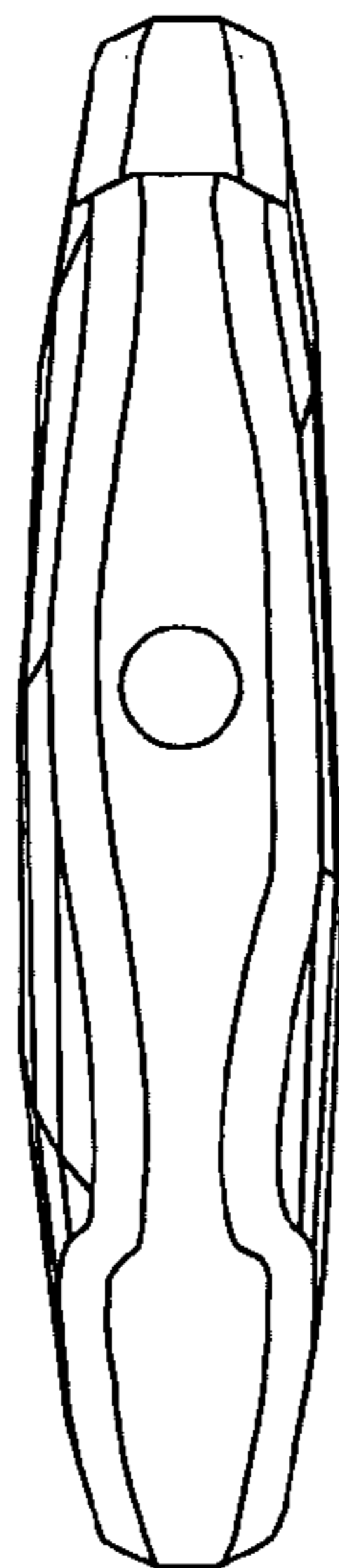

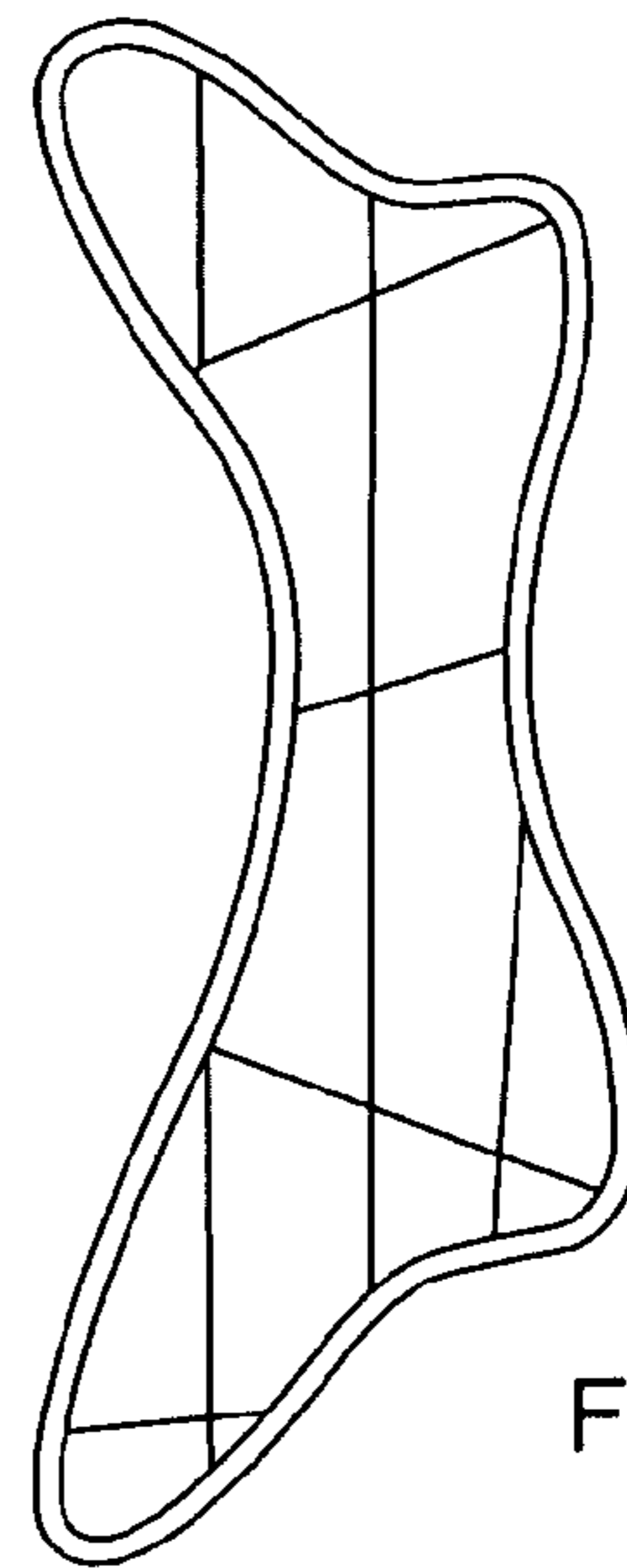

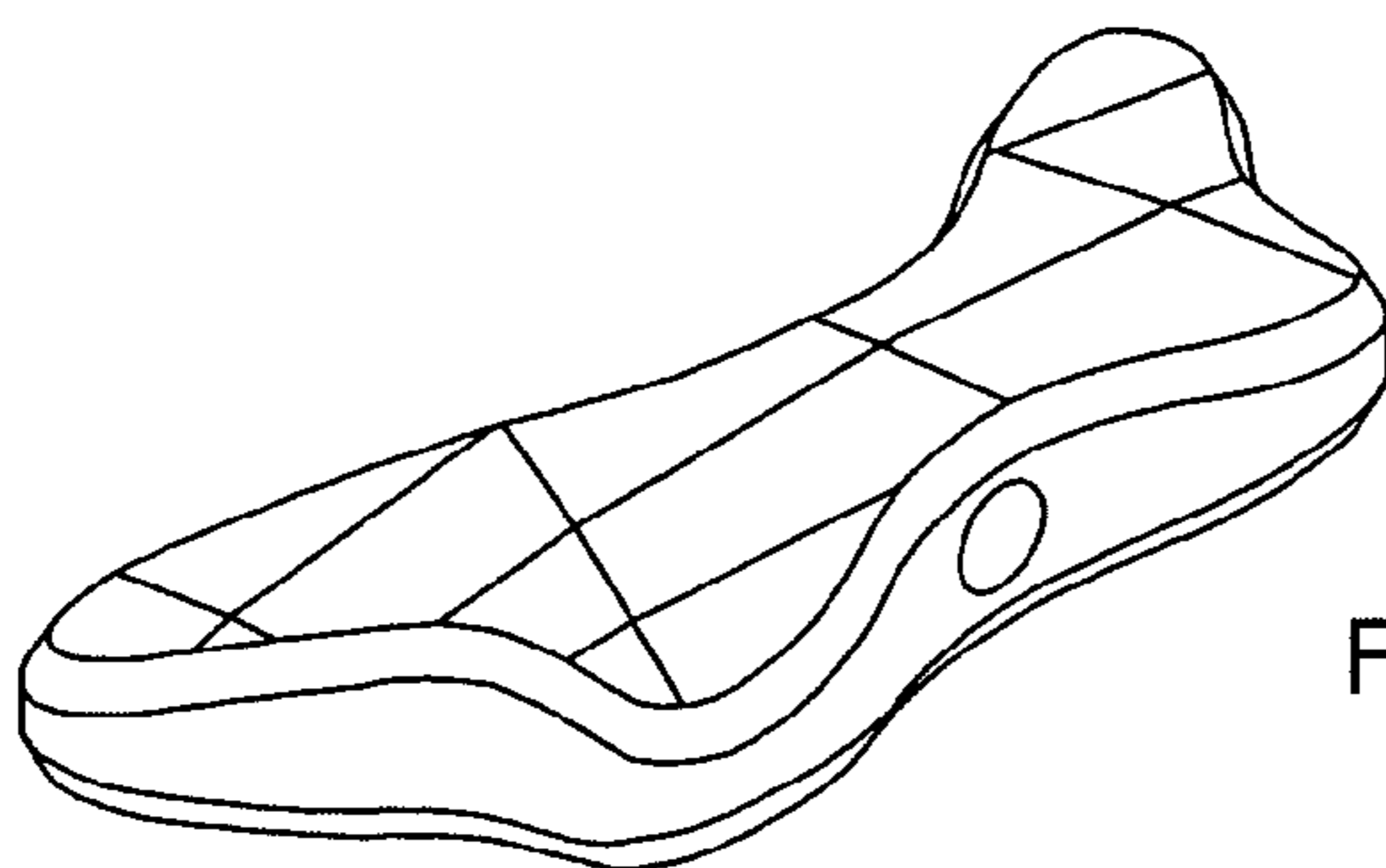
