DESCRIPTION

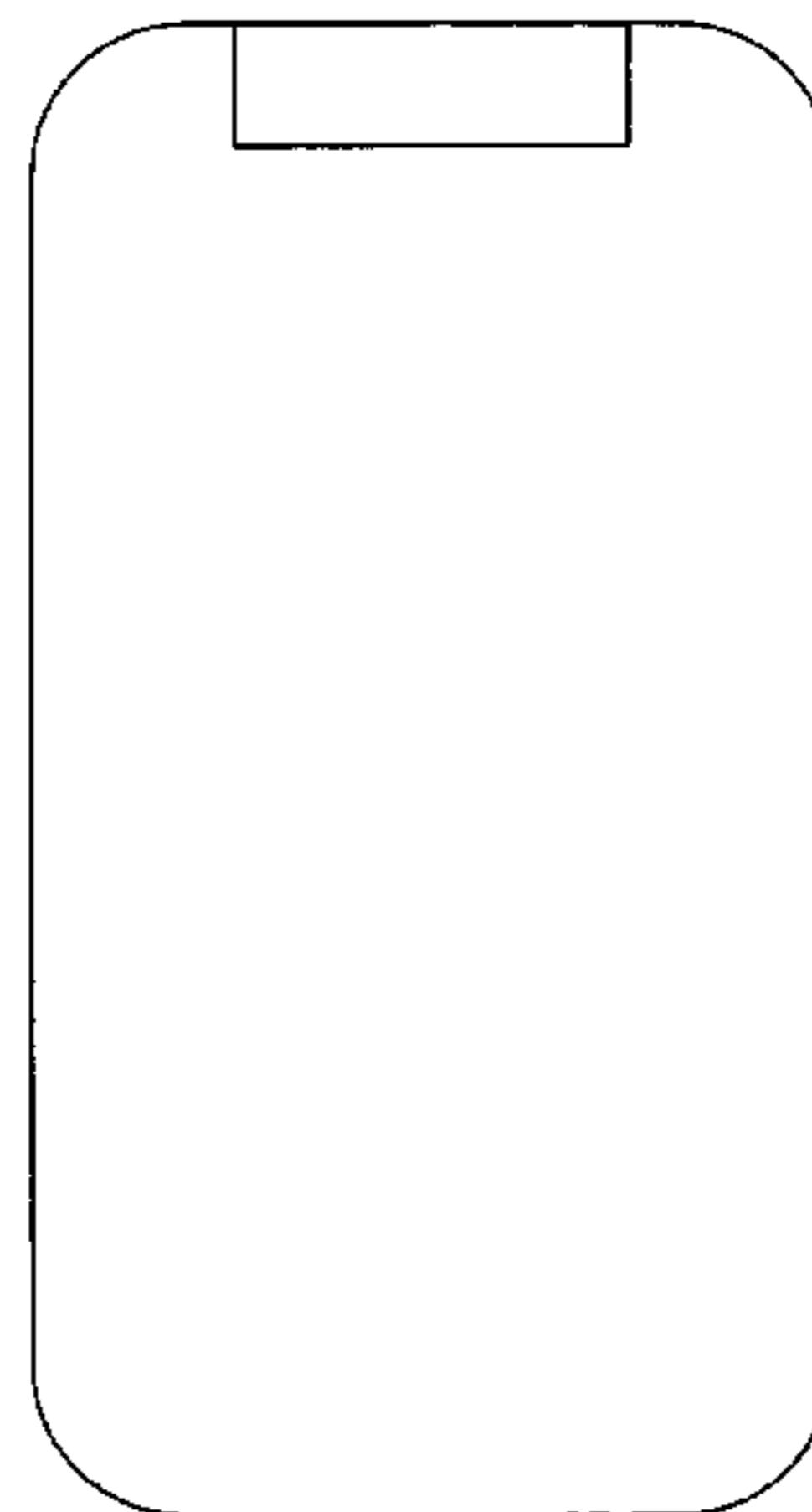
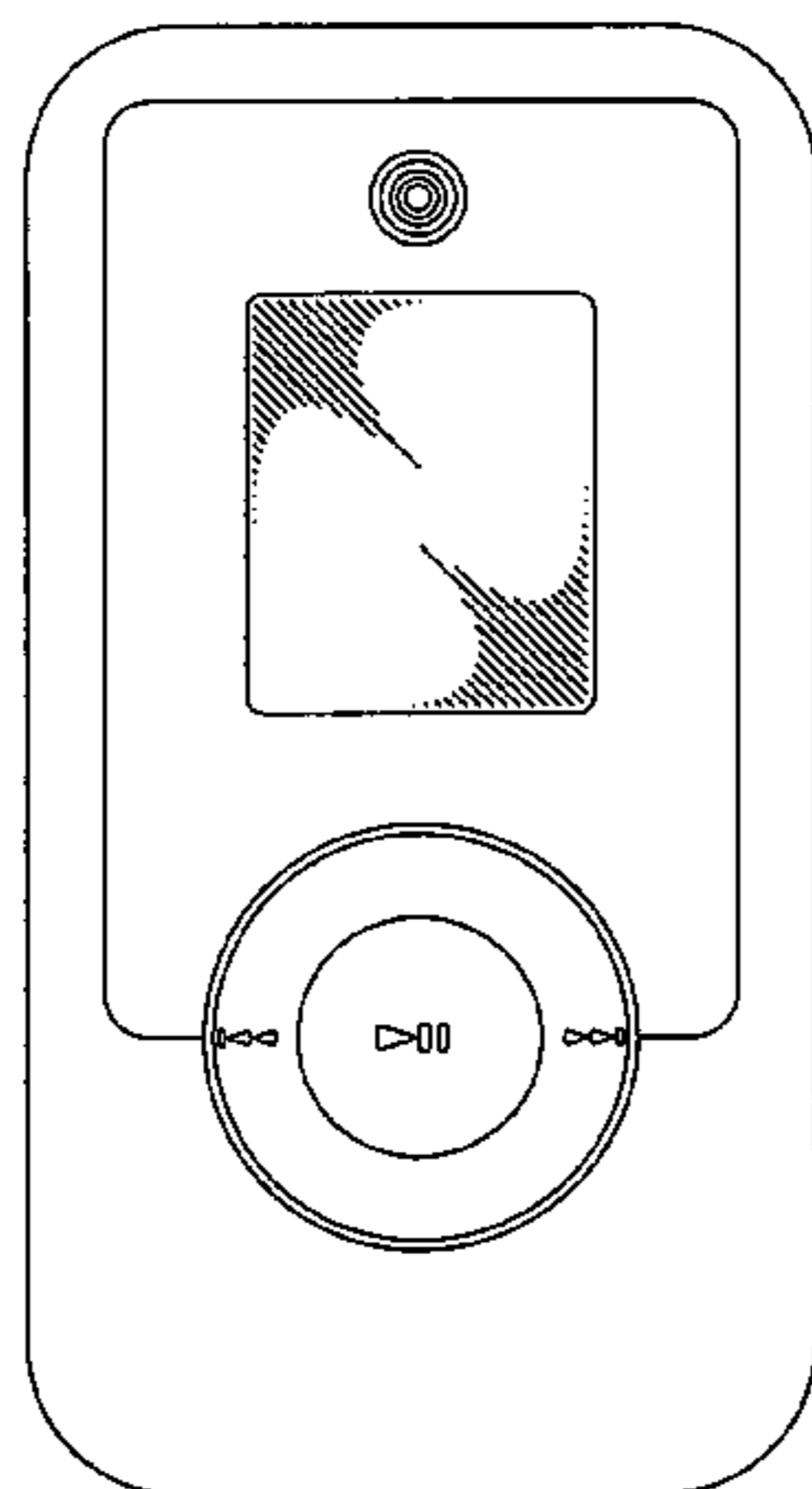

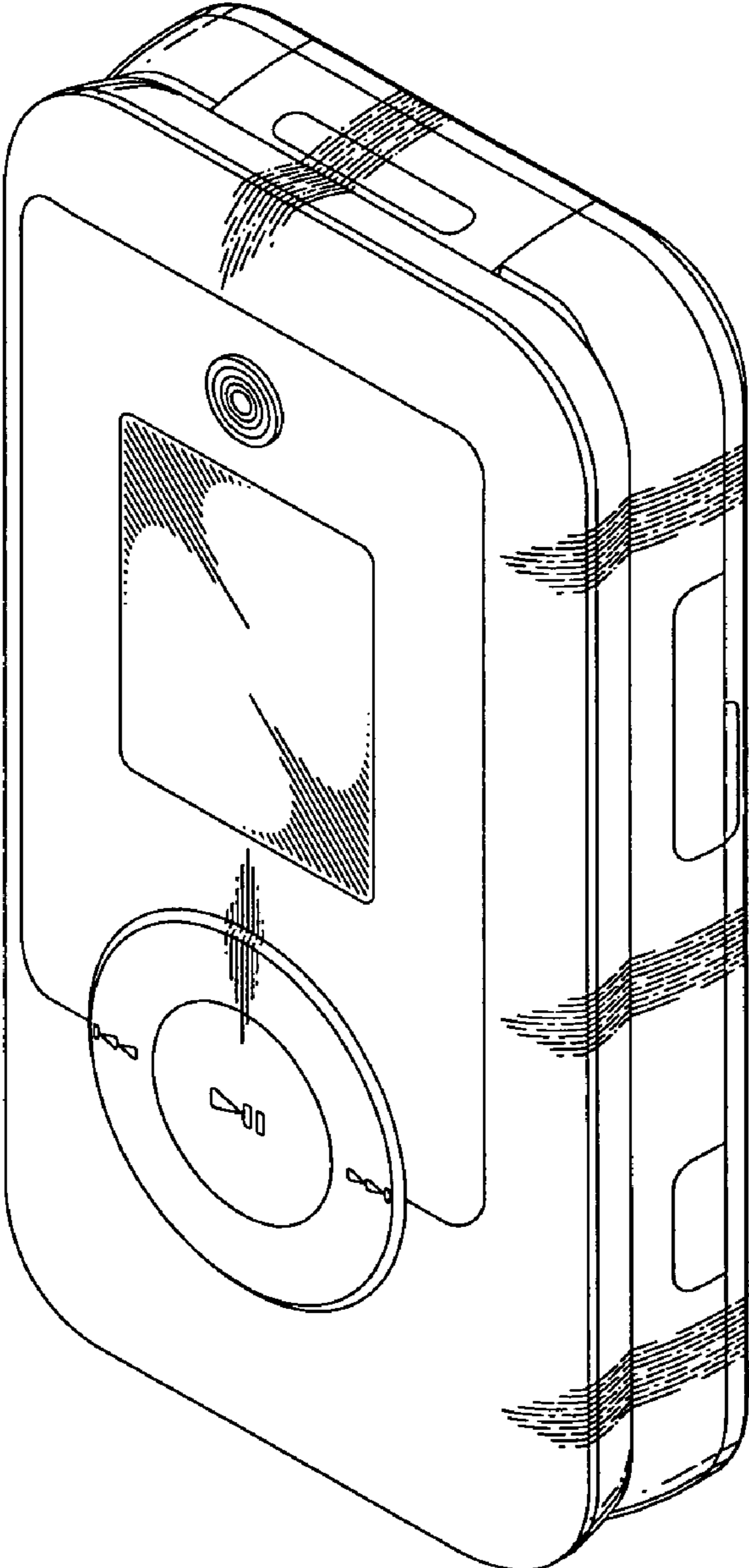

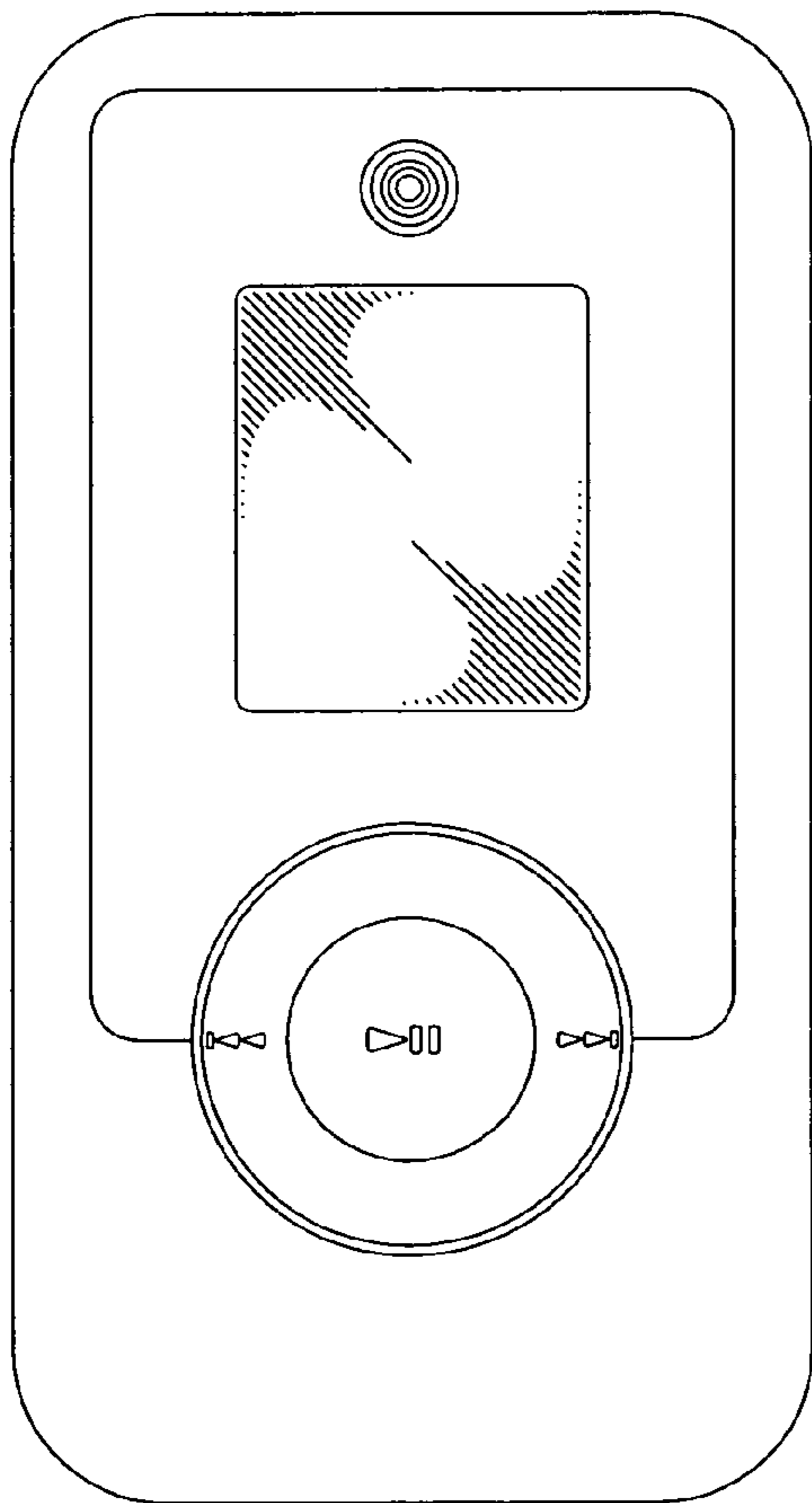

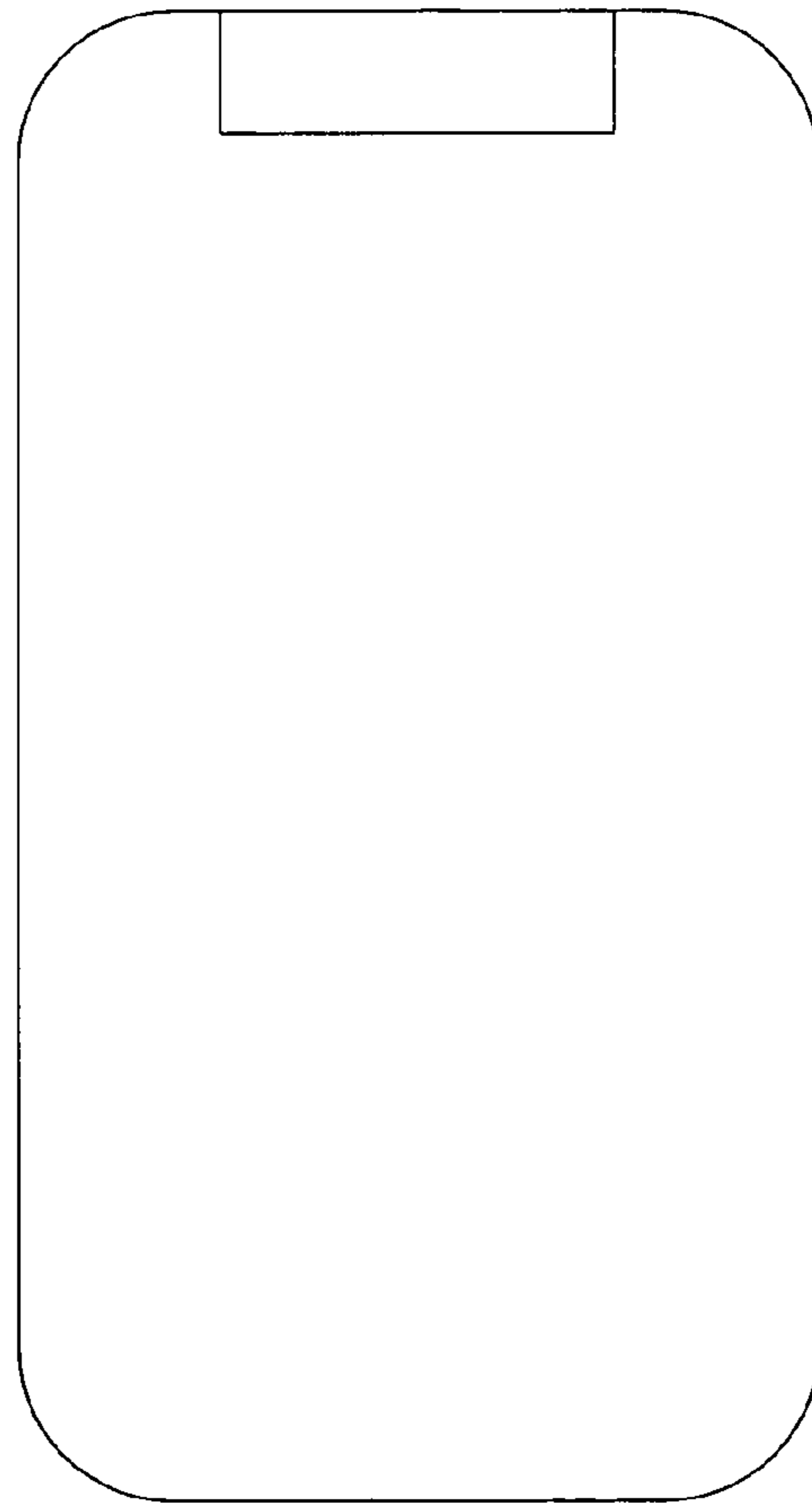

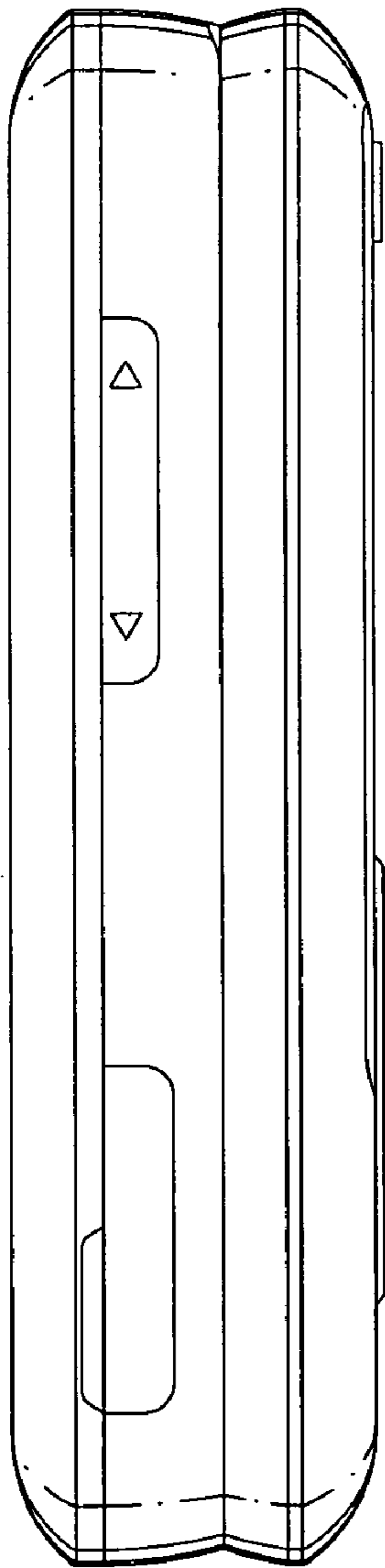

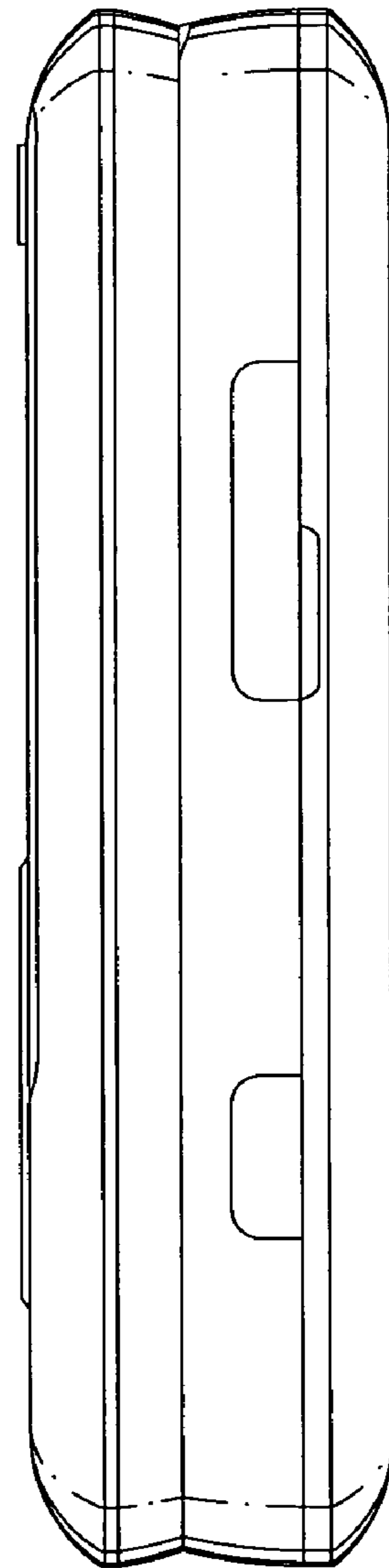

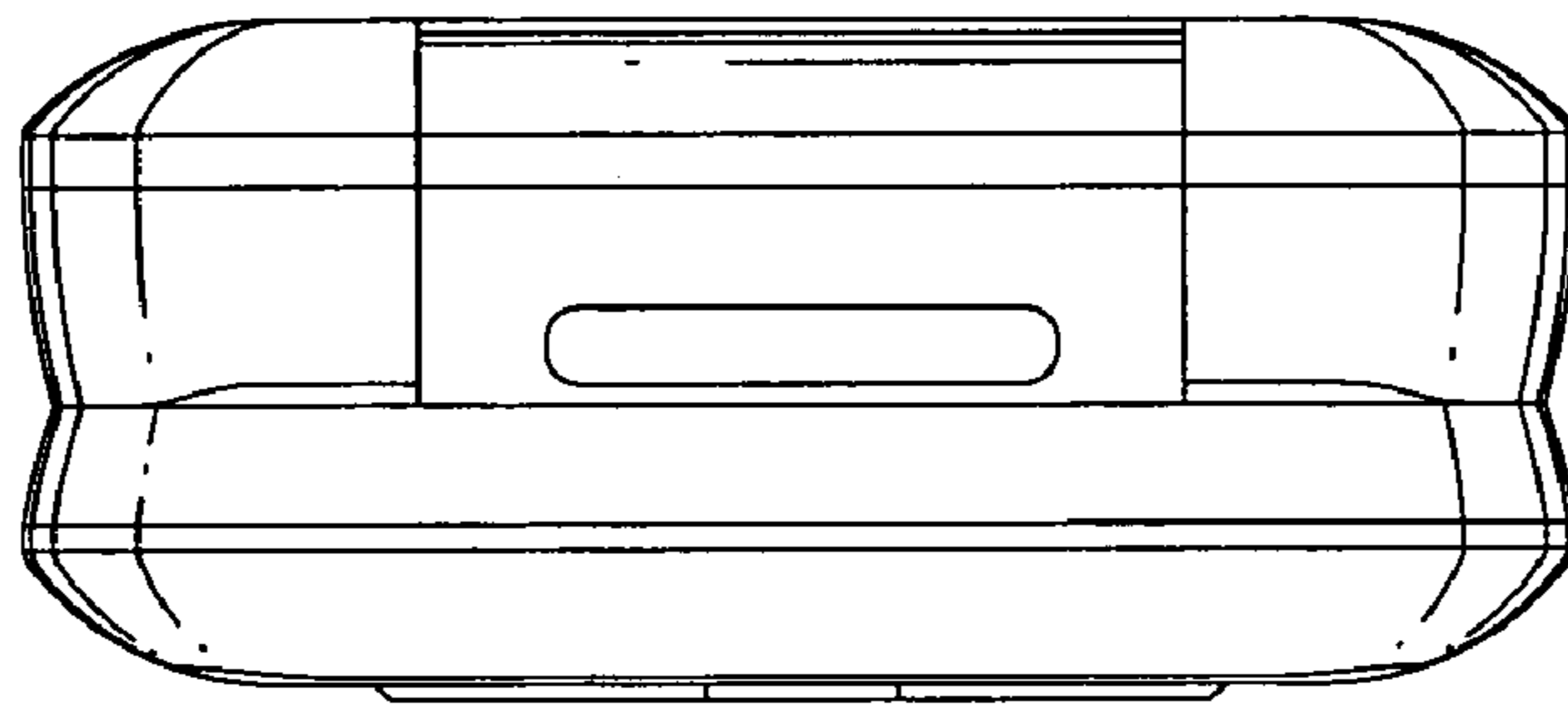

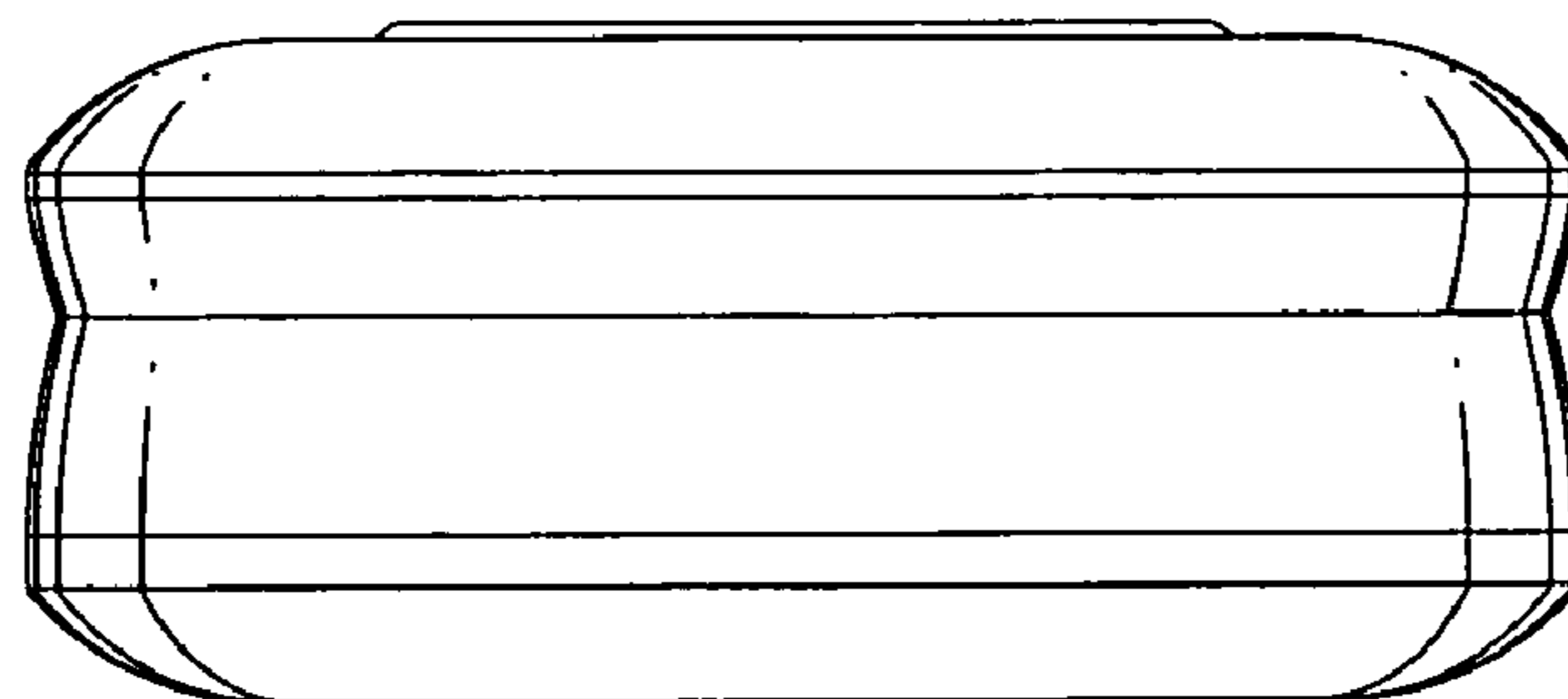
