FIG. 4 is an opposite side view of the computer unit.

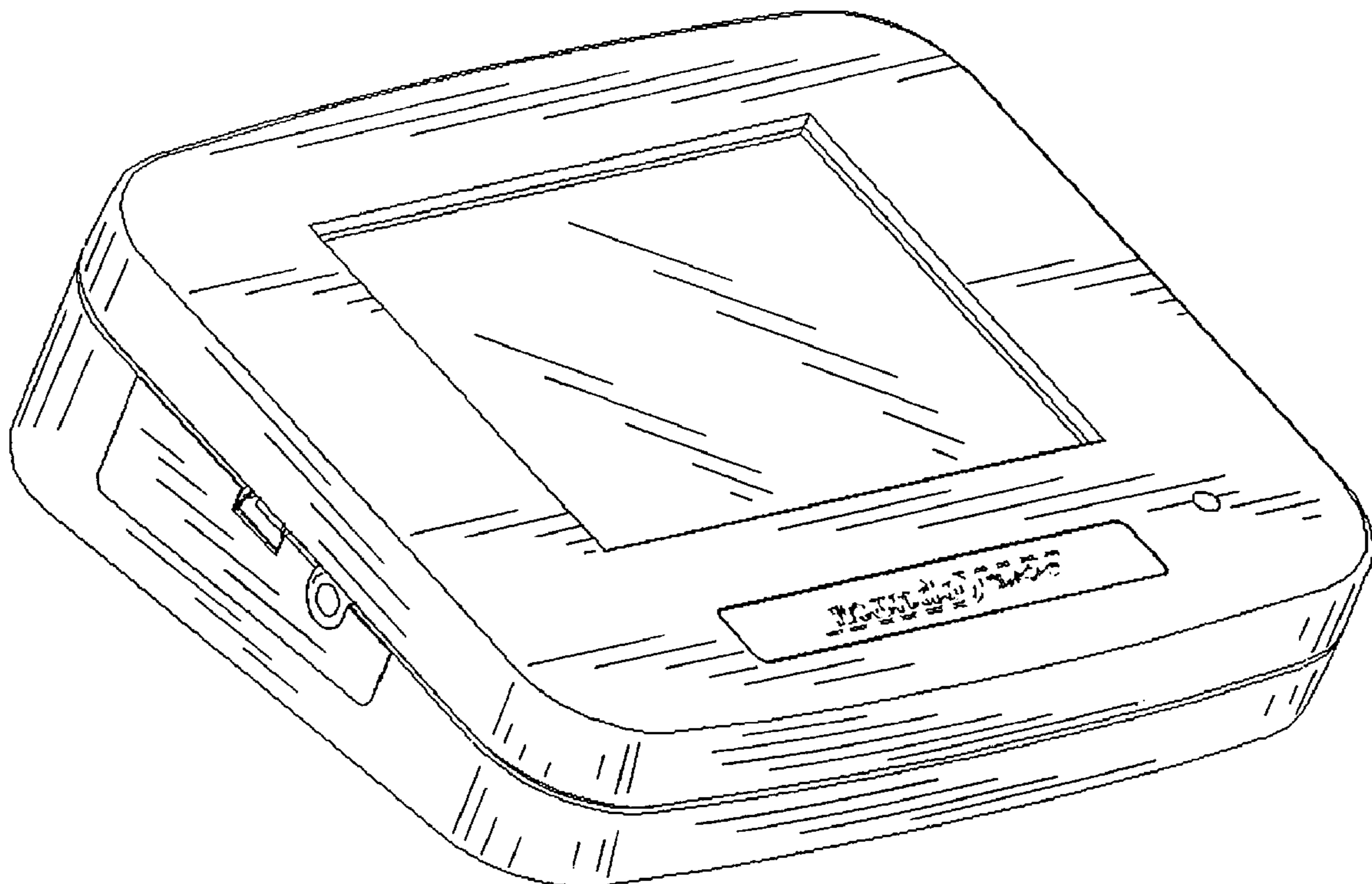
FIG. 5 is a top view of the computer unit.

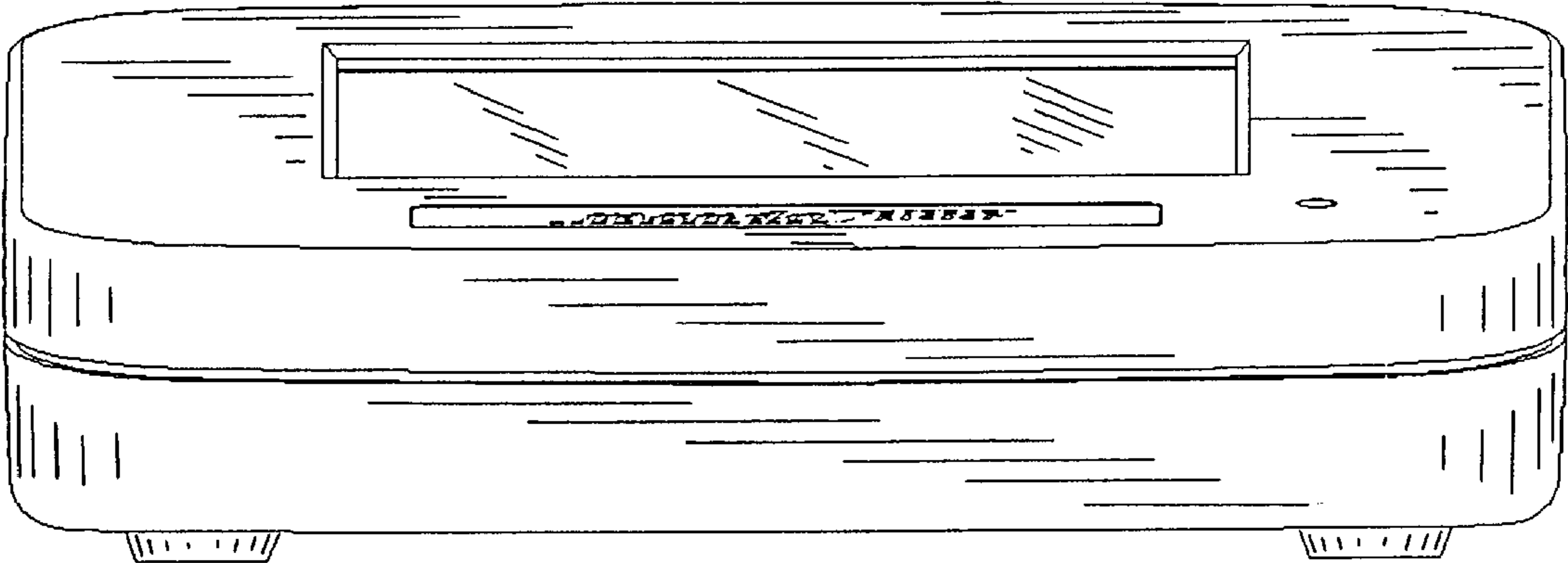

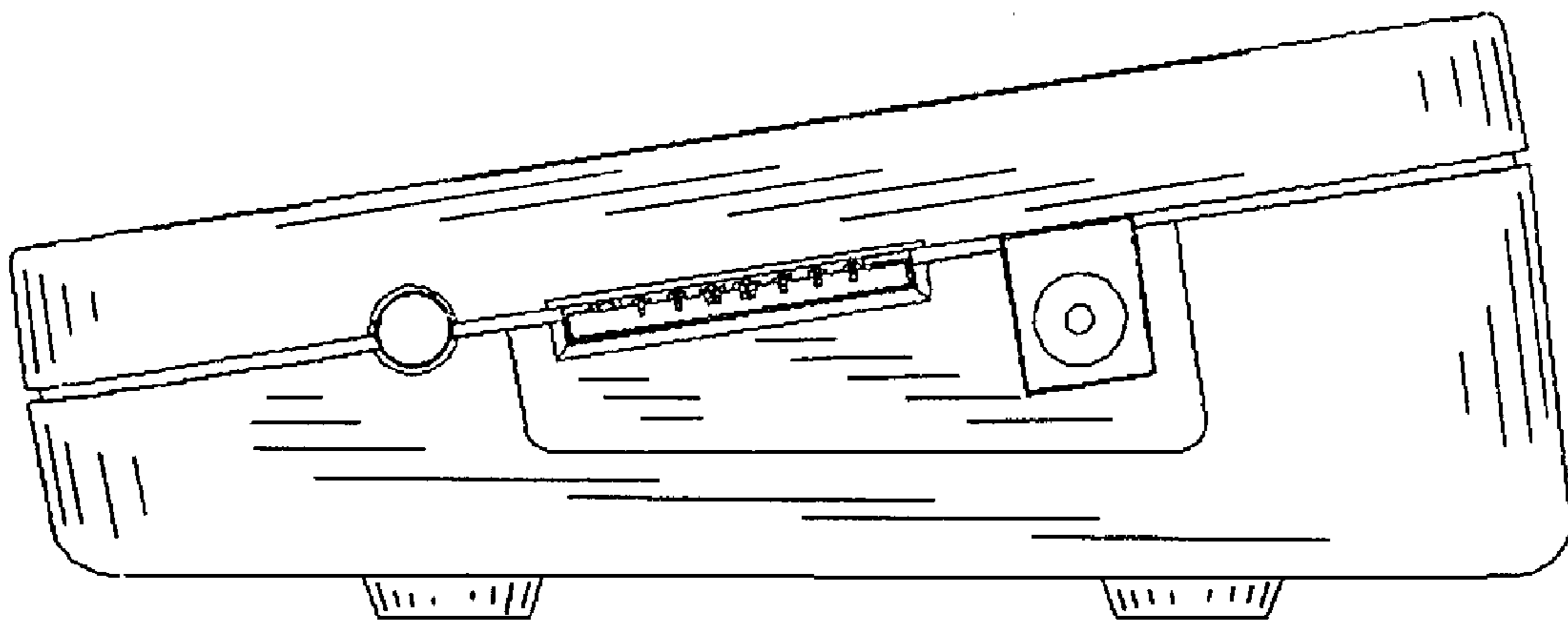

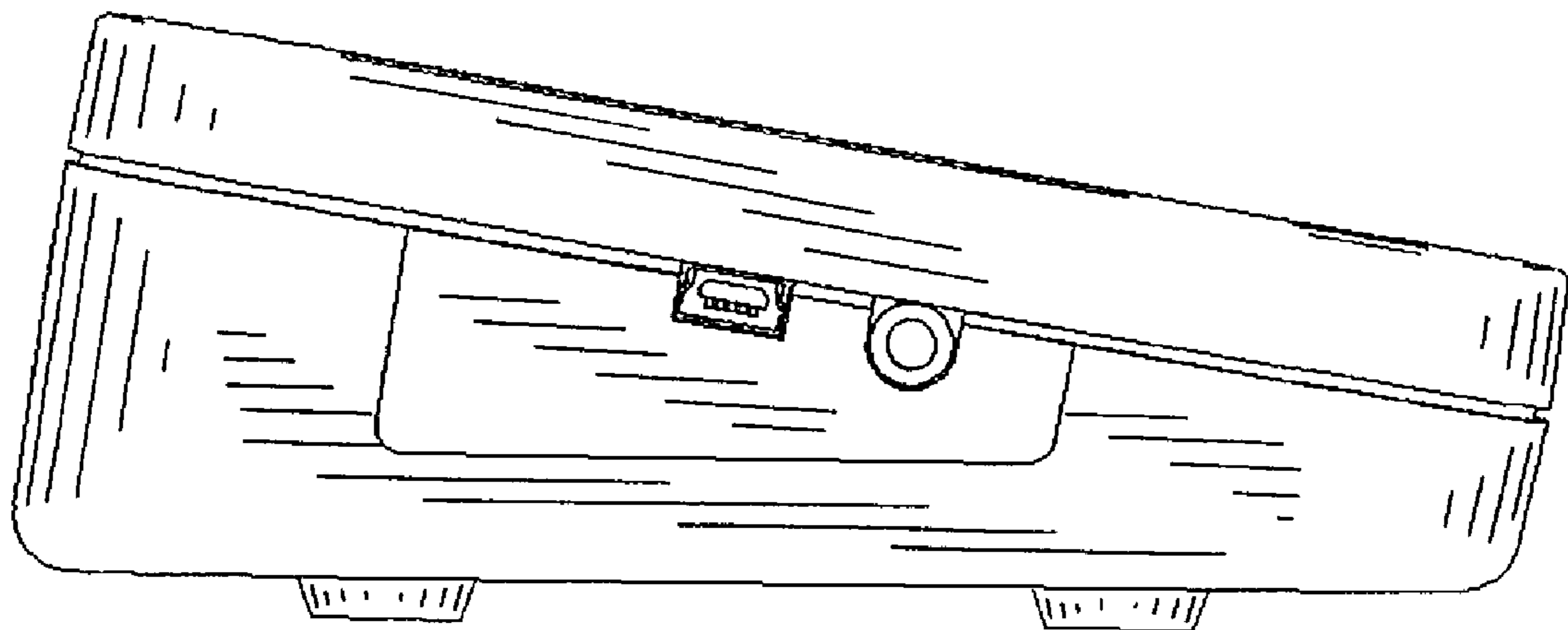

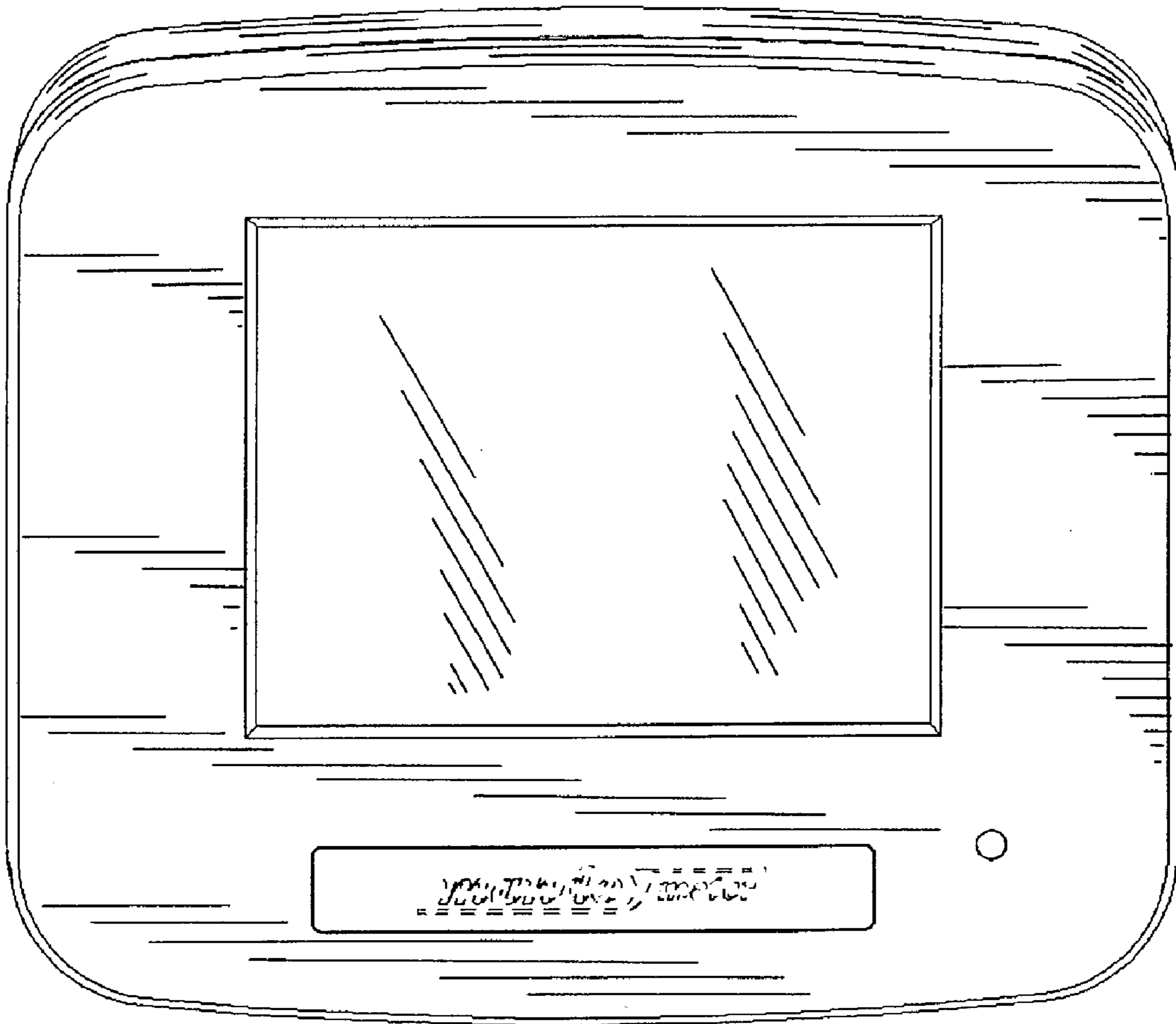

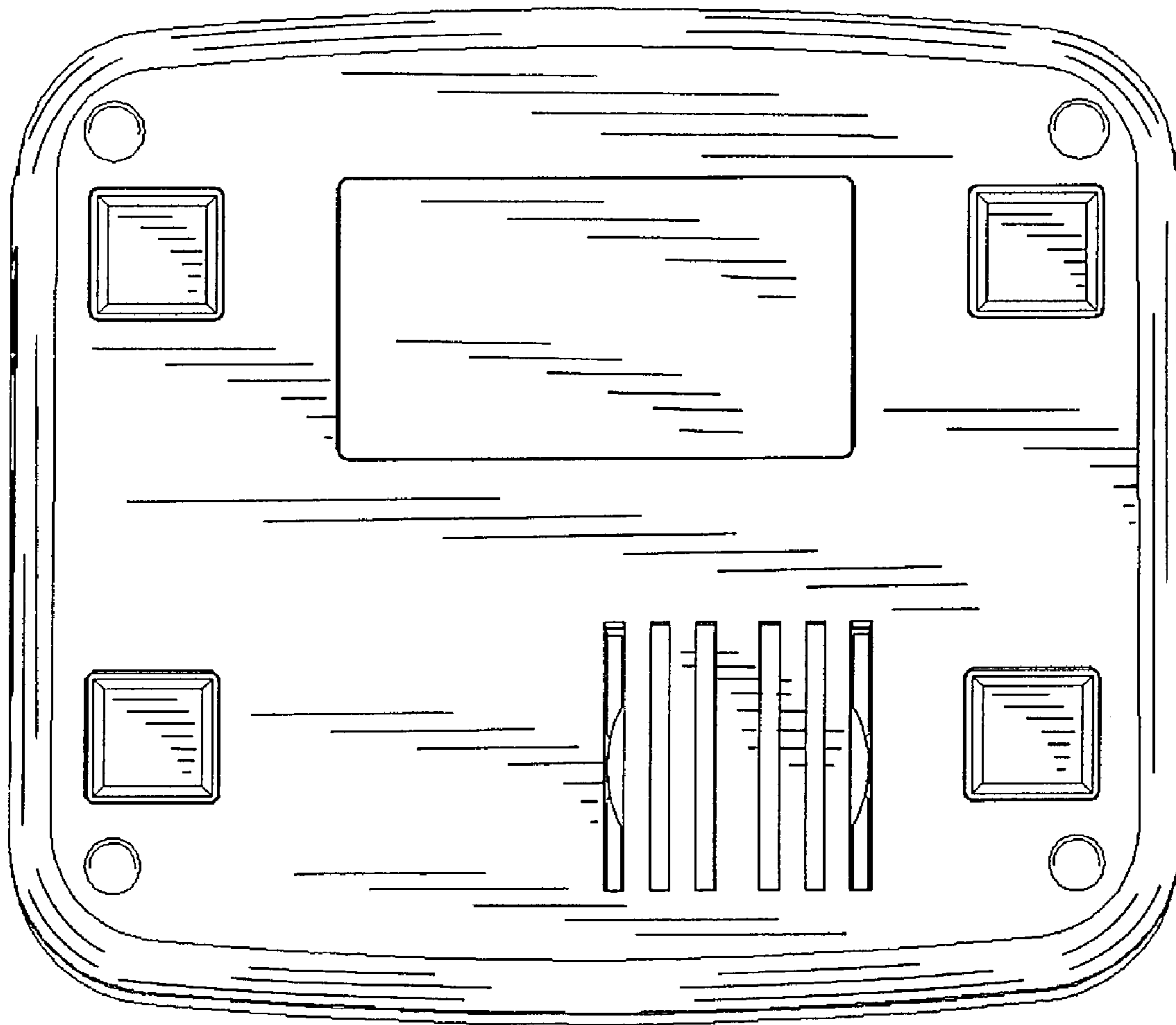

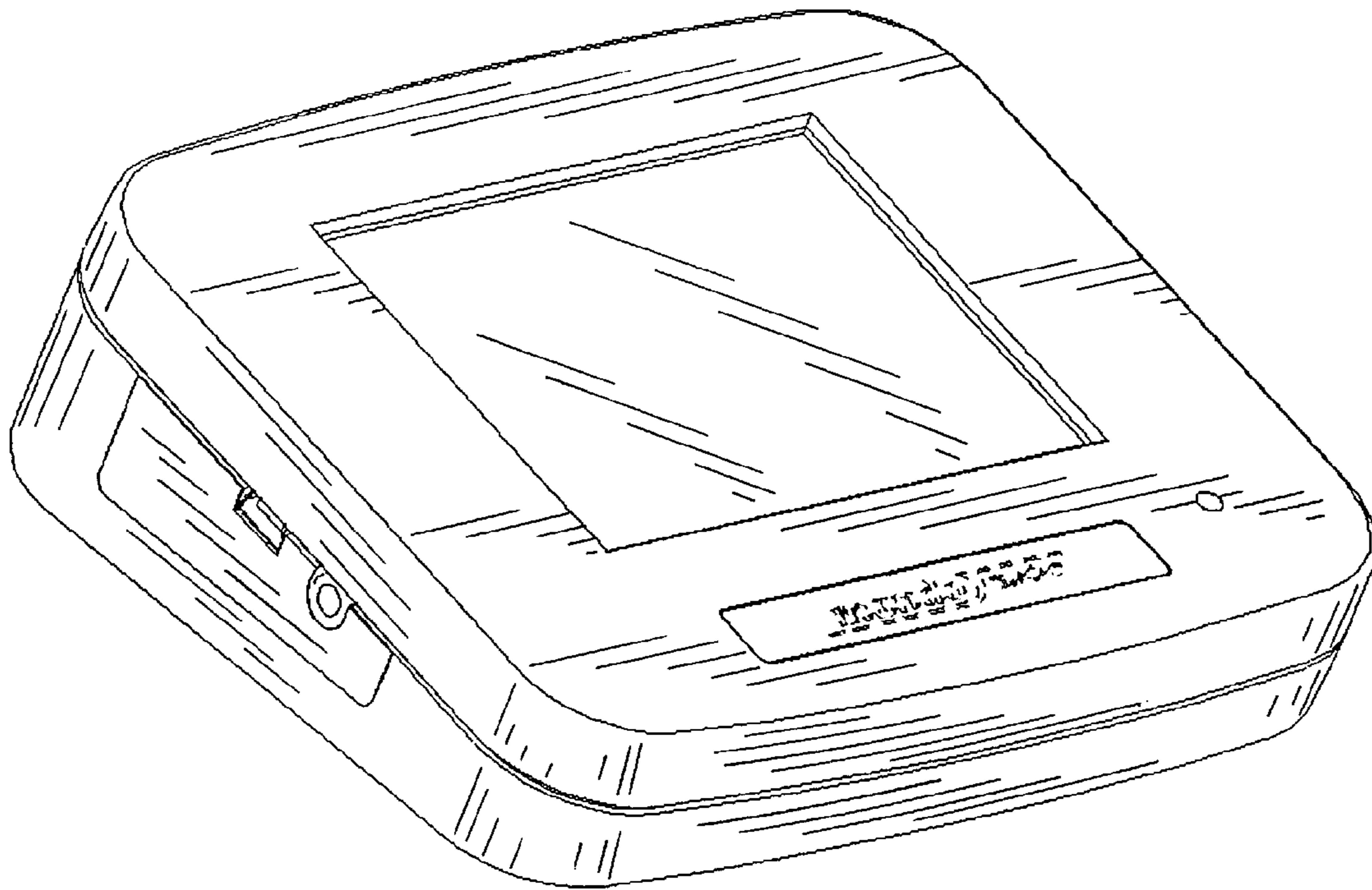
