(57) **CLAIM**

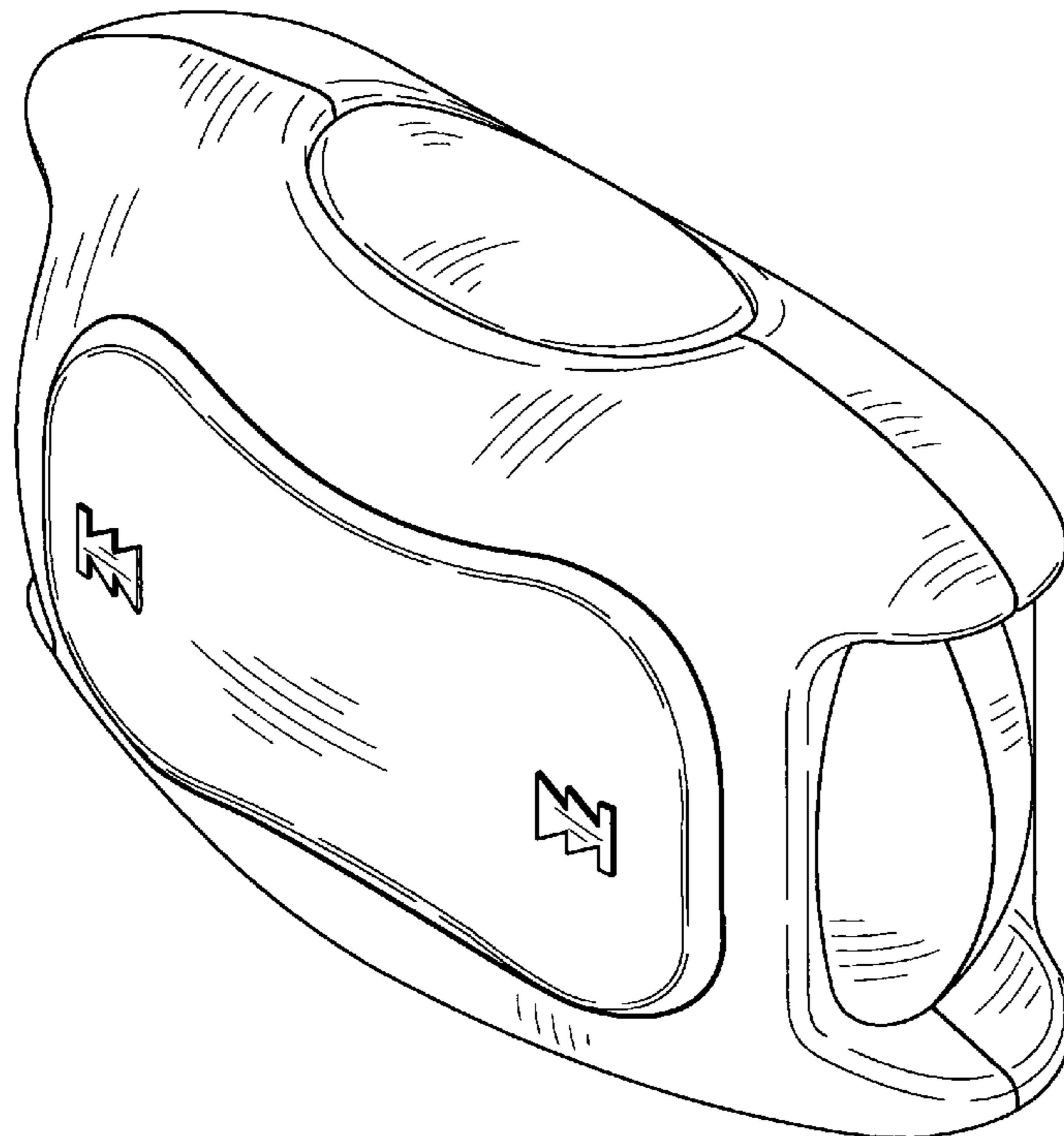
The ornamental design for a digital audio player, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the new design;

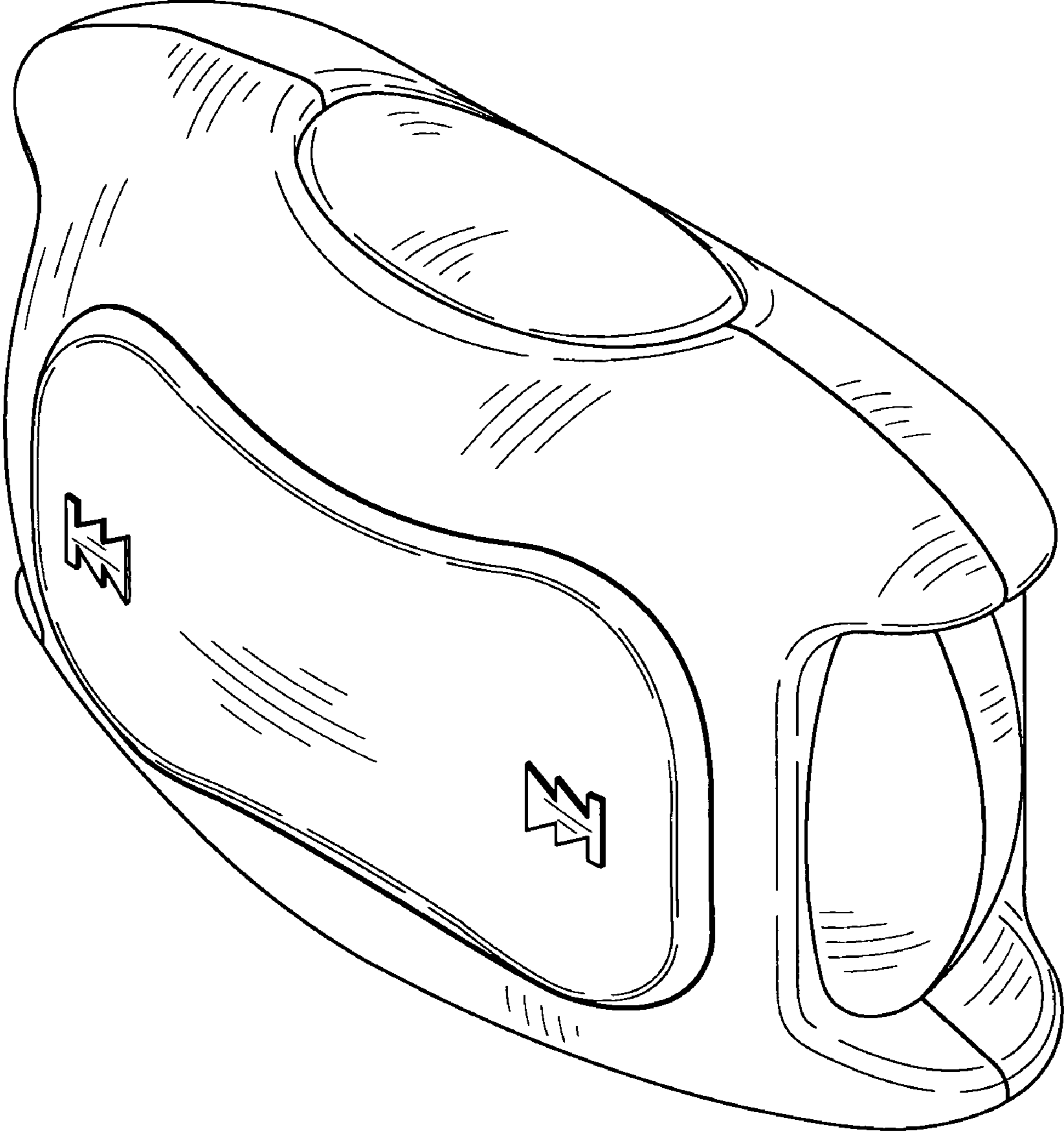

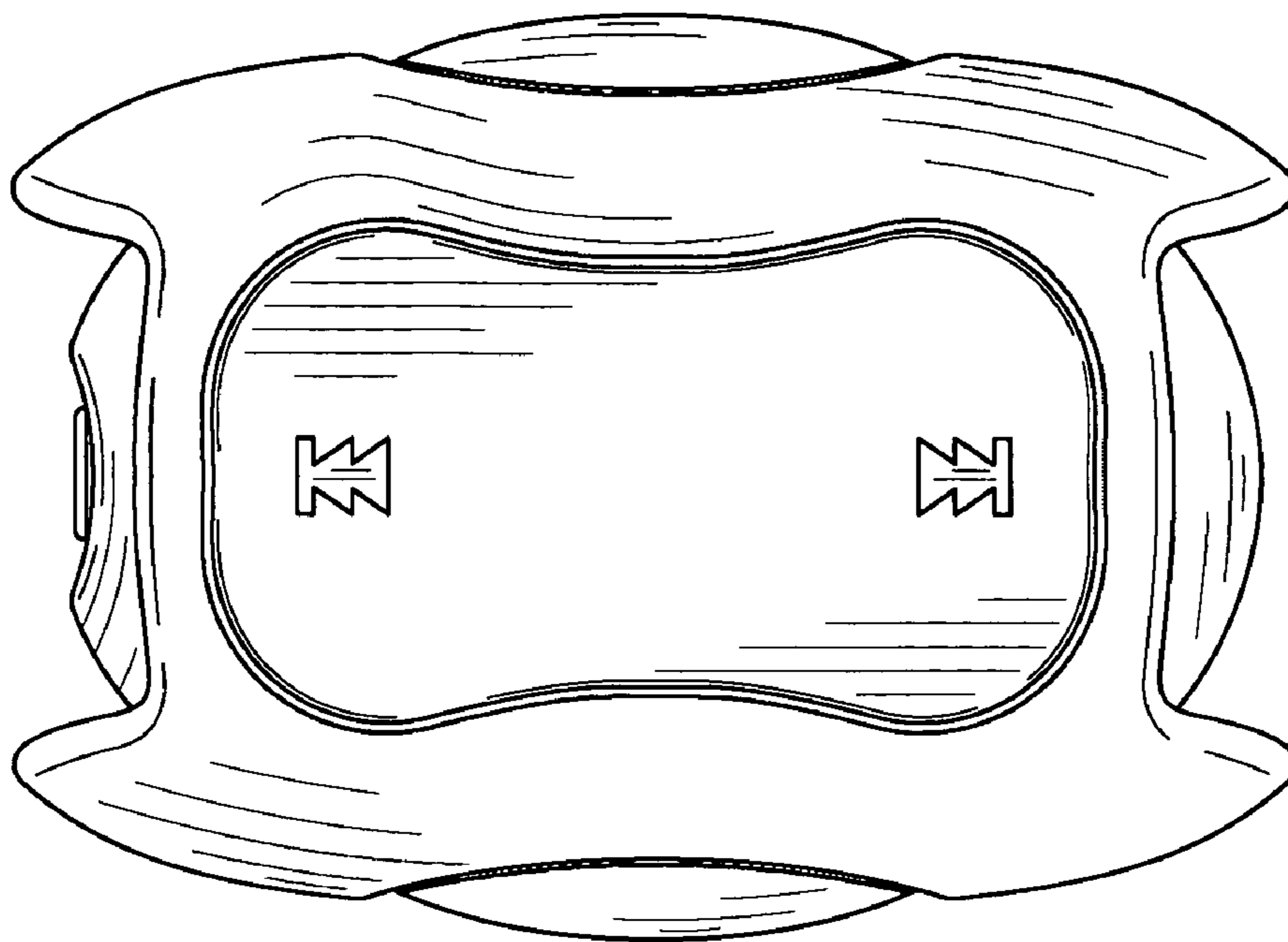

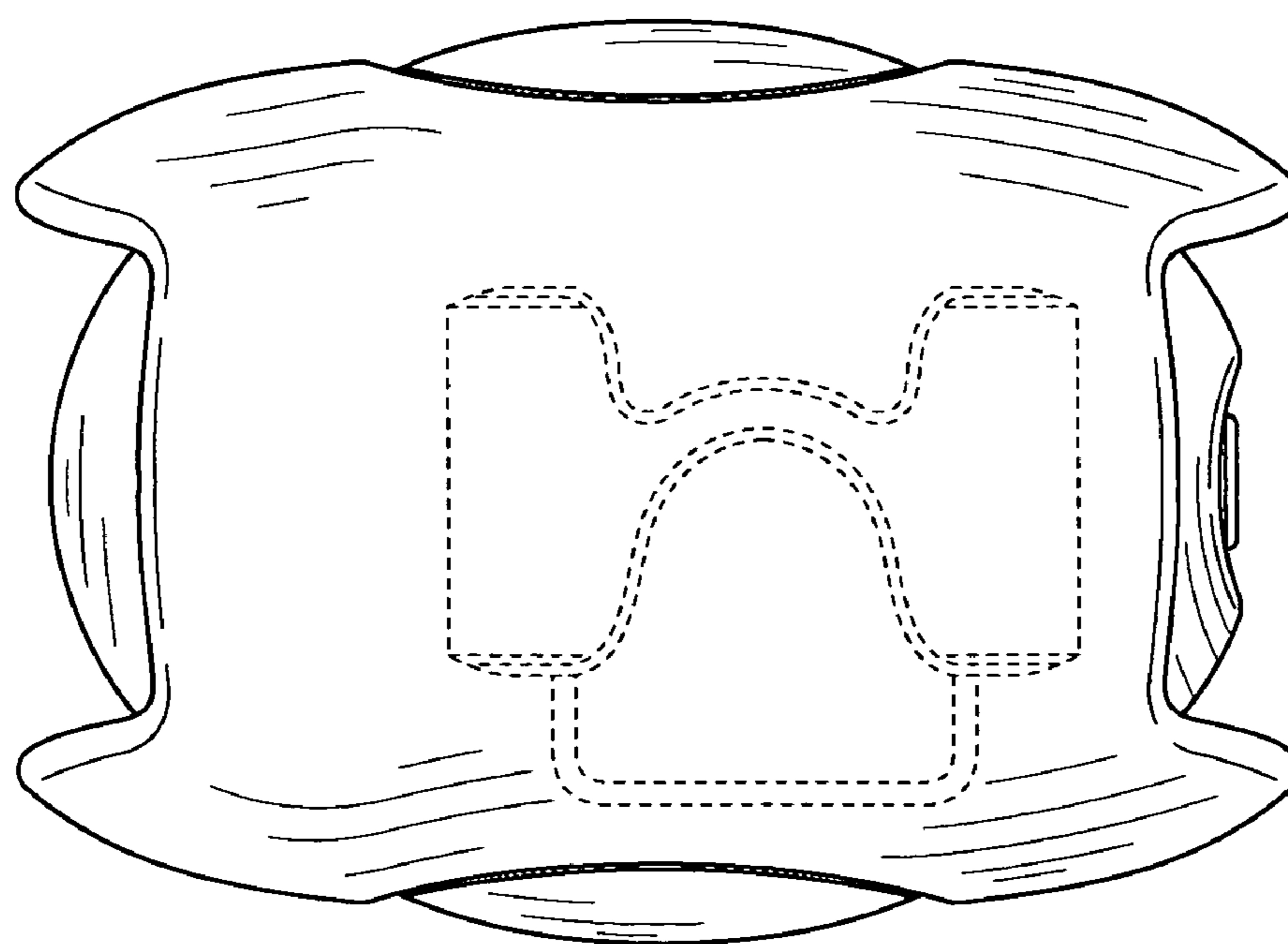

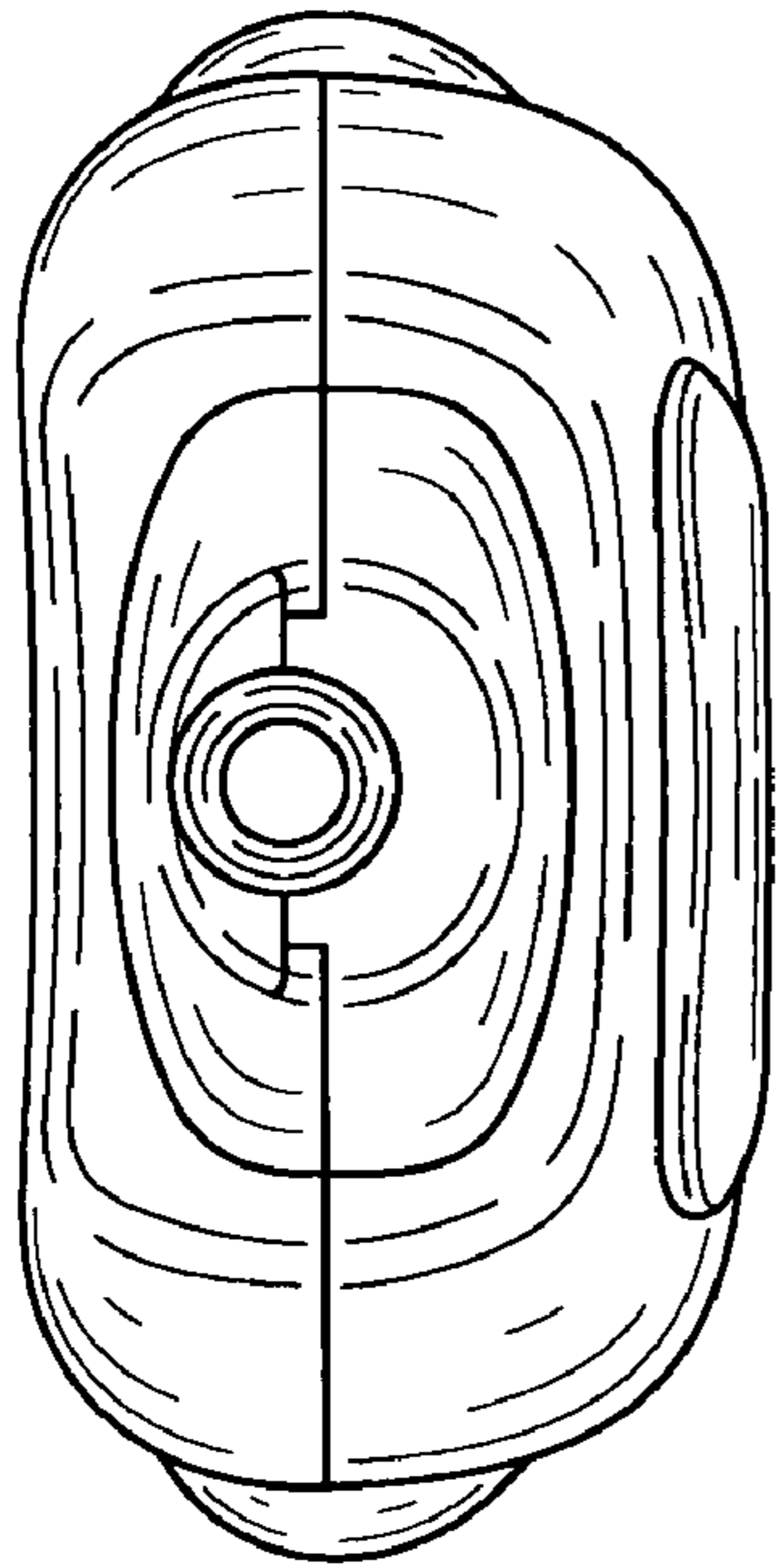

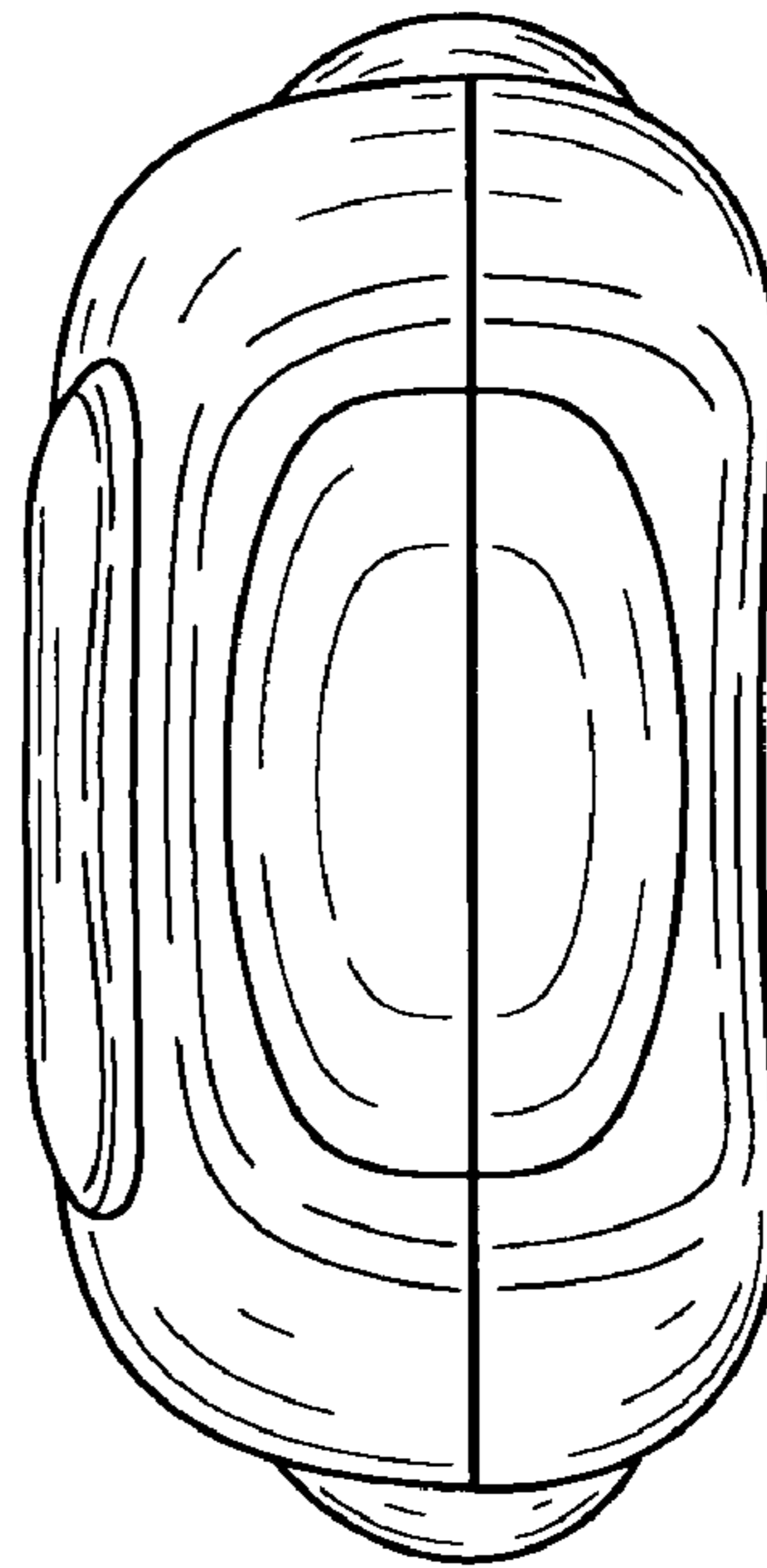

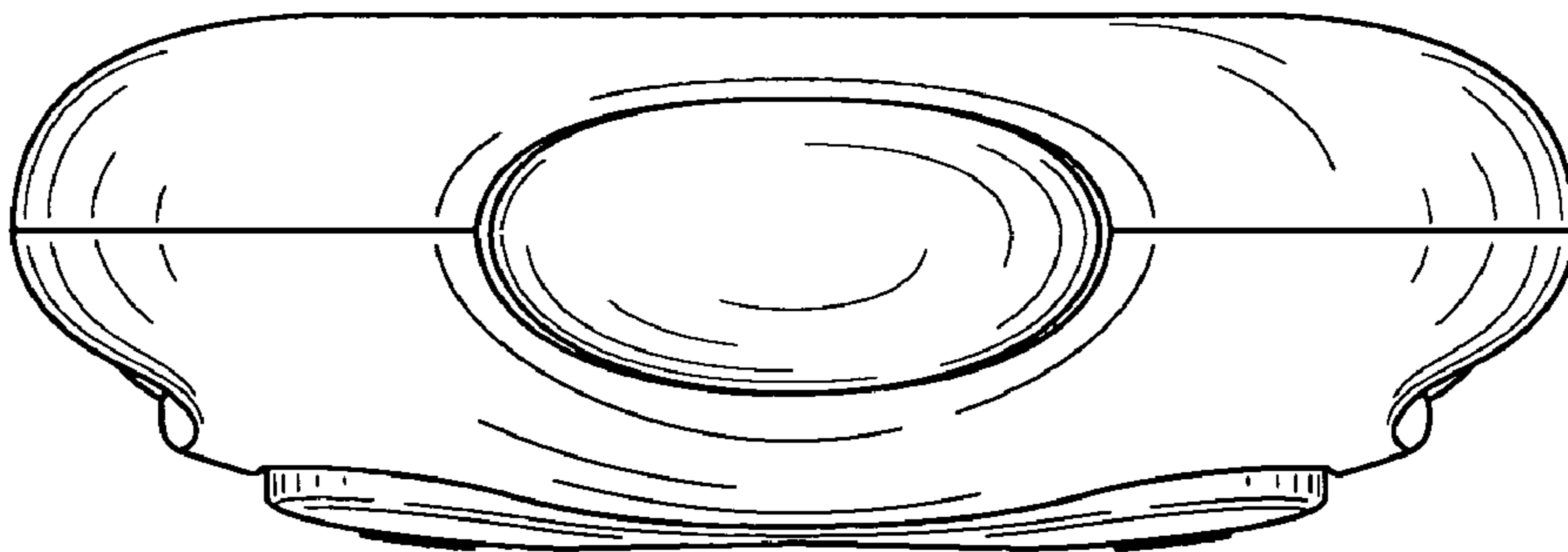

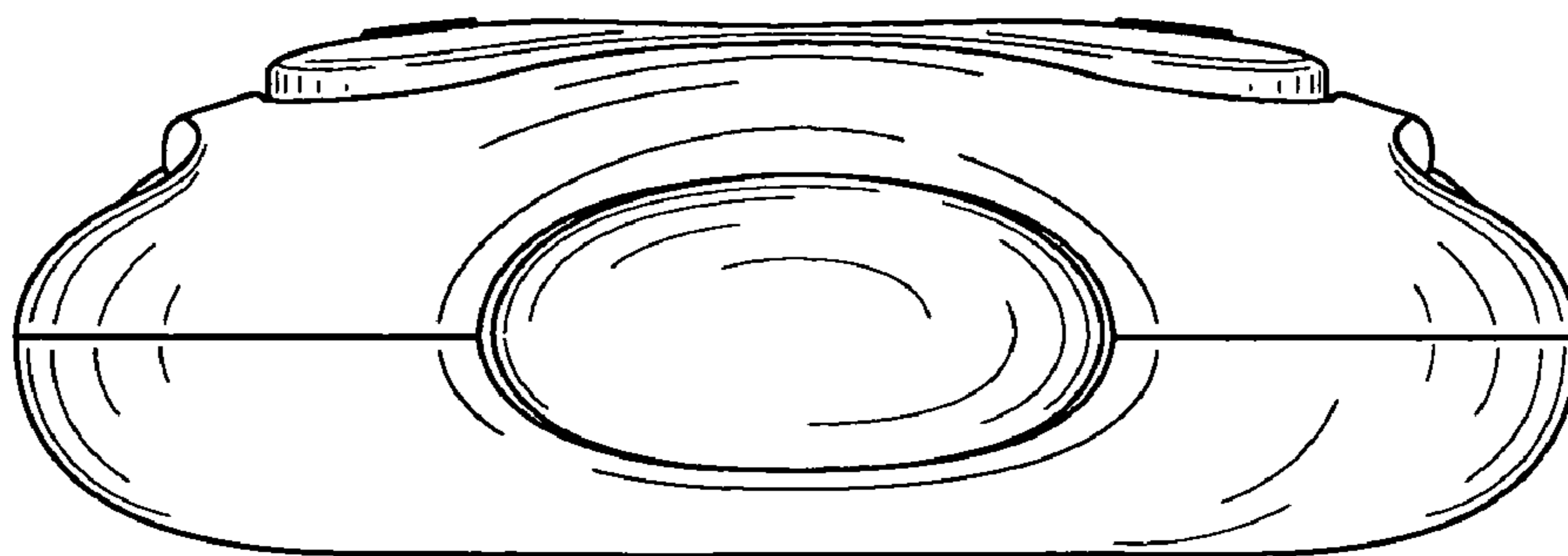
