The ornamental design for a refrigerator with knife rack, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a refrigerator with knife rack in accordance with my design;

FIG. 3 is a front elevation view of FIG. 1;

FIG. 12 is a bottom plan view of FIG. 8;

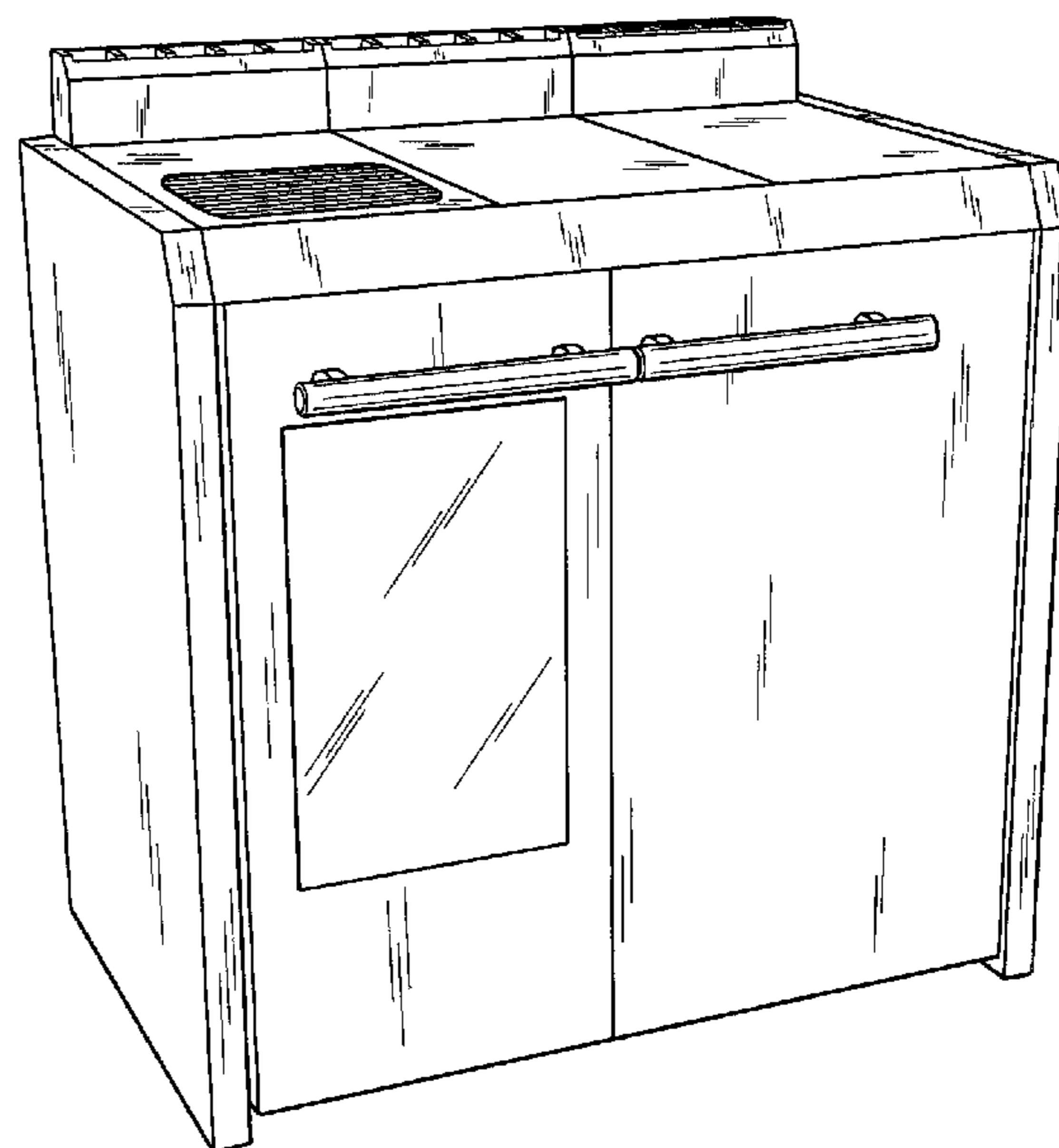
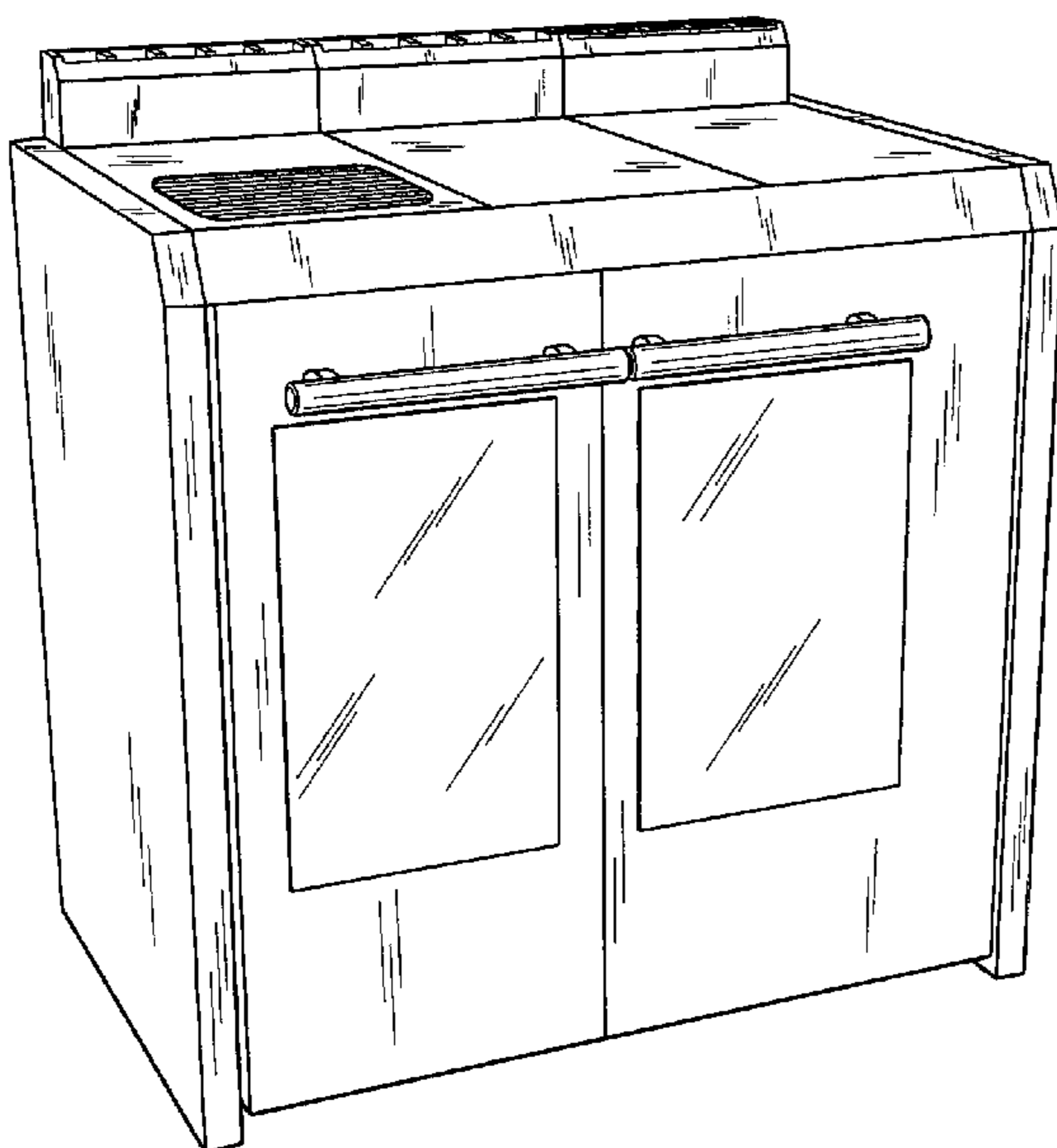
FIG. 13 is a left side elevation view of FIG. 8; and

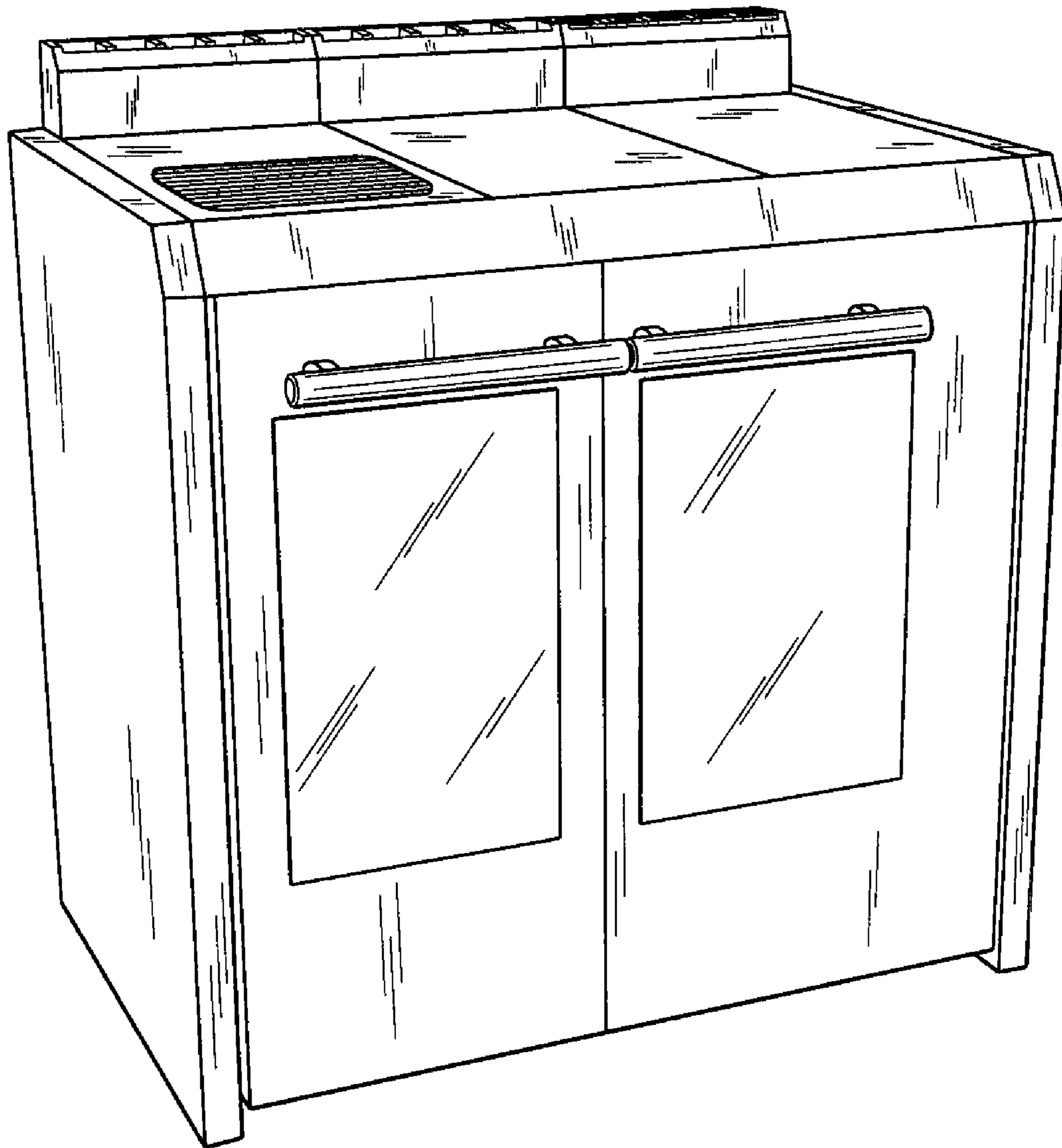

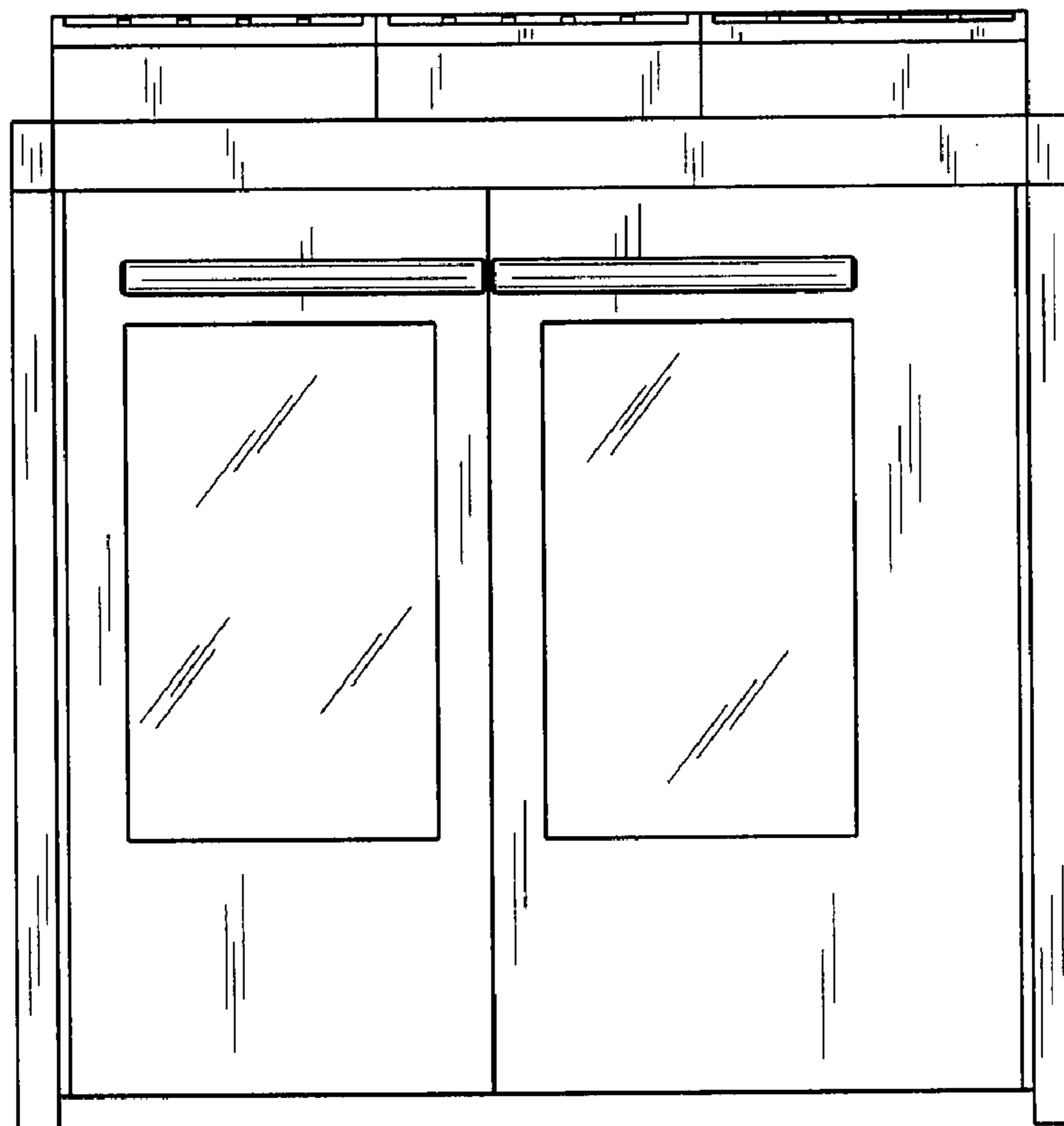
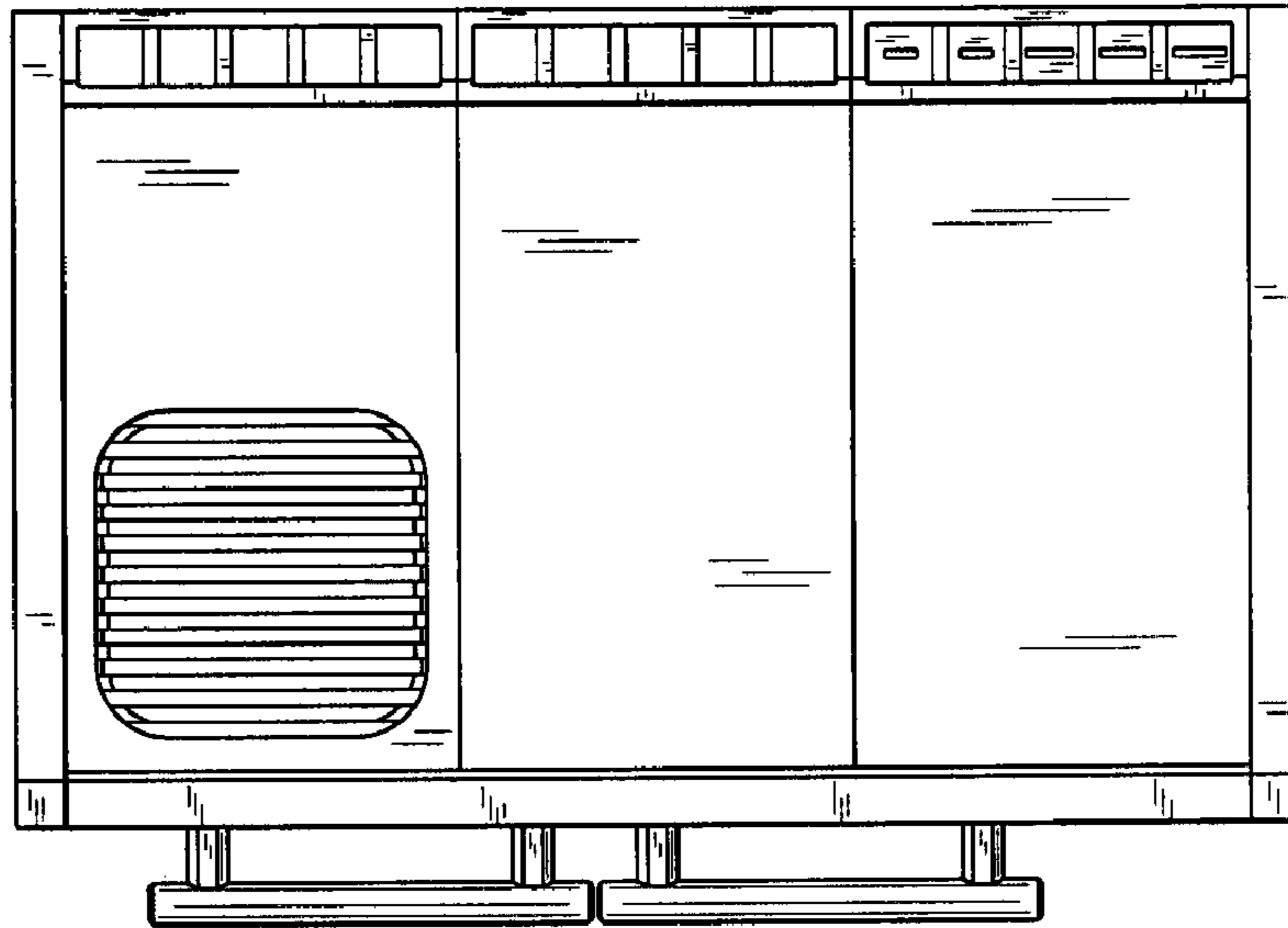

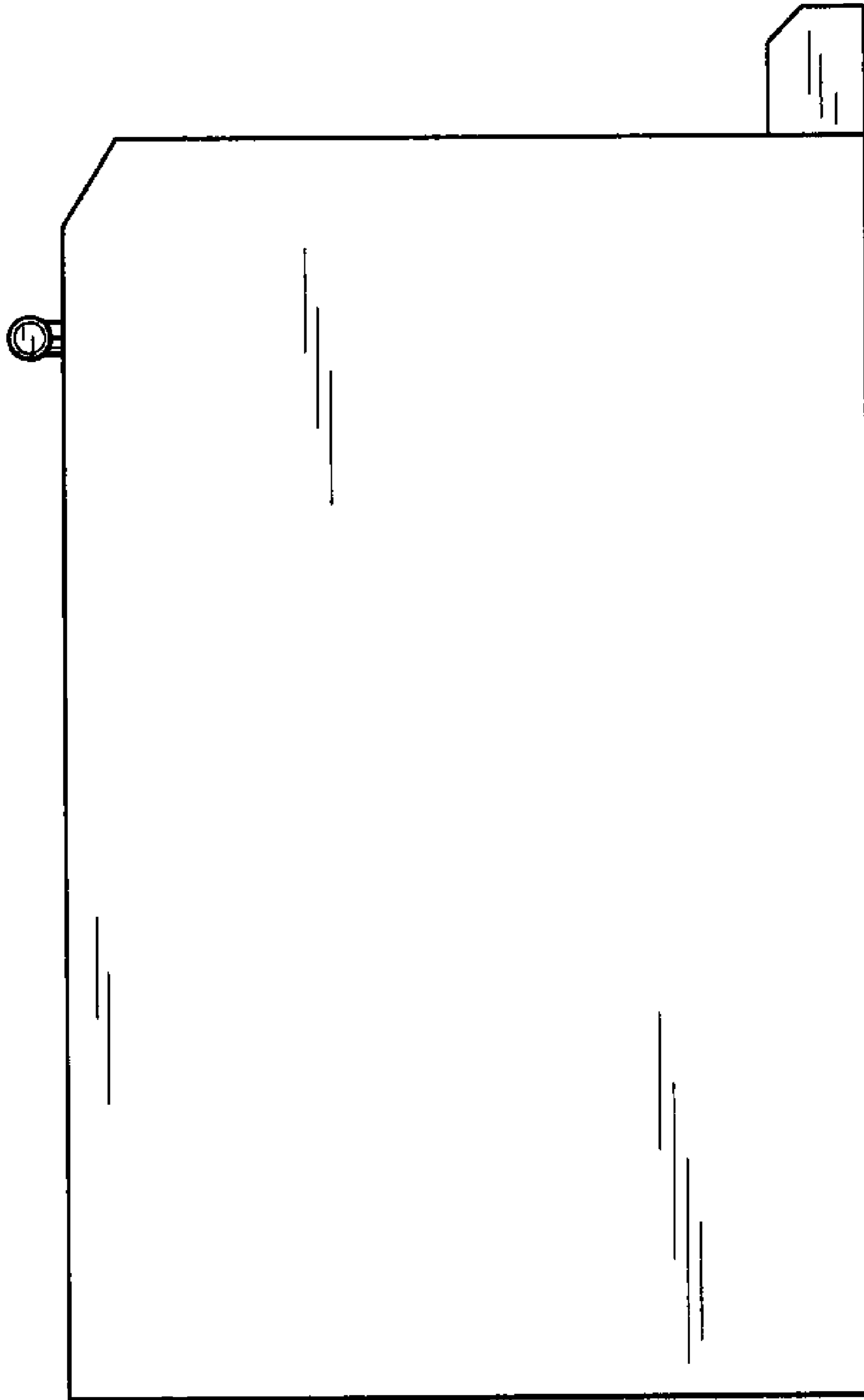

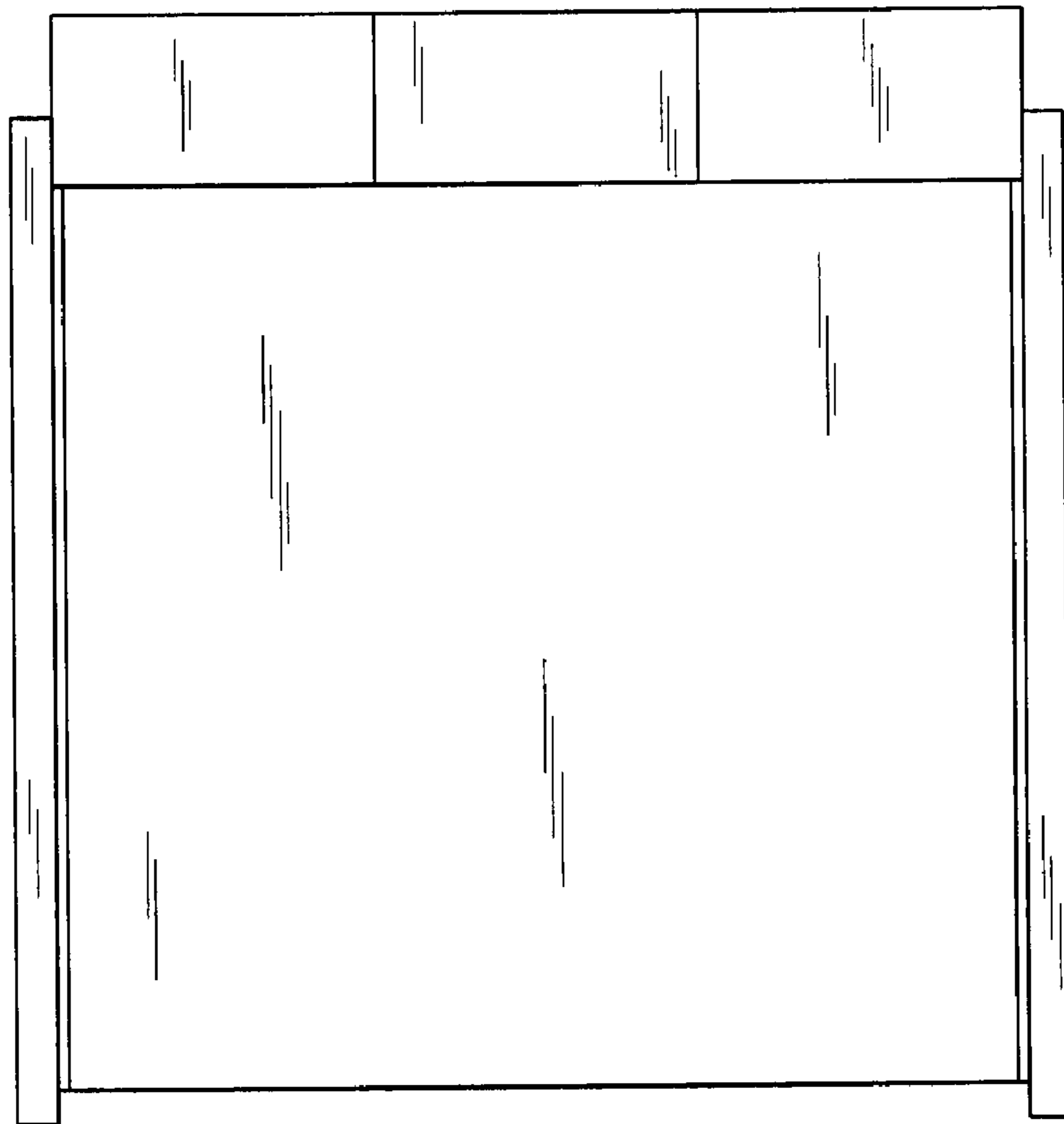
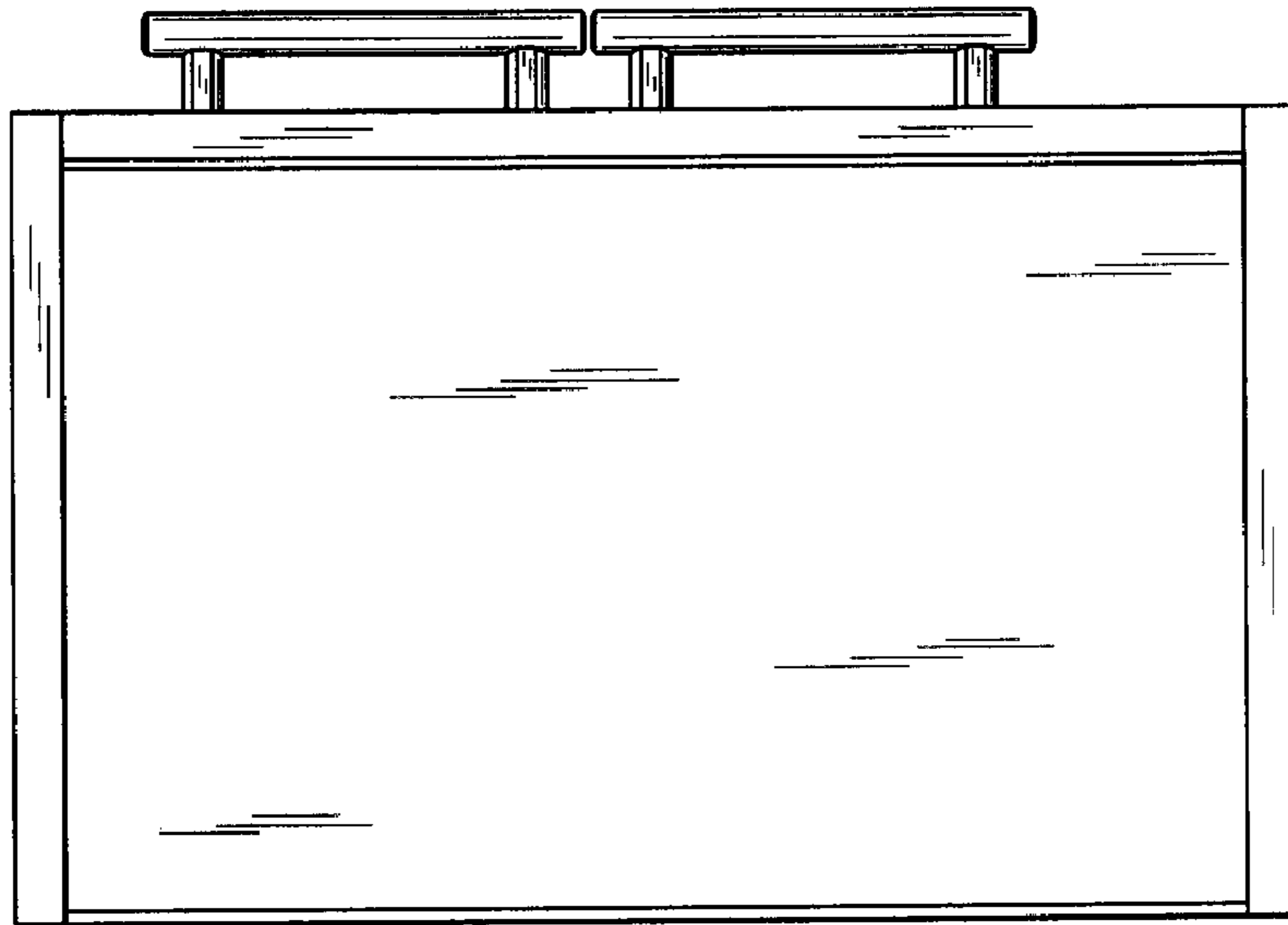

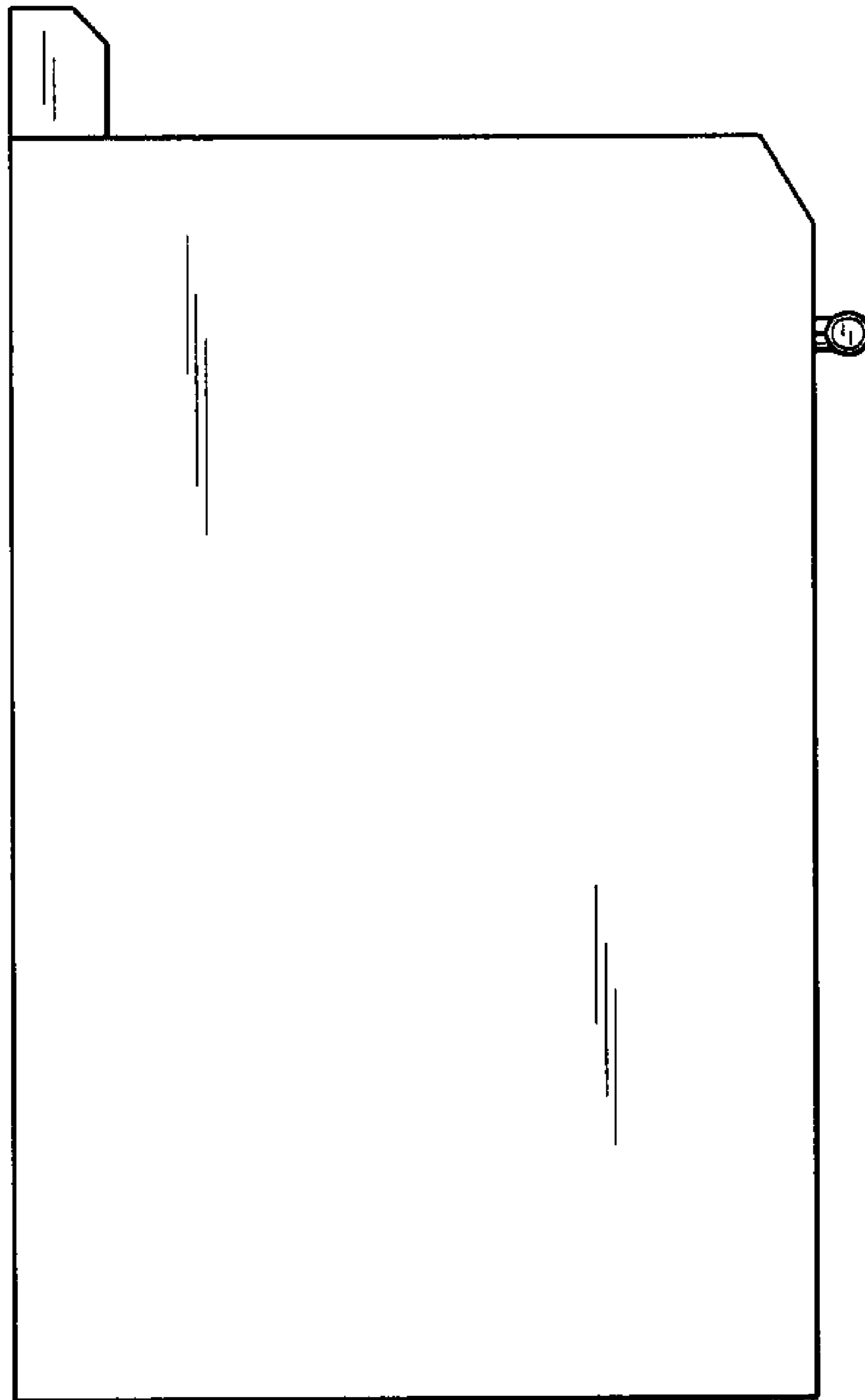

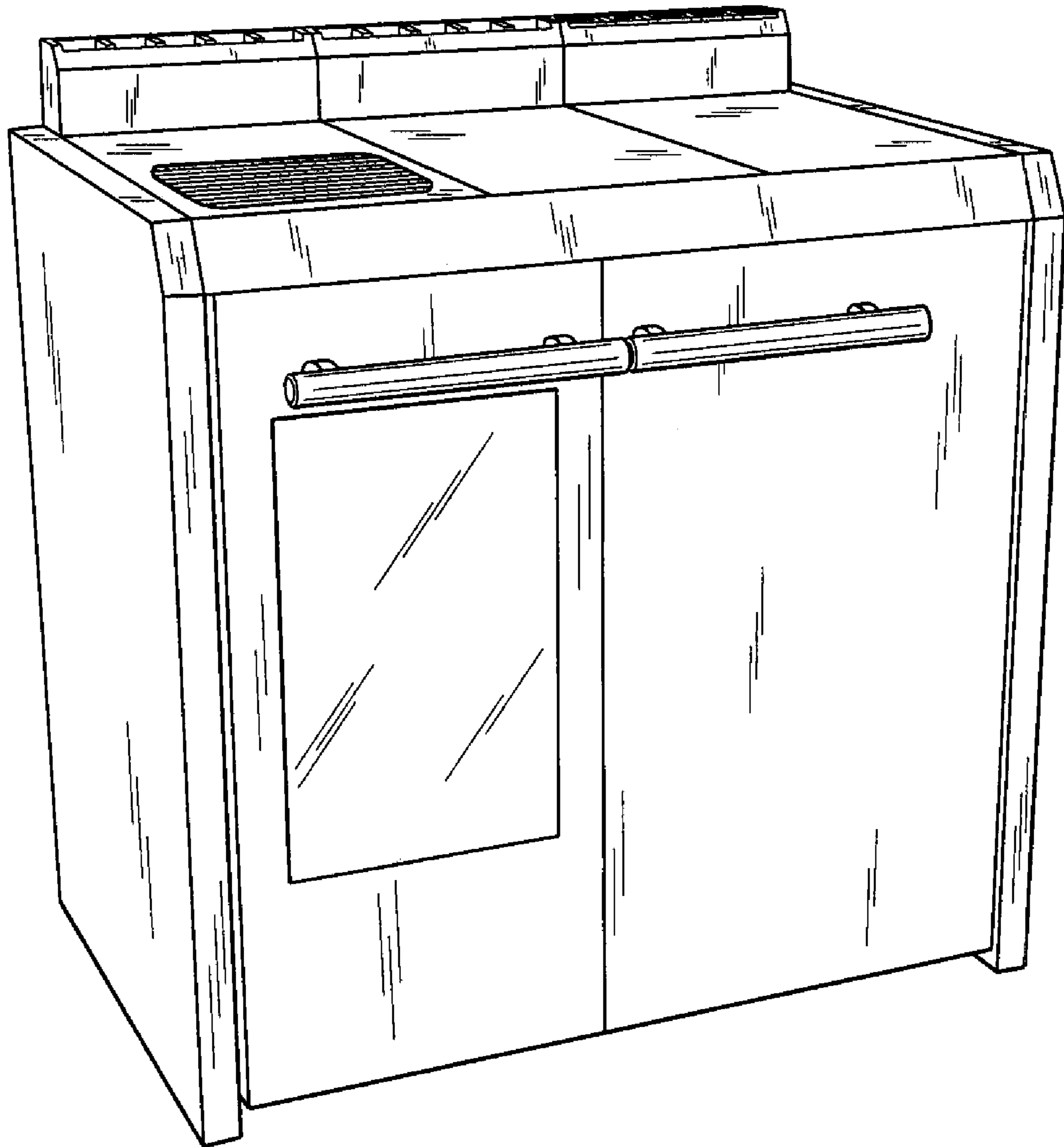

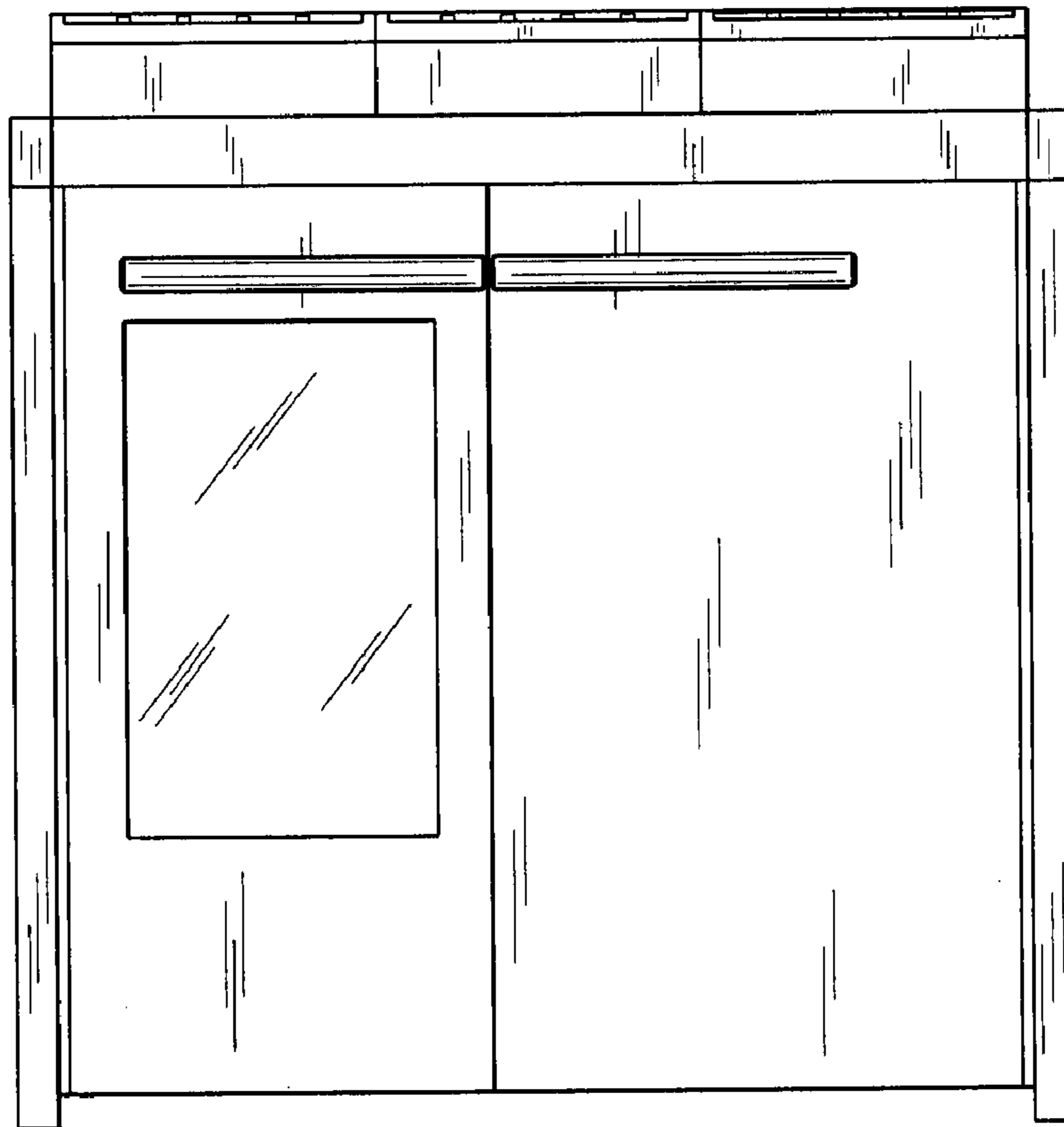
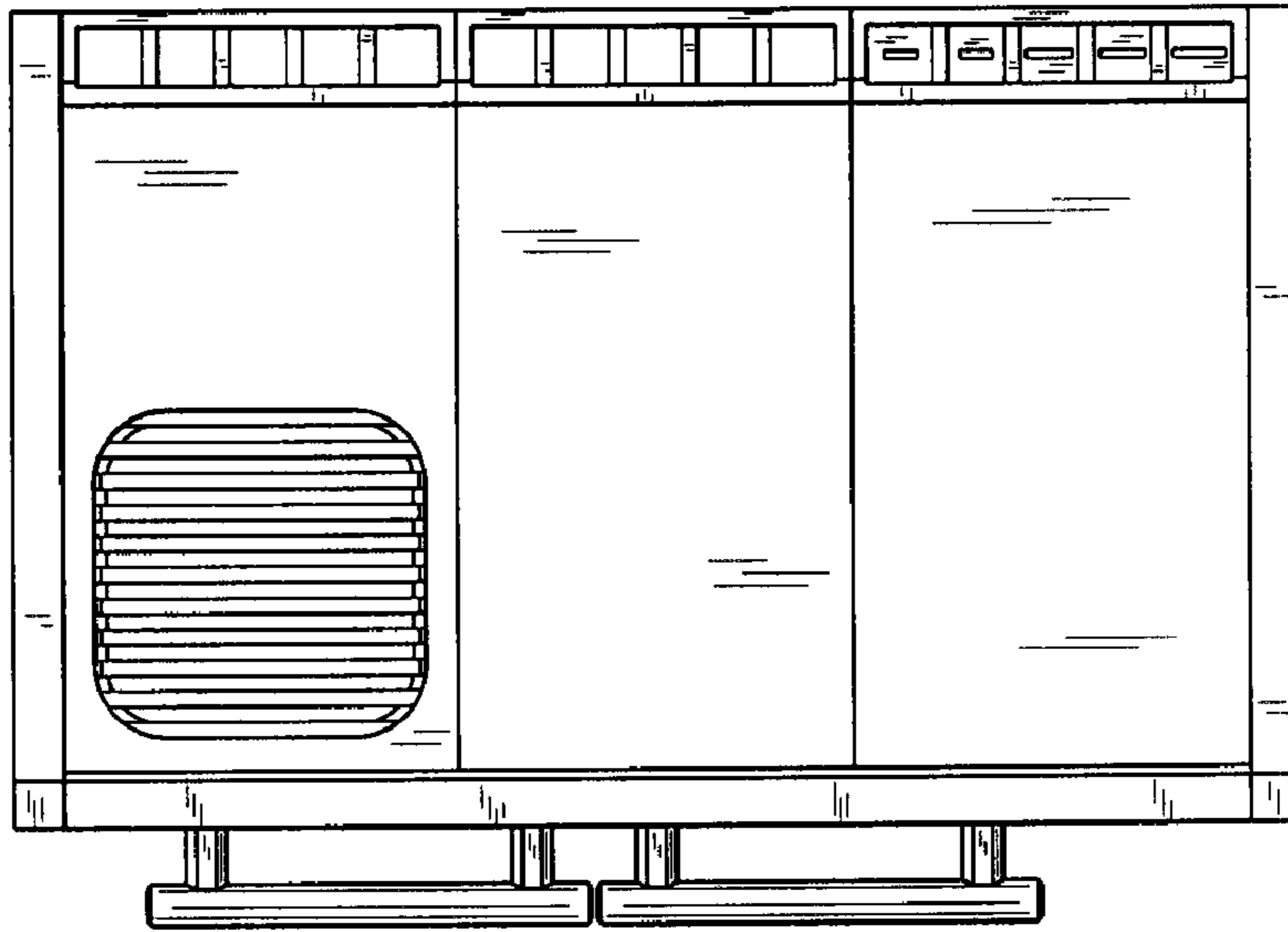

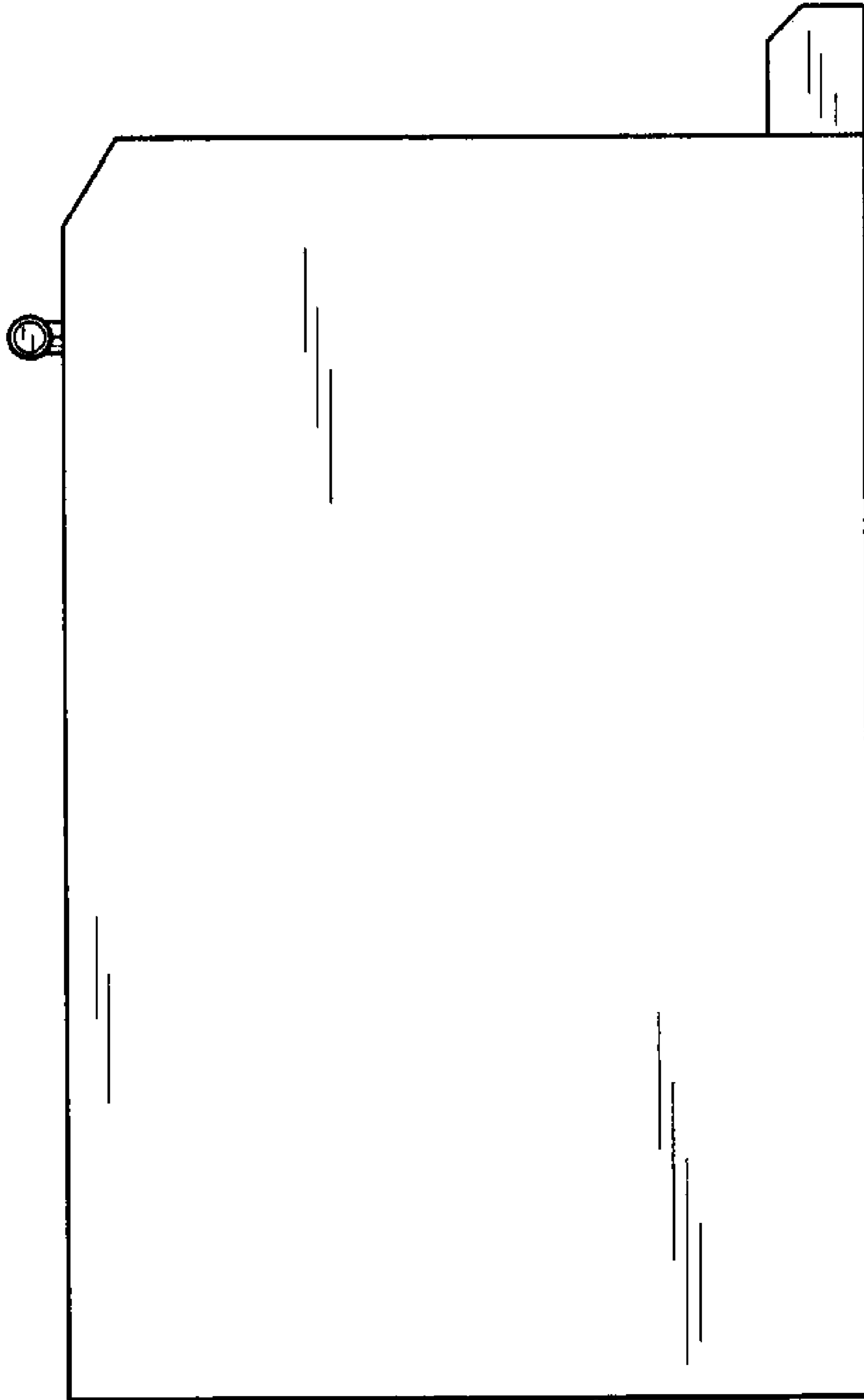

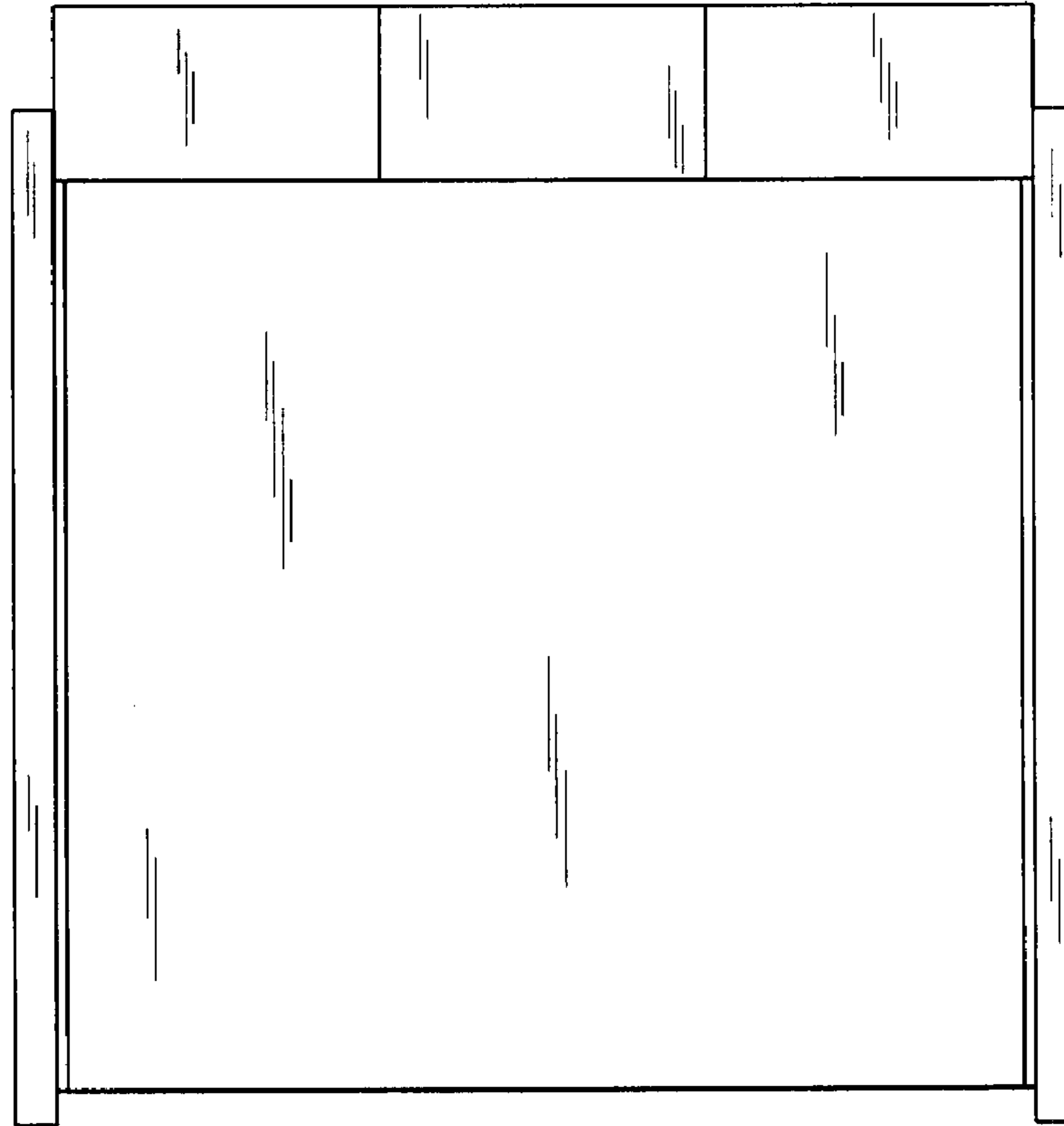
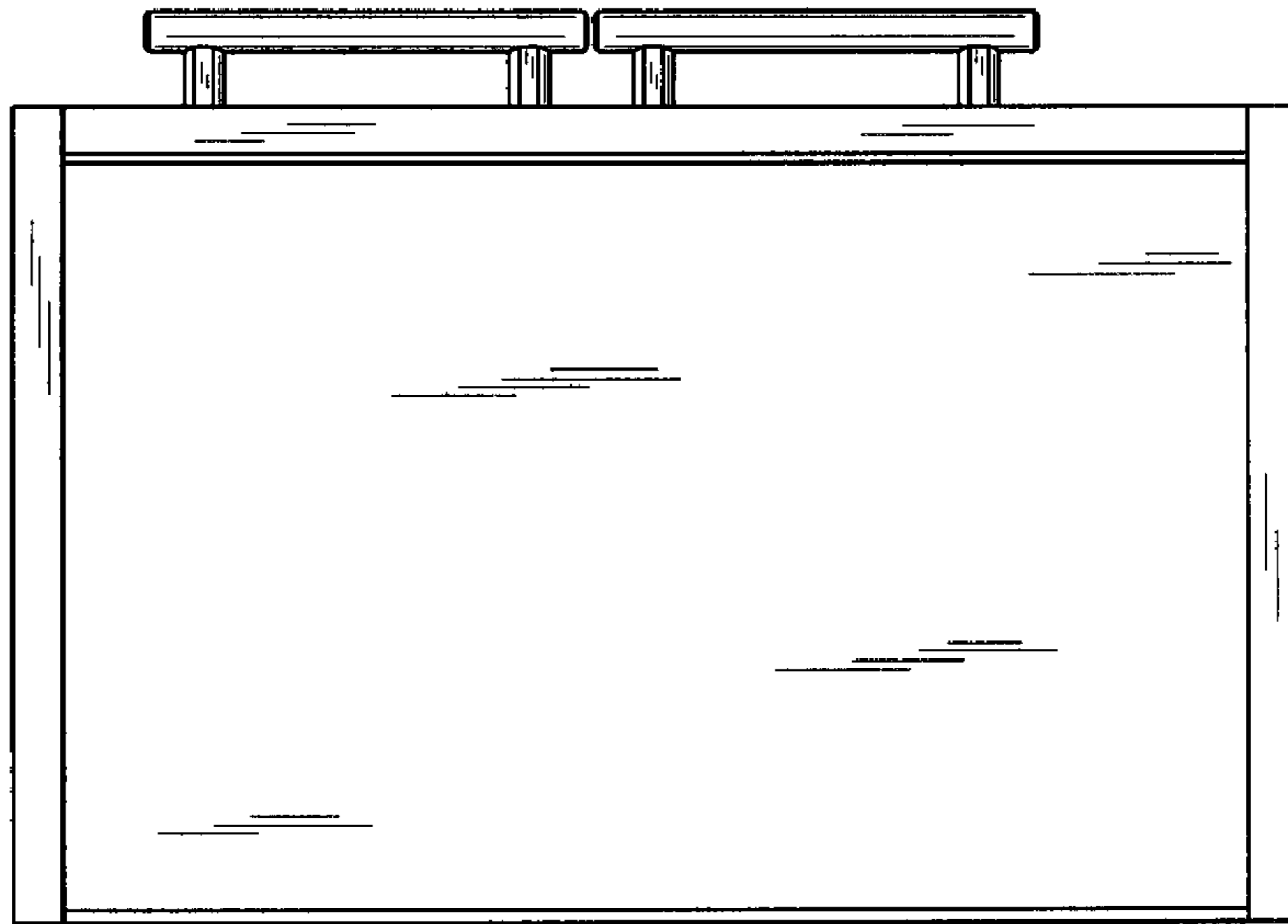

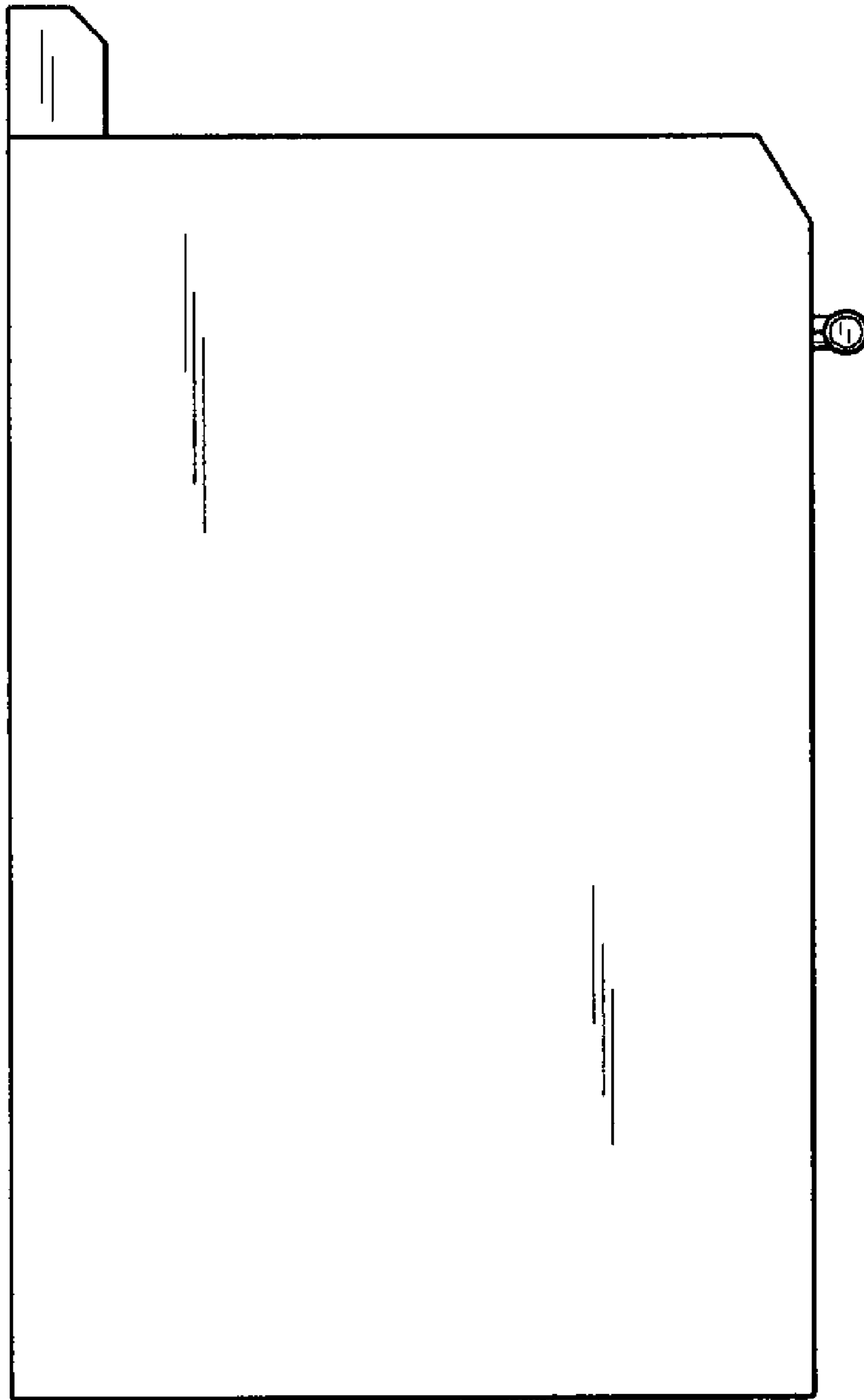

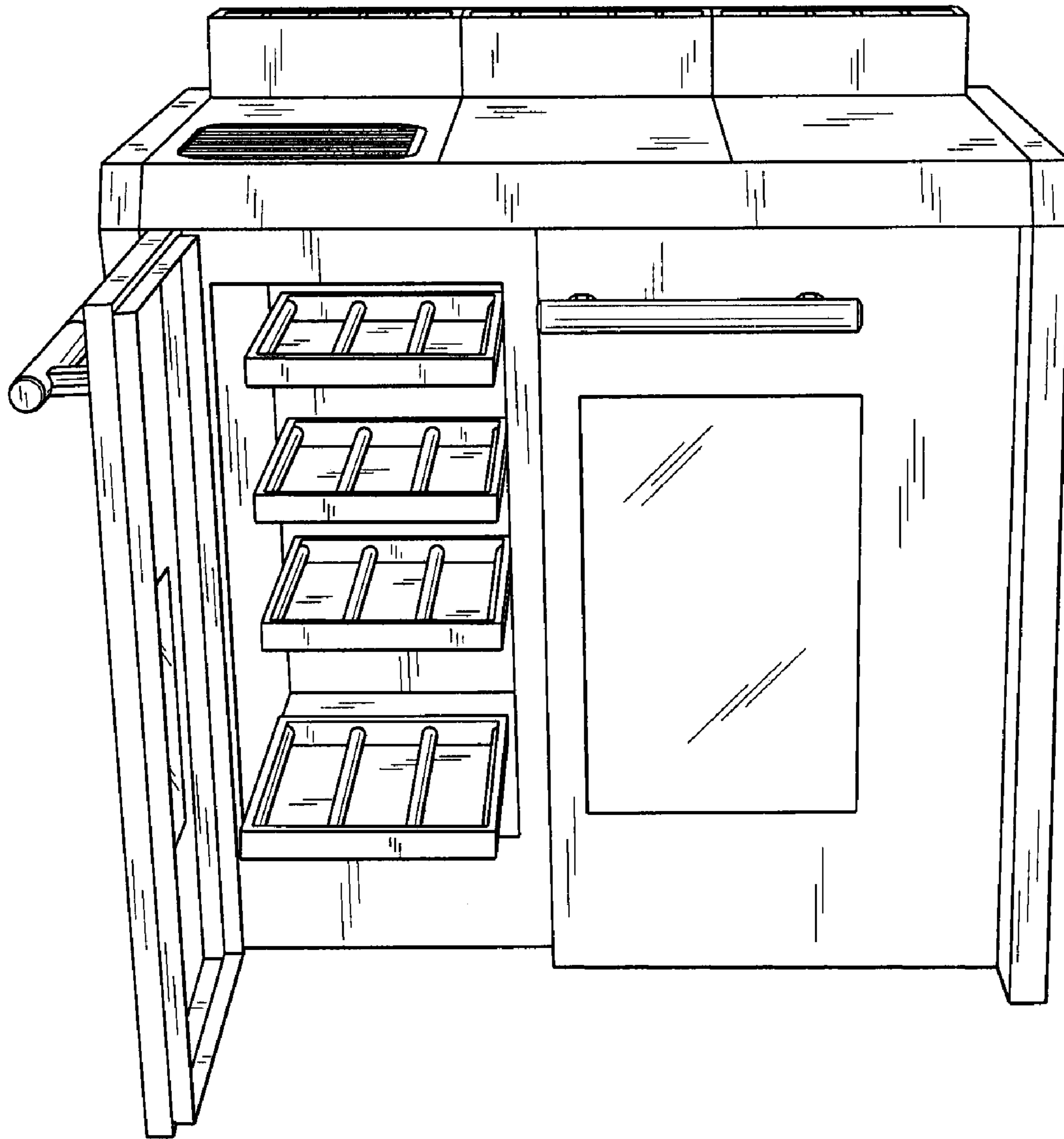

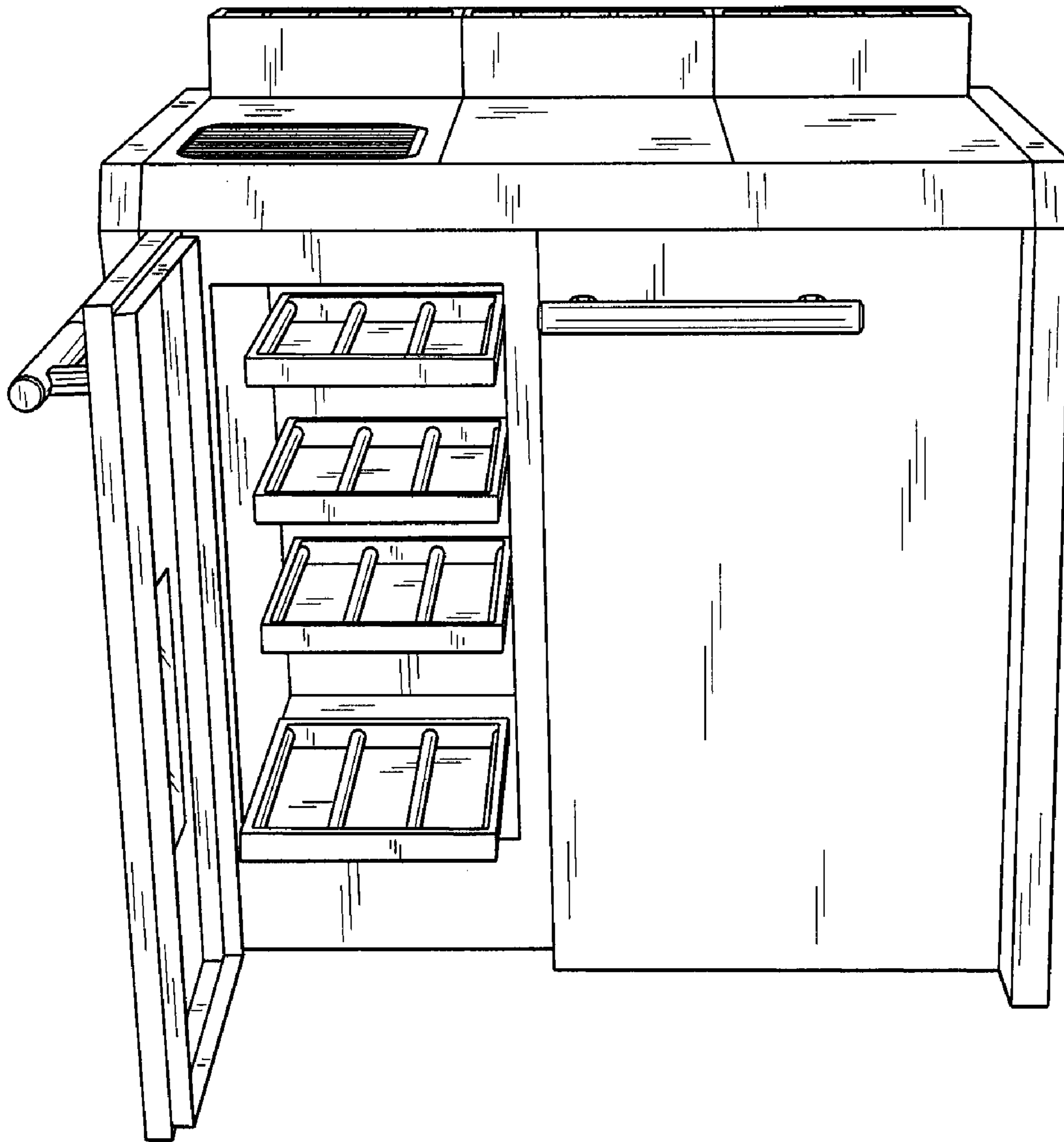
