DESCRIPTION

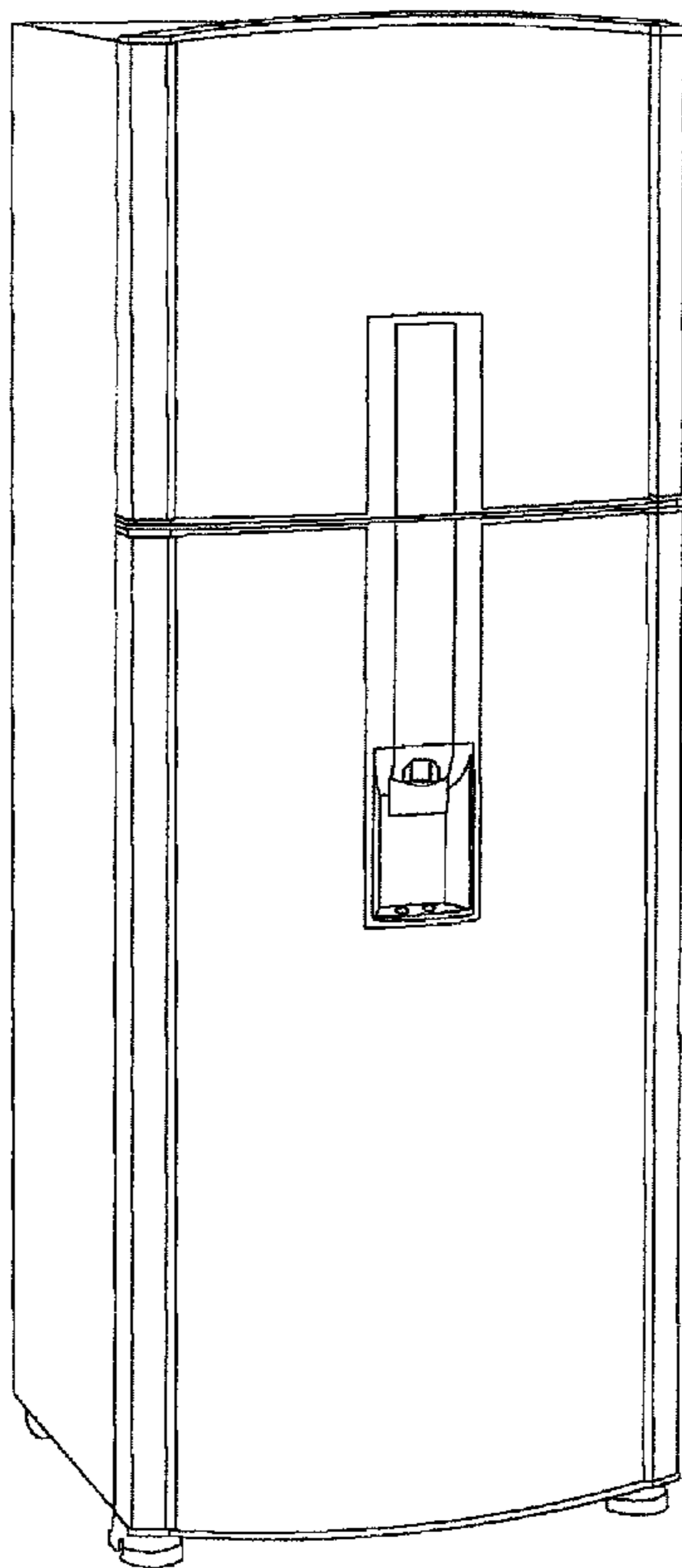
FIG. 1 is a perspective view of a refrigerator, in accordance with the present invention.

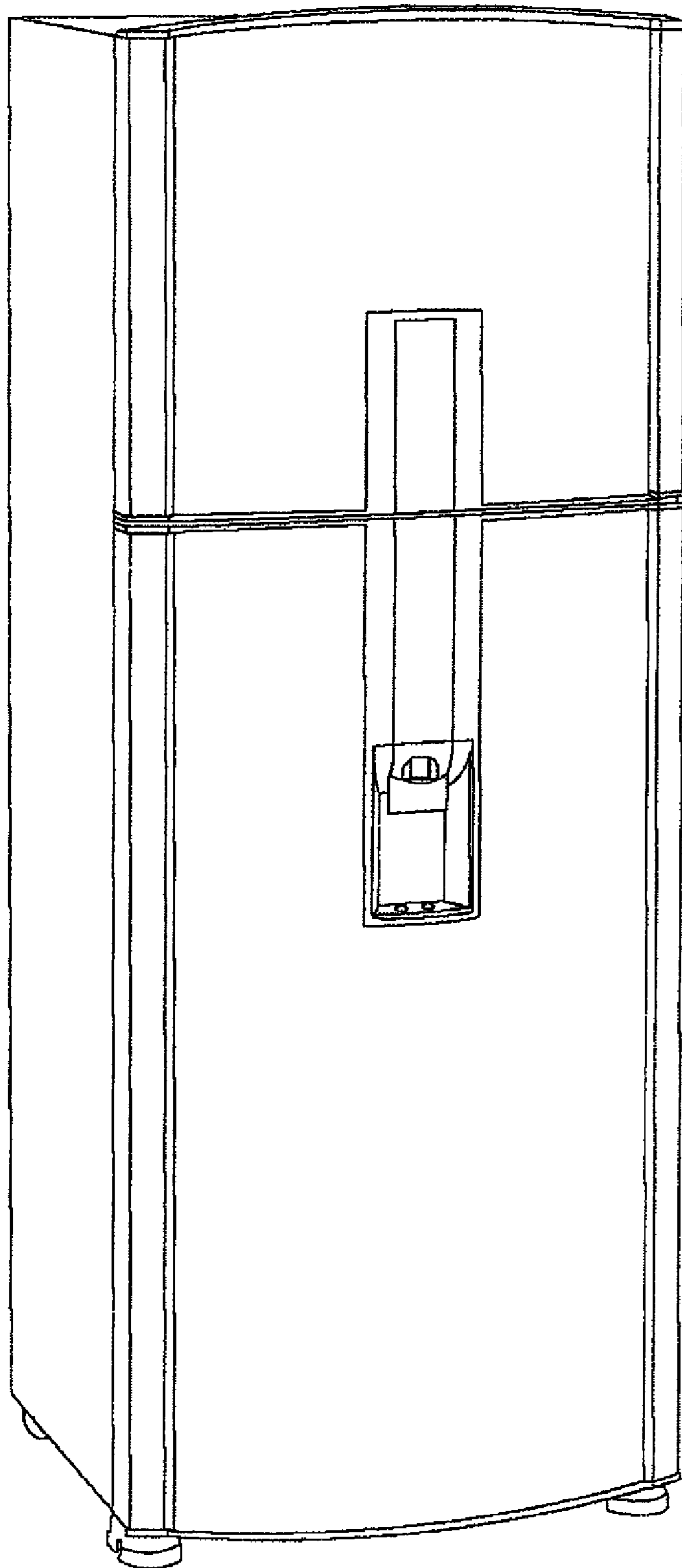

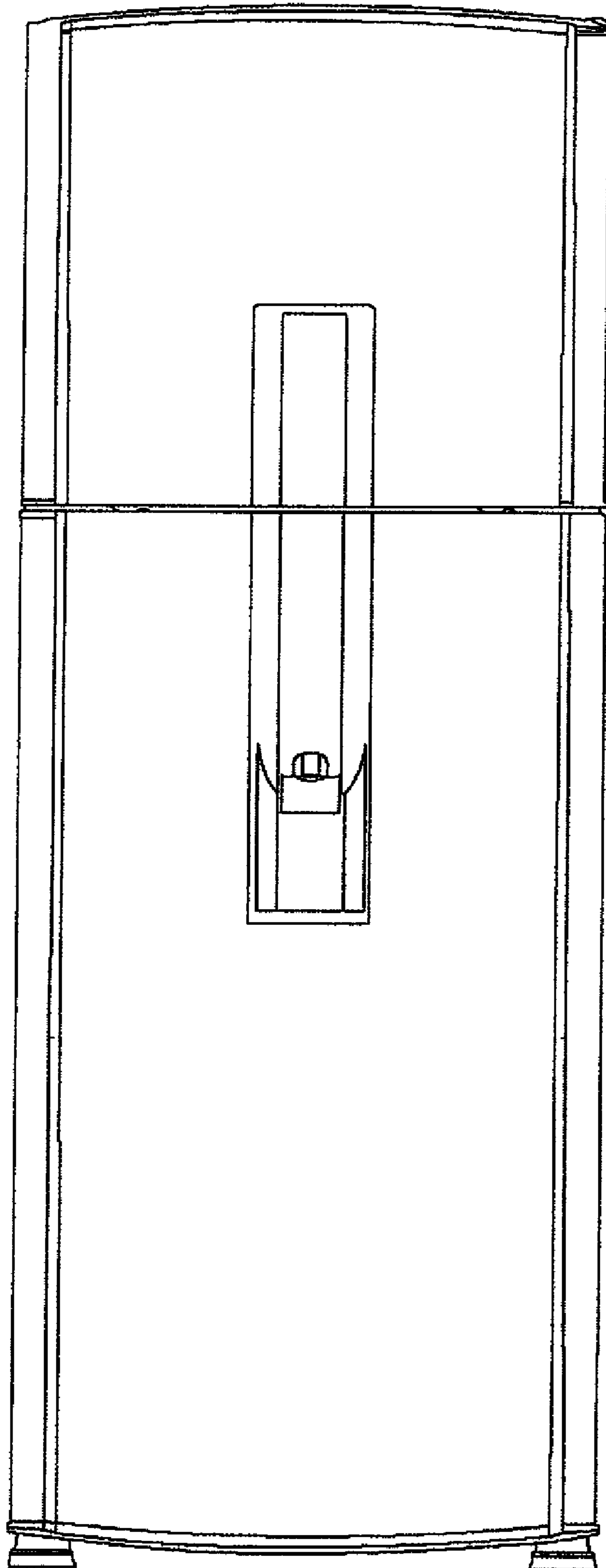

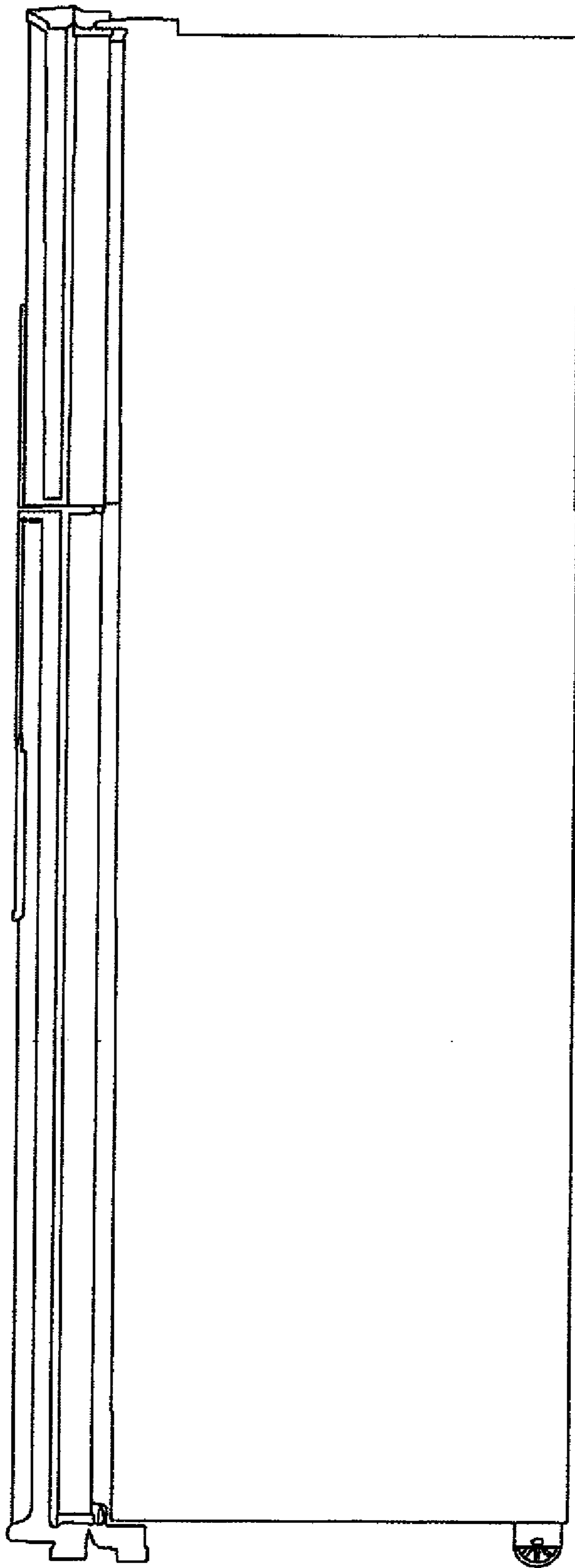

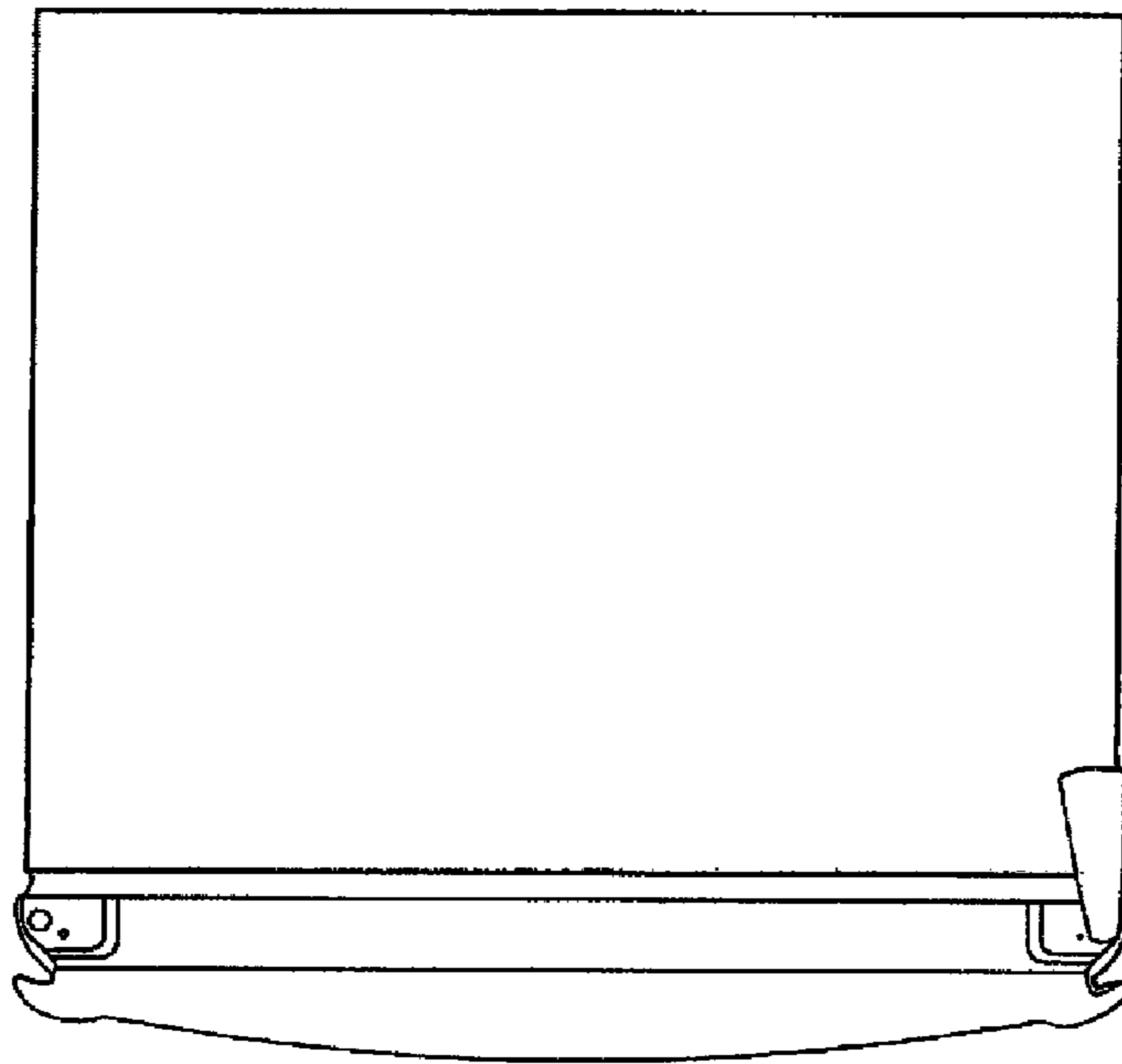
