(57) **CLAIM**

The ornamental design for a lavatory, as shown and described.

DESCRIPTION

In a preferred embodiment, the nature of this product is as a plumbing fixture in the form of a lavatory which is primarily useful for washing various items and the body parts of humans.

FIG. 1 is a top, left, front perspective view of a lavatory embodying our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof, the right side elevational view thereof being a mirror image of the left side shown;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is sectional view taken along line 7—7 of FIG. 2.

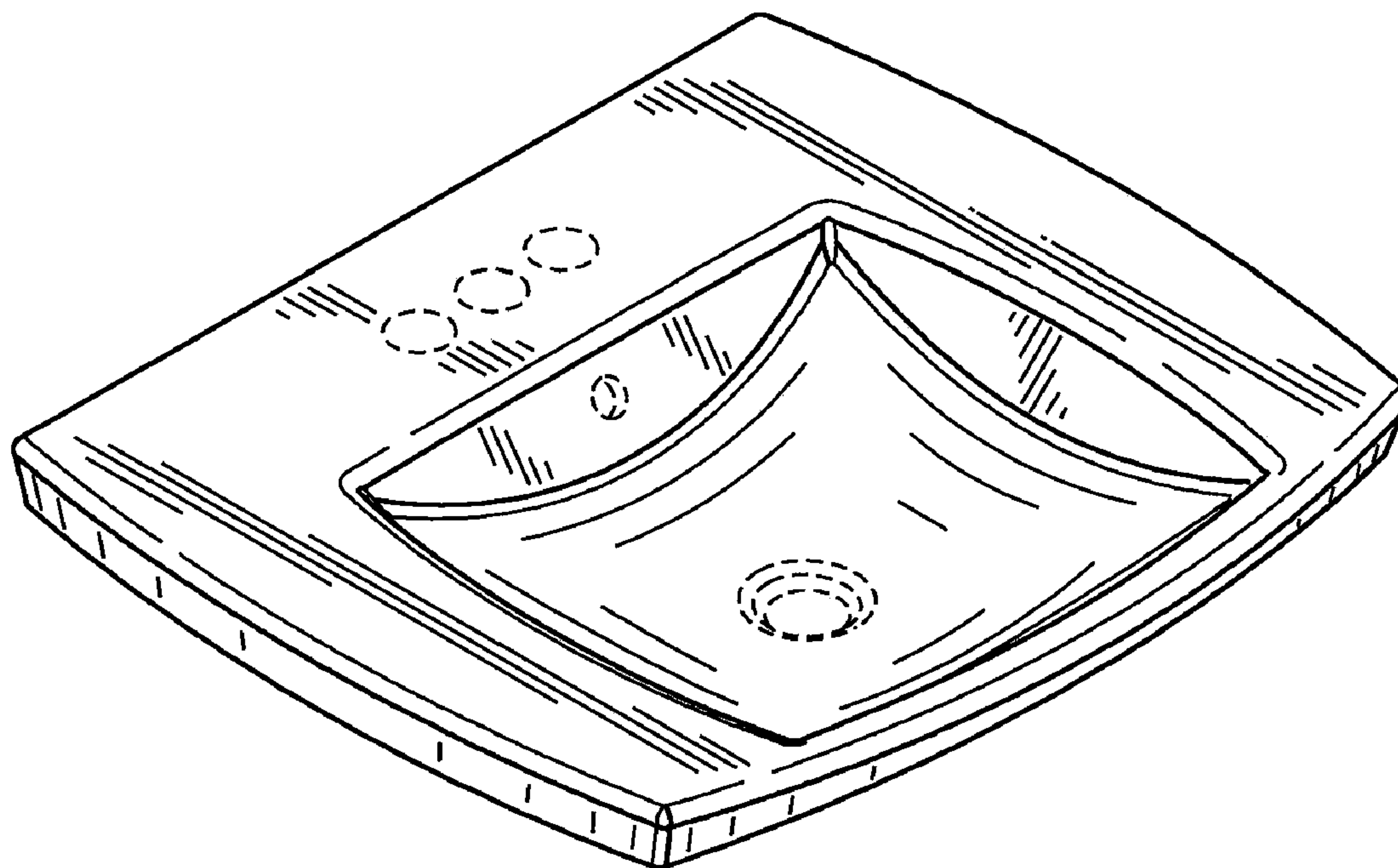

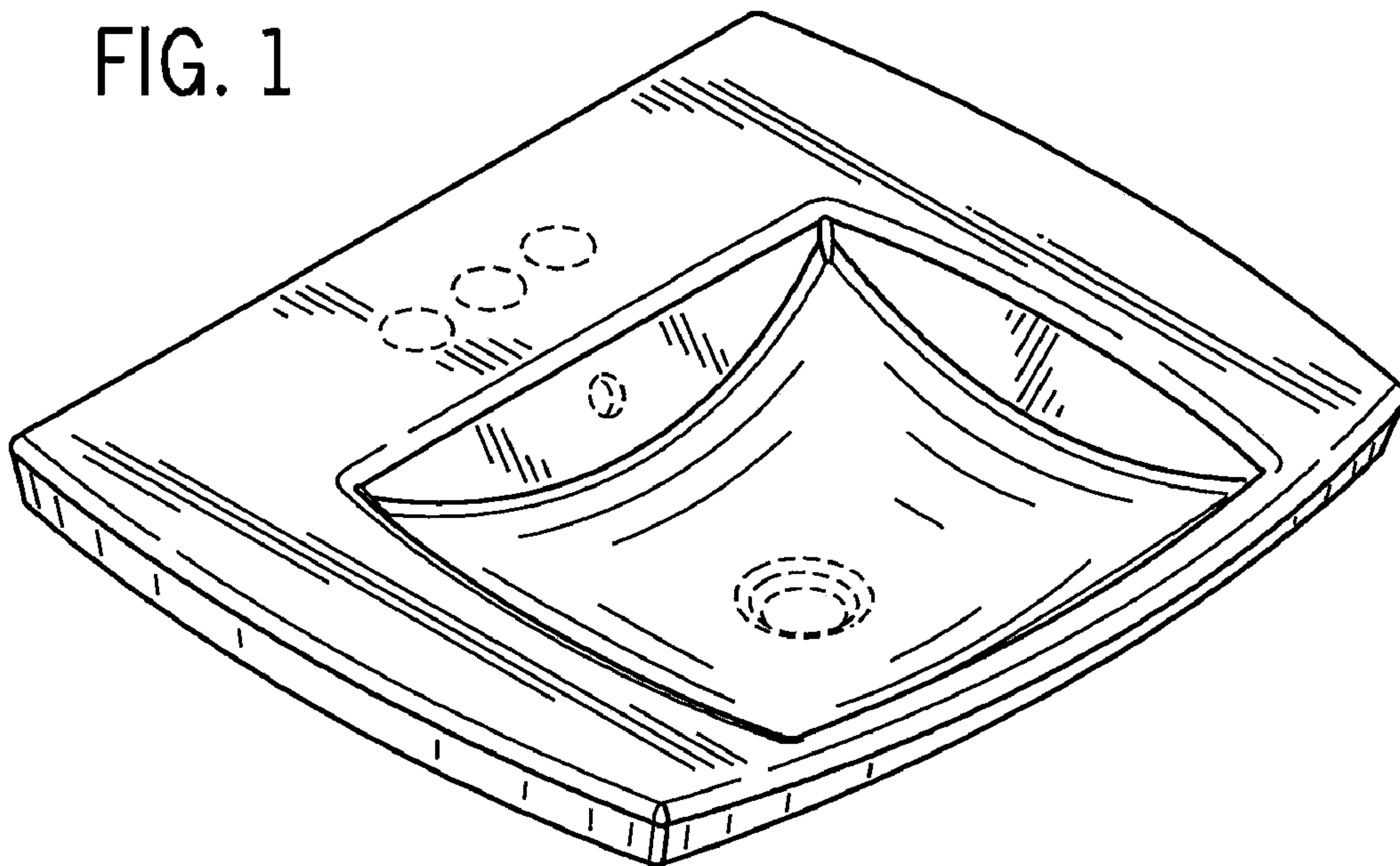

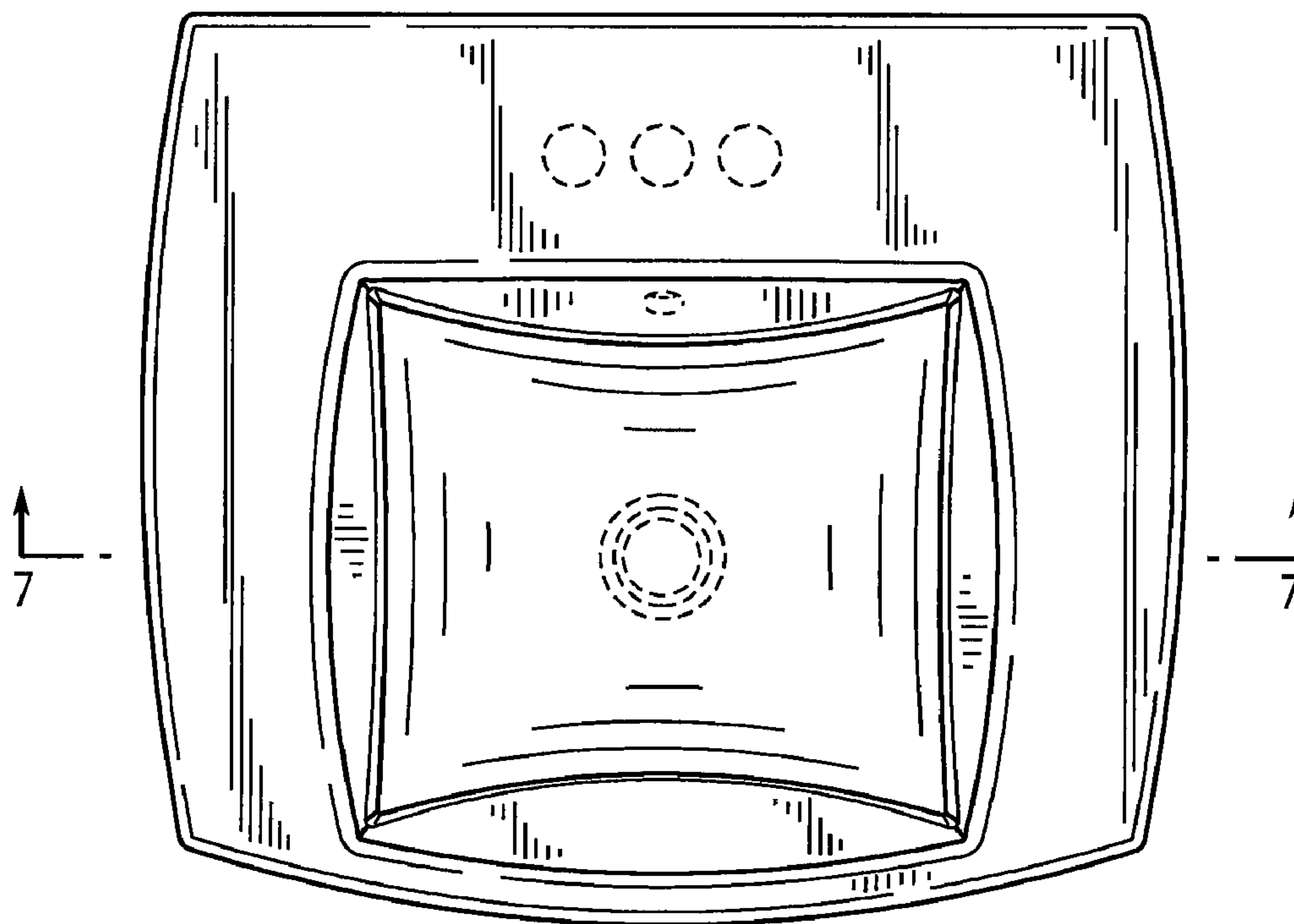

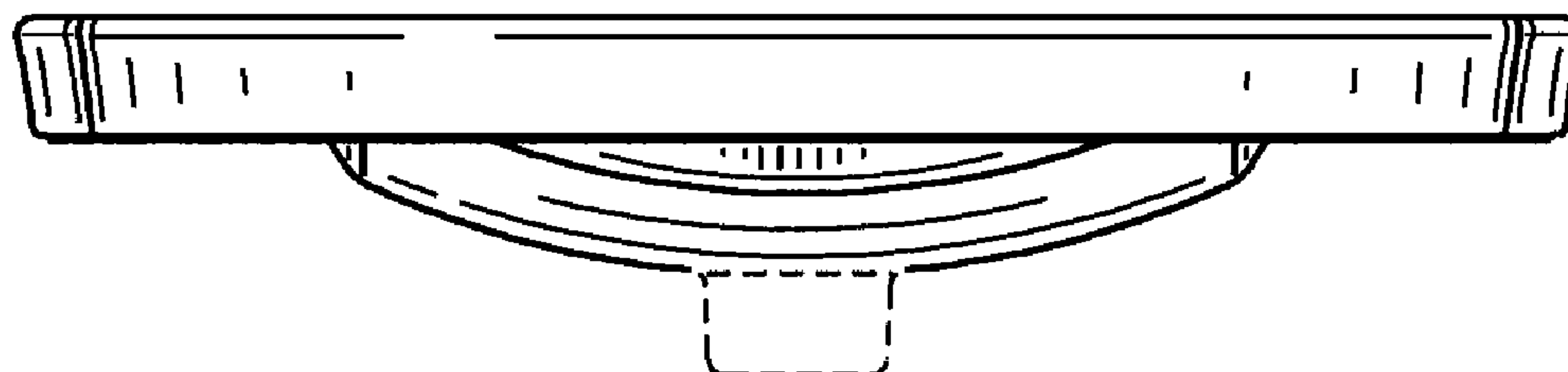

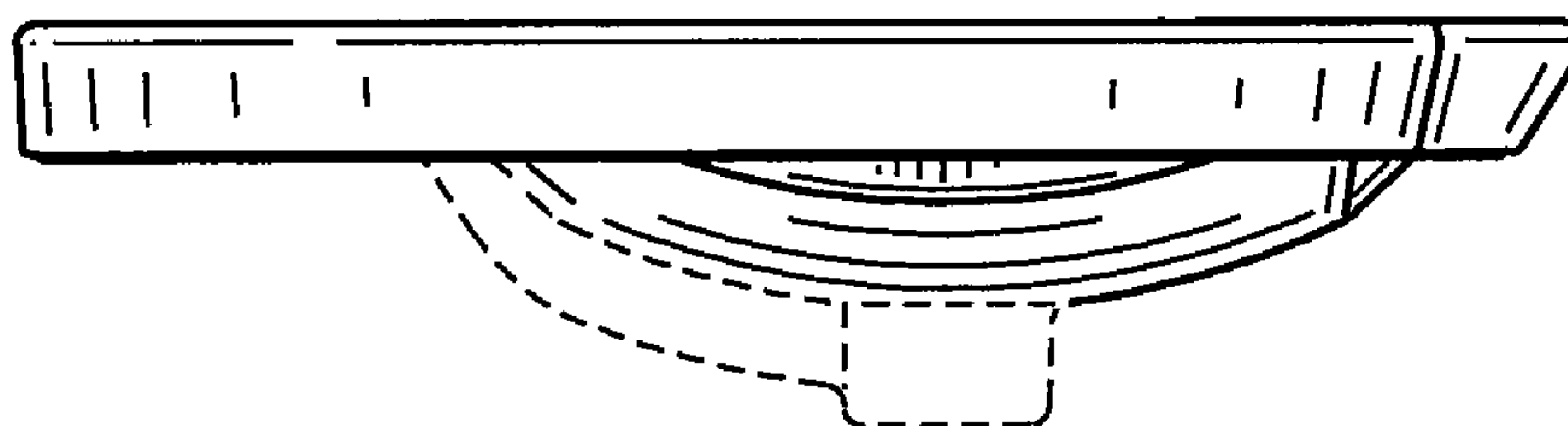

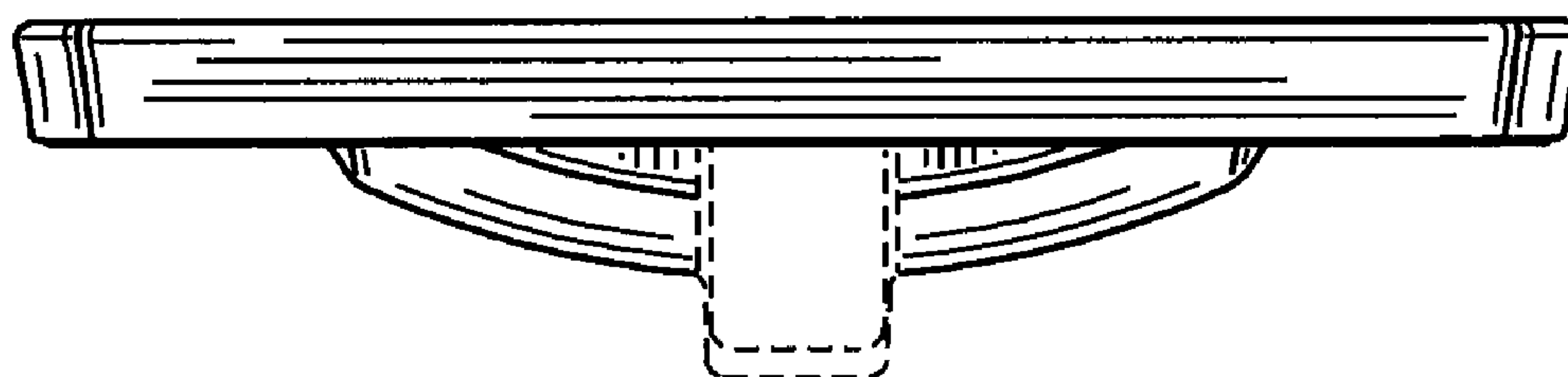

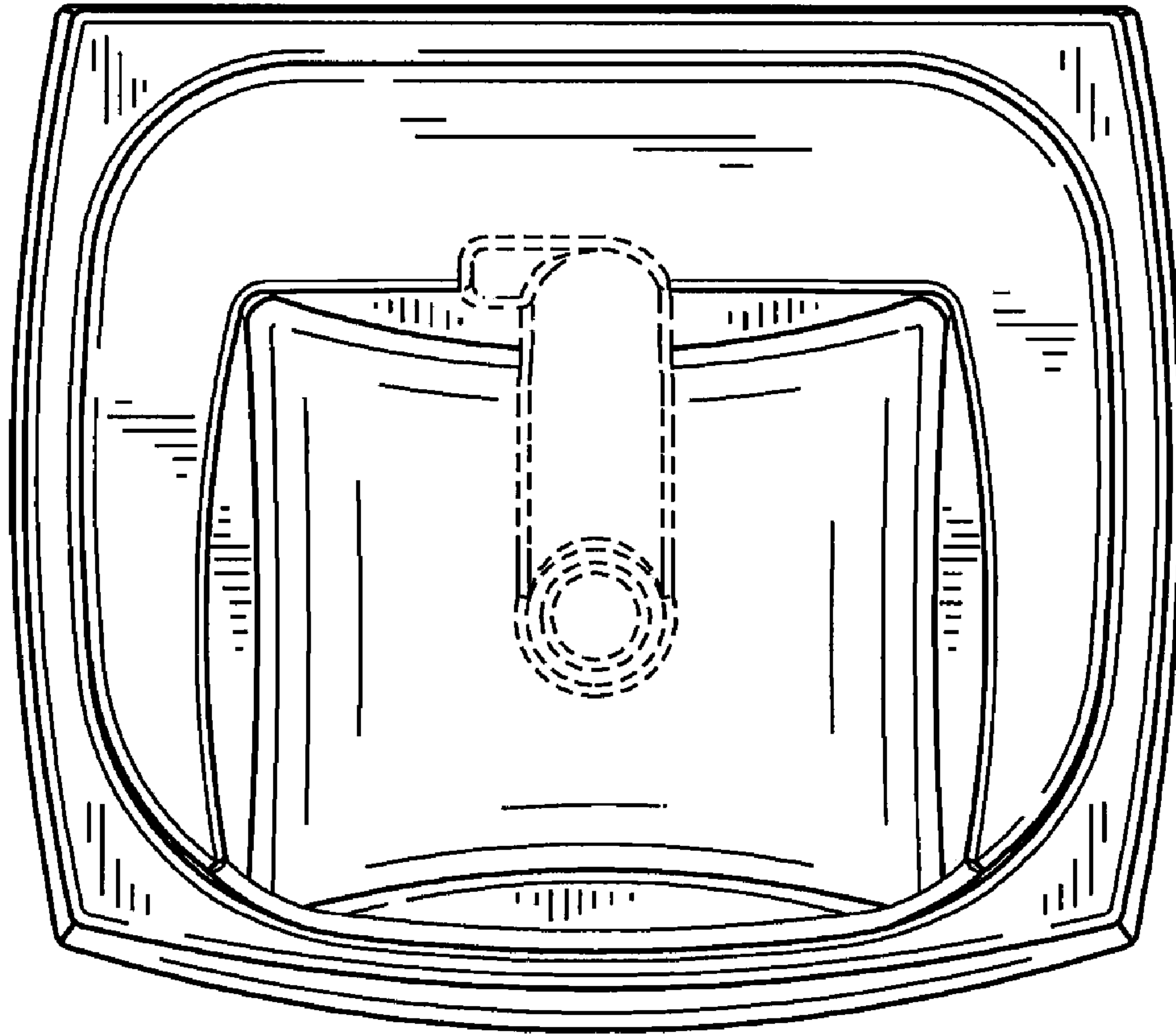
