DESCRIPTION

In a preferred embodiment, the nature of this product is as a plumbing fixture in the form of a lavatory which is primarily useful for washing various items and the body parts of humans.

FIG. 1 is a right, left, front perspective view of a lavatory embodying my new design;

FIG. 2 is a top plan view thereof;

FIG. **3** is a front elevational view thereof;

FIG. **4** is a right side elevational view thereof, the left side elevational view thereof being a mirror image of the right side shown;

FIG. 5 is a rear elevational view thereof; and,

FIG. 6 is a bottom plan view thereof.
