(57) **CLAIM**

I claim the ornamental design for a pet scratching device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pet scratching device, showing my new design;

FIG. 2 is a front elevational view of the invention;

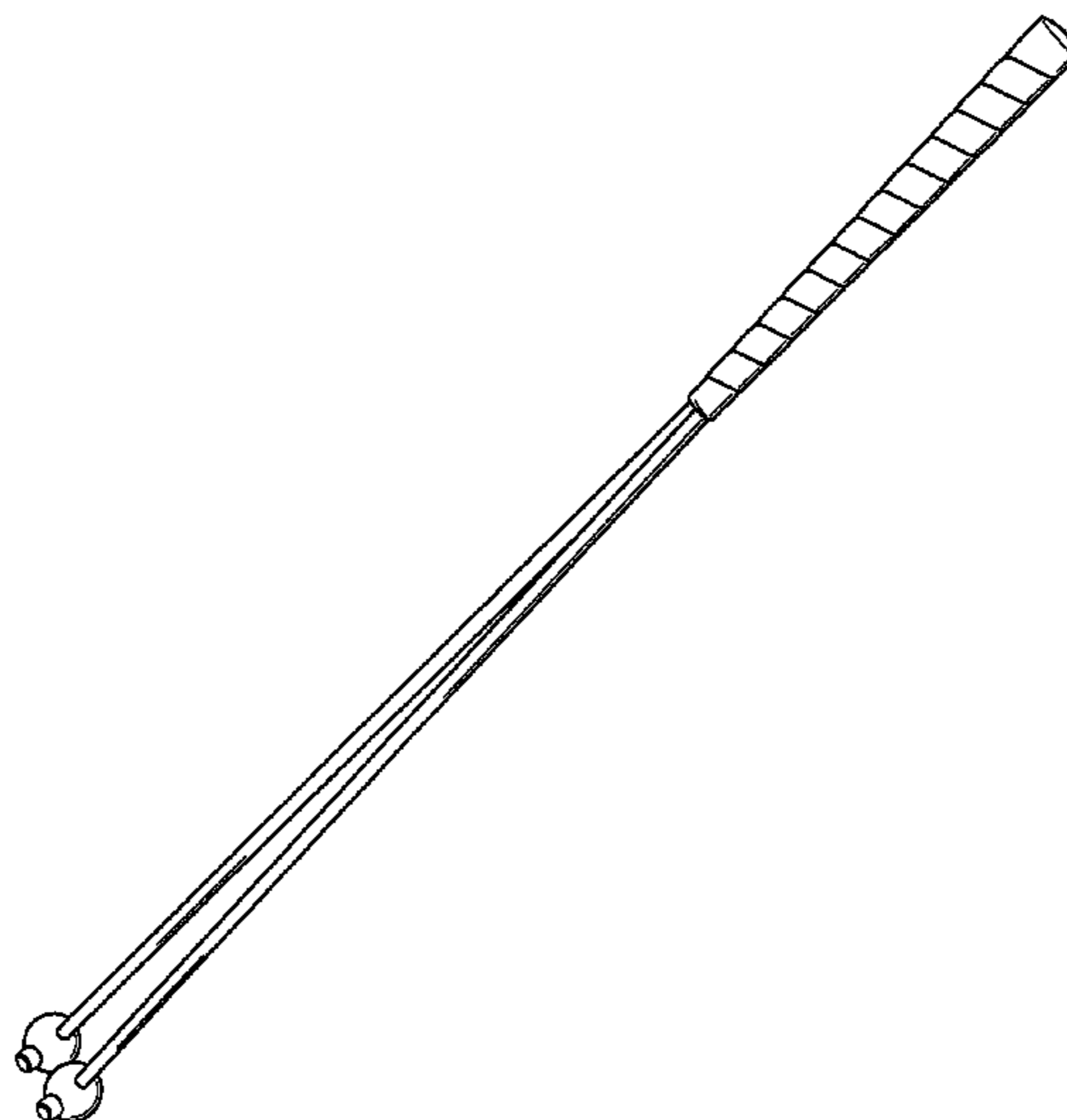
FIG. 3 is a rear elevational view of the invention;

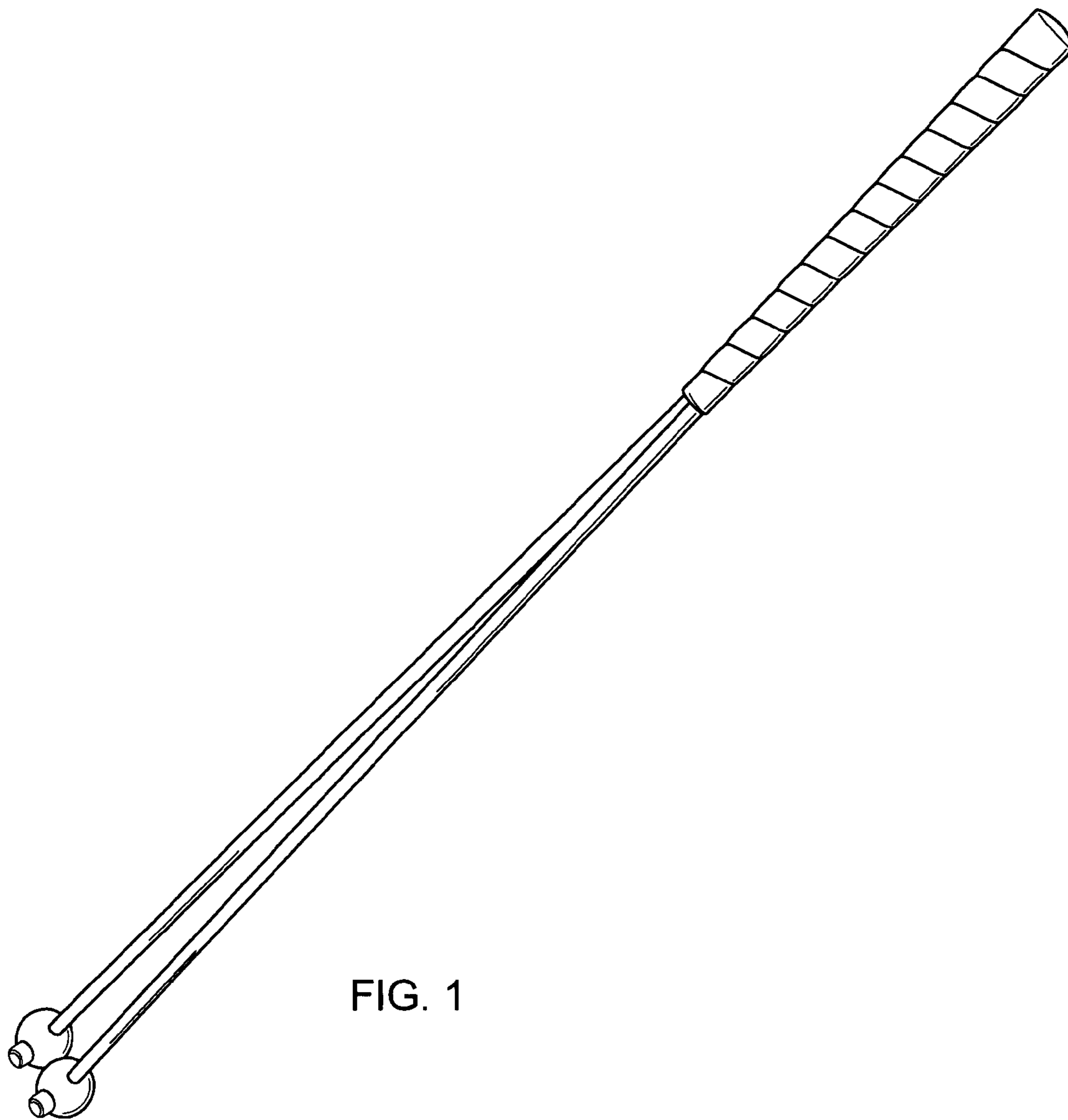

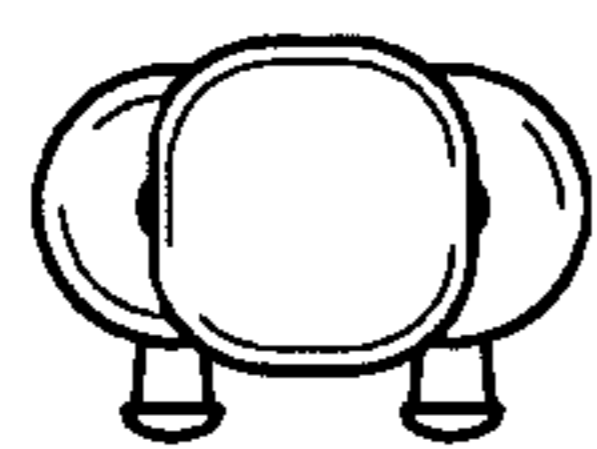

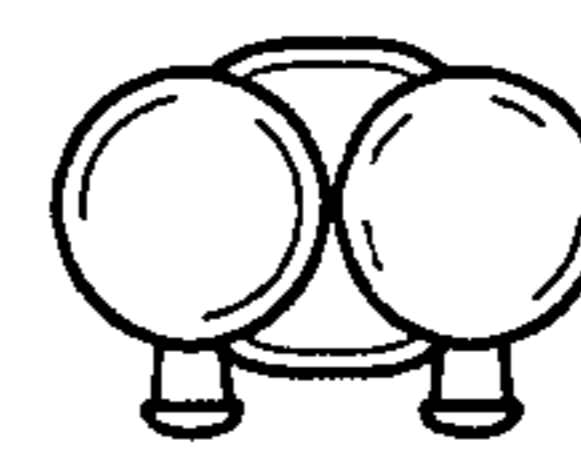

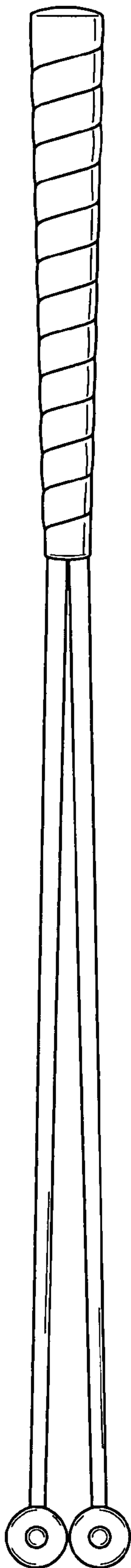

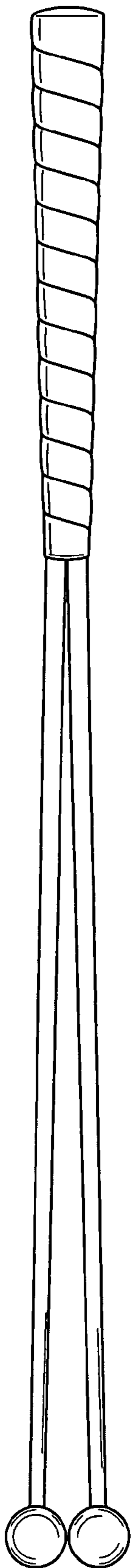

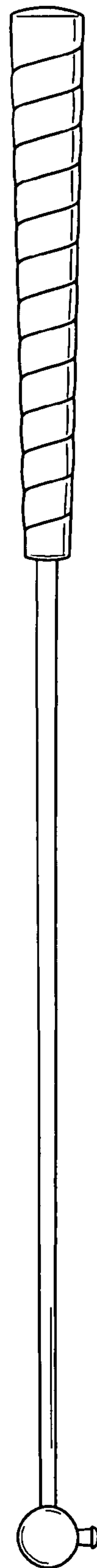
