FIG. 4 is a right end view thereof;

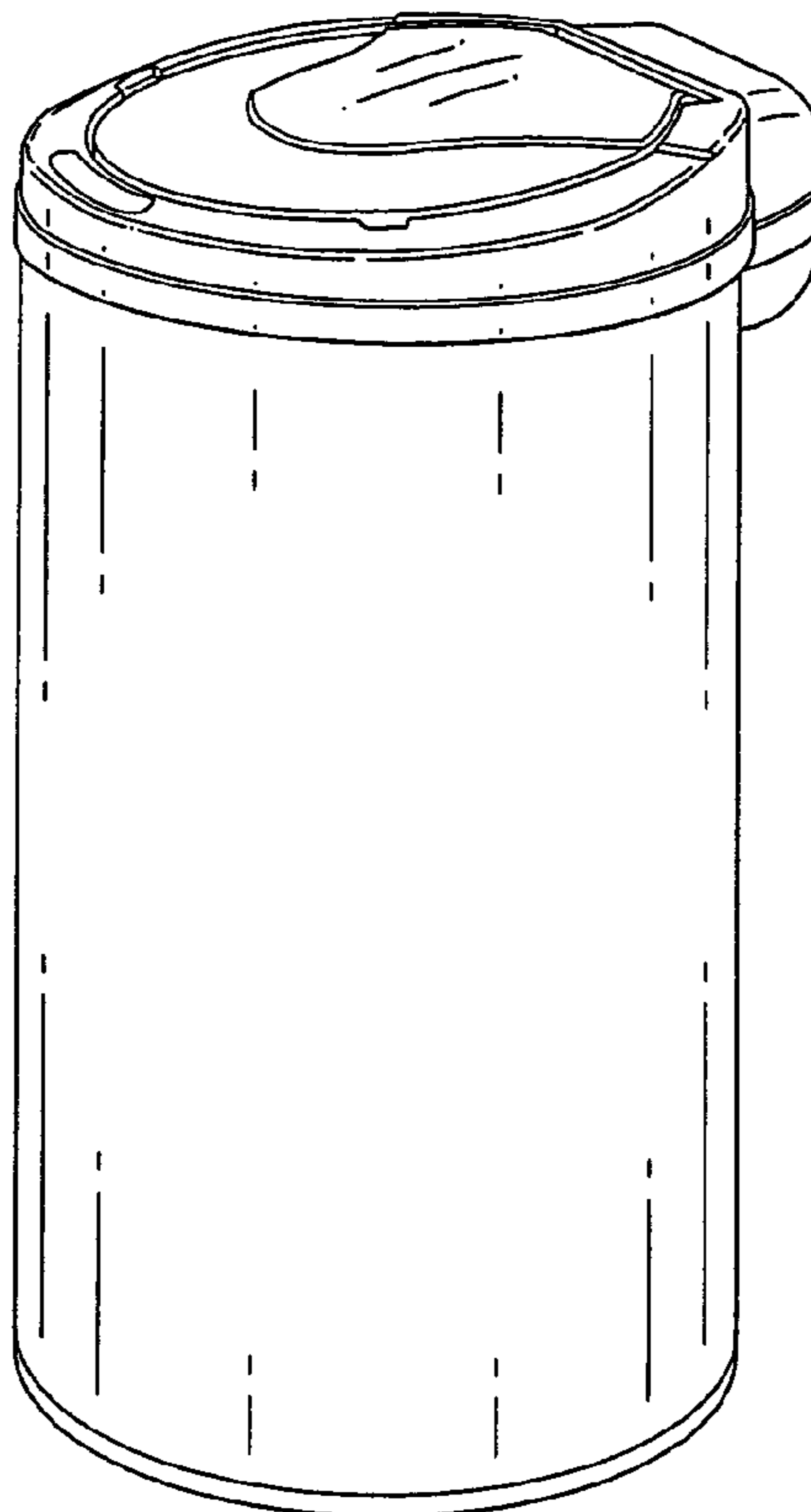
FIG. 5 is a left end view thereof;

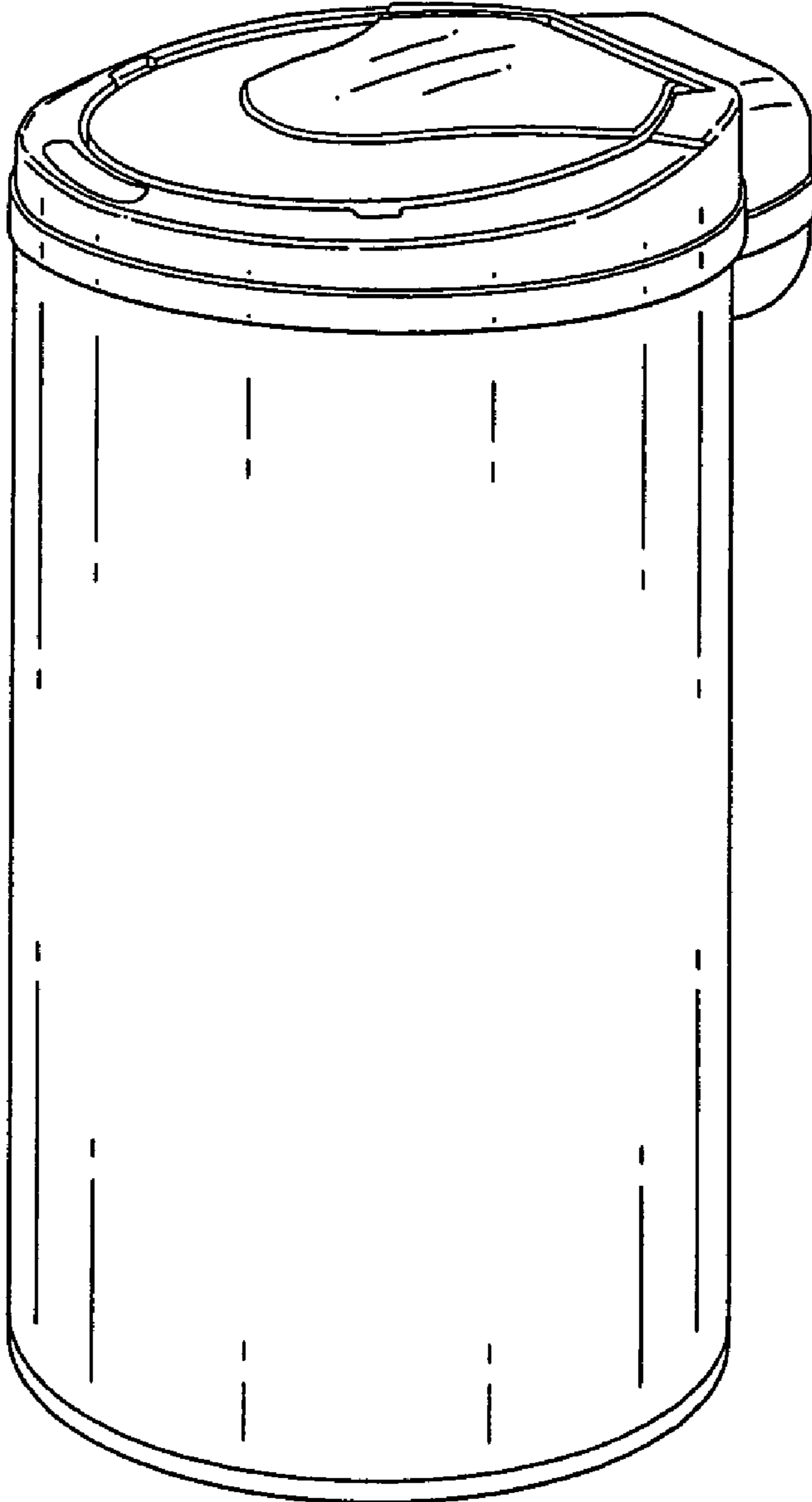

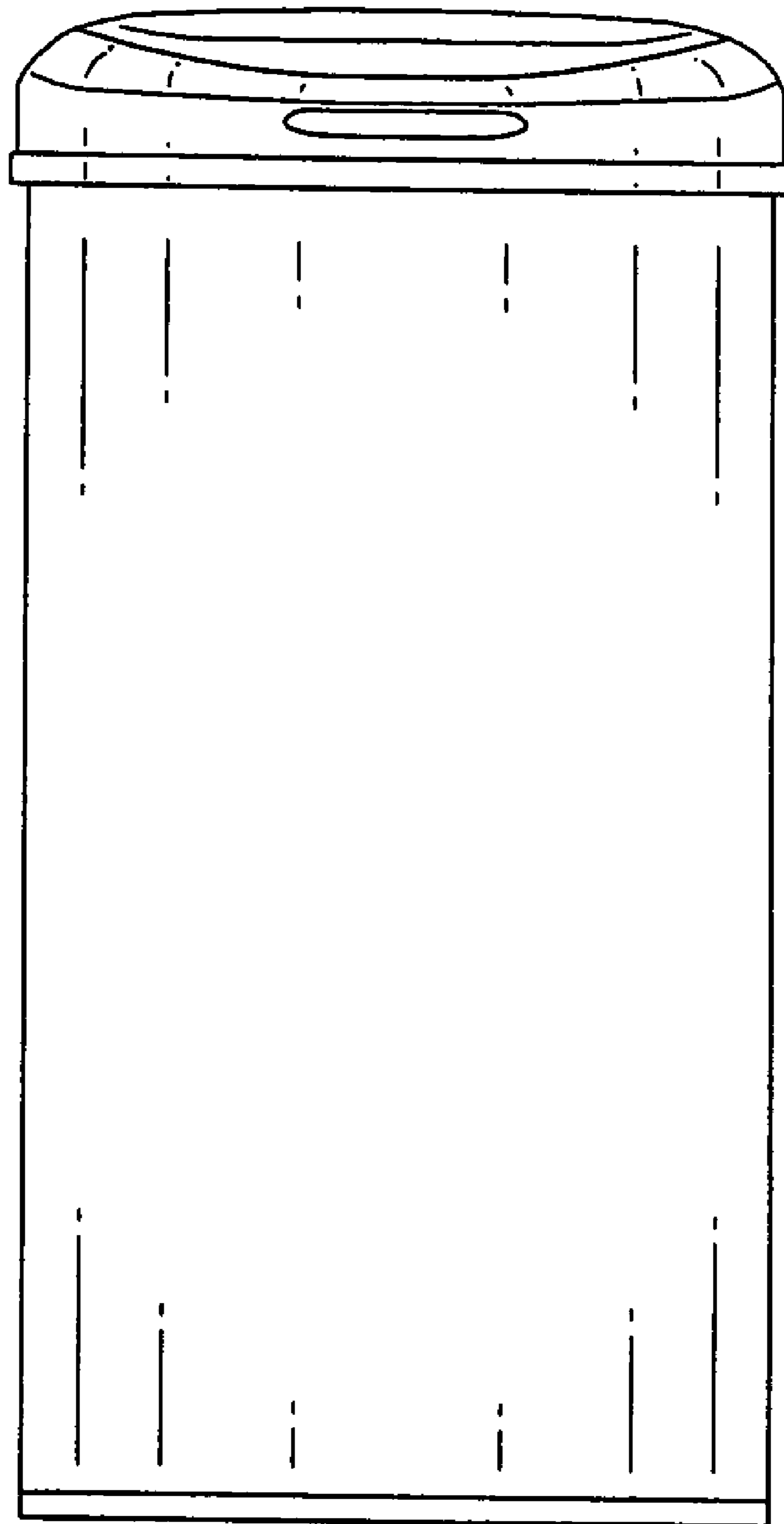

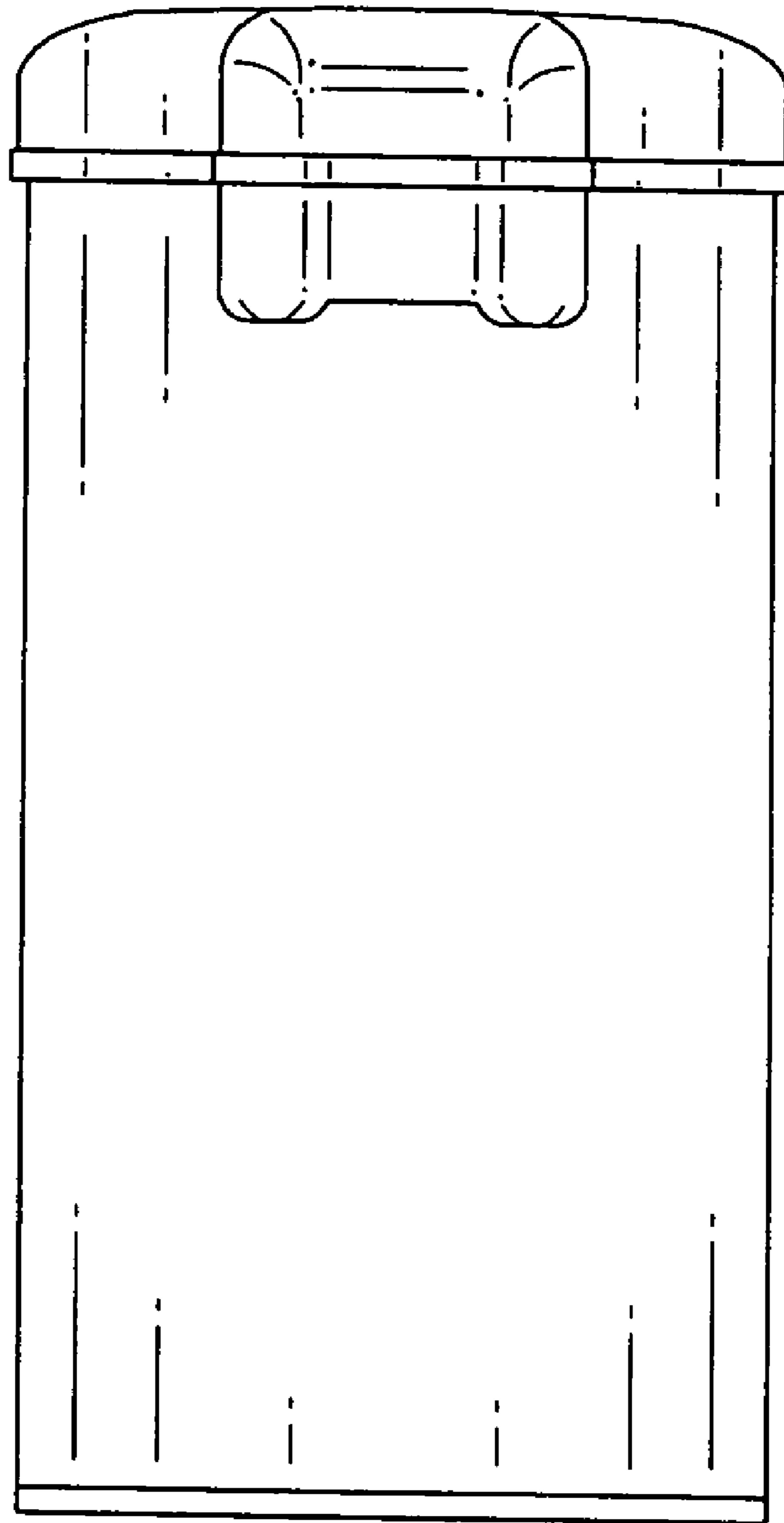

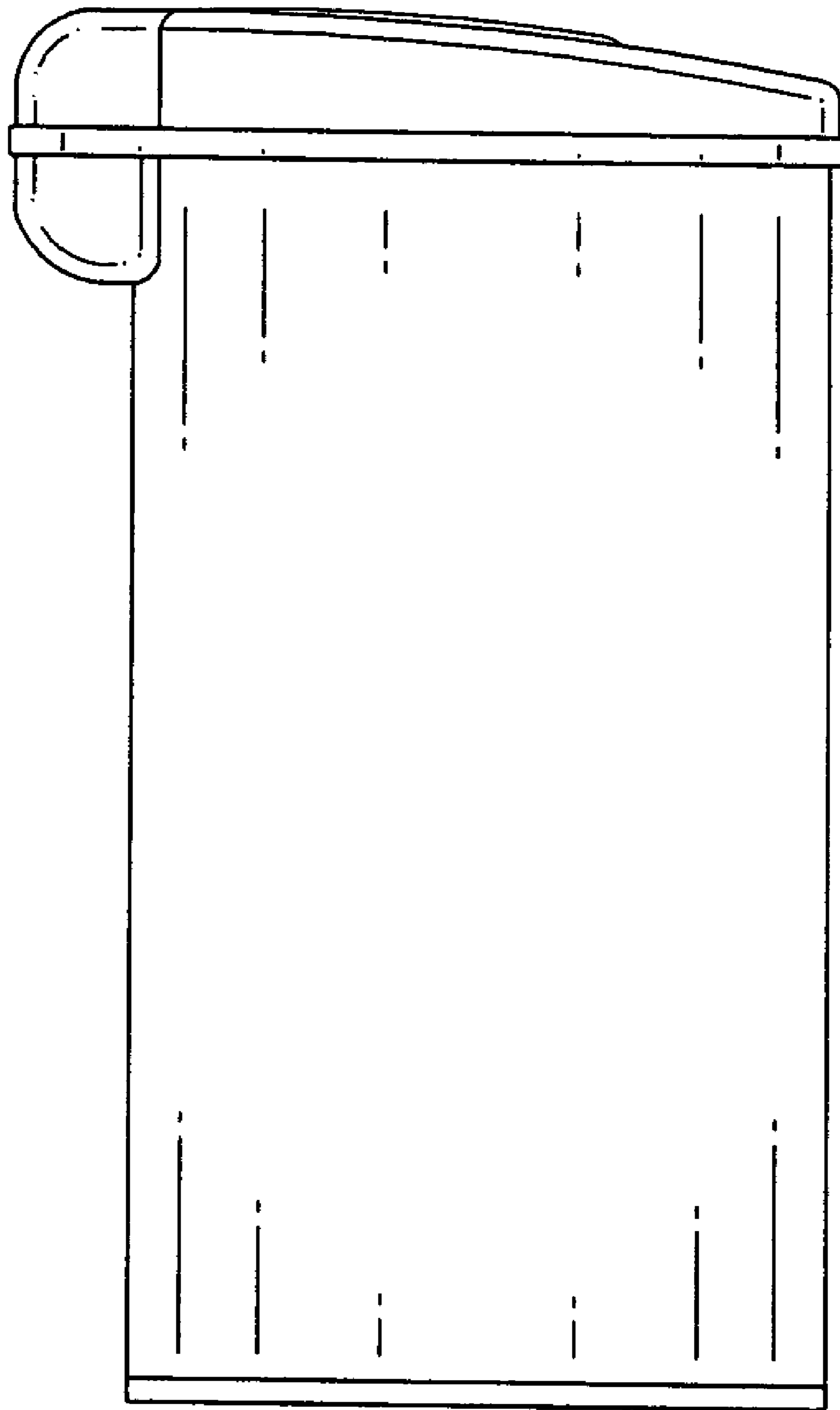

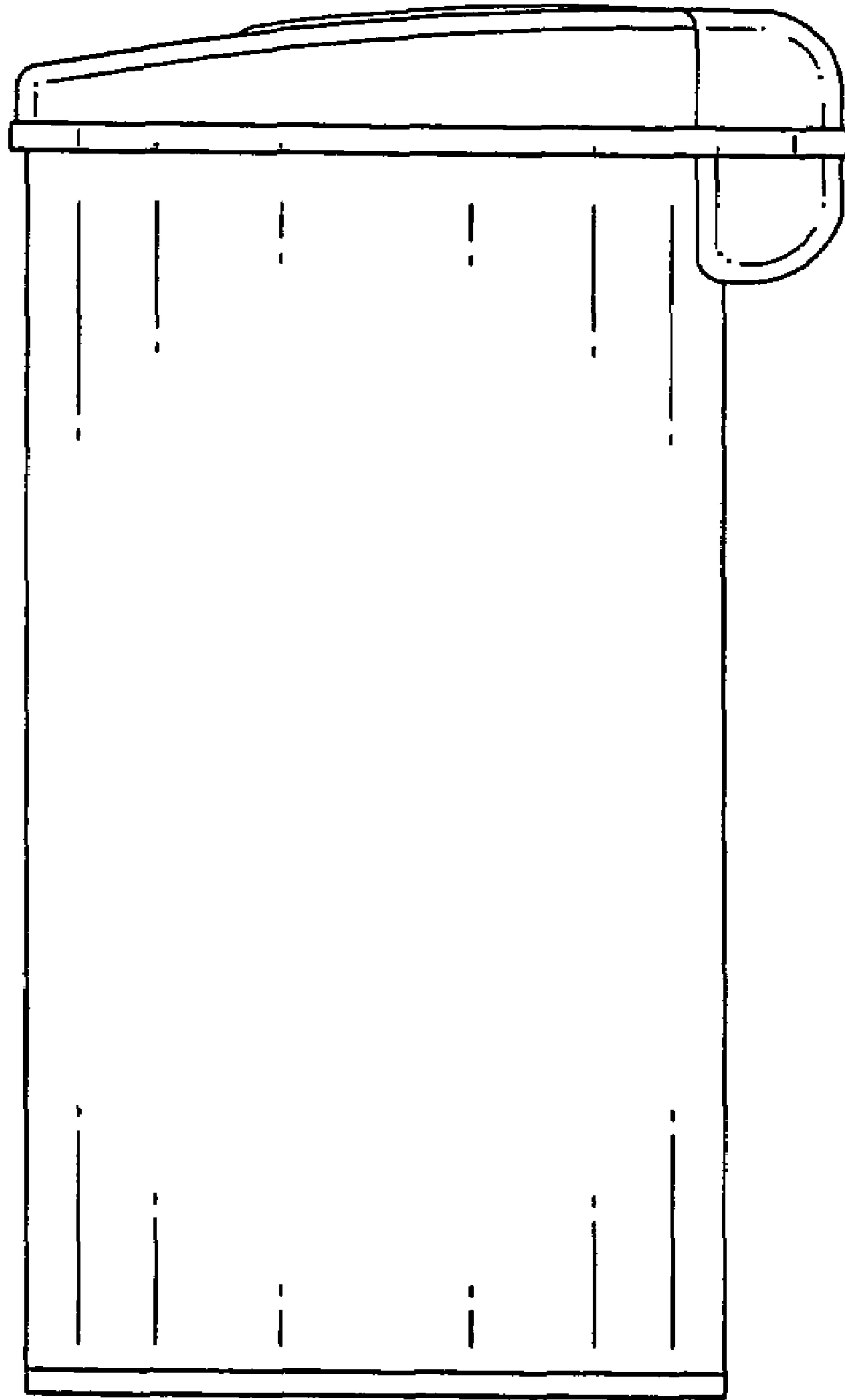

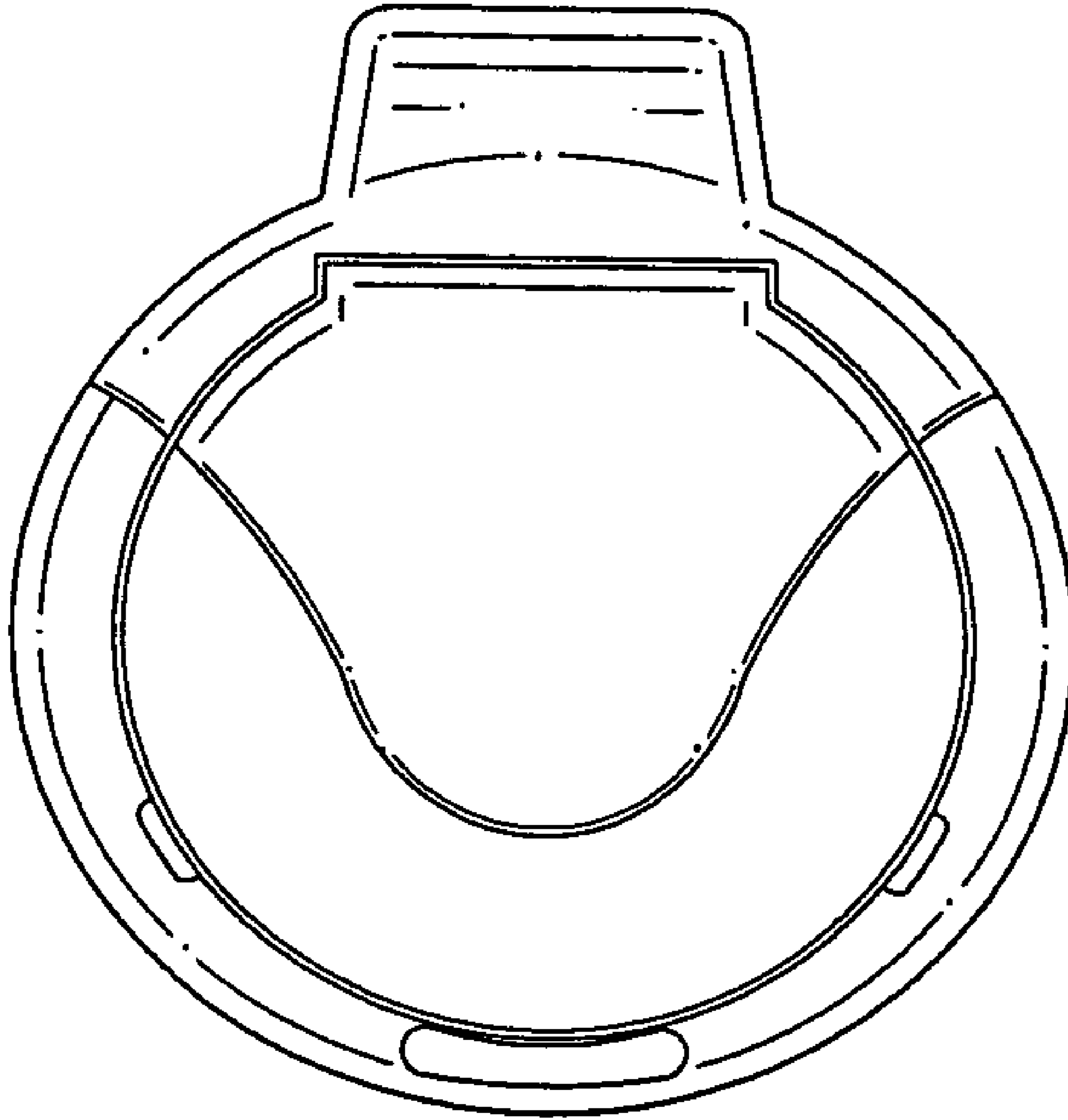

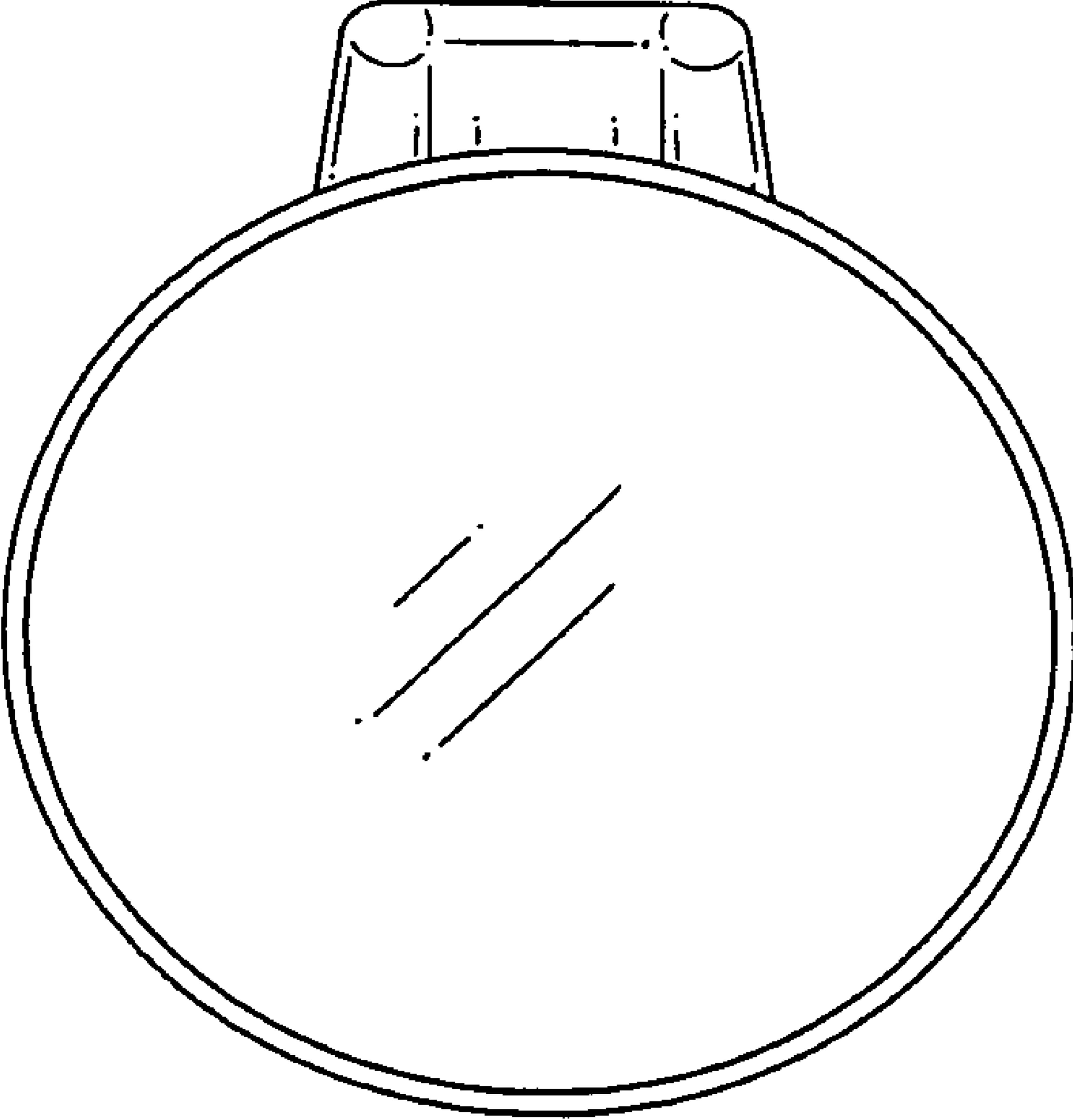

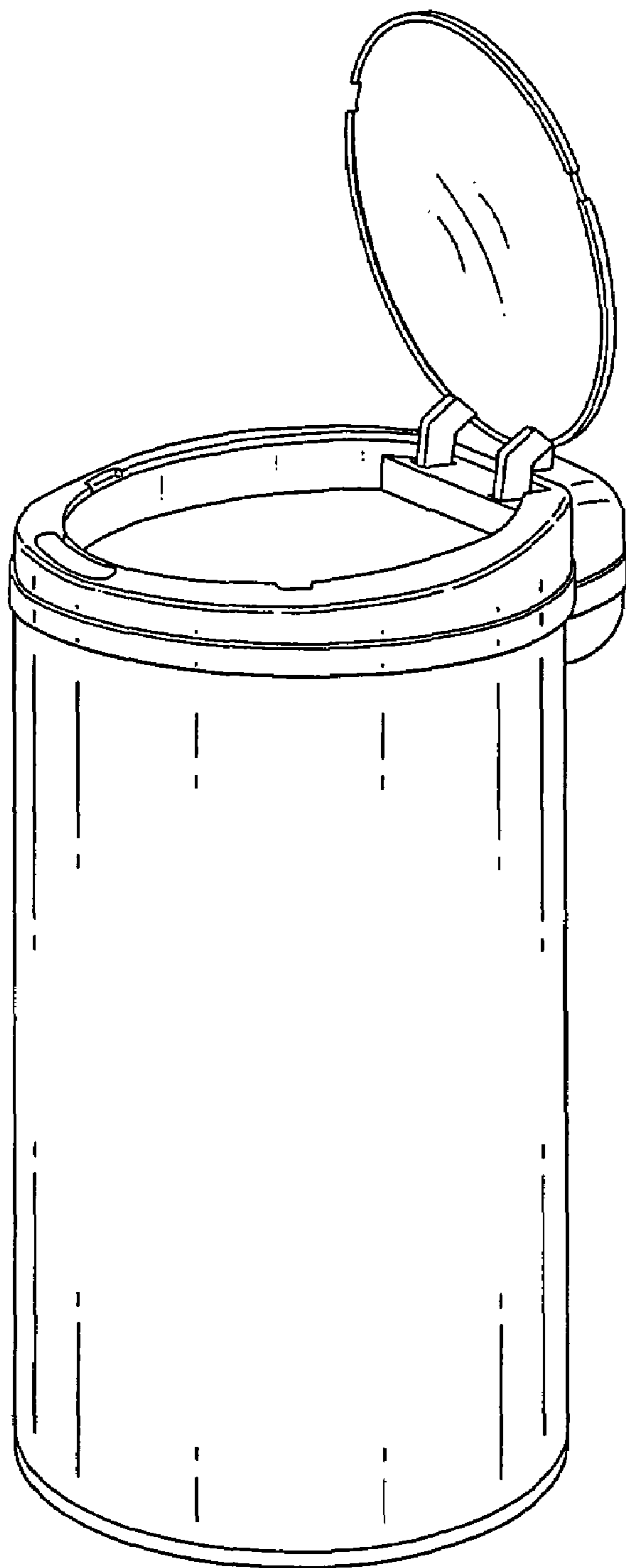
