(57) **CLAIM**

The ornamental design for a set of containers, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a set of containers embodying our new design;

FIG. 2 is a top, front, right side perspective view of the first container in the set shown in FIG. 1;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof, shown at an enlarged scale;

FIG. 5 is a right side elevational view of the bottle of FIG. 2;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a top, front, right side perspective view of the second container in the set shown in FIG. 1;

FIG. 9 is a rear elevational view thereof;

FIG. 10 is a left side elevation view thereof, shown at an enlarged scale;

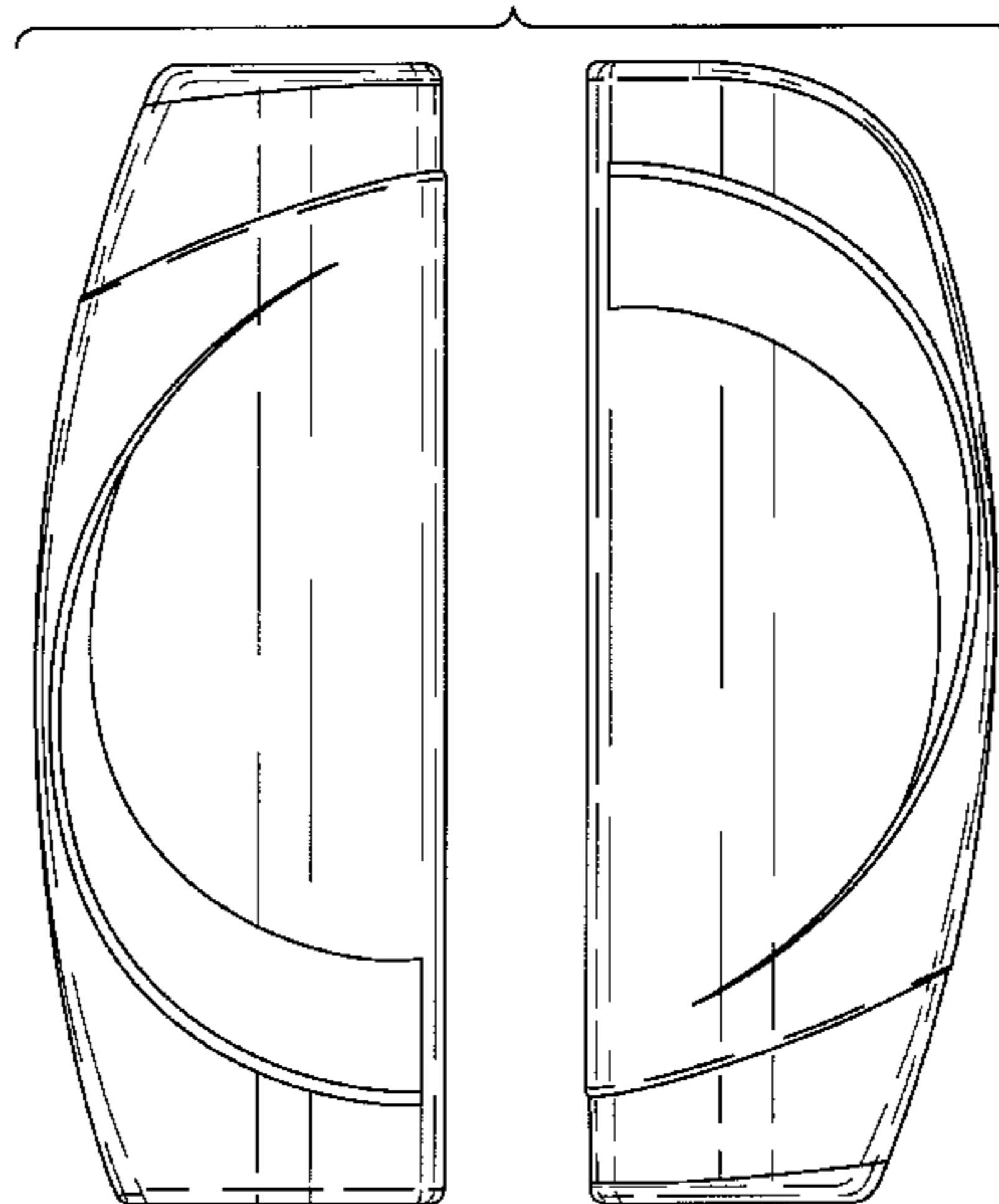
FIG. 11 is a right side elevational view of the bottle of FIG. 8;

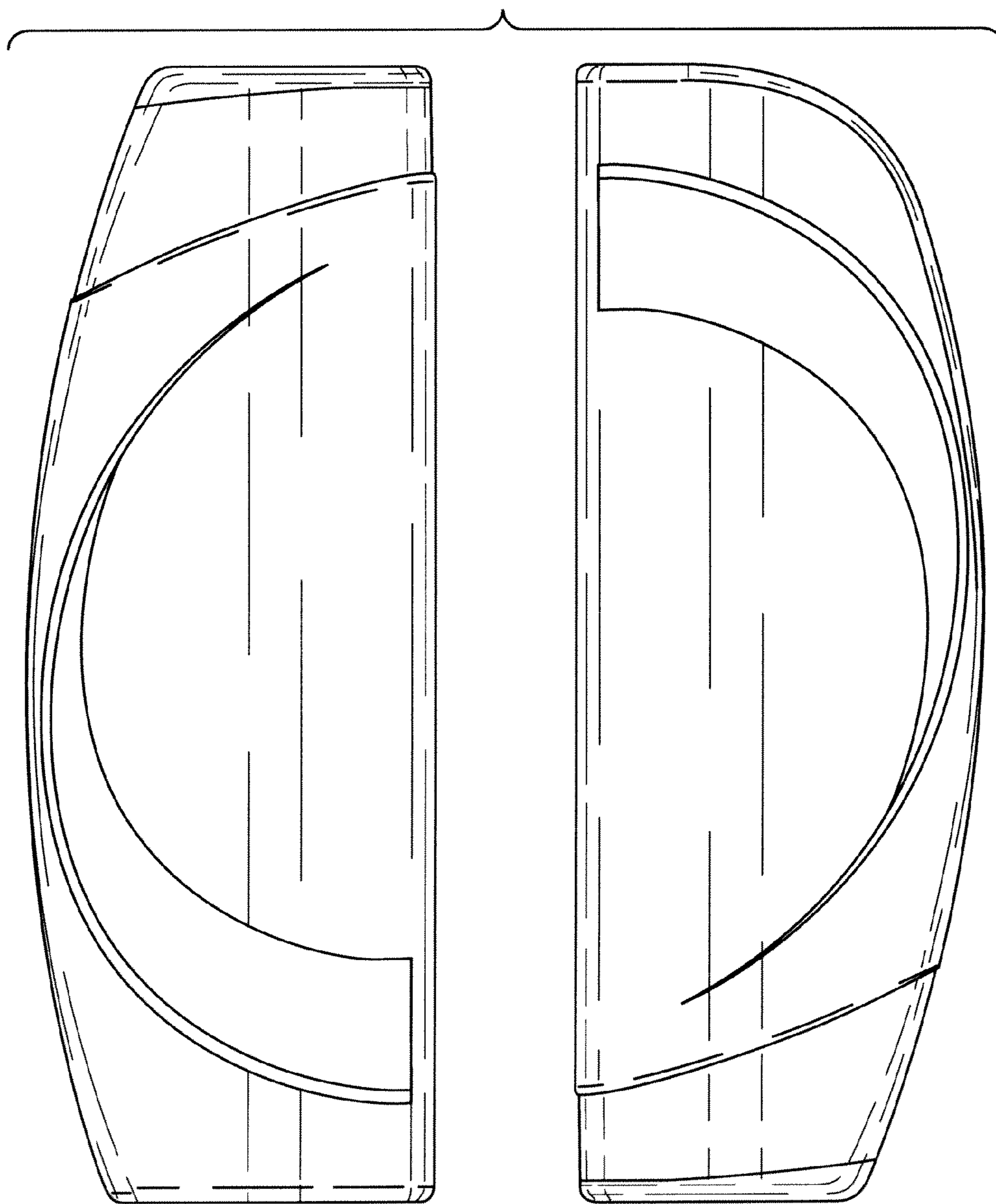

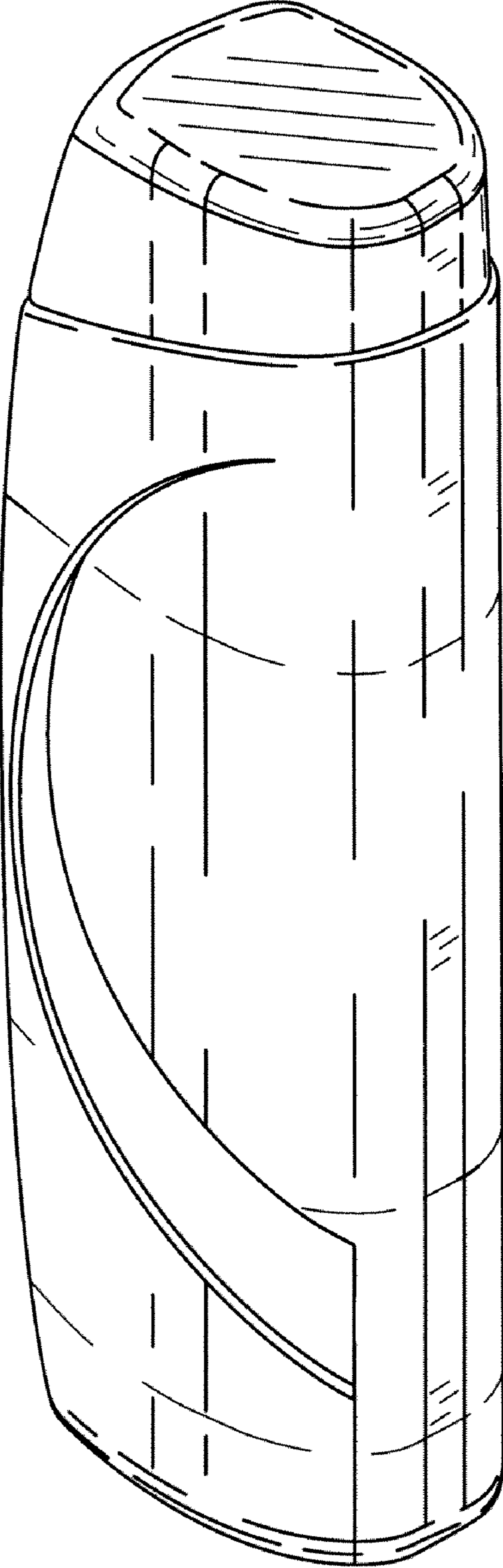

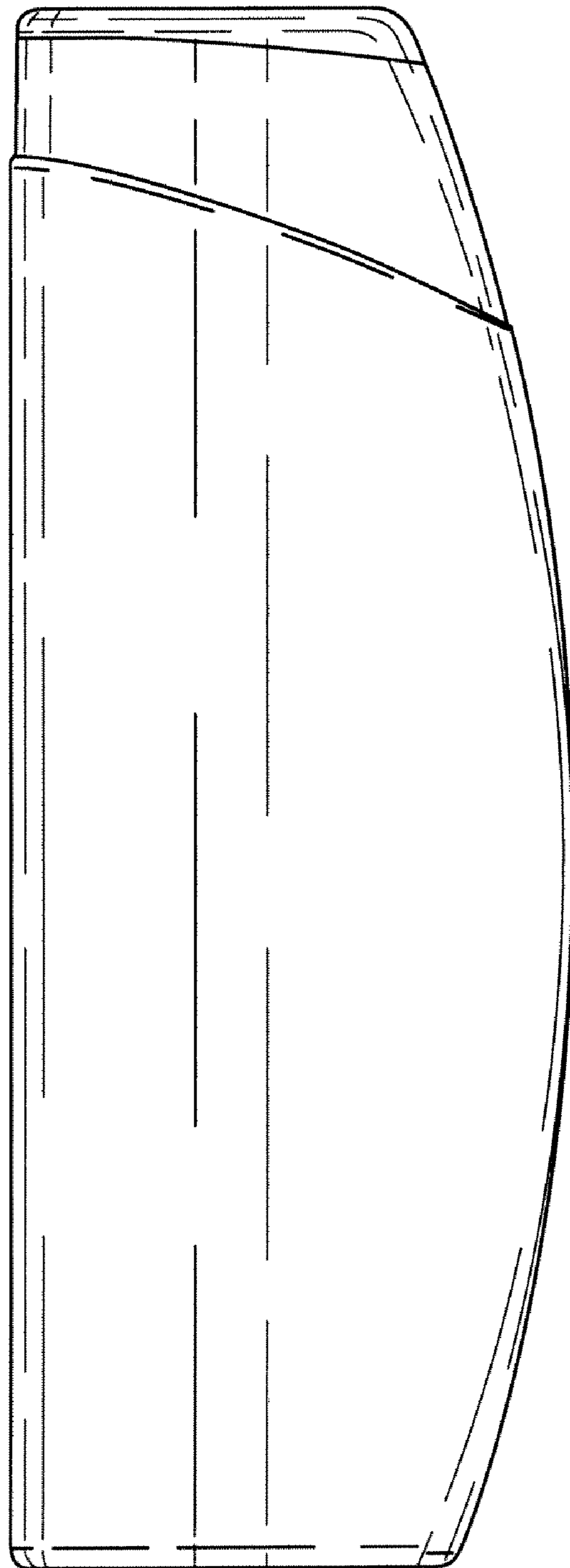

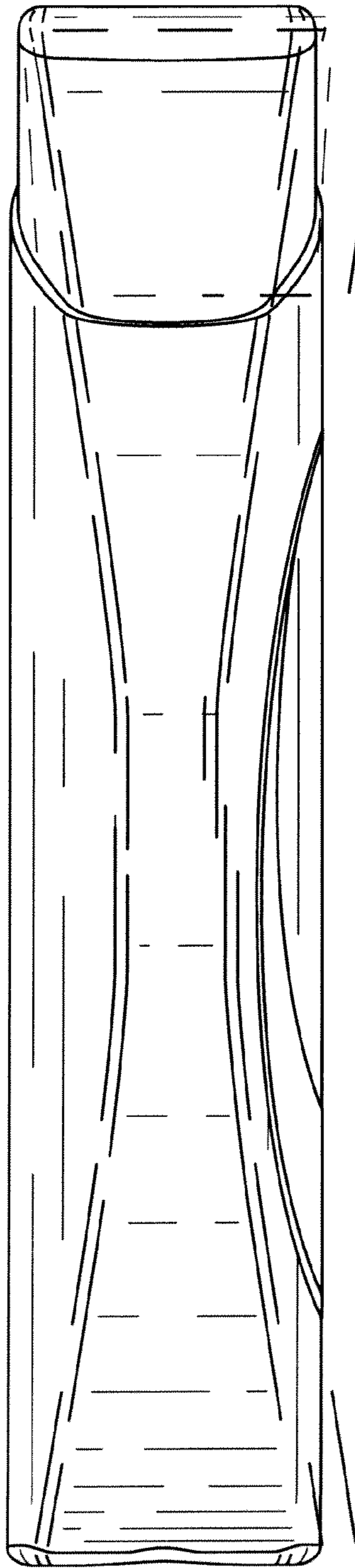

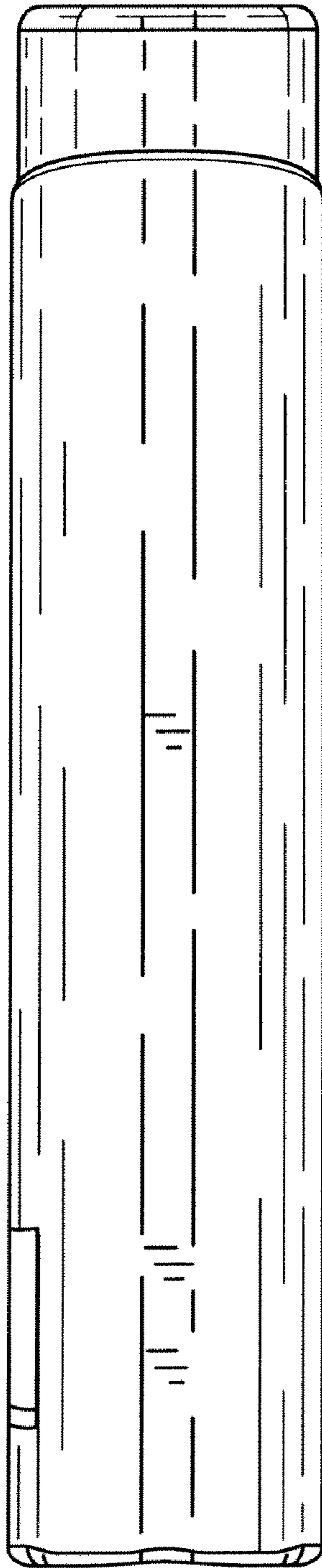

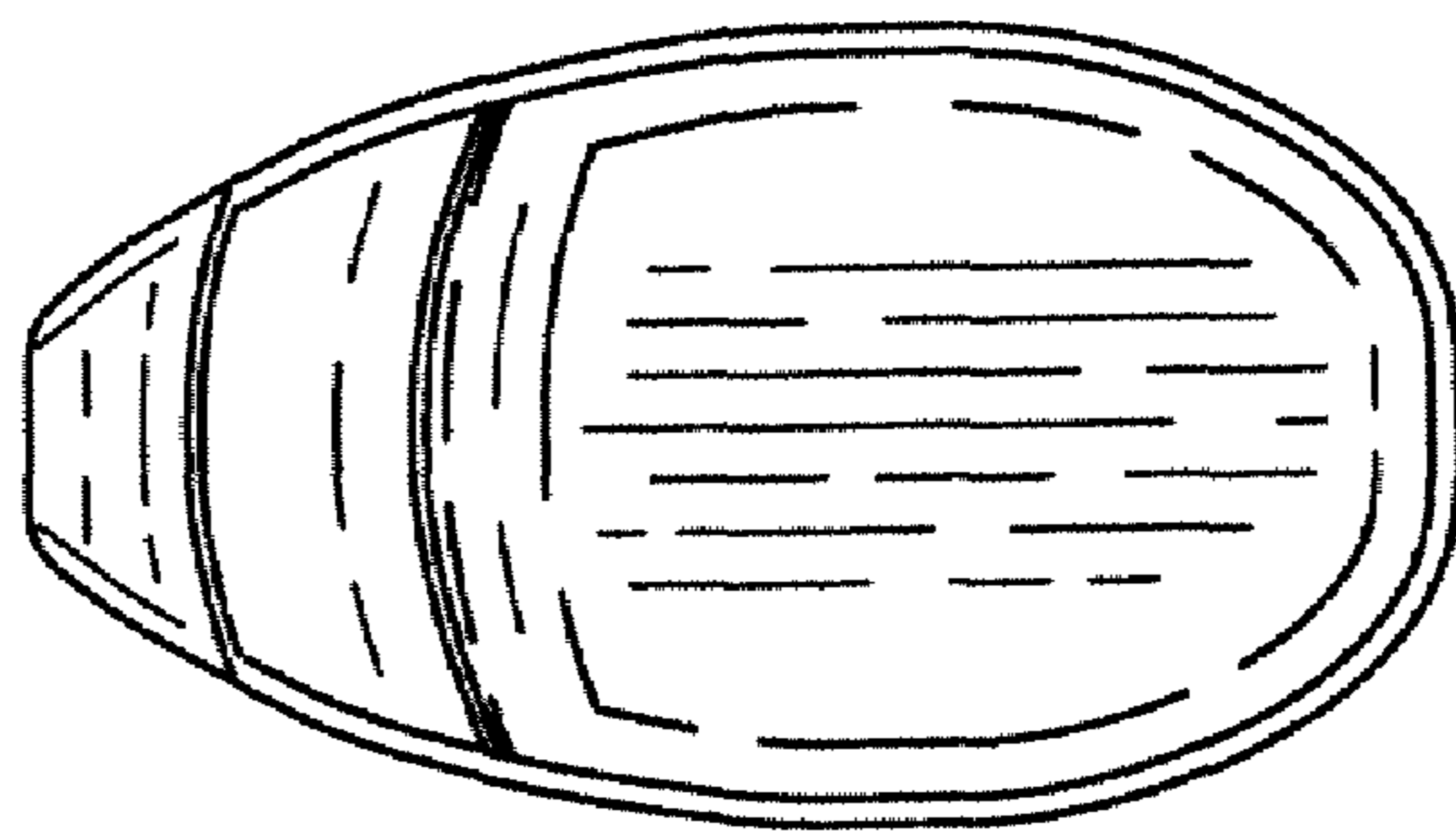

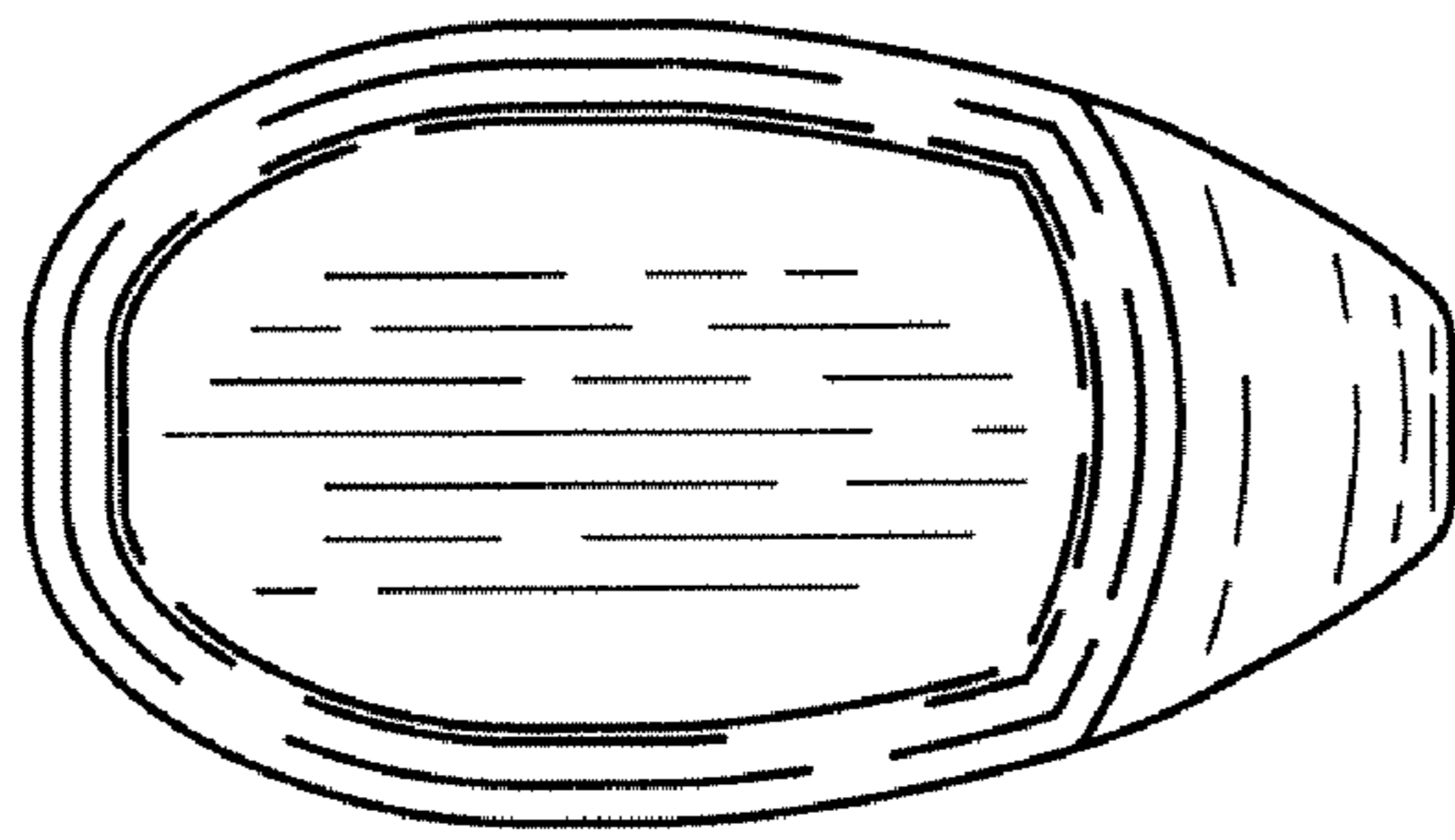

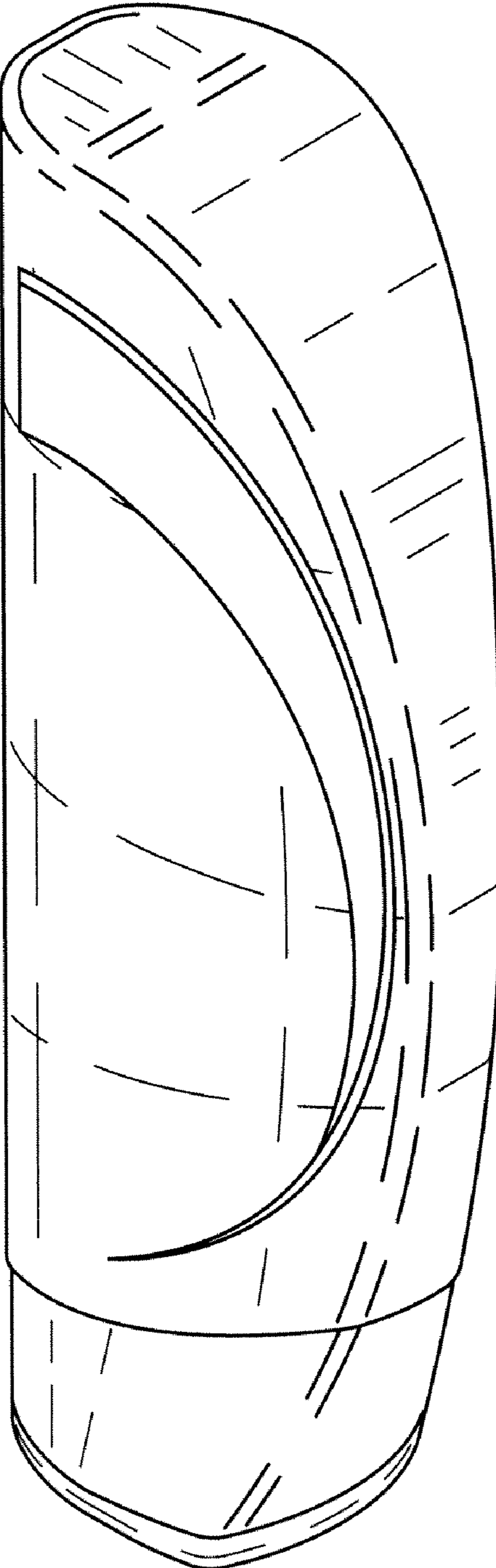

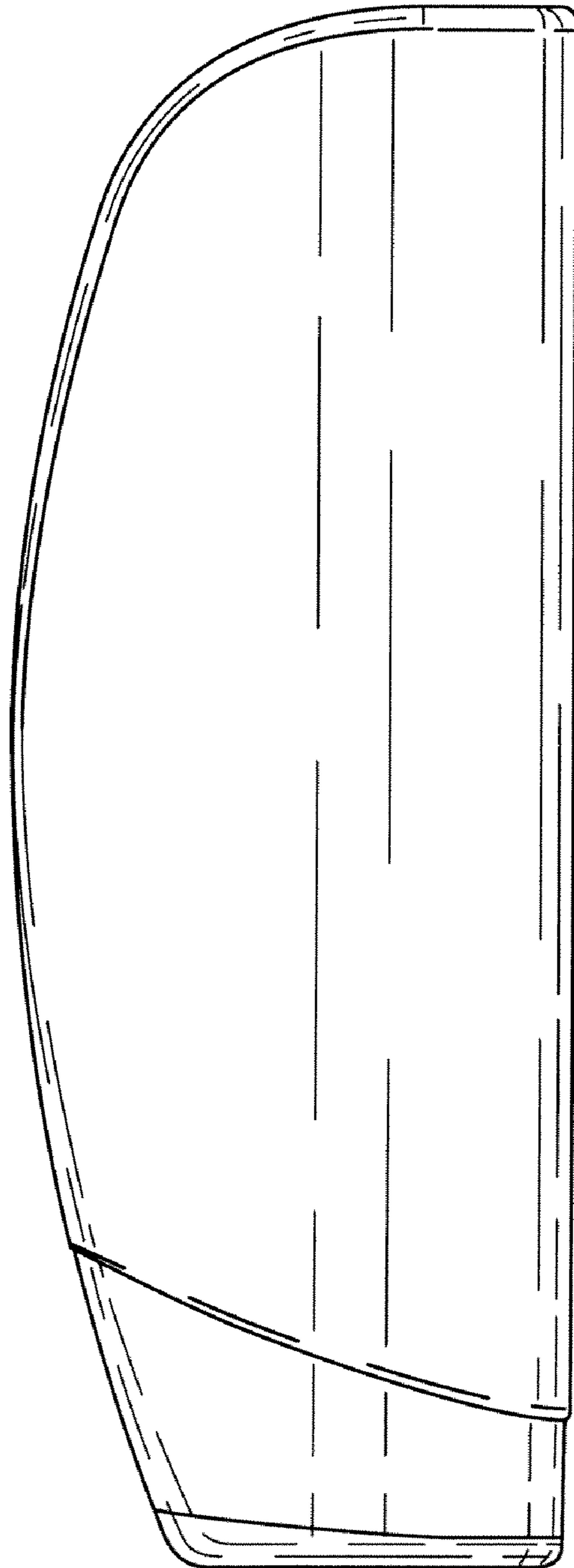

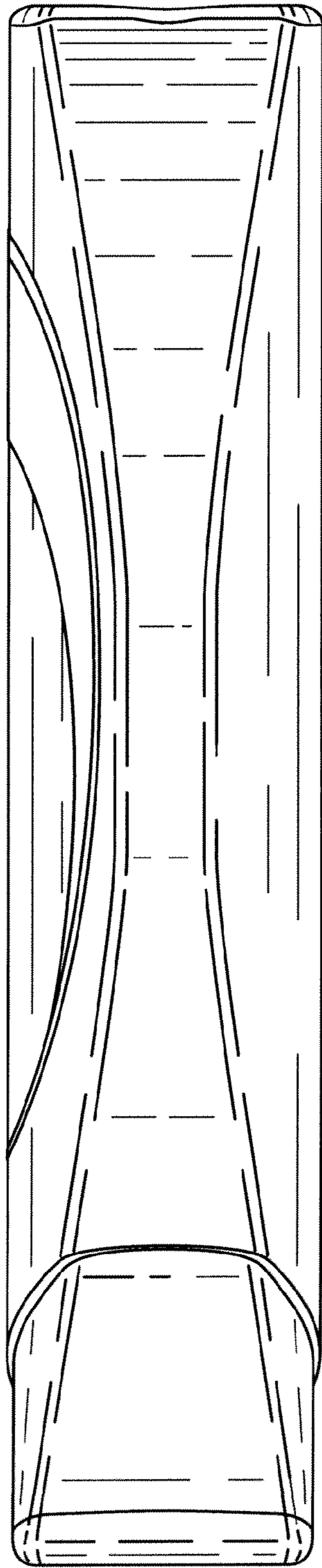

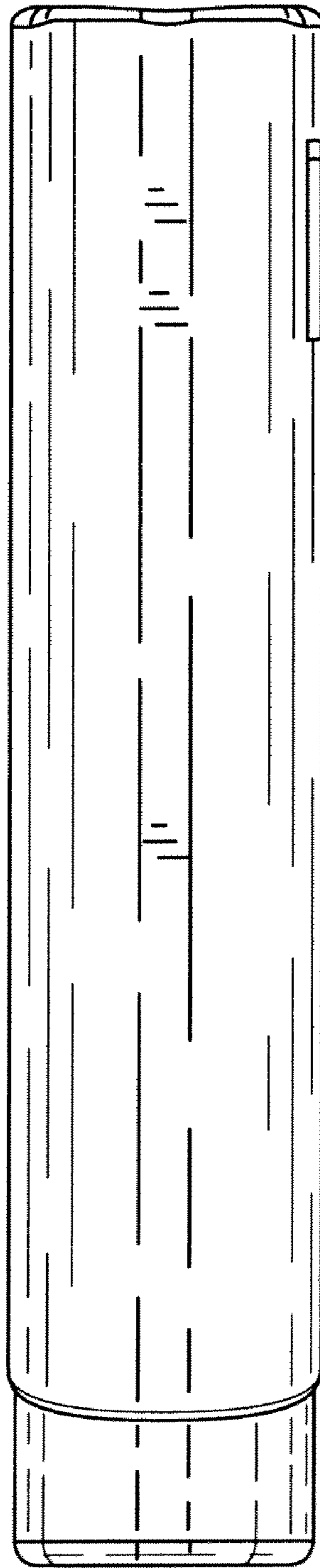

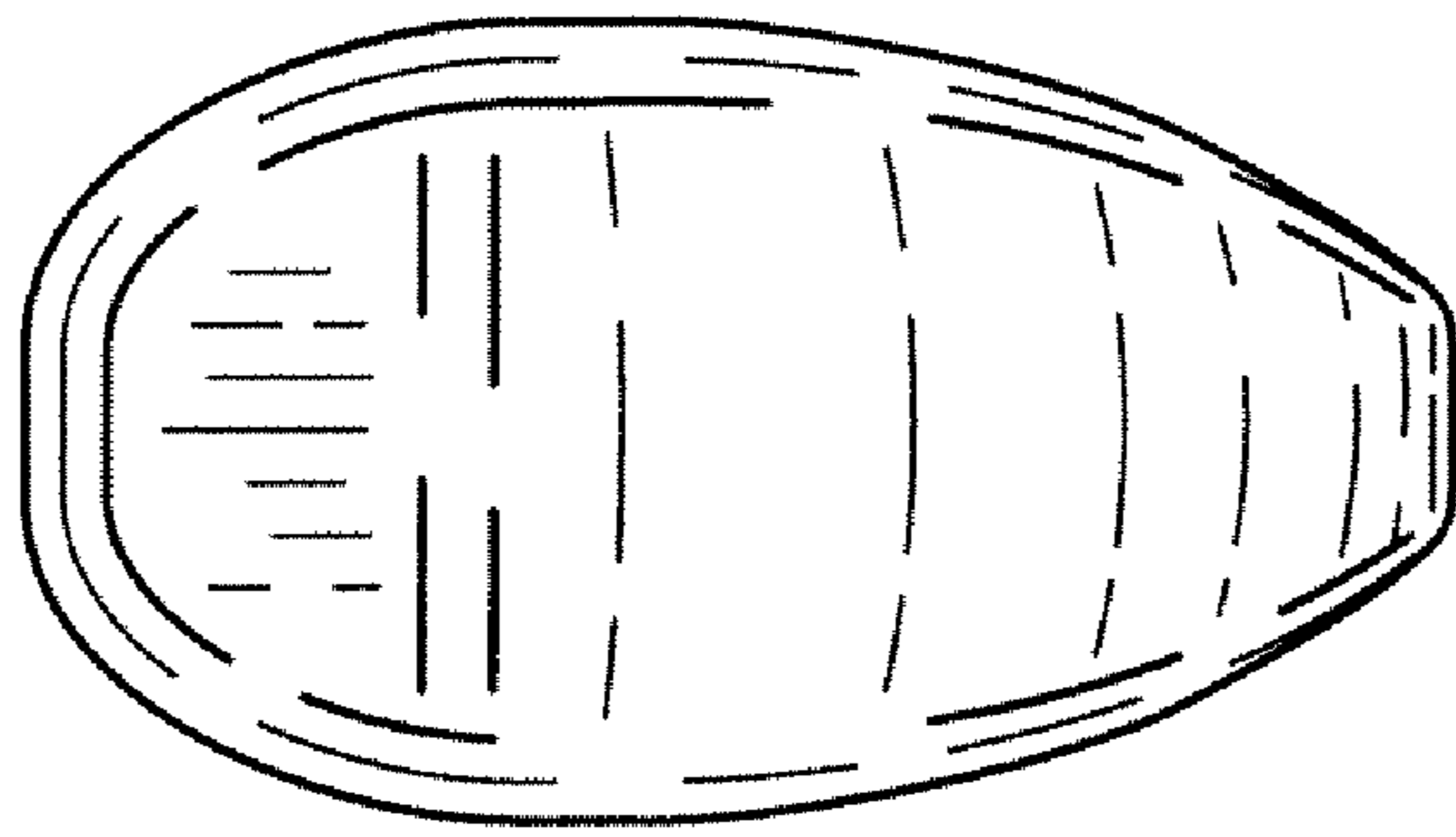

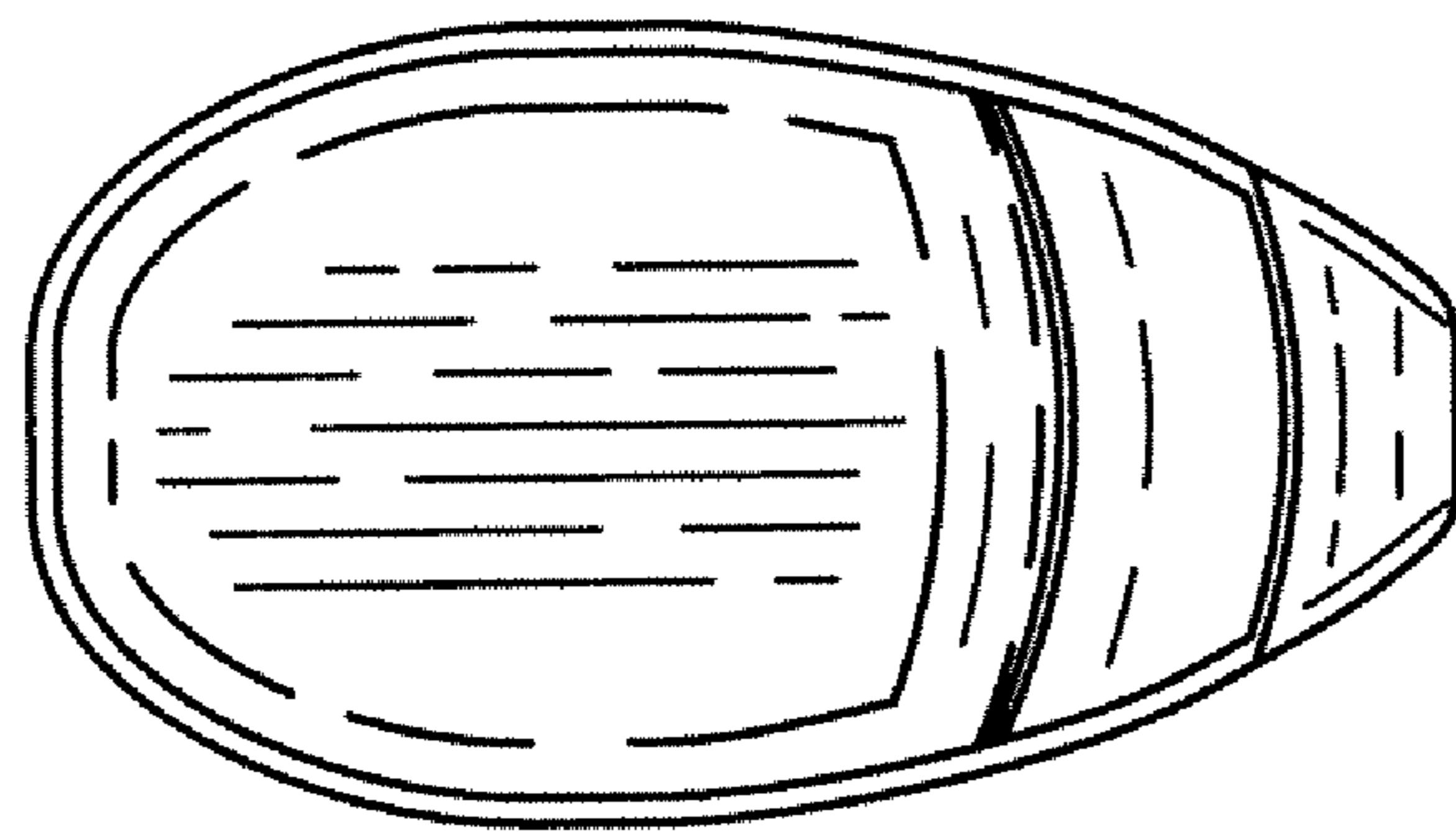
