I claim the ornamental design for an spray bottle, as shown and described.

DESCRIPTION

FIG. 1 is an elevation view showing my new design for a spray bottle in a closed state;

FIG. 2 is a perspective view thereof;

FIG. 3 is an exploded side elevation view of the design;

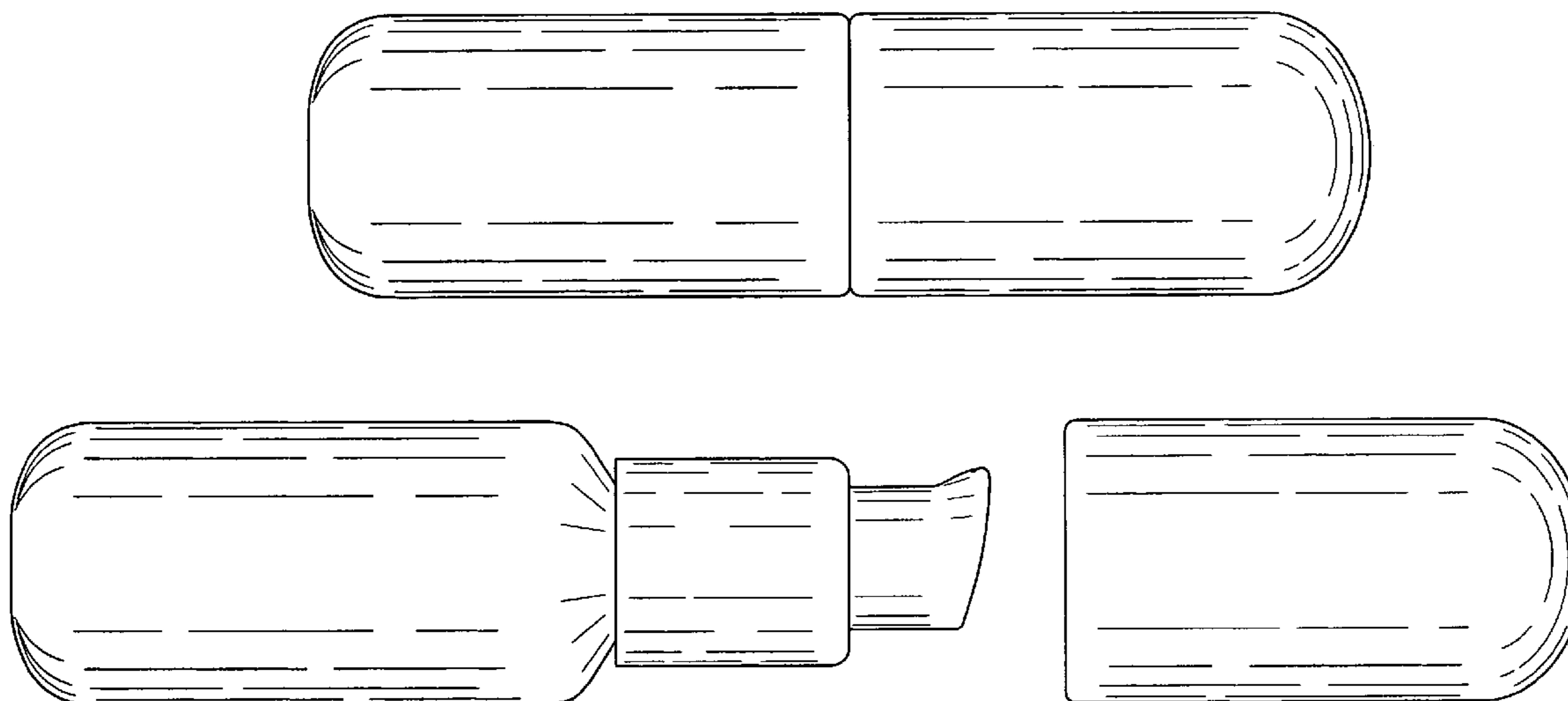
FIG. 4 is an exploded front view thereof;

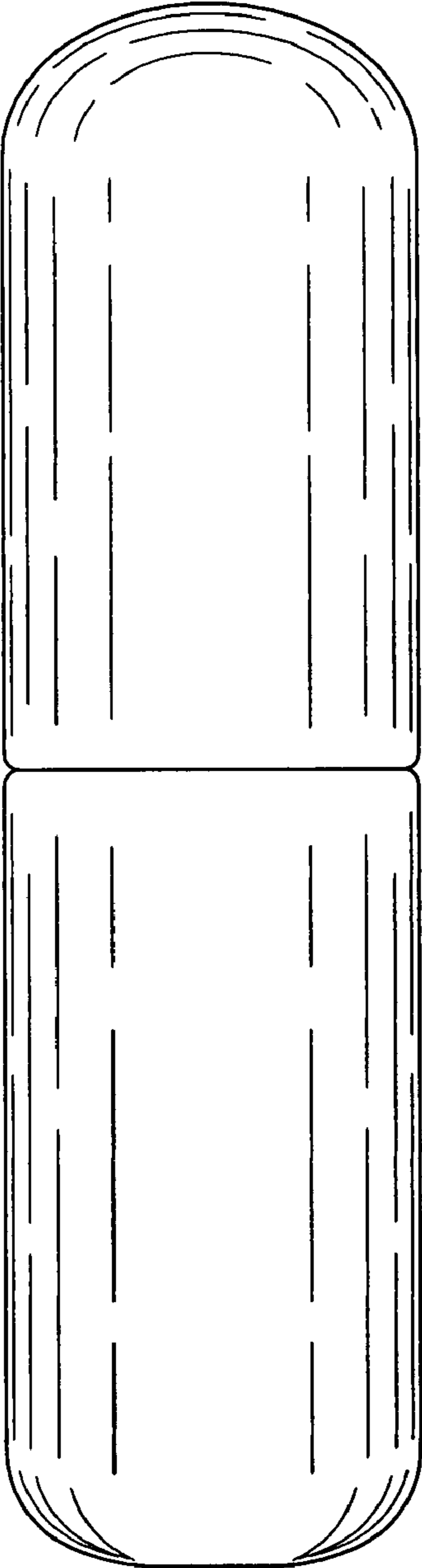

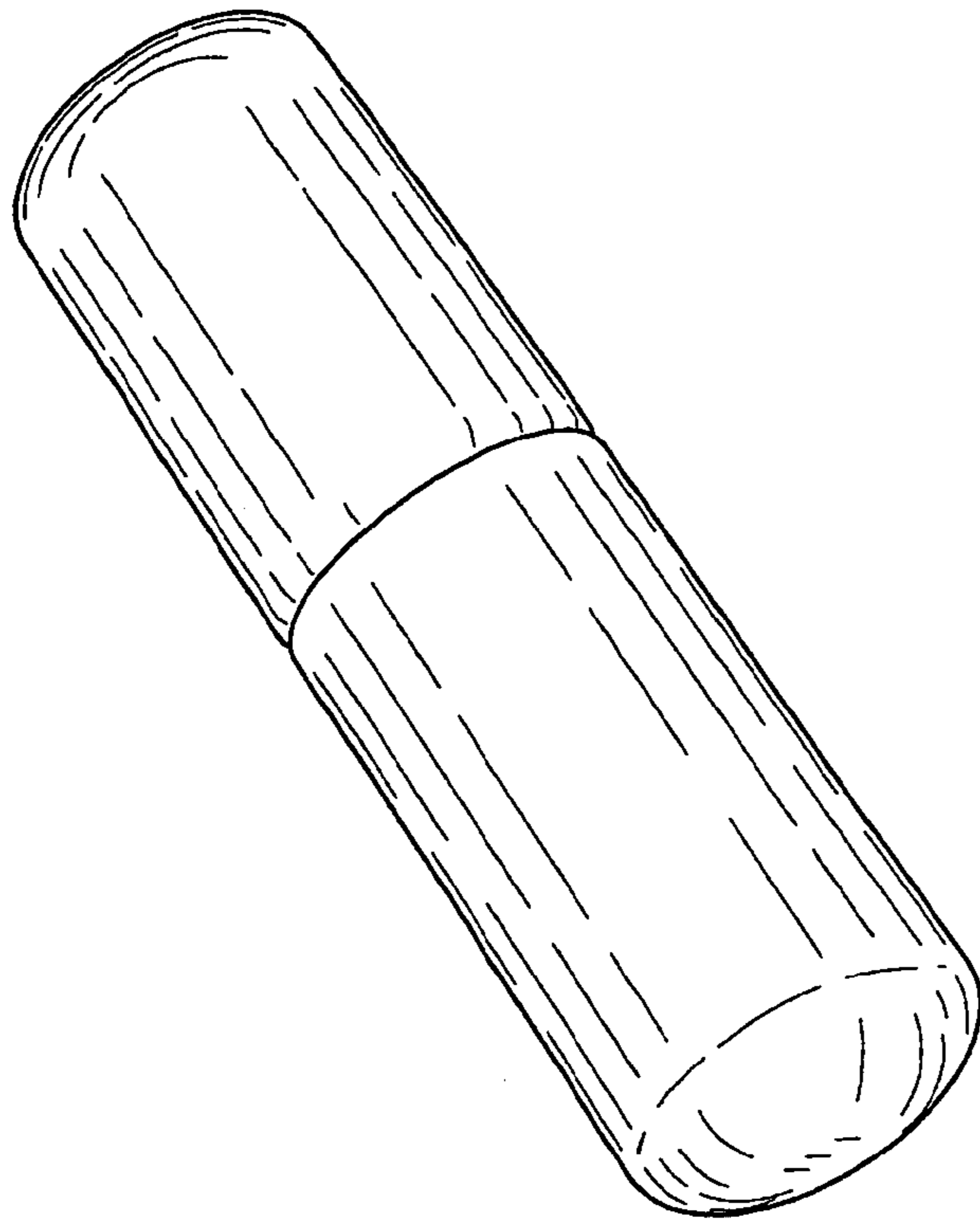

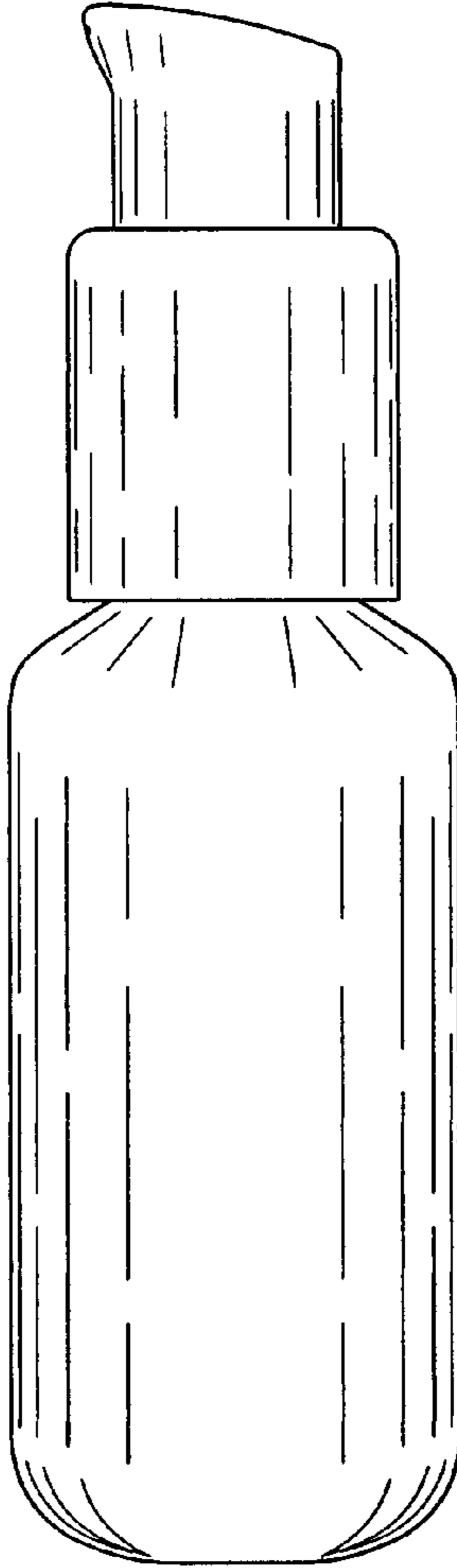
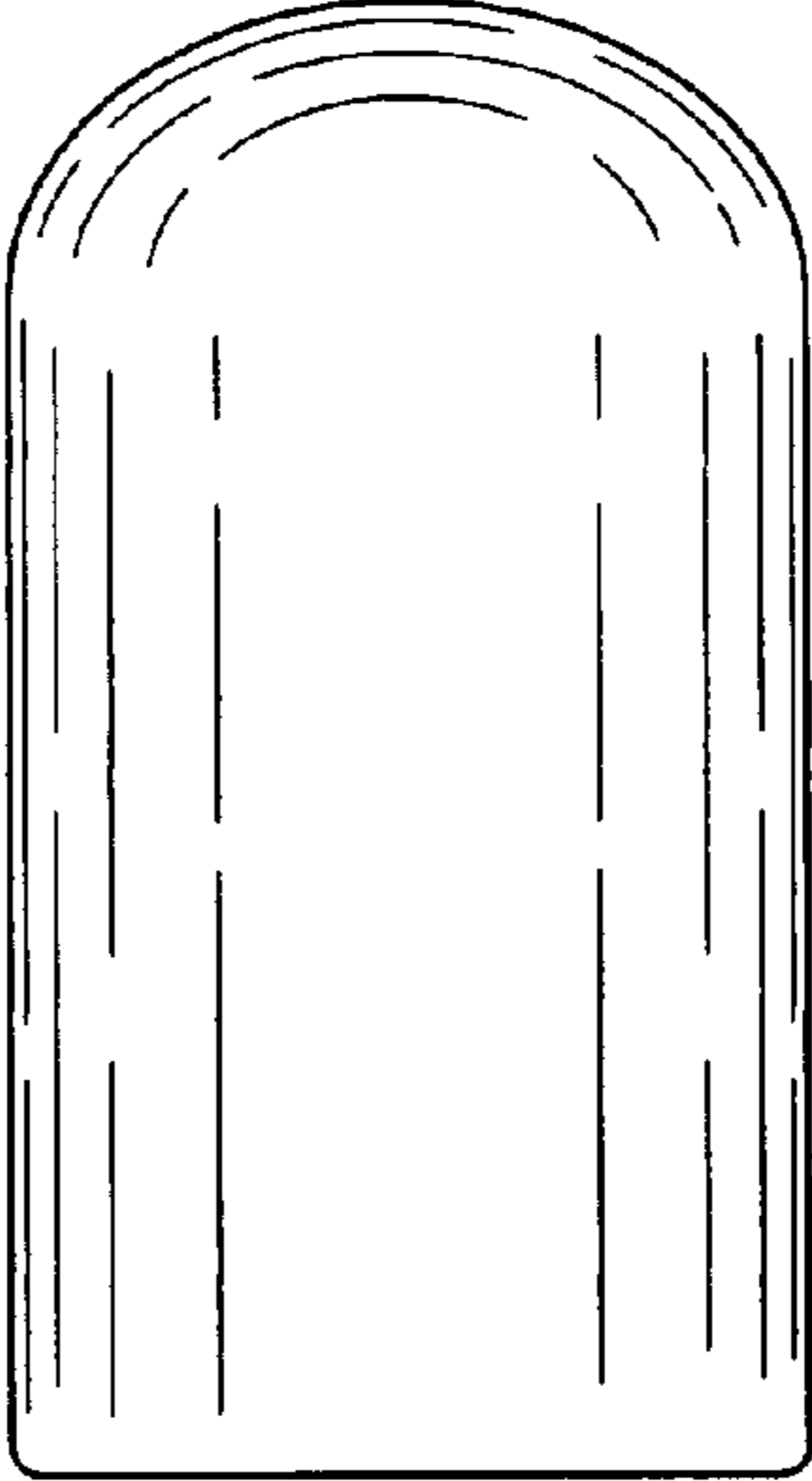

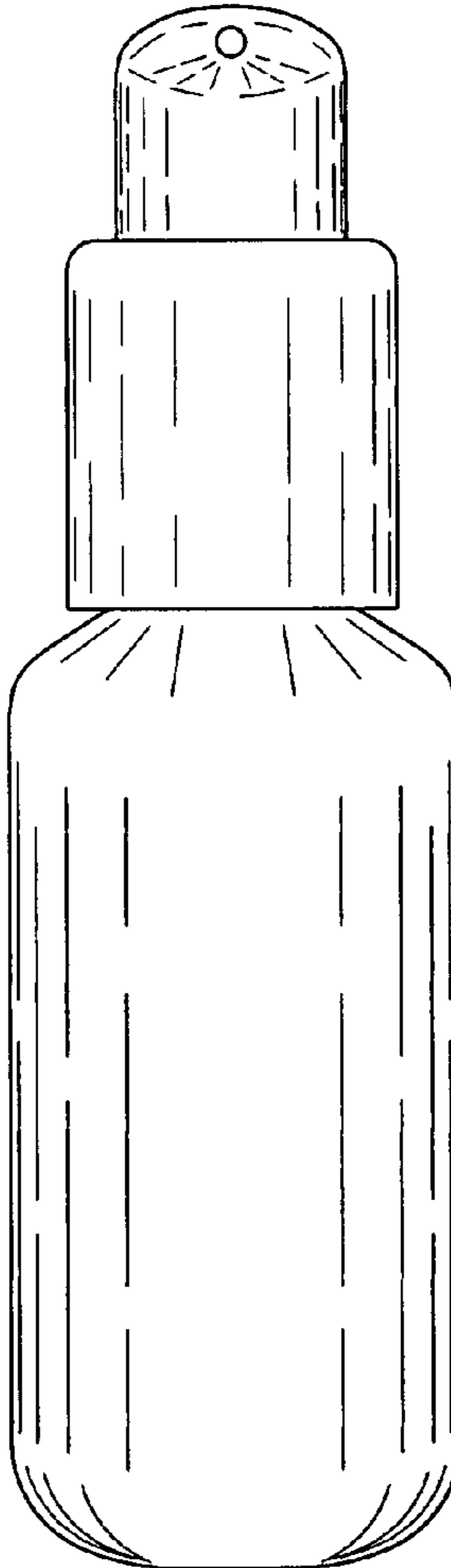
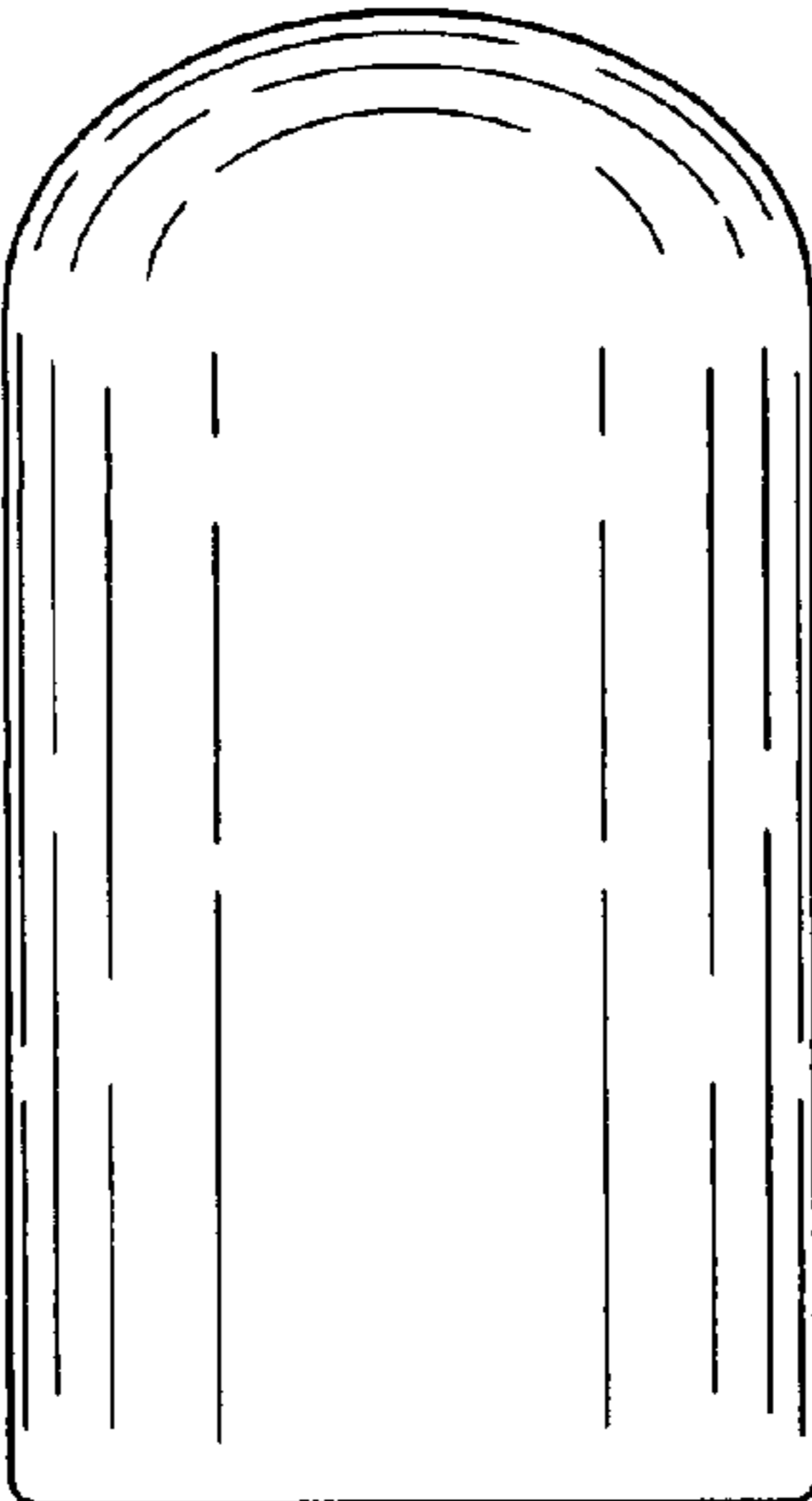

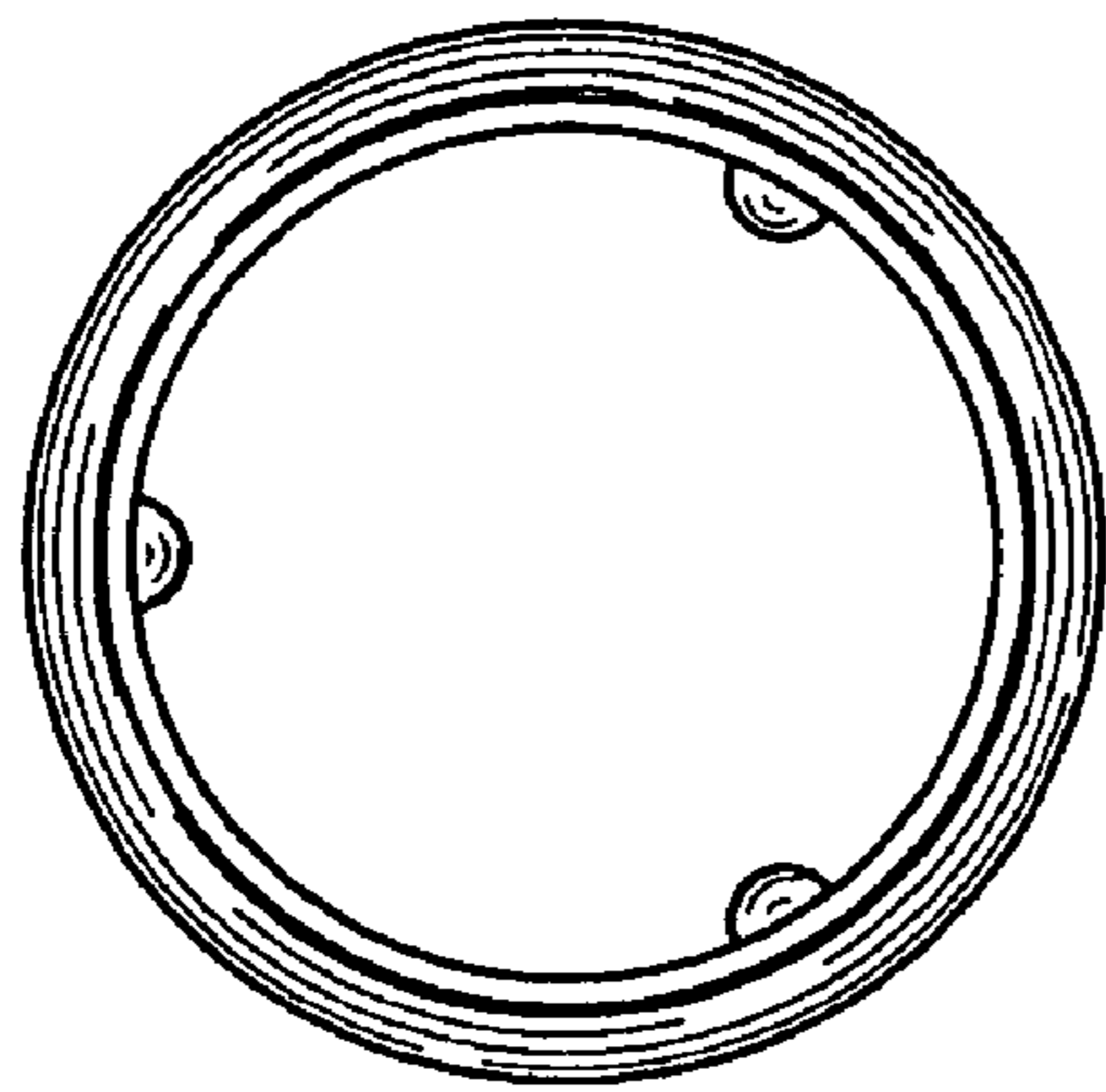

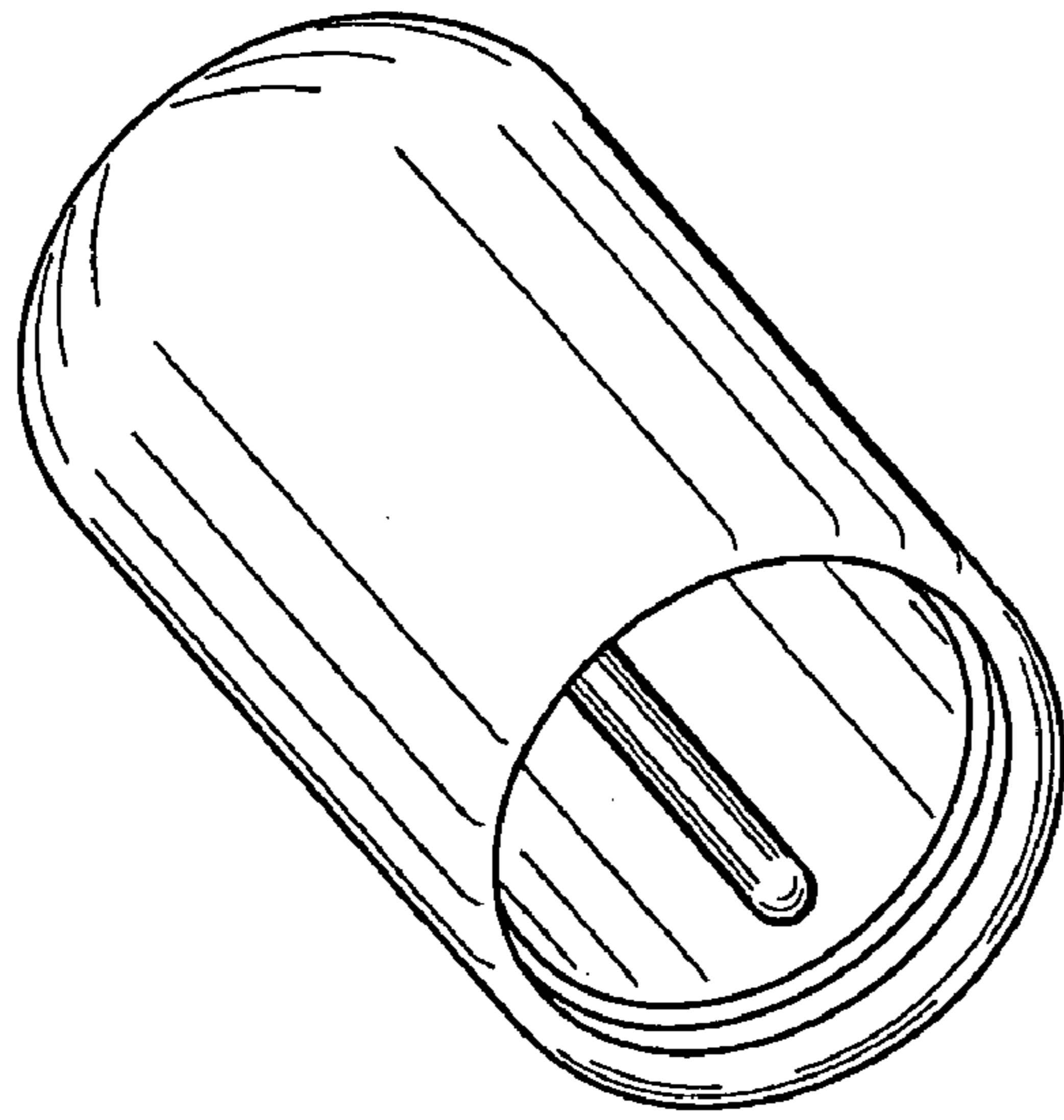
