The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle showing my new design;

FIG. 2 is a front side view of the bottle as shown in FIG. 1;

FIG. 3 is a back side view of the bottle as shown in FIG. 1;

FIG. 4 is a right side view of the bottle as shown in FIG. 1;

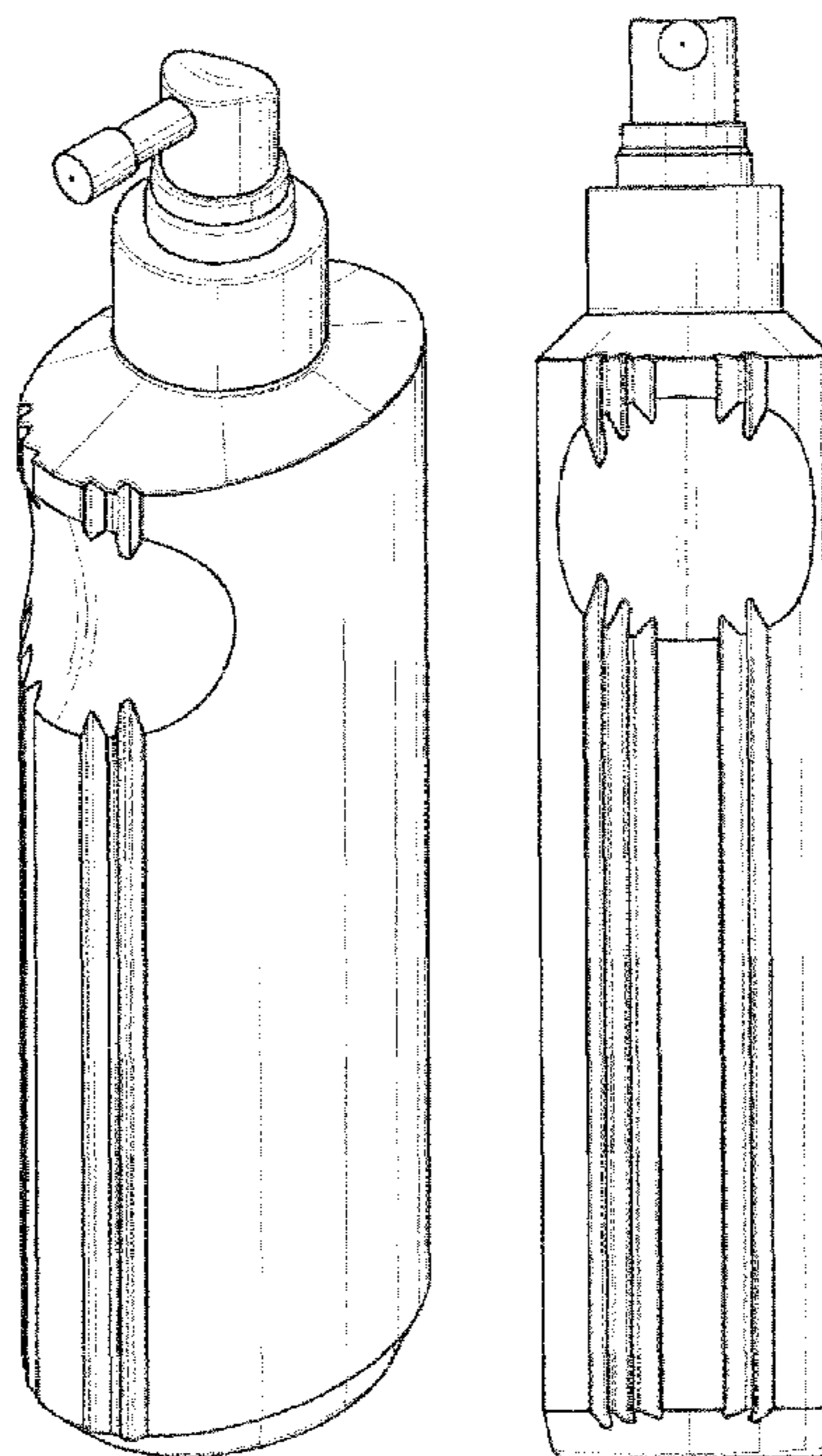
FIG. 5 is a left side view of the bottle as shown in FIG. 1;

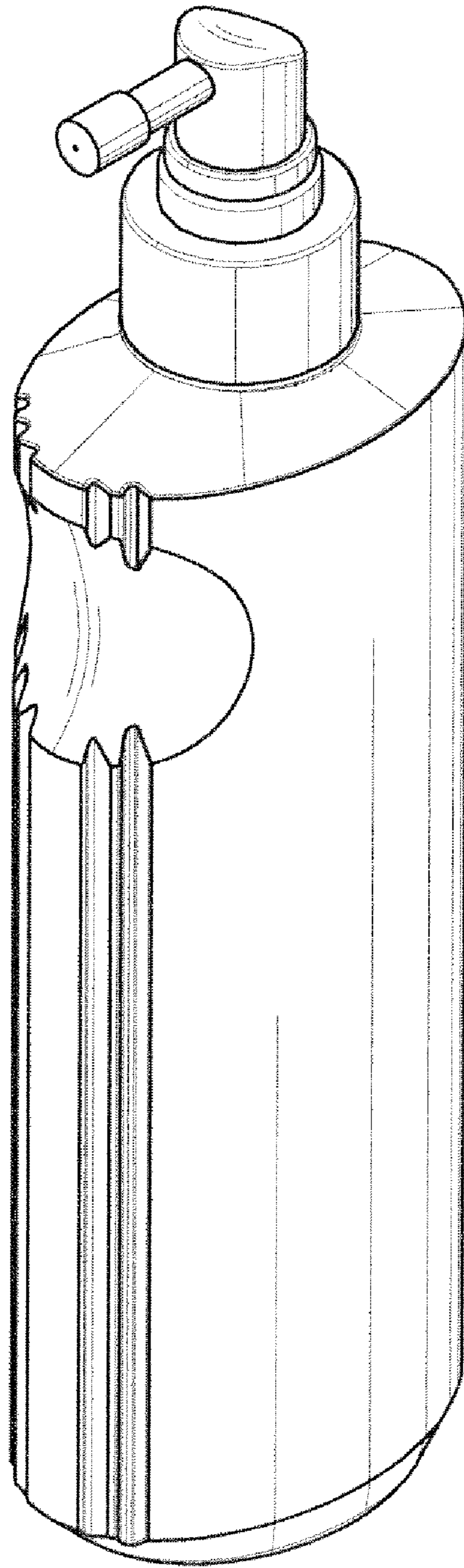

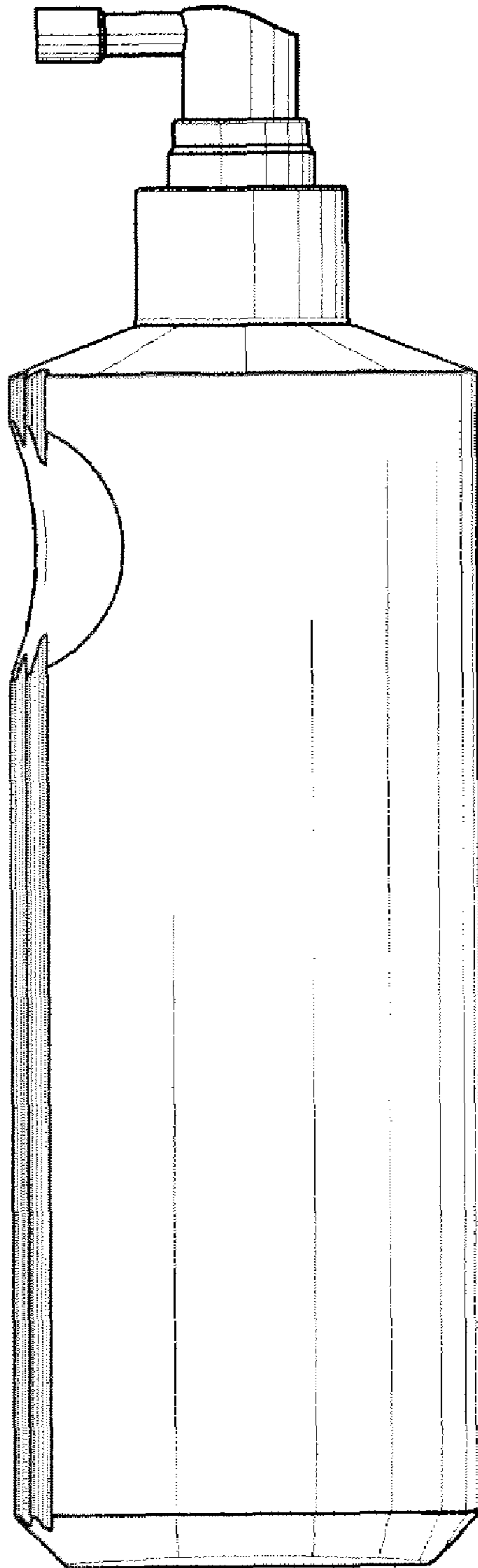

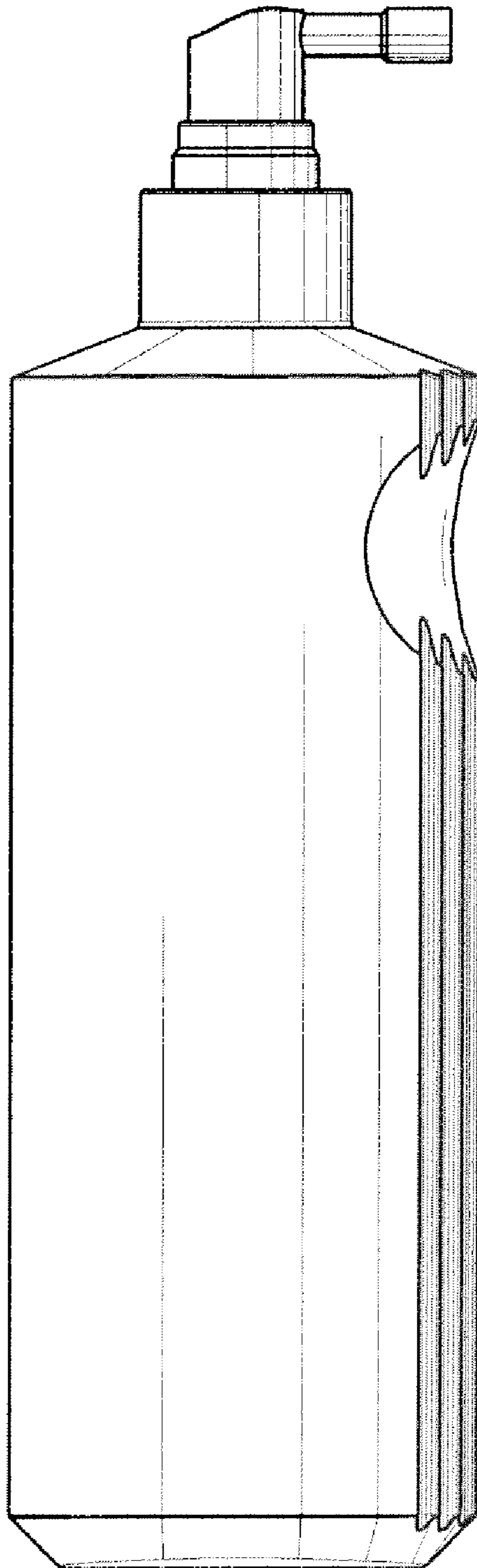

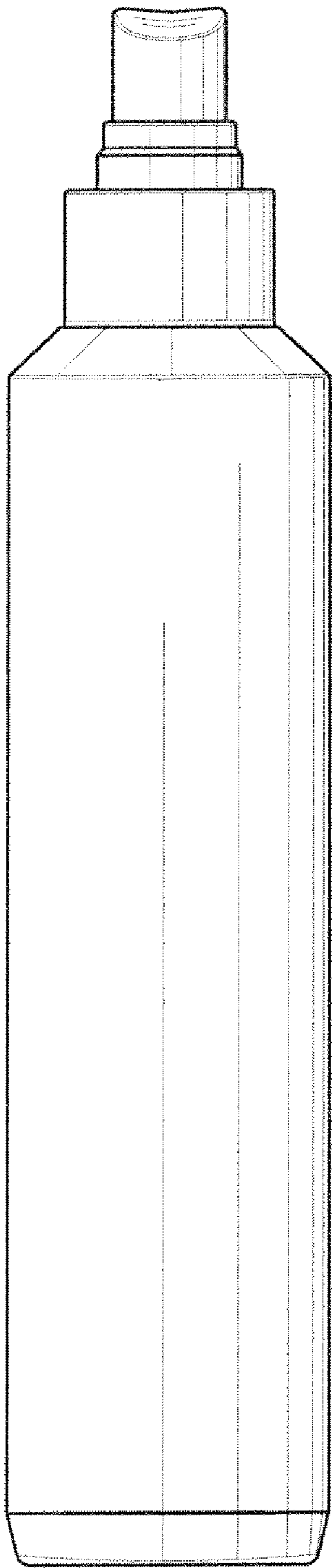

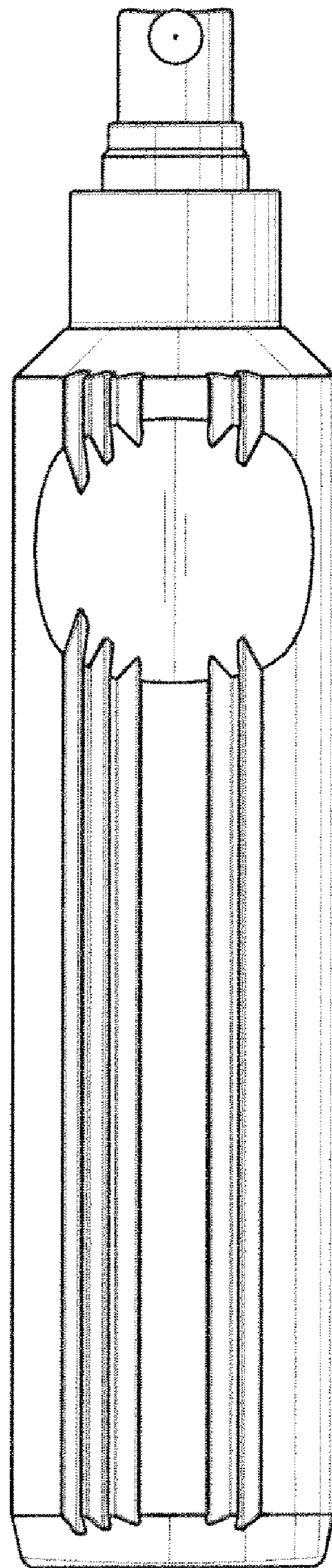

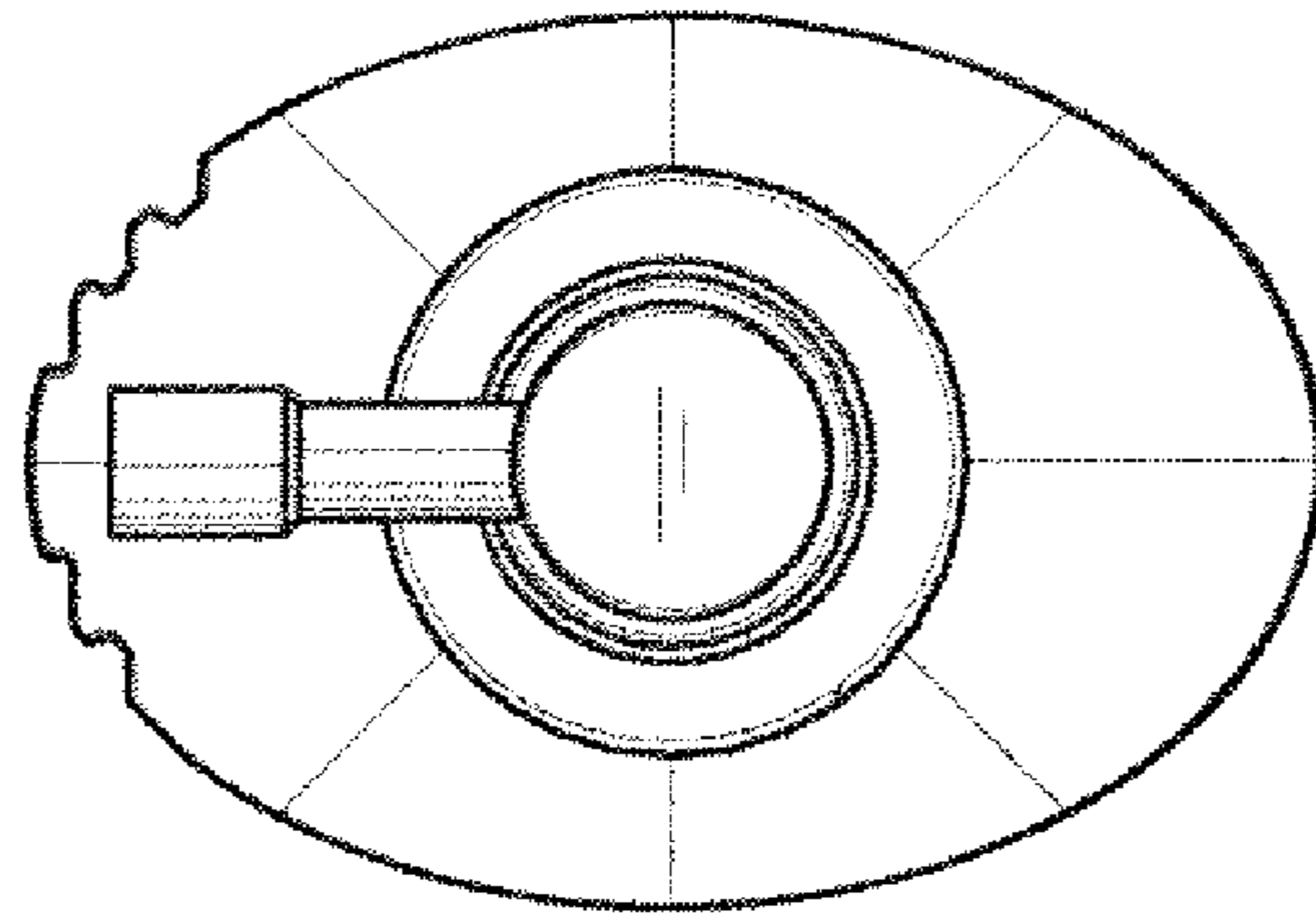

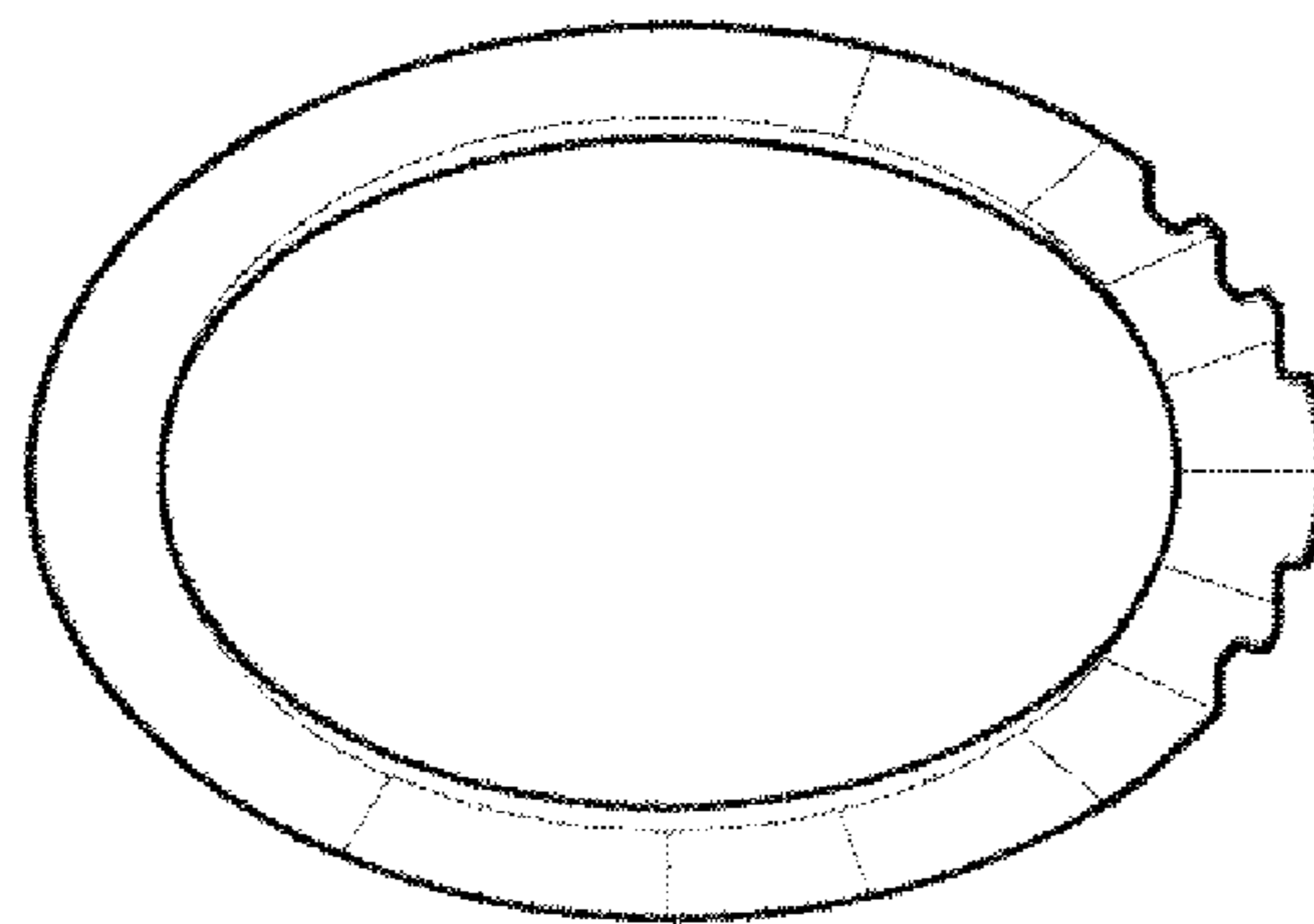
