FIG. 4 is a top side perspective view thereof;

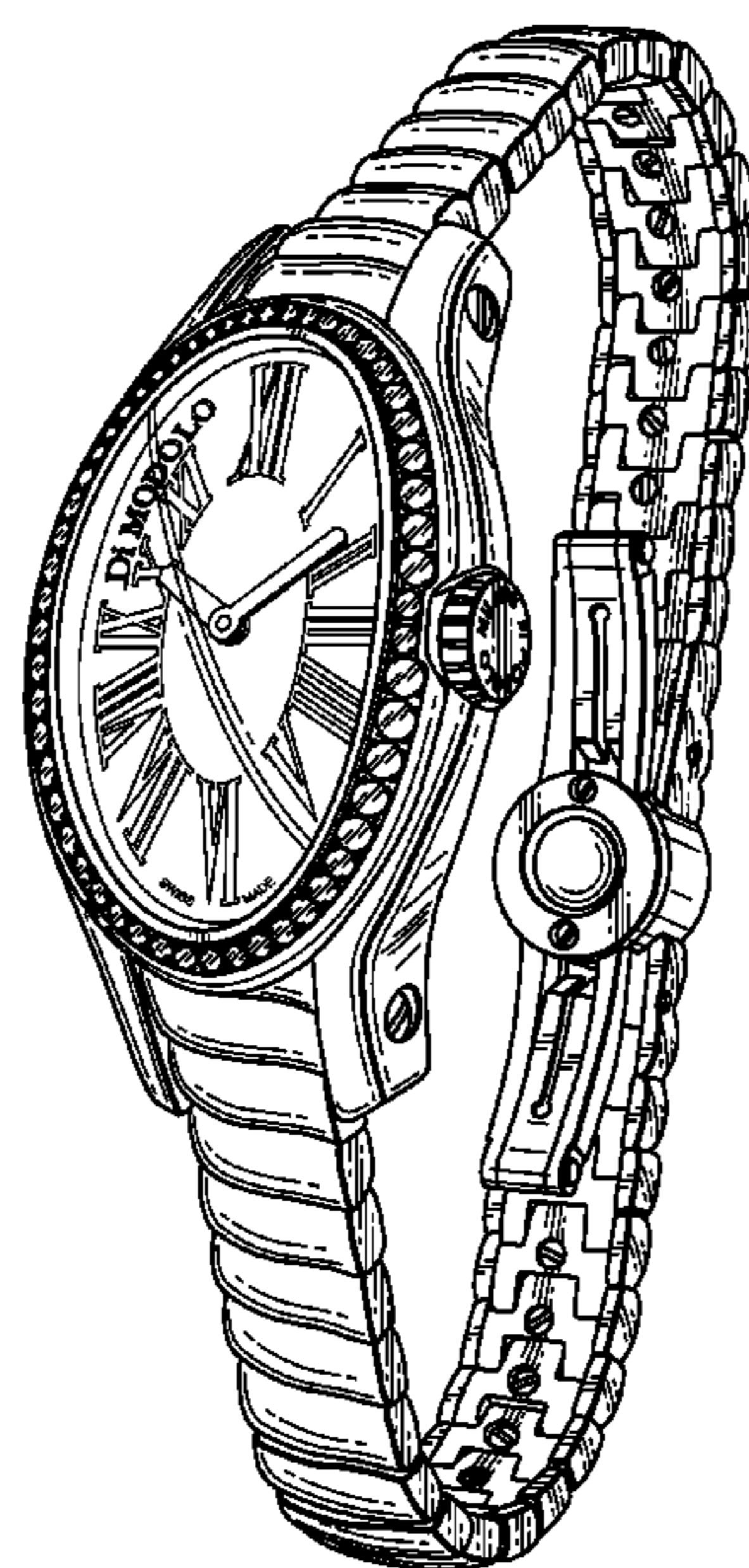
FIG. 5 is right side view thereof;

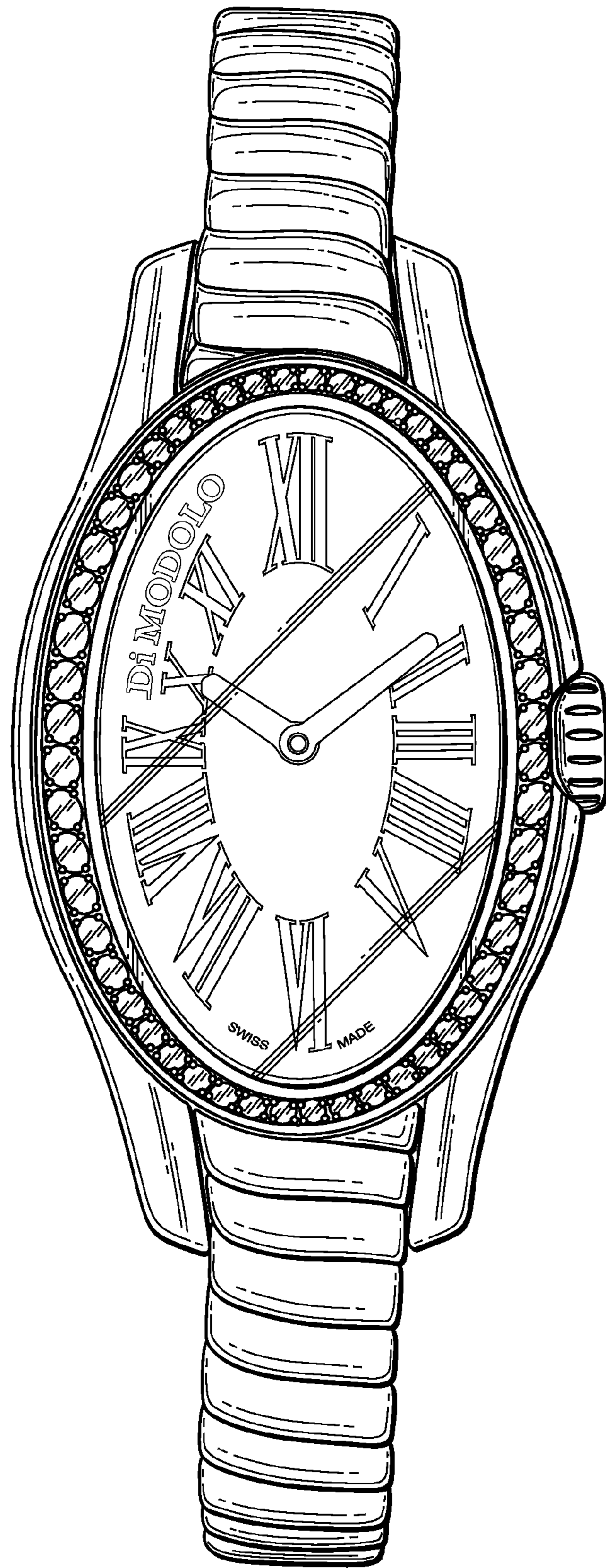

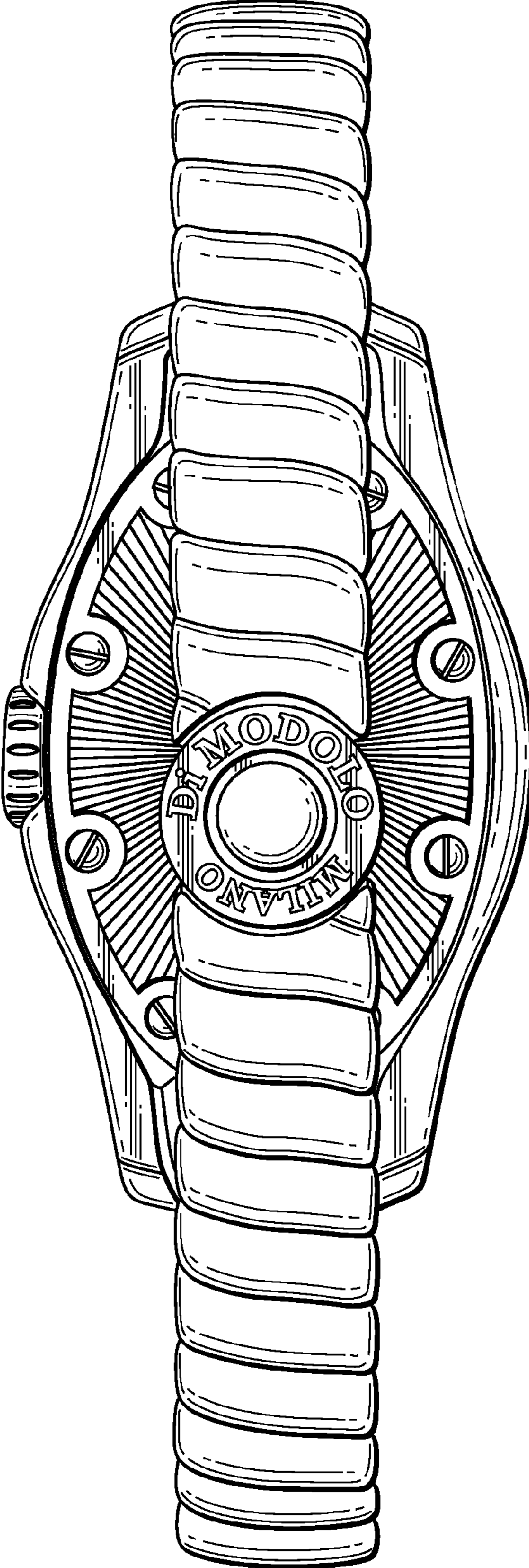

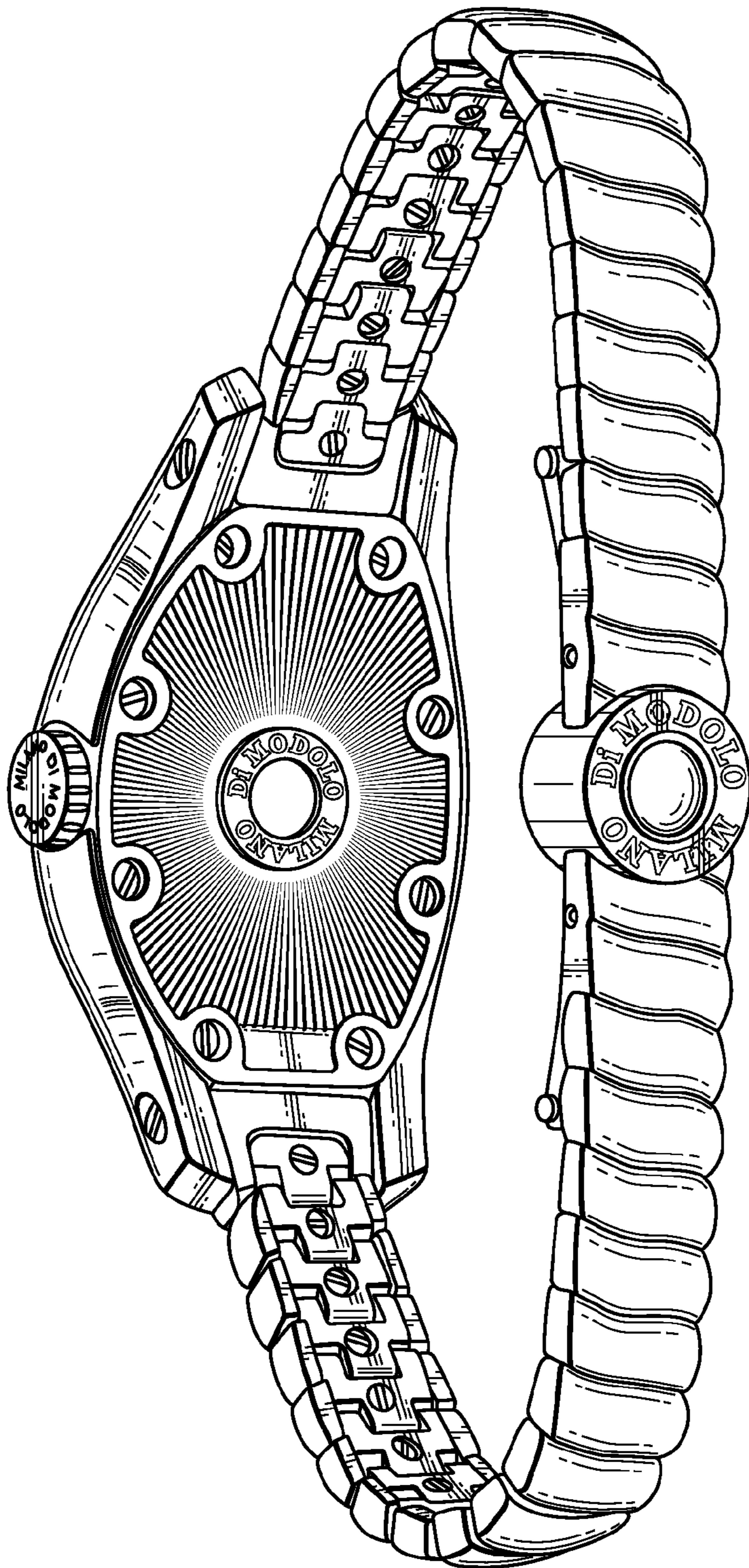

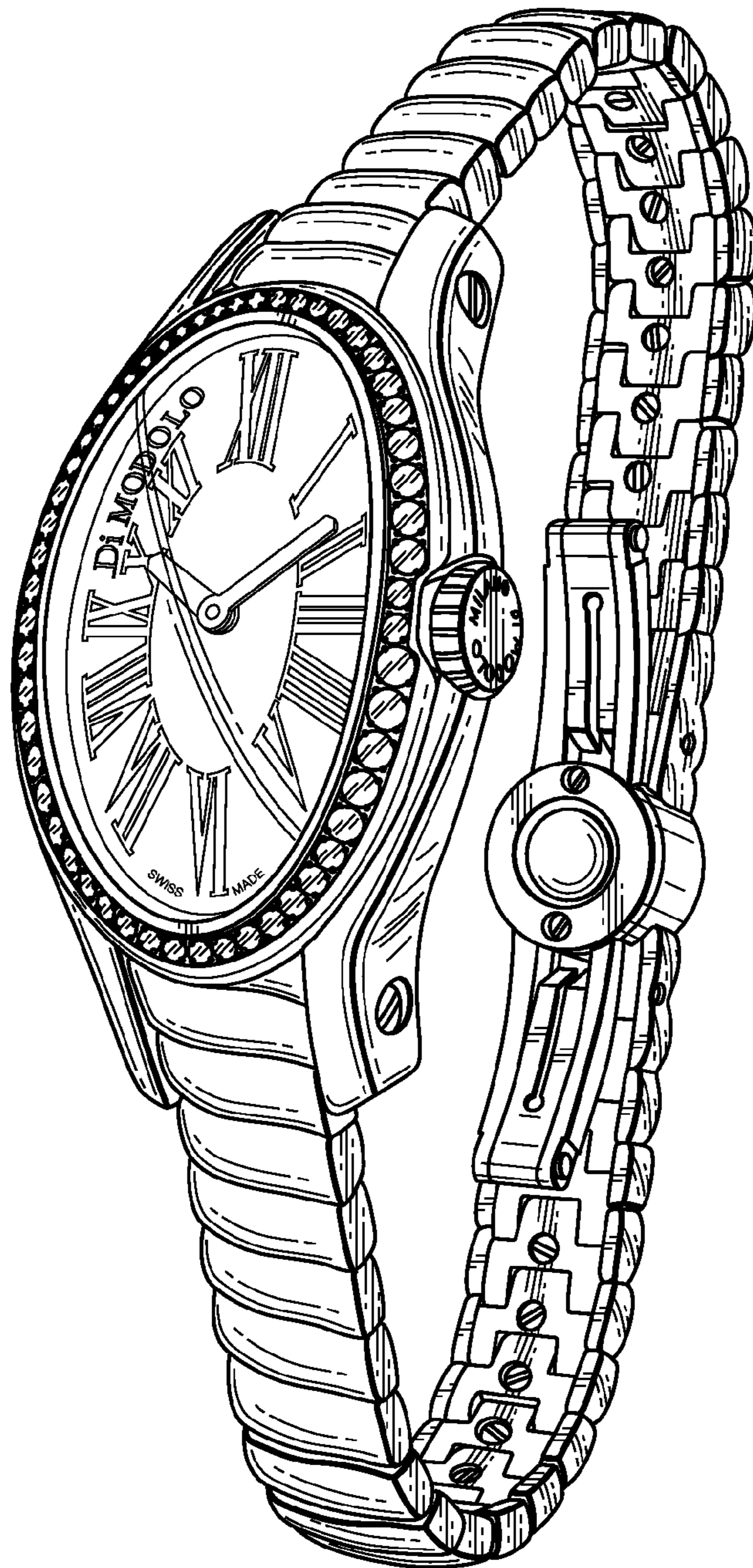

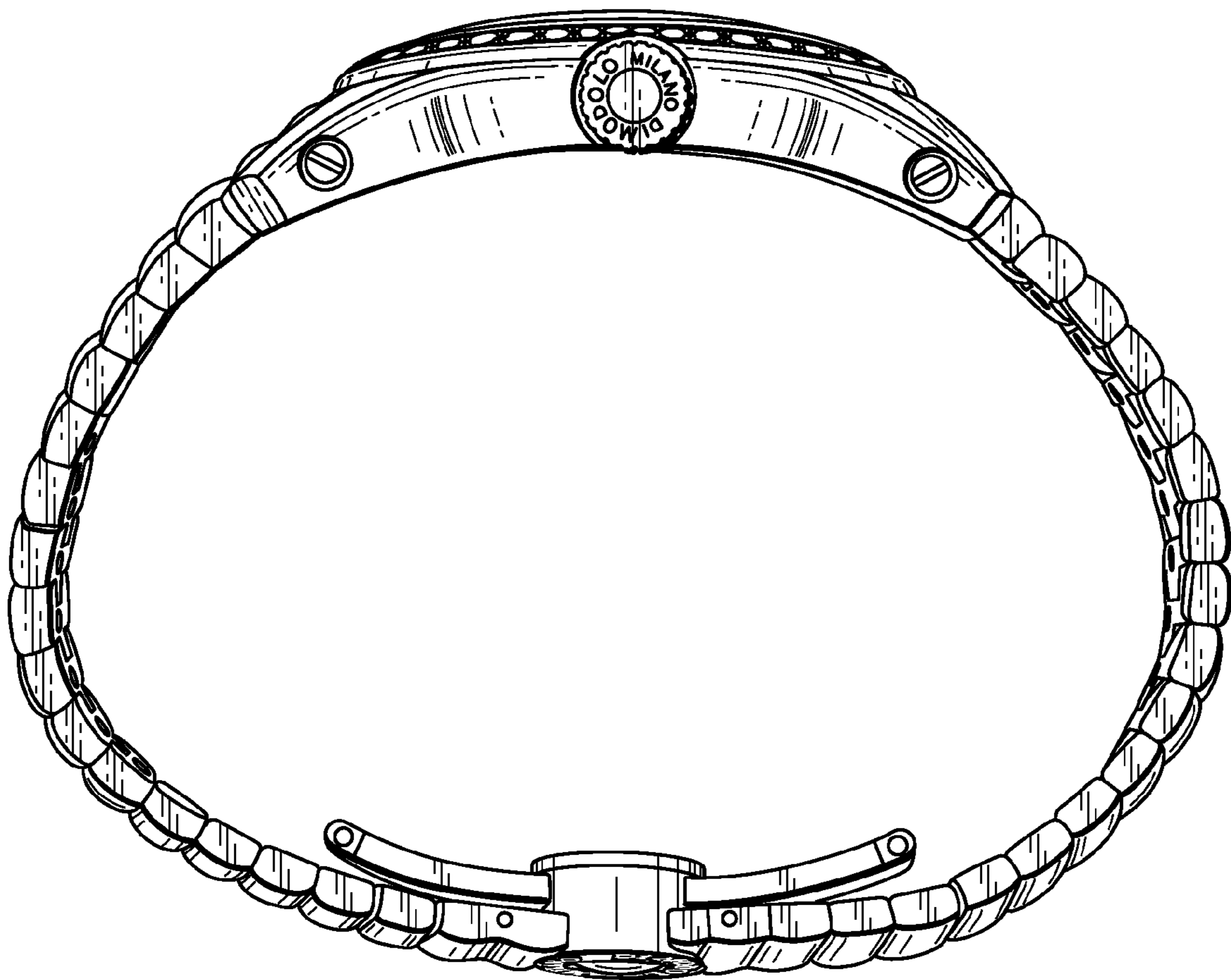

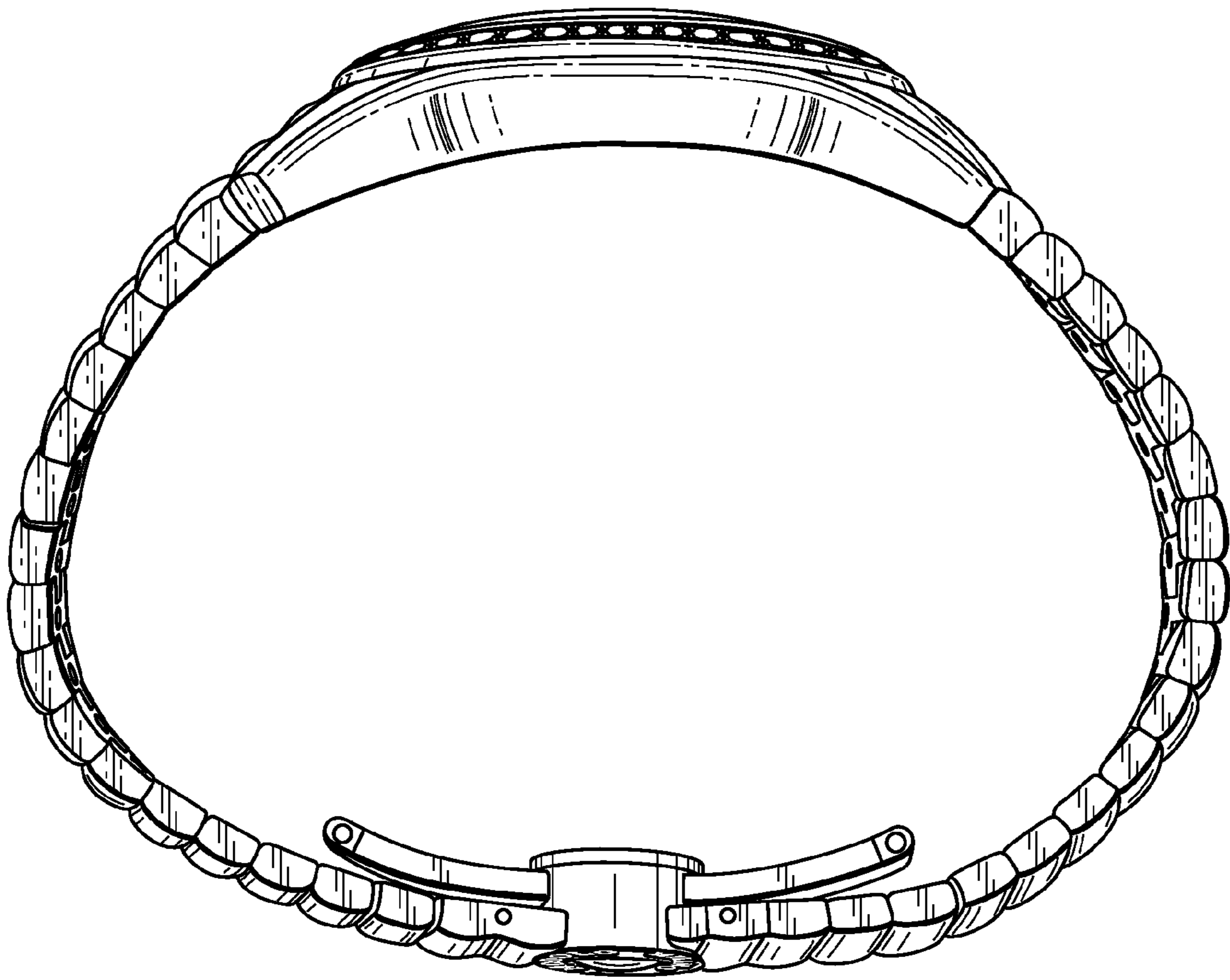

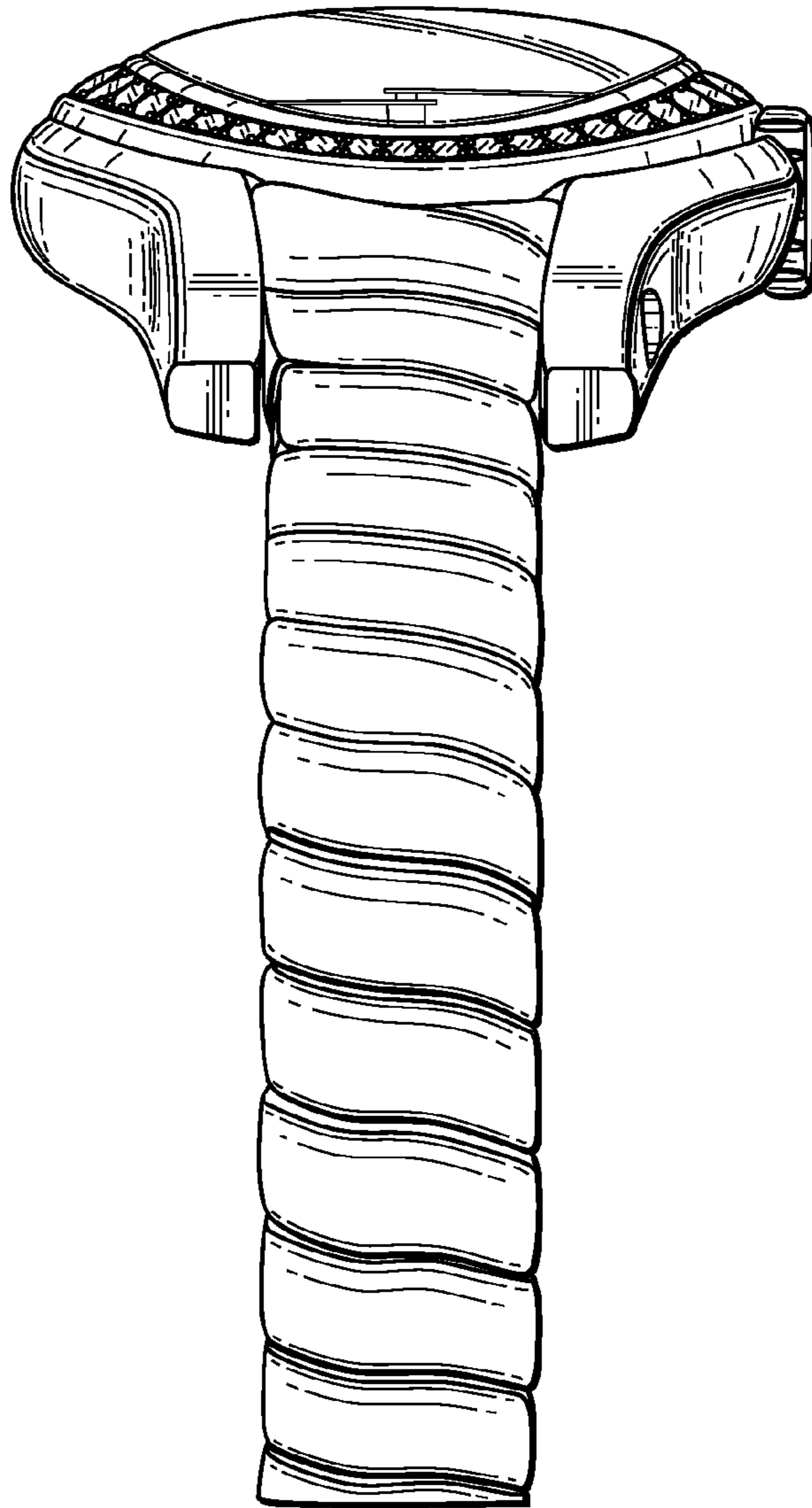

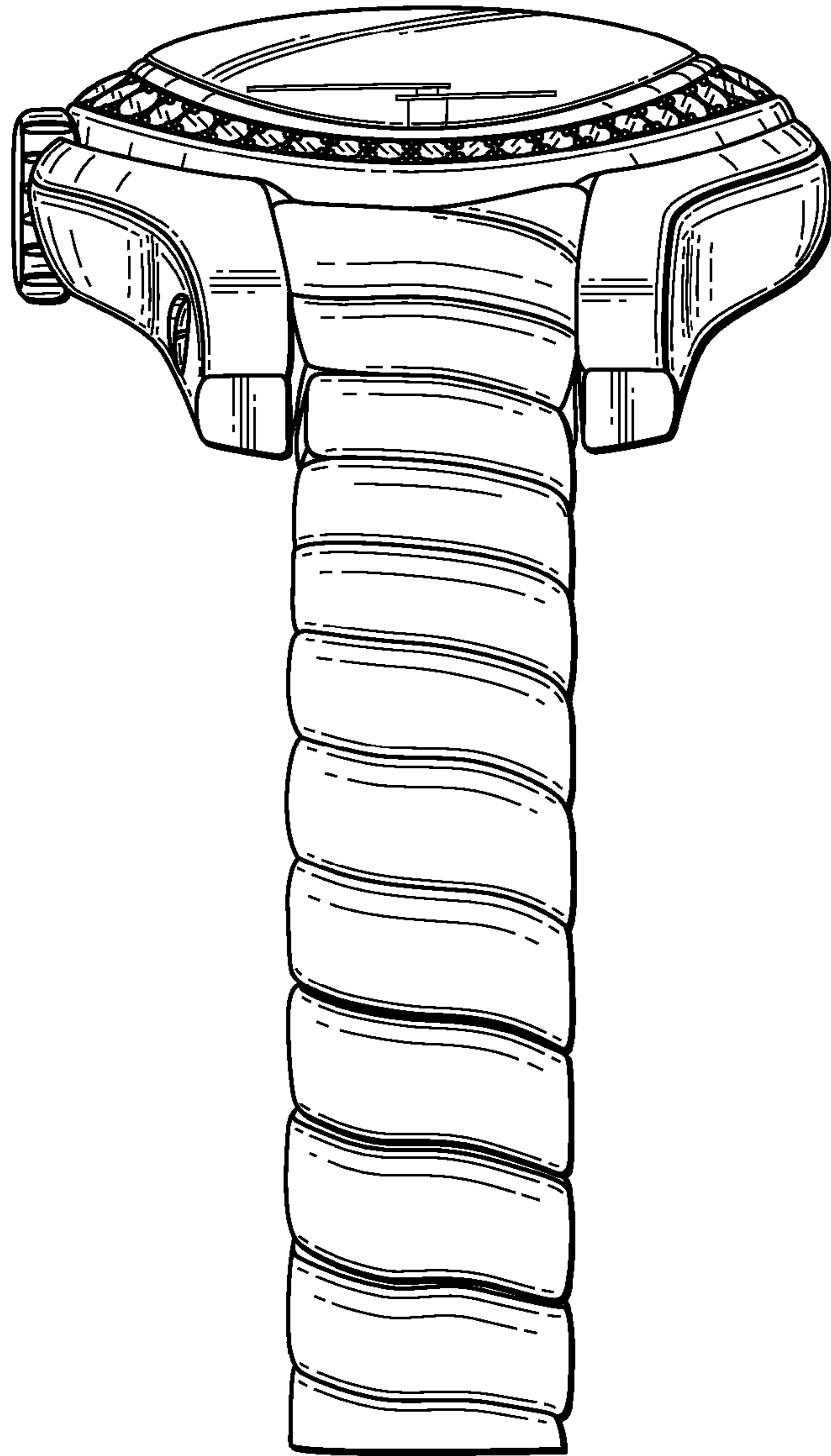
