(57) **CLAIM**

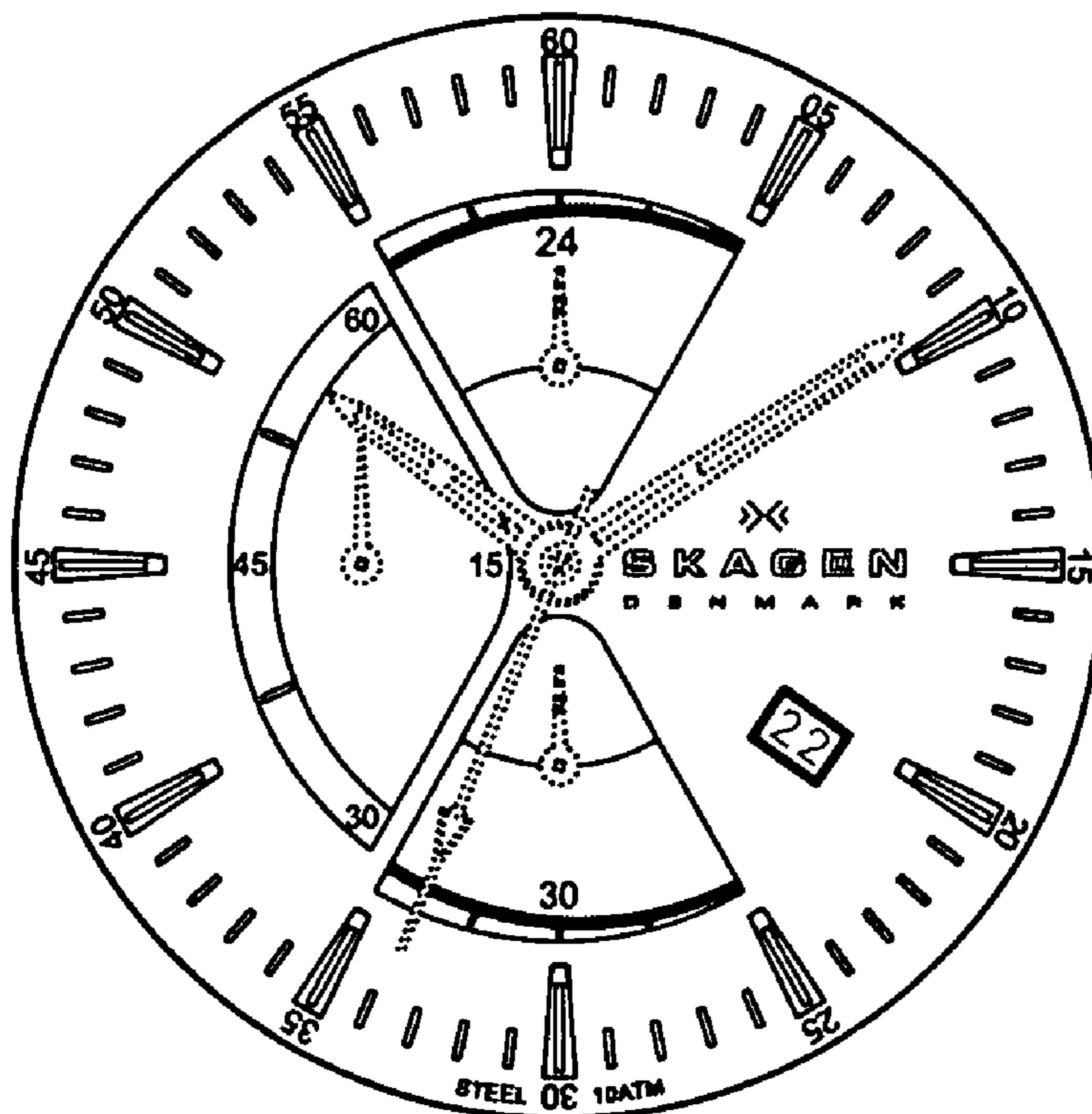
The ornamental design for a watch dial, as shown and described.

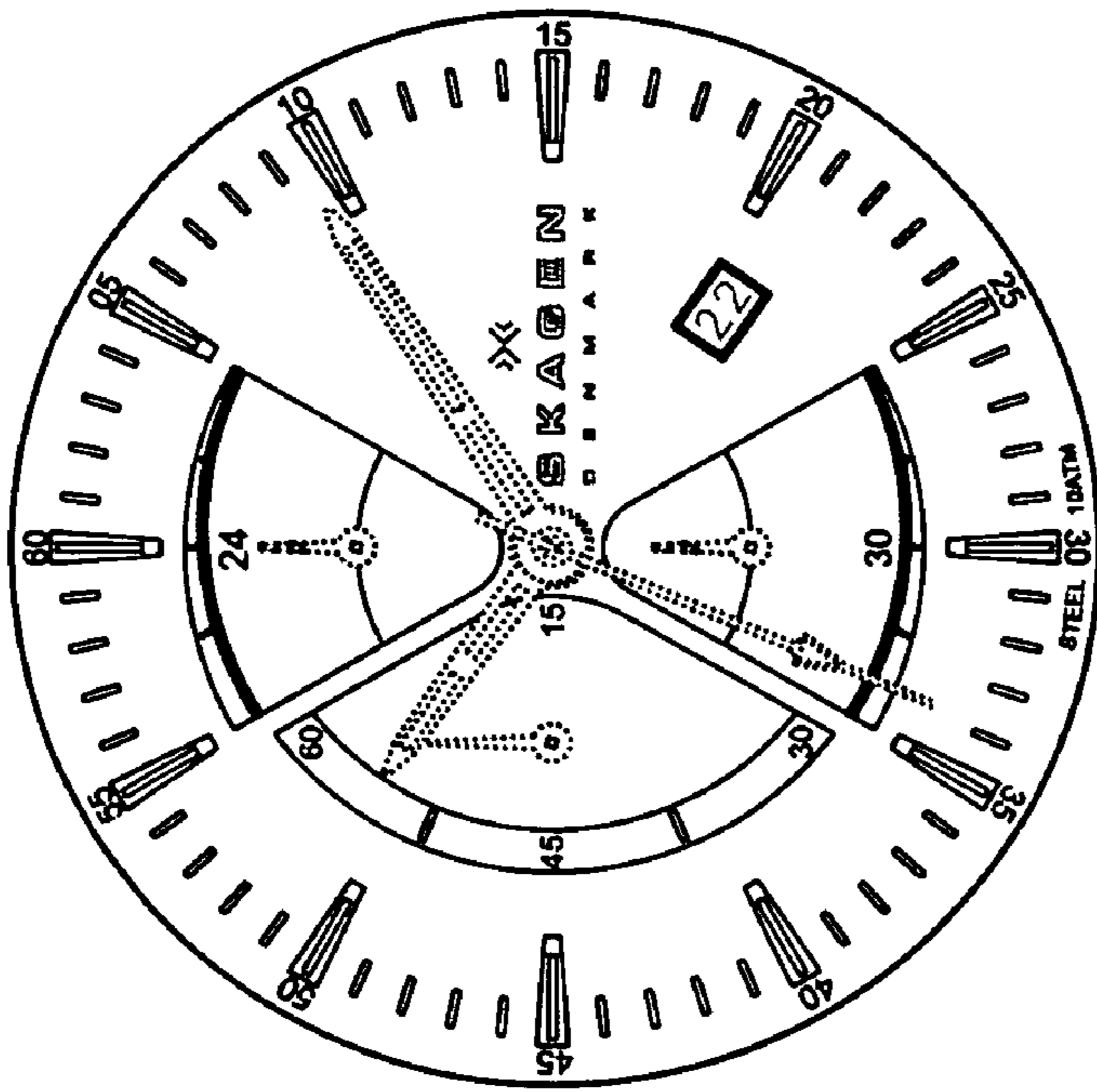
