(57) **CLAIM**

The ornamental design for a suspension strut, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a suspension strut that is arranged and configured in accordance with a preferred embodiment;

FIG. 2 is a front view of the suspension strut of FIG. 1;

FIG. 3 is a rear view of the suspension strut of FIG. 1;

FIG. 4 is a right side view of the suspension strut of FIG. 1 and the left side view is a mirror image of the right side view;

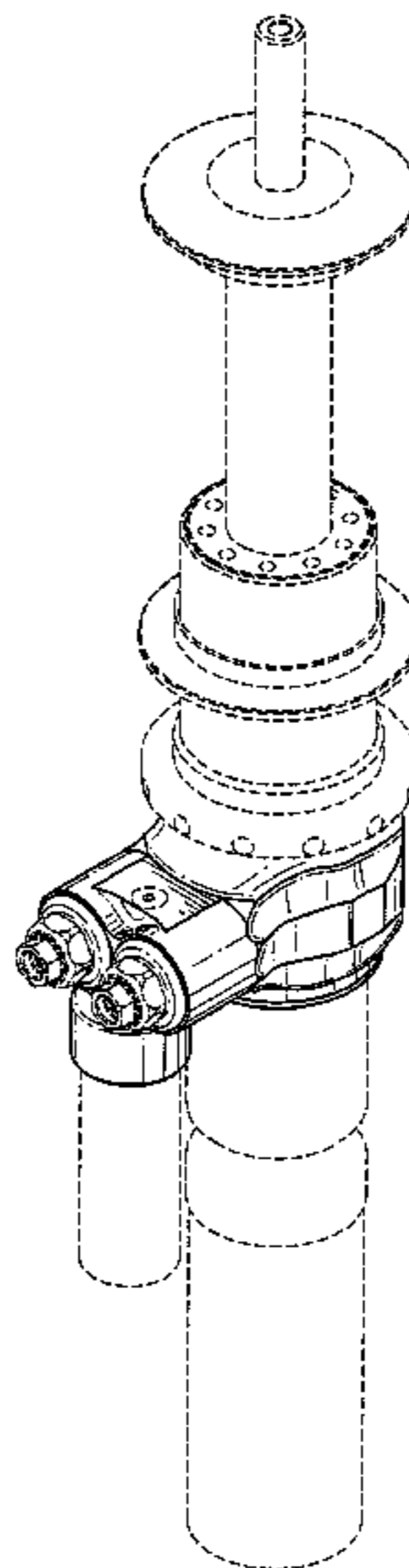
FIG. 5 is a top view of the suspension strut of FIG. 1;

FIG. 6 is a bottom view of the suspension strut of FIG. 1; and,

FIG. 7 is a bottom perspective view of the suspension strut of FIG. 1.

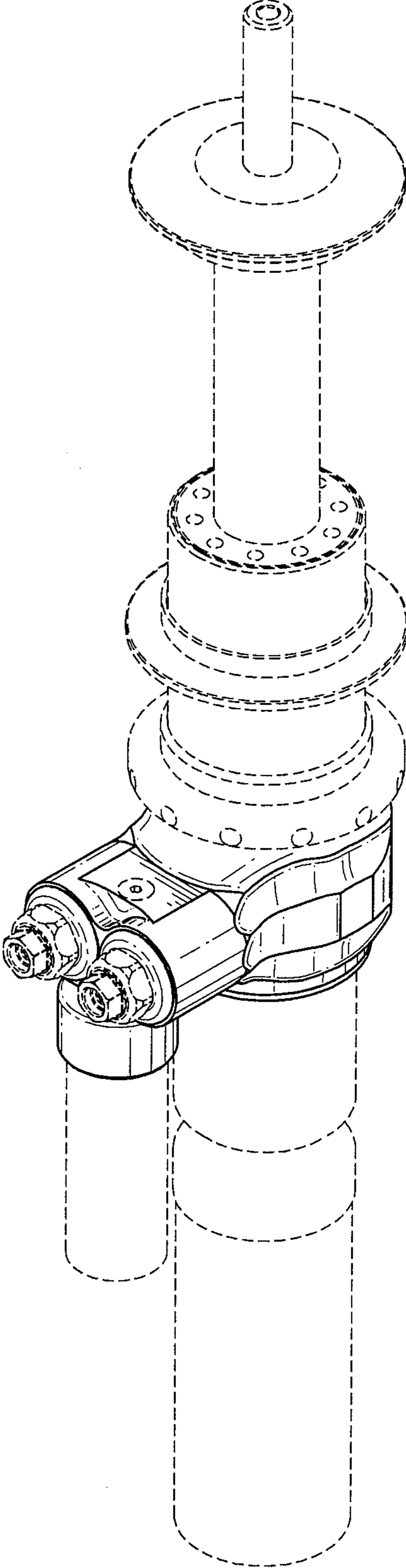

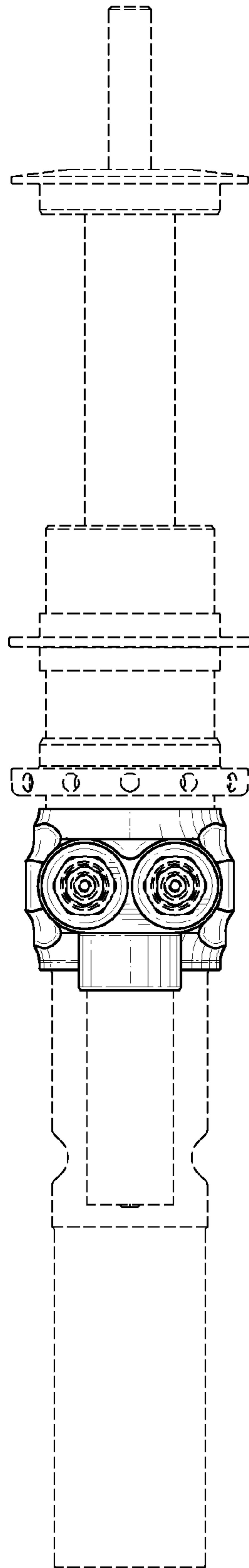

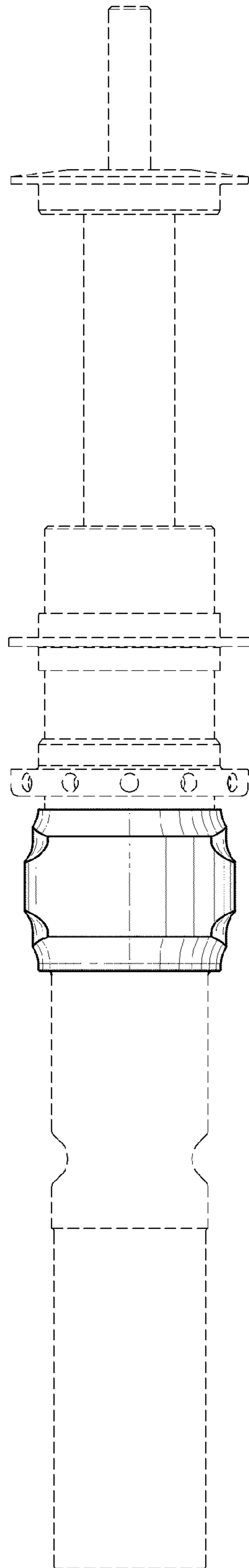

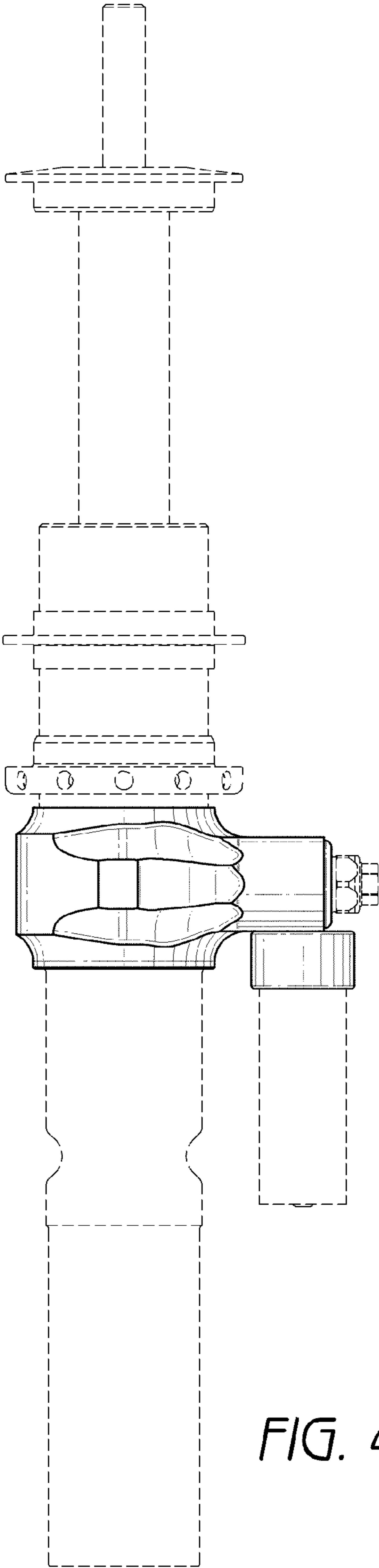

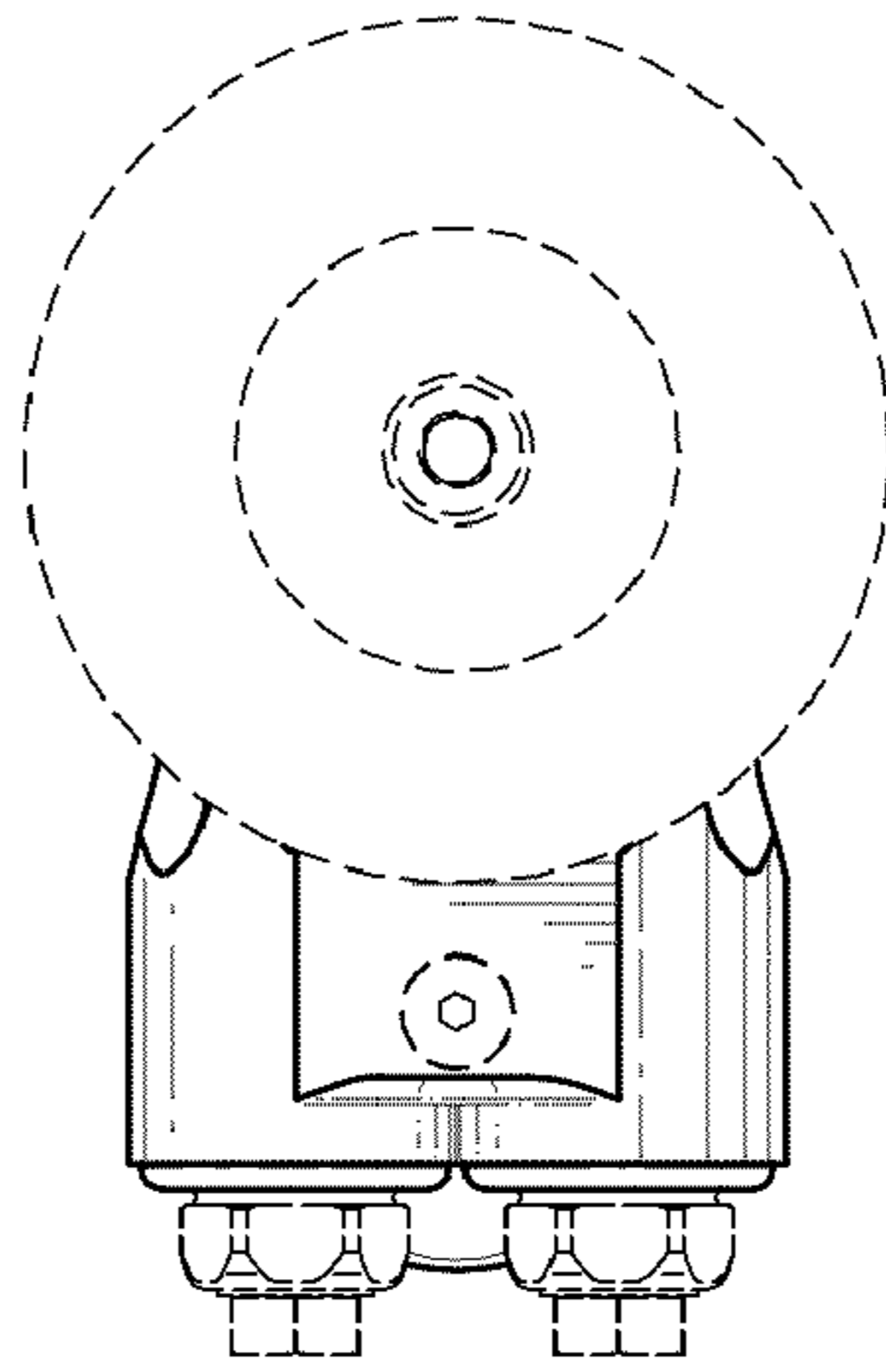

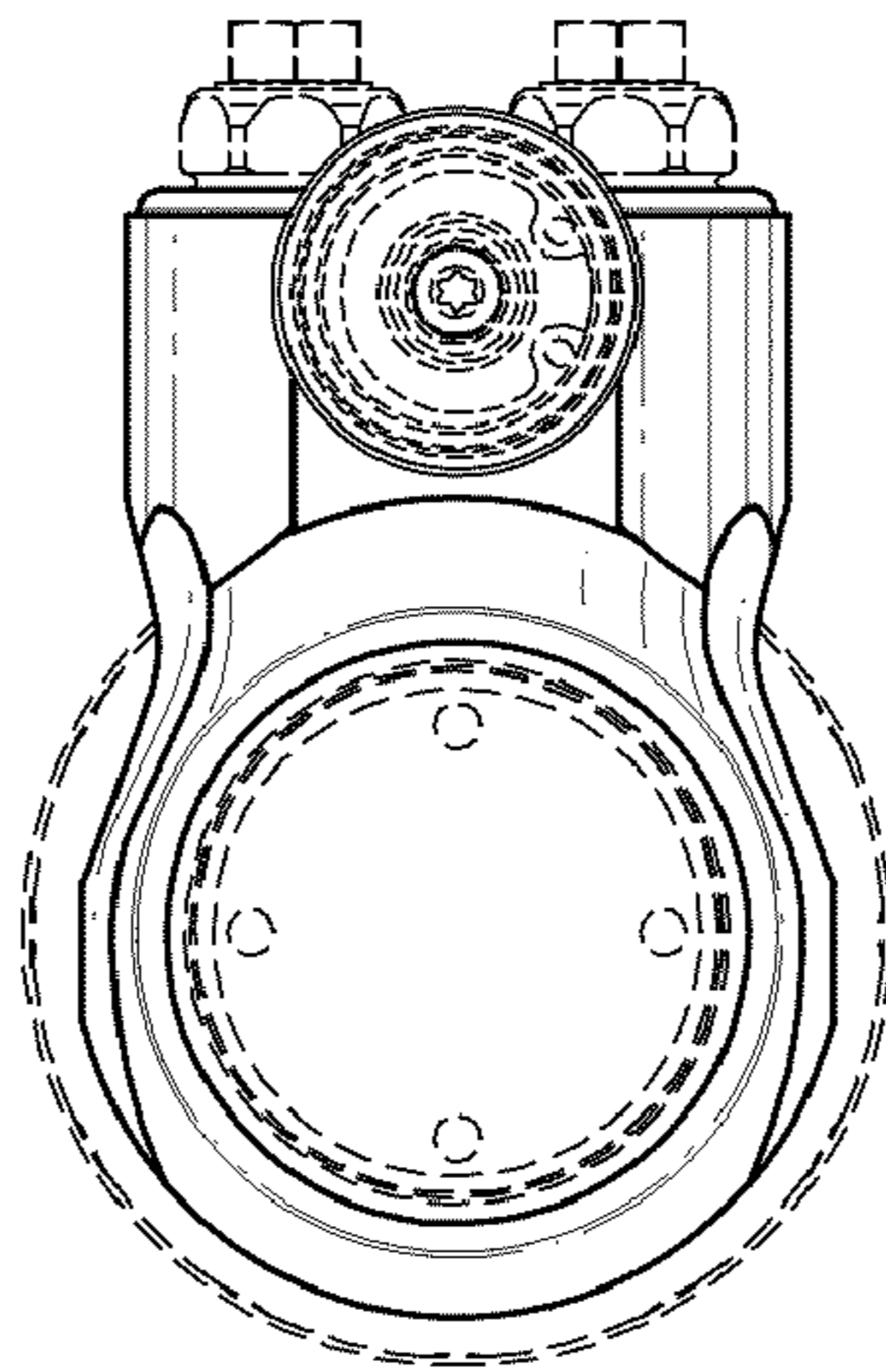

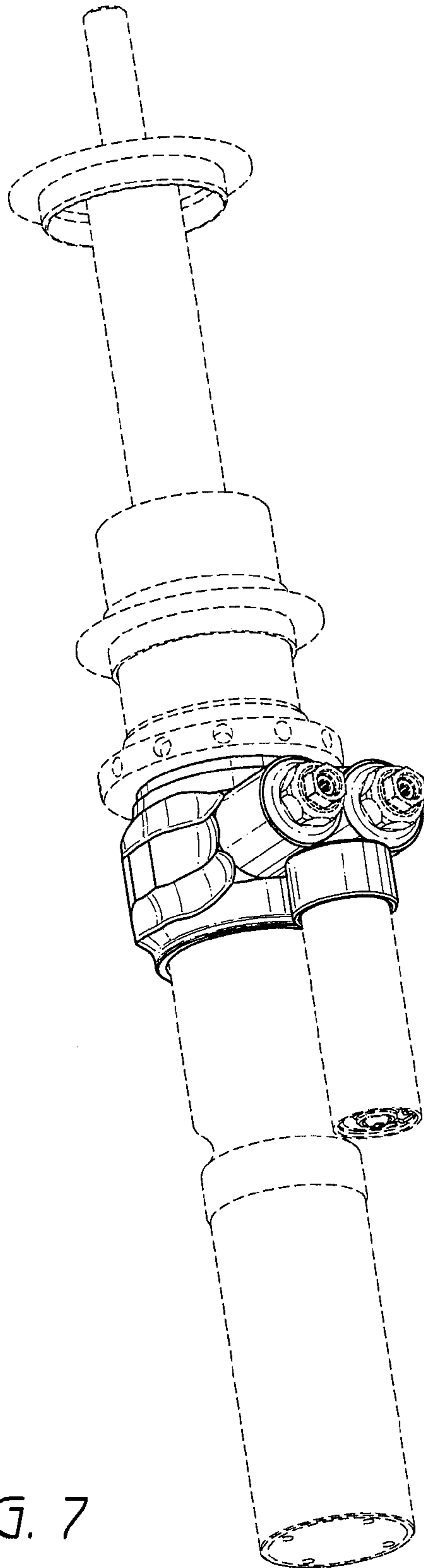
