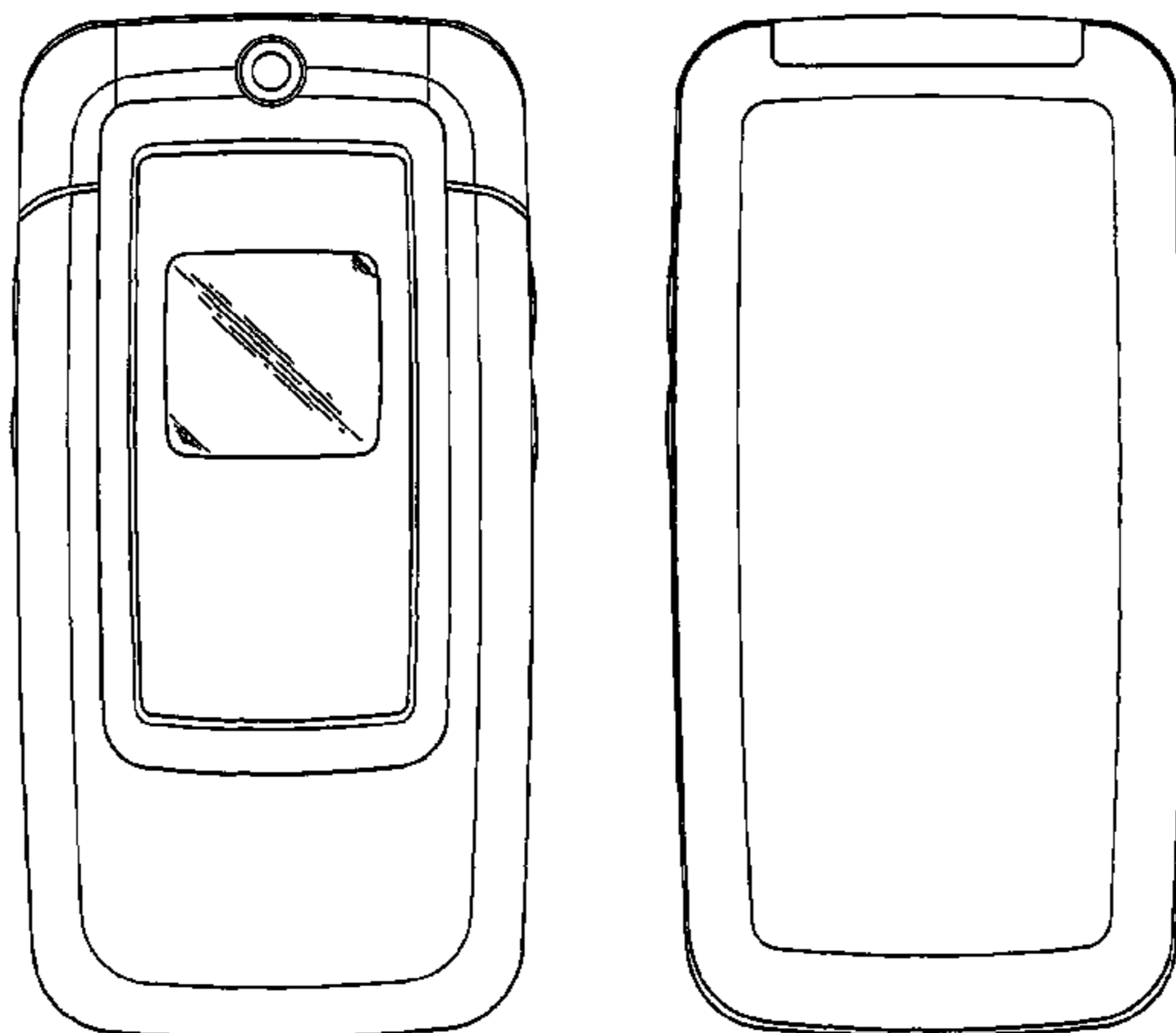
(57) **CLAIM**

The ornamental design for a portable phone, as shown and described.

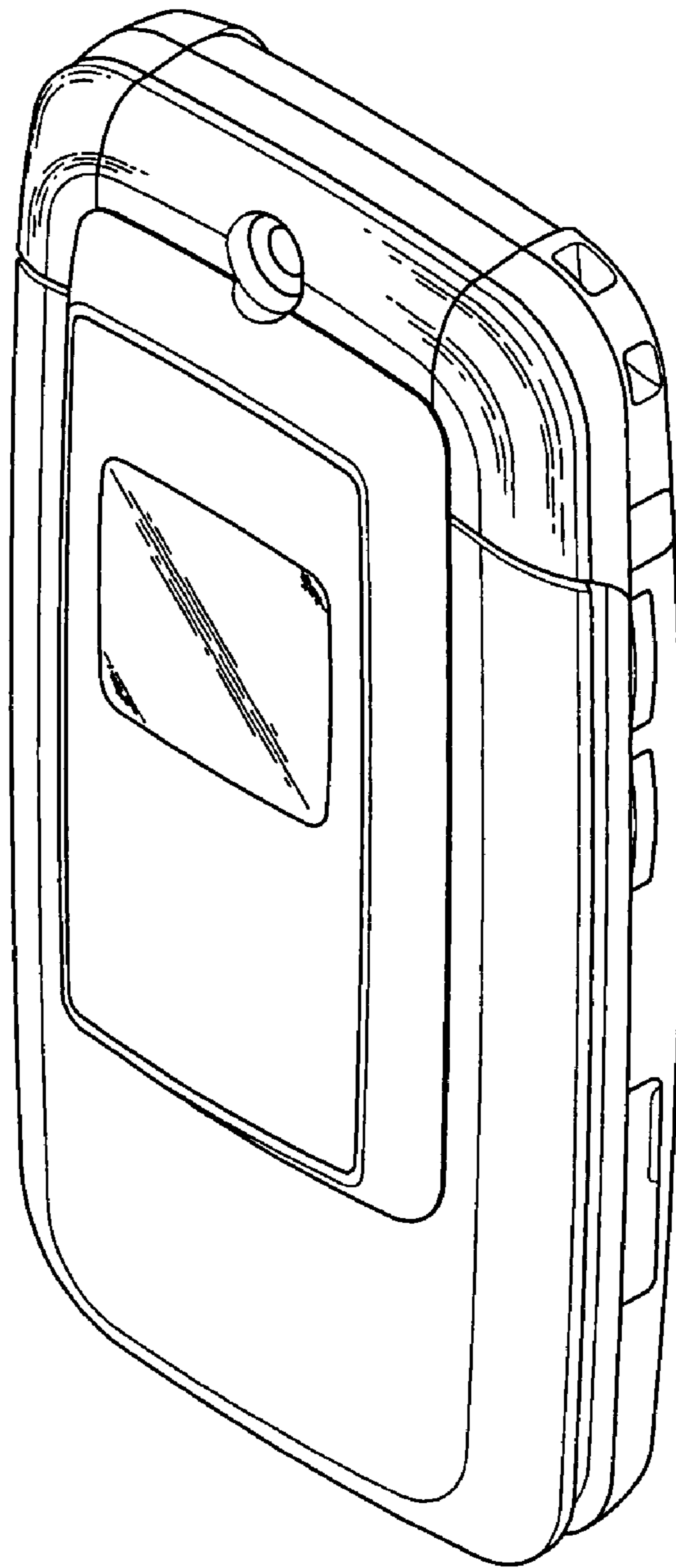
**DESCRIPTION**

 with the screen rotated counter clockwise.

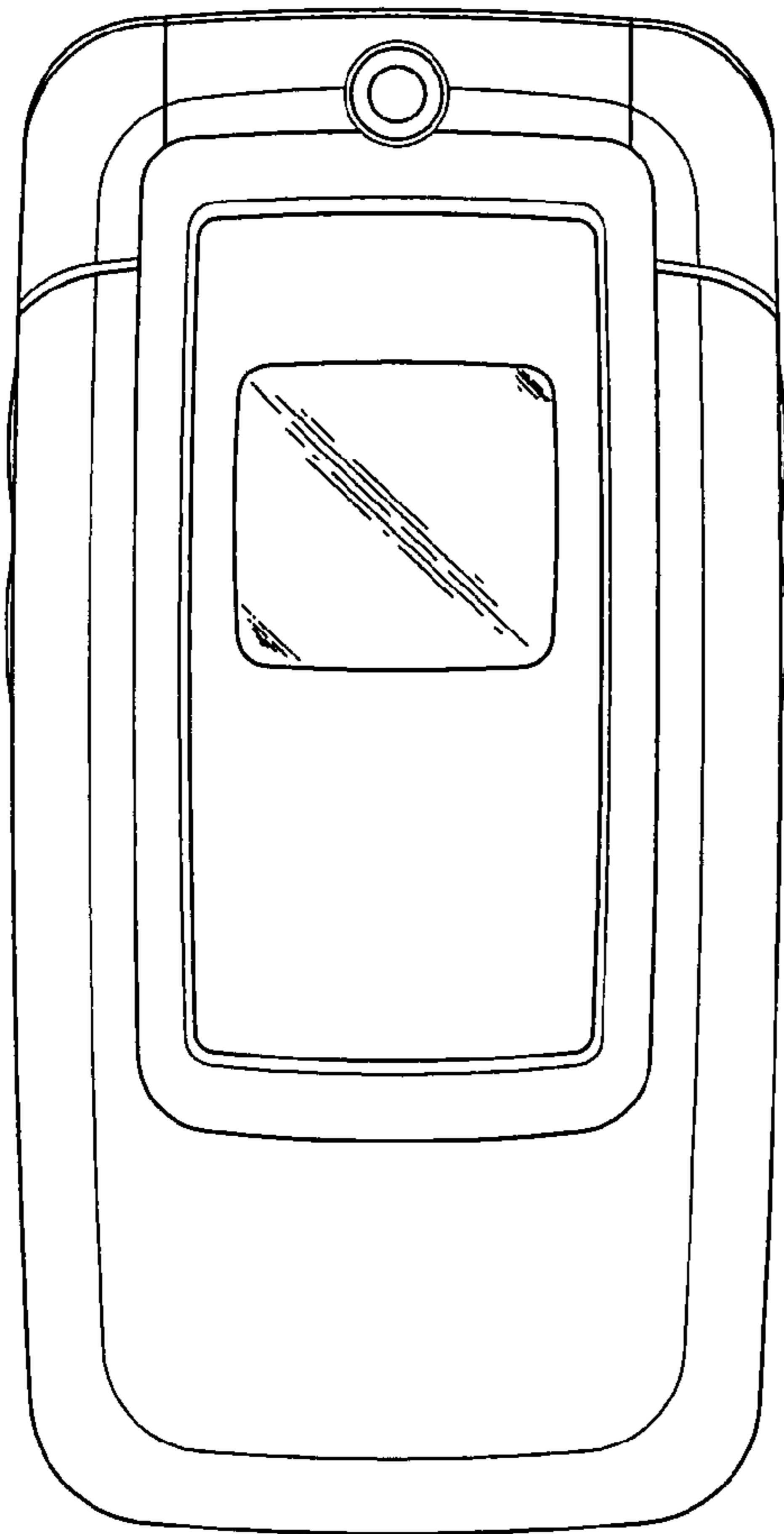

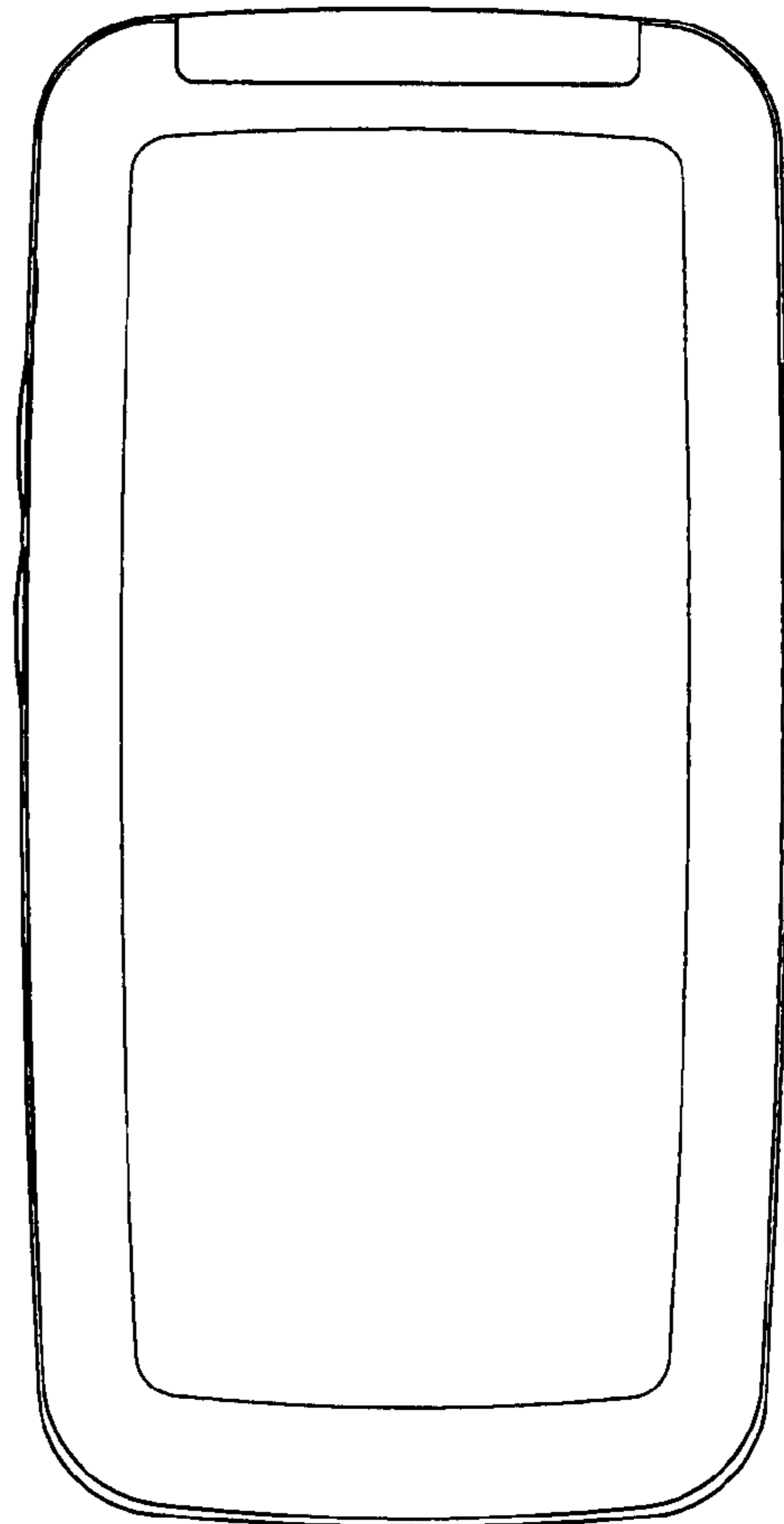

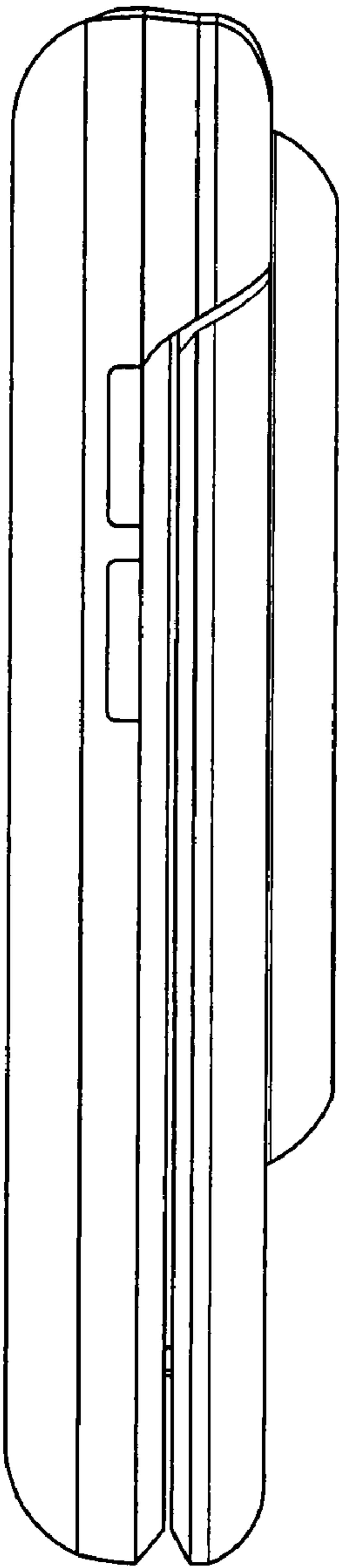

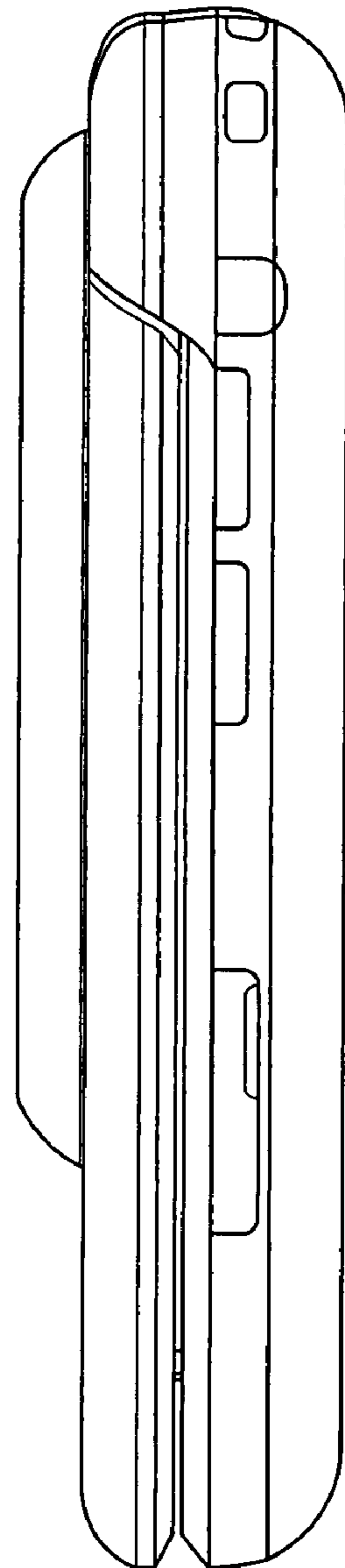

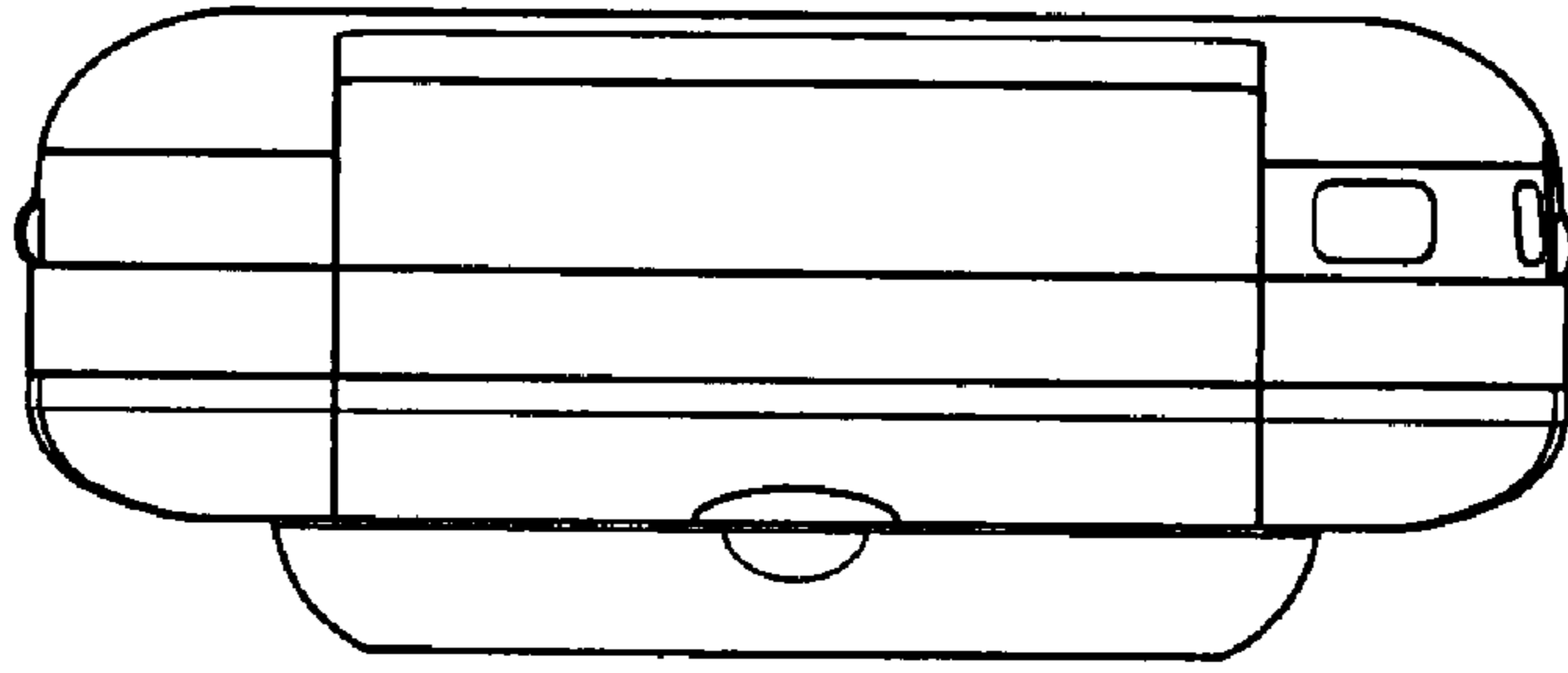

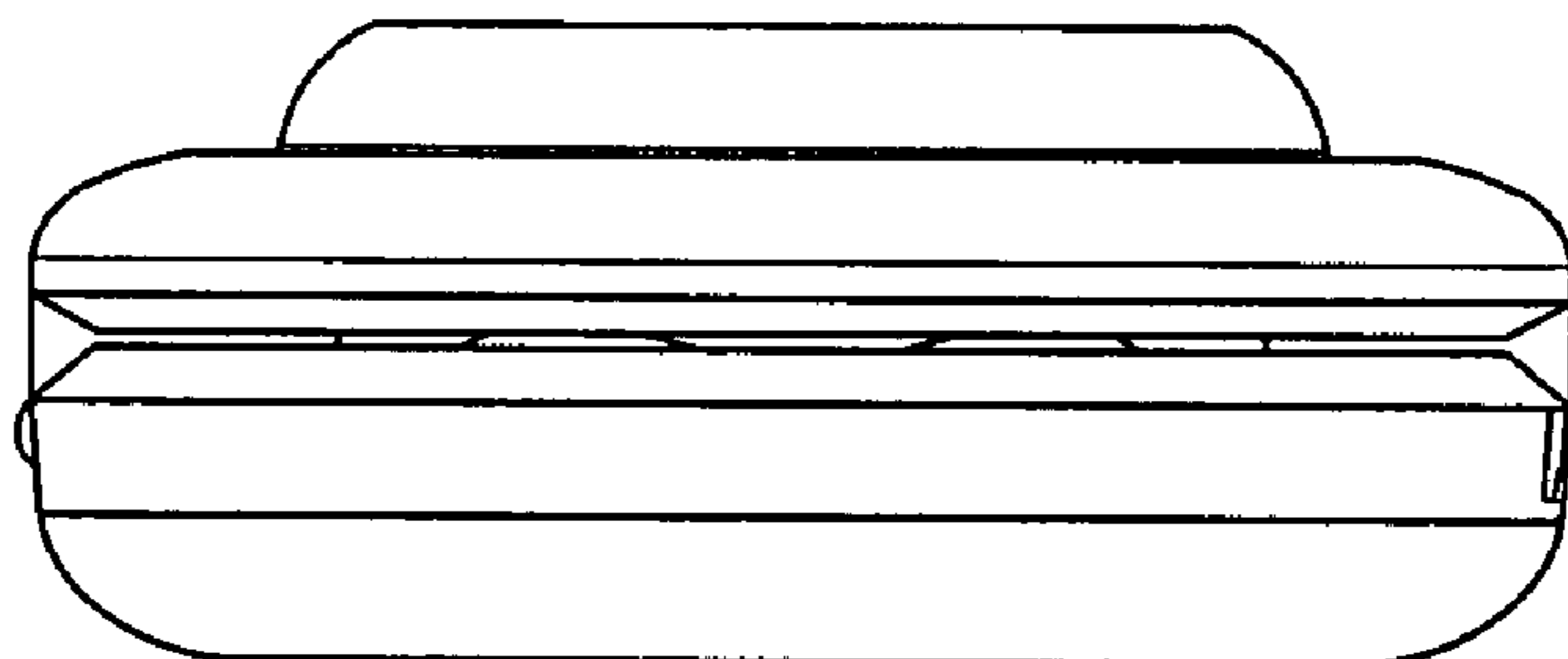

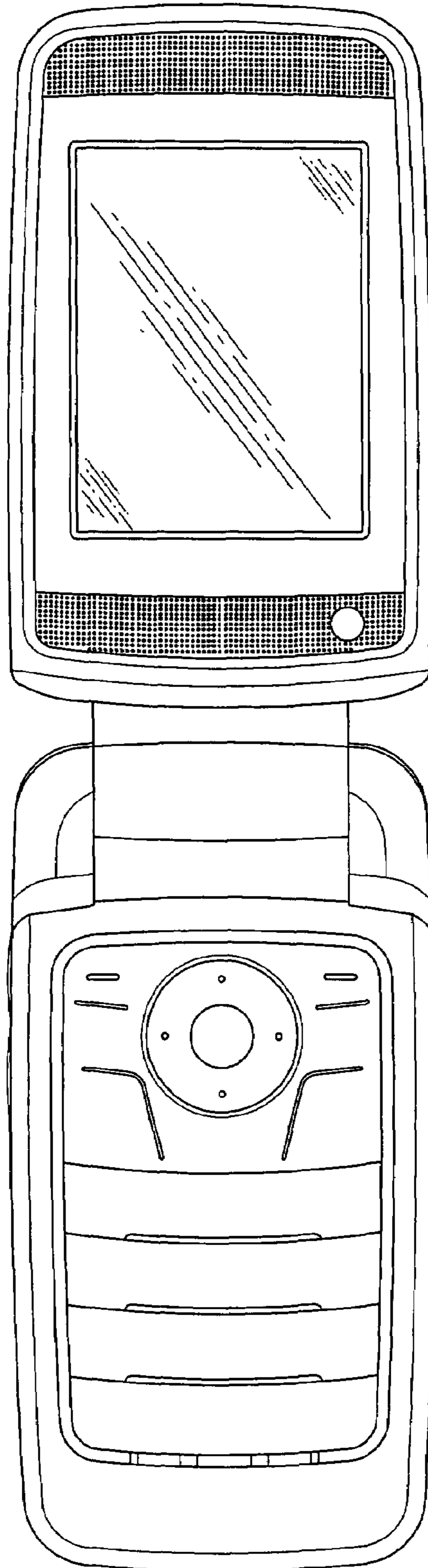
