1.

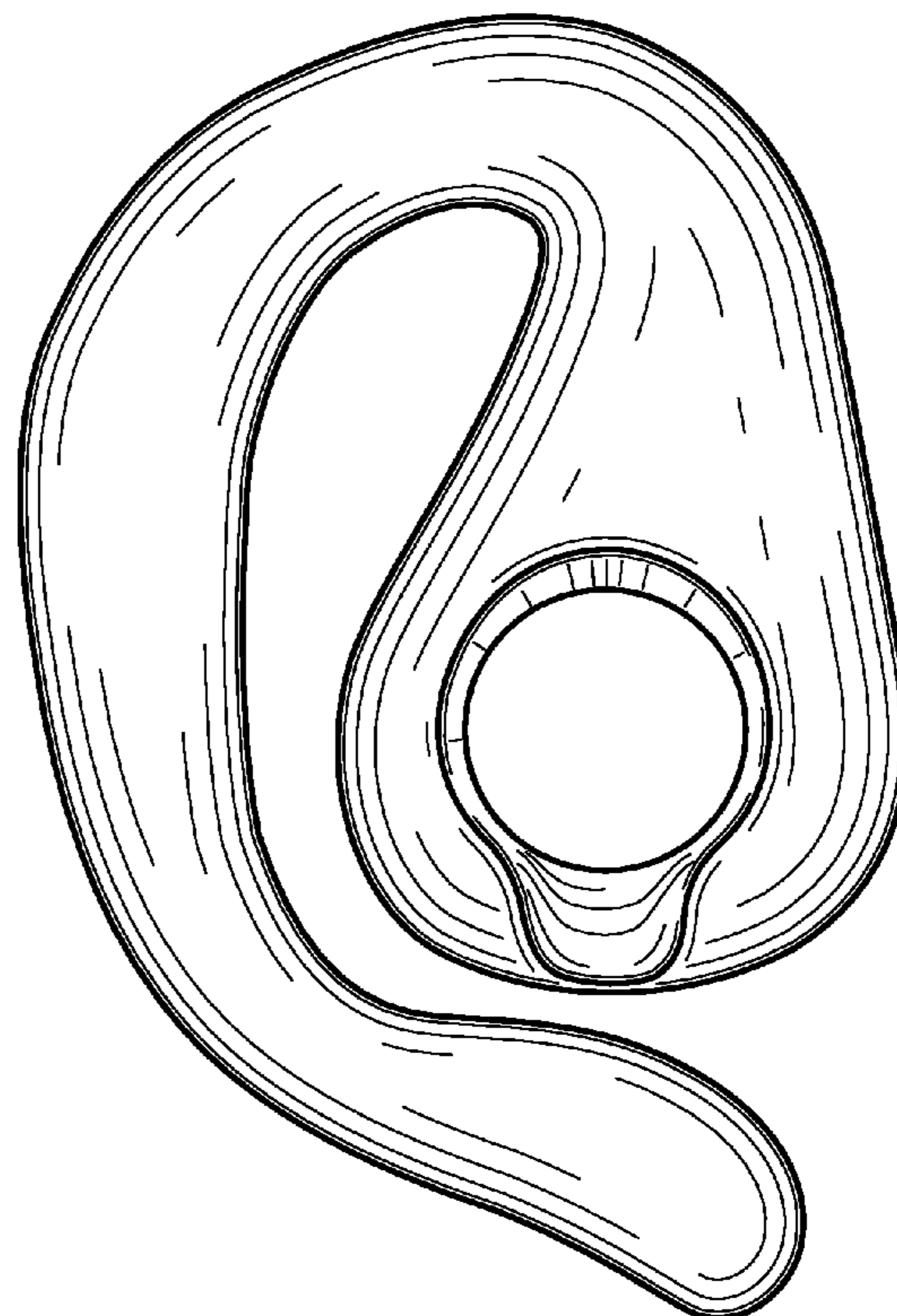
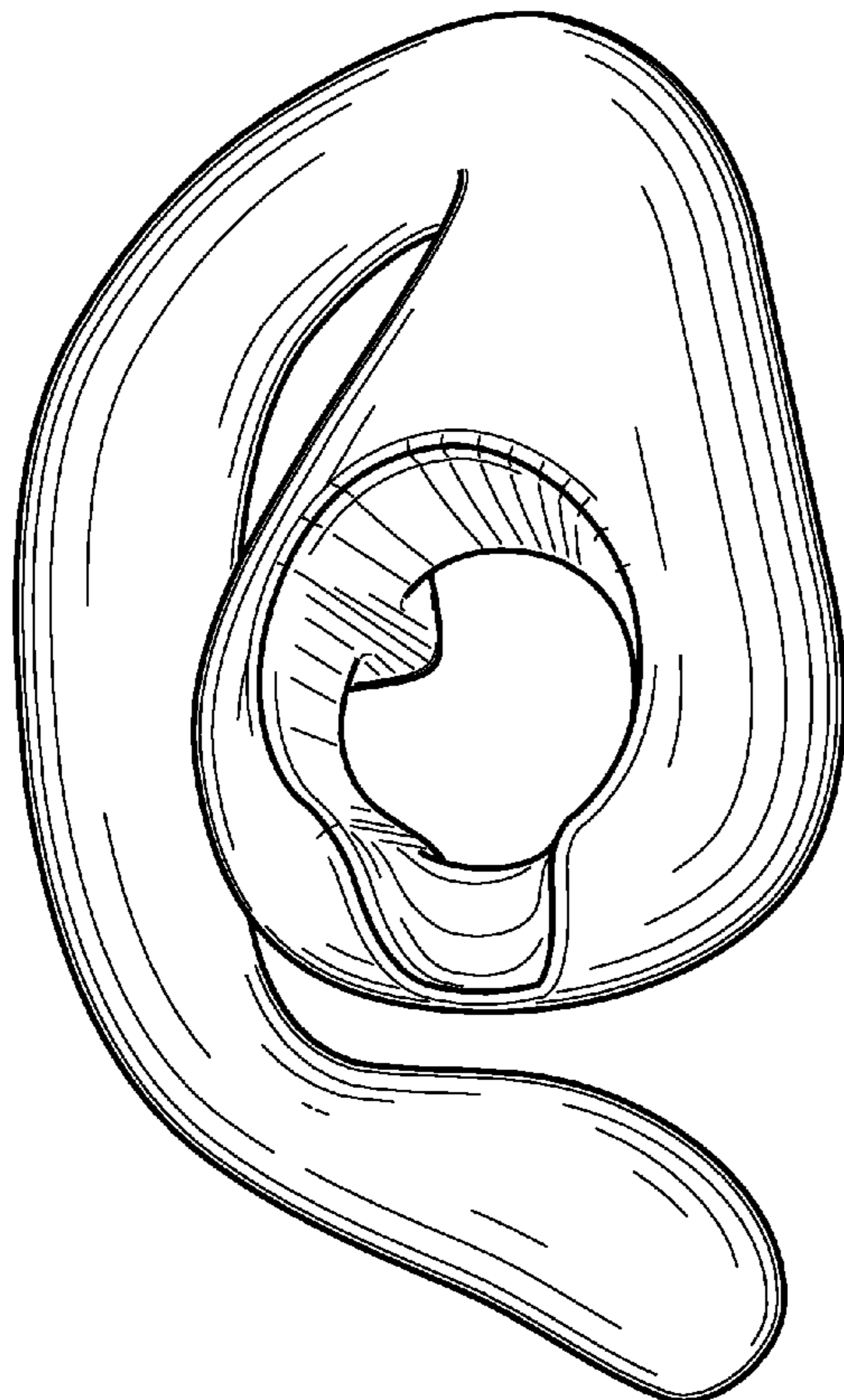
FIG. 5 is a front view of the audio earbud carrier of FIG. 1.

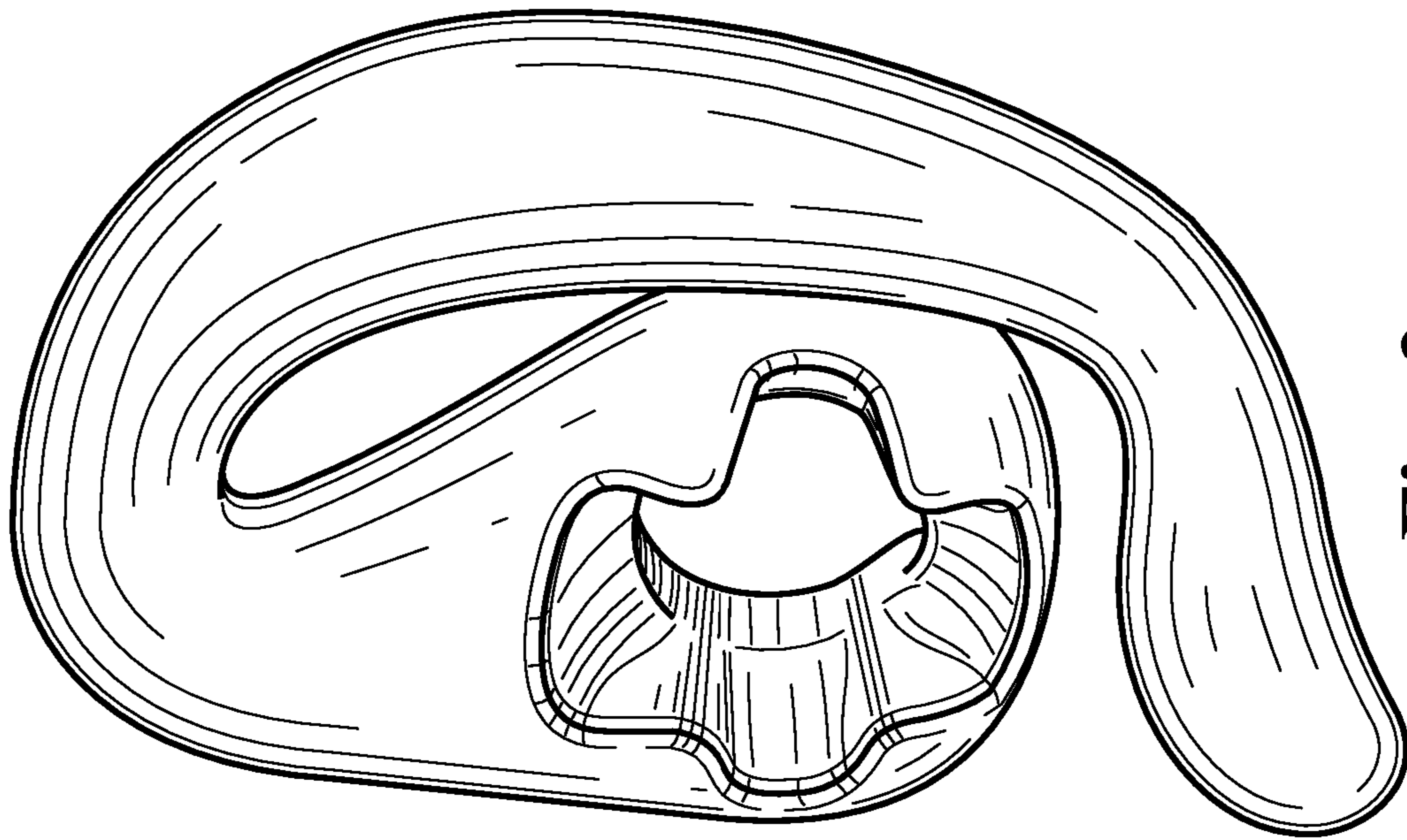
FIG. 6 is a rear view of the audio earbud carrier of FIG. 1.

FIG. 7 is a top view of the audio earbud carrier of FIG. 1; and,

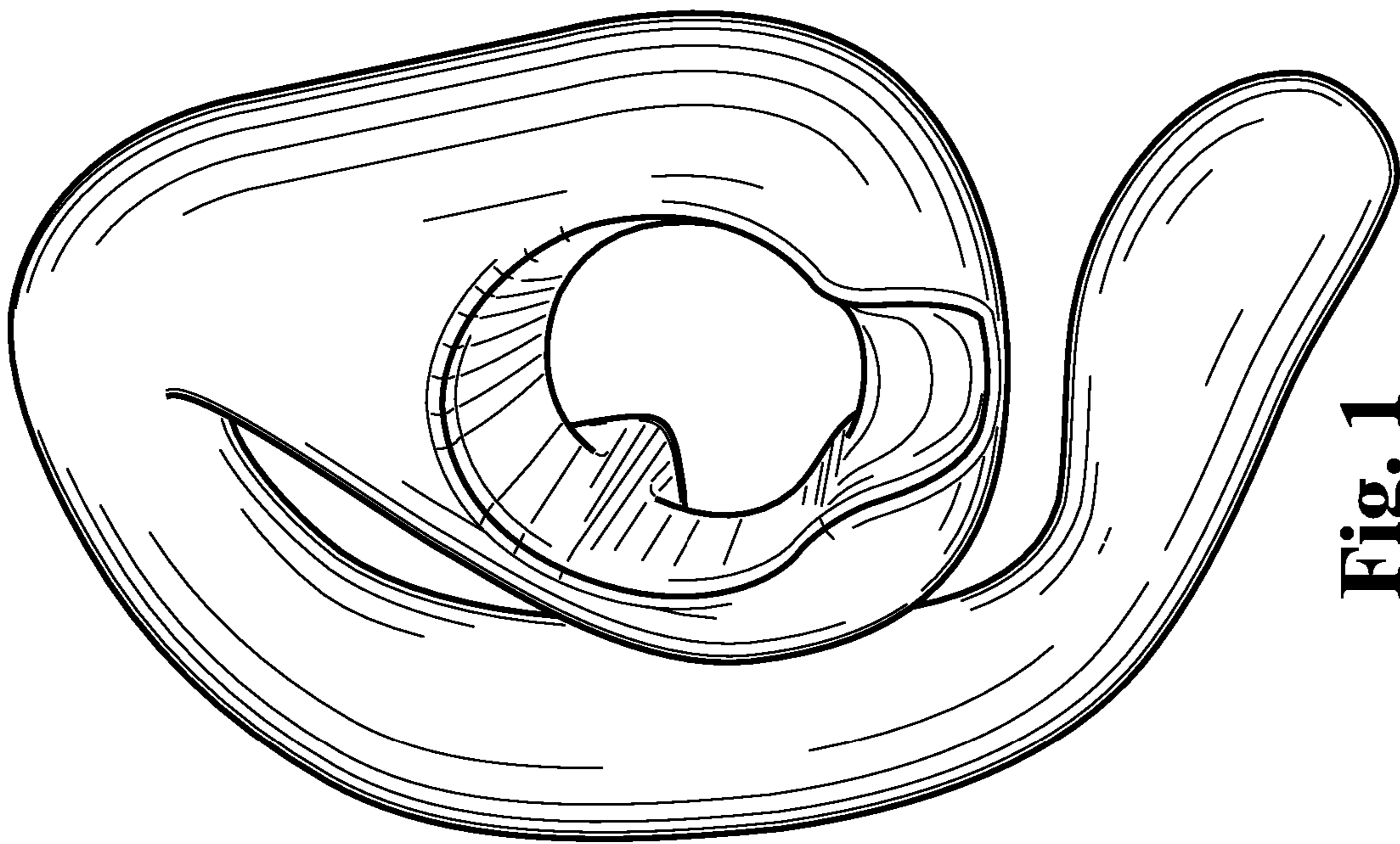
FIG. 8 is a bottom view of the audio earbud carrier of FIG. 1.

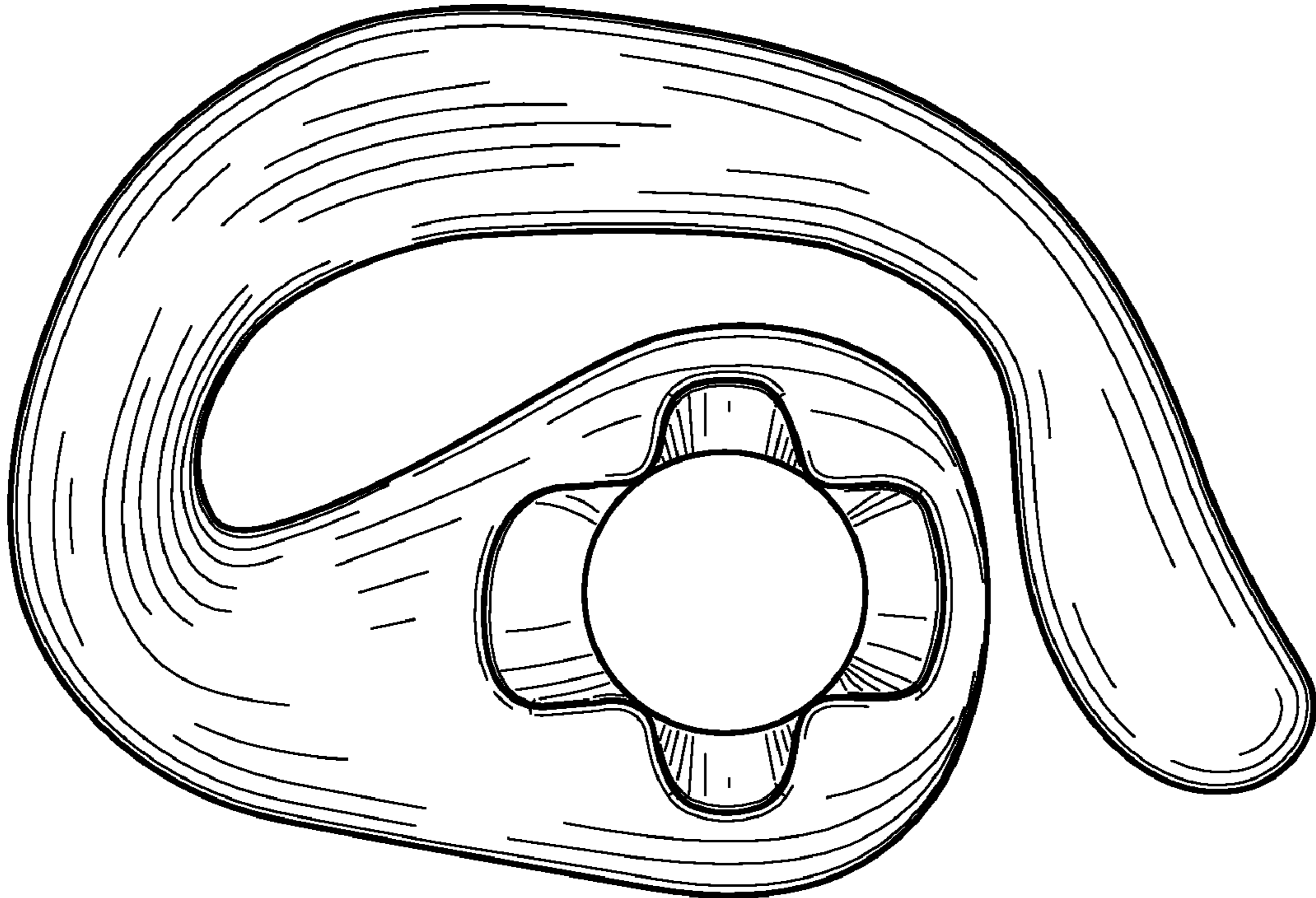

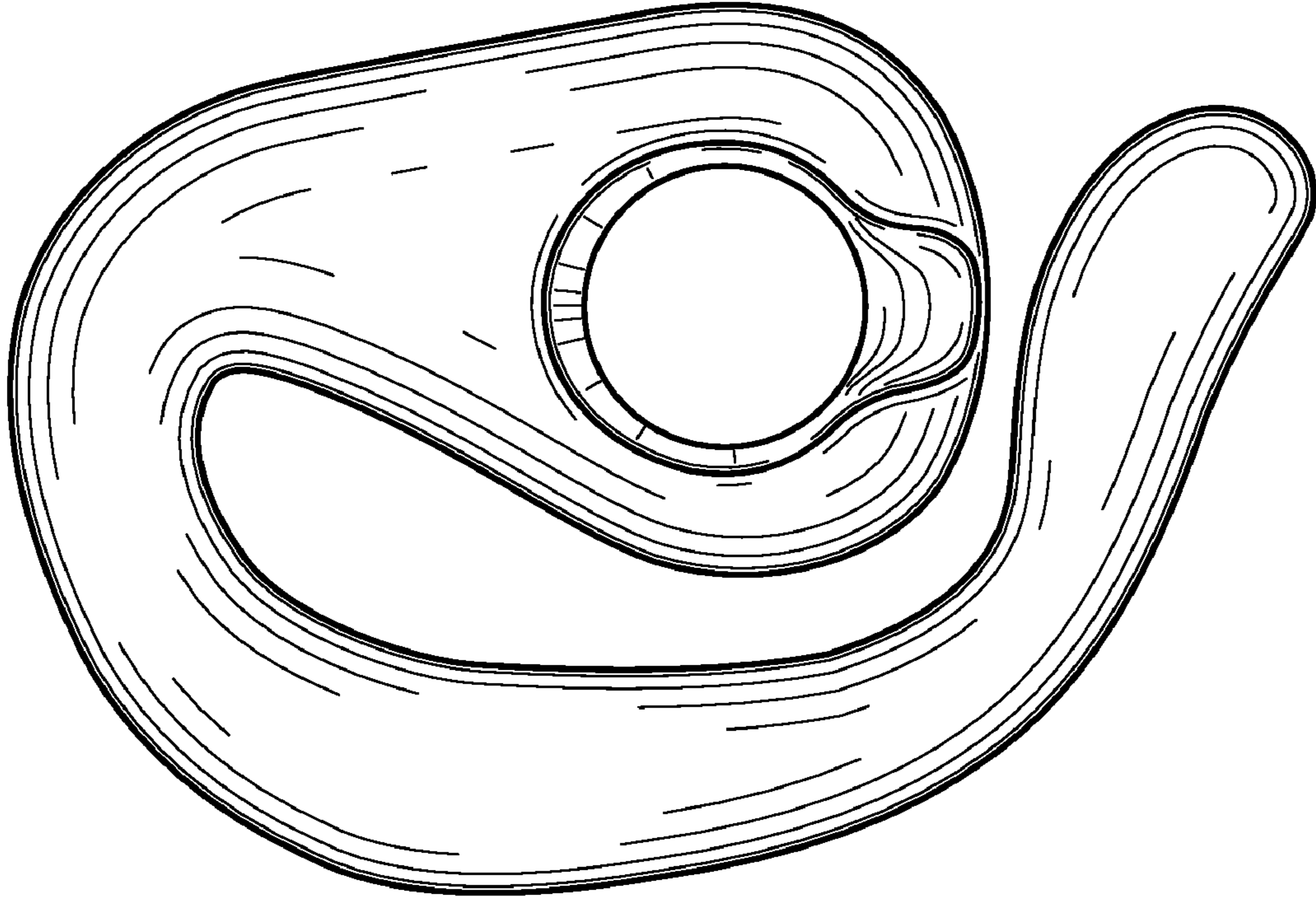
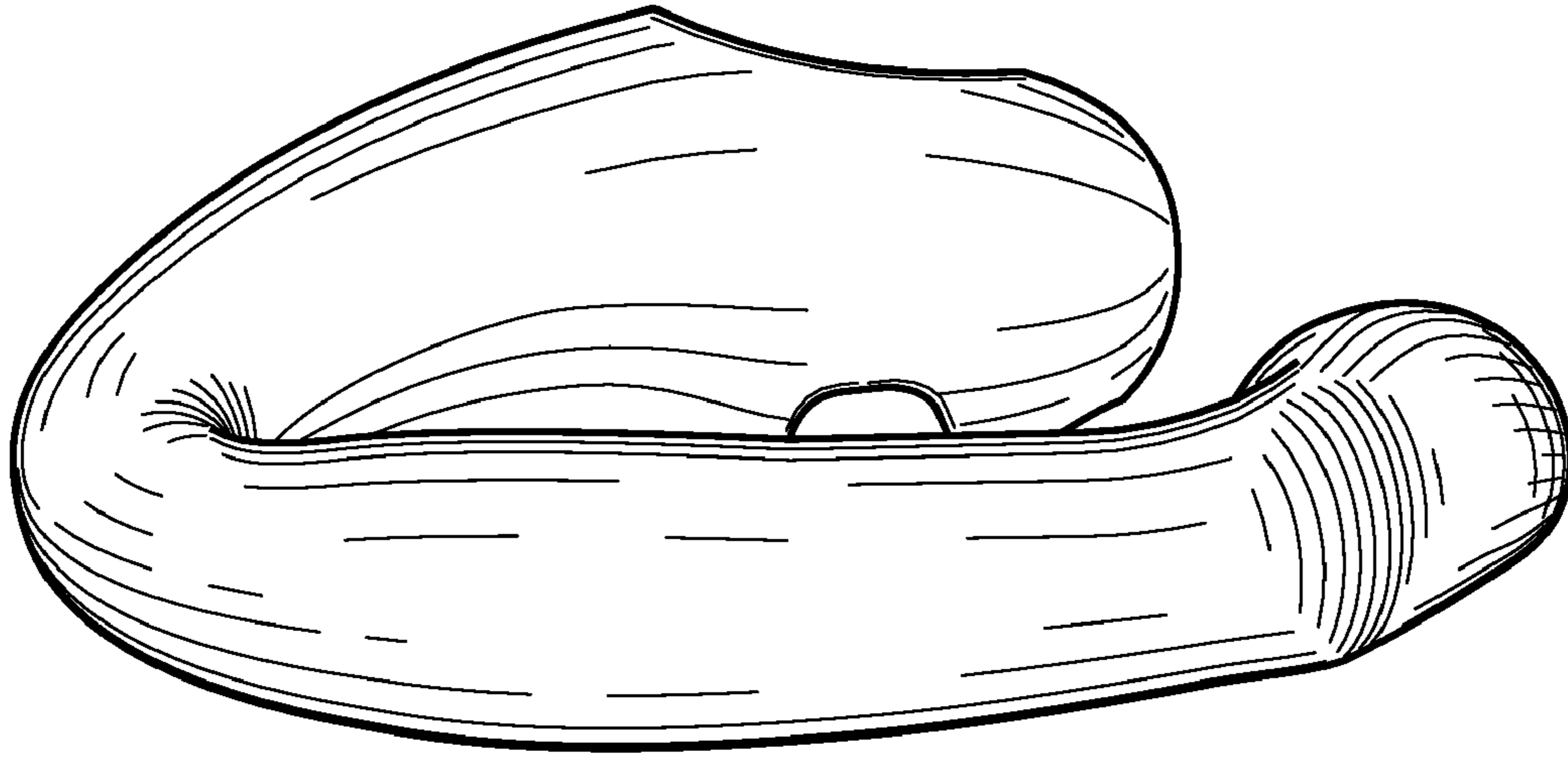
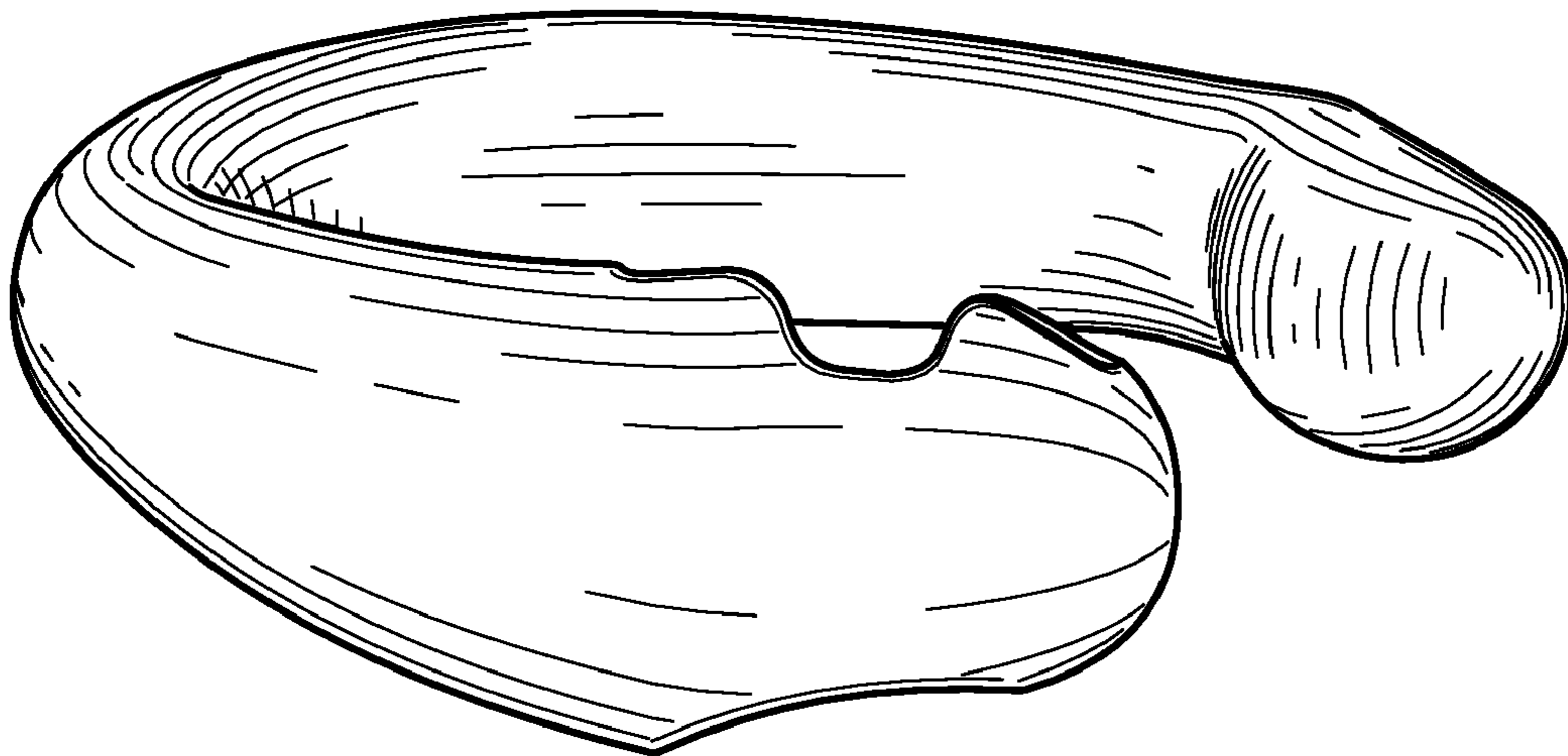


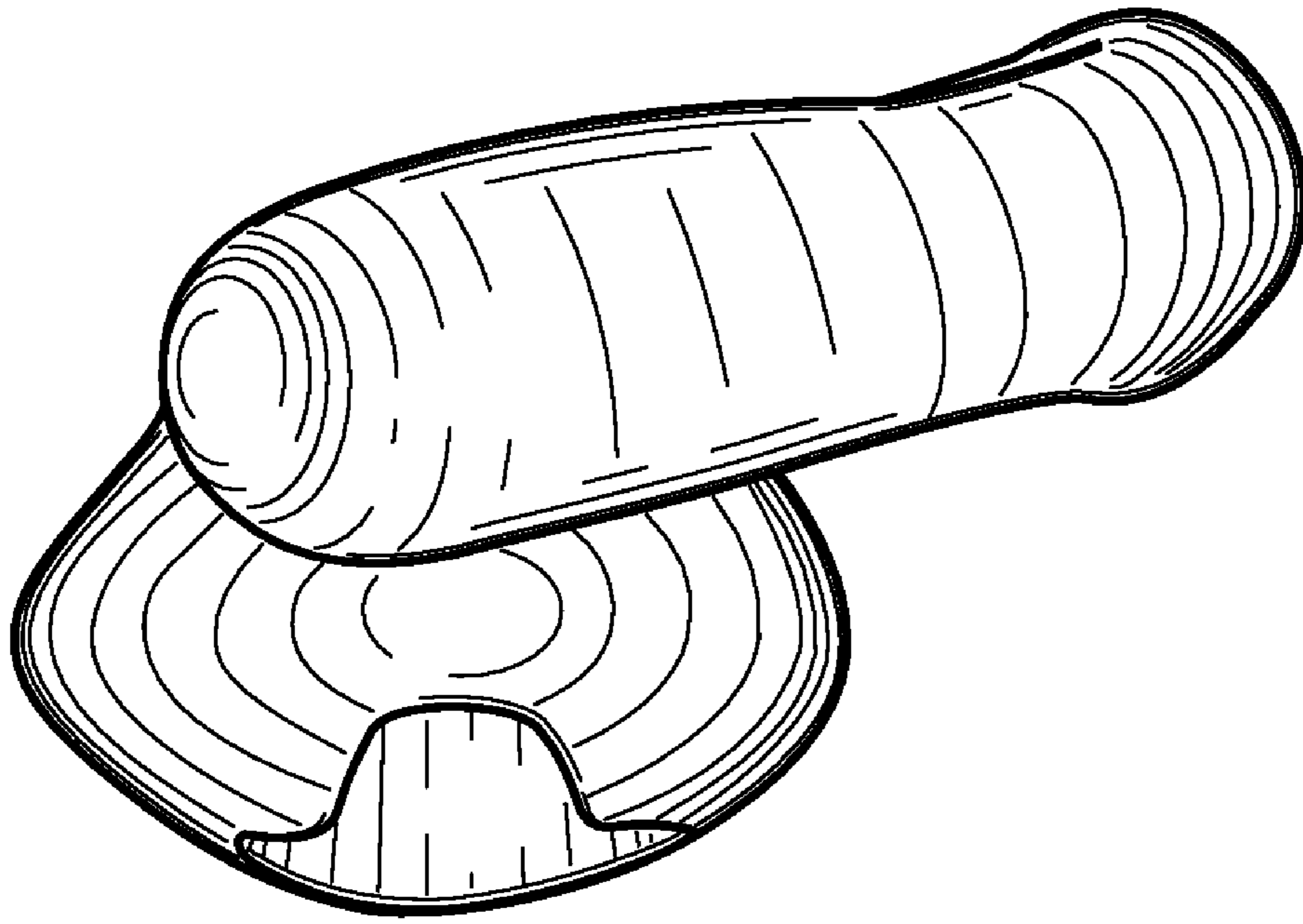

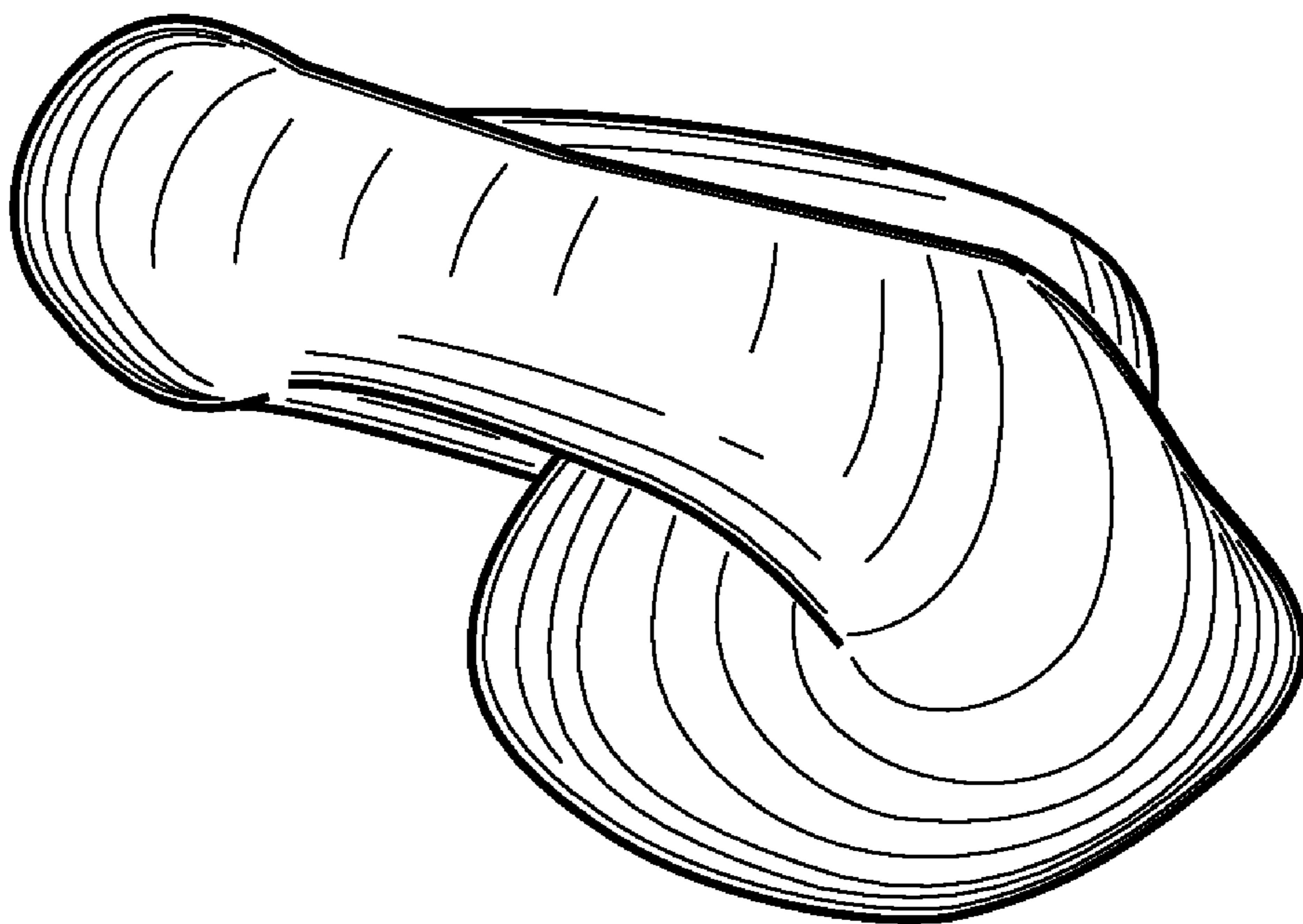
