(57) **CLAIM**

The ornamental design for a video image display for portable phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first image for a video image display for portable phone;

FIG. 2 is a front view thereof;

FIG. 3 is an enlarged front view thereof but shown without broken lines for ease of illustration;

FIG. 4 is a front view of a second image for a video image display for portable phone; and,

FIG. 5 is a front view of a third image for a video image display for portable phone.

The broken line showing of a portable phone is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

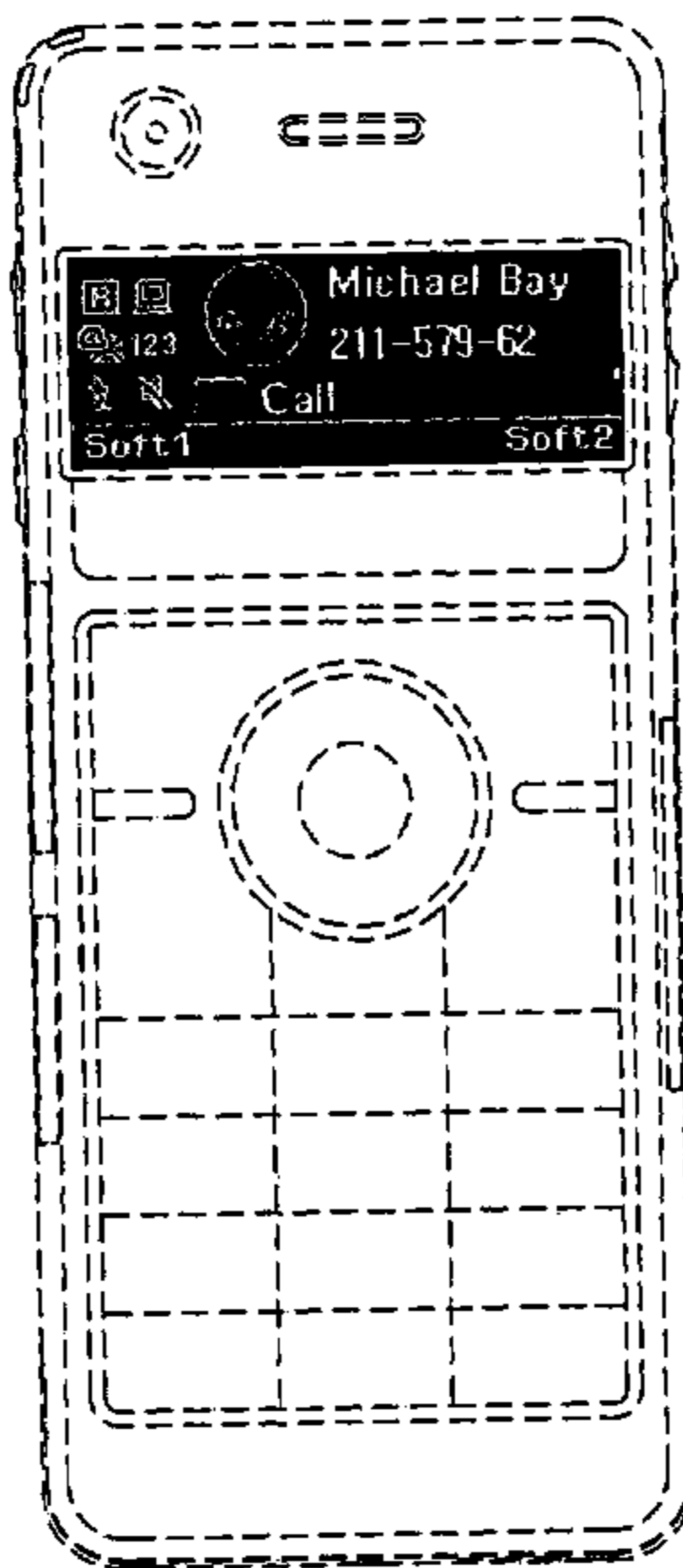

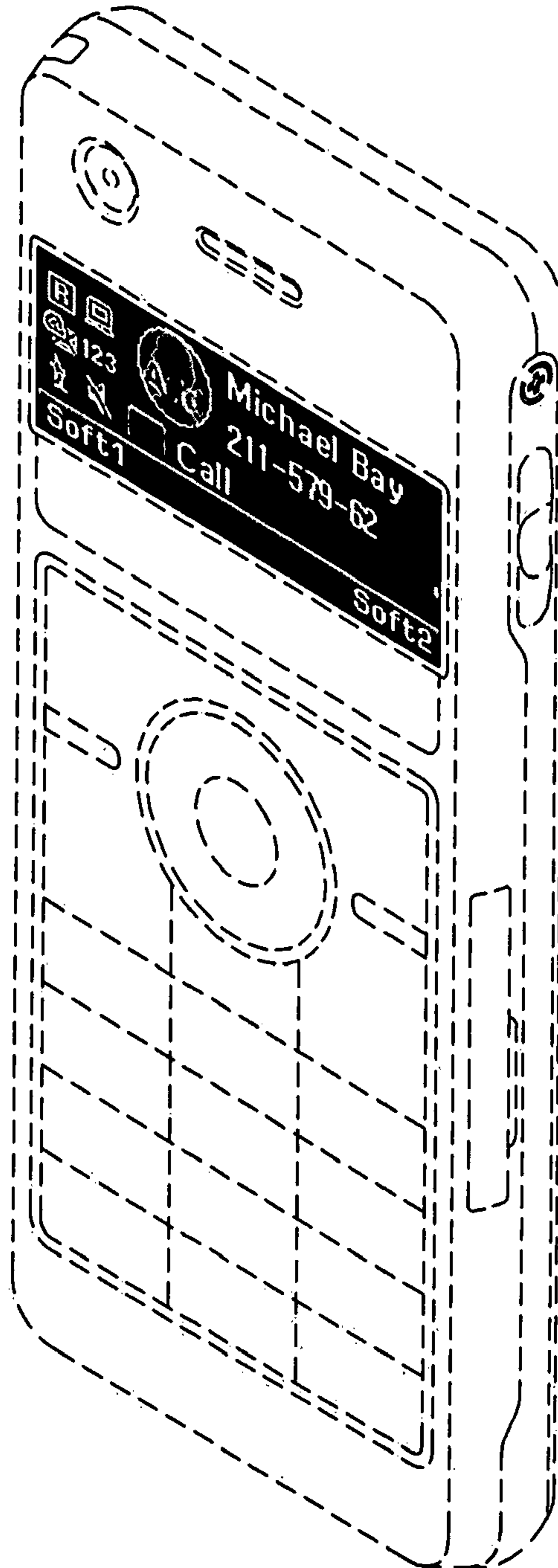

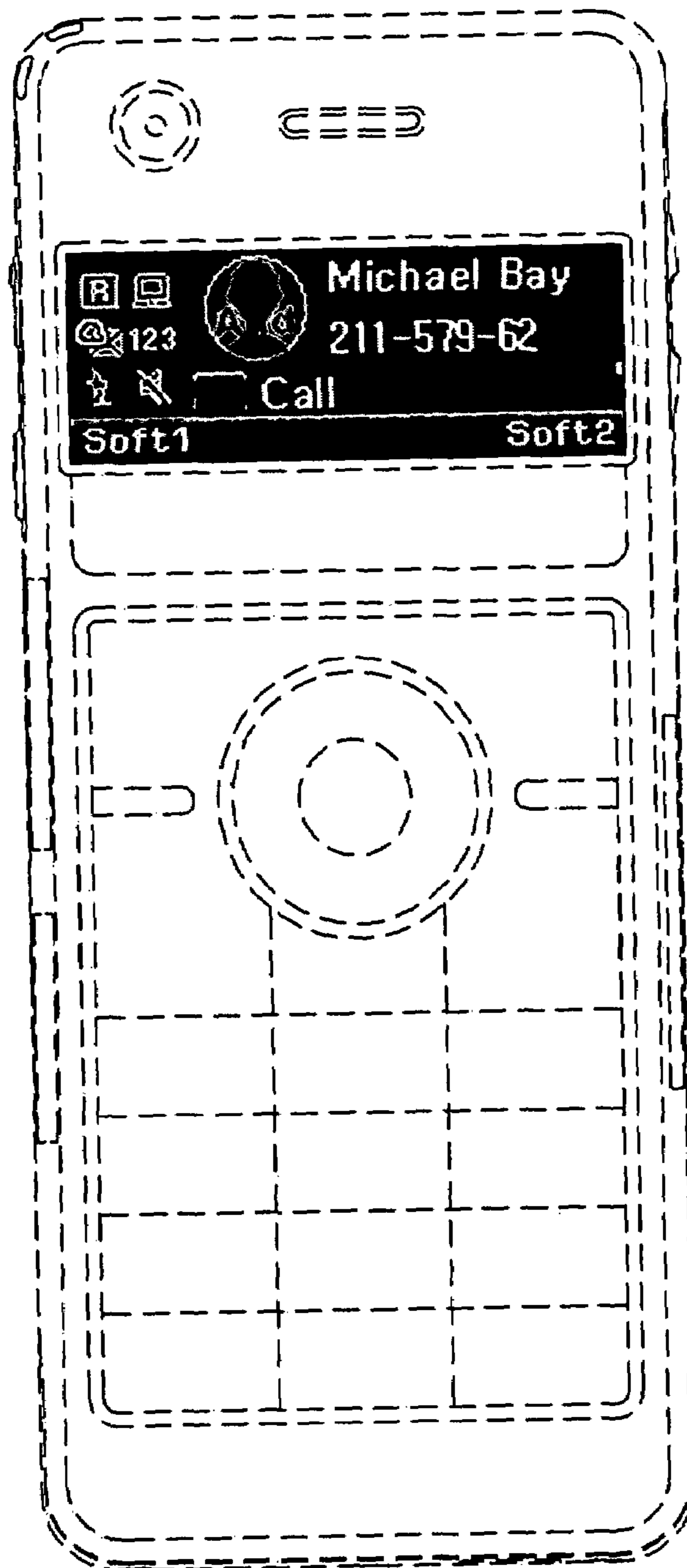

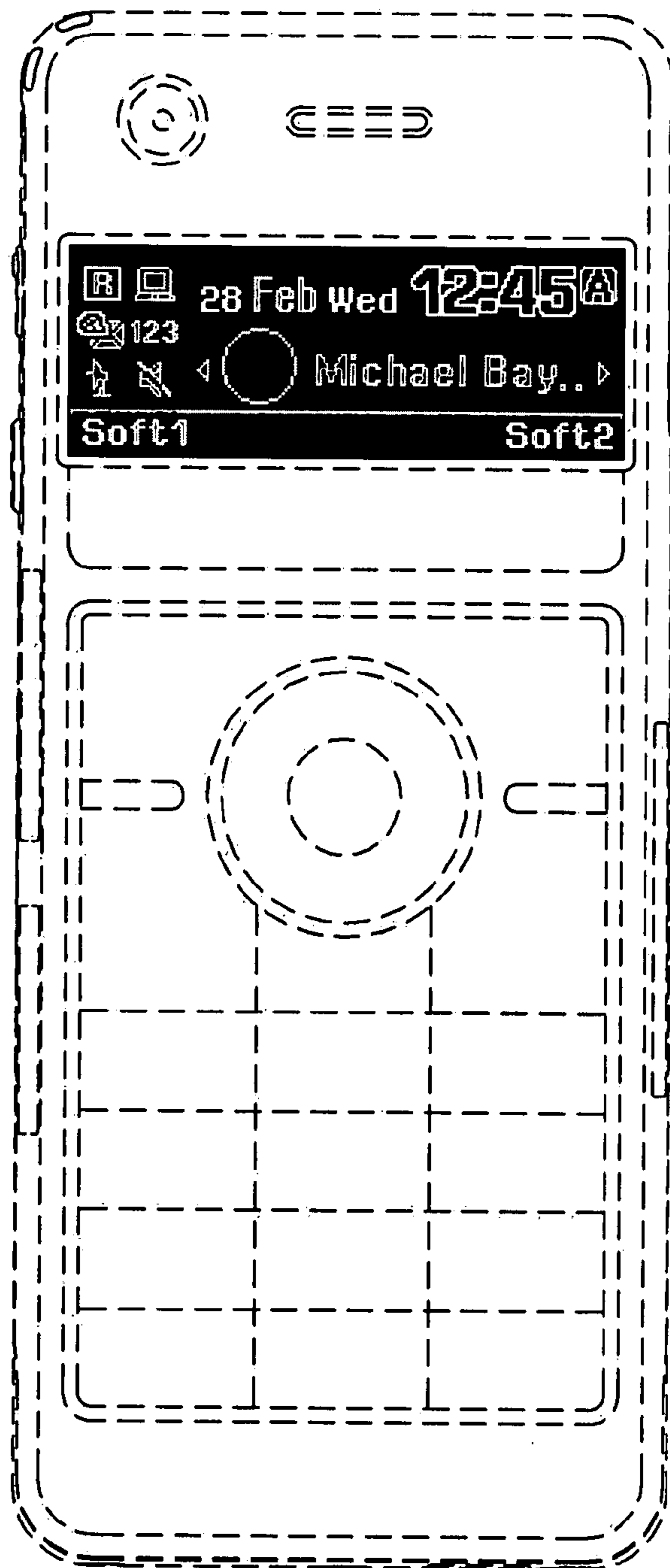
