DESCRIPTION

FIG. 5 is a front side elevational view thereof in the open position;

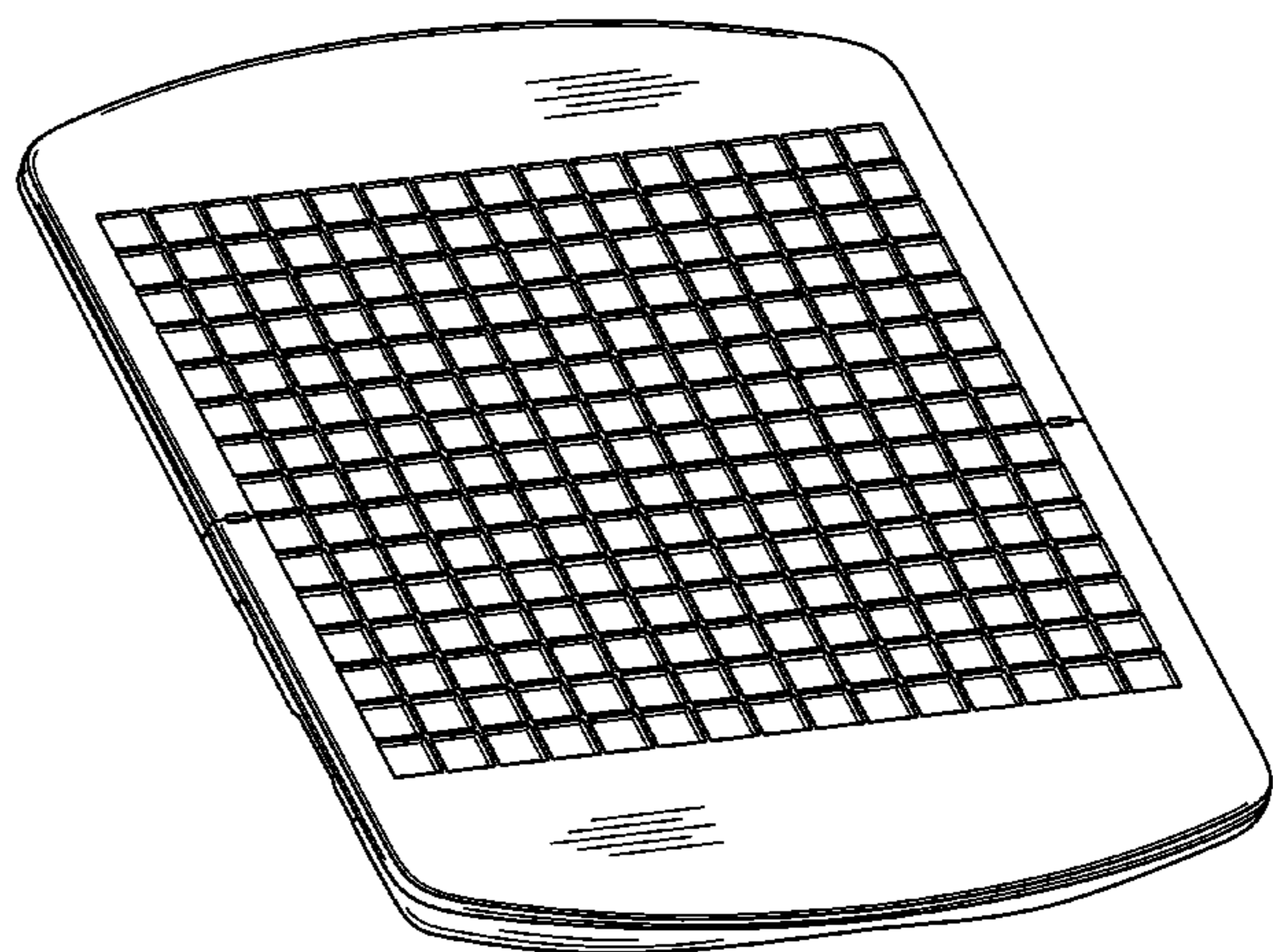
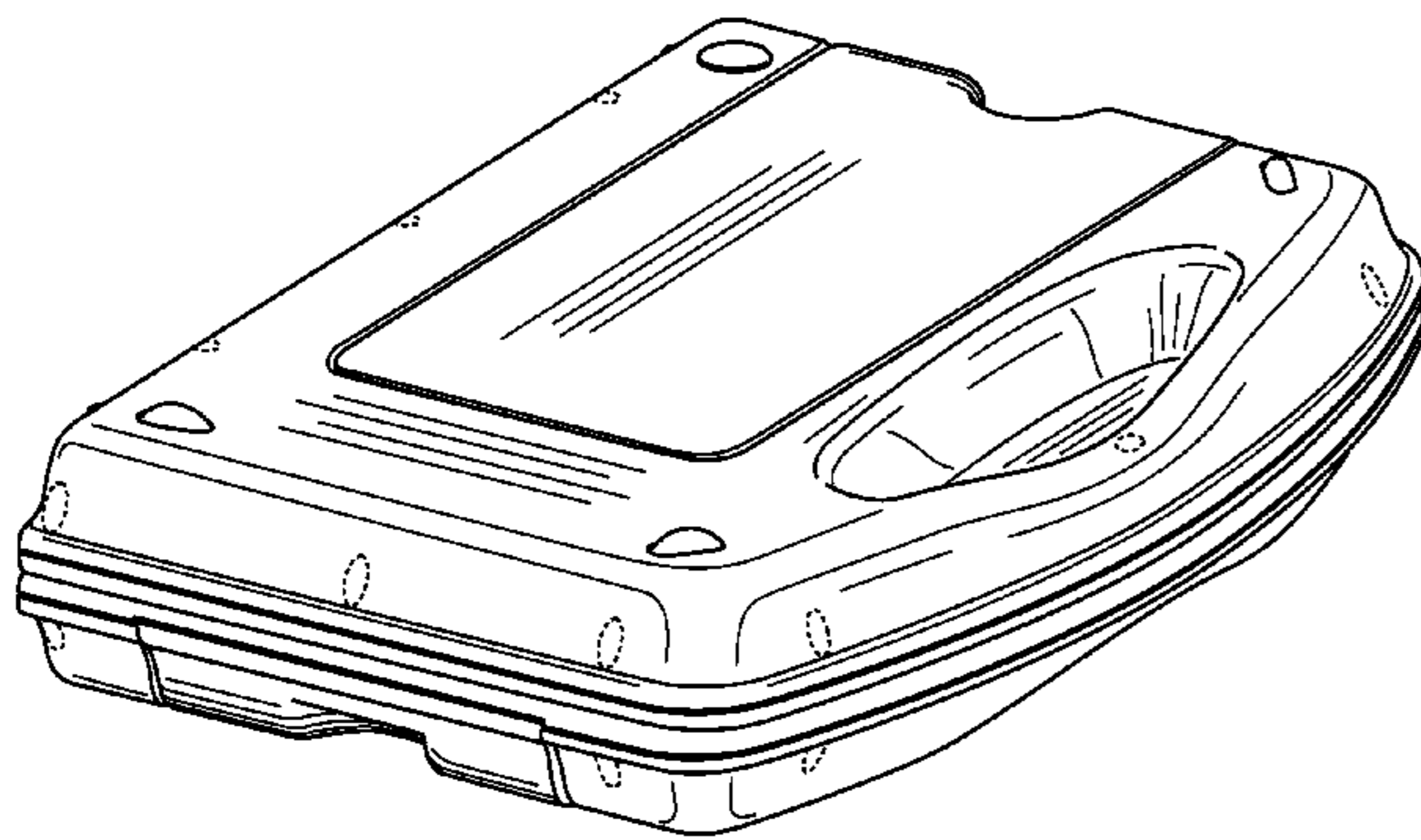
FIG. 6 is a rear side elevational view thereof in the open position;

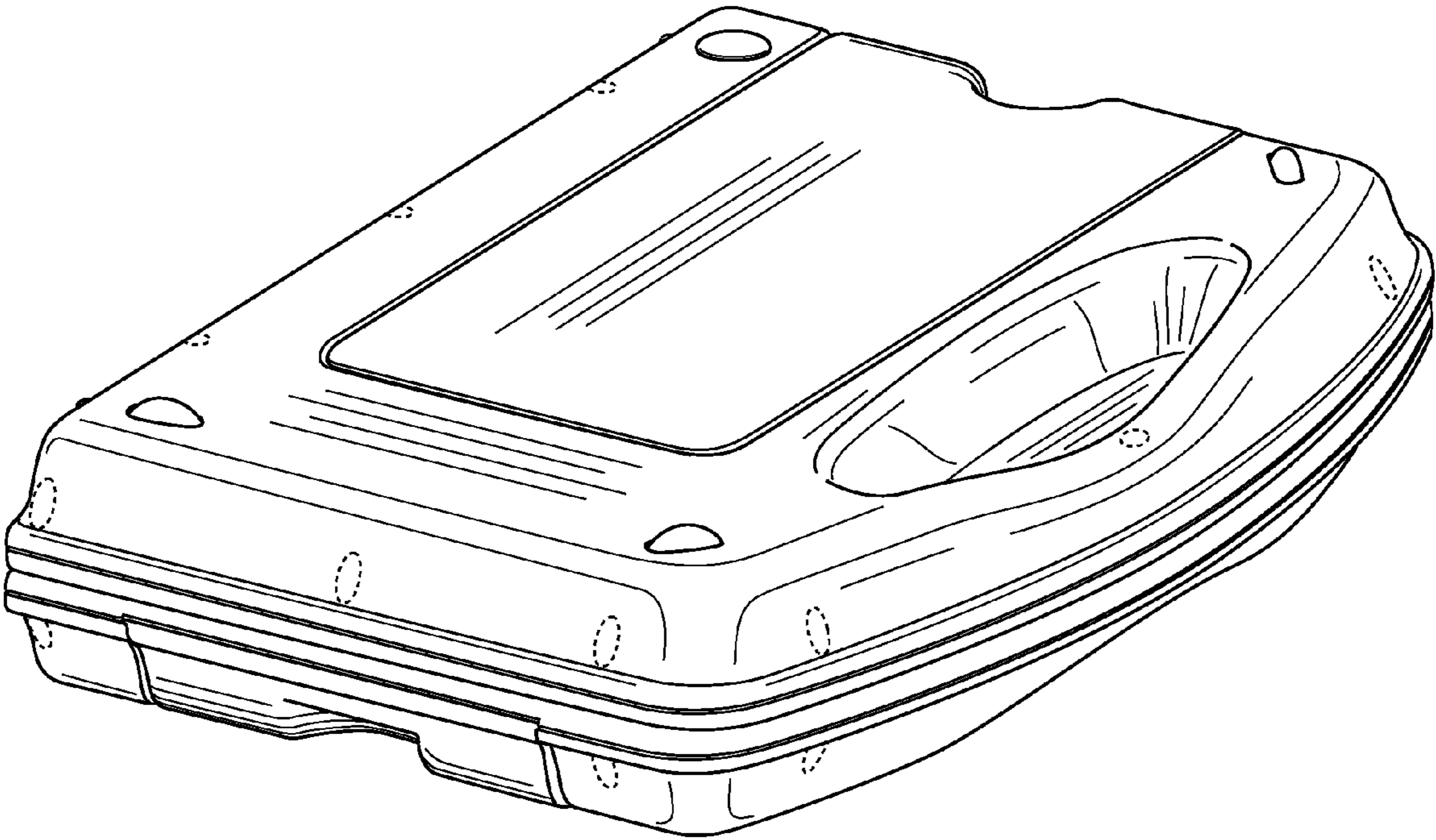

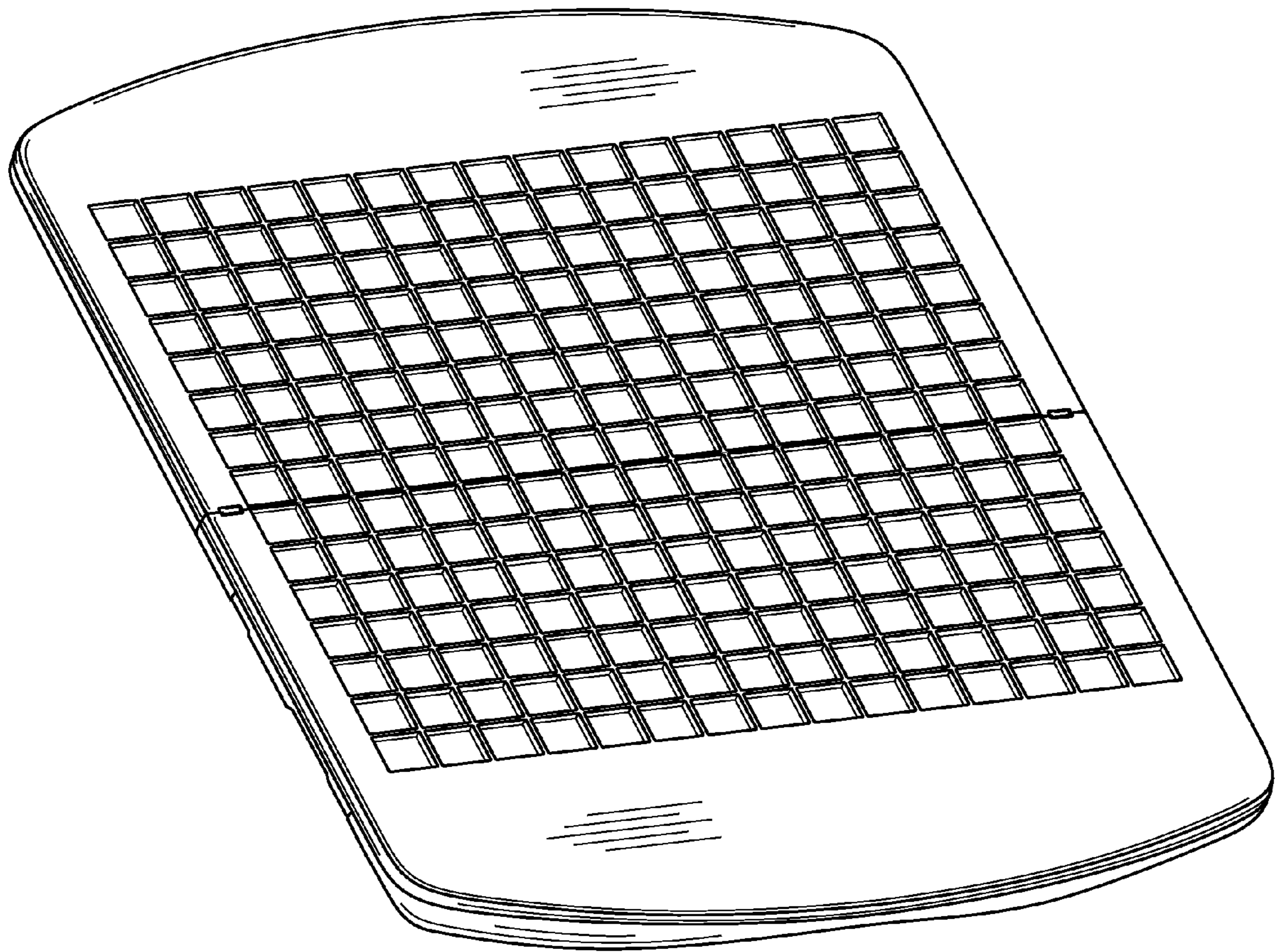

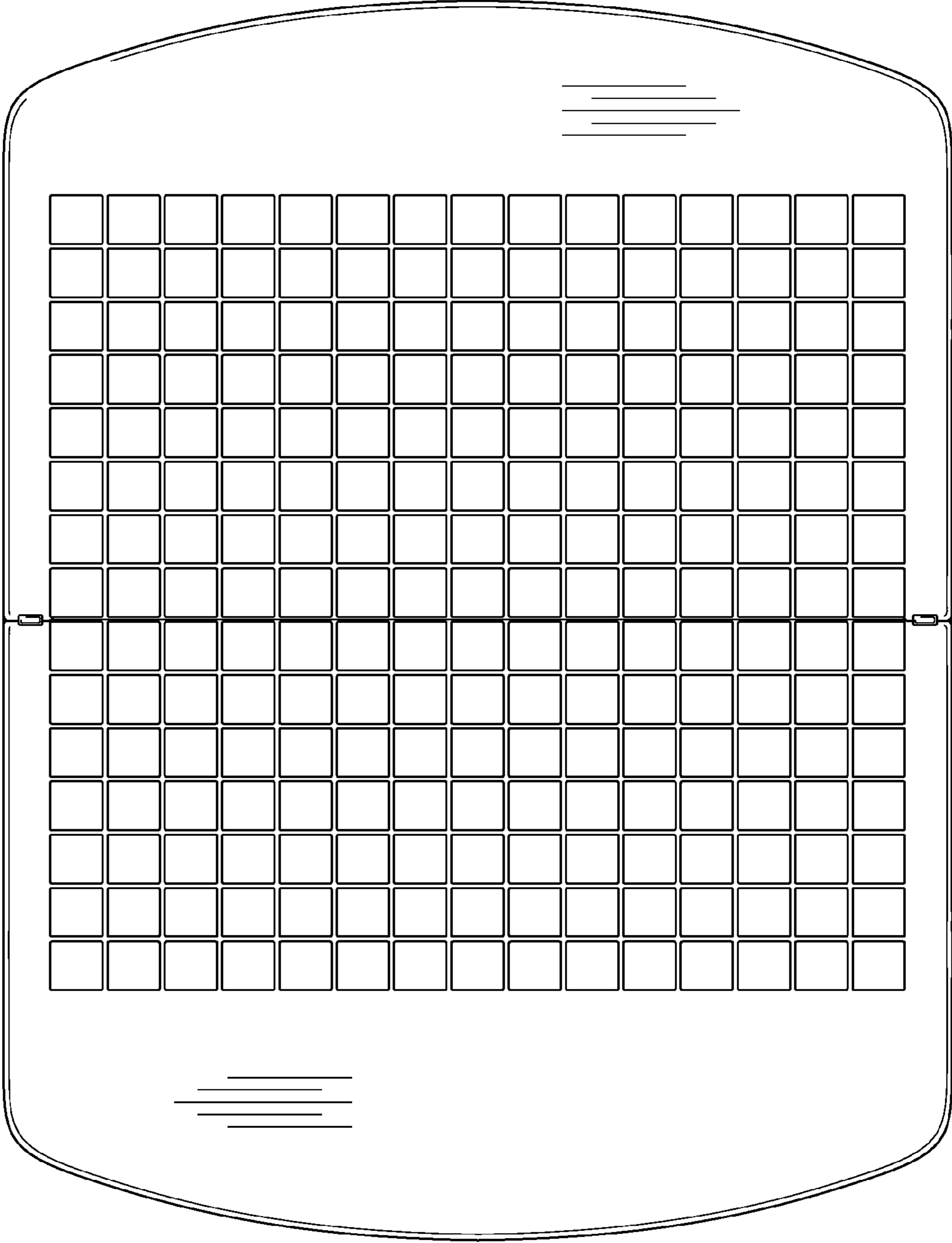

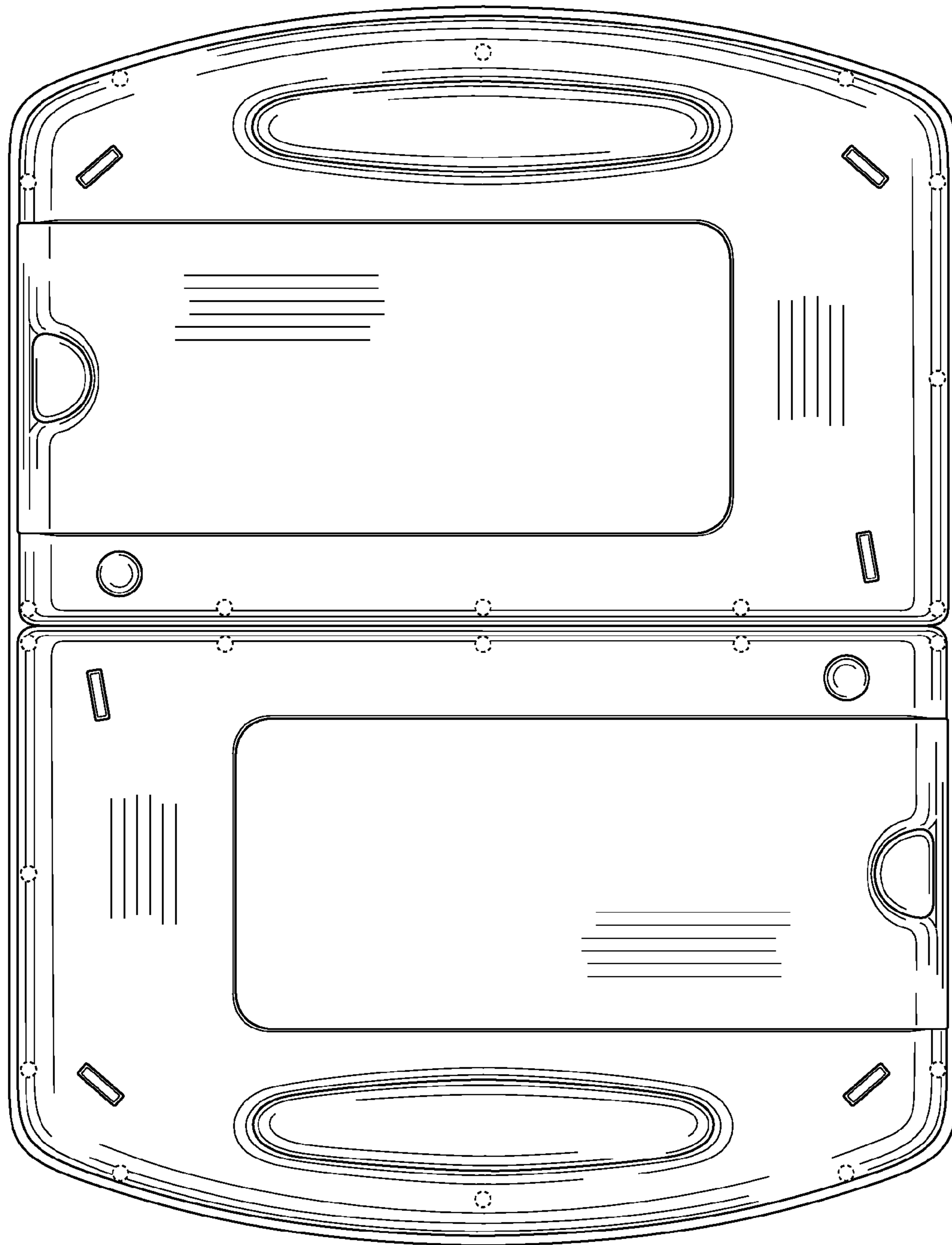

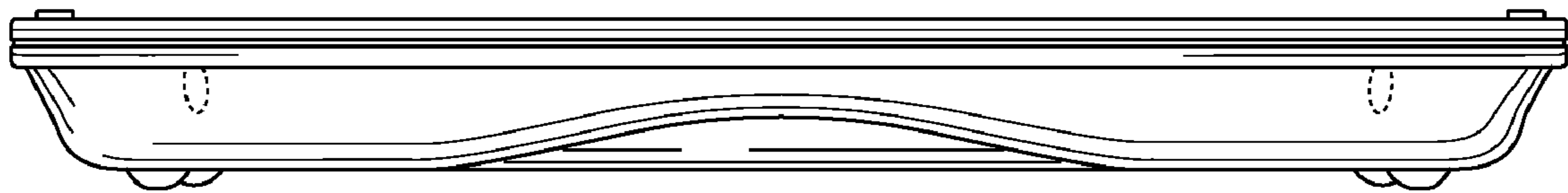

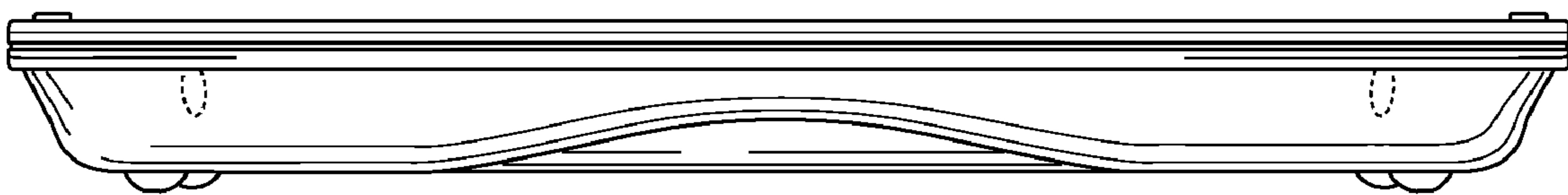

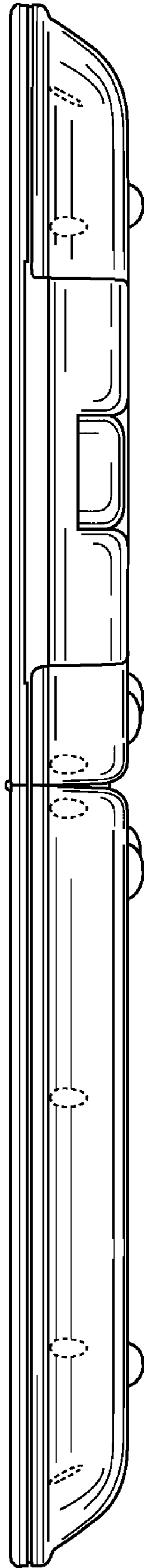

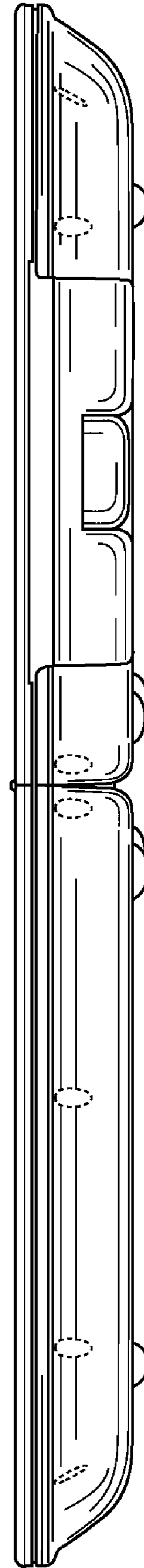
