I claim the ornamental design for an apparatus for photographing an oral cavity, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of an apparatus for photographing an oral cavity showing my new design;

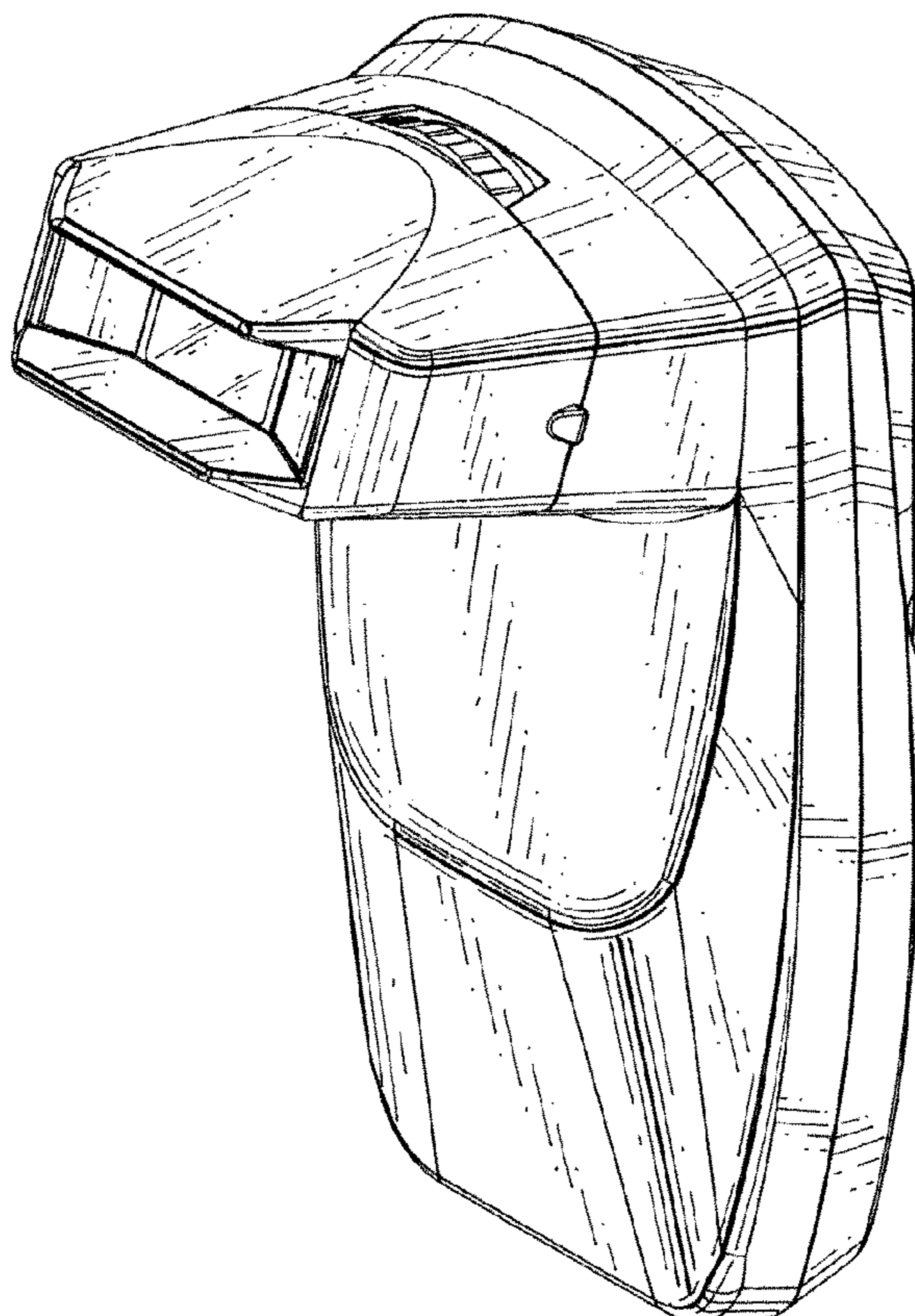

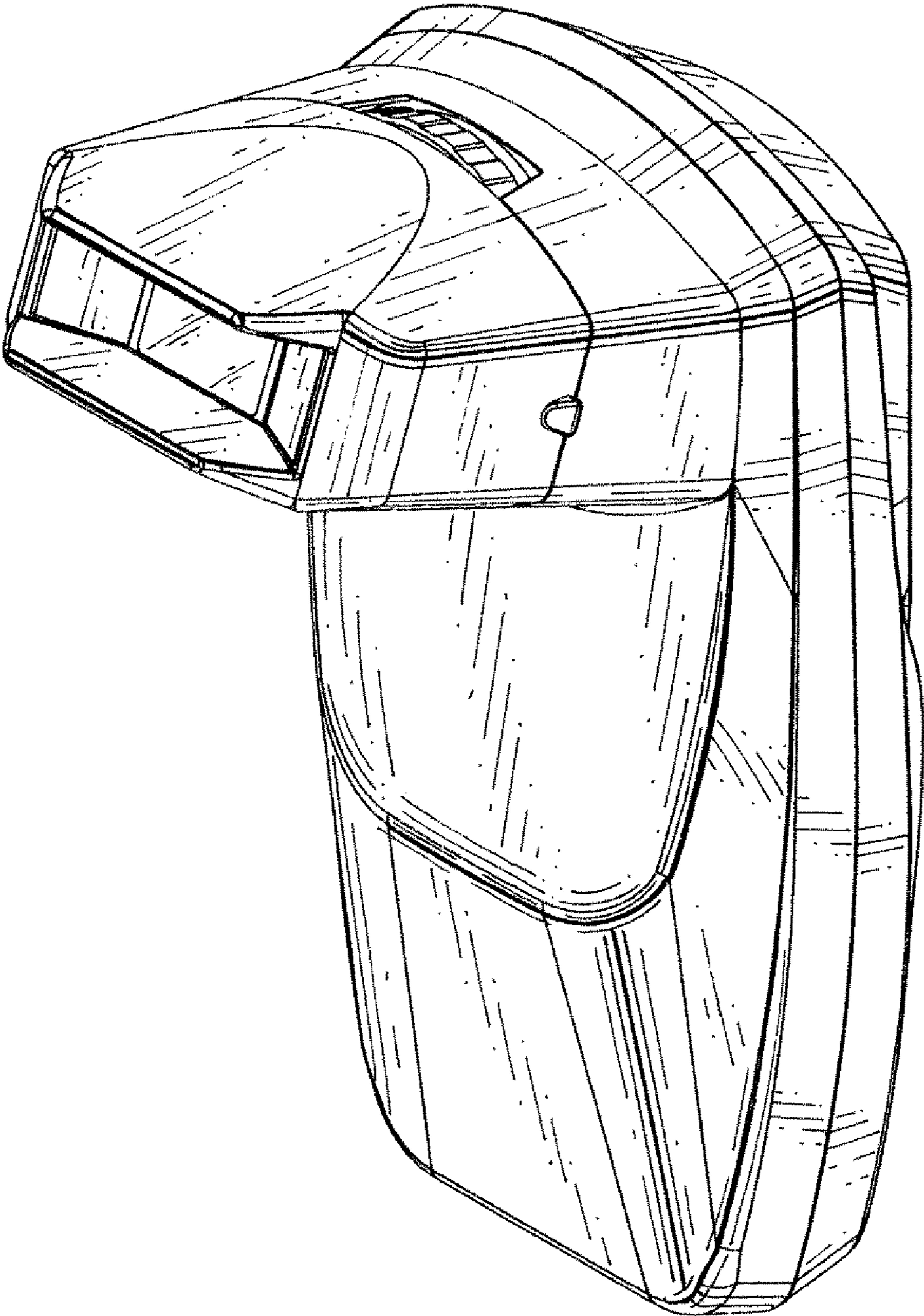

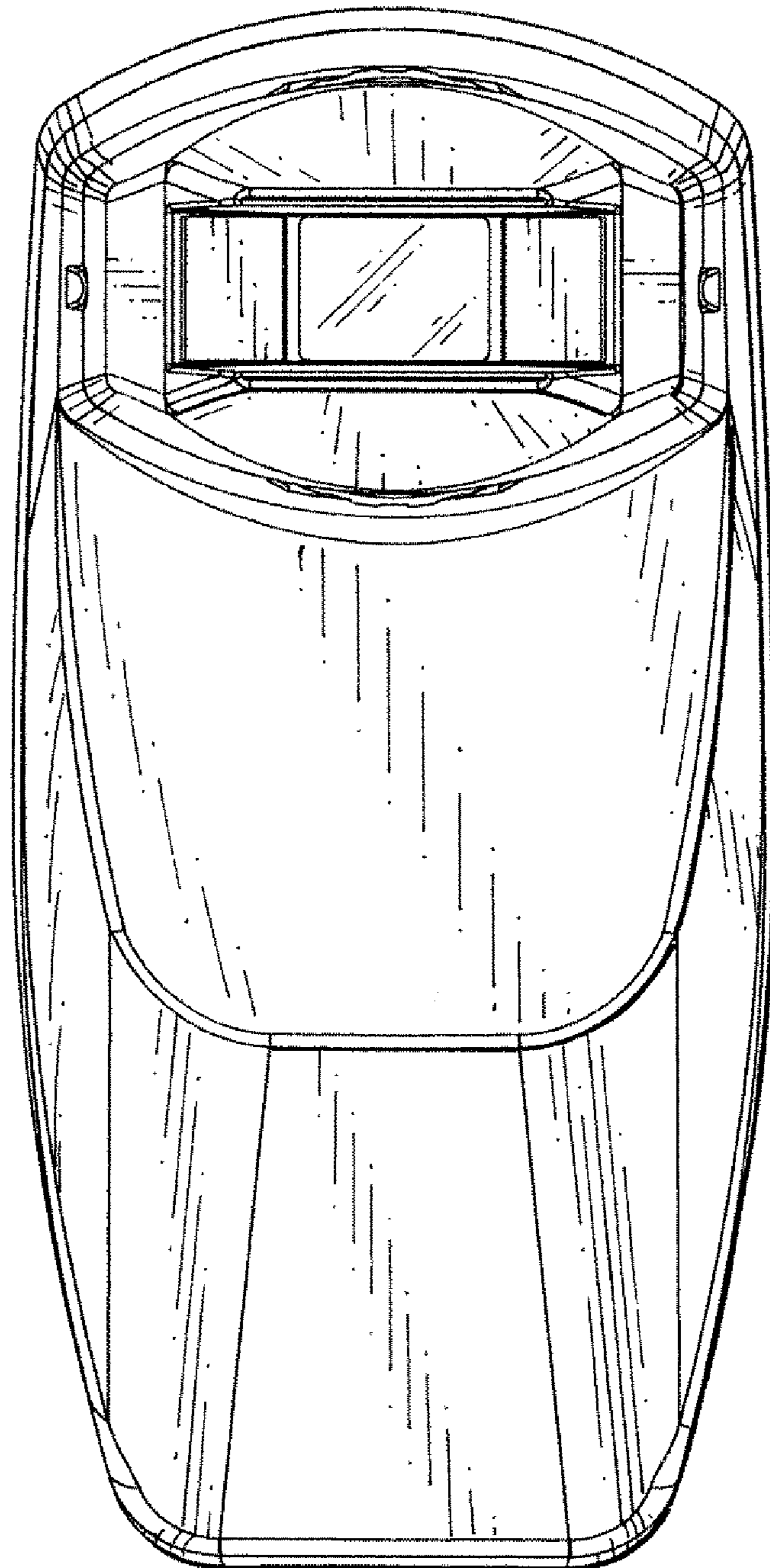

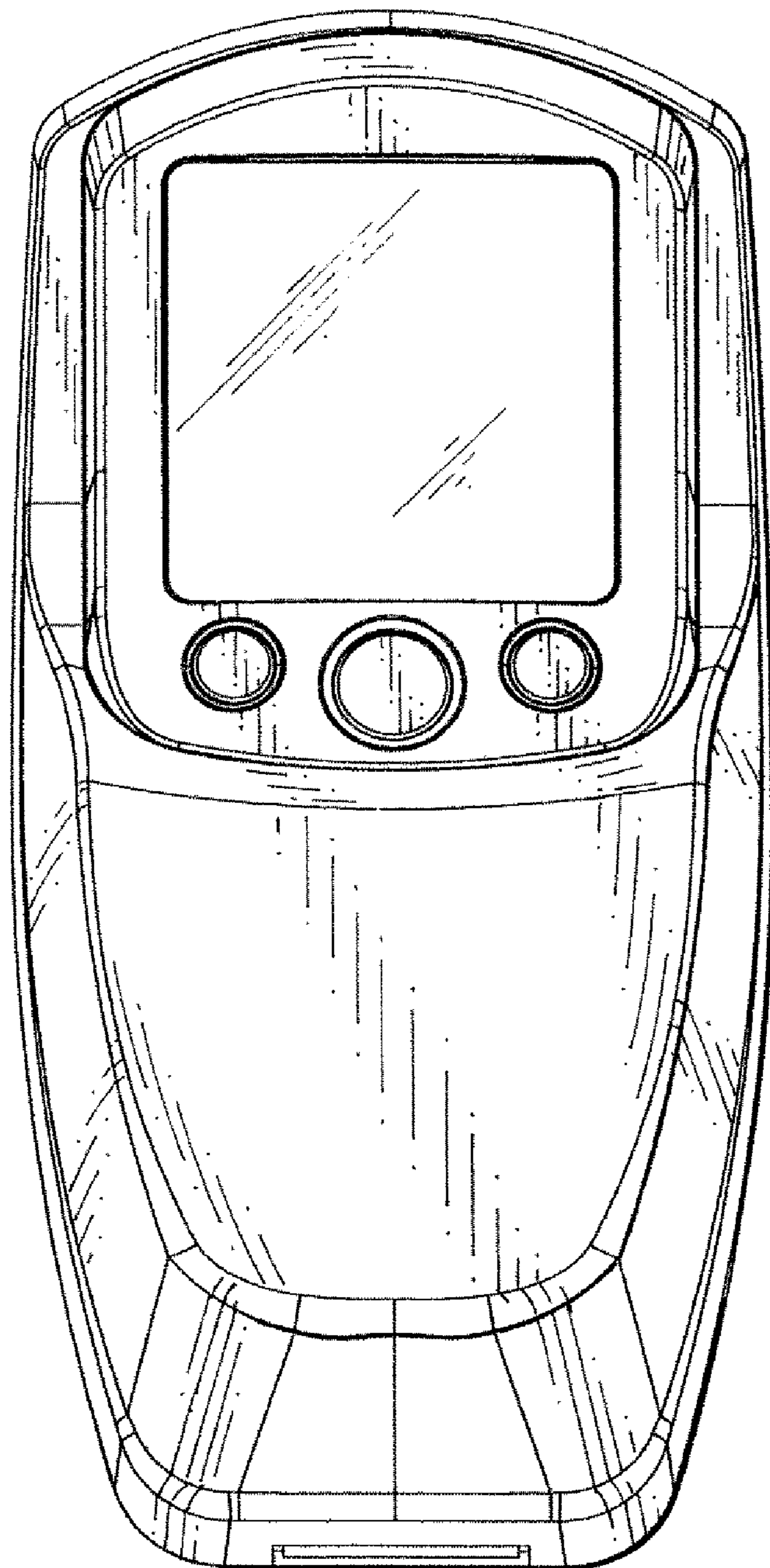

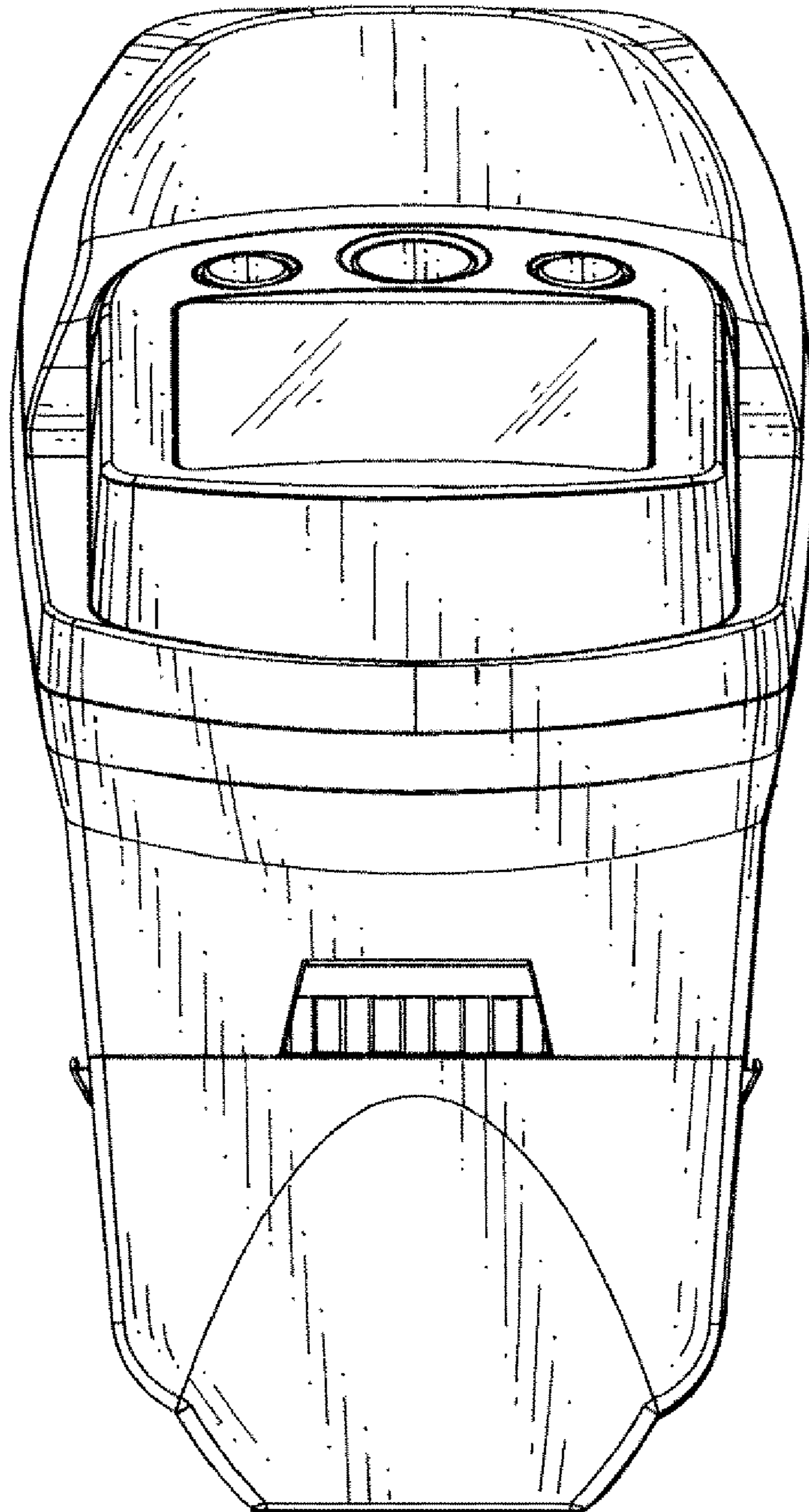

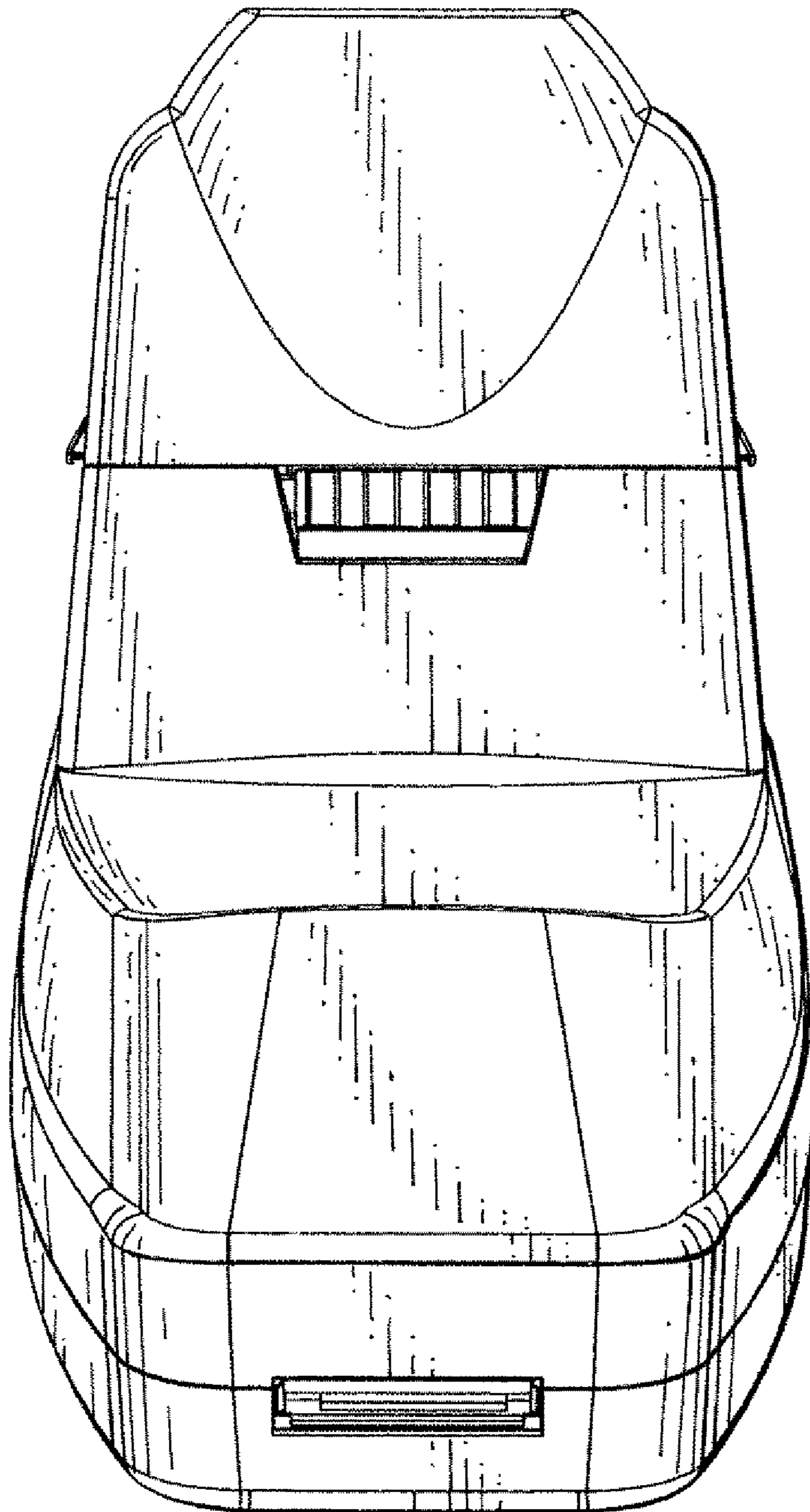

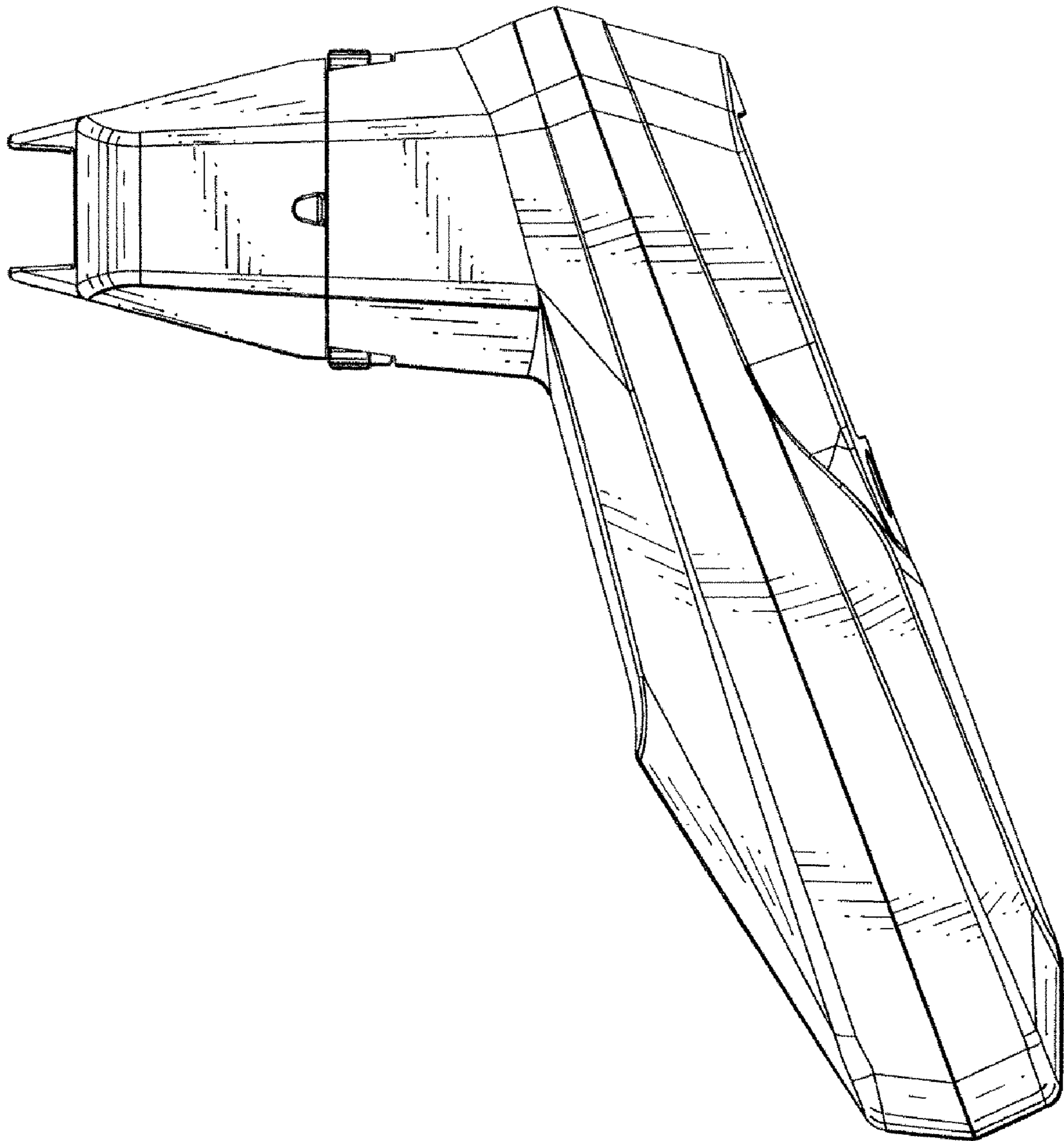
