(57) **CLAIM**

We claim the ornamental design for a baby bottle cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a baby bottle cover in accordance with the new design, with a baby bottle shown in phantom.

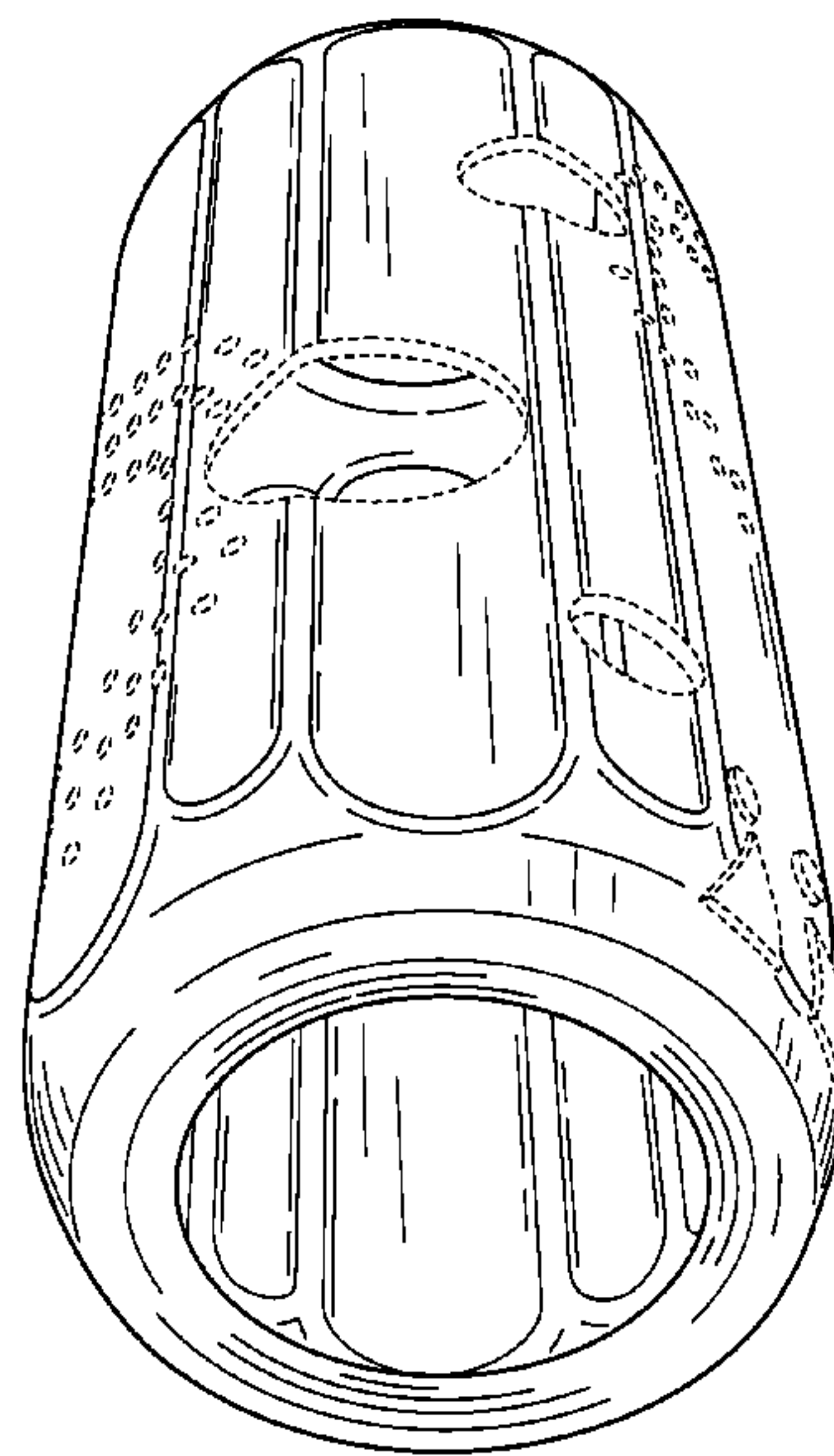
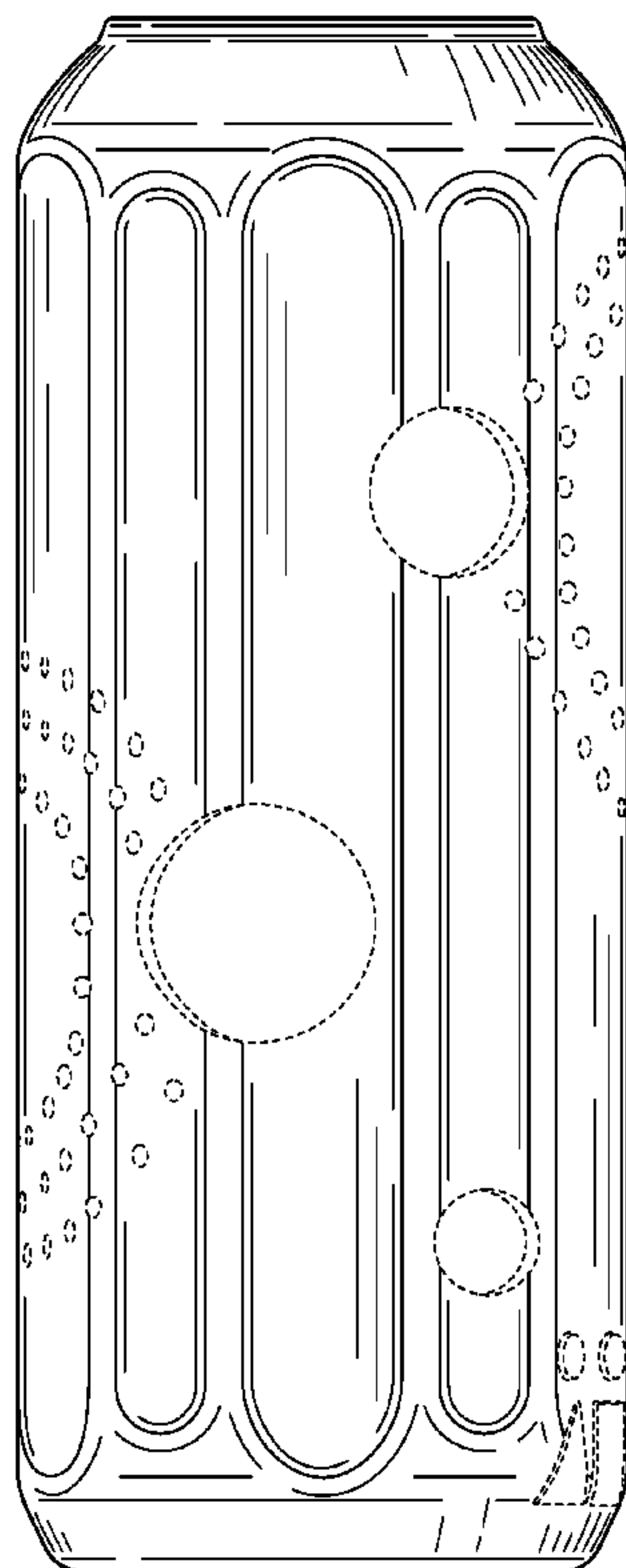
FIG. 2 is a first side elevational view of the bottle cover of FIG. 1.

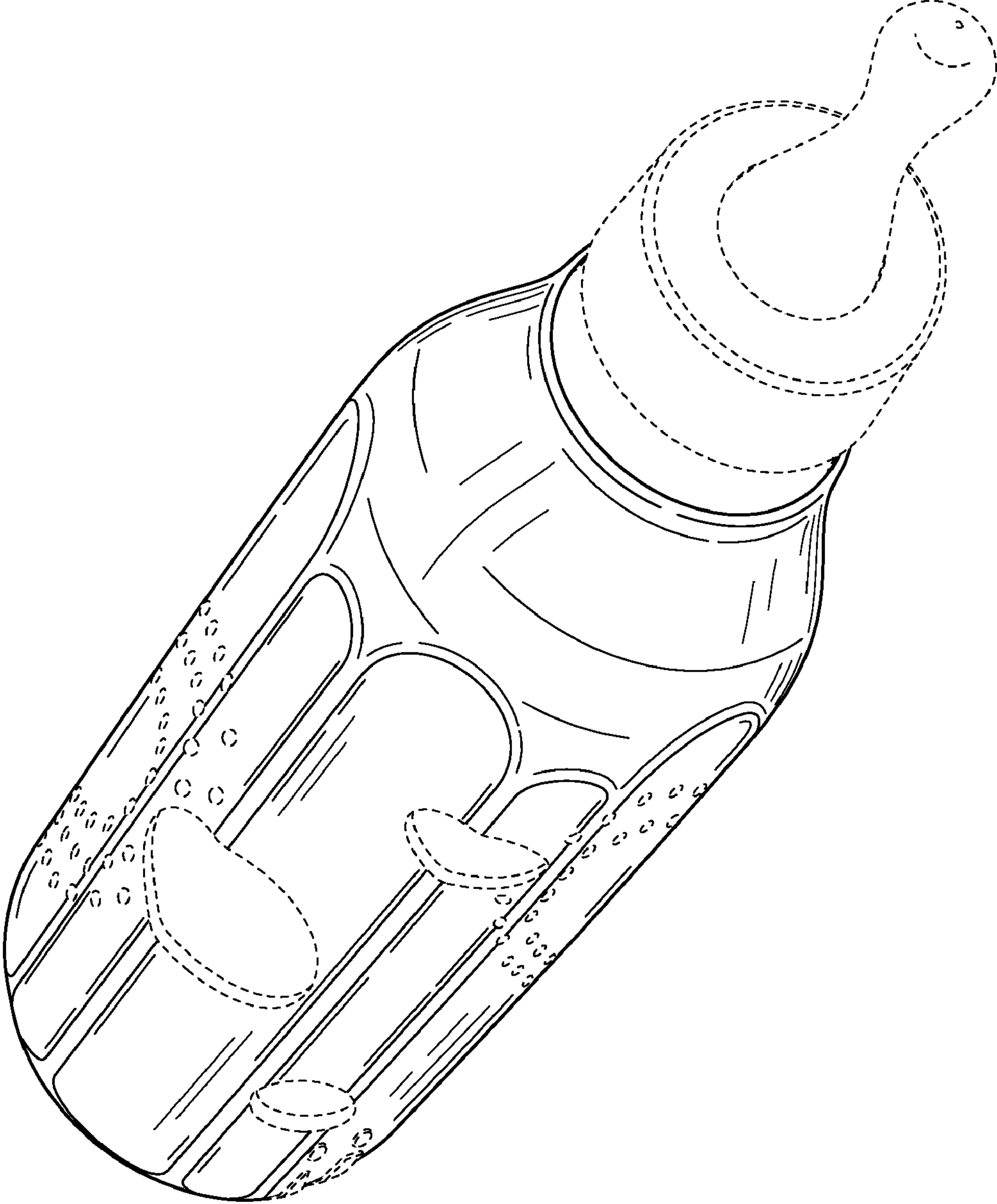

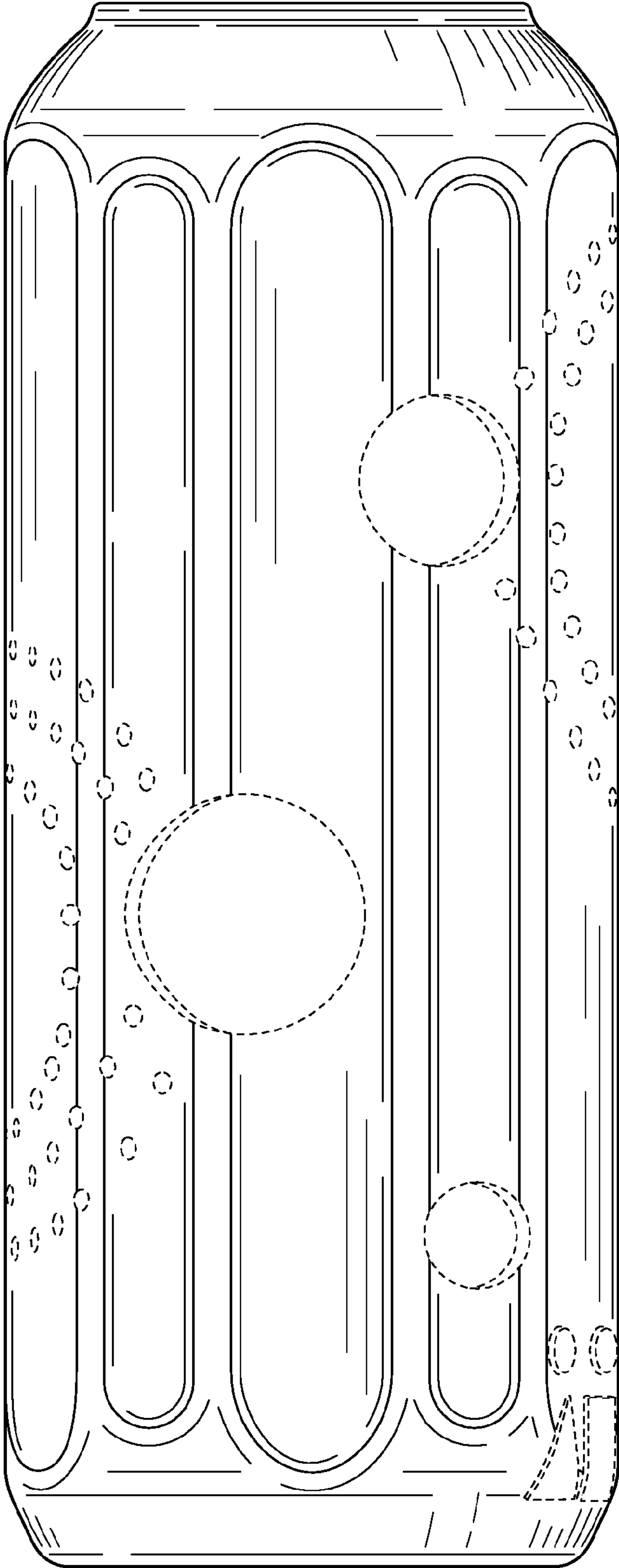

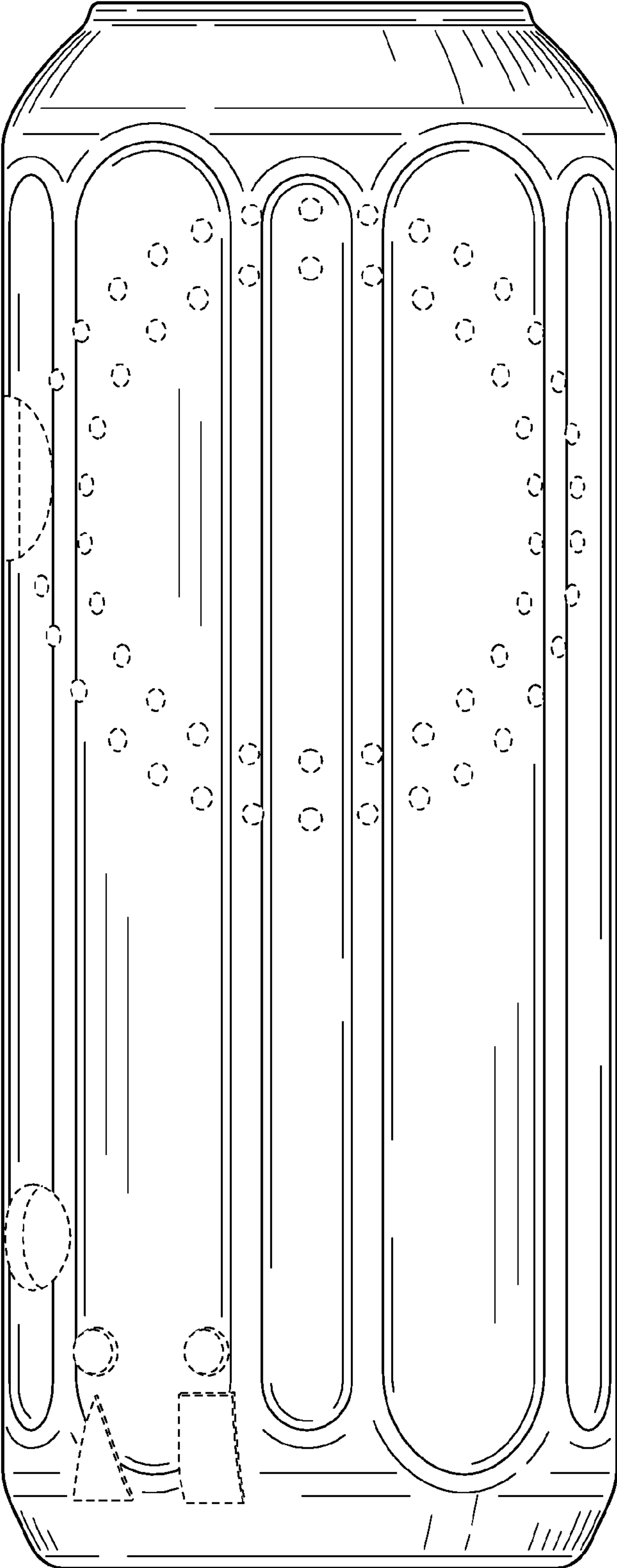

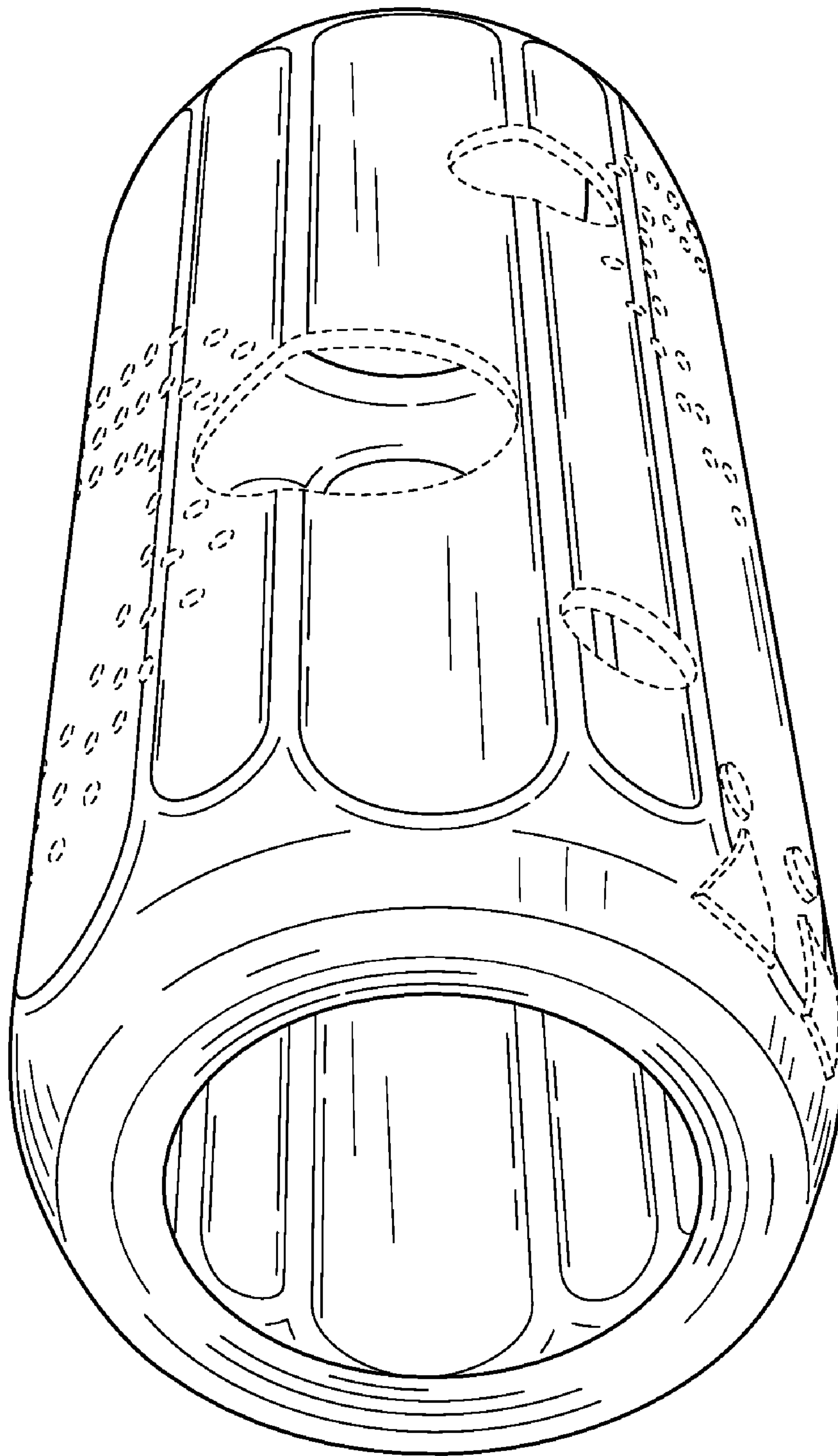
