(57) **CLAIM**

The ornamental design for a portion of a footwear upper, as shown and described.

DESCRIPTION

FIG. 1 is a lateral perspective view of a portion of a footwear upper showing my new design;

FIG. 2 is a medial side elevational view thereof;

FIG. 3 is a lateral side elevational view thereof;

FIG. 4 is a front elevational view thereof;

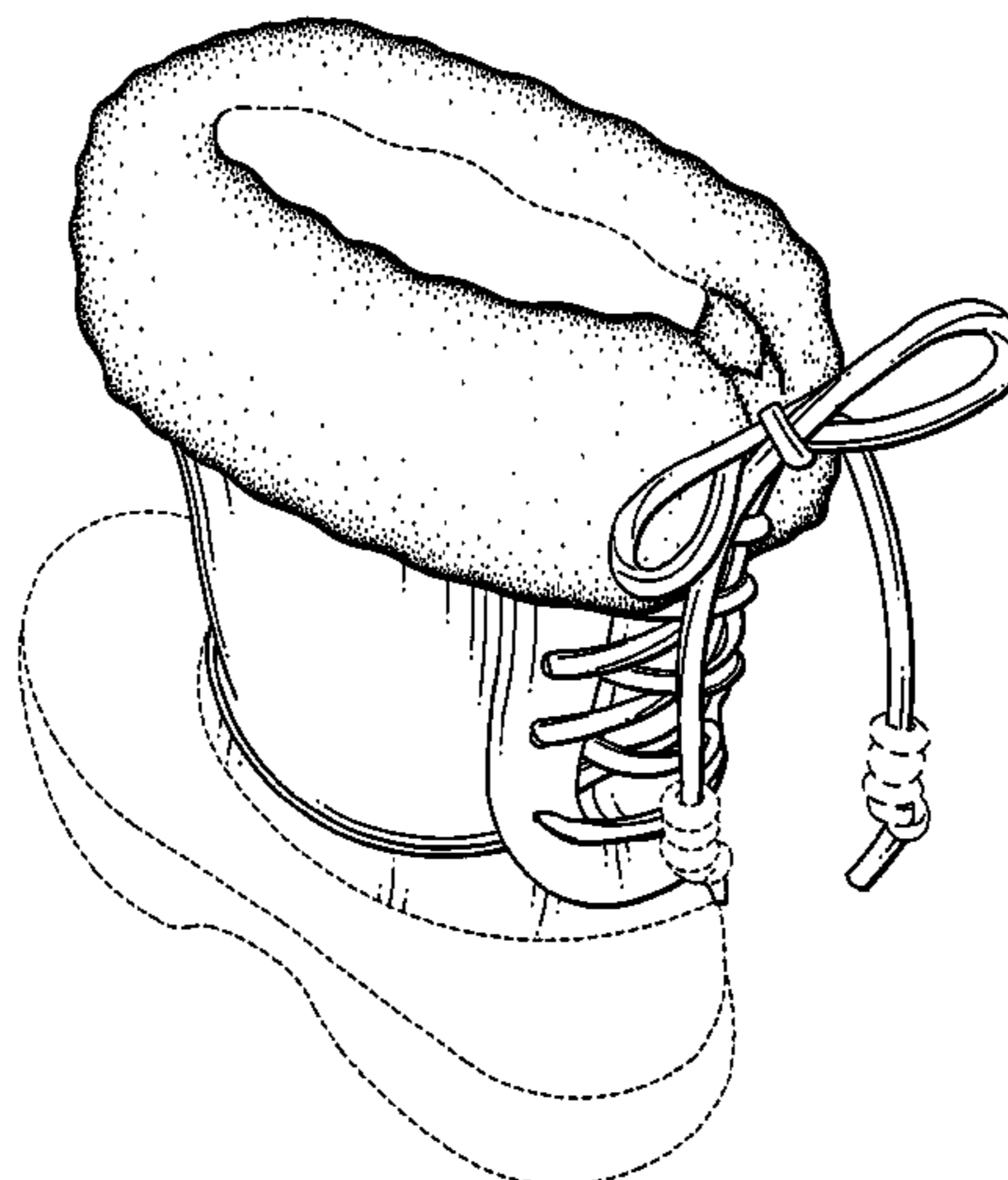
FIG. 5 is a rear elevational view thereof;

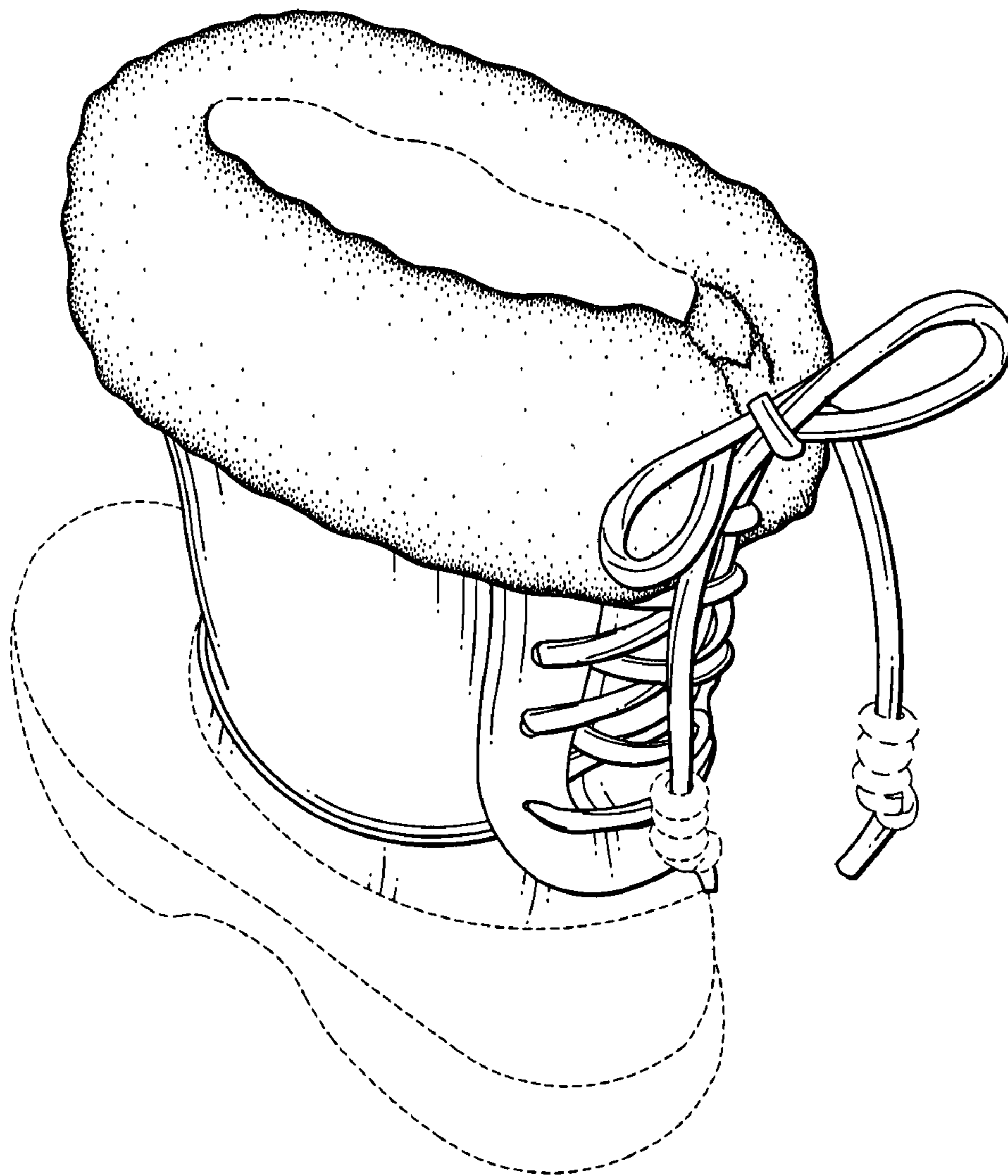

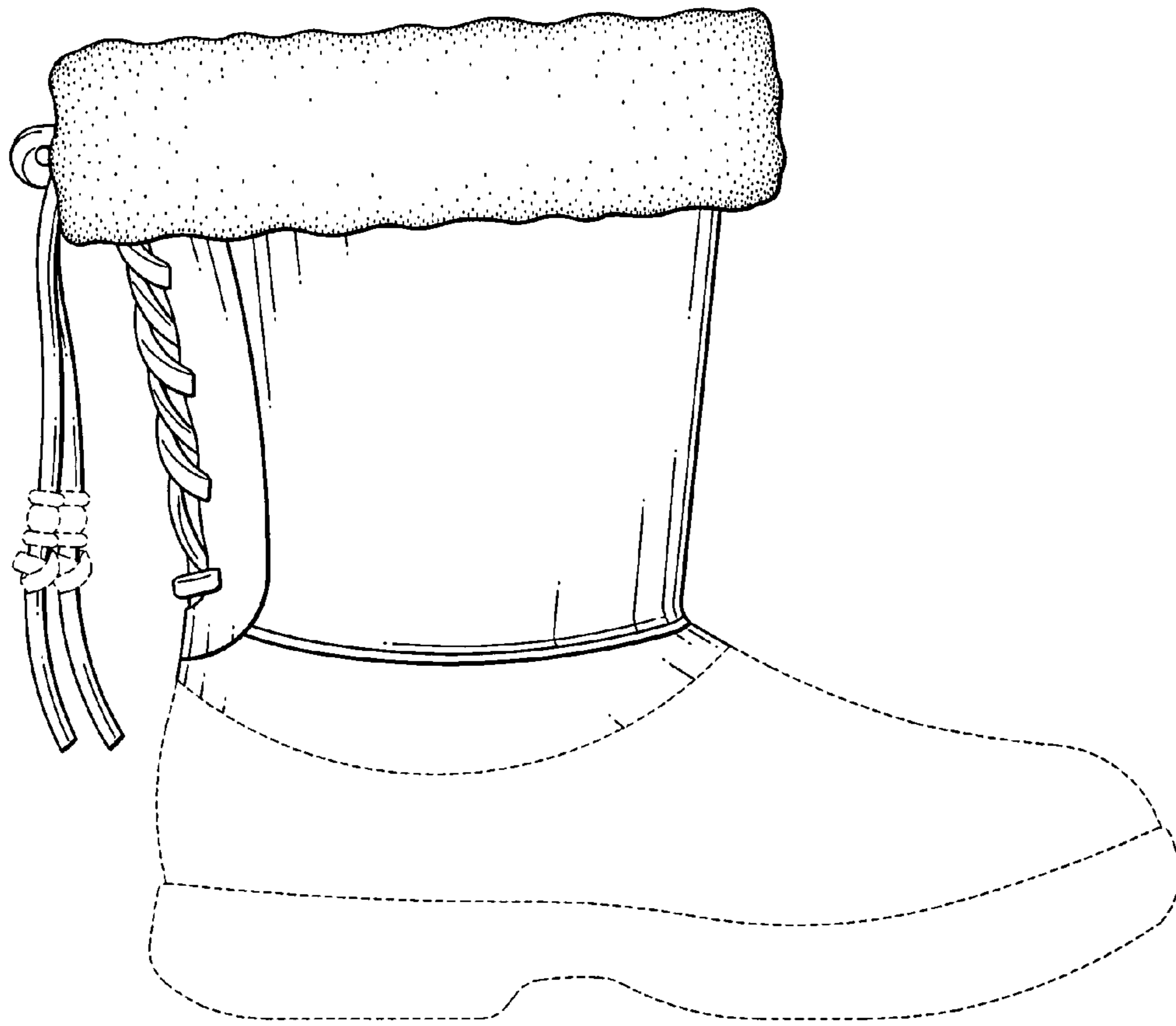

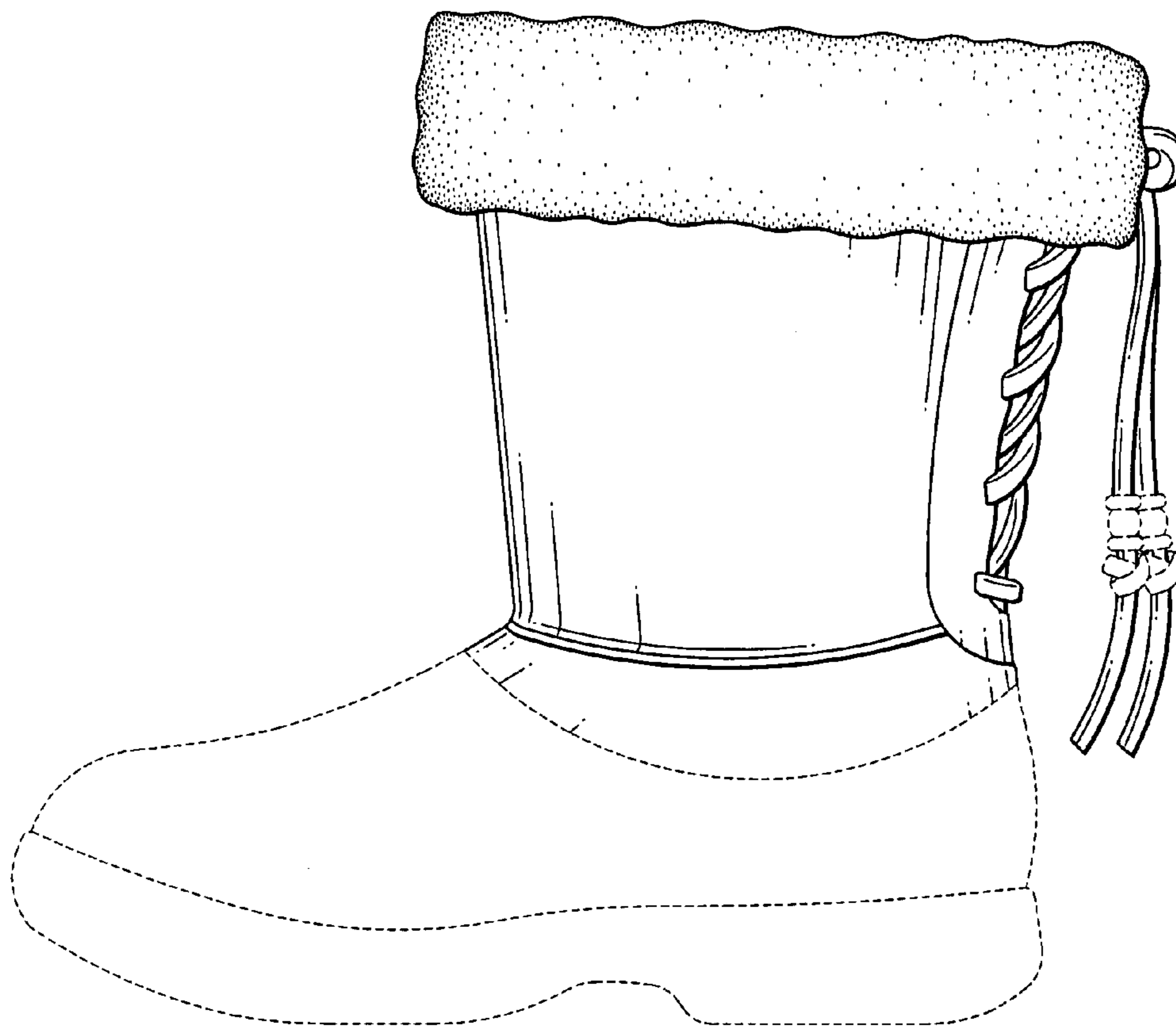

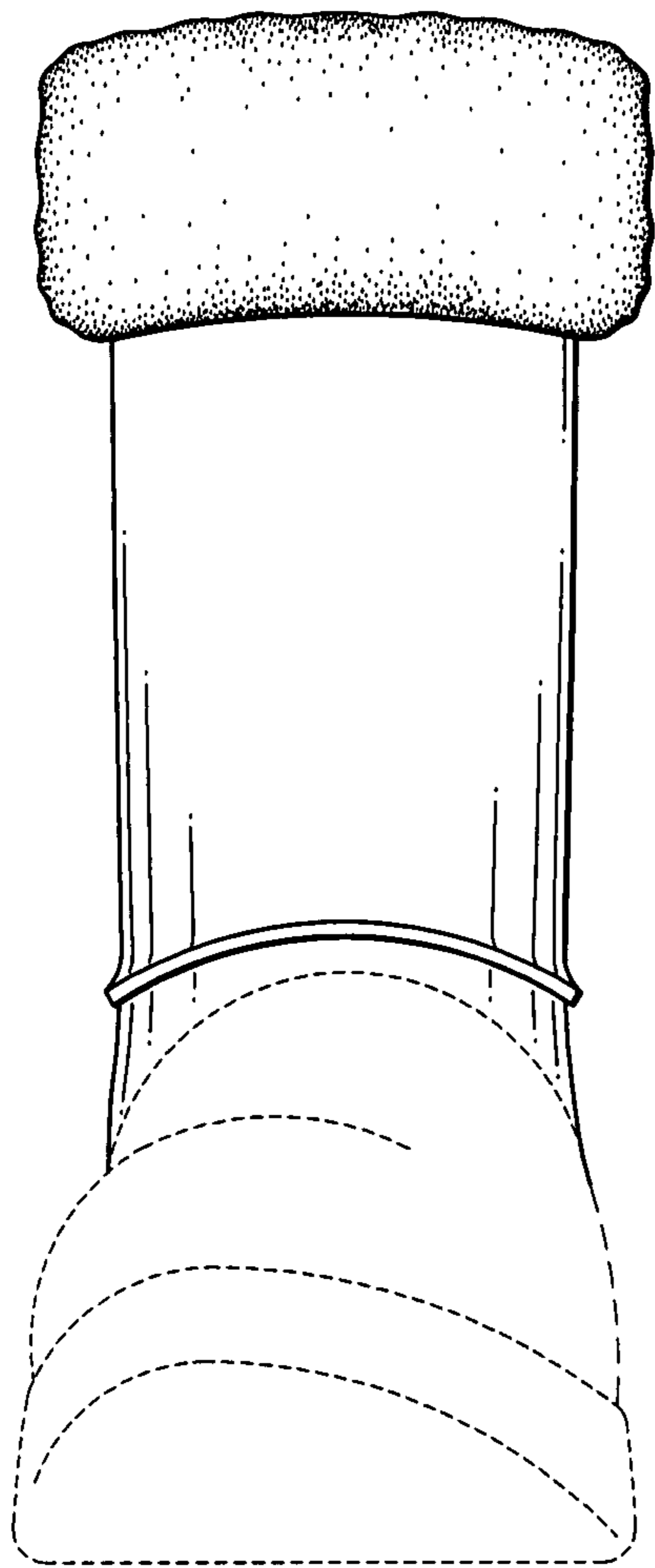

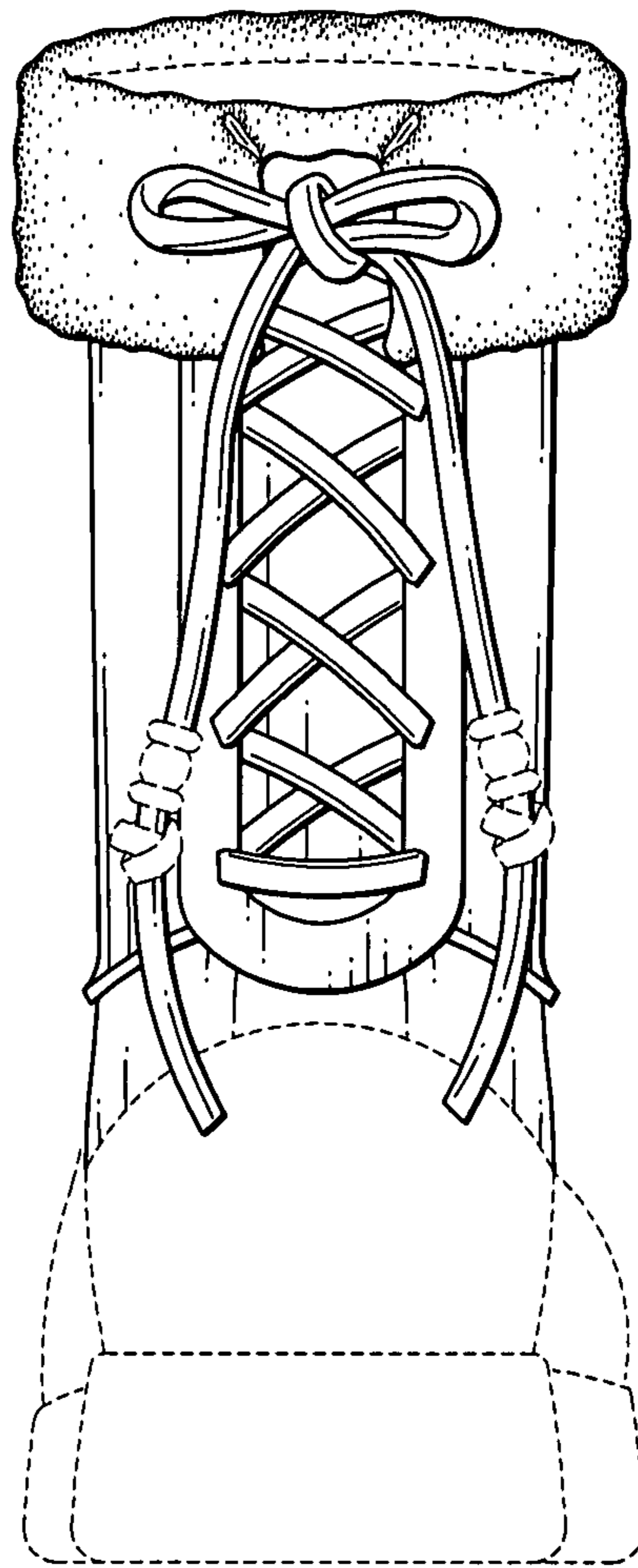

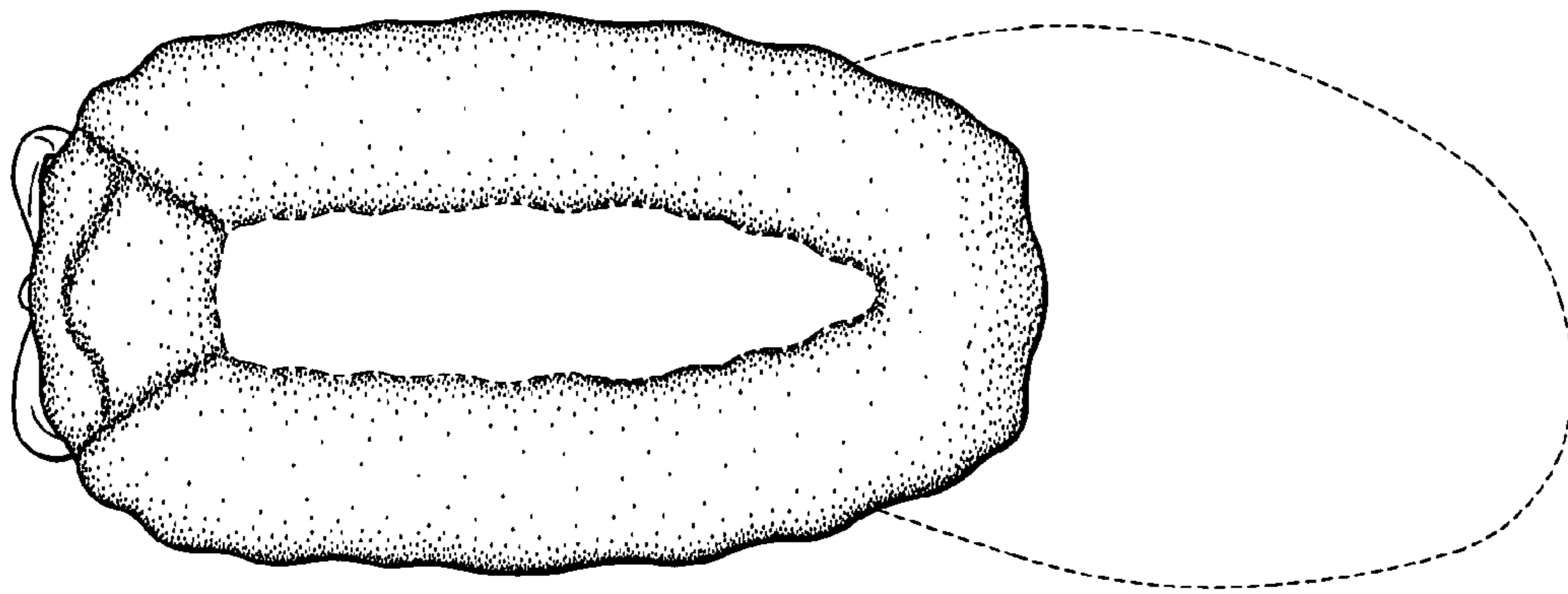

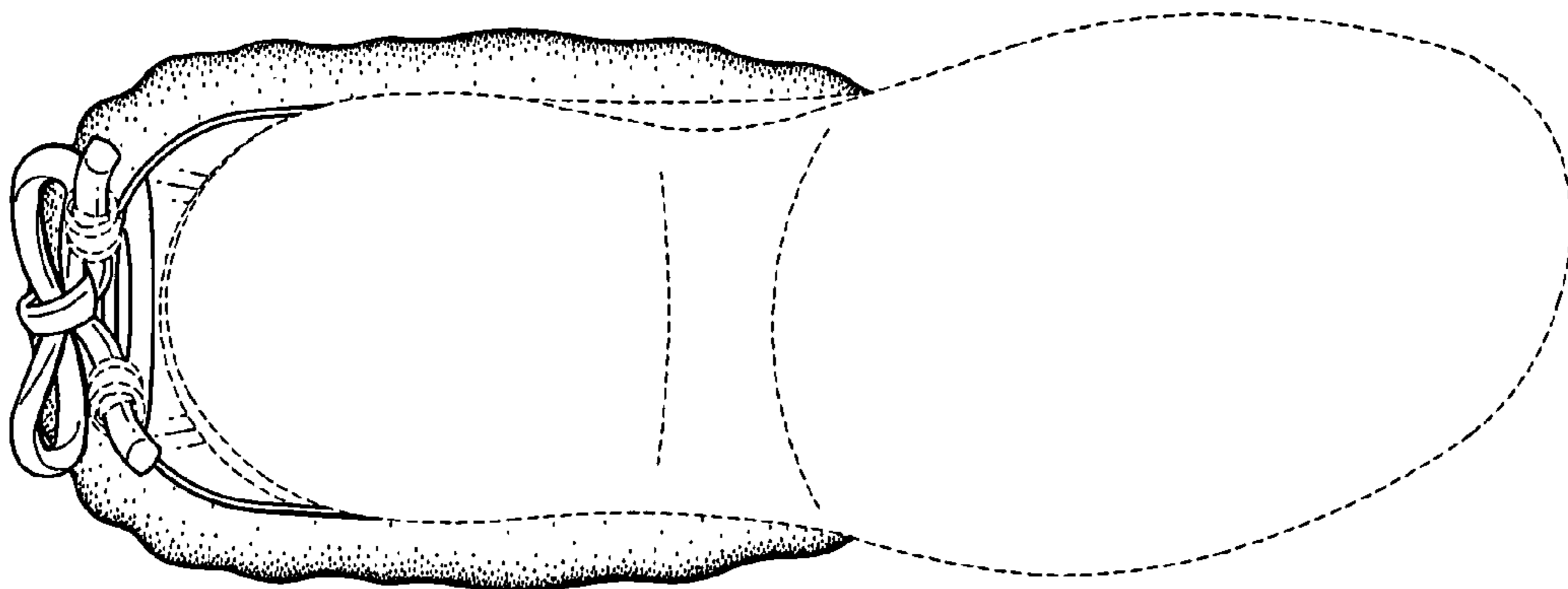
