(57) **CLAIM**

The ornamental design for a carrying bag for a survey rod, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective of a carrying bag for a survey rod;

FIG. 2 is a right side elevational view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

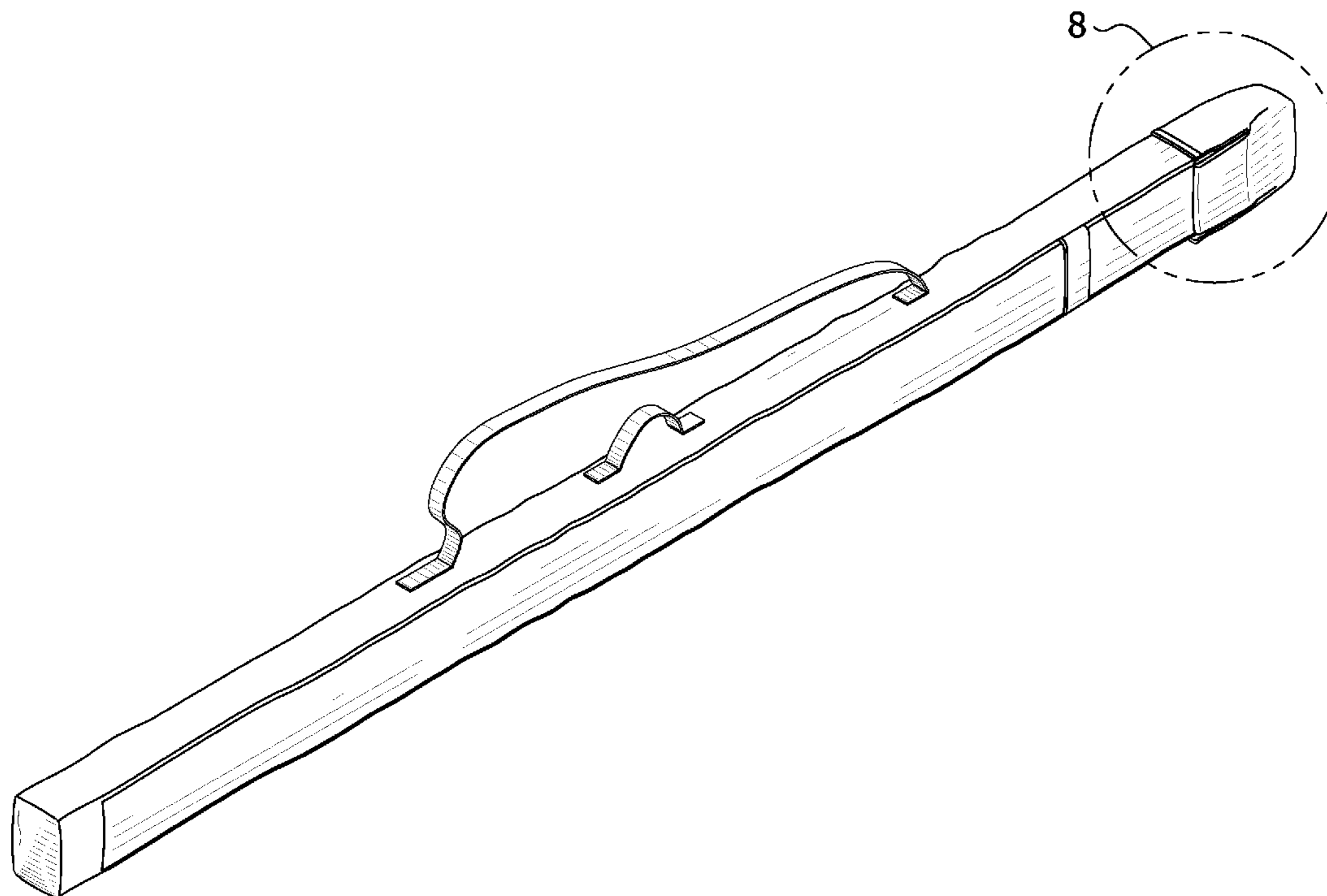
FIG. 6 is a rear end view thereof;

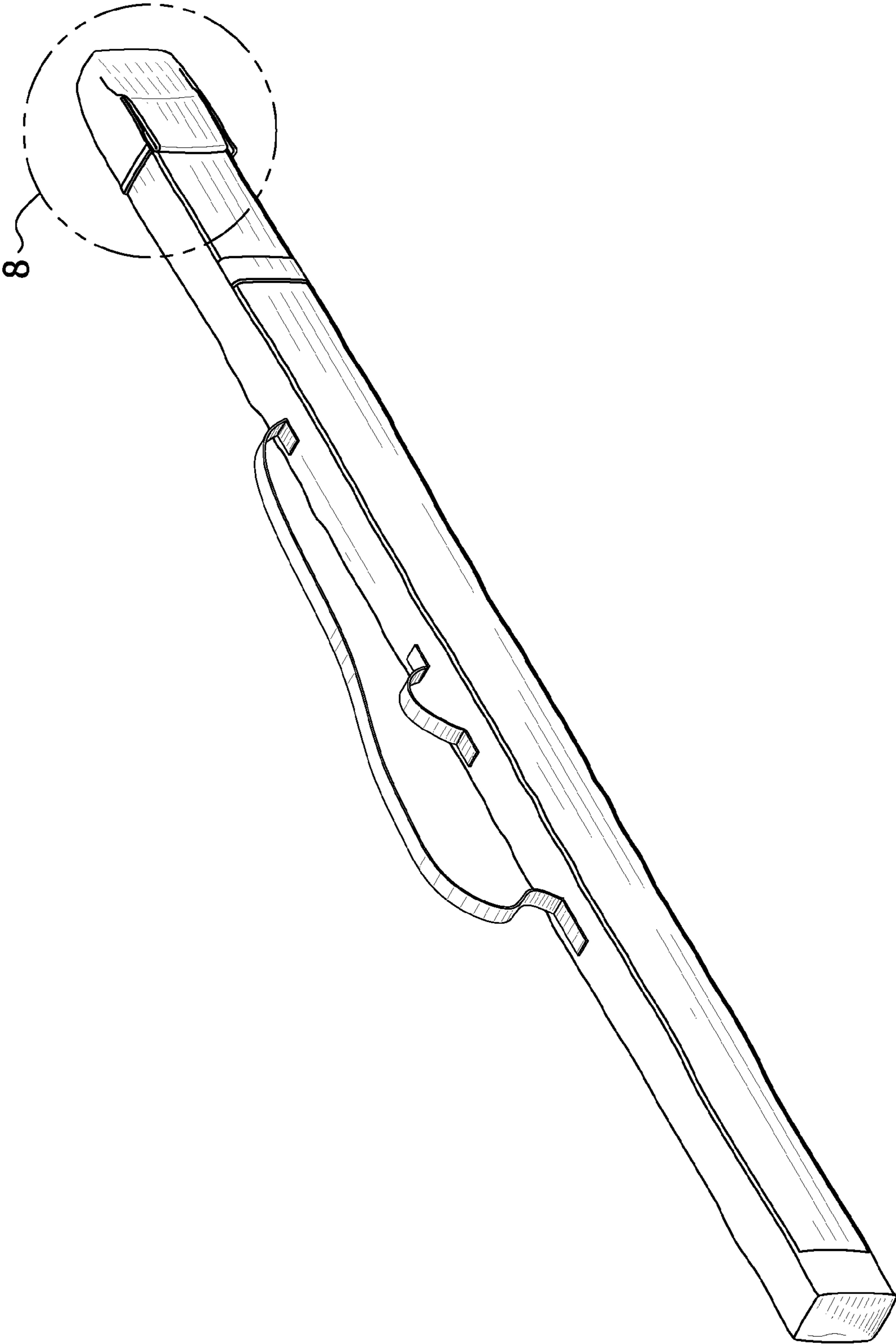

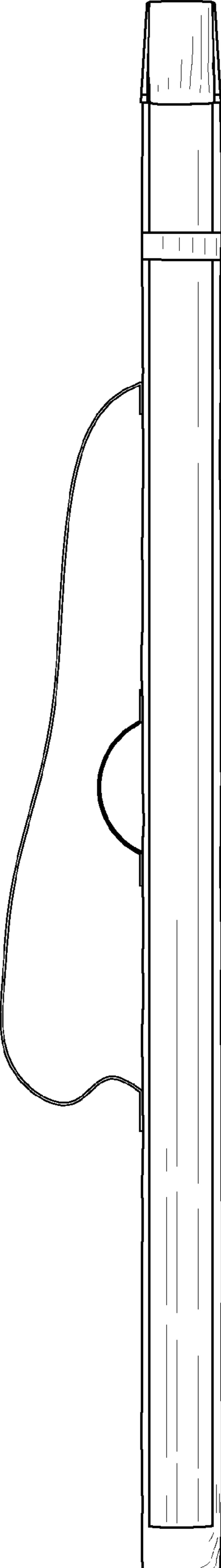

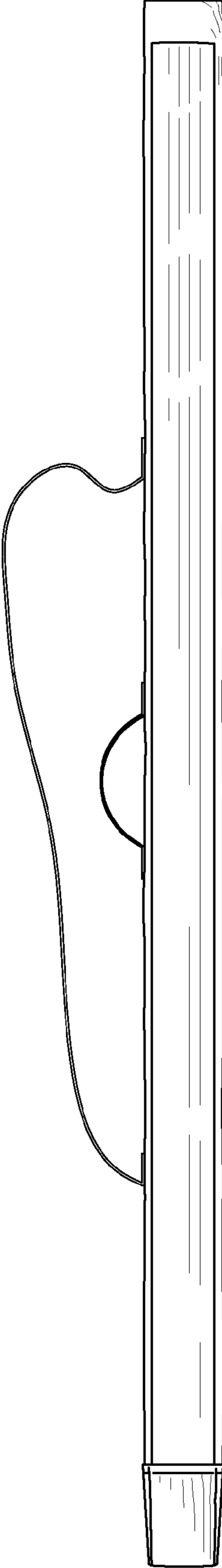

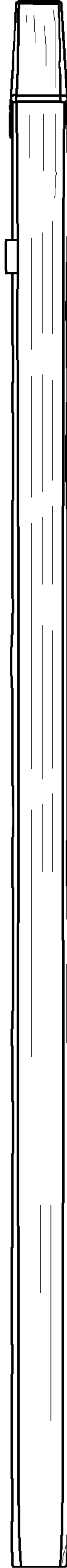

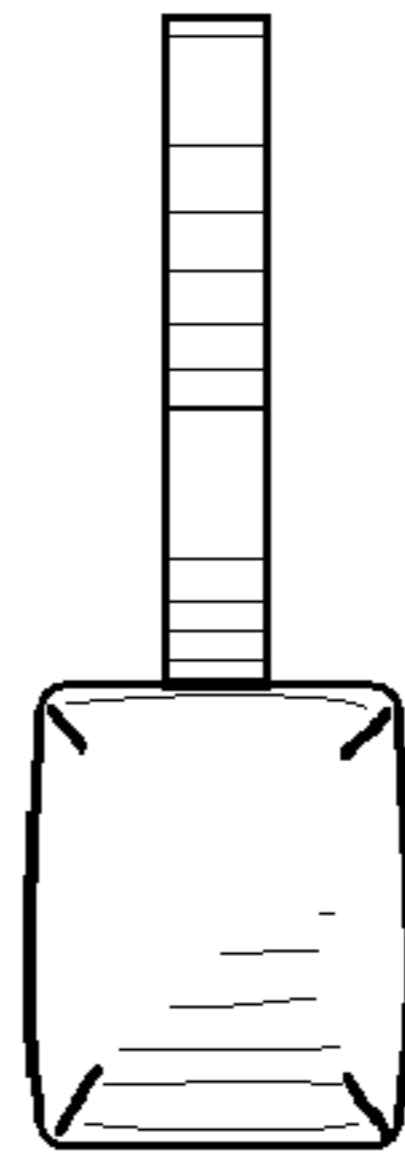

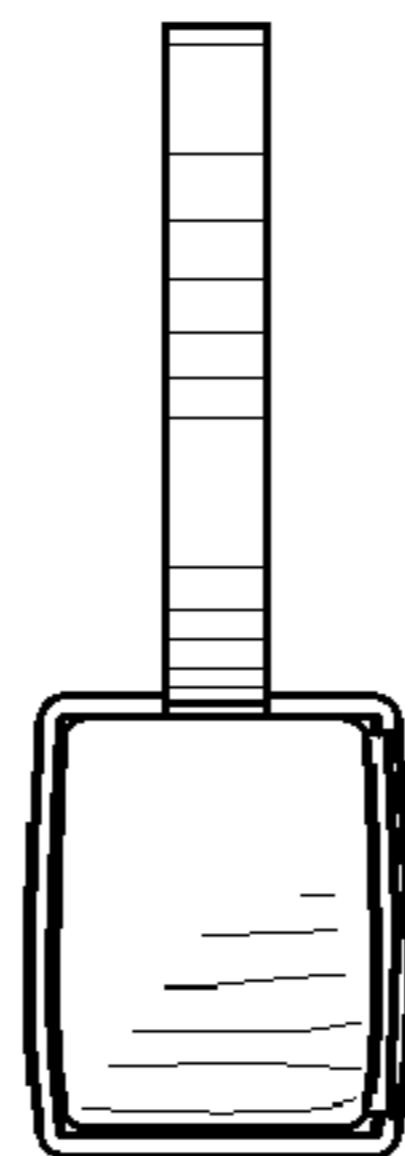

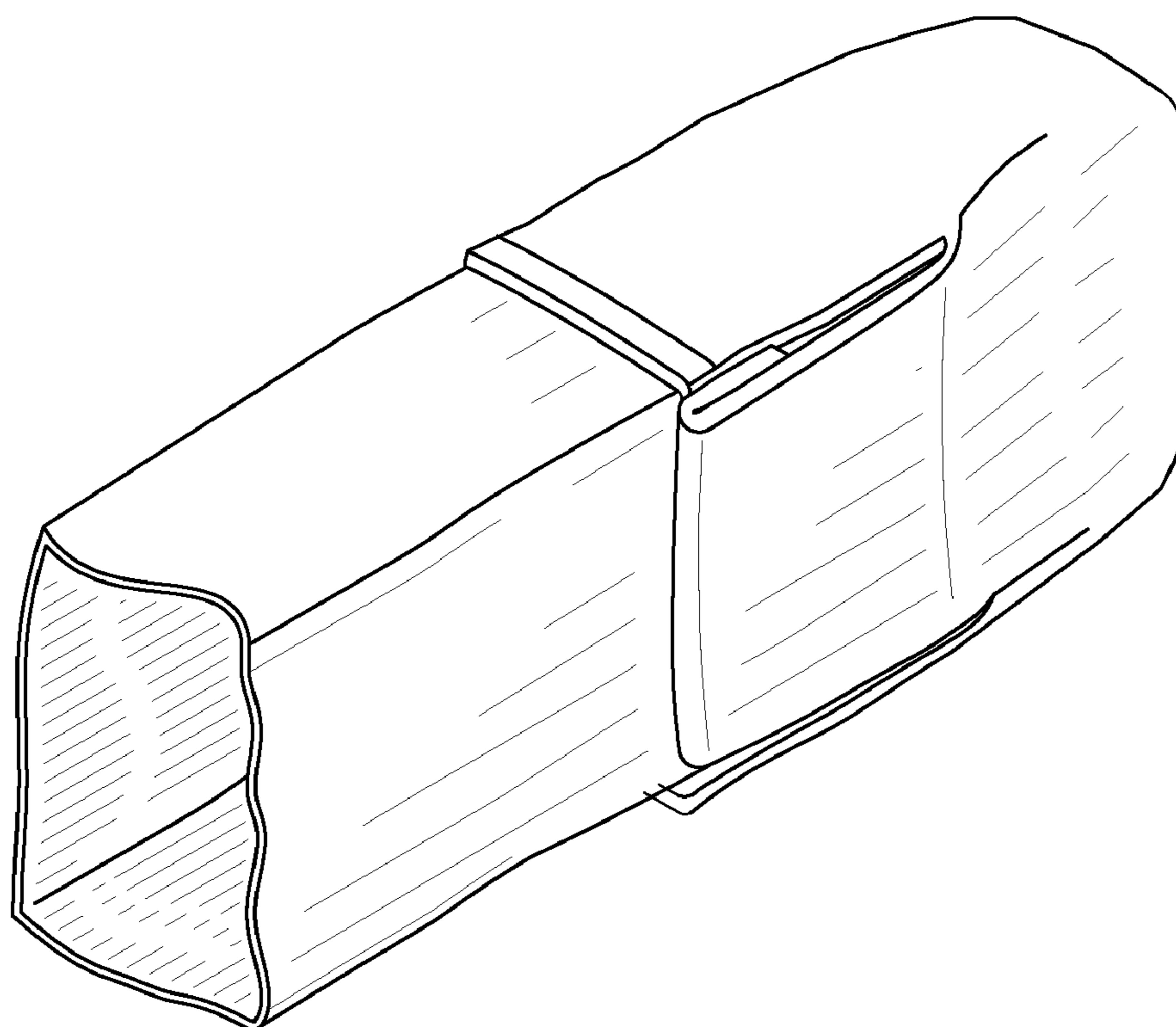
