(57) **CLAIM**

The ornamental design for an oral brush head, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of the oral brush head showing the new design, the broken lines showing a second brush head and a handle being included for the purpose of illustrating environmental structure that forms no part of the claimed design;

FIG. 2 is an enlarged isometric view of the oral brush head of FIG. 1;

FIG. 3 is a front elevation view of the oral brush head of FIG. 2;

FIG. 4 is a rear elevation view of the oral brush head of FIG. 2;

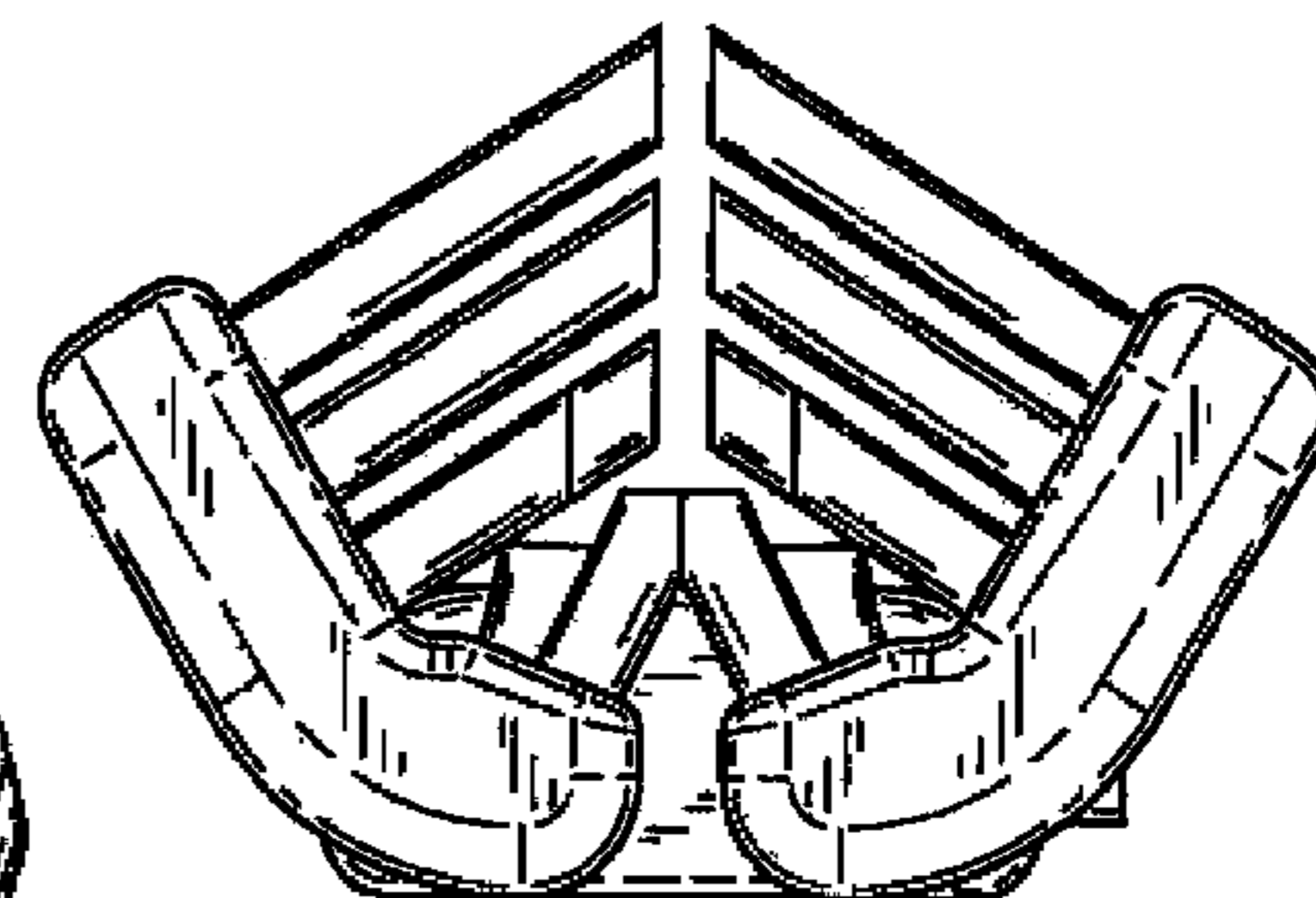
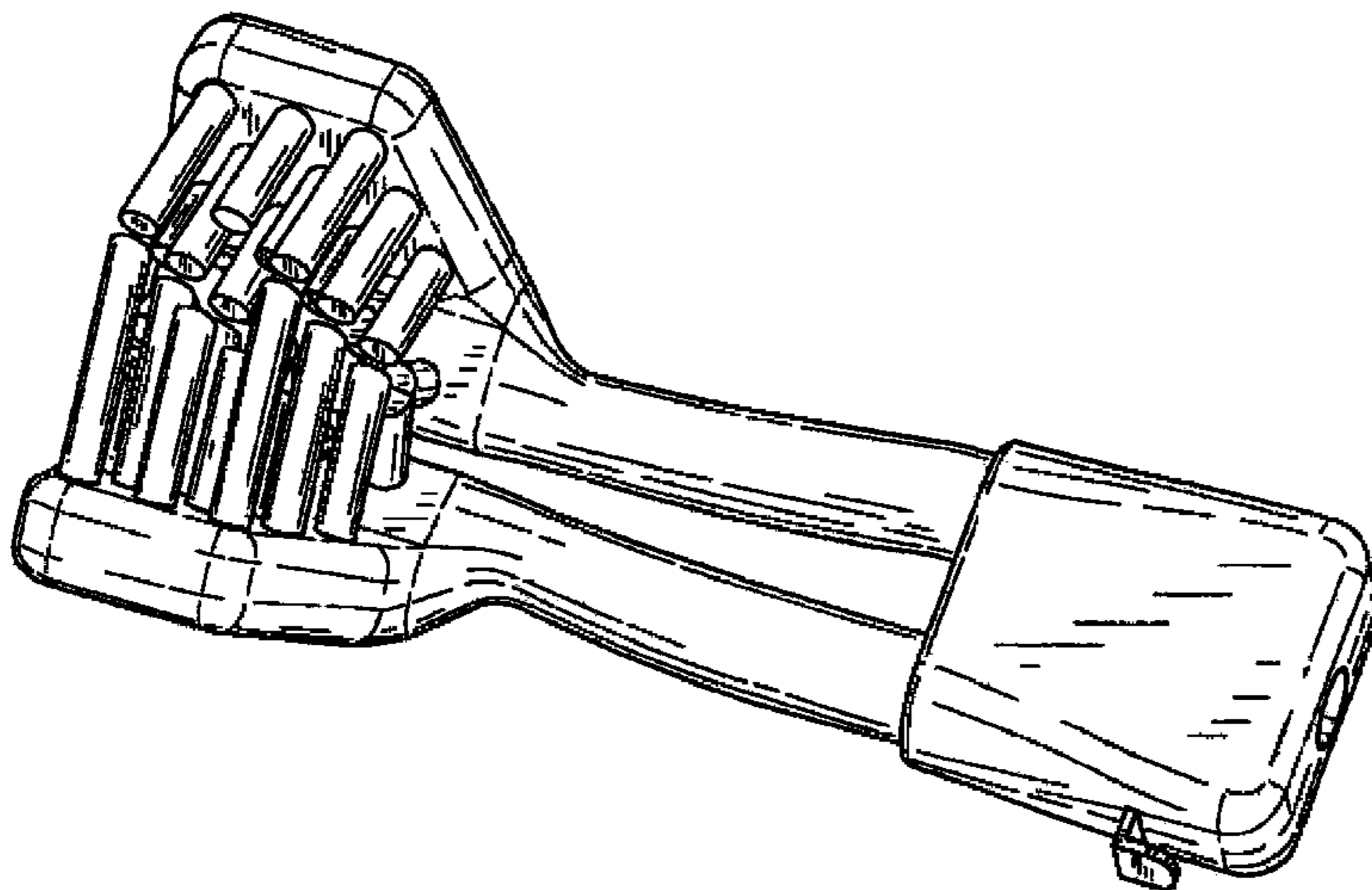
FIG. 5 is an elevation view of one side of the oral brush head of FIG. 2;

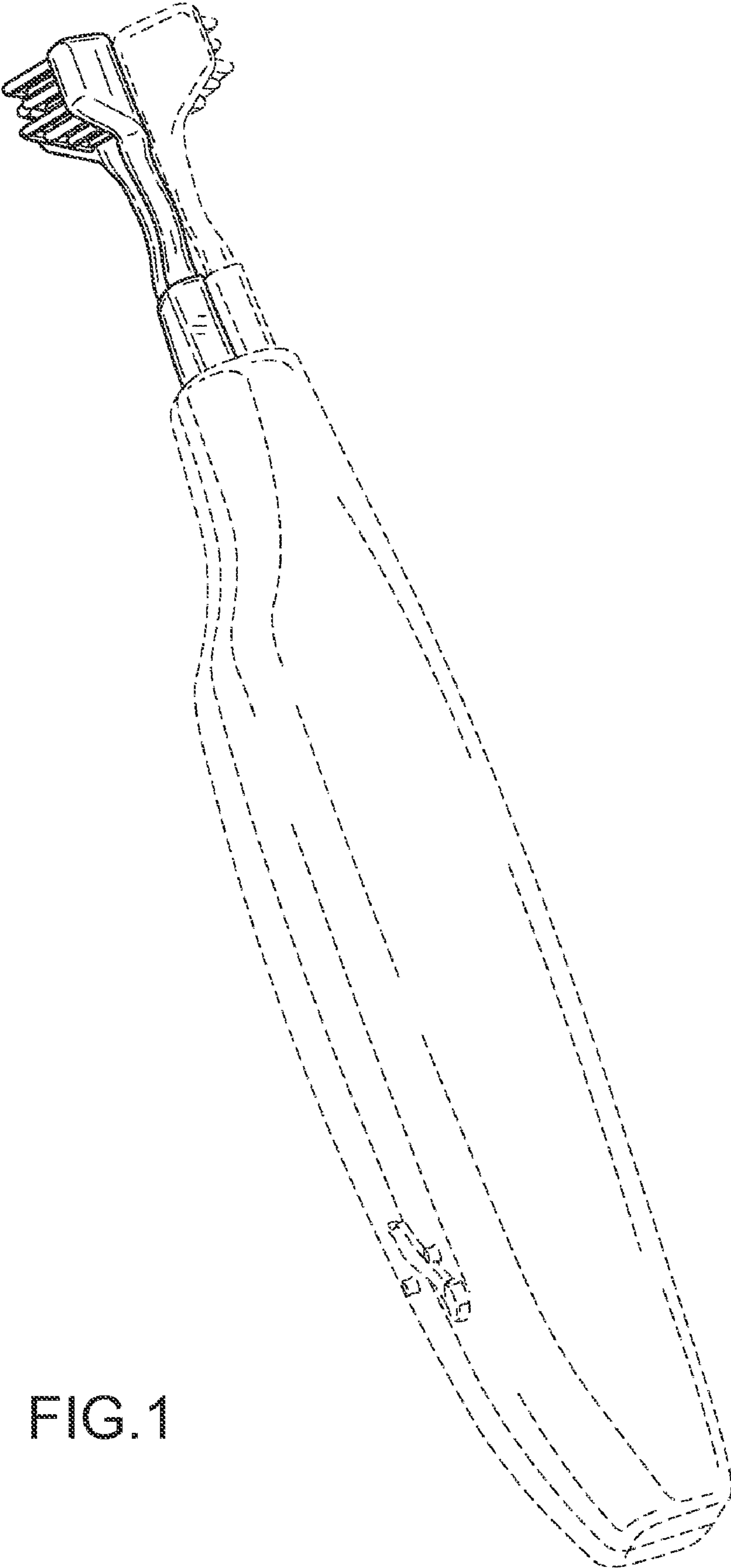

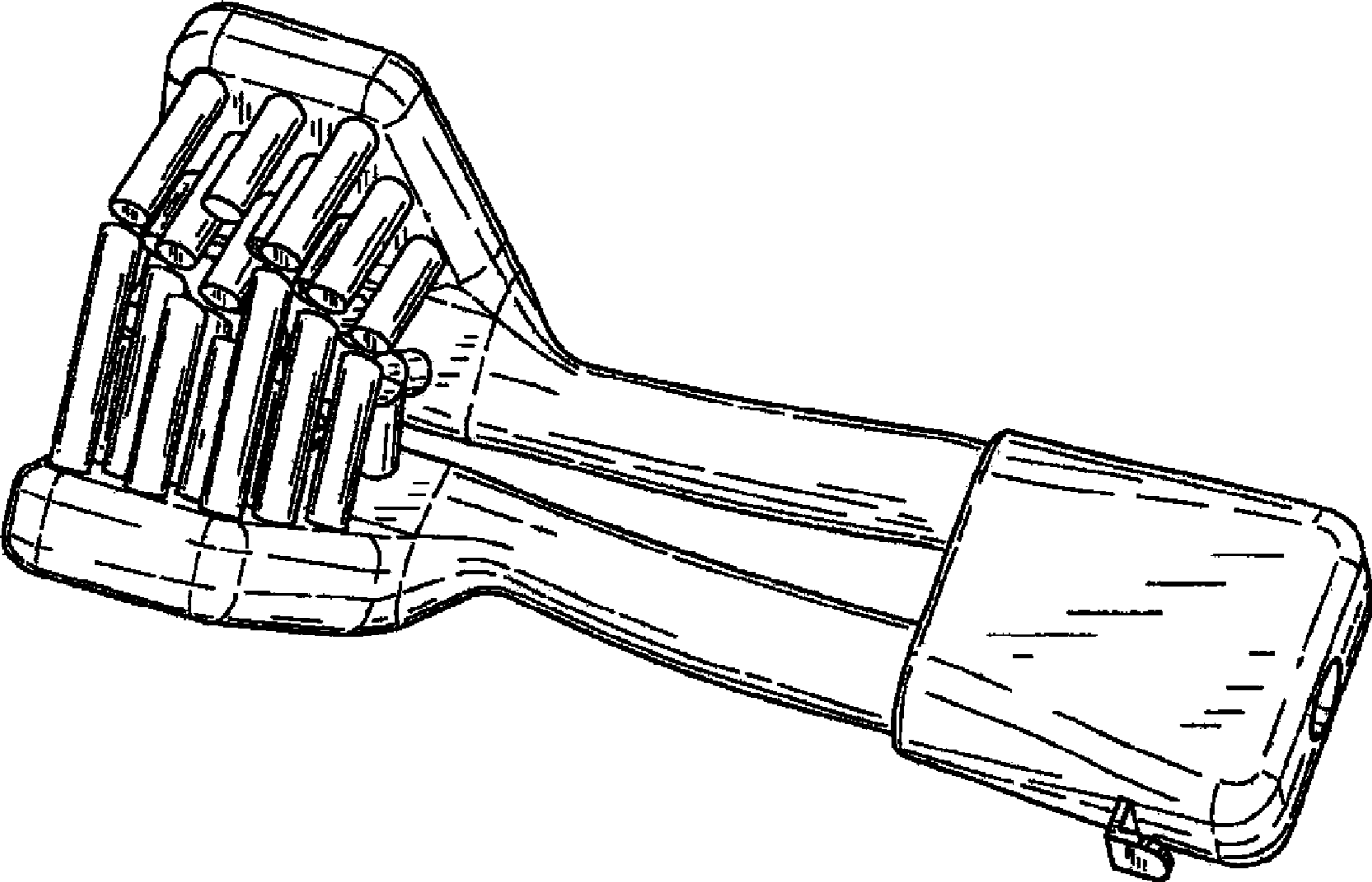

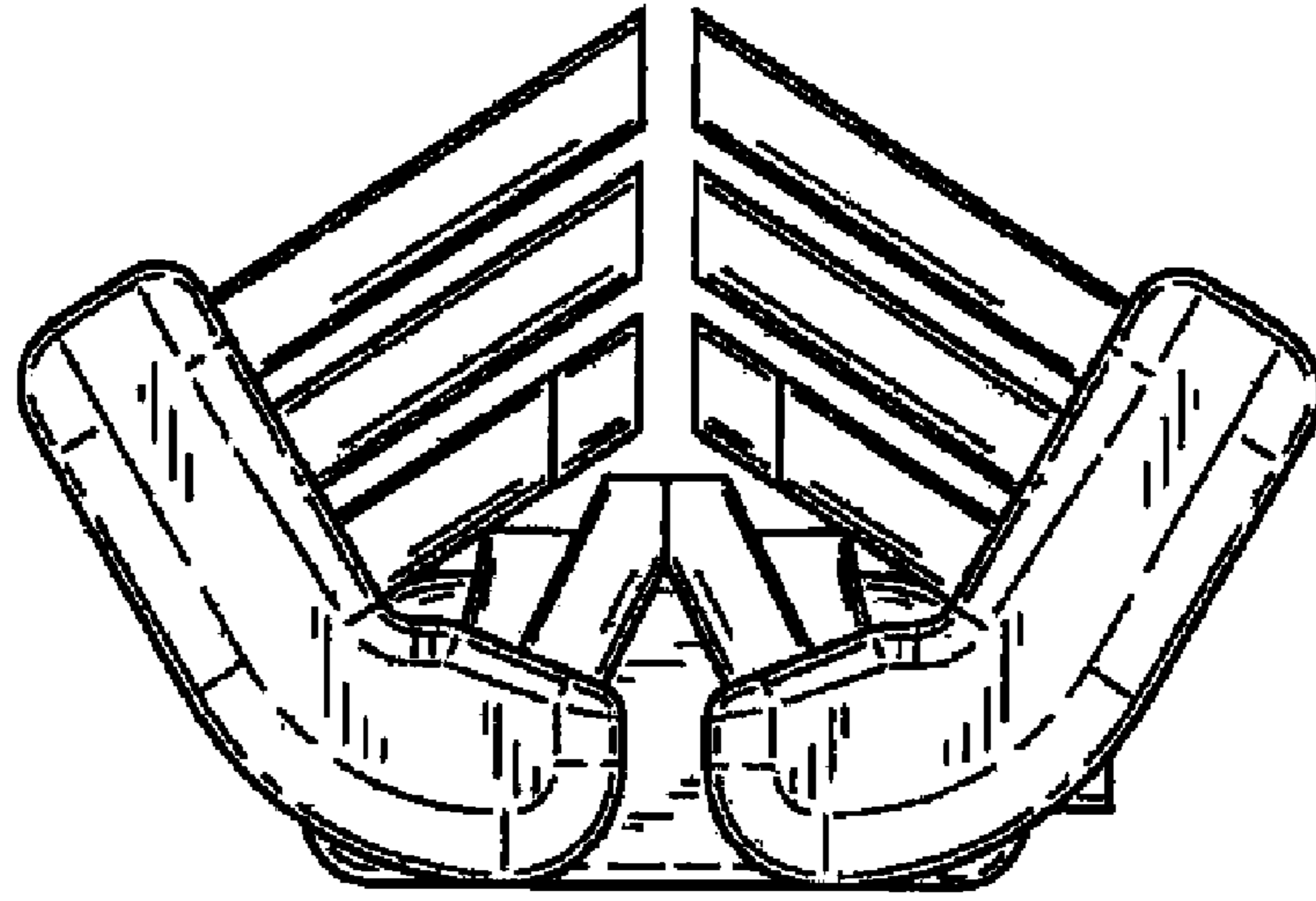

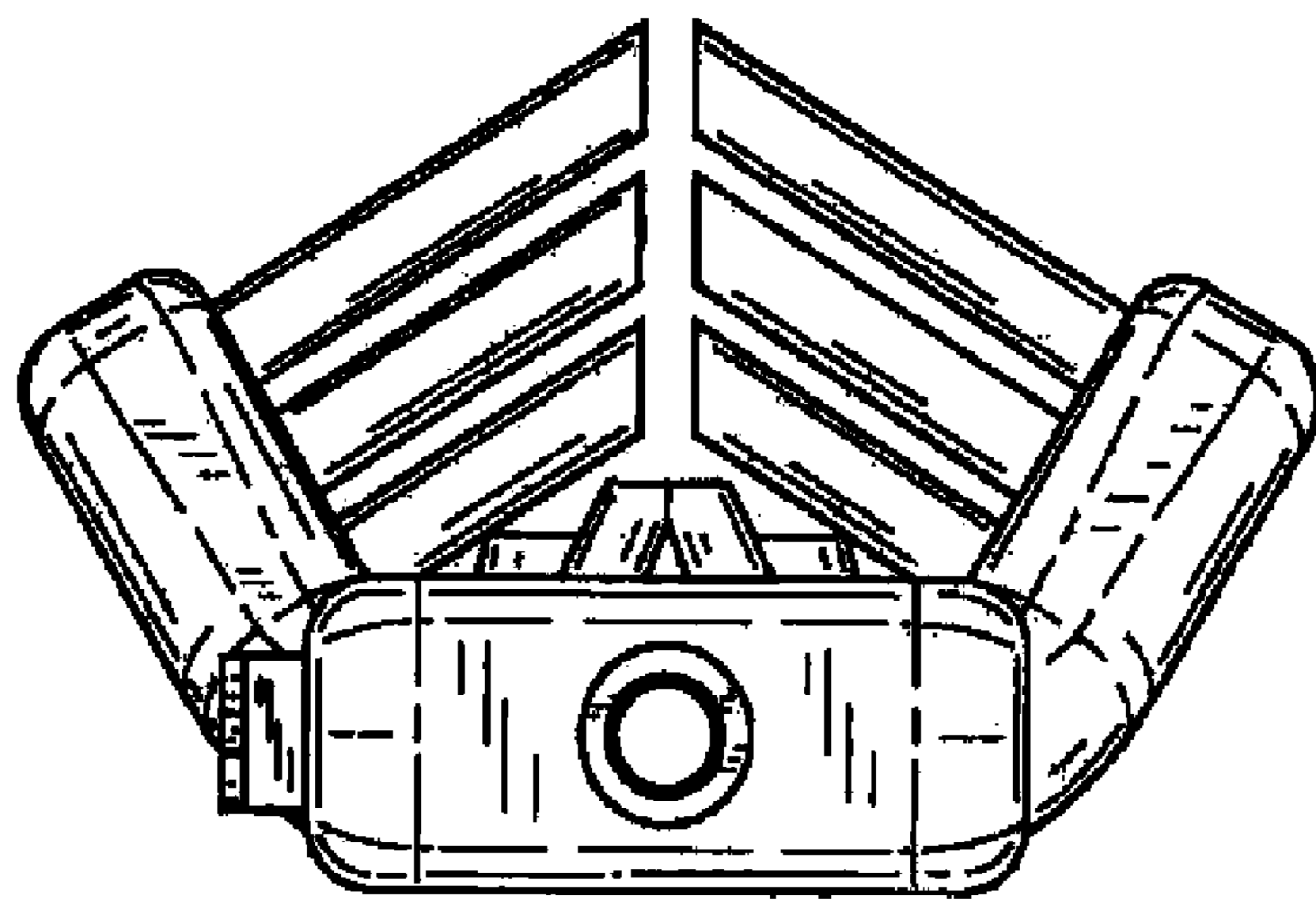

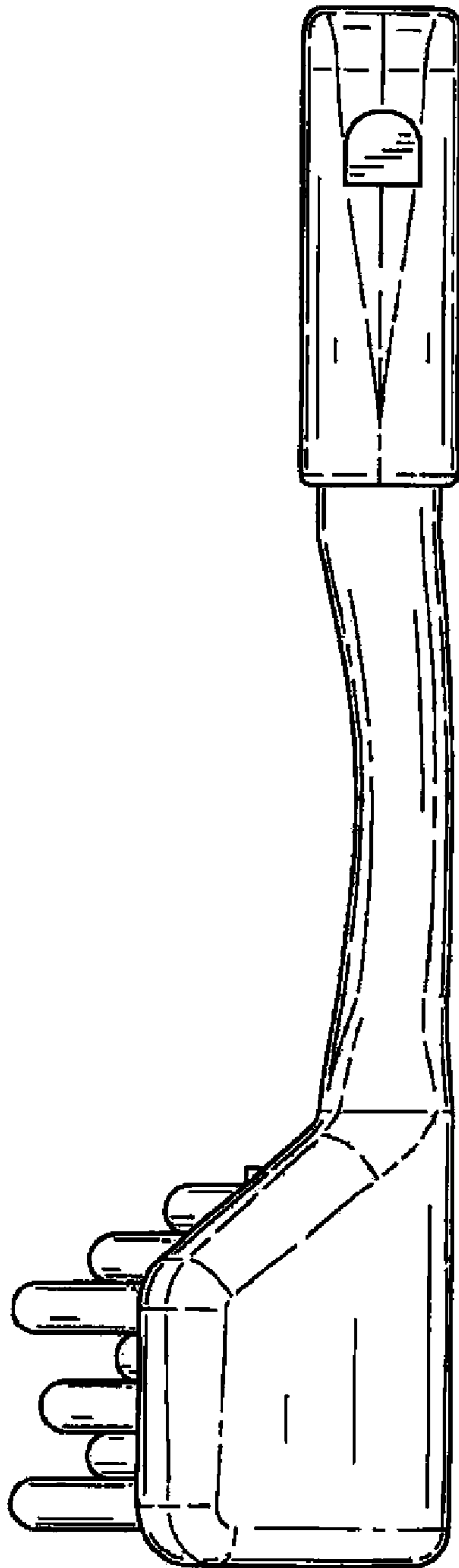

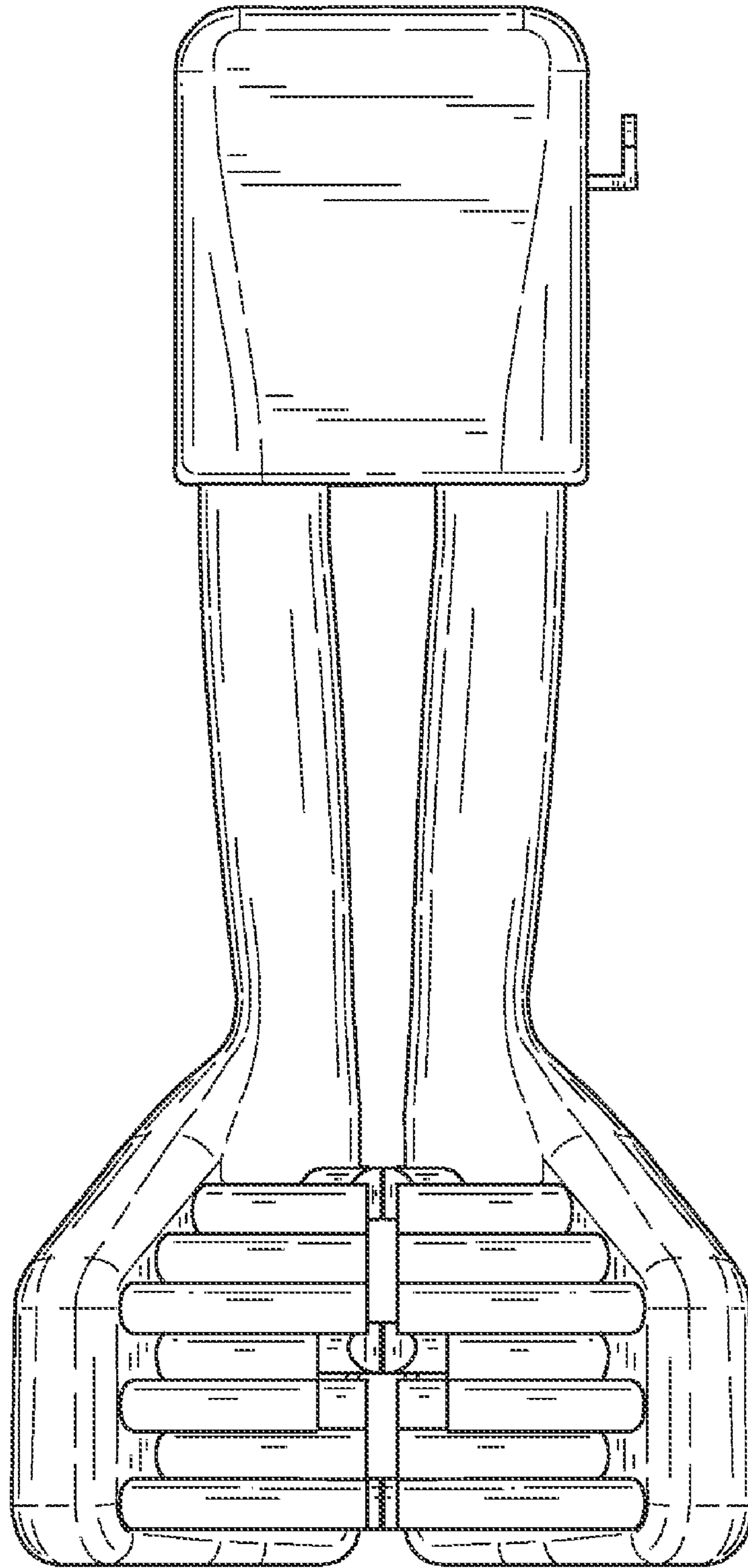

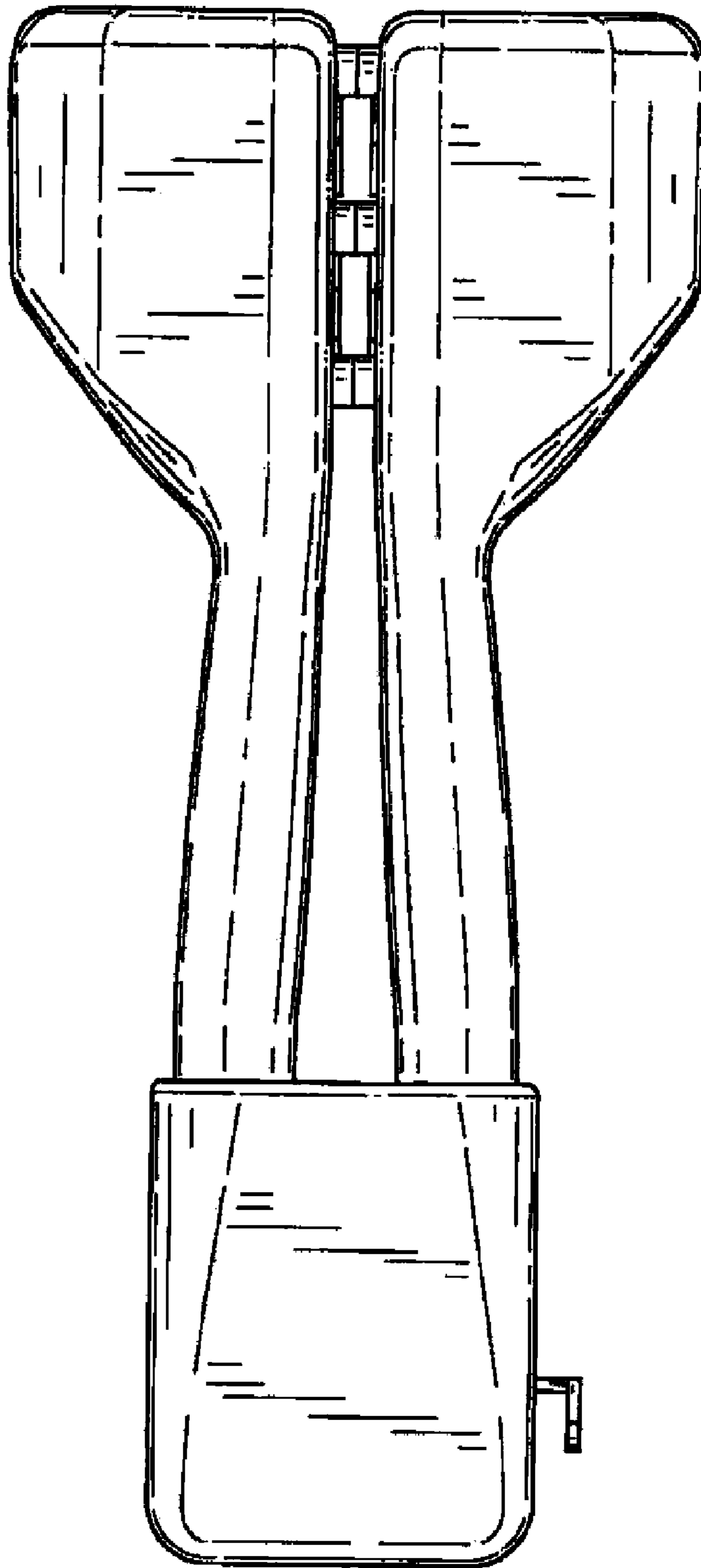
