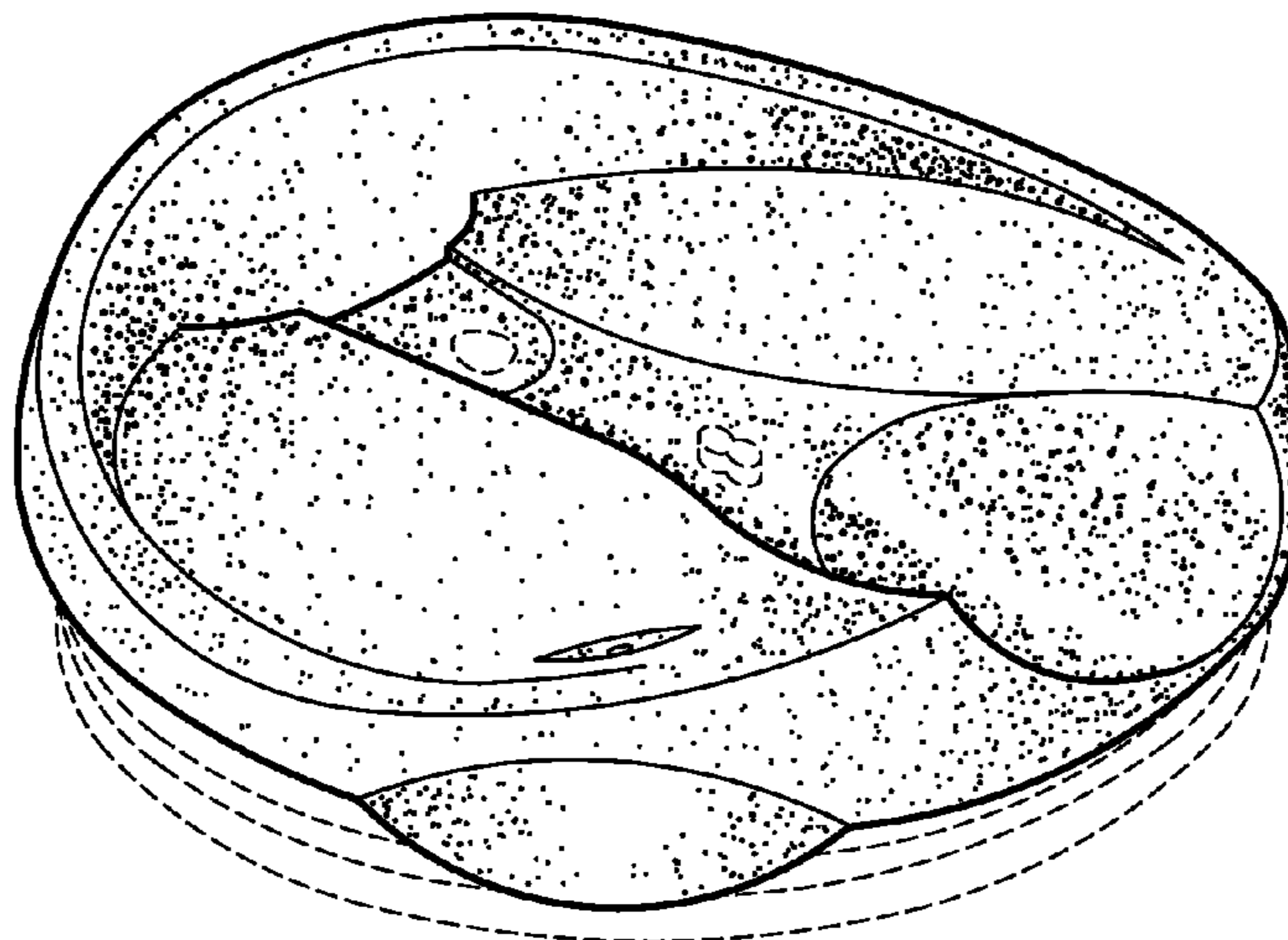
The ornamental design of a mug lid, as shown and described.

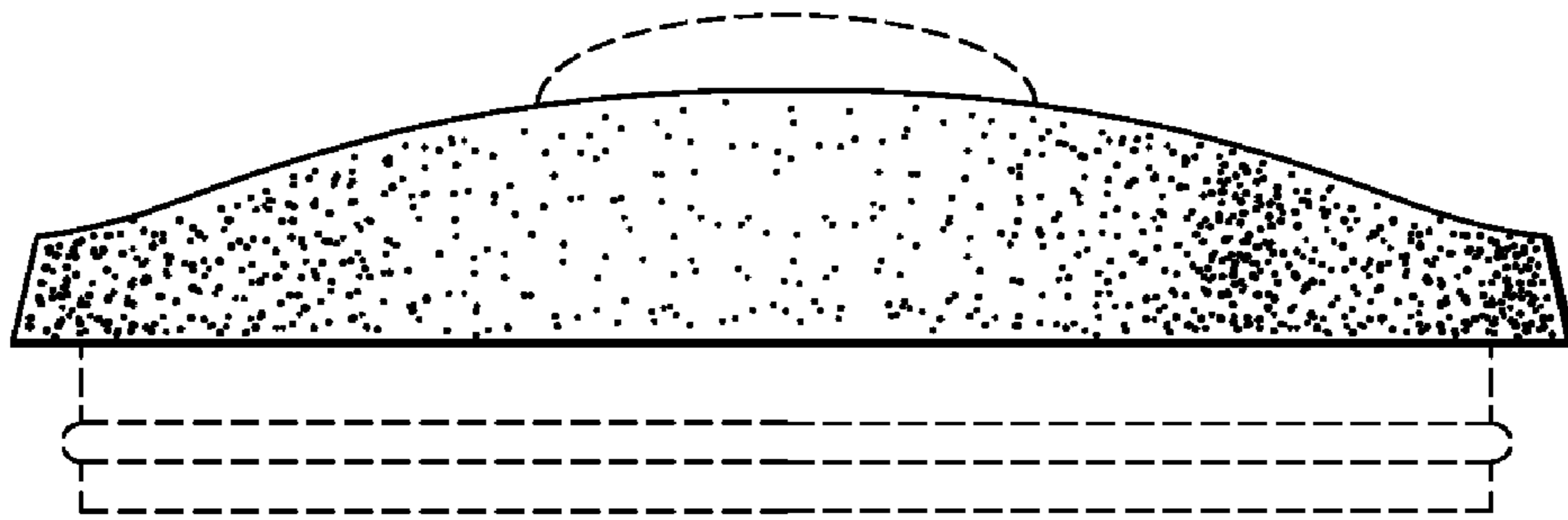

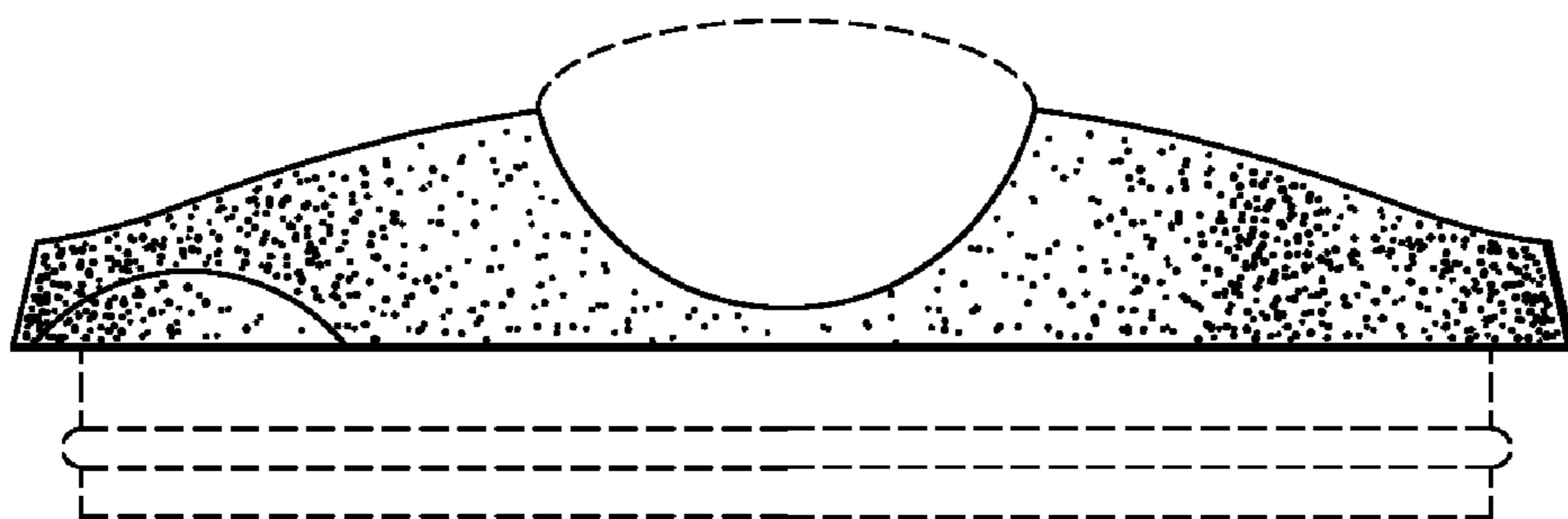

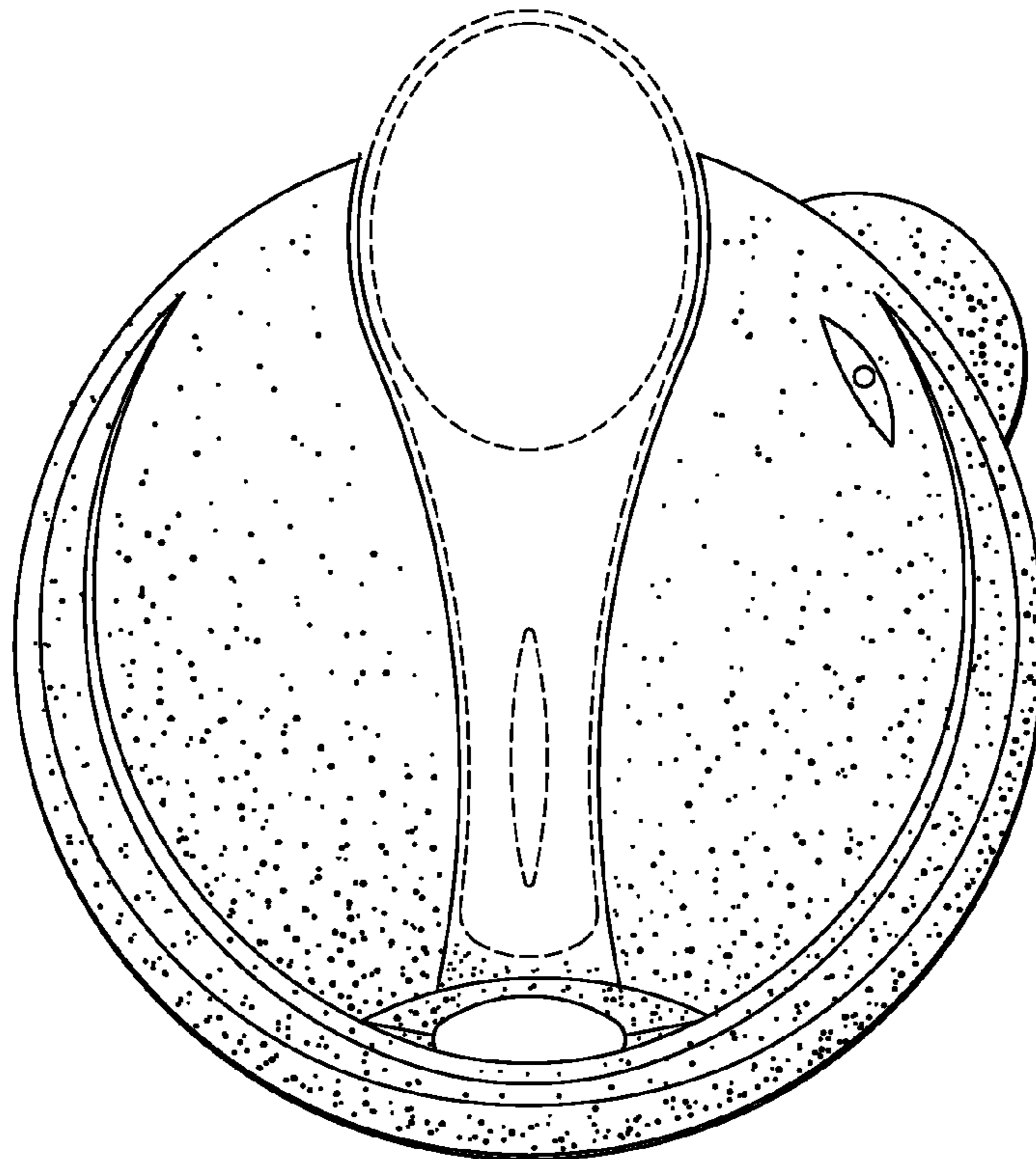

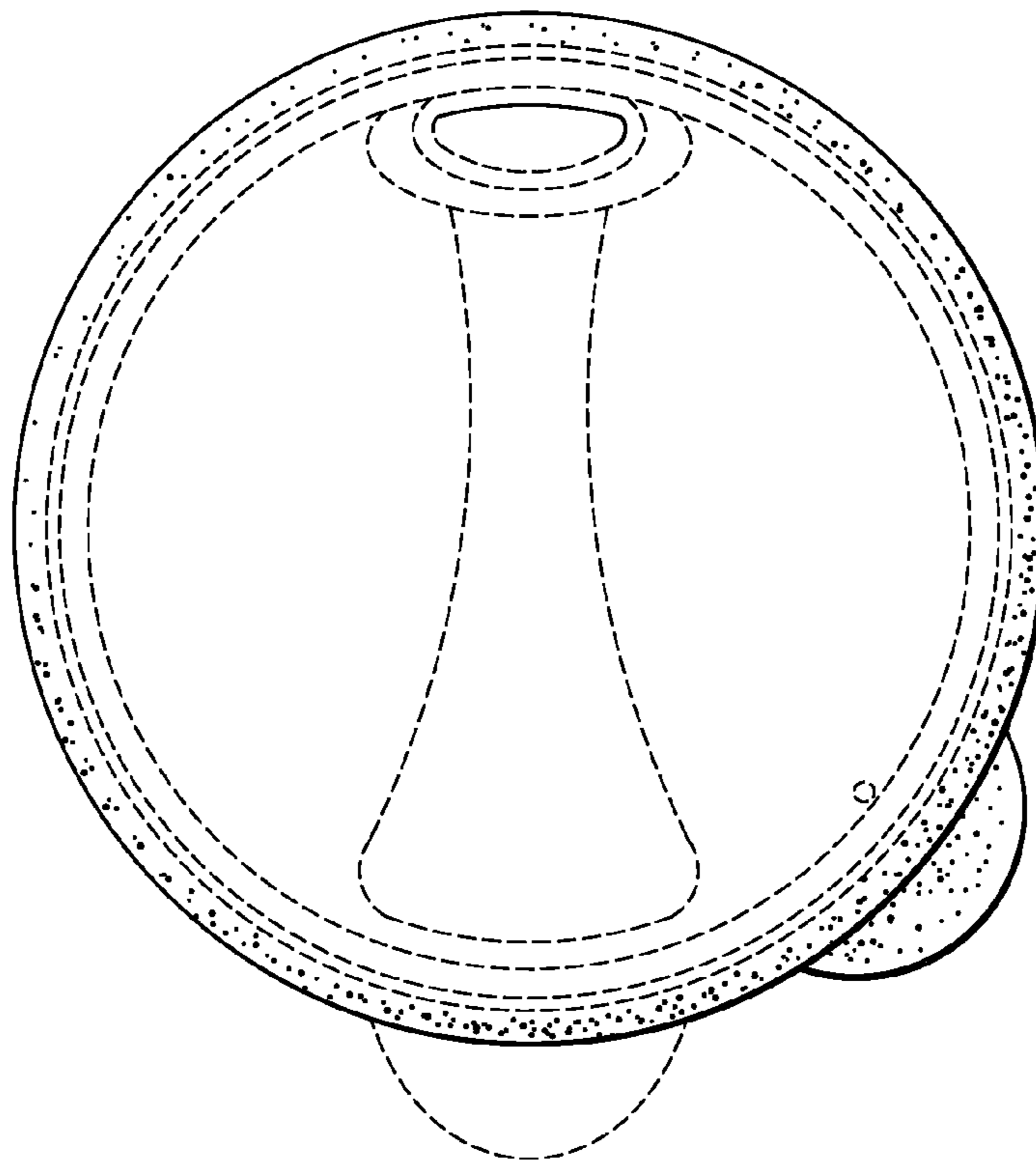

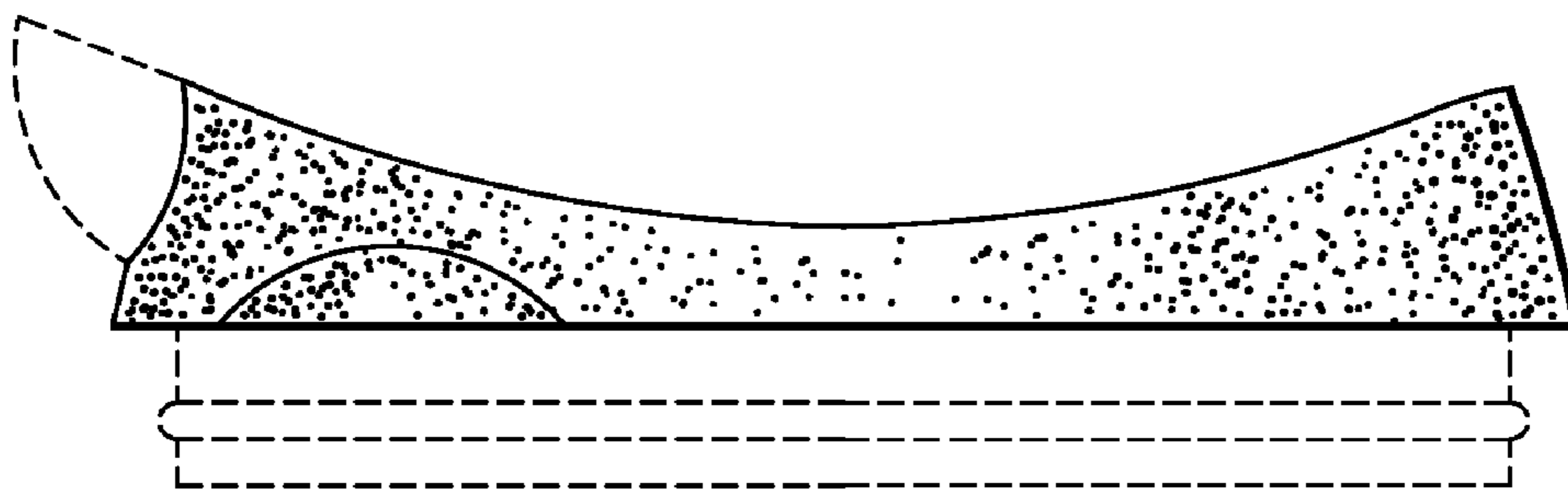

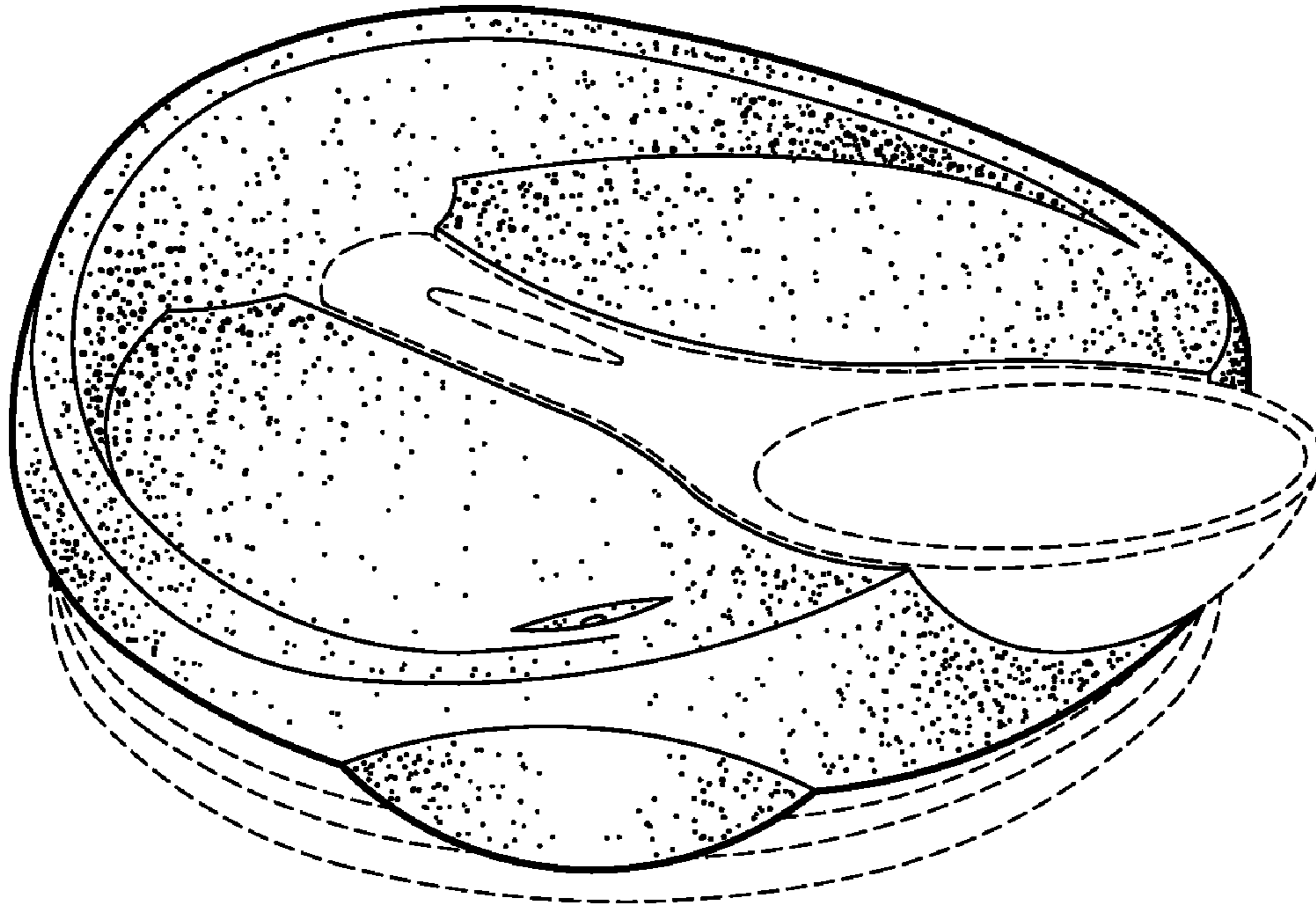

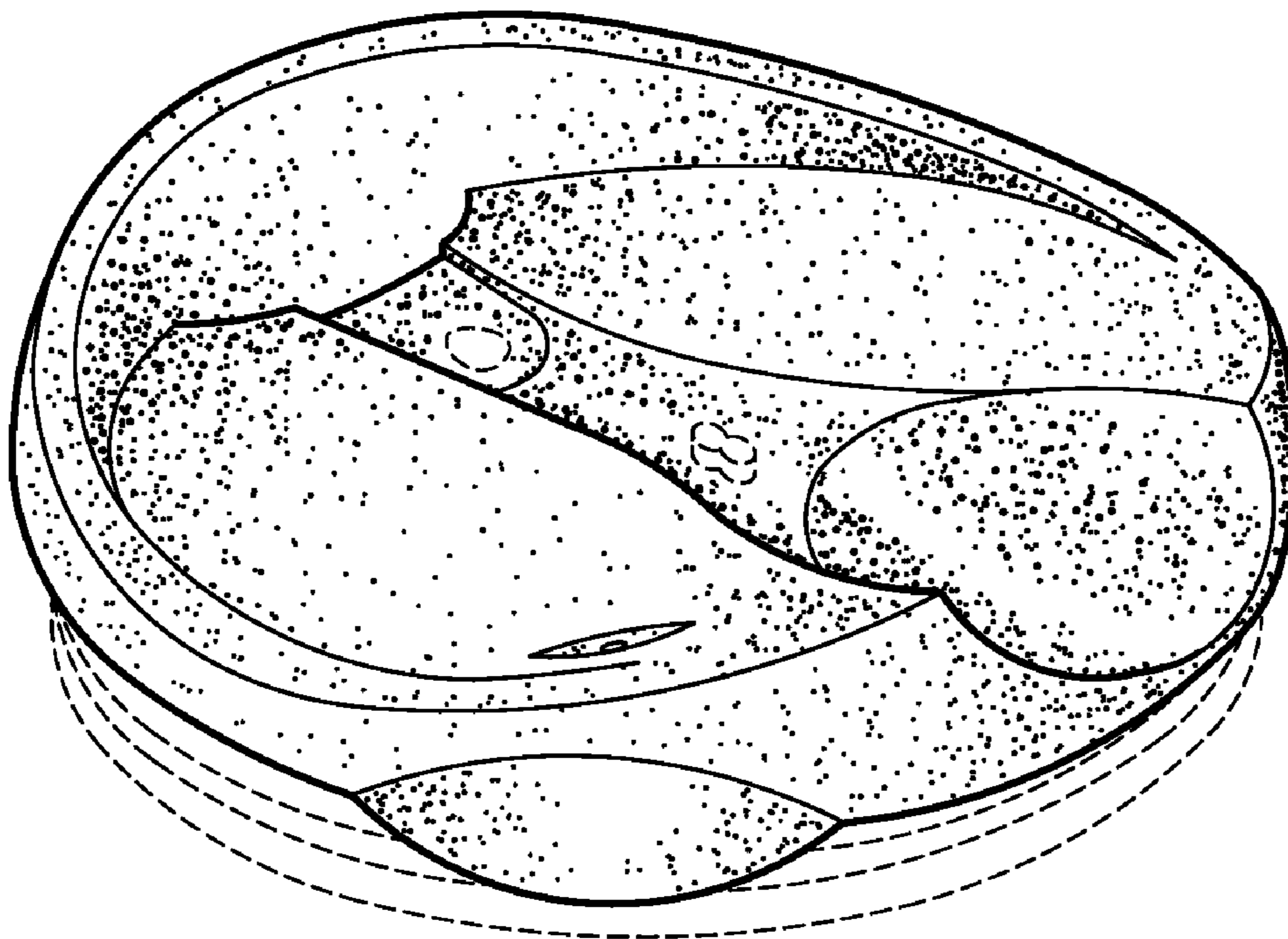
