age loop in accordance with the present invention;

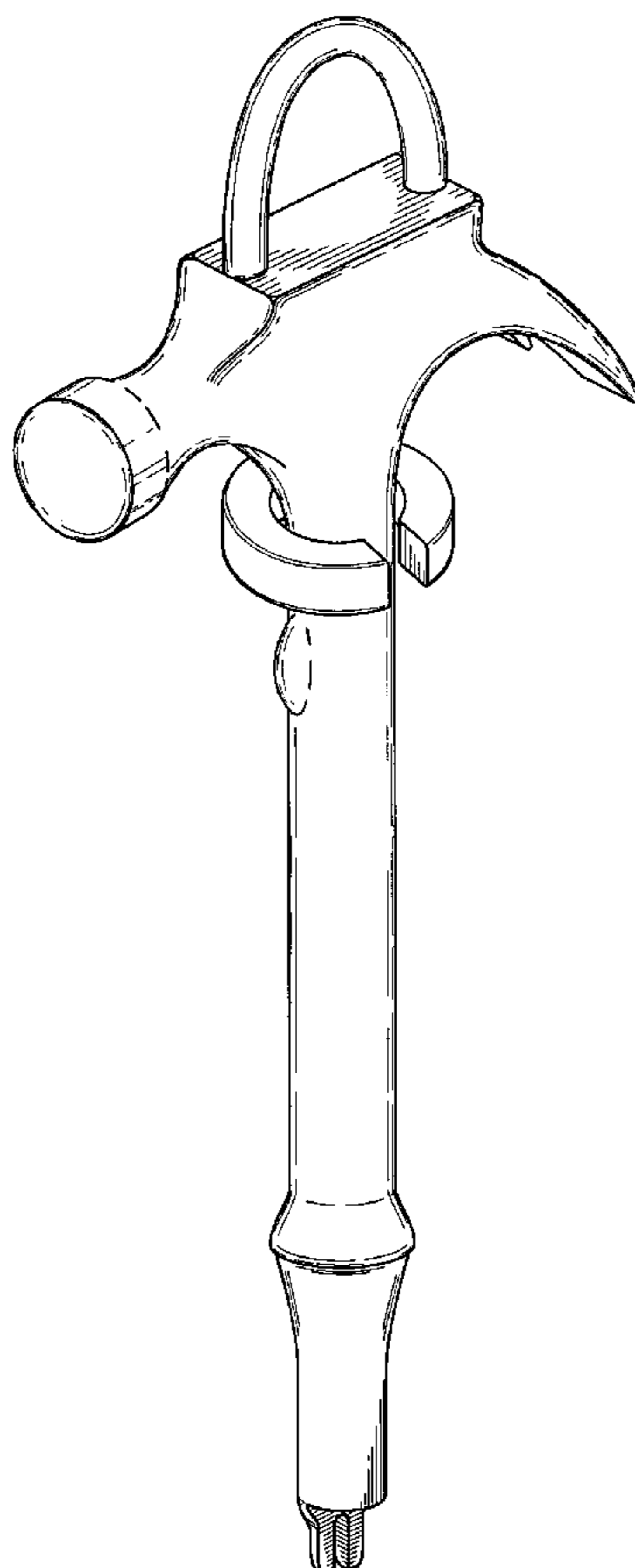
FIG. 2 illustrates a right side elevation view of the hammer

loop; and,

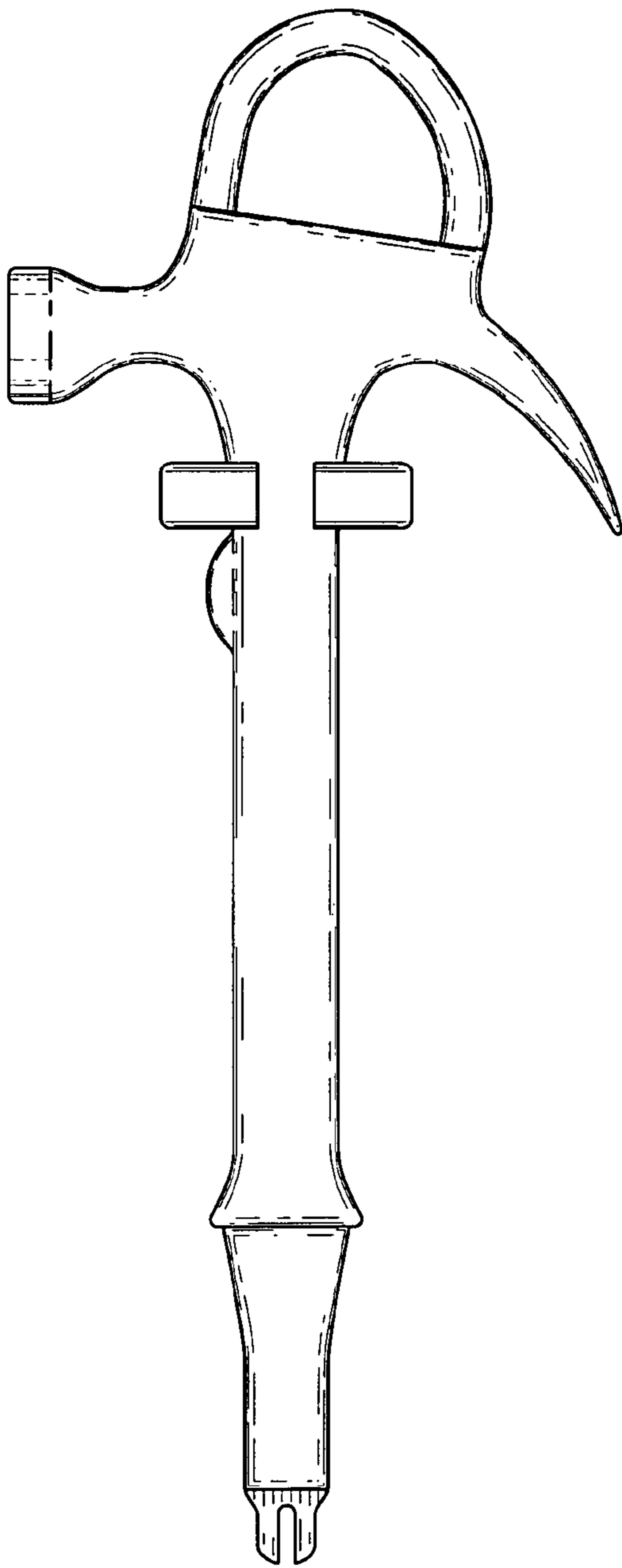
FIG. 5 illustrates a bottom plan view of the hammer with

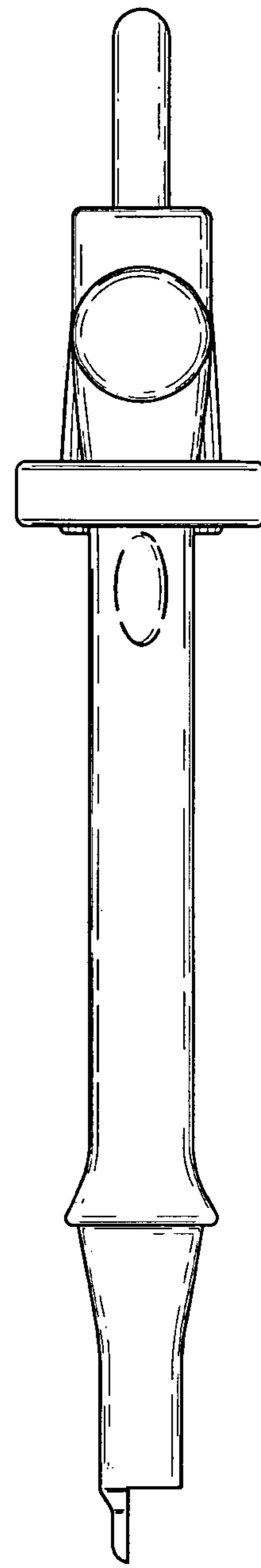




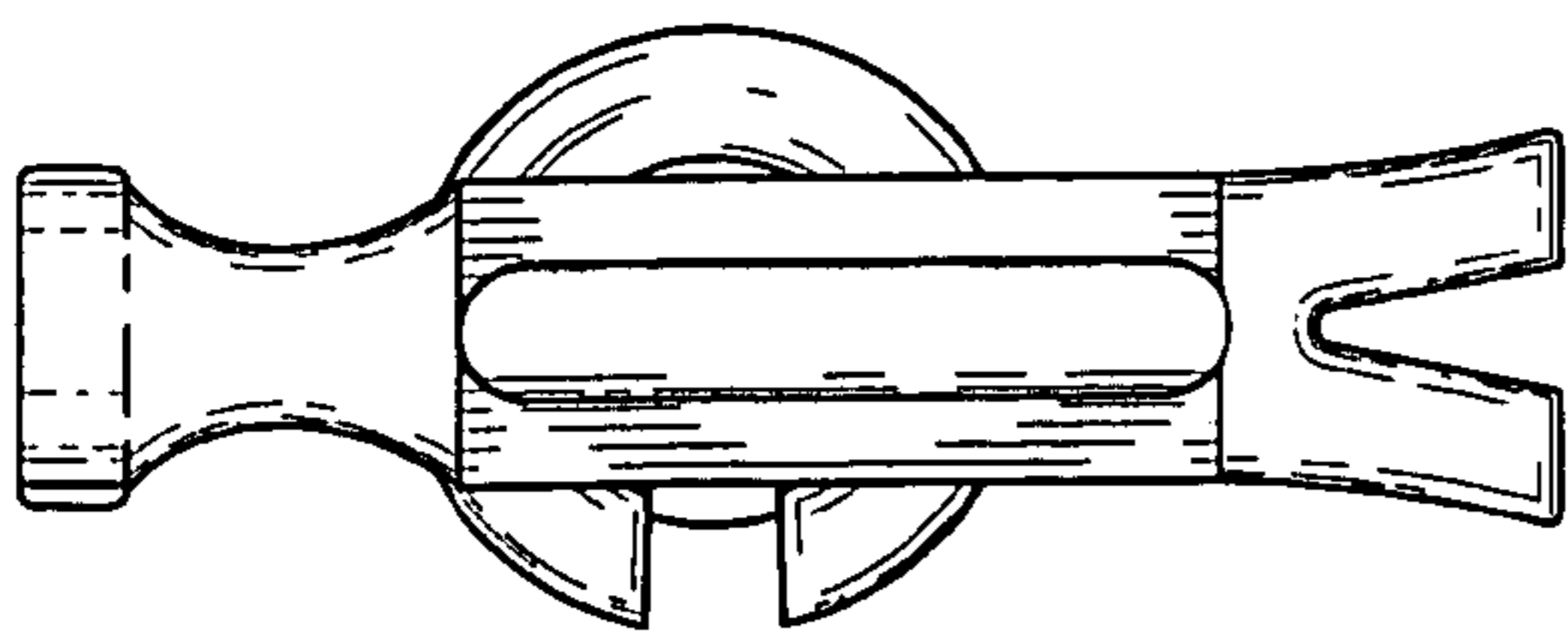

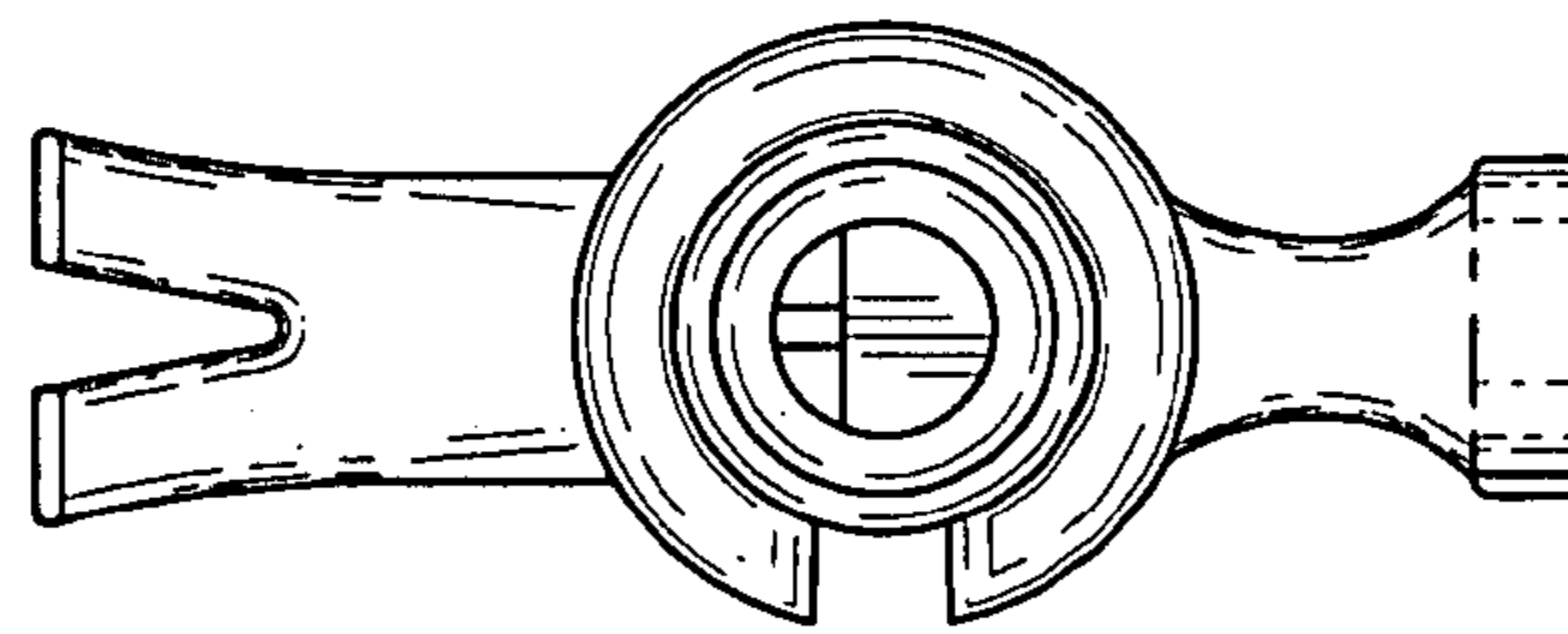
