(57) **CLAIM**

The ornamental design for a tamper-resistant food container package, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a tamper-resistant food container package showing our new design, as seen in an open condition.

FIG. 2 is an enlarged isometric view of the design depicted in FIG. 1, as seen in a closed condition;

FIG. 3 is a top view thereof;

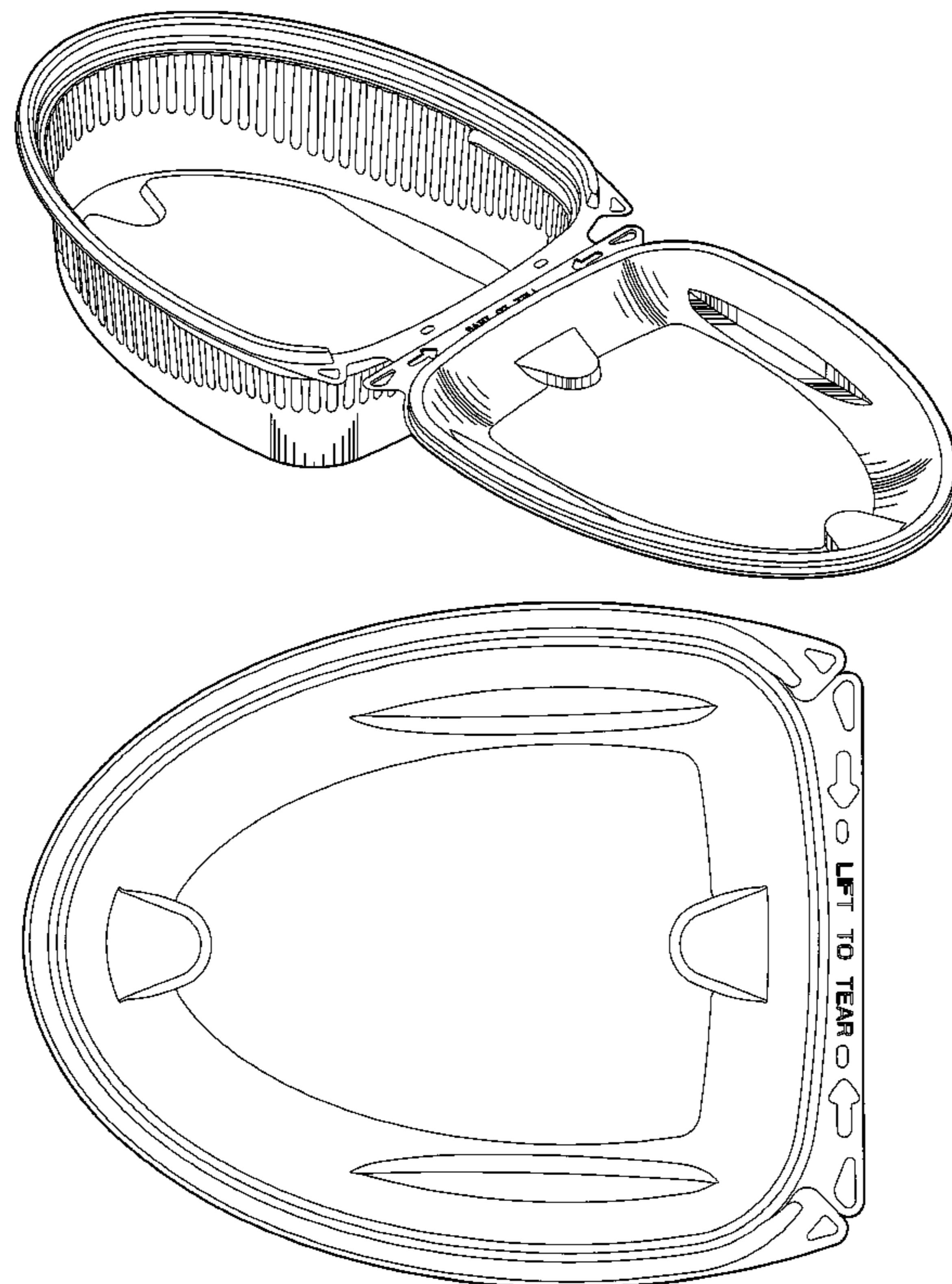
FIG. 4 is a bottom view thereof;

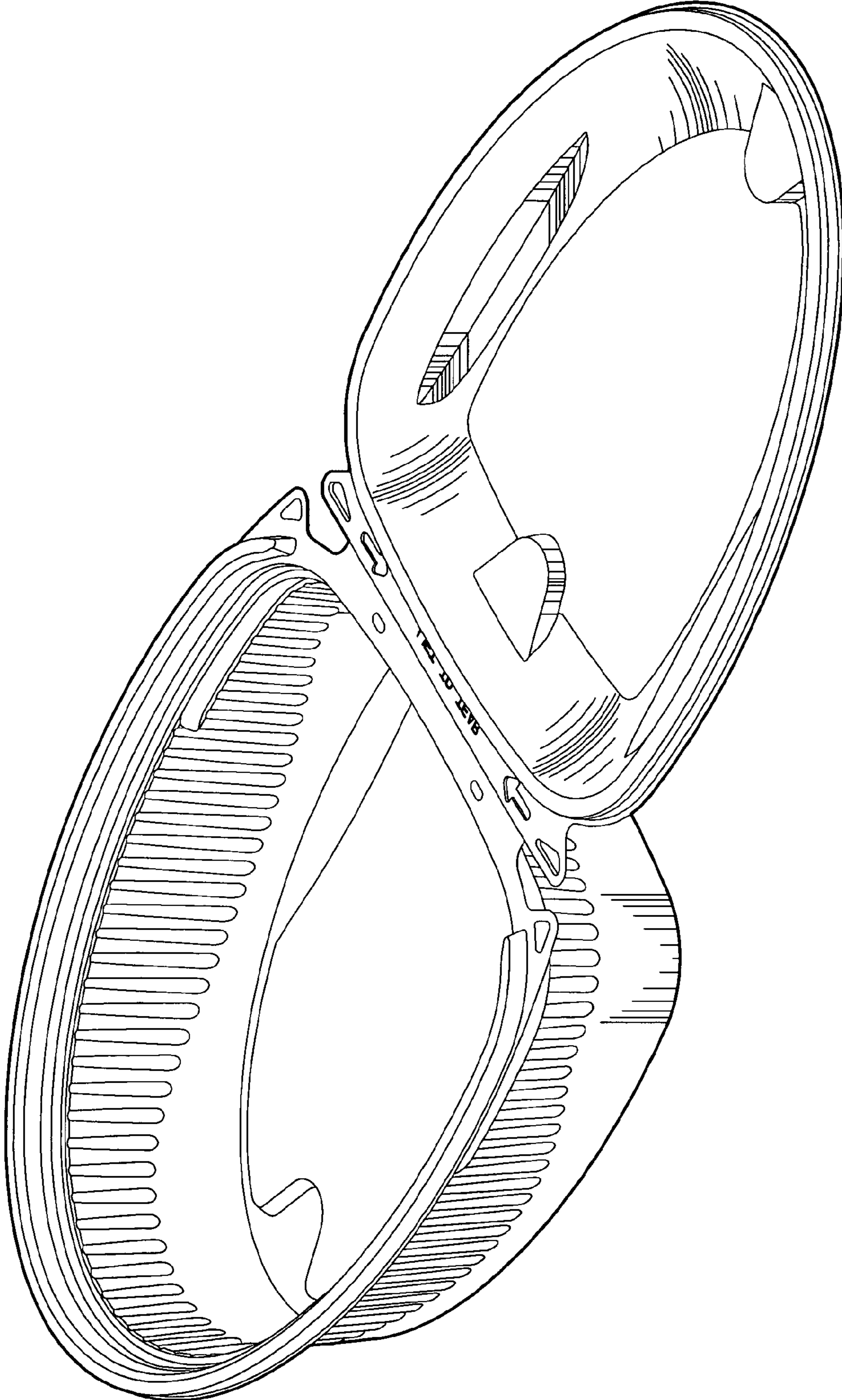

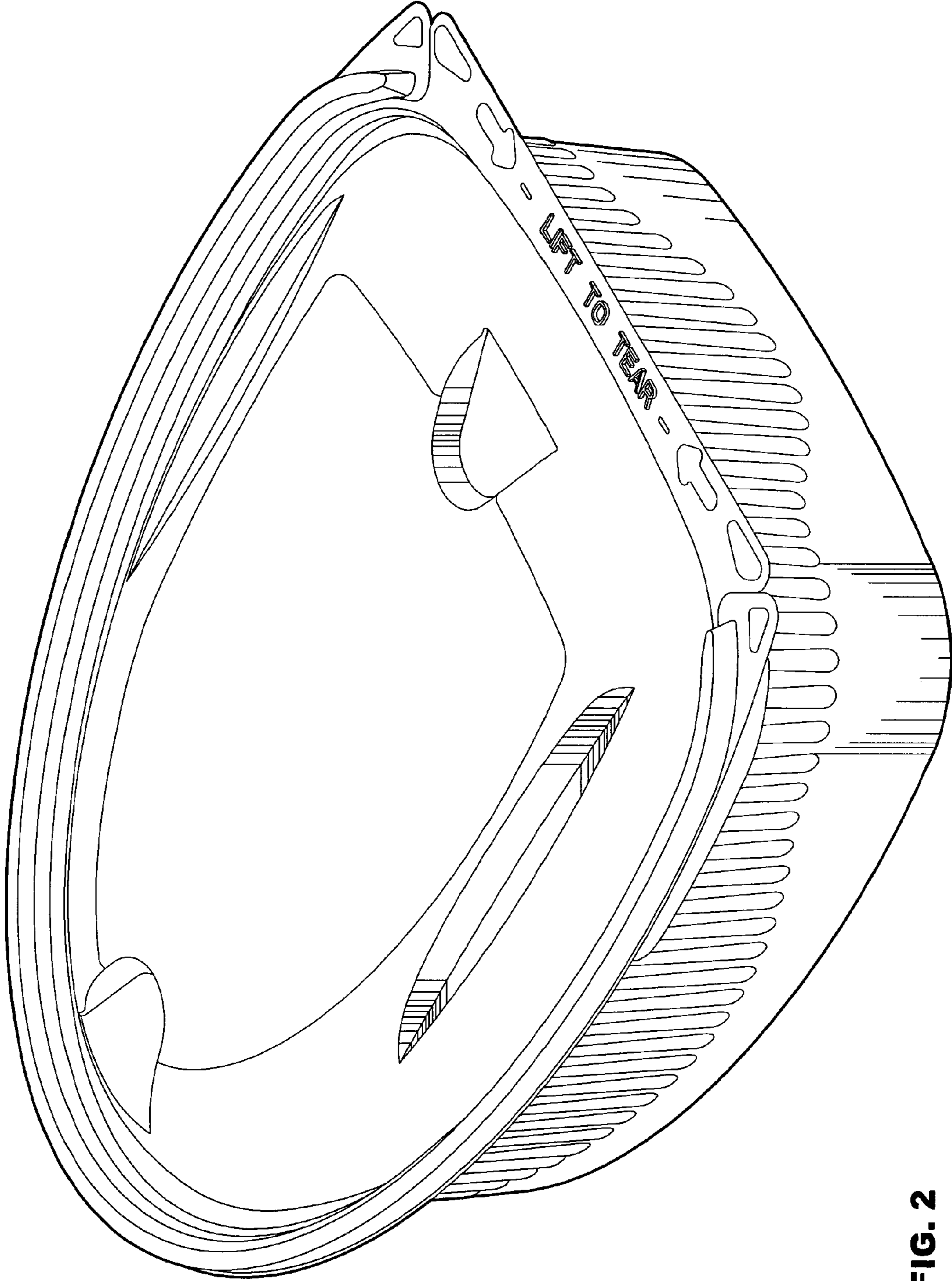

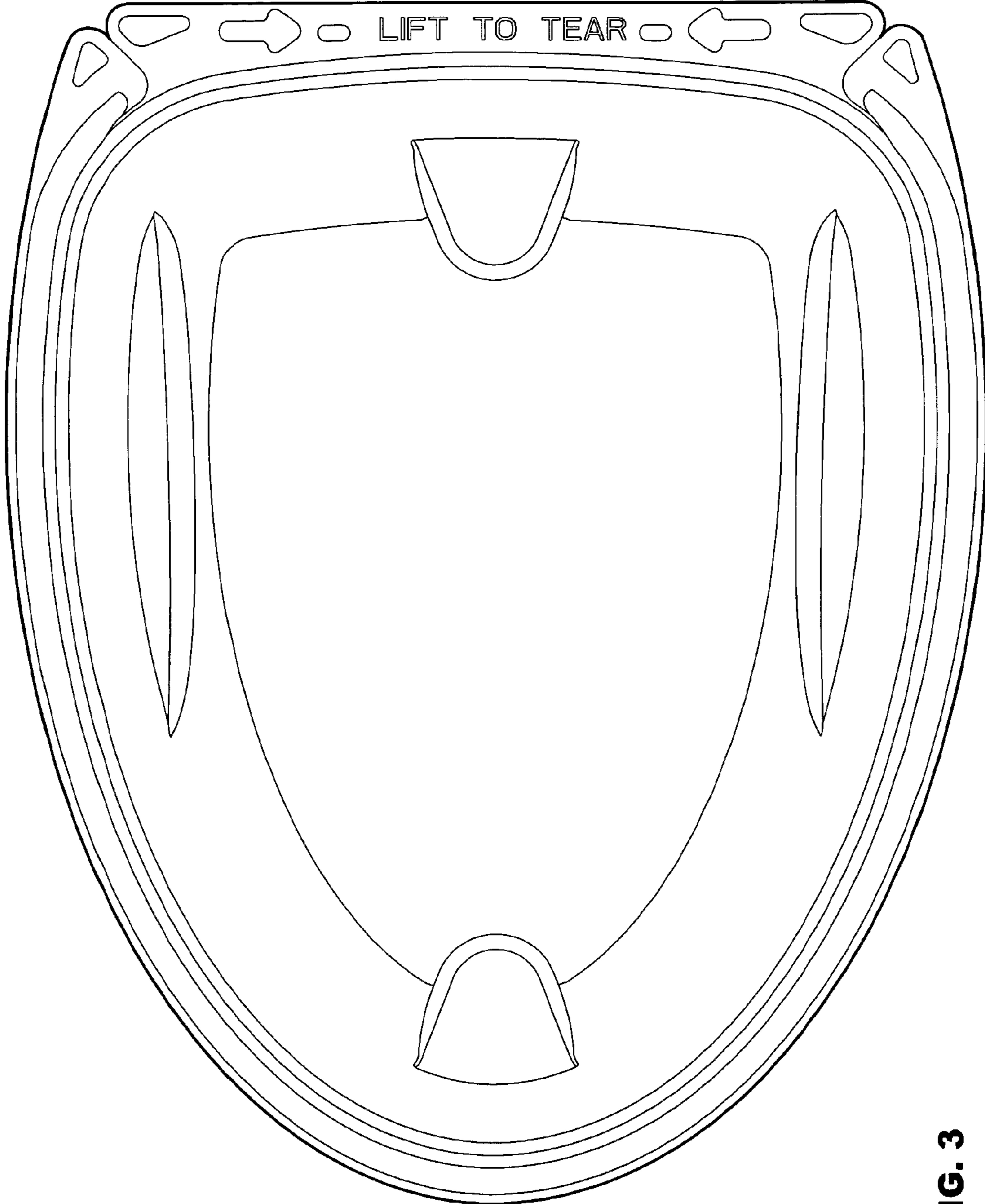

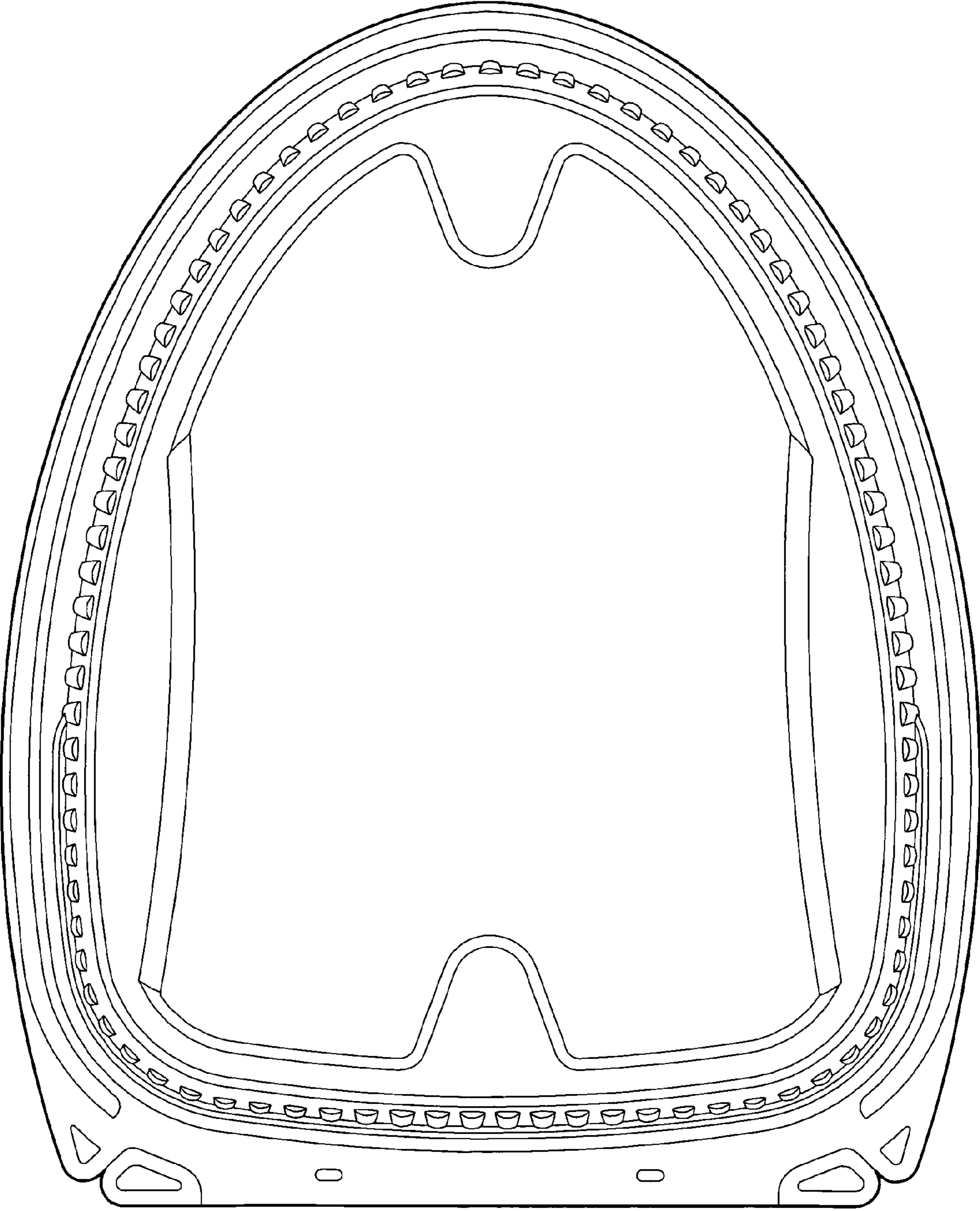

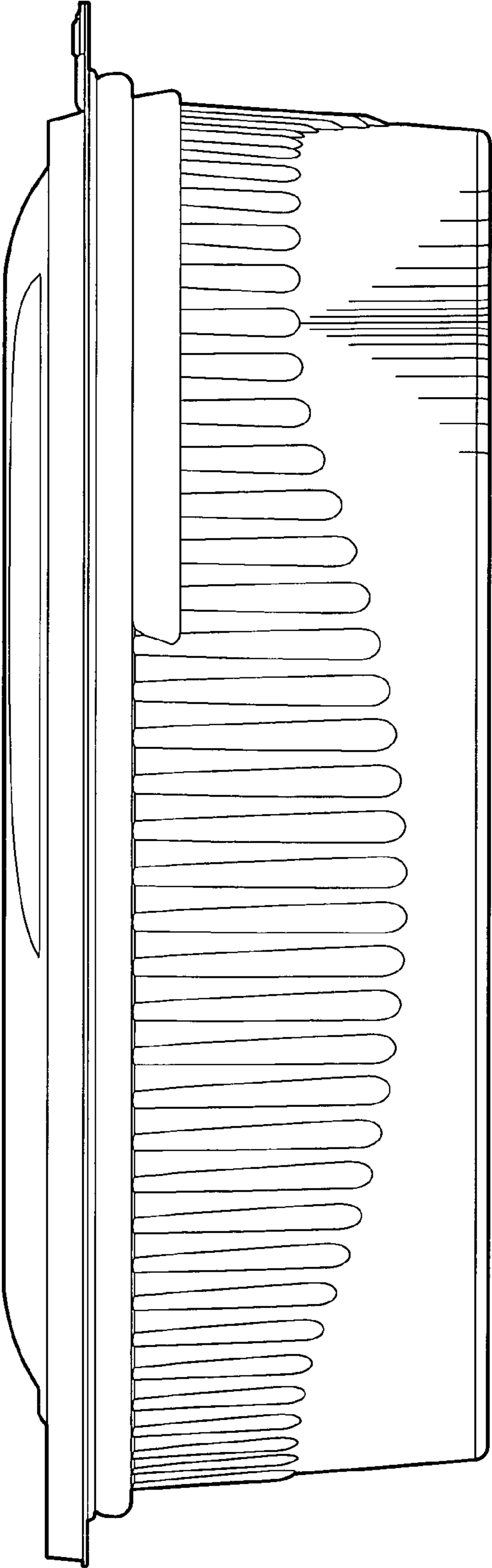

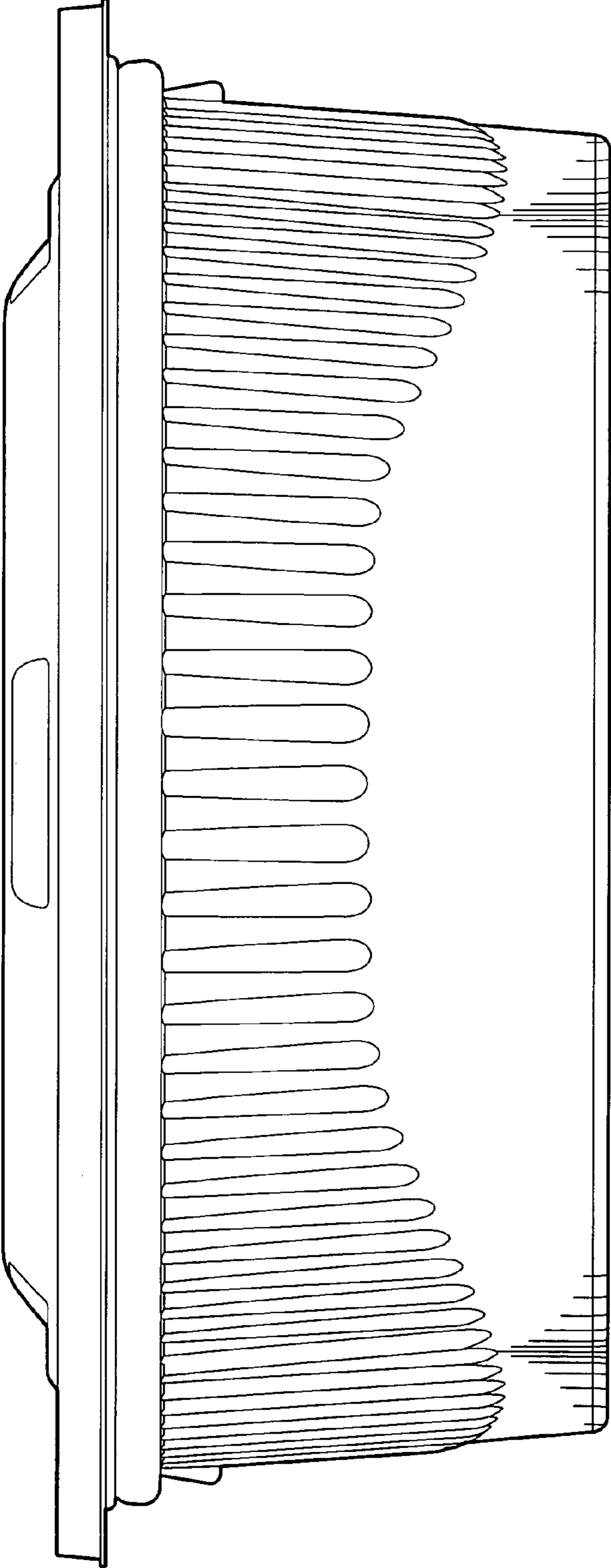

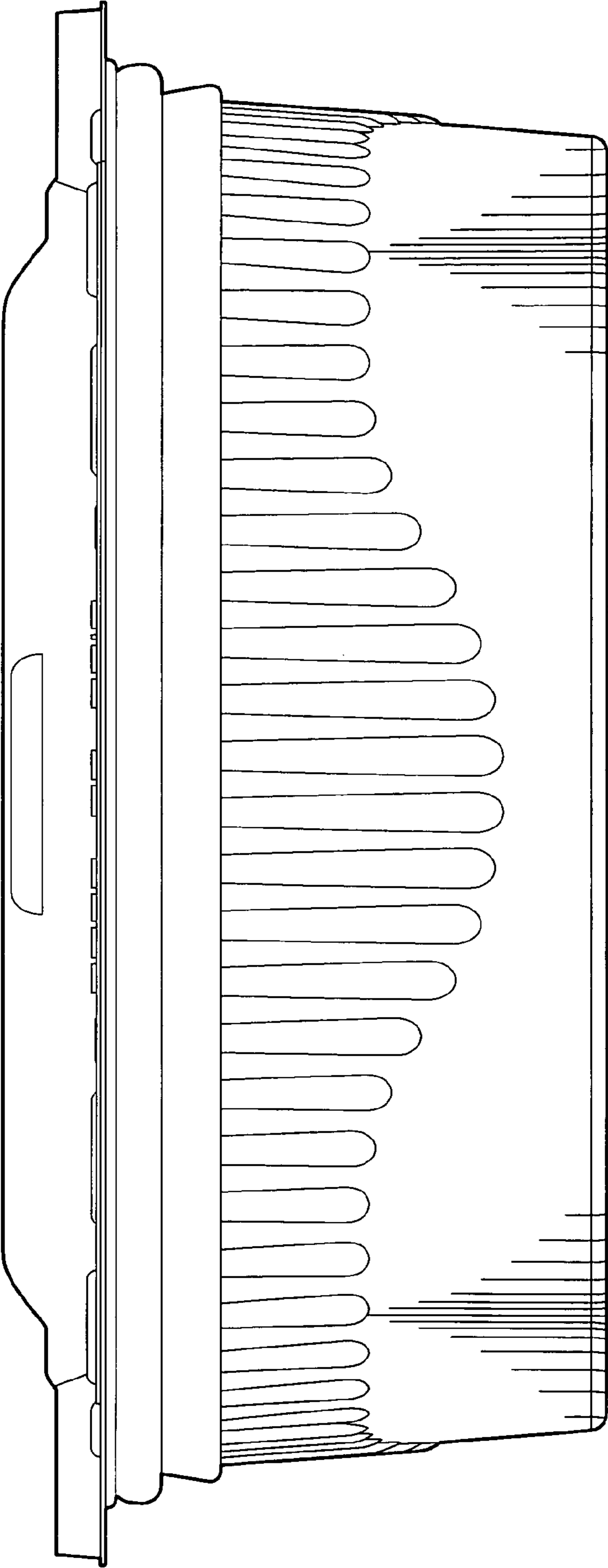
