(57) **CLAIM**

We claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a bottle in accordance with our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof; and,

FIG. 6 is a top plan view thereof.

The portions of the bottle shown in broken lines in FIGS. 1-6 illustrate portions of the design which form no part of the claim.

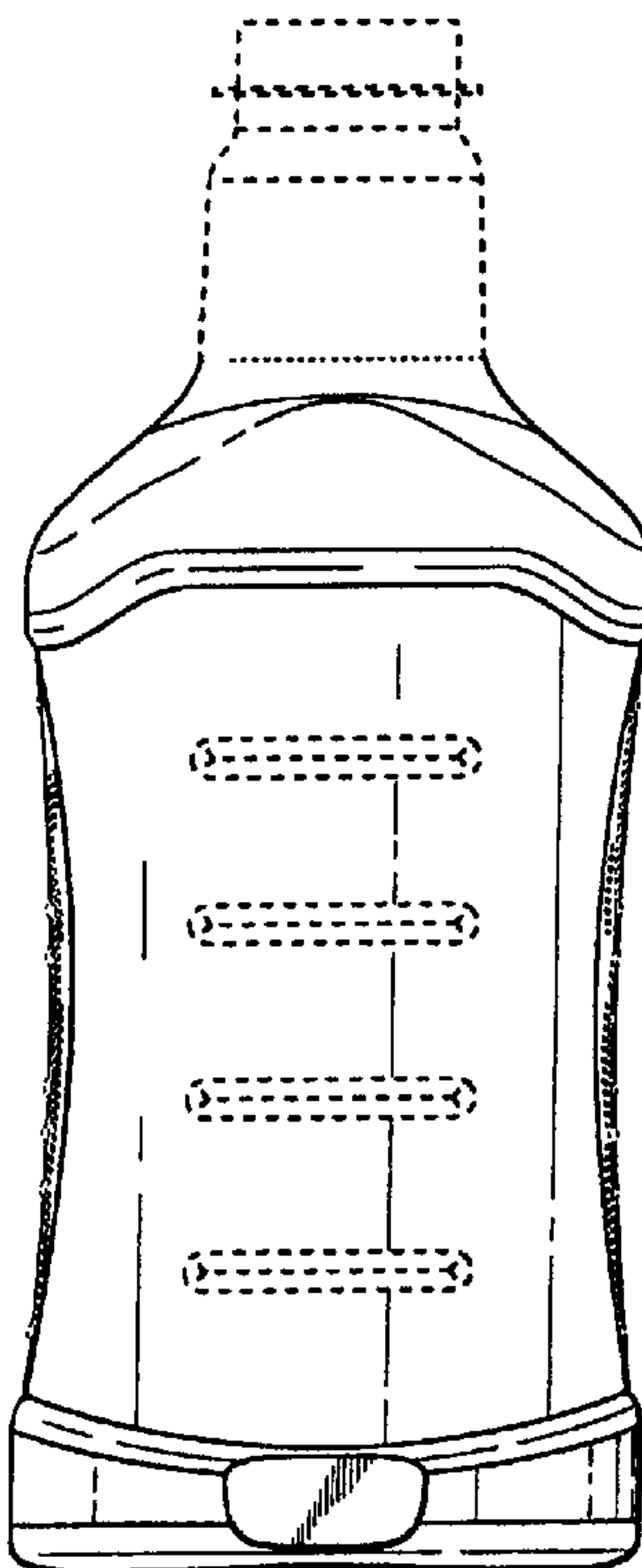

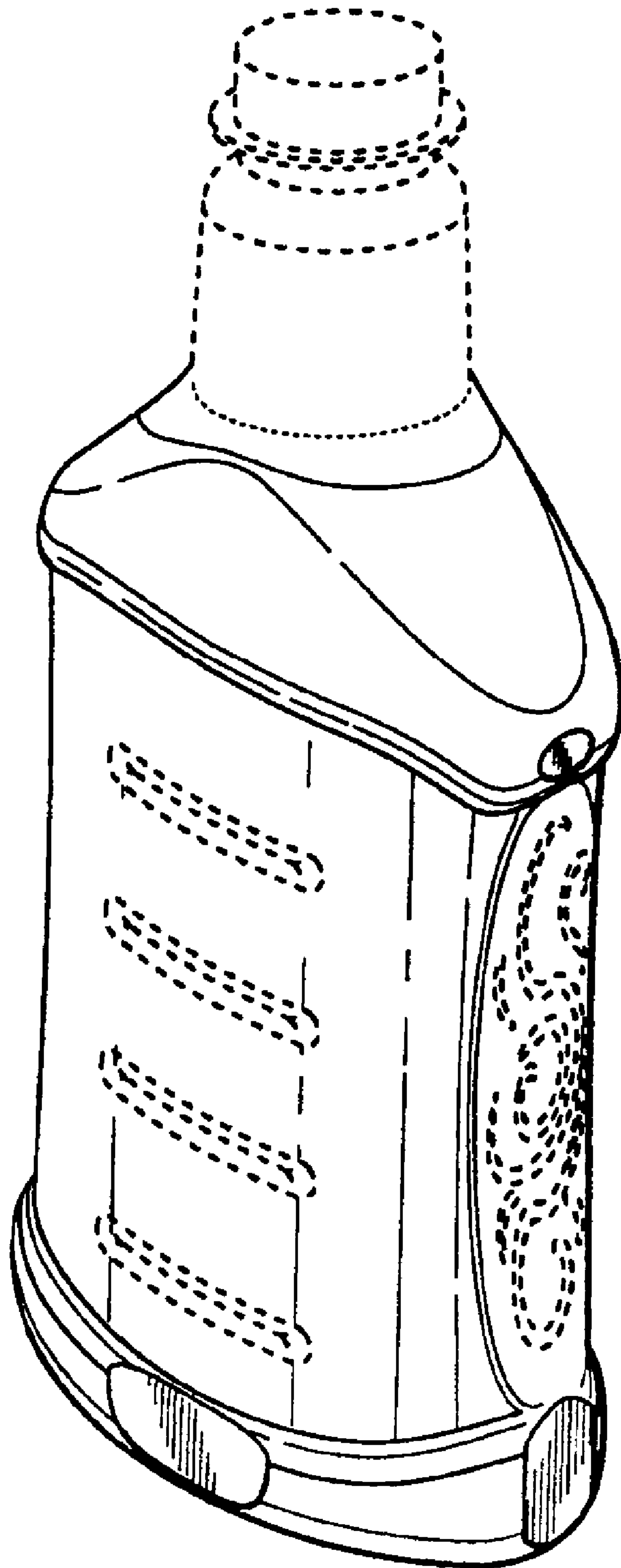

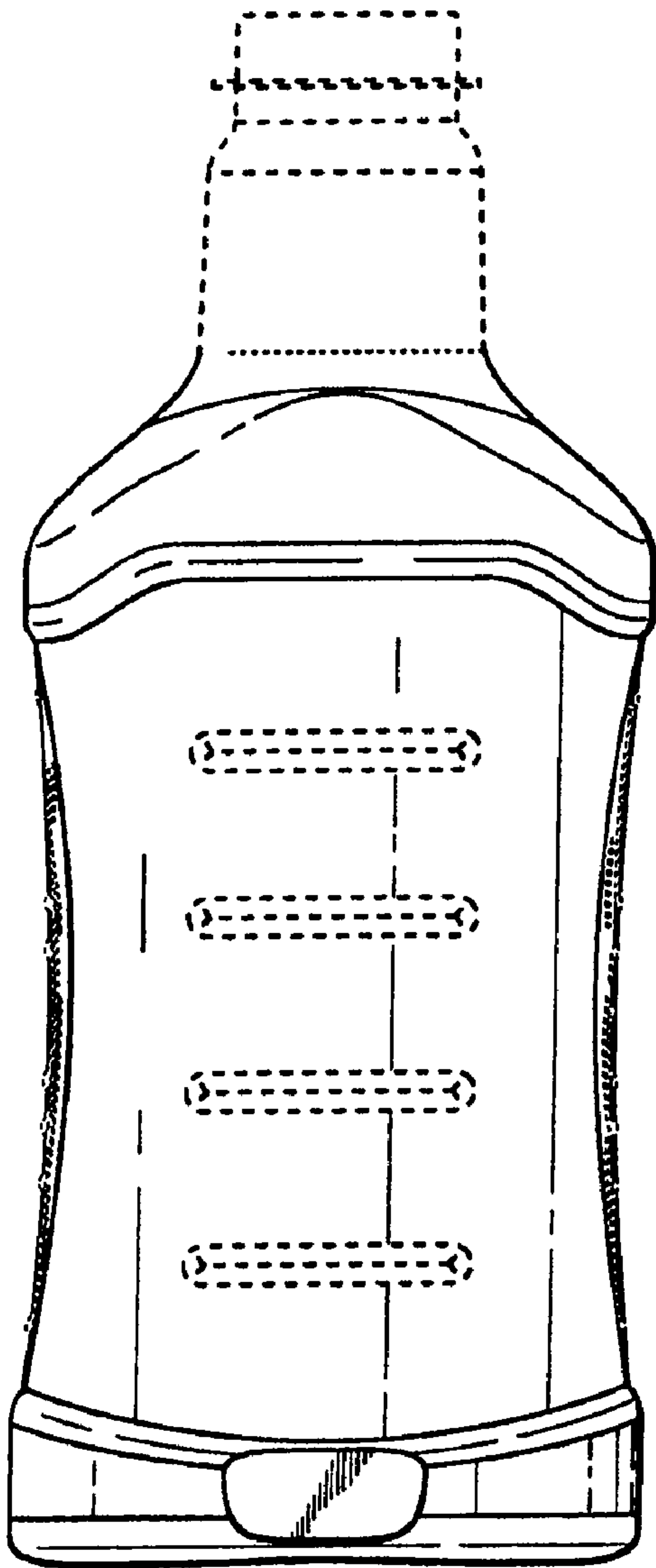

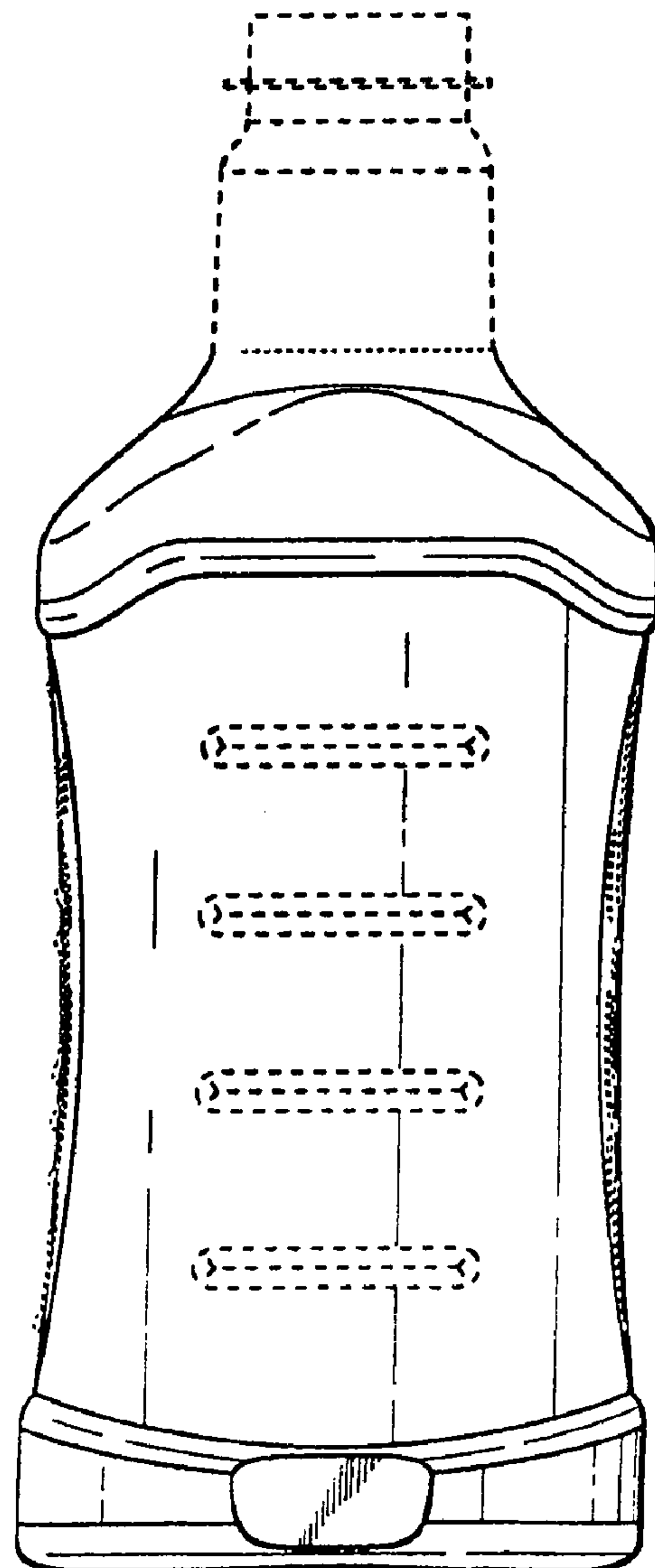

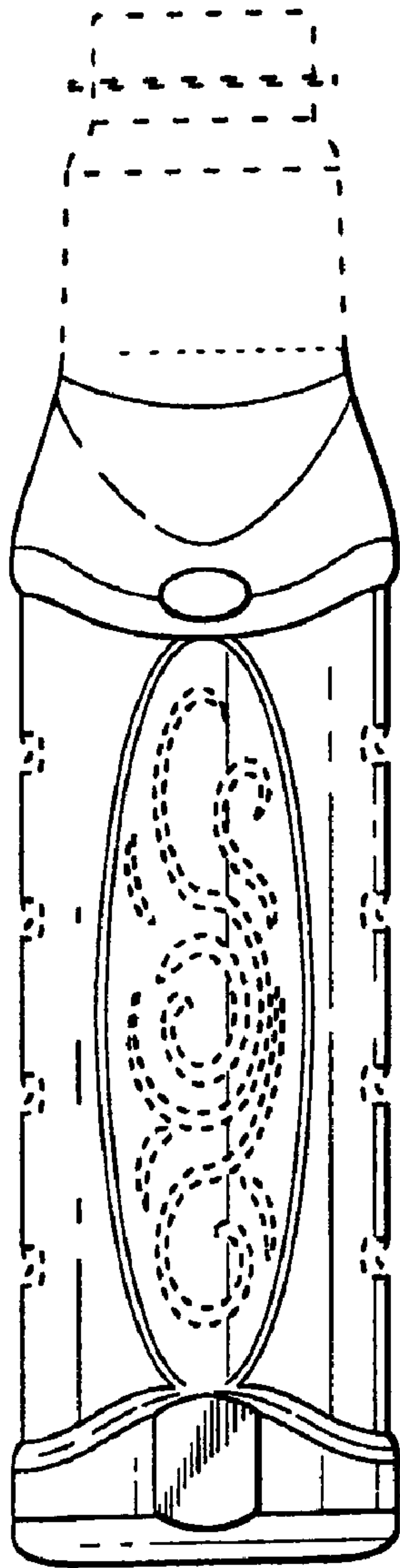

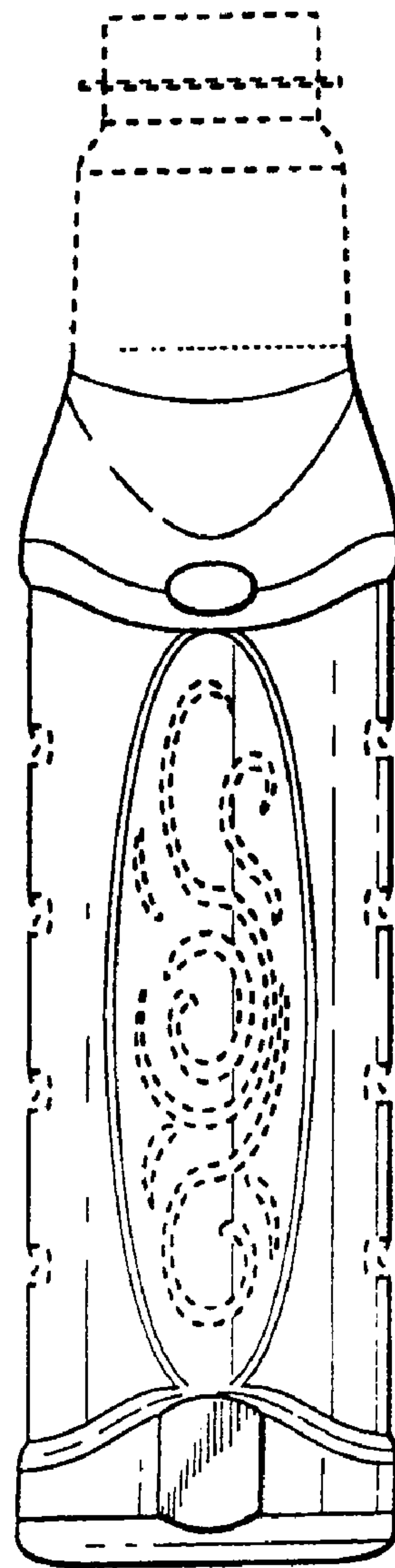
