FIG. 7 is a right side elevational view thereof.

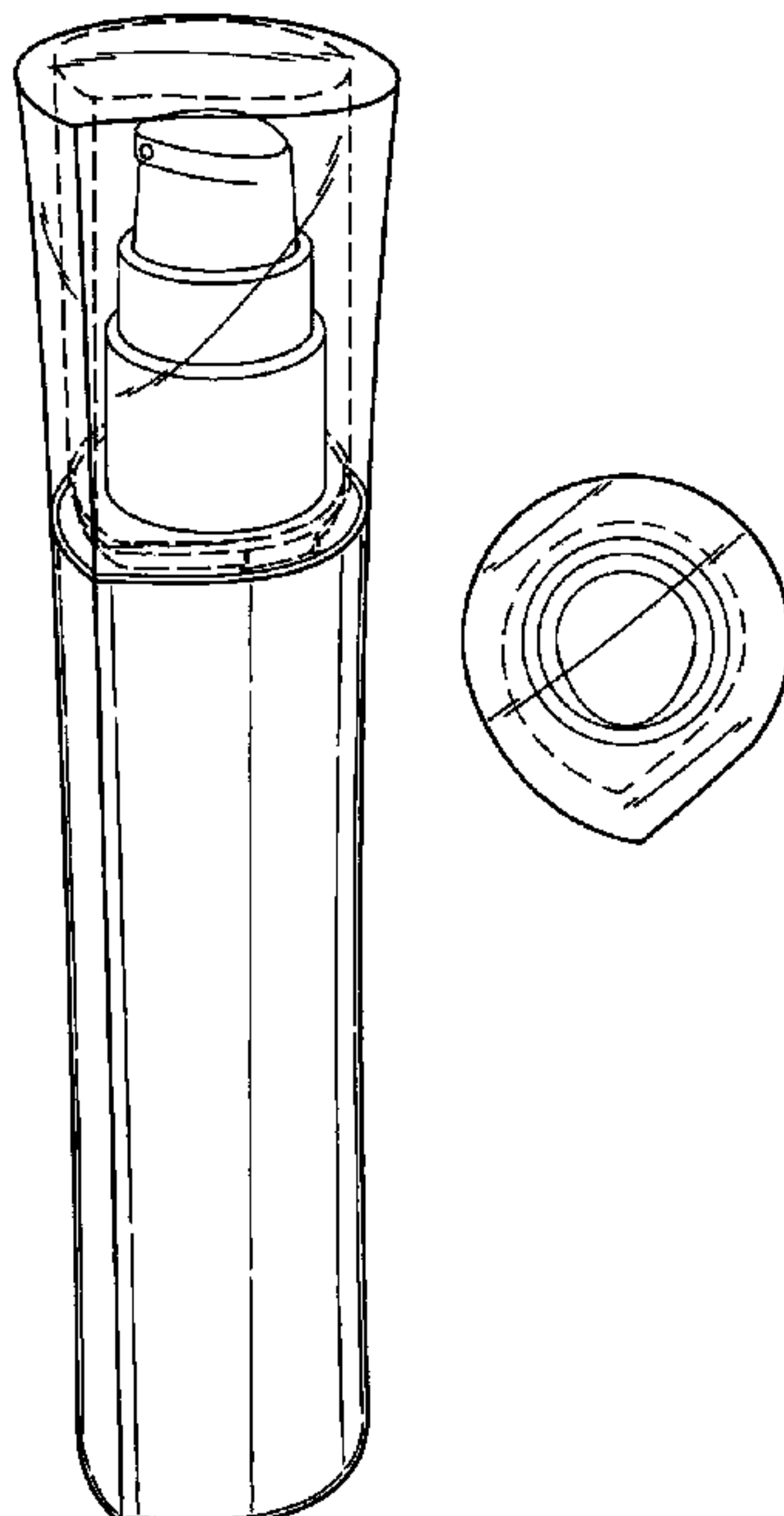
The broken lines are included for the purpose of illustrating portions of the bottle, including structures seen through the transparent over cap and on the bottom end that form no part of the claimed design.

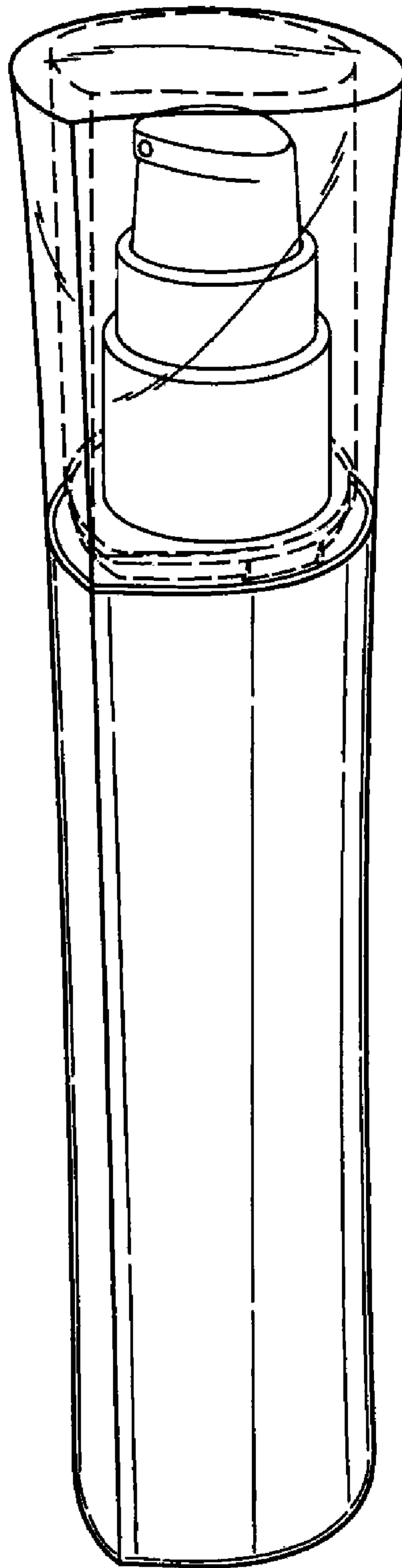

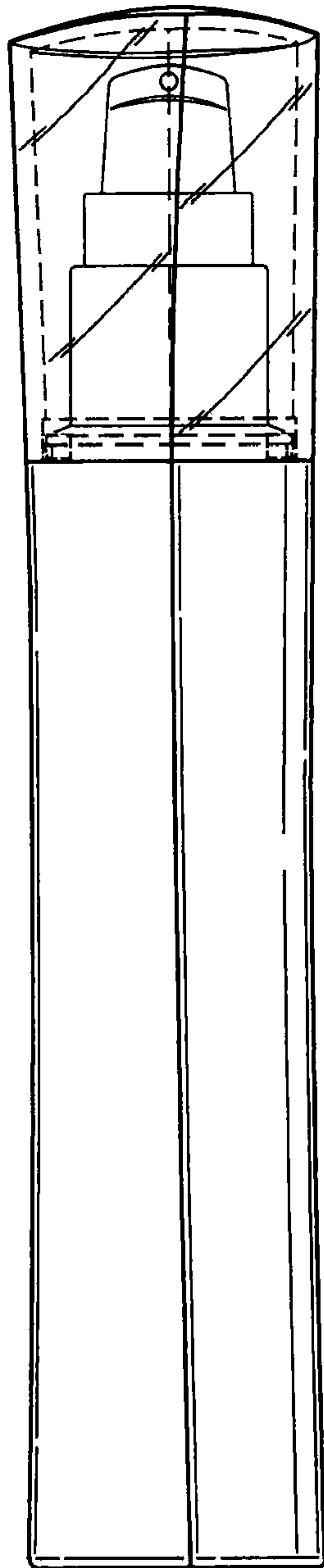

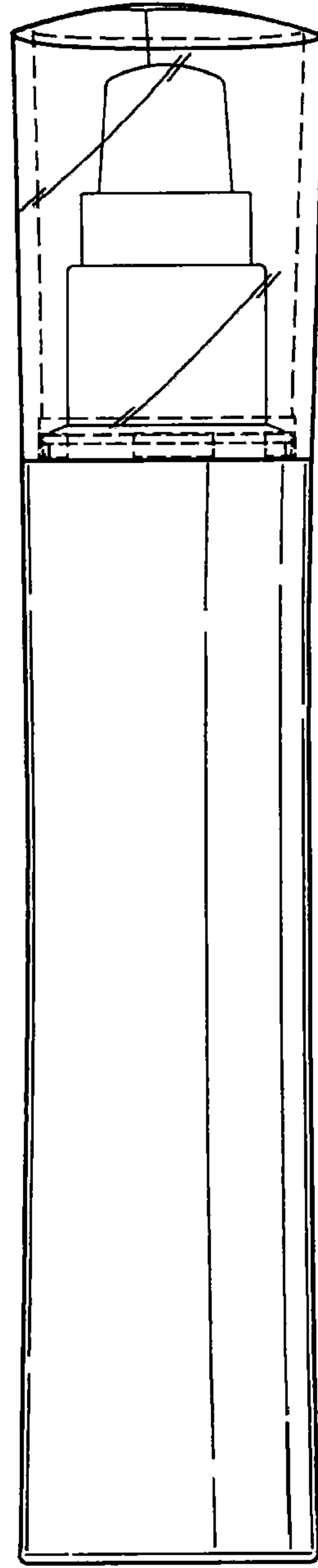

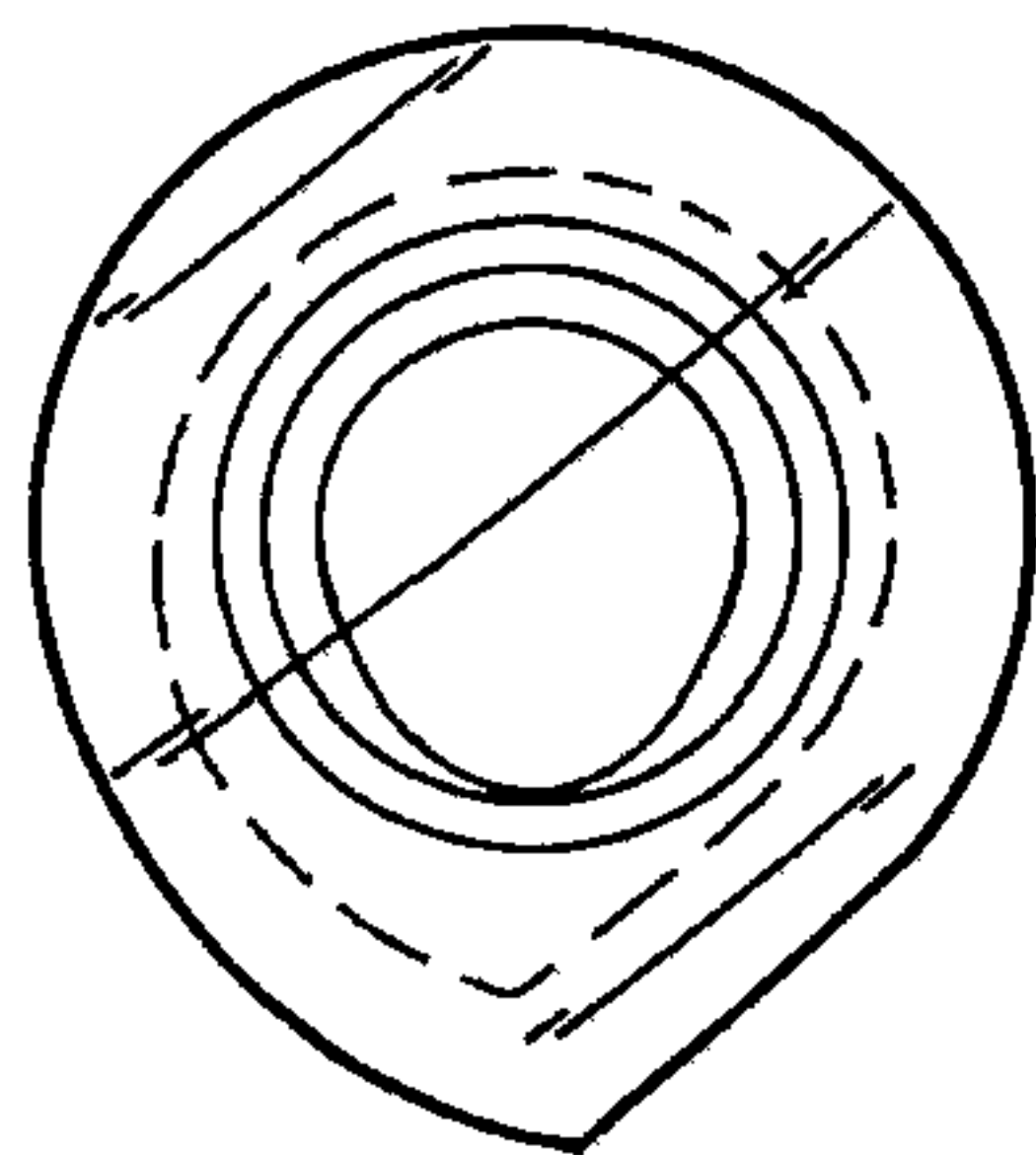

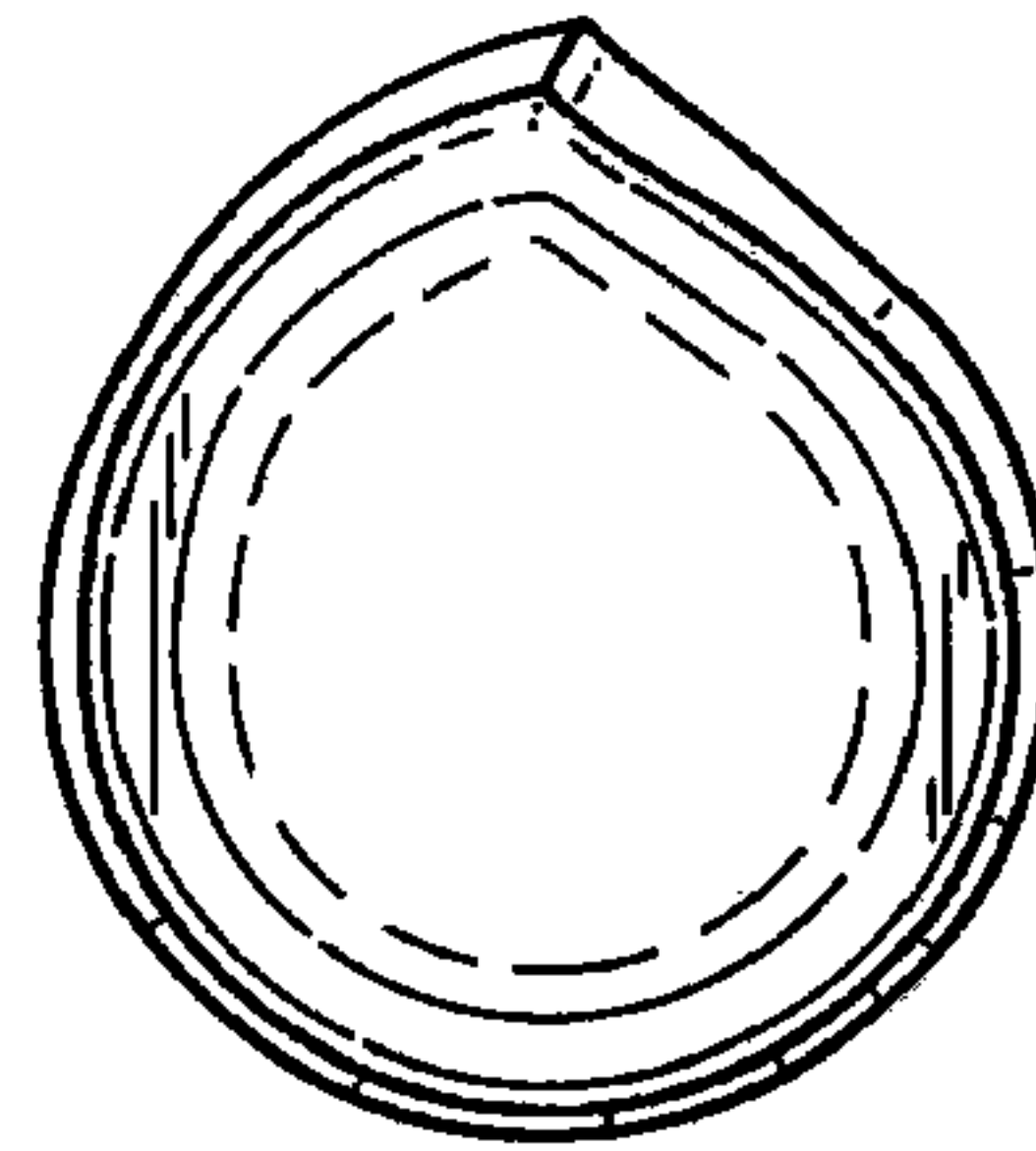

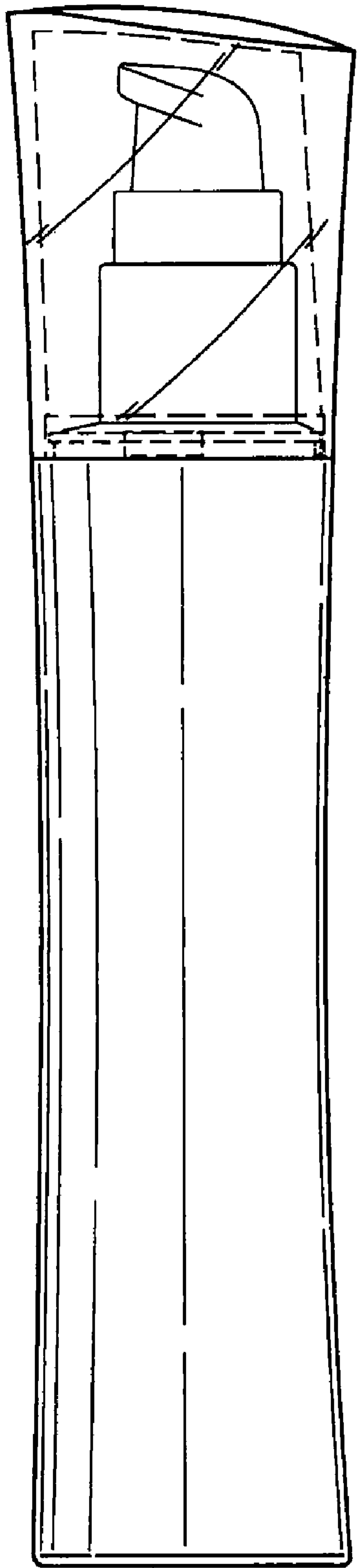

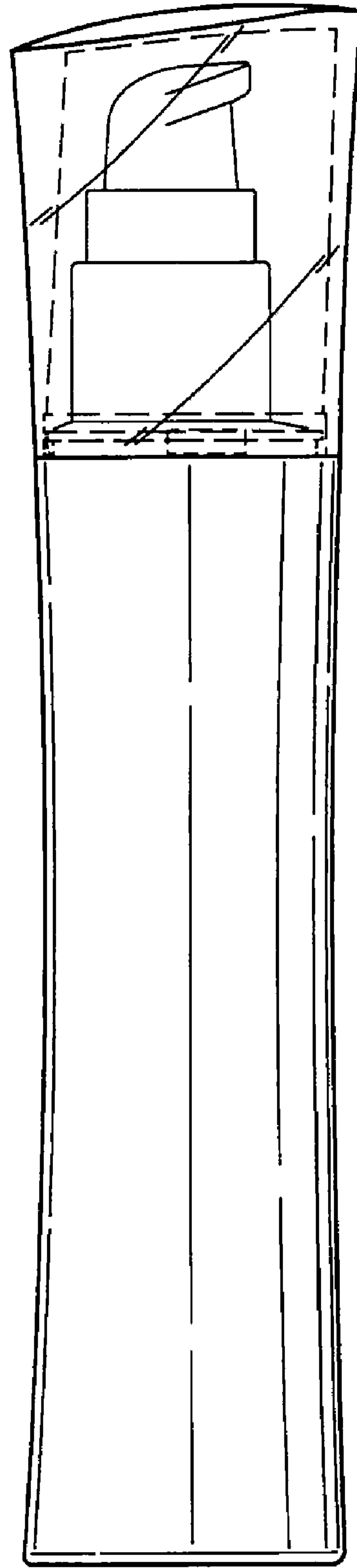
