**DESCRIPTION**

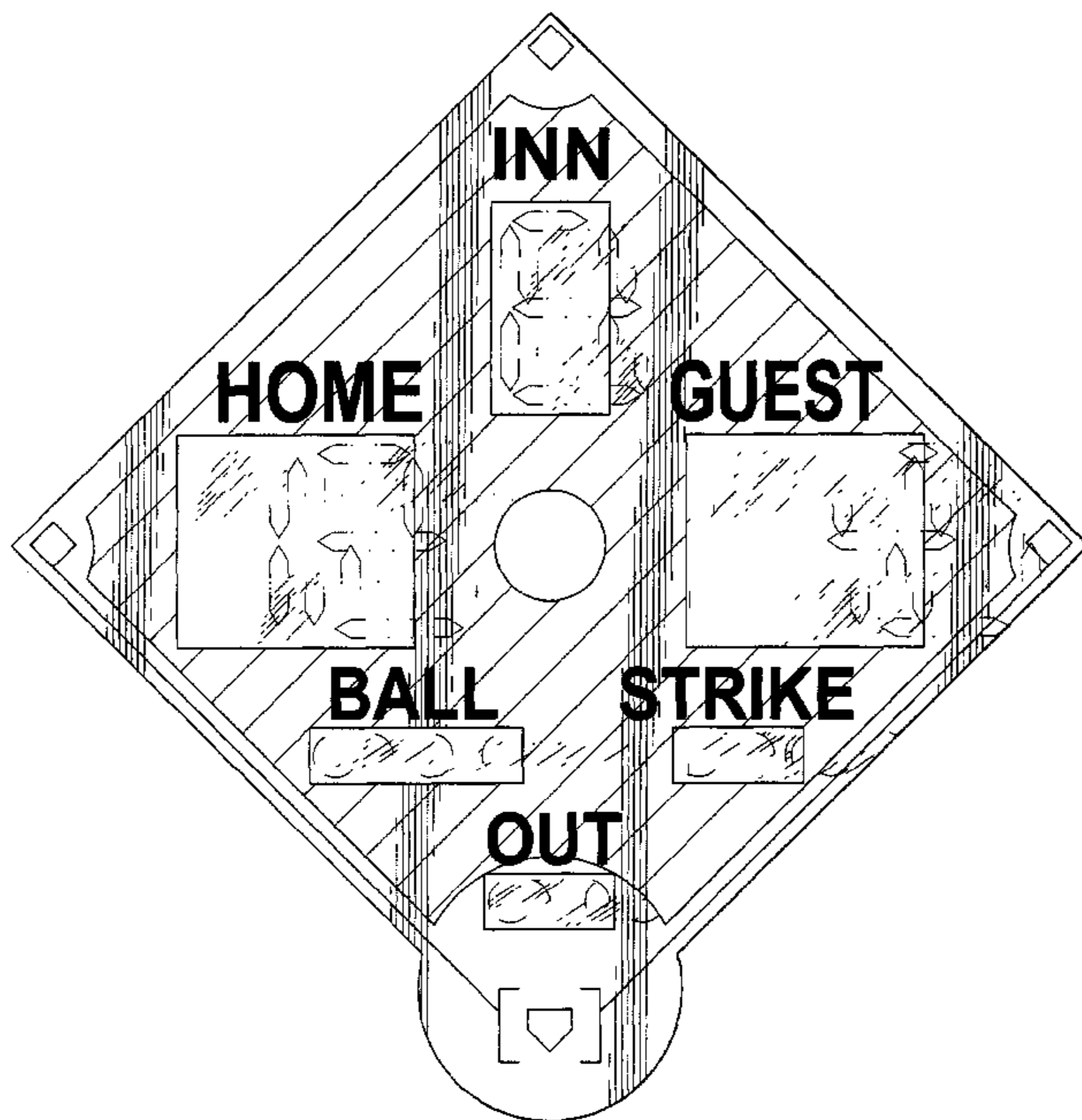

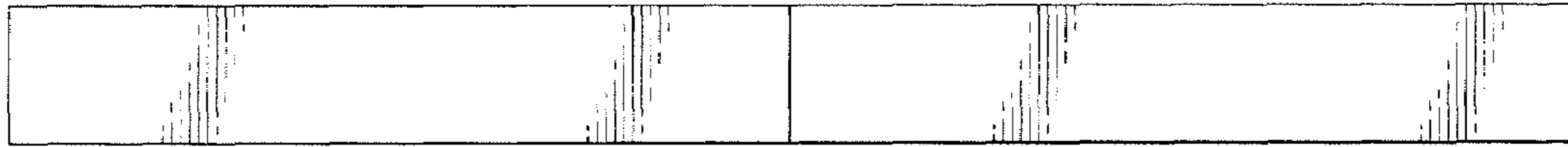

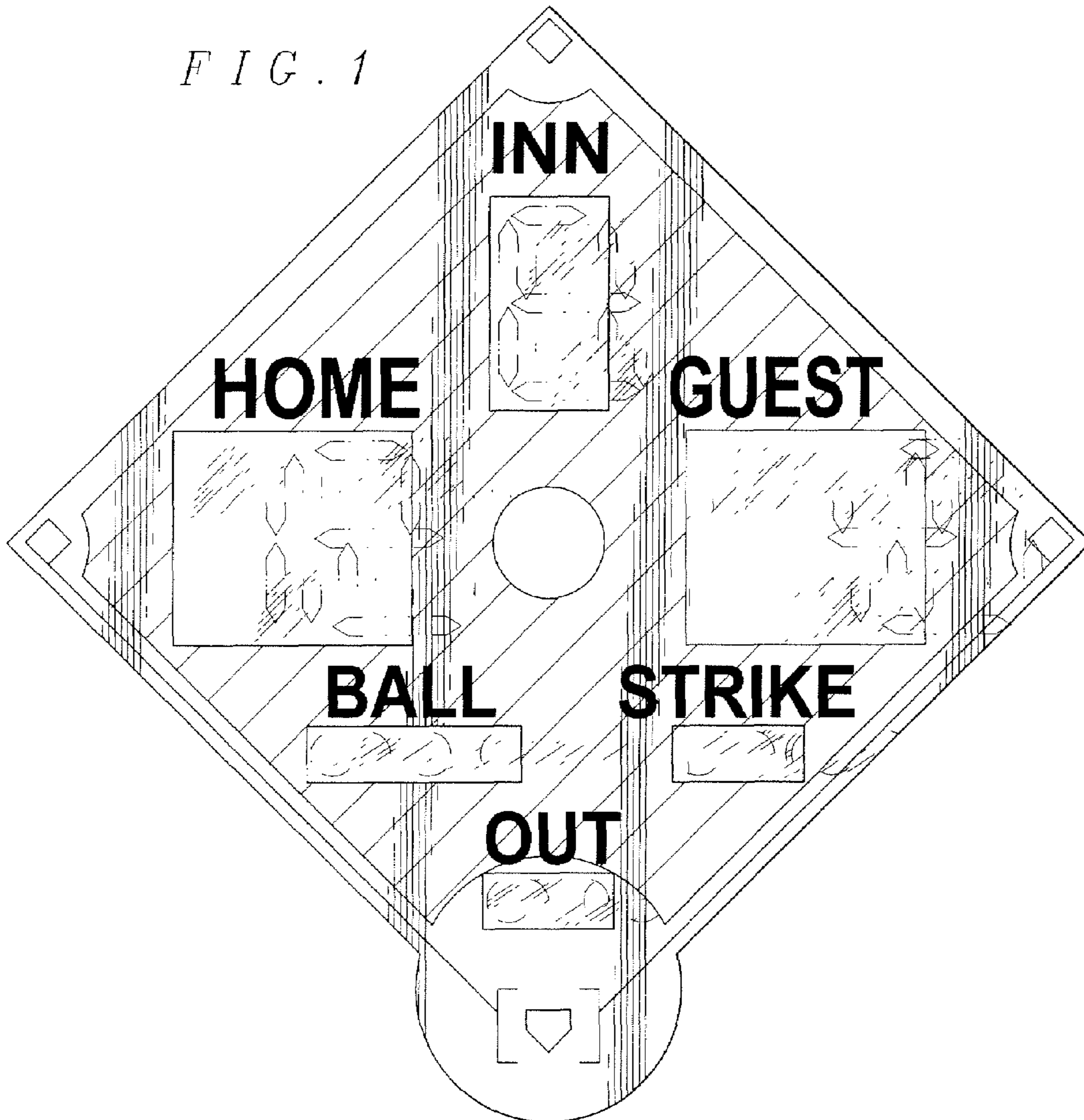
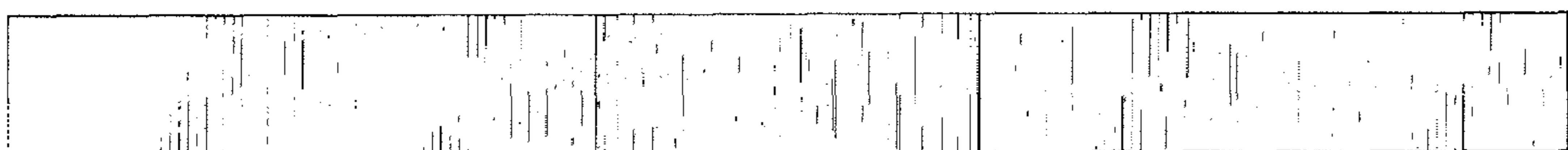
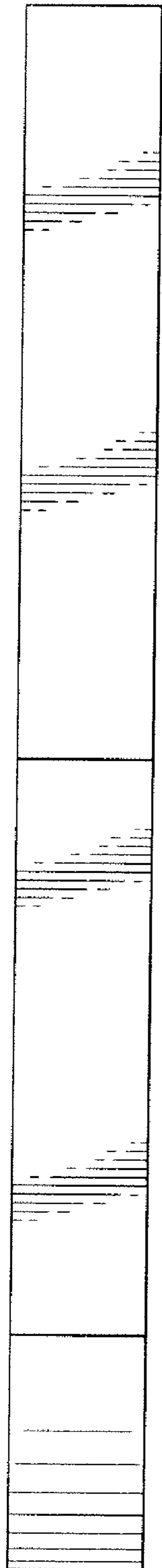
