(57) **CLAIM**

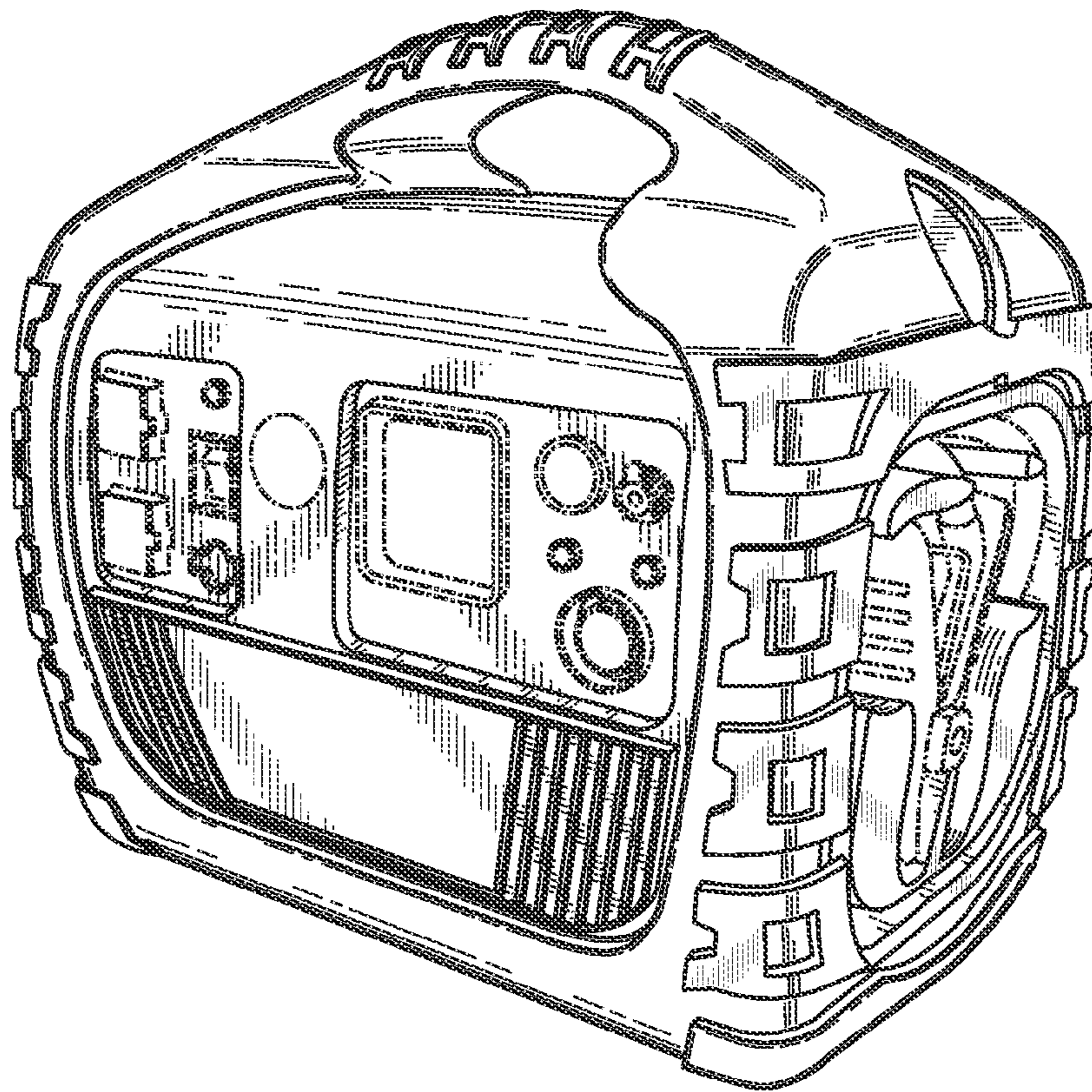
The ornamental design for a compact generator, as shown and described.

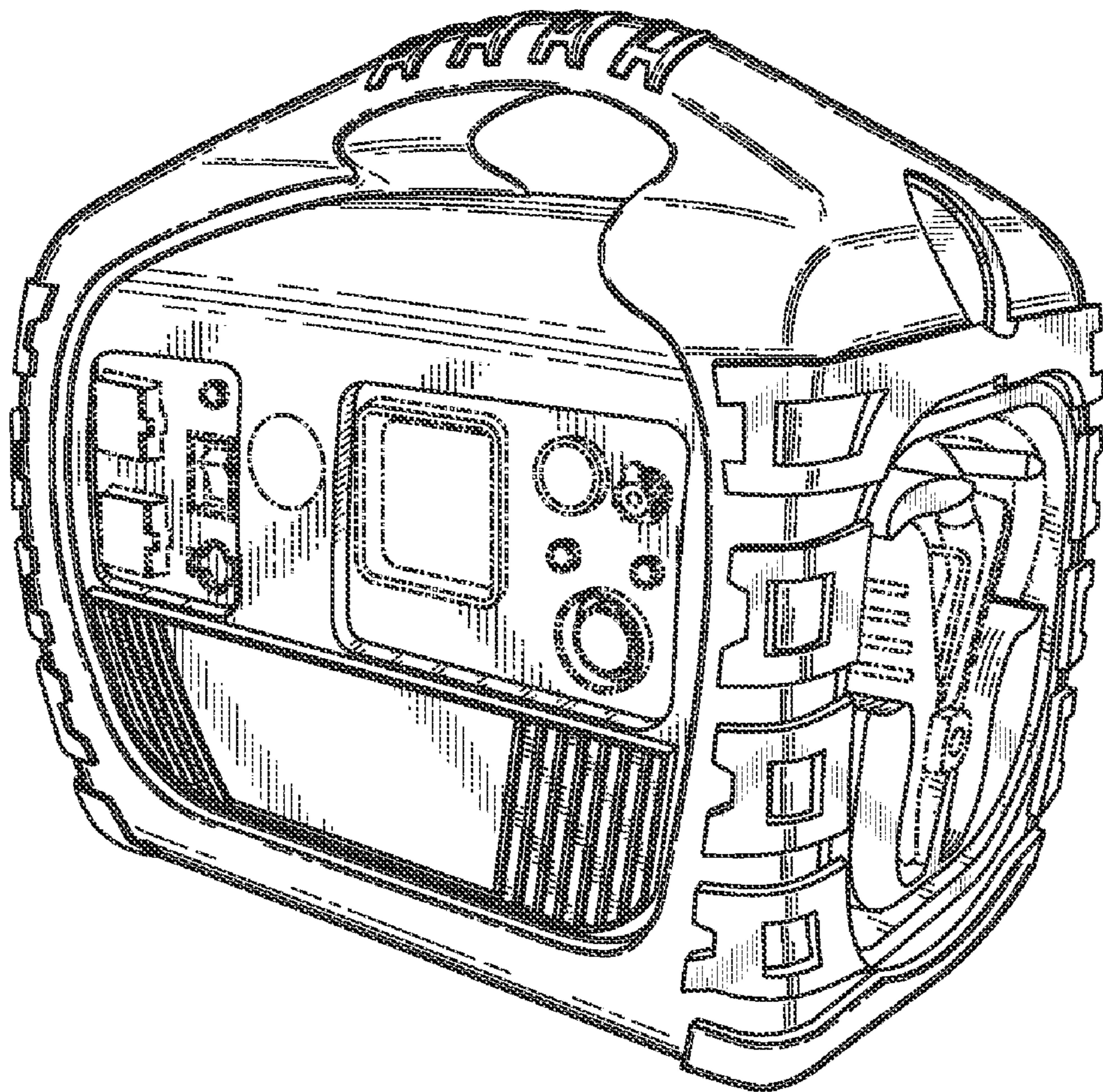

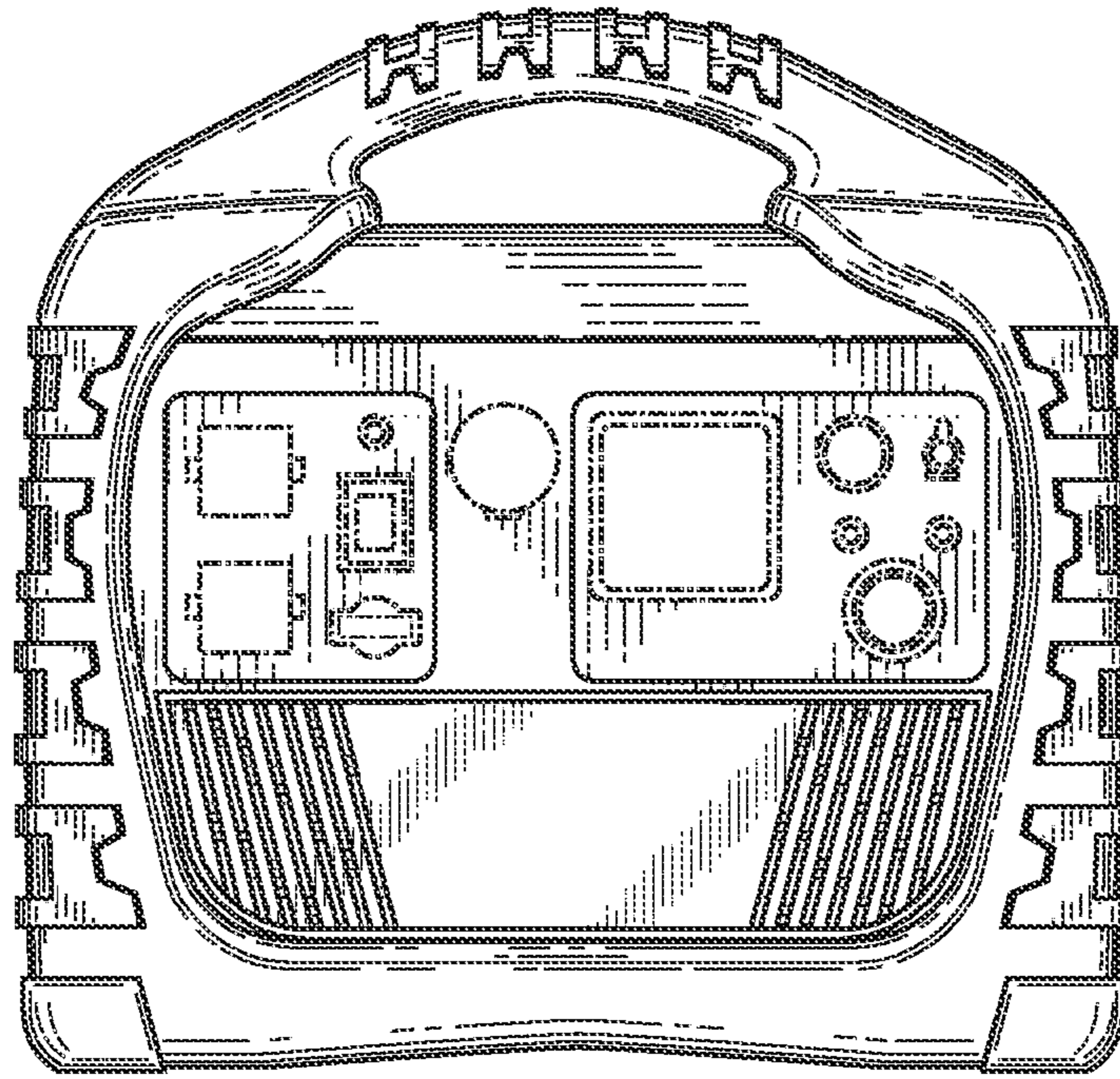

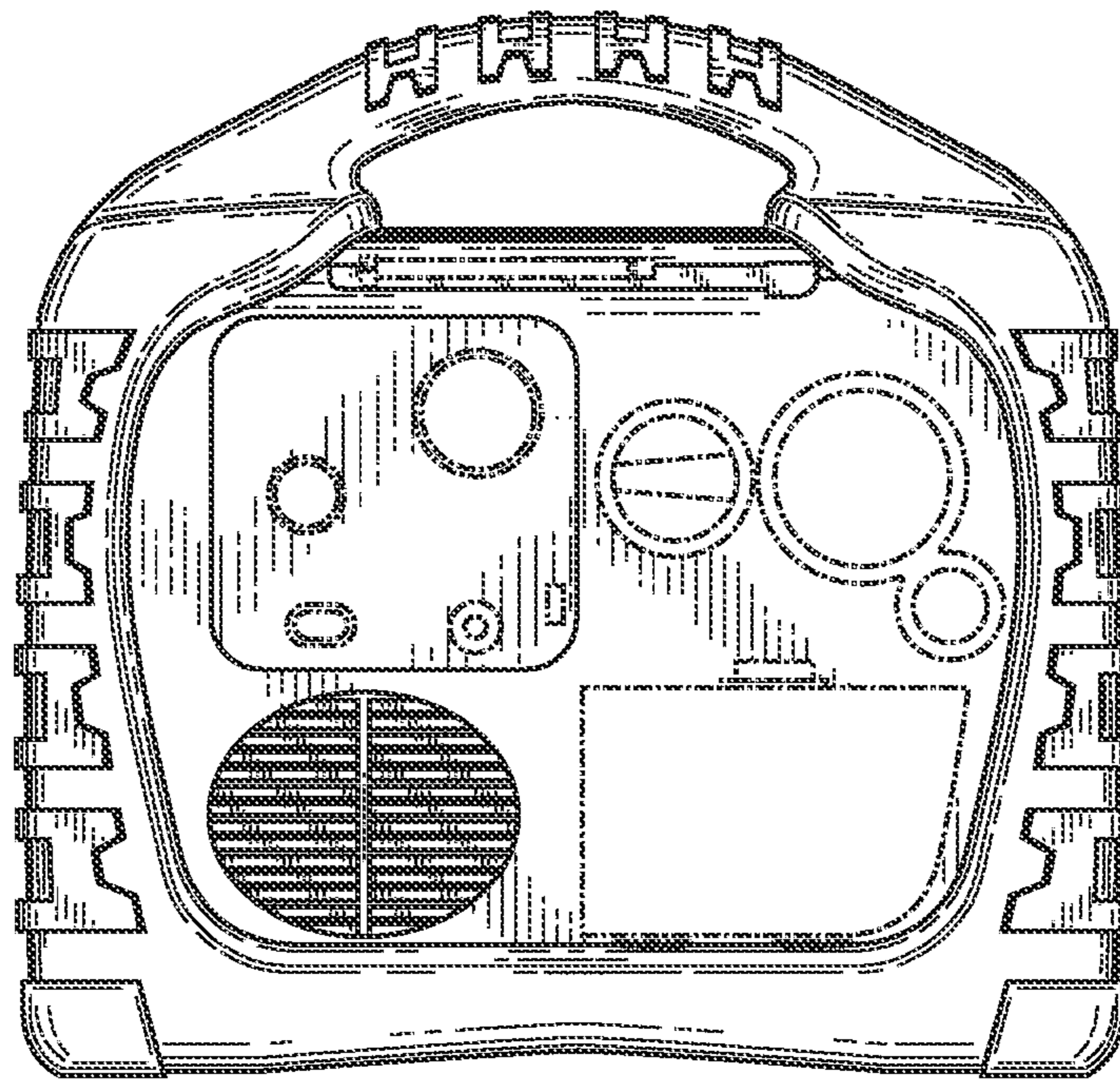

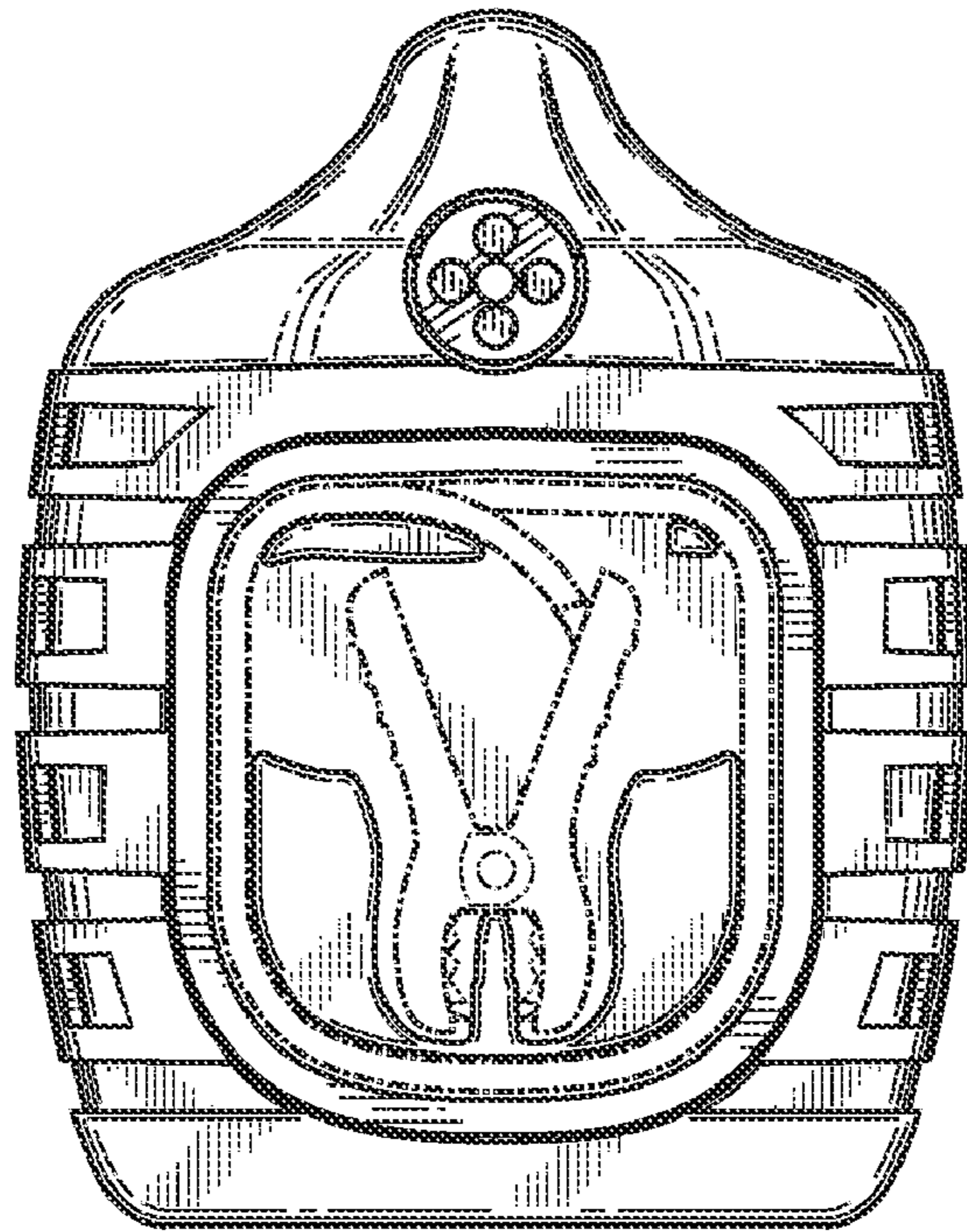

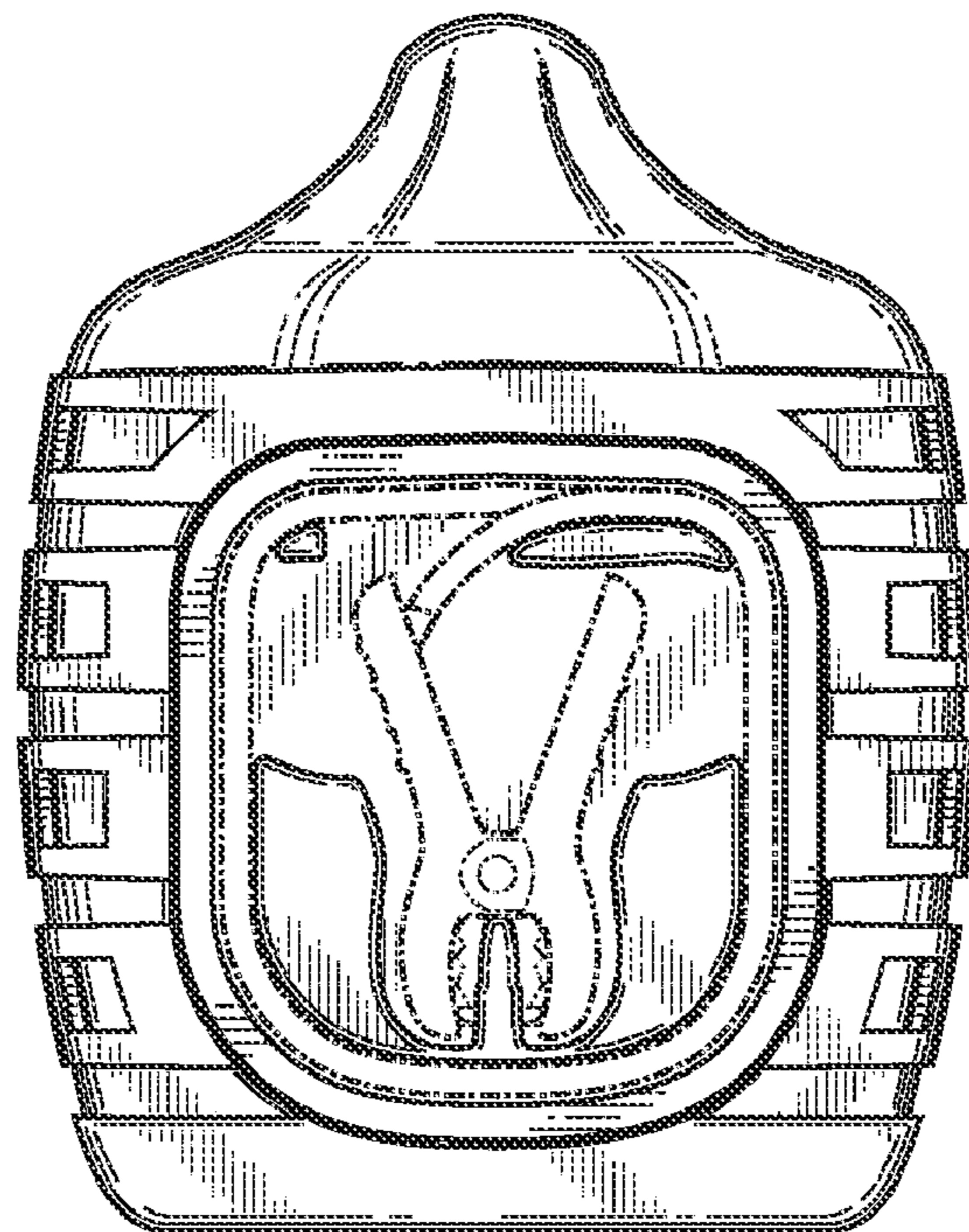

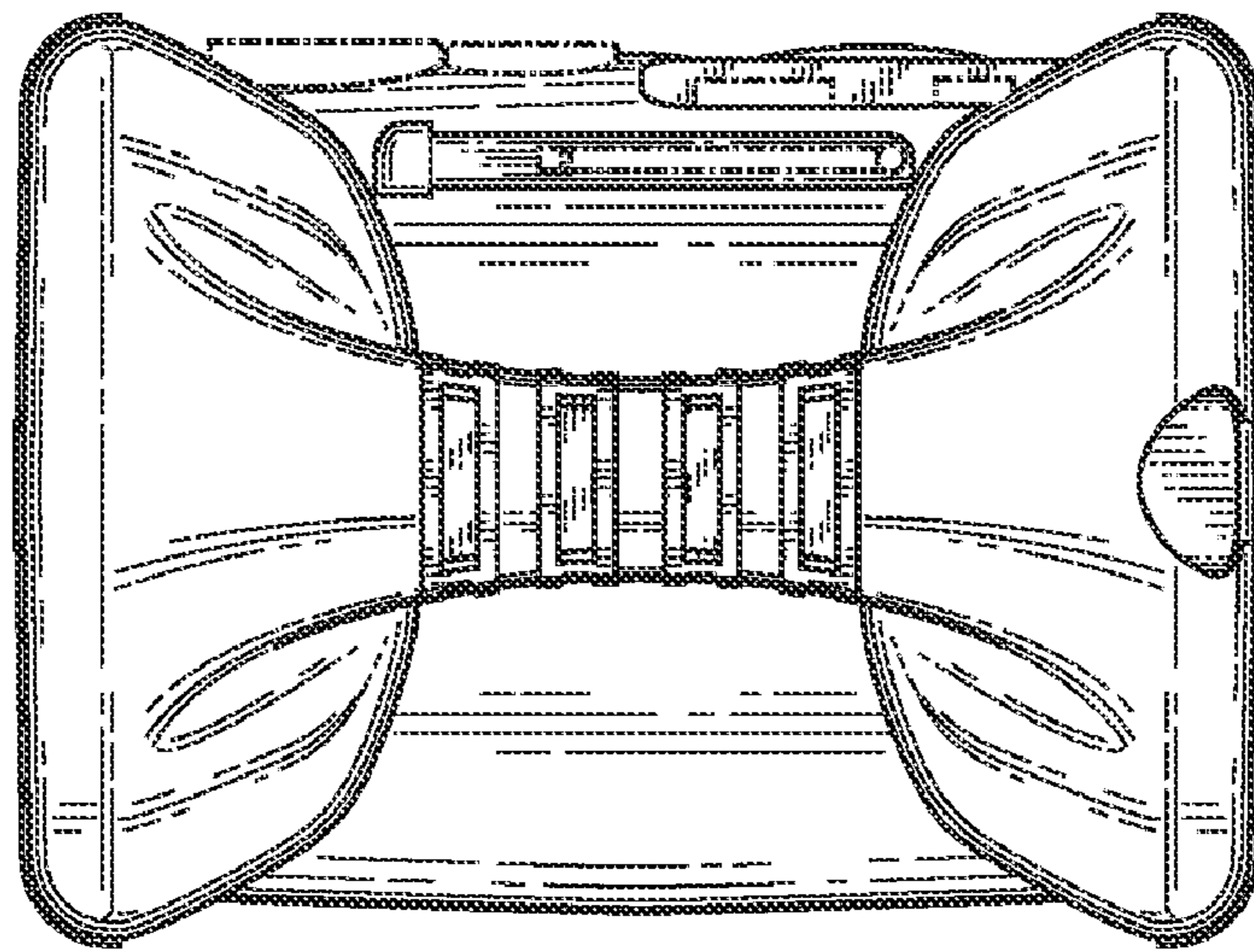

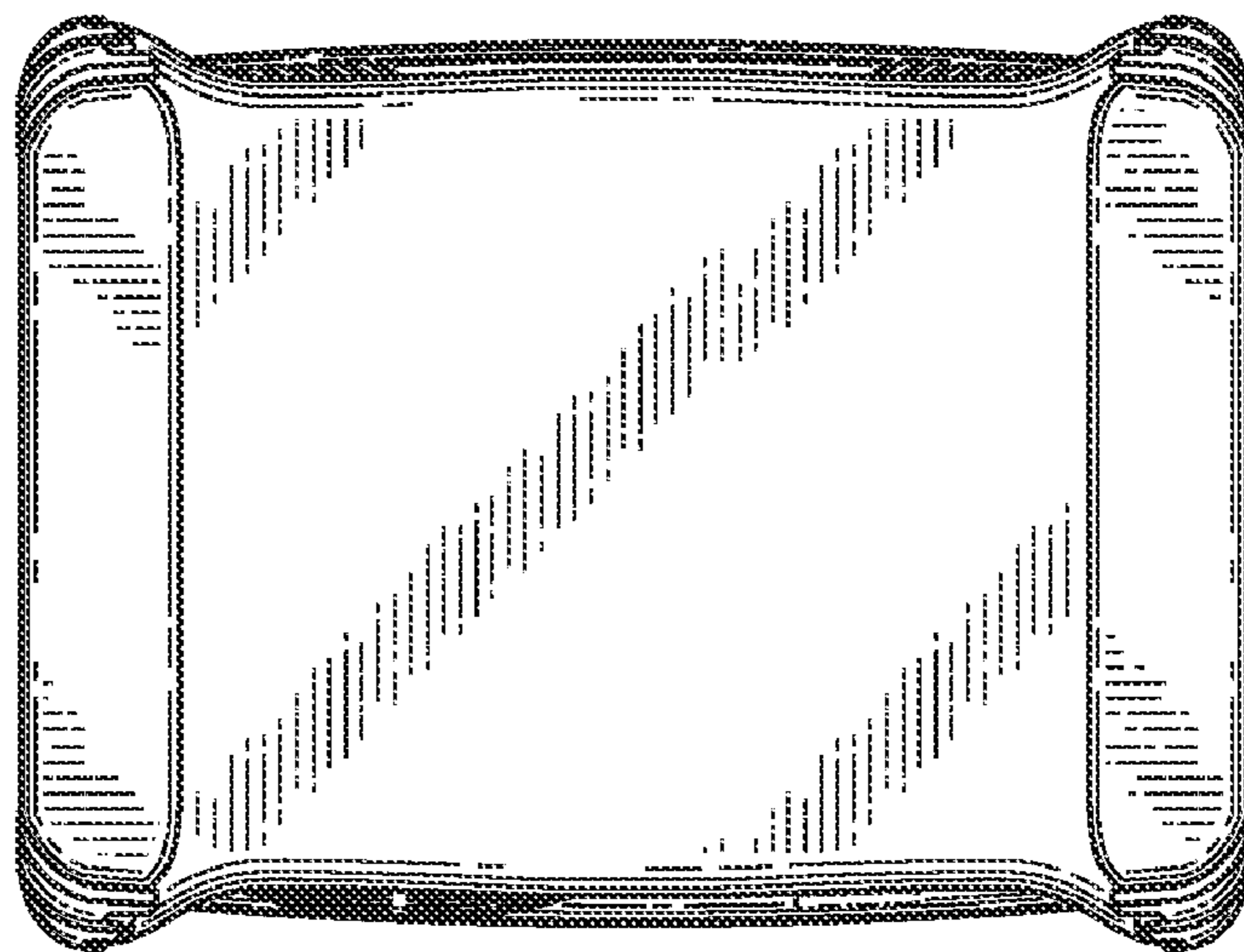
