FIG. 4 is a top plan view of the earphone of FIG. 1.

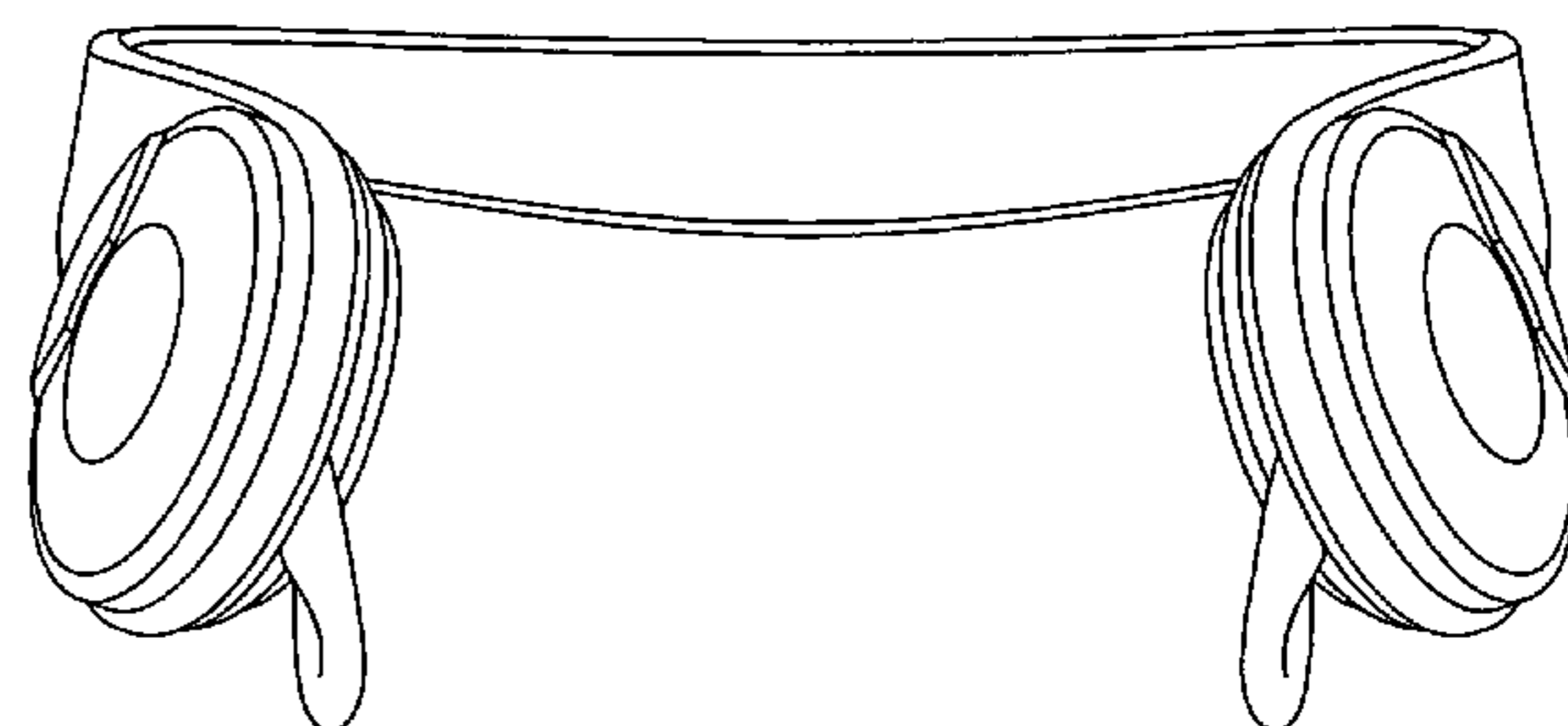
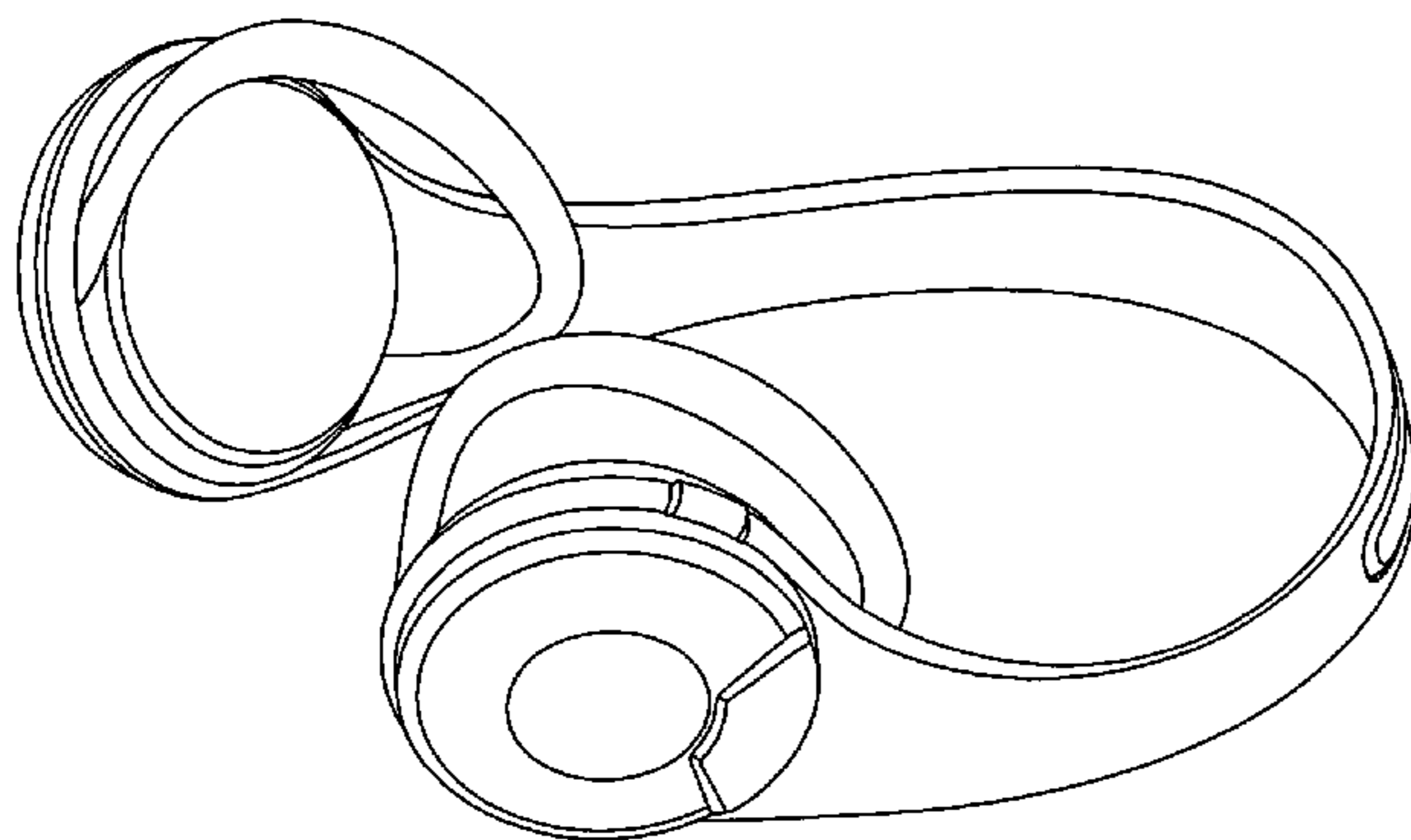
FIG. 5 is a right side elevation view of the earphone of FIG. 1.

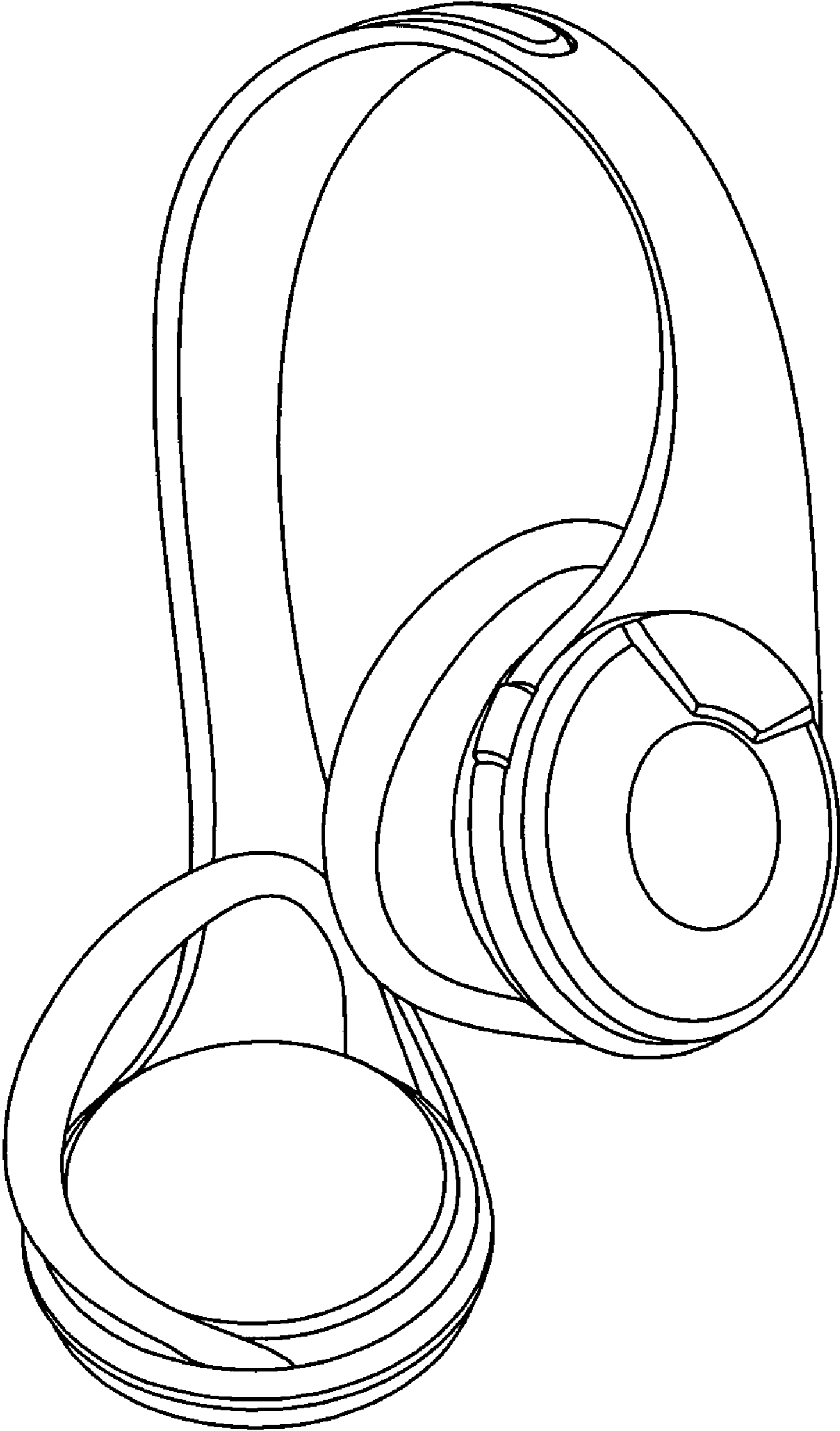

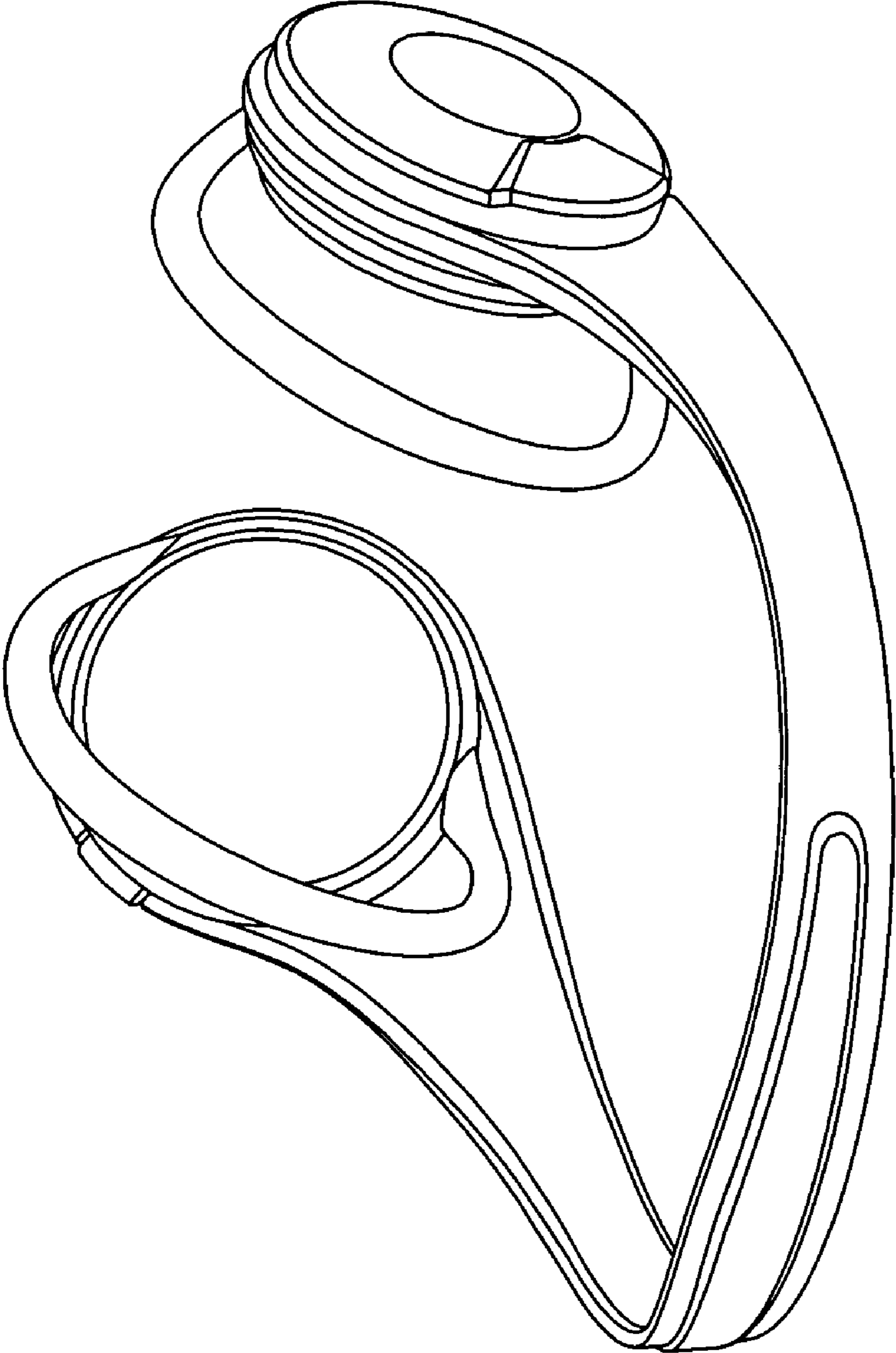

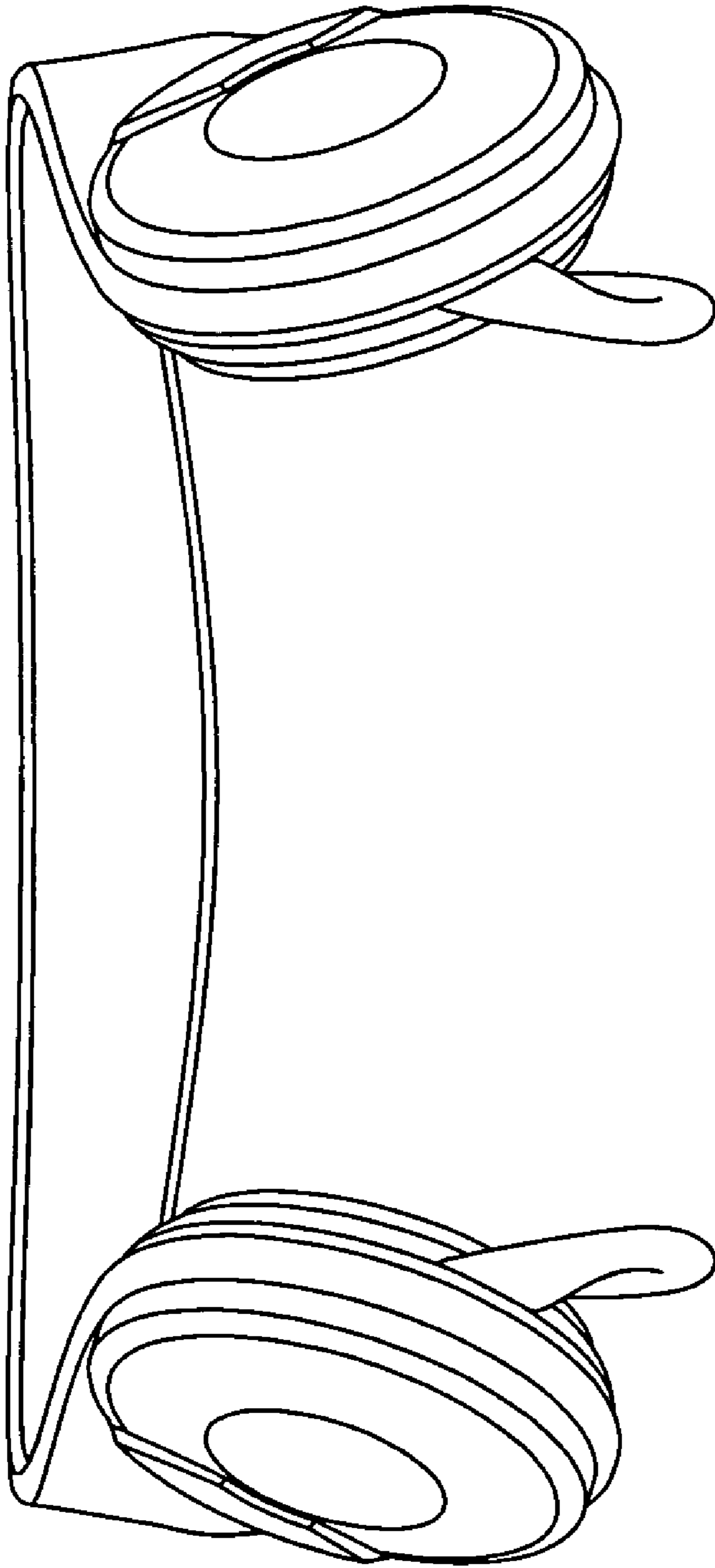

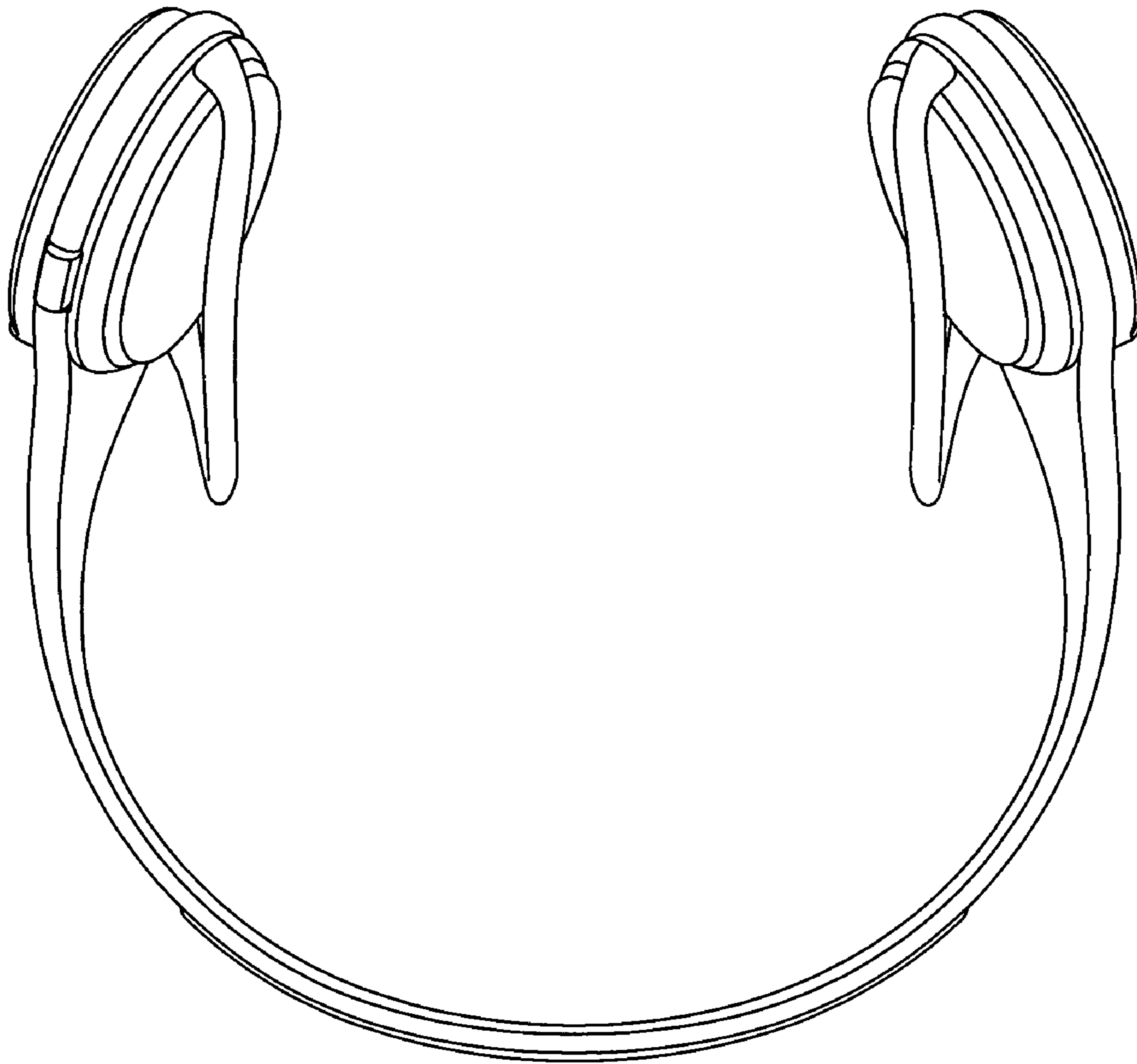

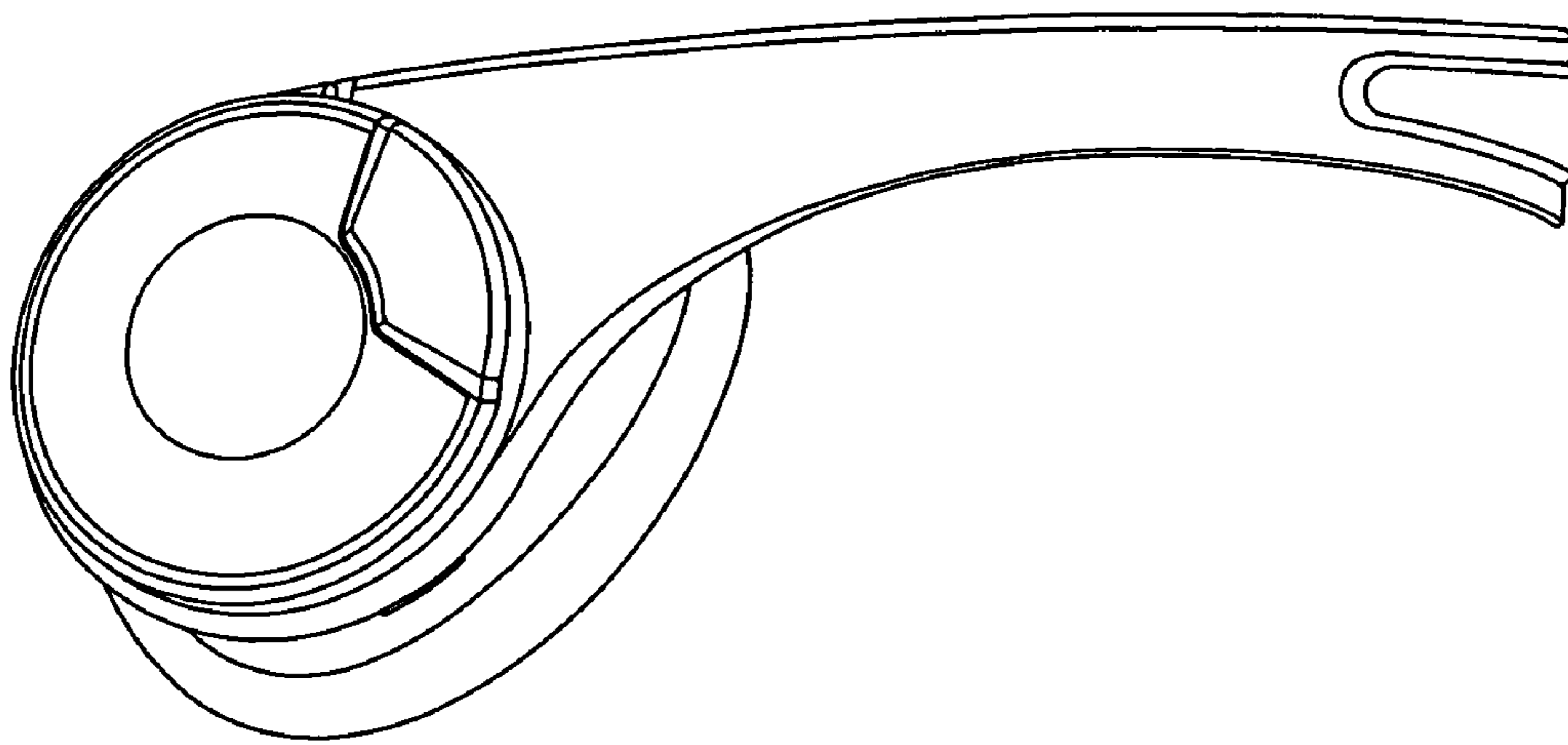

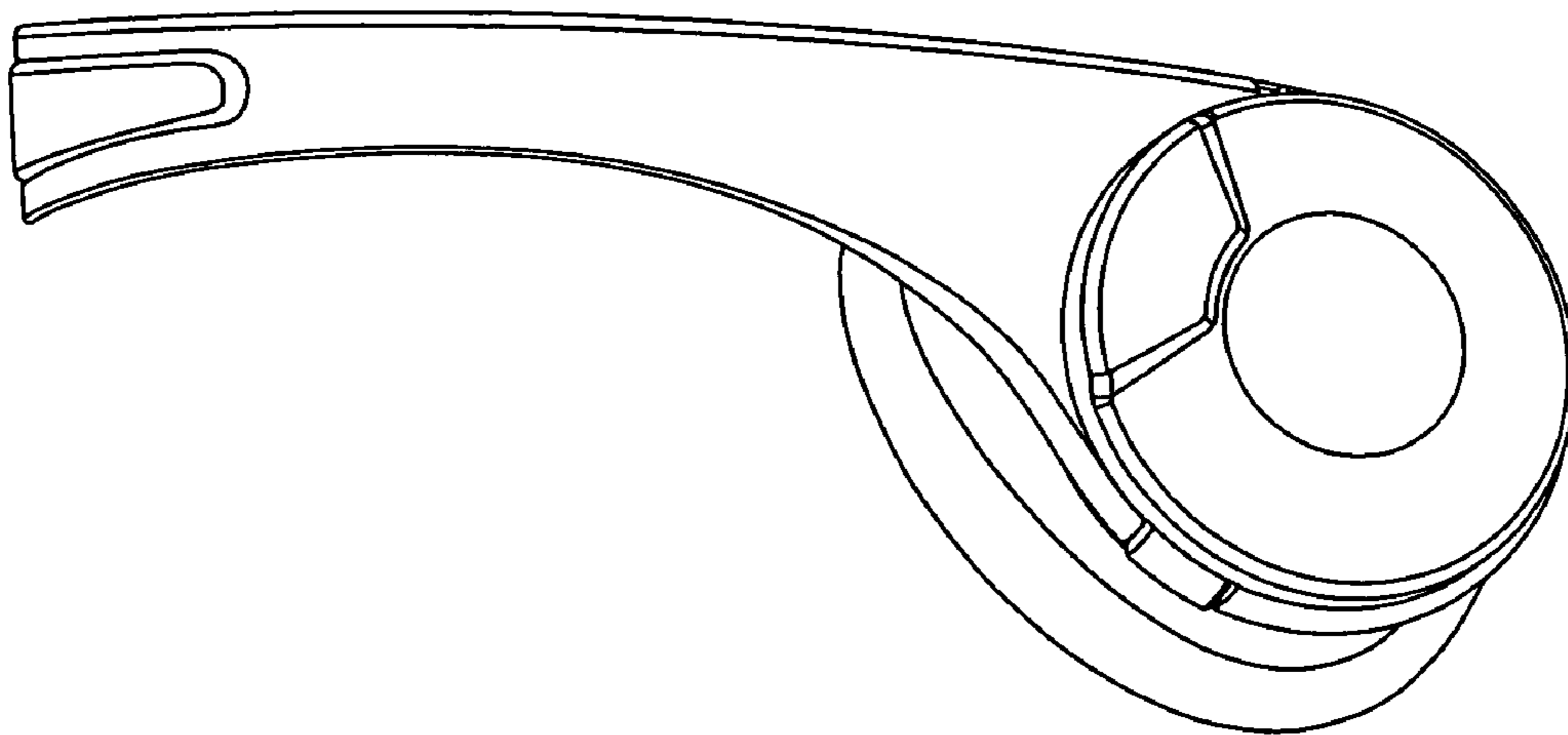

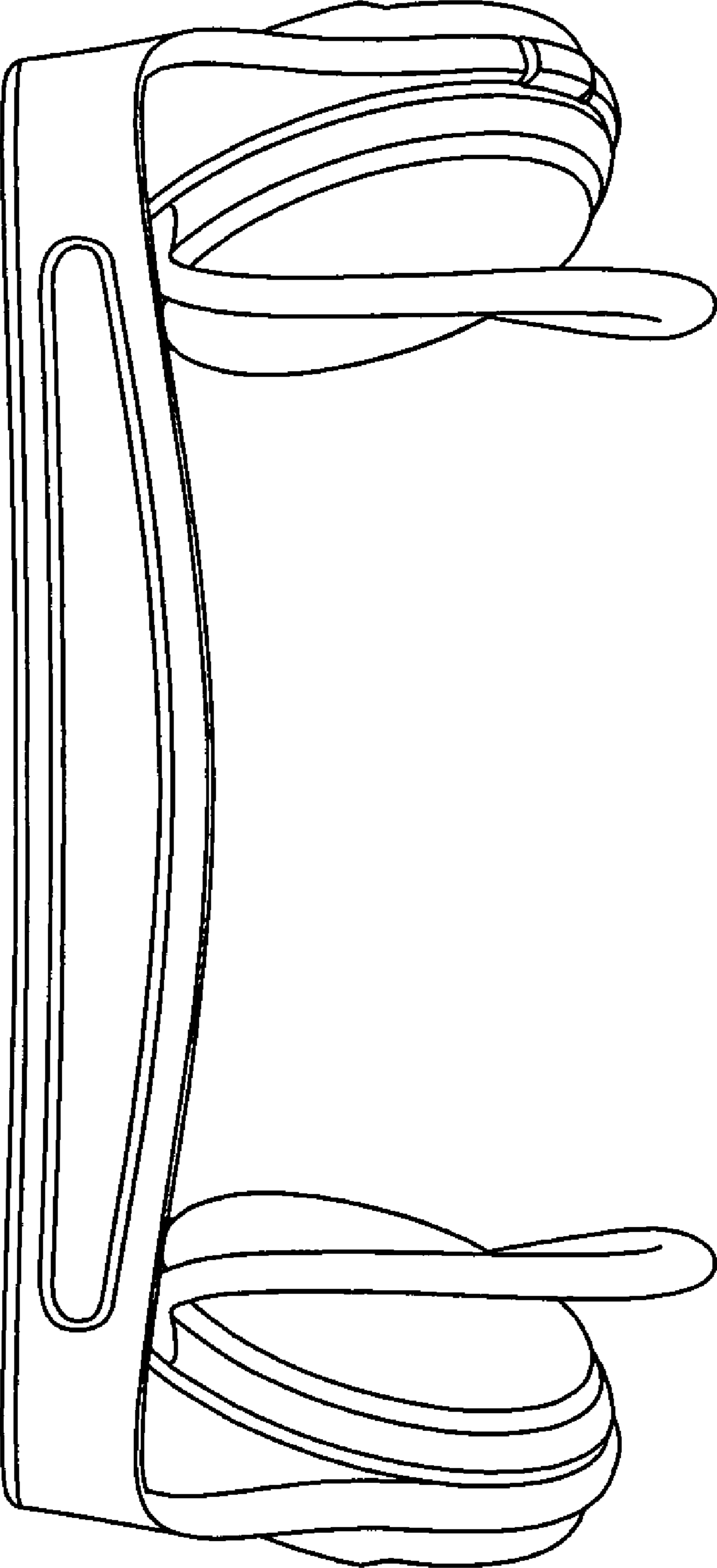
