FIG. 2 is an isometric enlarged view of the drill bit tip of FIG. 1;

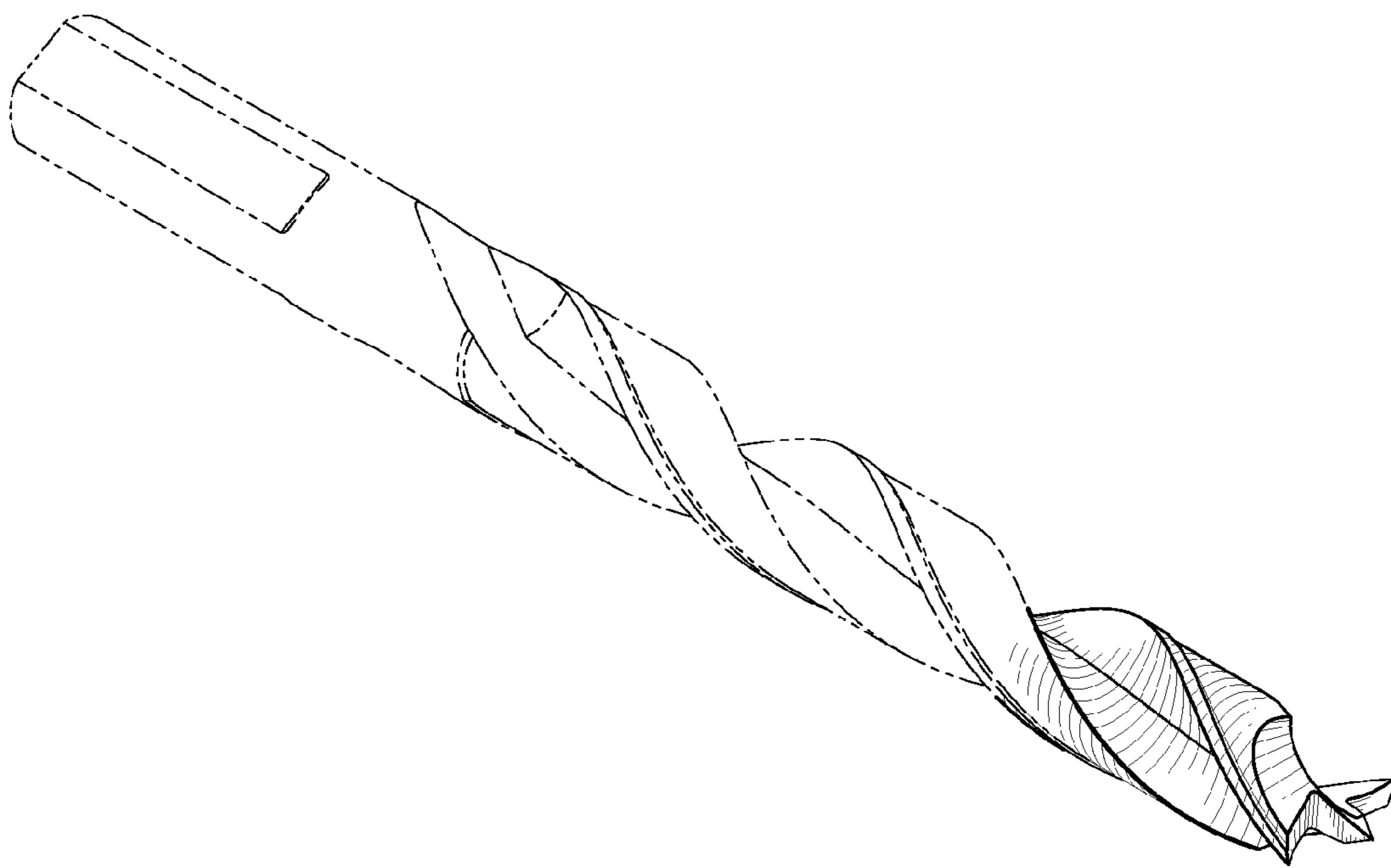
FIG. 3 is an end view of the drill bit tip of FIG. 2;

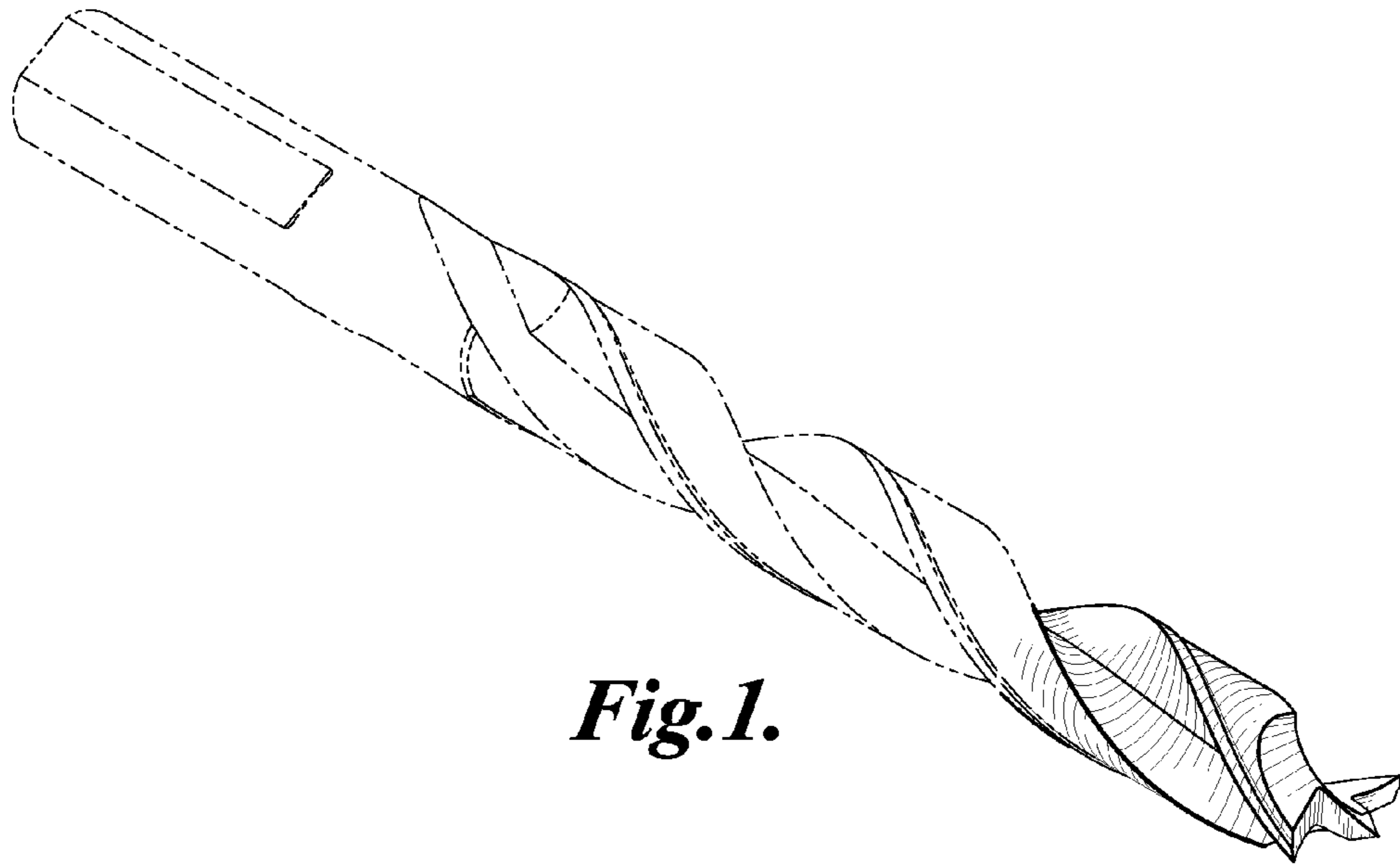
FIG. 4 is a side view of the drill bit tip of FIG. 2; and,

FIG. 5 is a top view of the drill bit tip of FIG. 2.

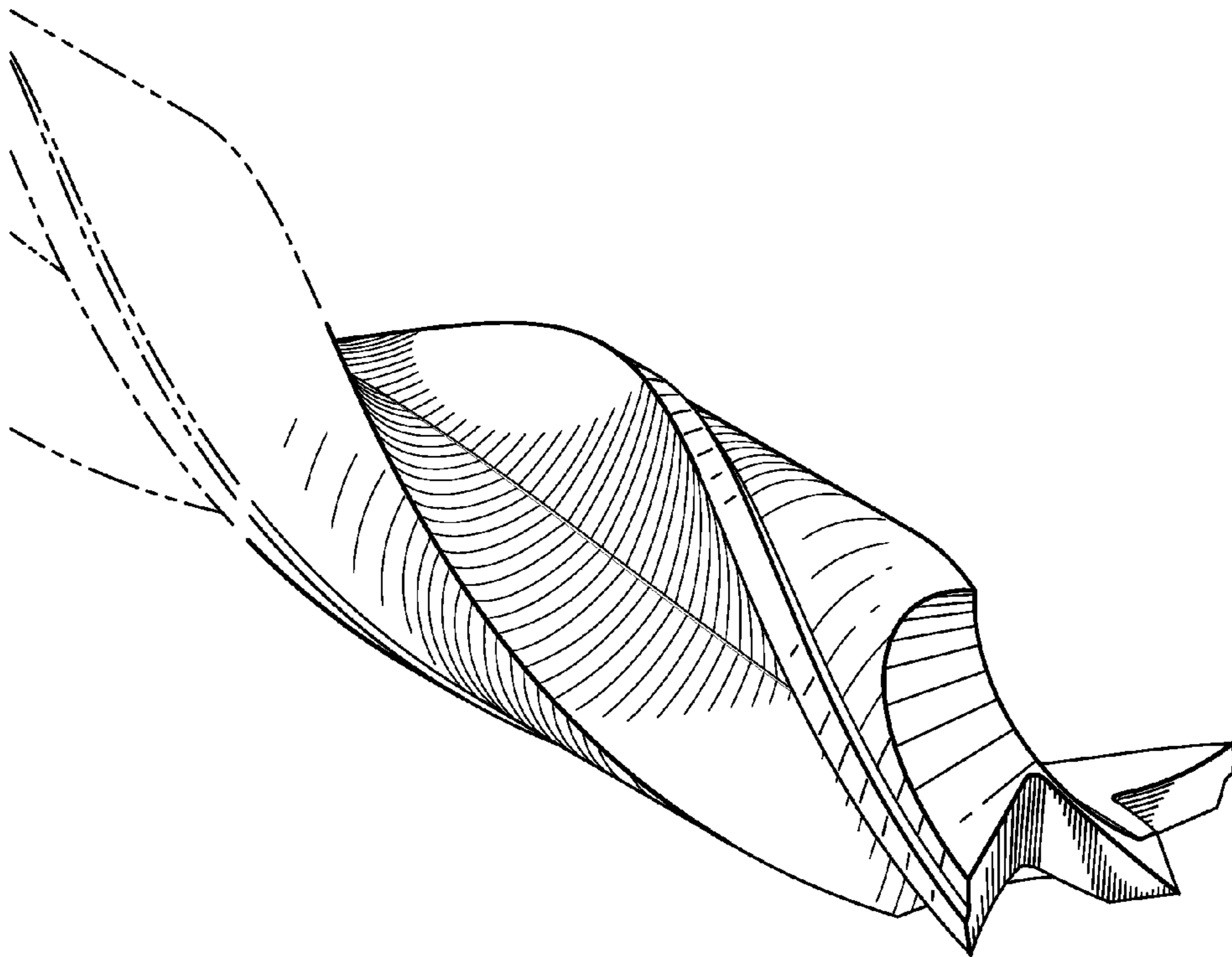

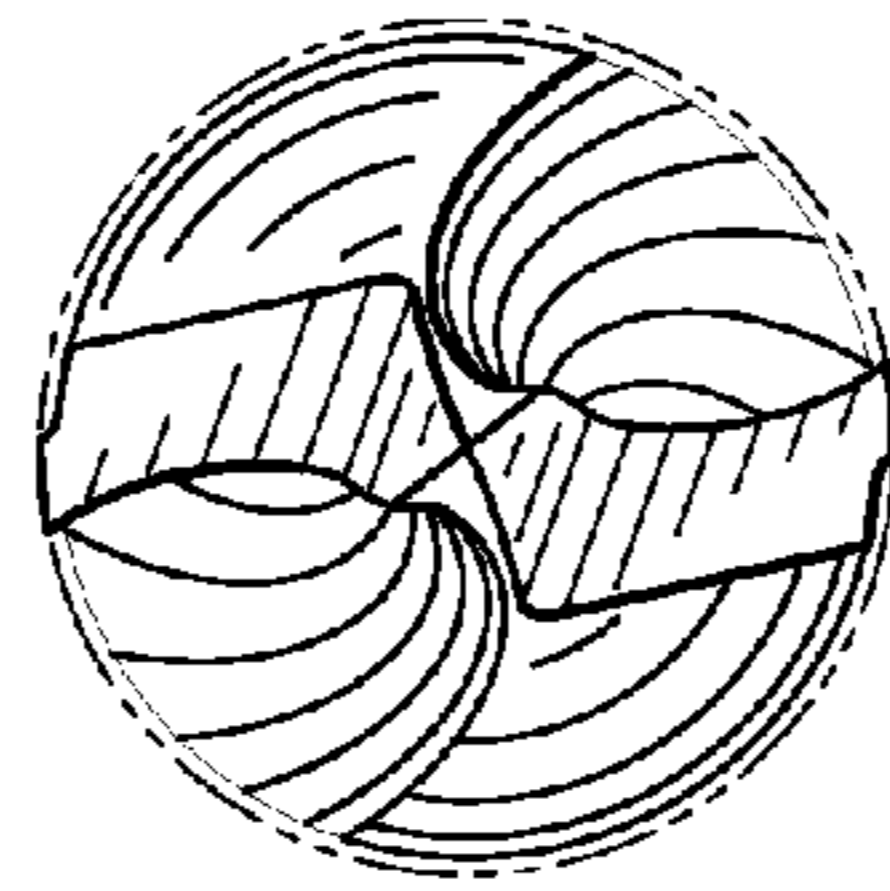




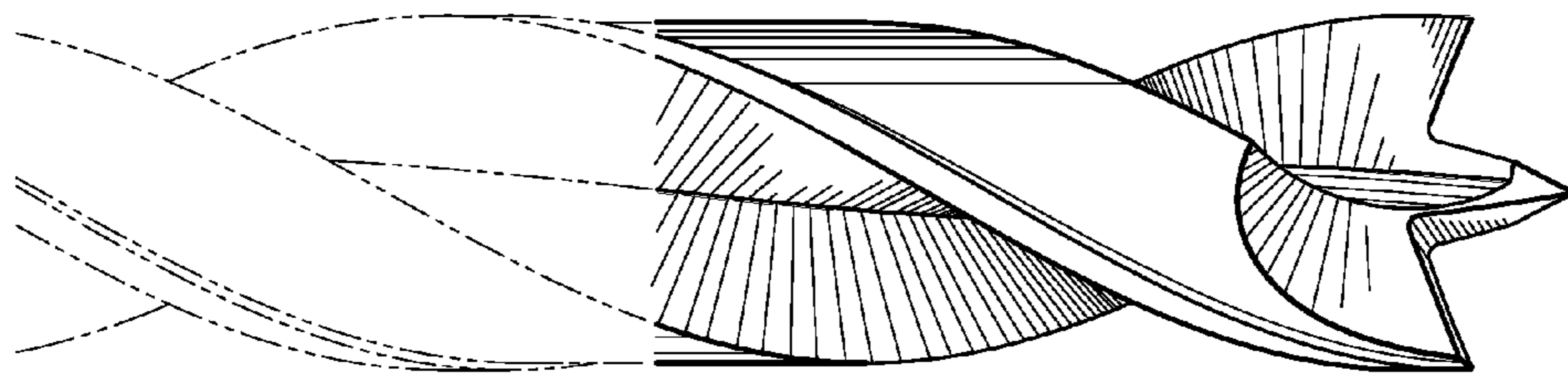

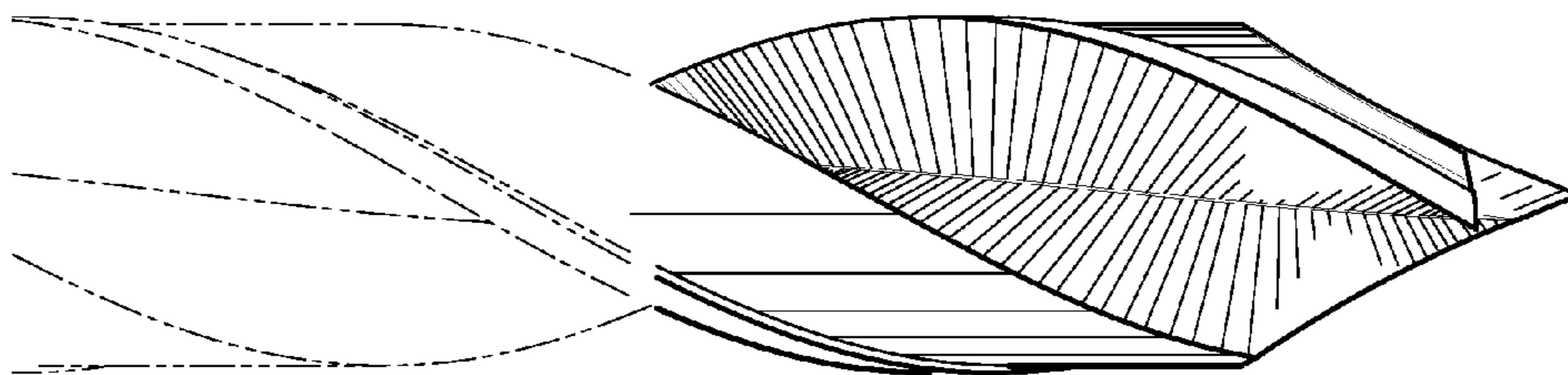
