The ornamental design for a tag holder, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a tag holder embodying my design;
FIG. 2 is a right side view of the tag holder;
FIG. 3 is a rear view of the tag holder;
FIG. 4 is a left side view of the tag holder;
FIG. 5 is a top view of the tag holder;
FIG. 6 is a bottom view of the tag holder;
FIG. 7 is a front view of the tag holder shown in use mounted to a tag; and,
FIG. 8 is a right side view of the tag holder shown in use mounted to the tag.

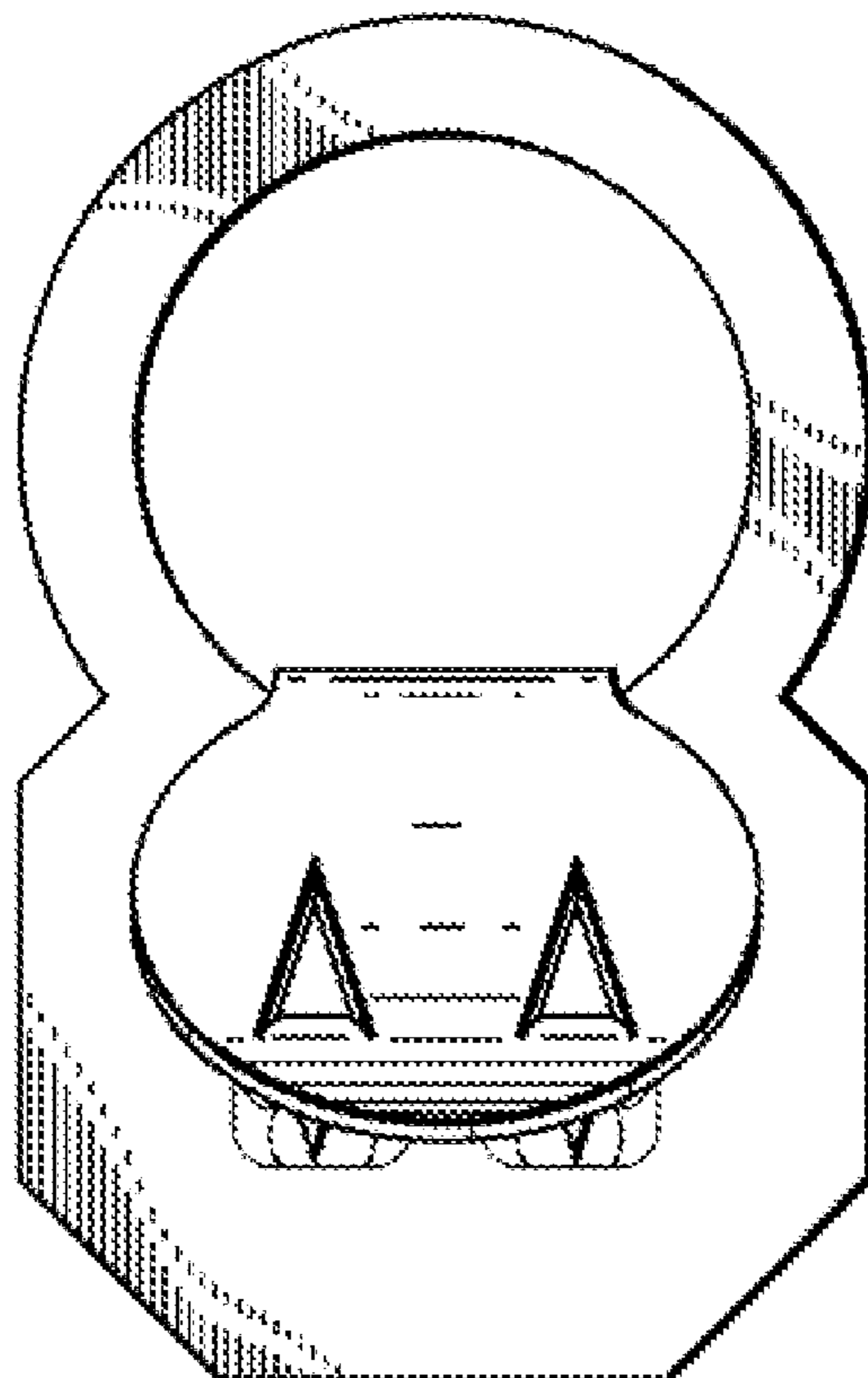

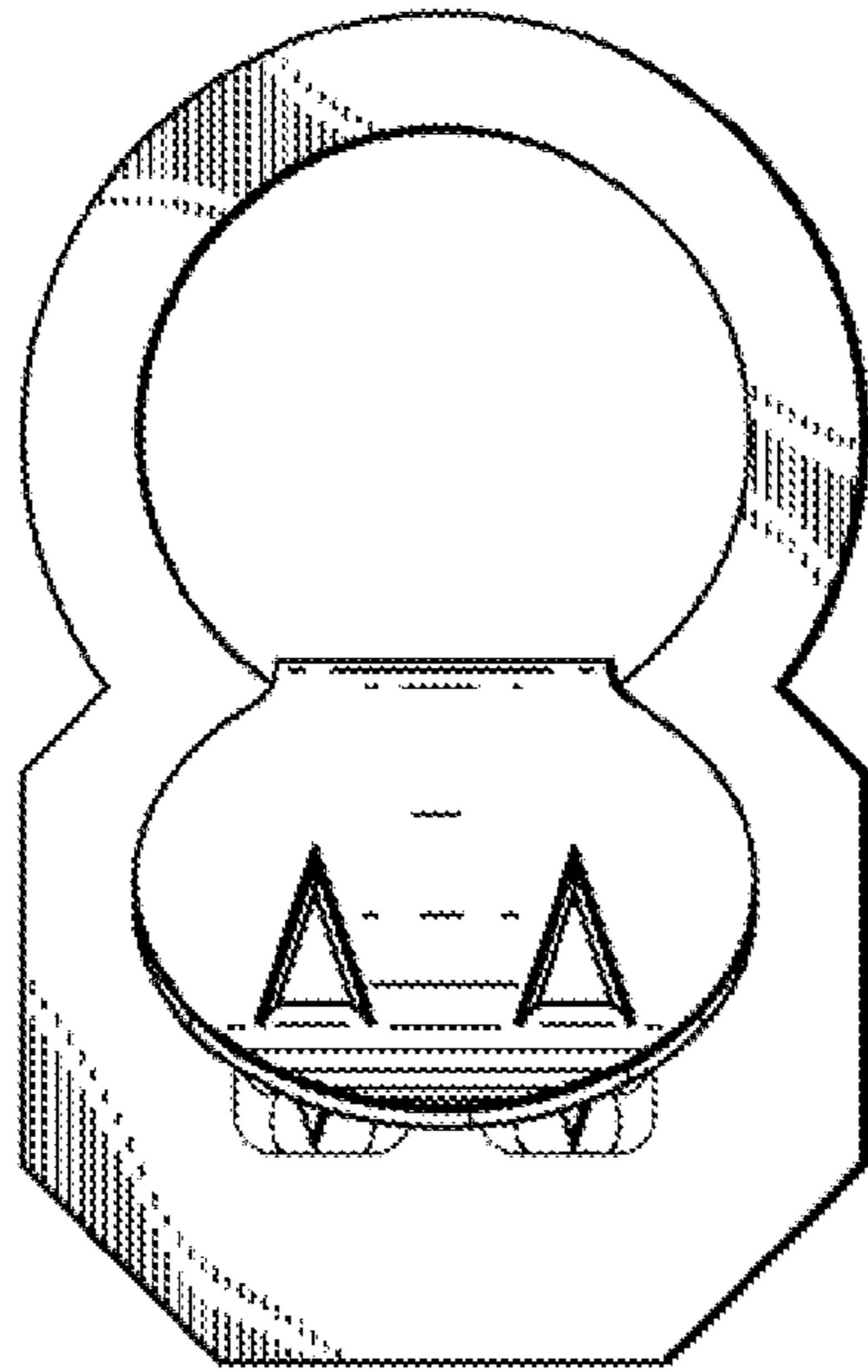

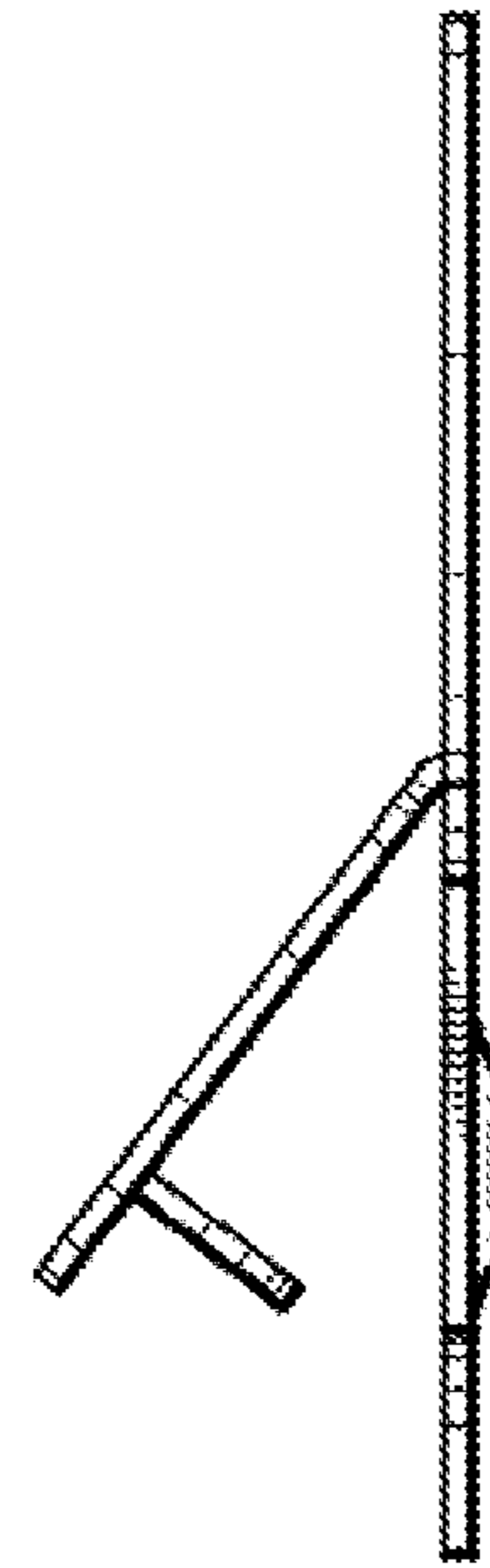

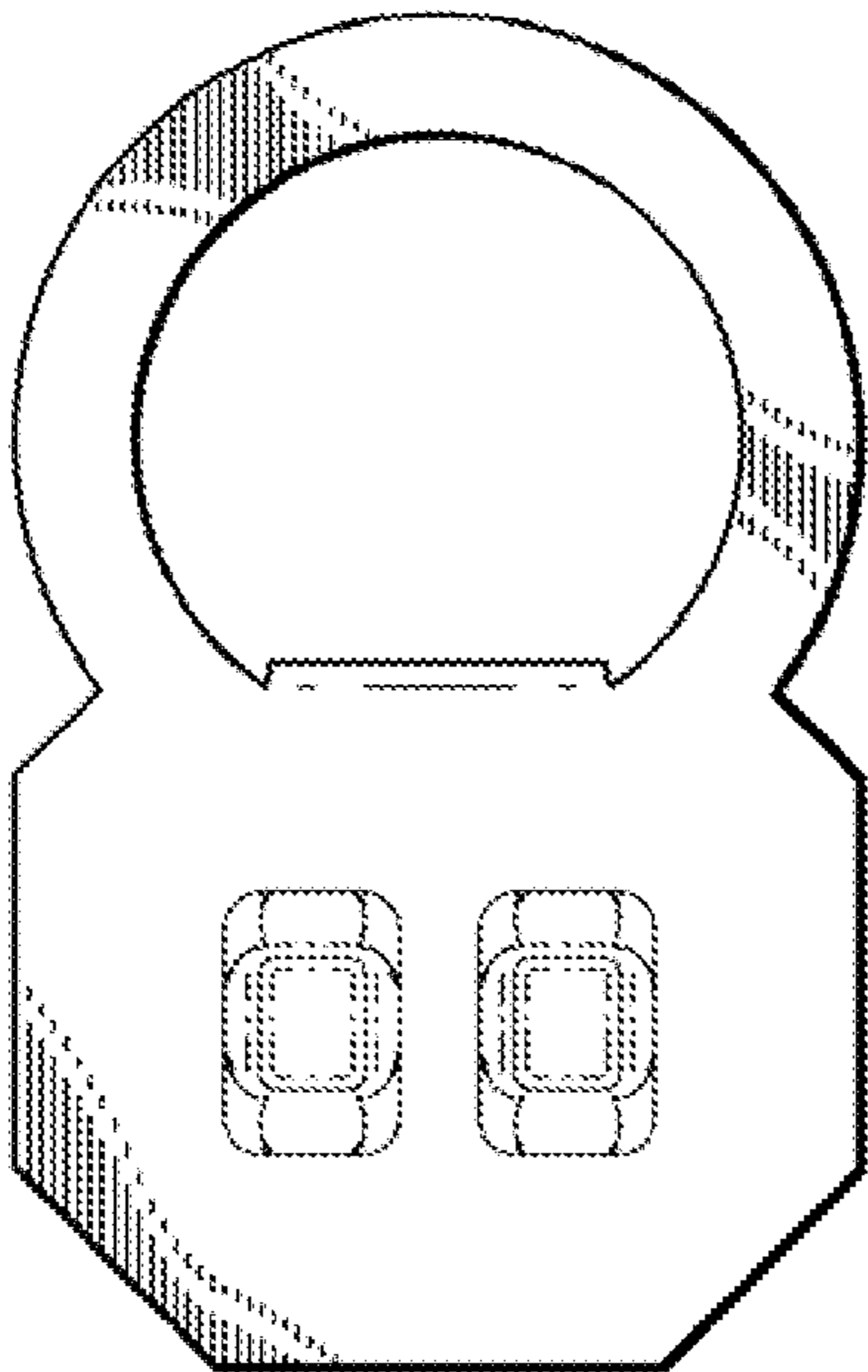

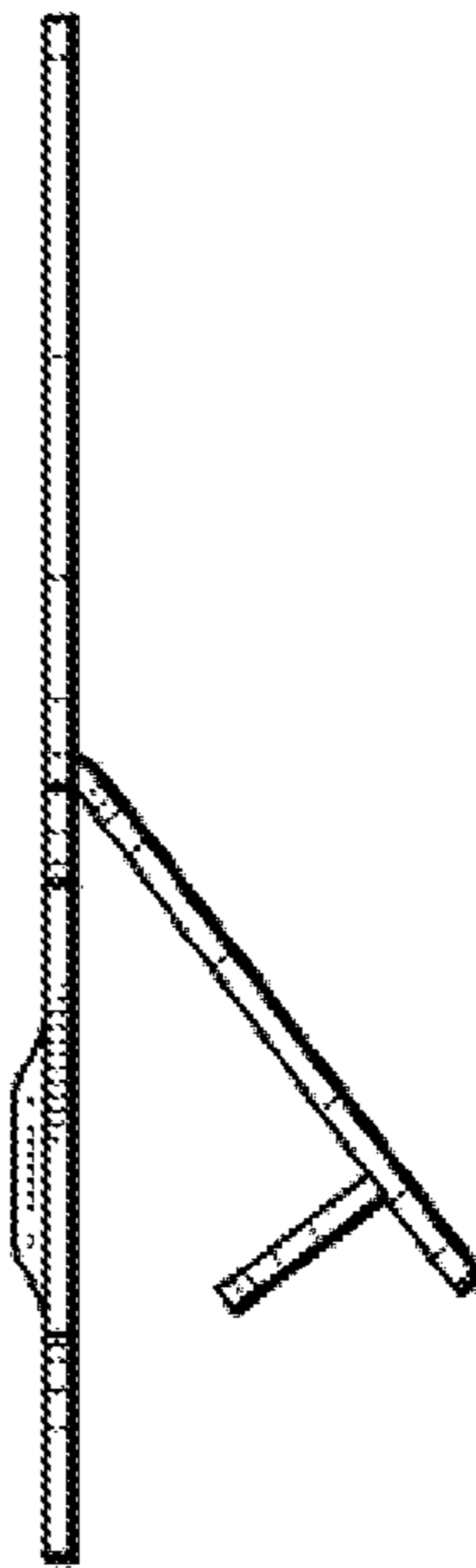

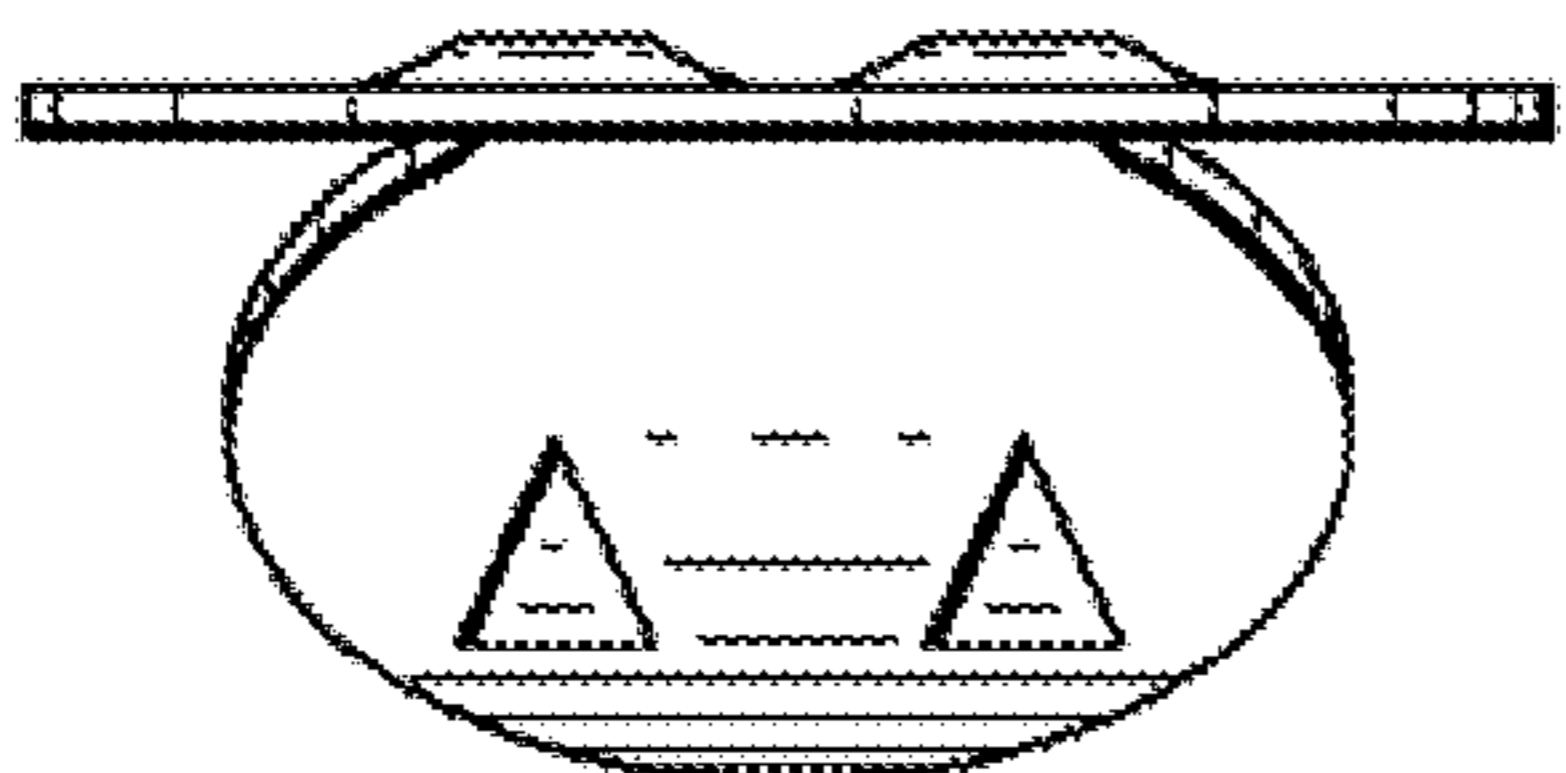

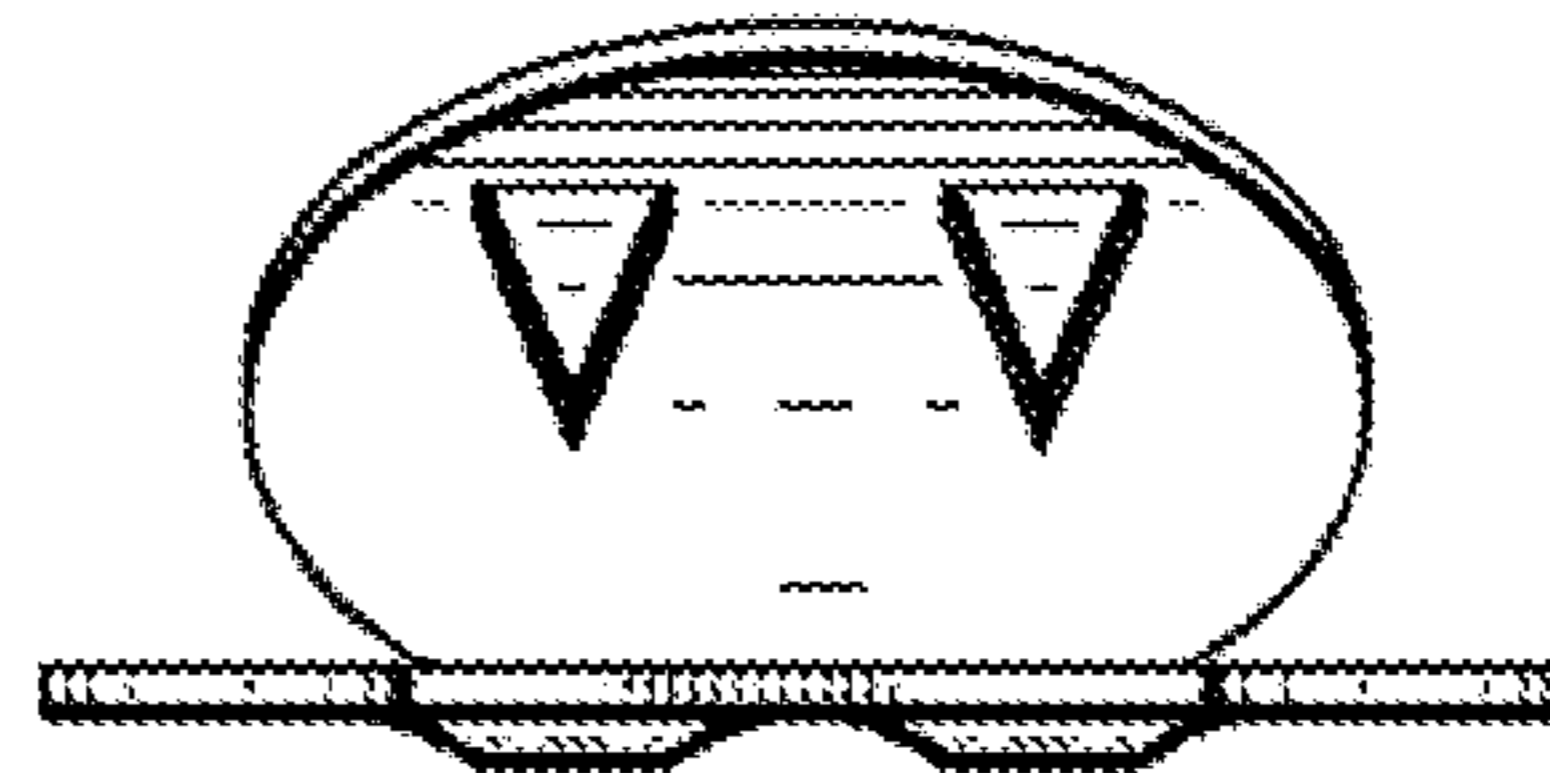

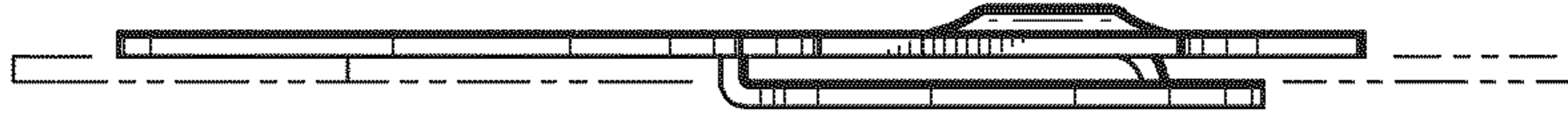
