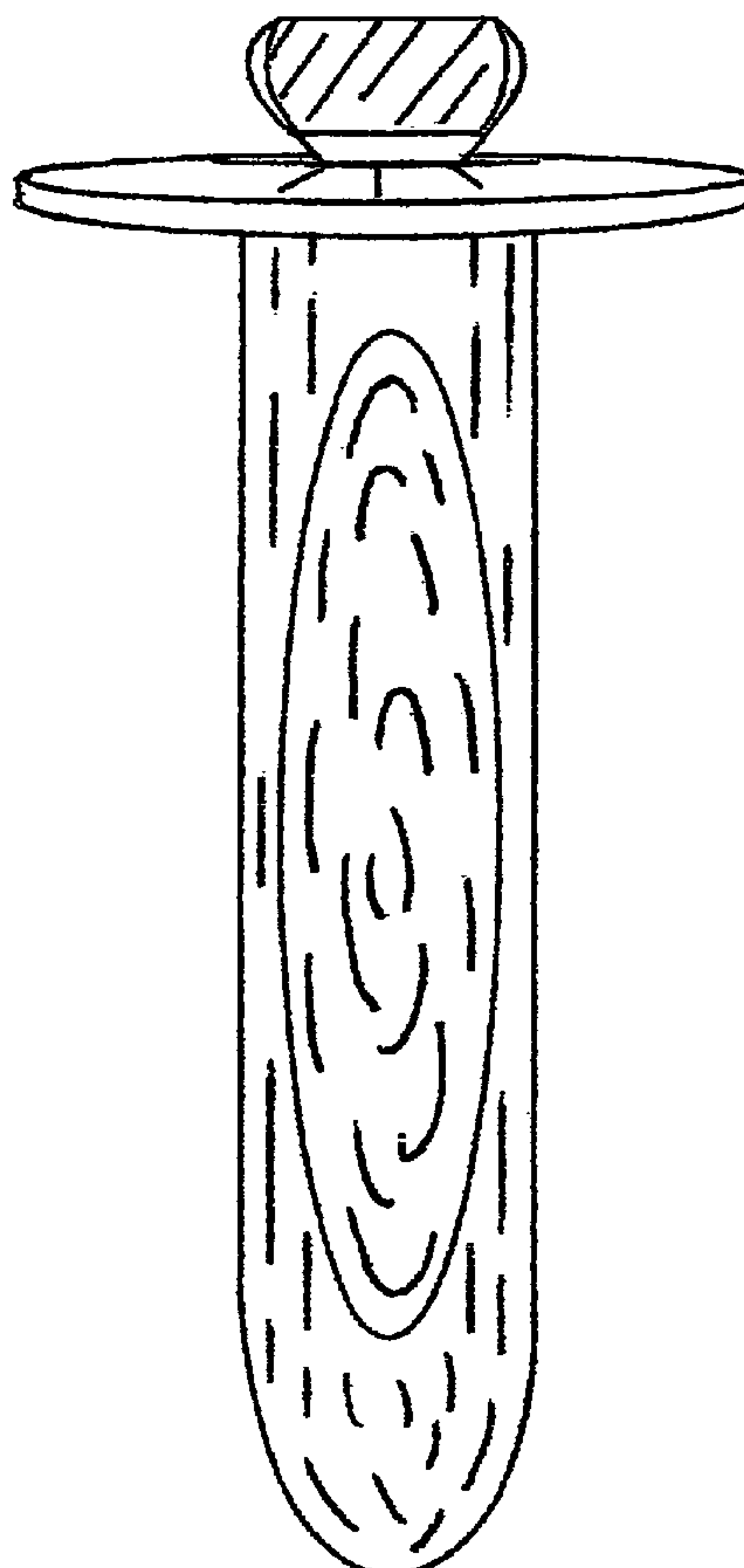
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view showing my new design;
FIG. 2 is a side elevational view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a cross-sectional view taken along lines 6—6 of FIG. 3 with the guard portion removed for ease of illustration; and,

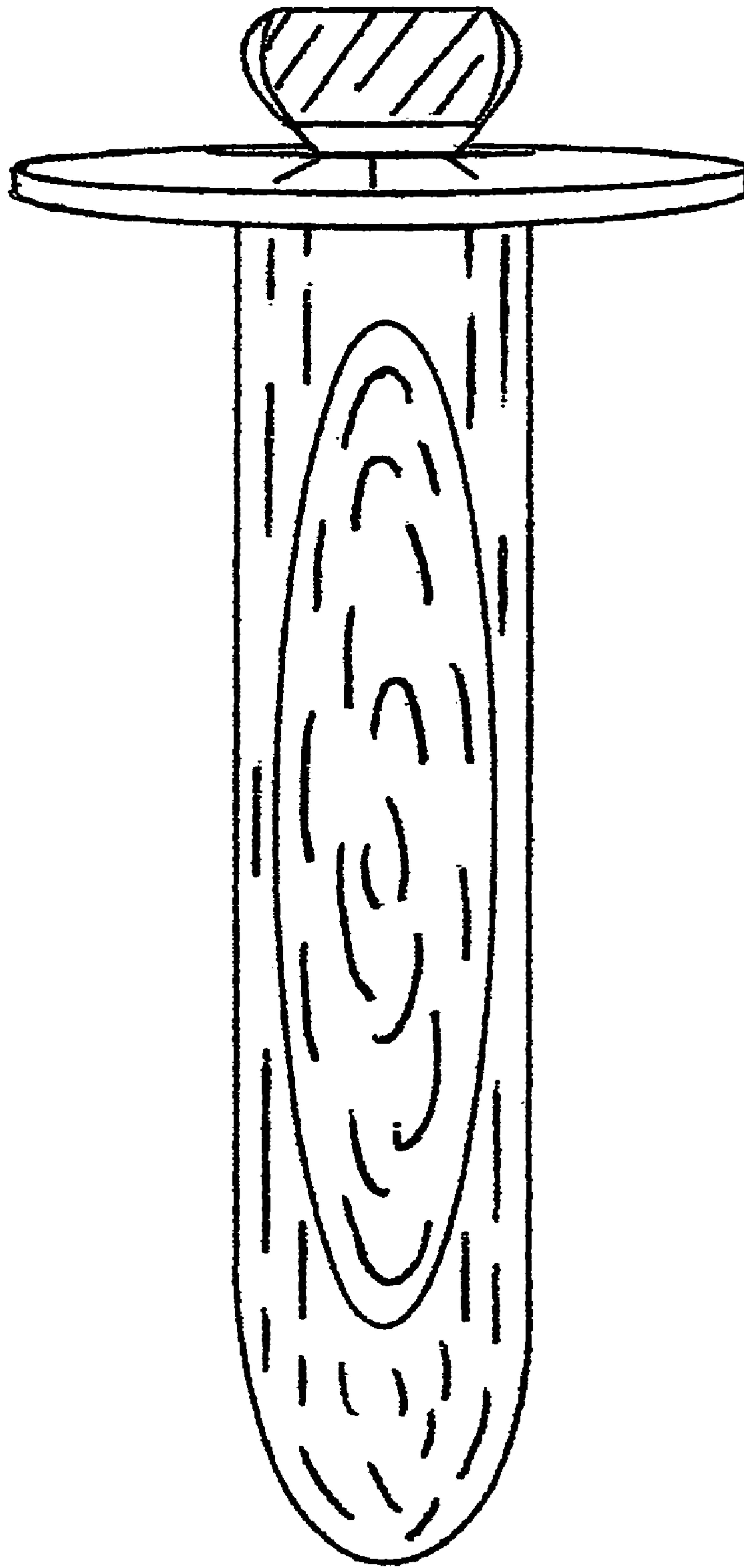

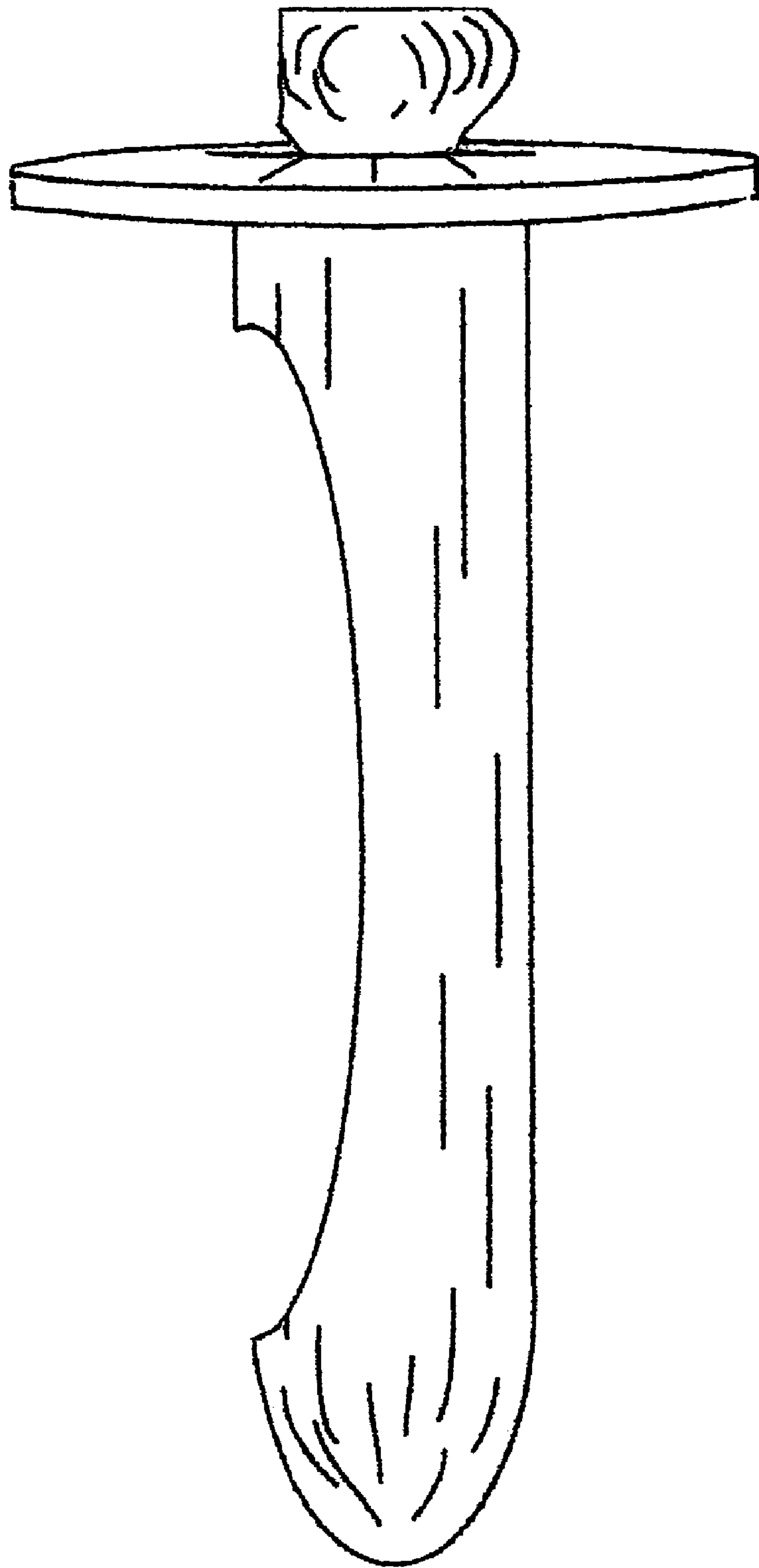

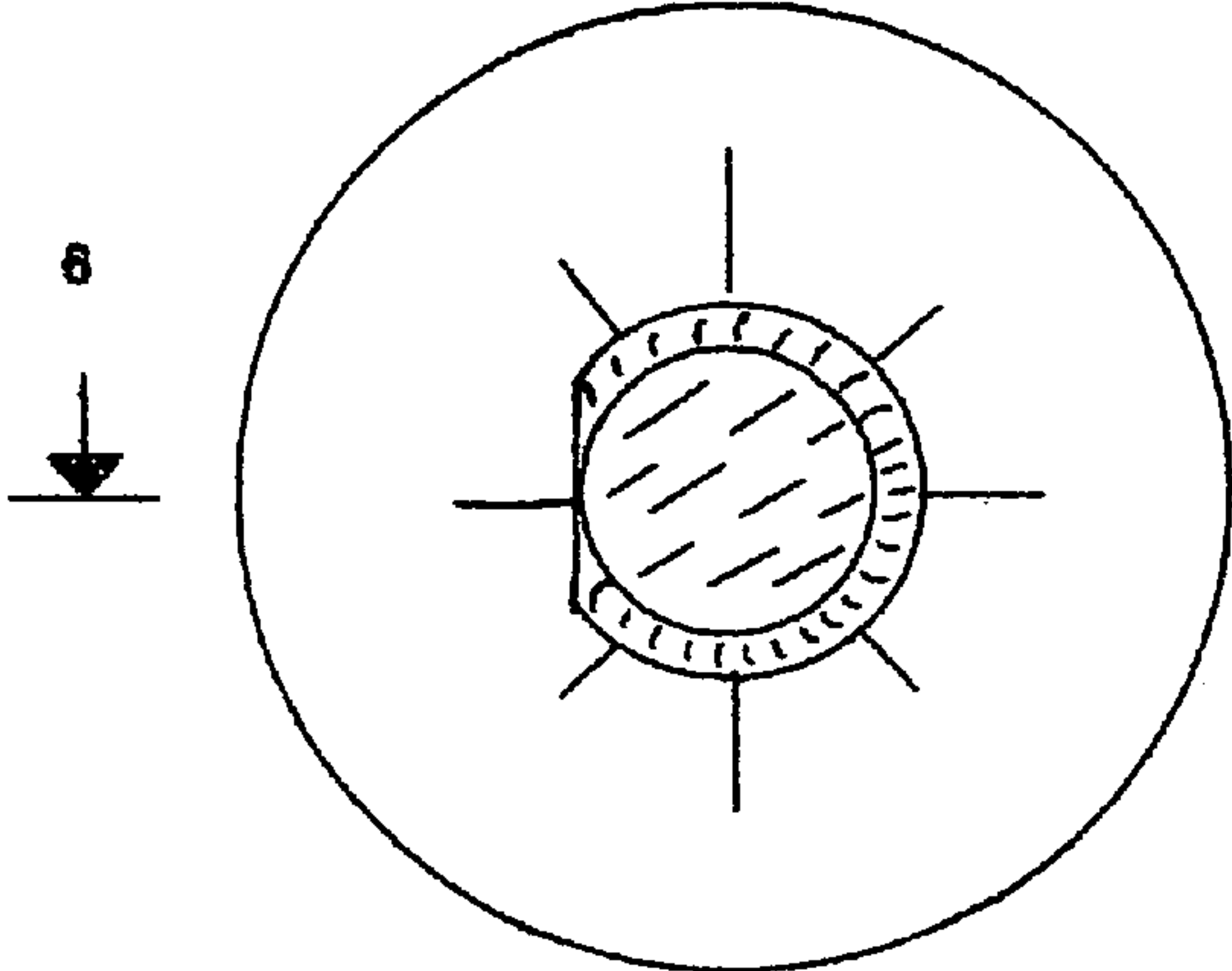

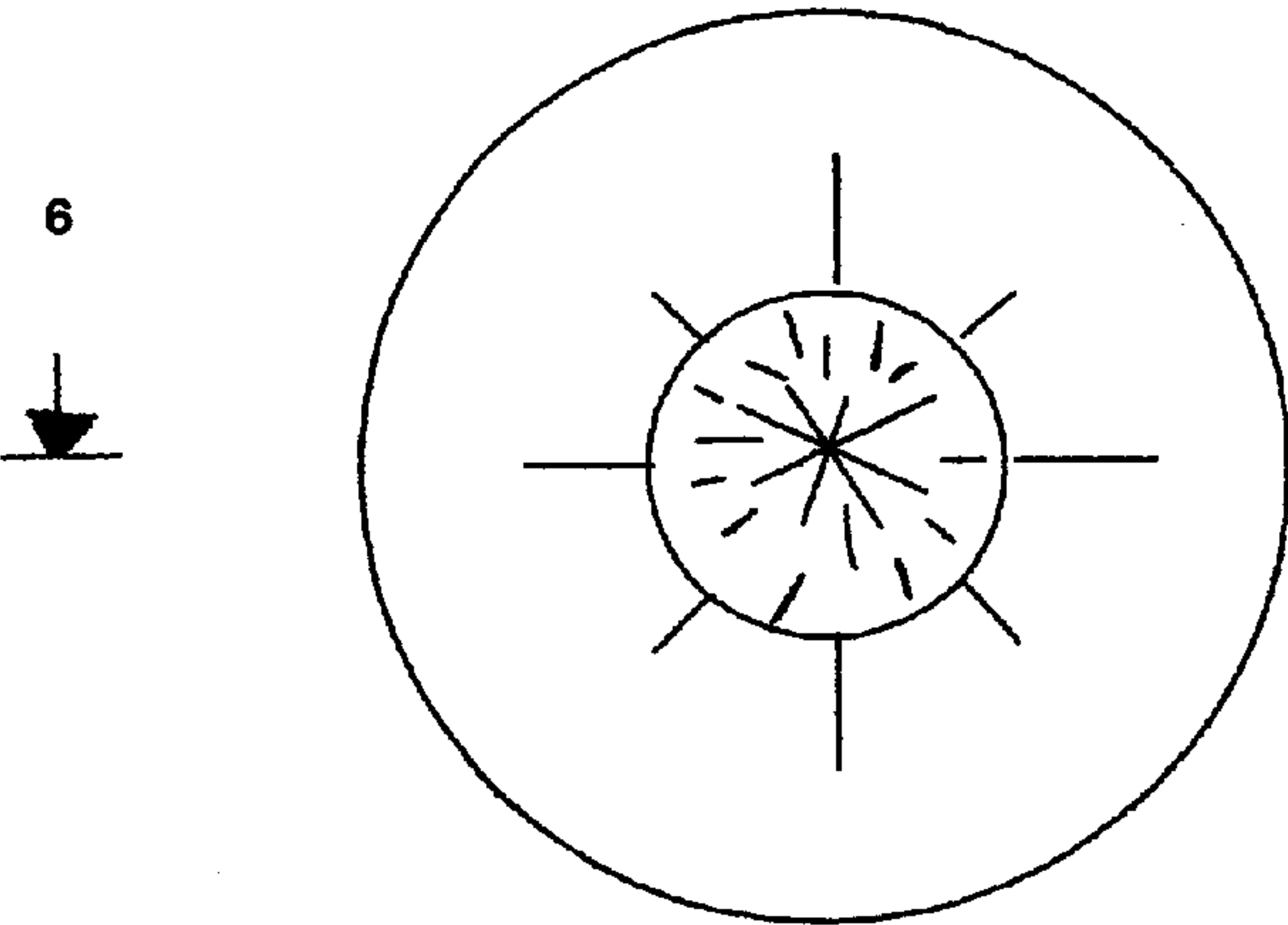

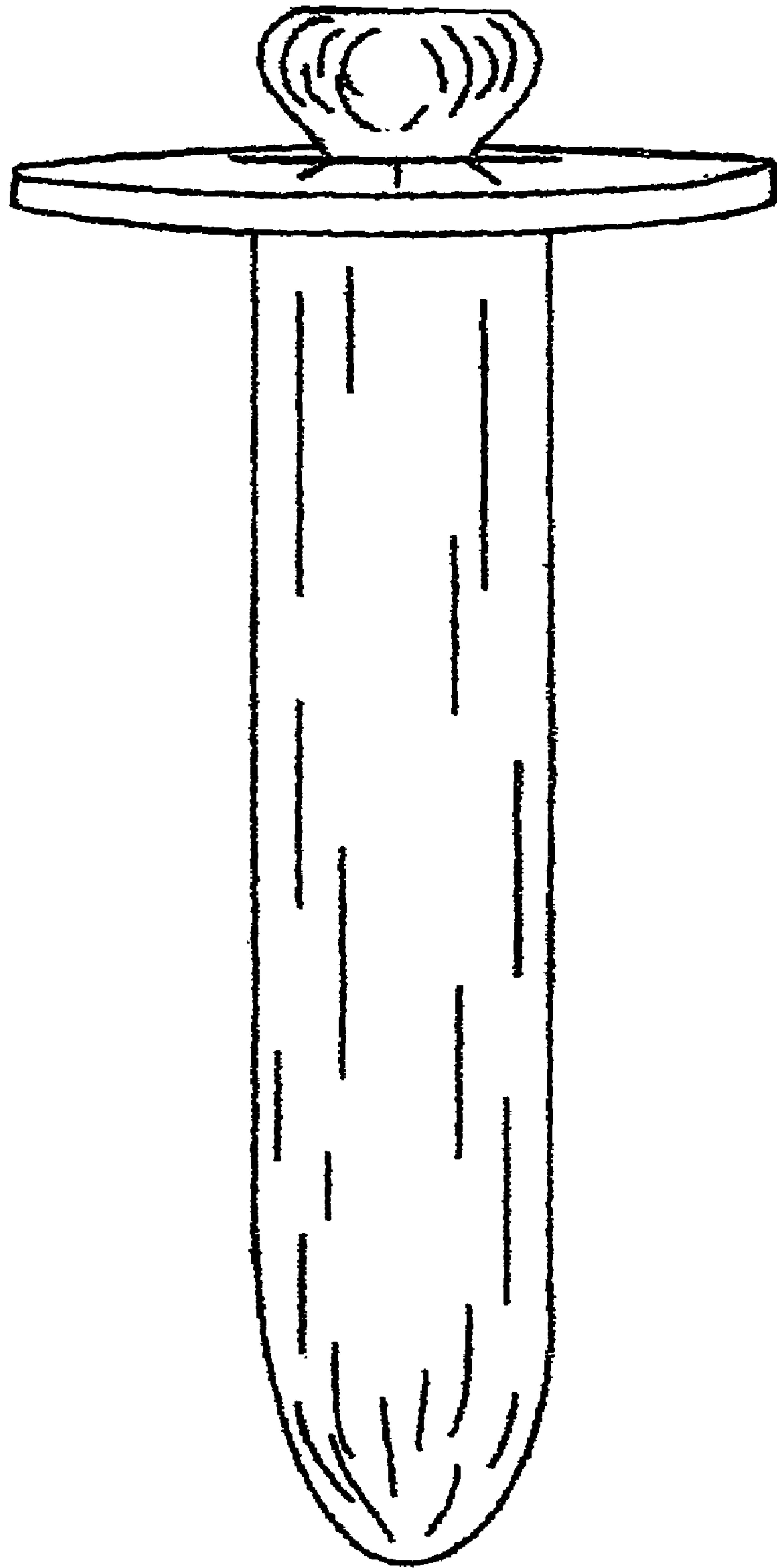

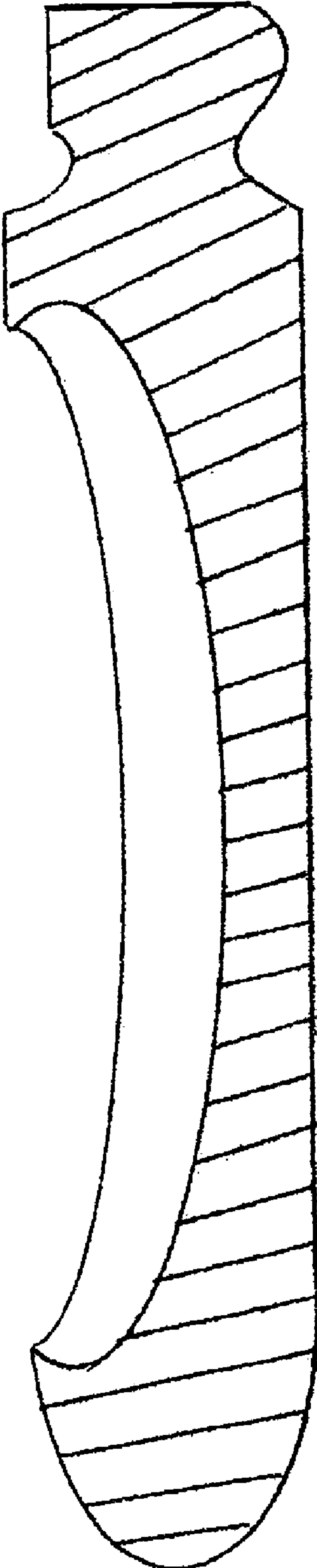

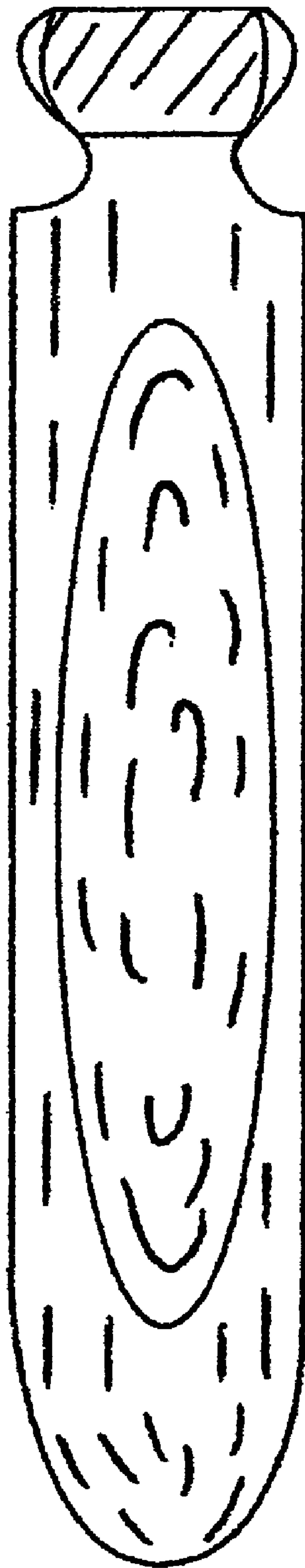
