(57) **CLAIM**

The ornamental design for a sanitary wall base having an inclined corner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the sanitary wall base having an inclined corner according to the invention;

FIG. 2 is a top view of the sanitary wall base having an inclined corner as shown in FIG. 1;

FIG. 3 is a front view of the sanitary wall base having an inclined corner as shown in FIG. 1;

FIG. 4 is a side view of the sanitary wall base having an inclined corner as shown in FIG. 1;

FIG. 5 is a rear view of the sanitary wall base having an inclined corner as shown in FIG. 1;

FIG. 6 is side view of the sanitary wall base having an inclined corner as shown in FIG. 1, shown from the opposite side as that shown in FIG. 4; and,

FIG. 7 is a bottom view of the sanitary wall base having an inclined corner as shown in FIG. 1.

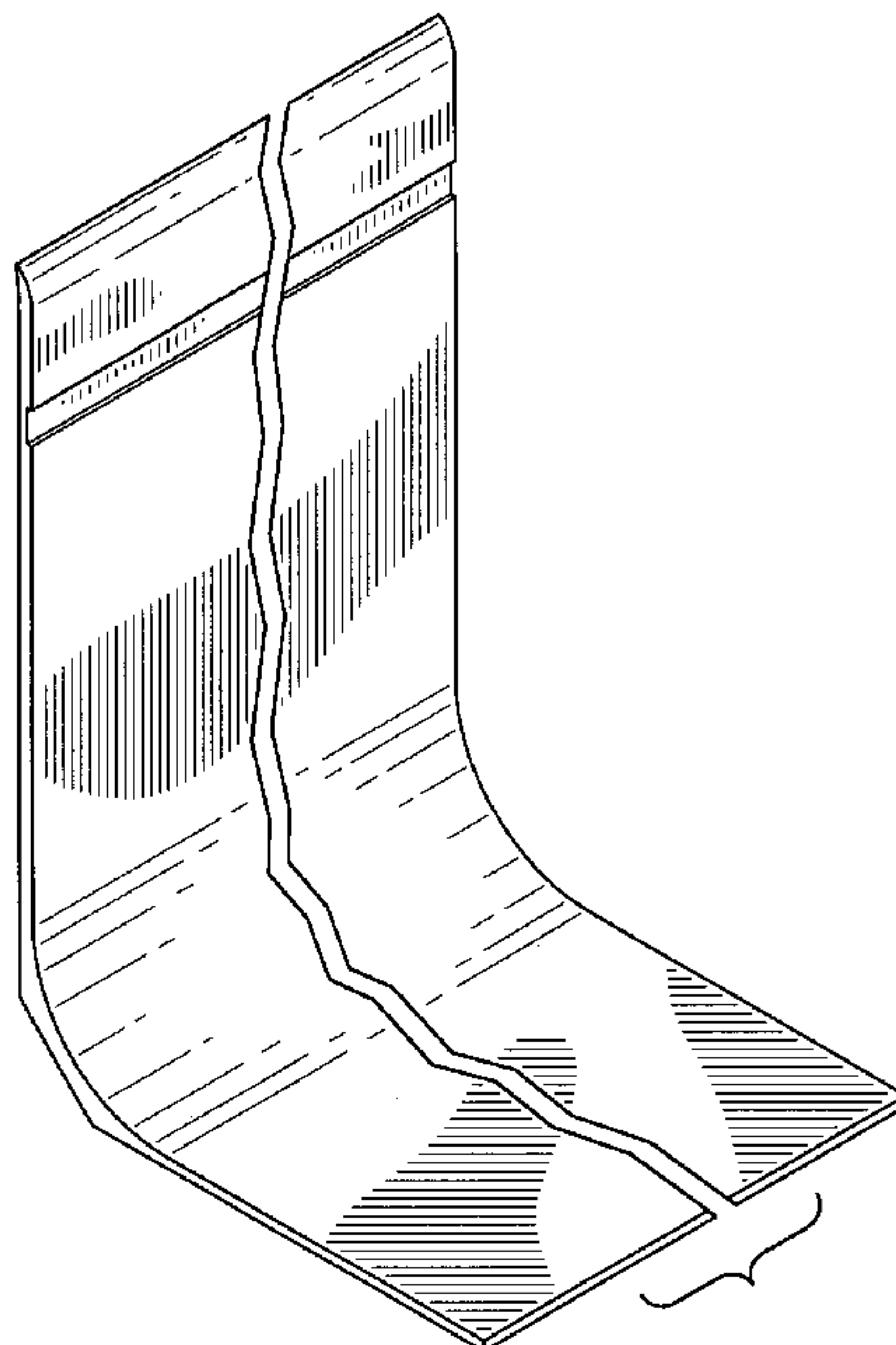

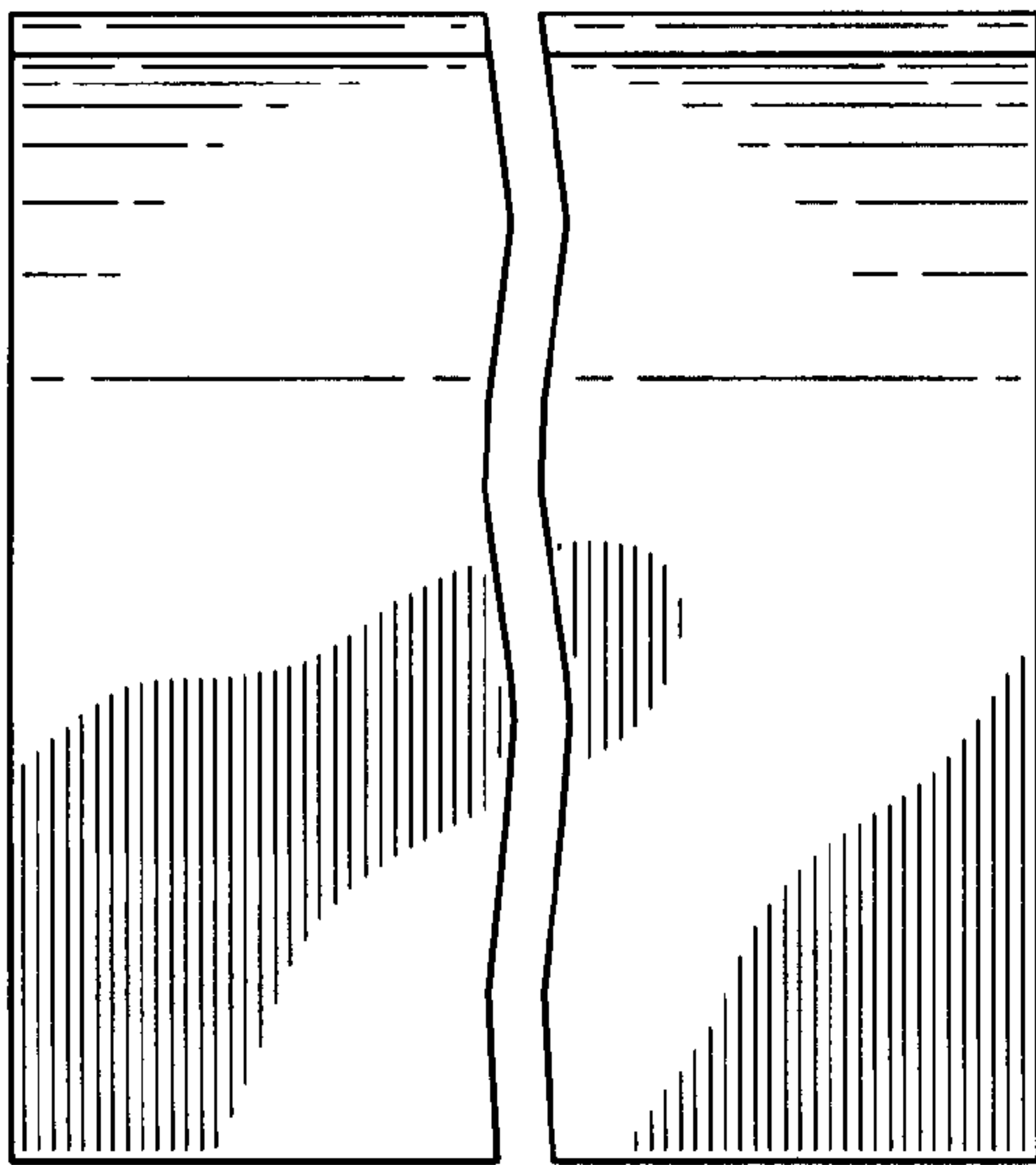

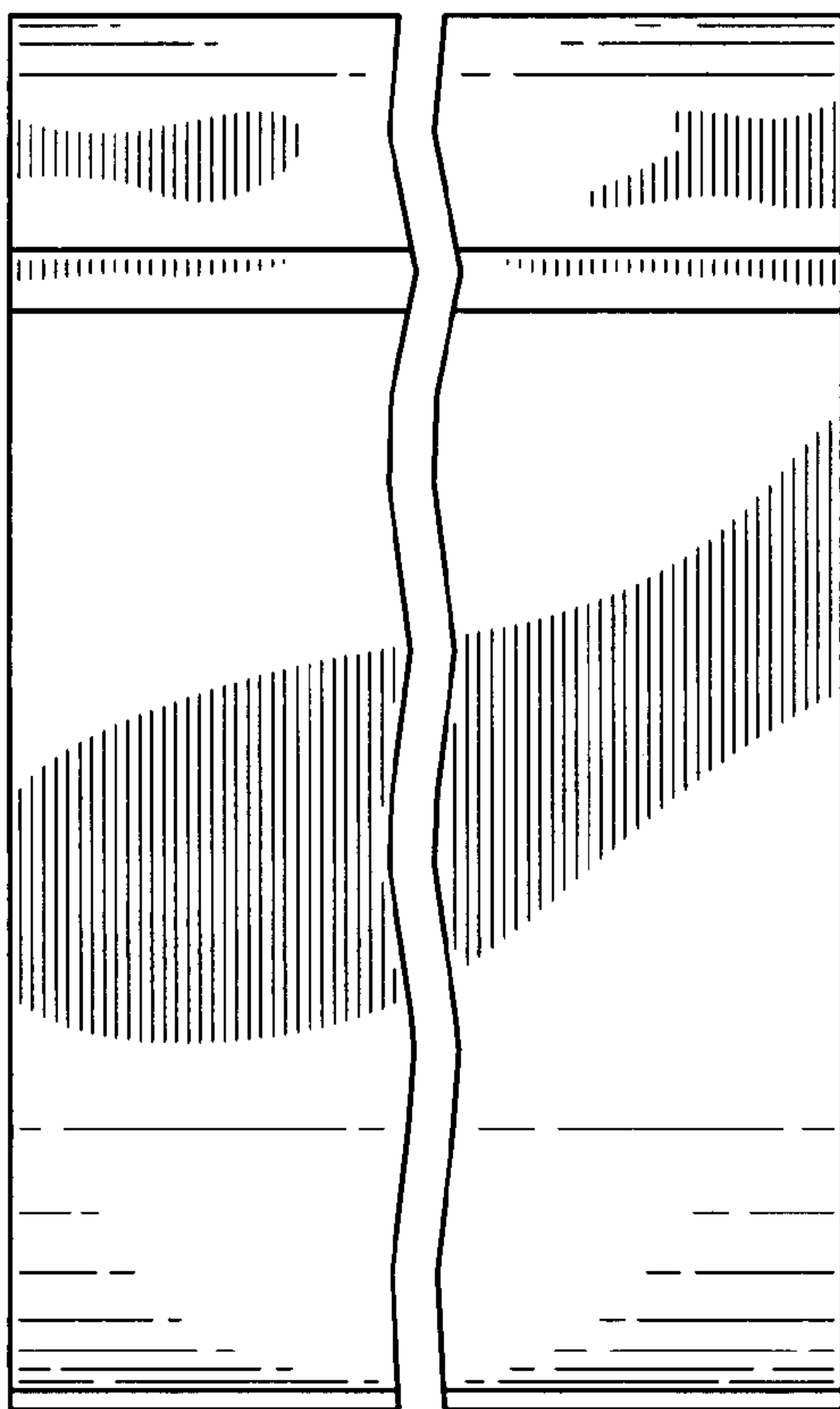

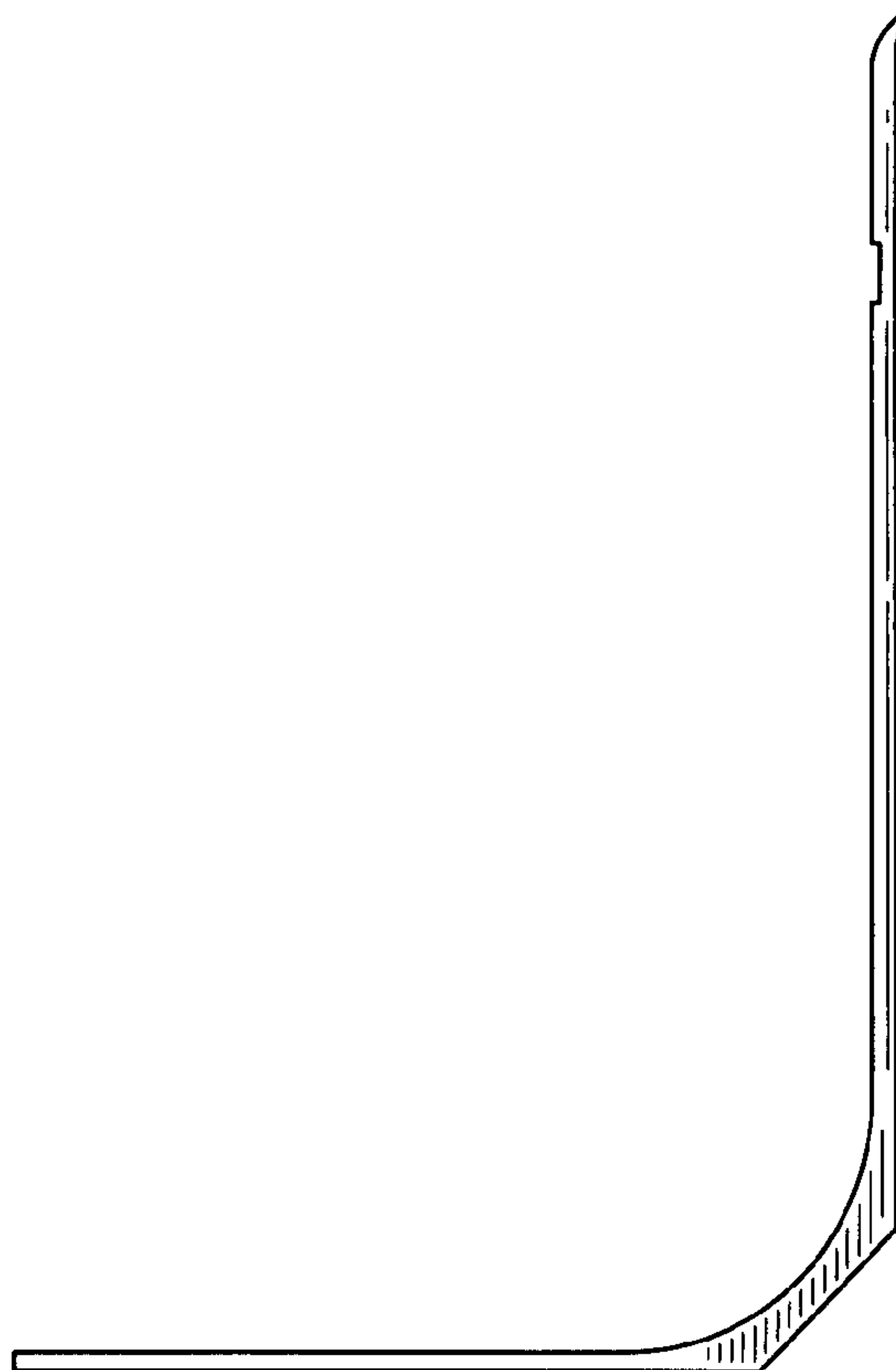

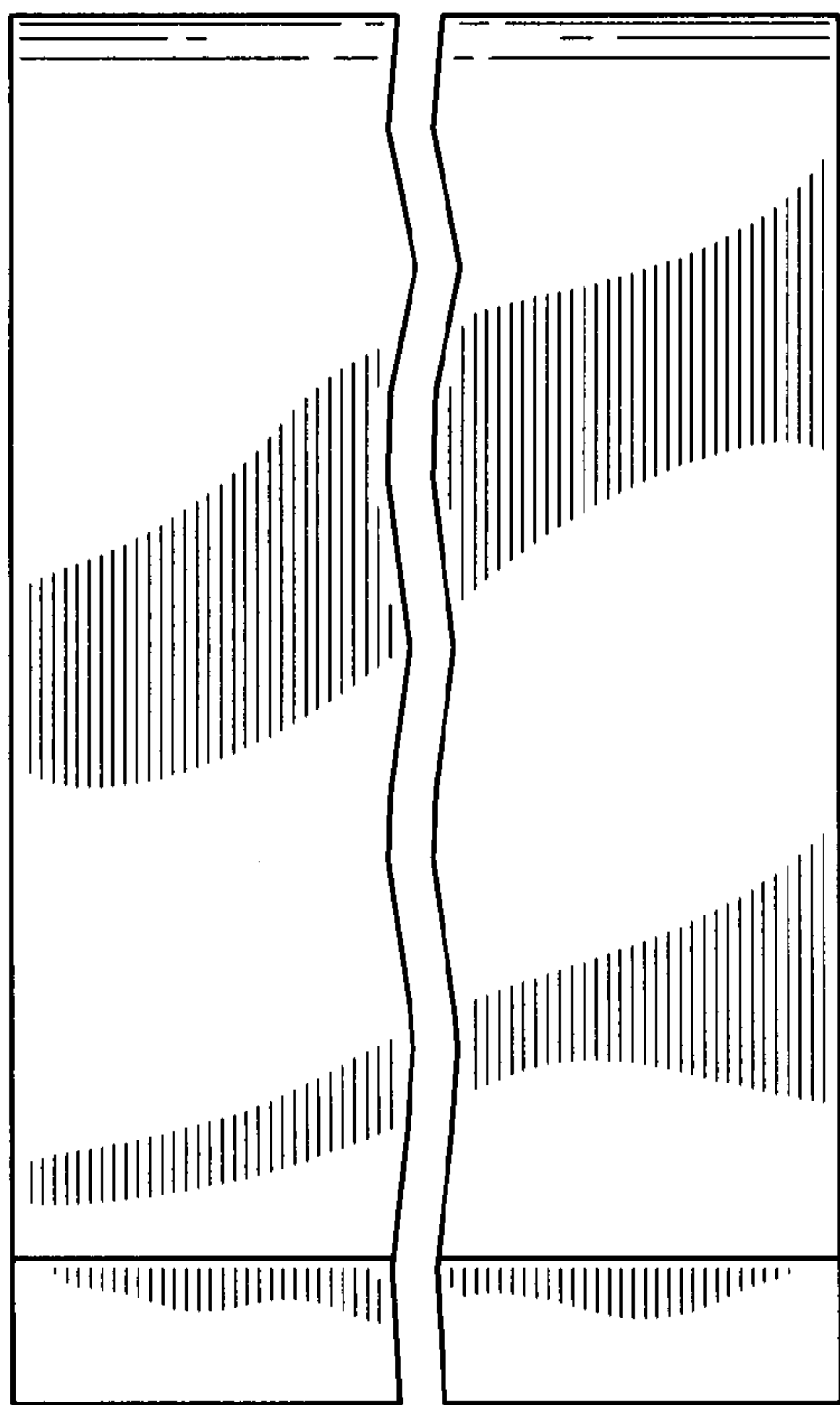

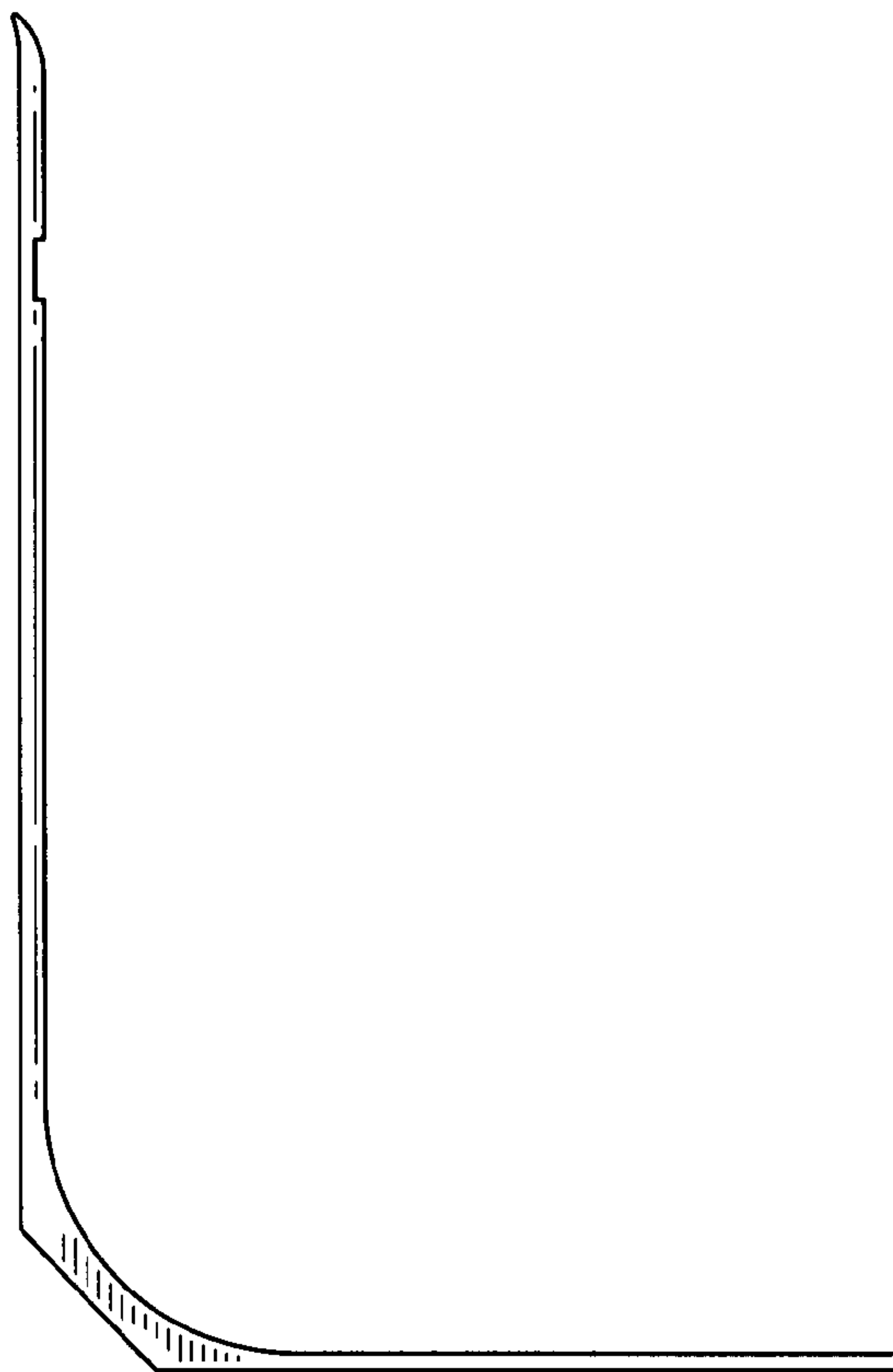

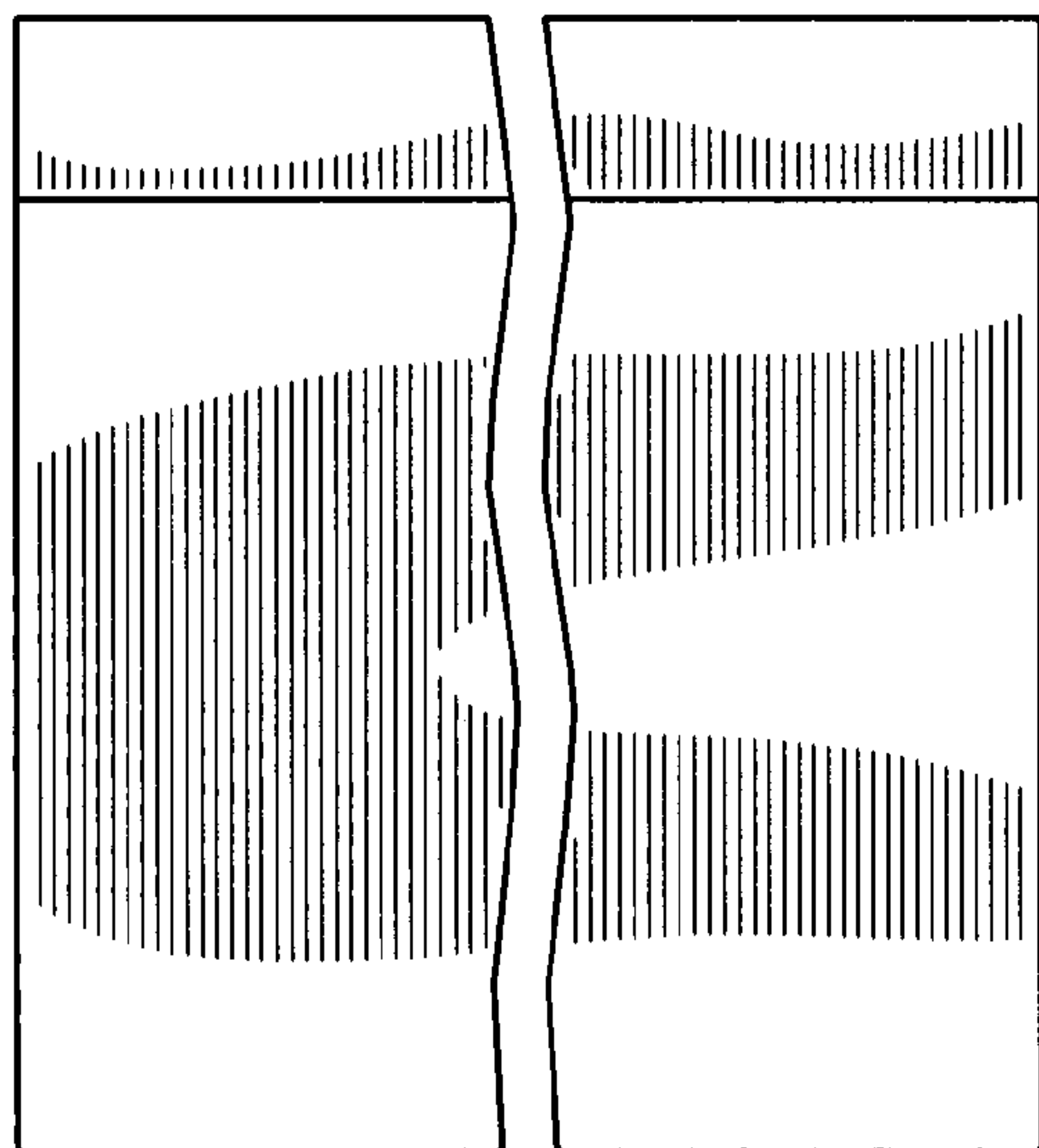
