(57) **CLAIM**

The ornamental design for a roof tile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective upper view of a roof tile according to the present design;

FIG. 2 is an elevational view of the left side of the roof tile shown in FIG. 1;

FIG. 3 is an elevational view of the right side of the roof tile shown in FIG. 1;

FIG. 4 is an elevational view of the nose end of the roof tile shown in FIG. 1;


FIG. 5 is an elevational view of the head end of the roof tile shown in FIG. 1;

FIG. 6 is a top plan view of the roof tile shown in FIG. 1; and,














