FIG. 5 is an elevational view of the nose end of the roof tile shown in FIG. 1;

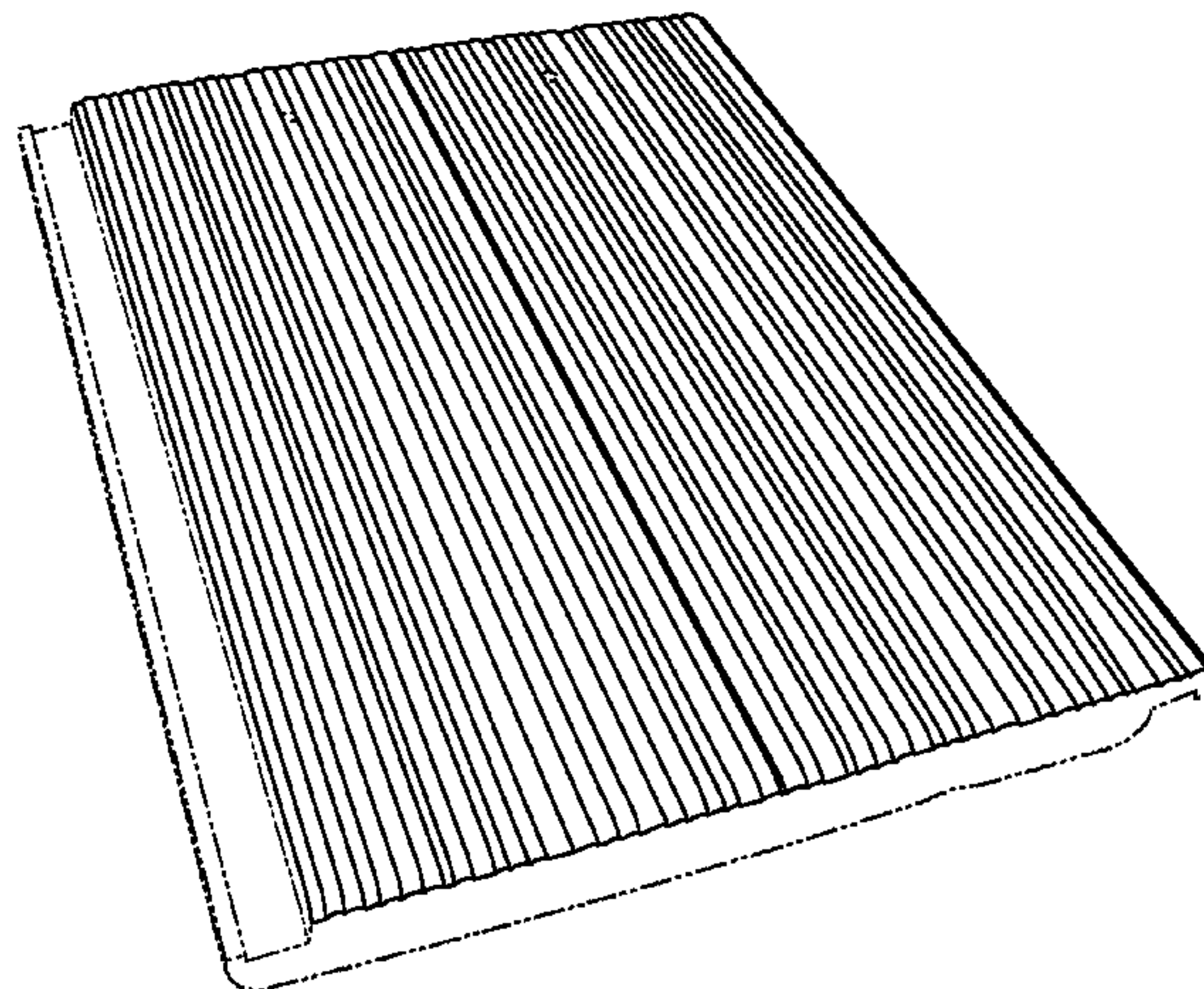
FIG. 6 is a top plan view of the roof tile shown in FIG. 1;

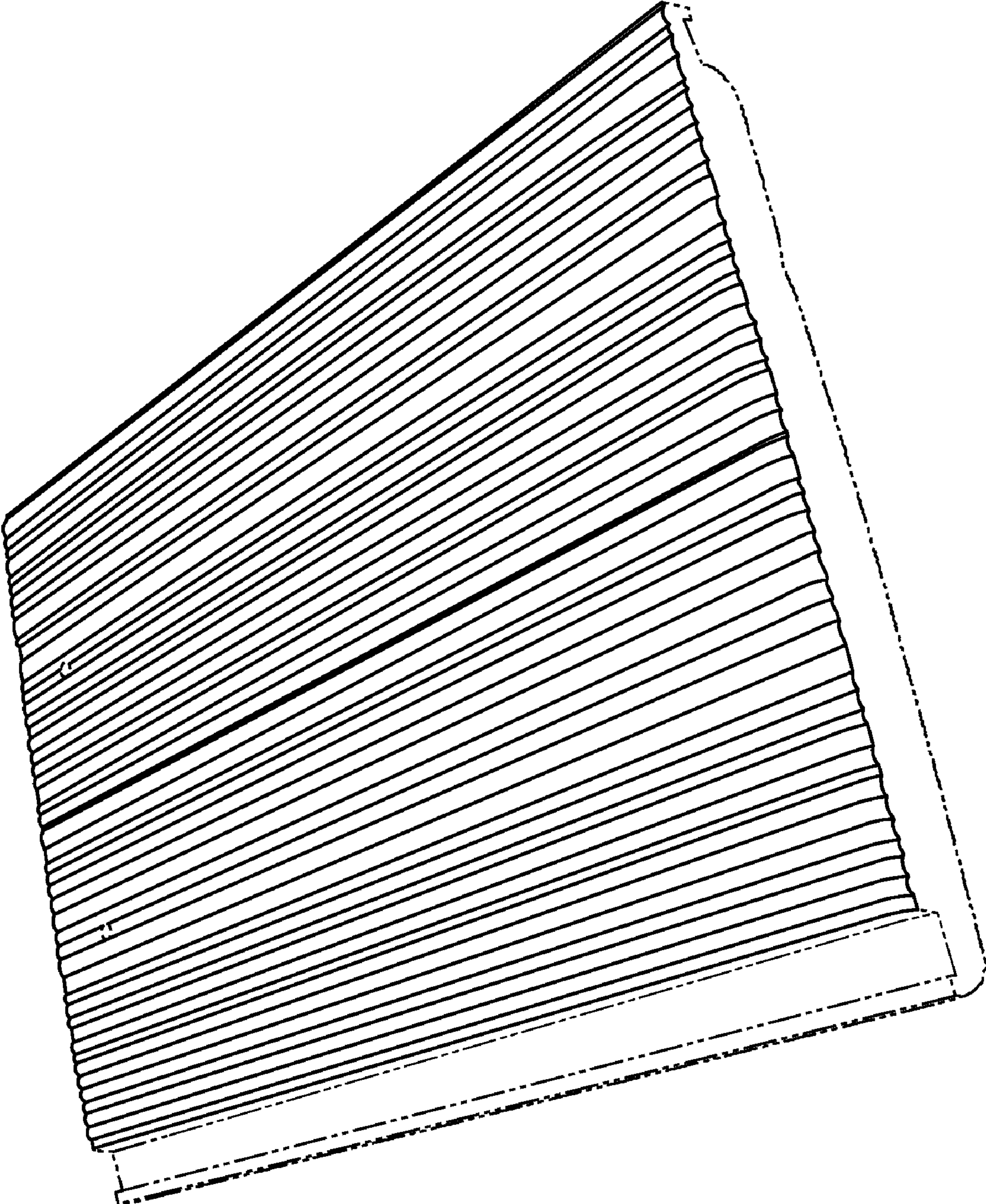

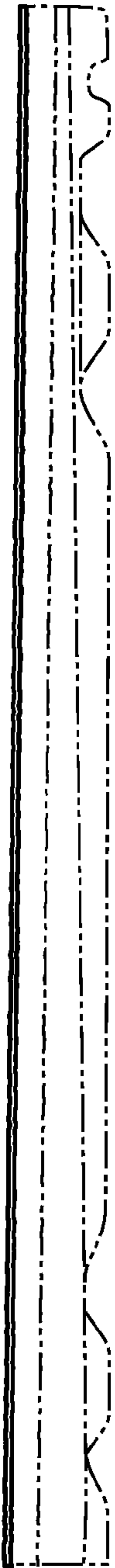

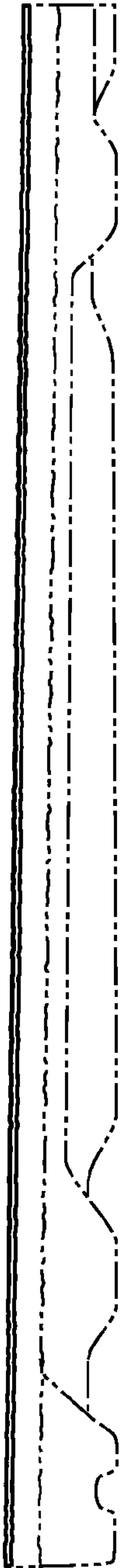

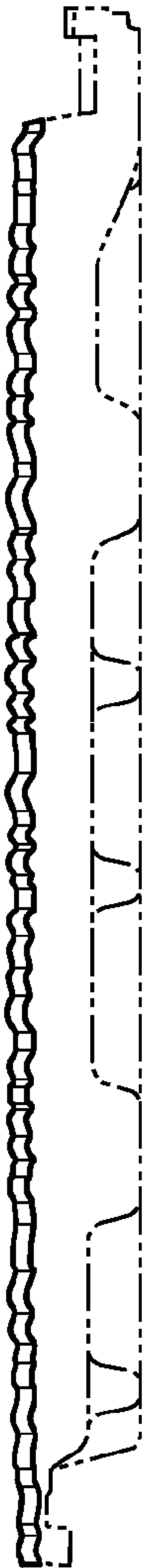

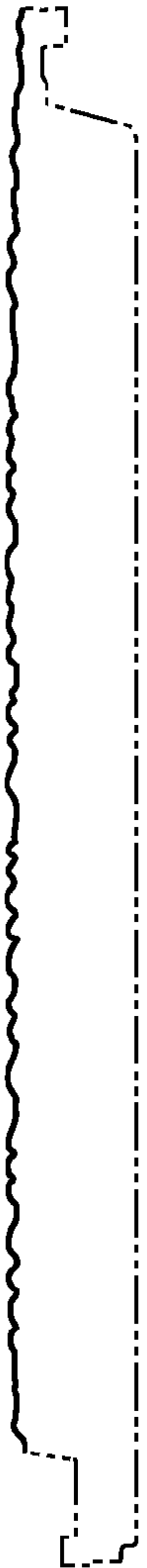
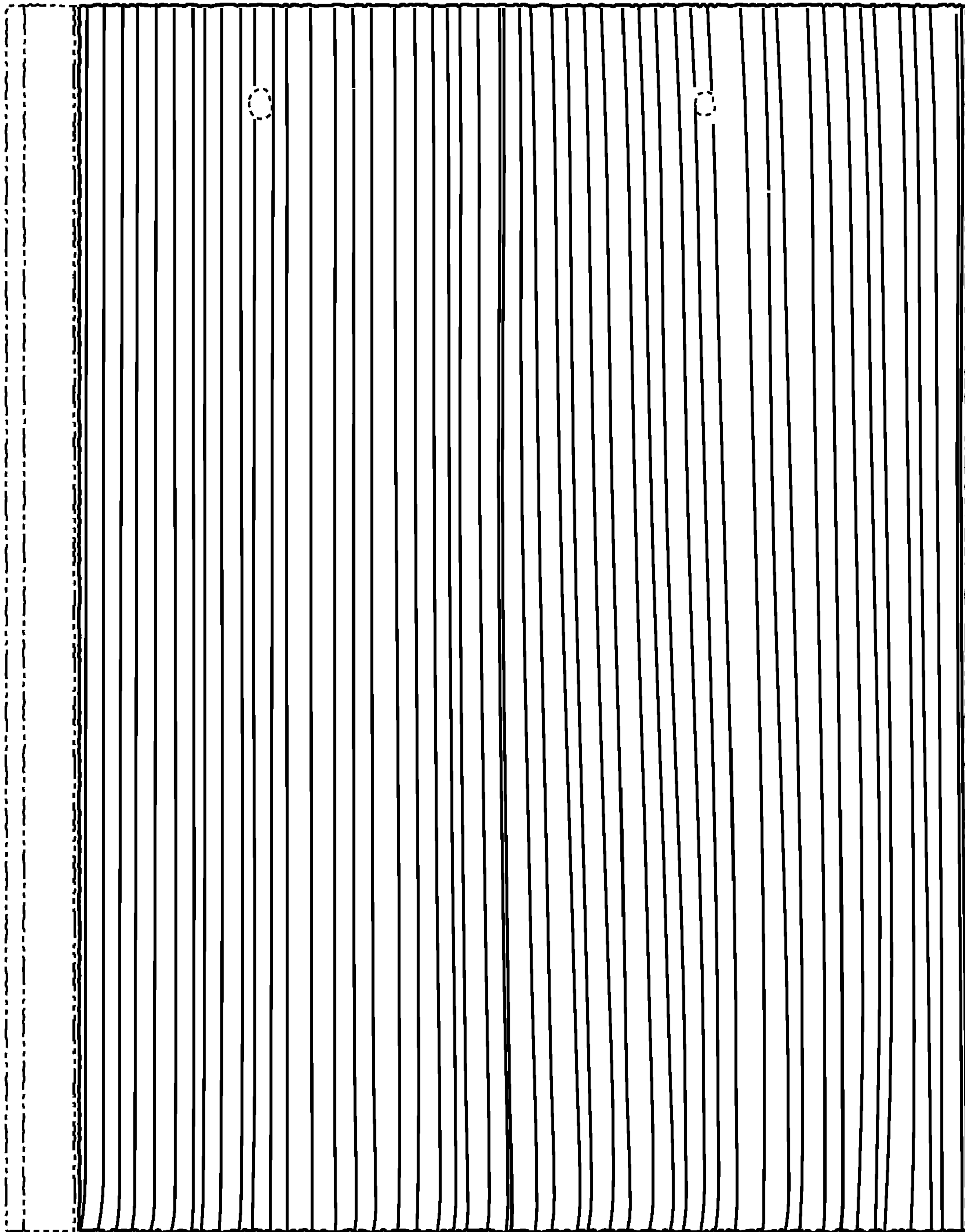
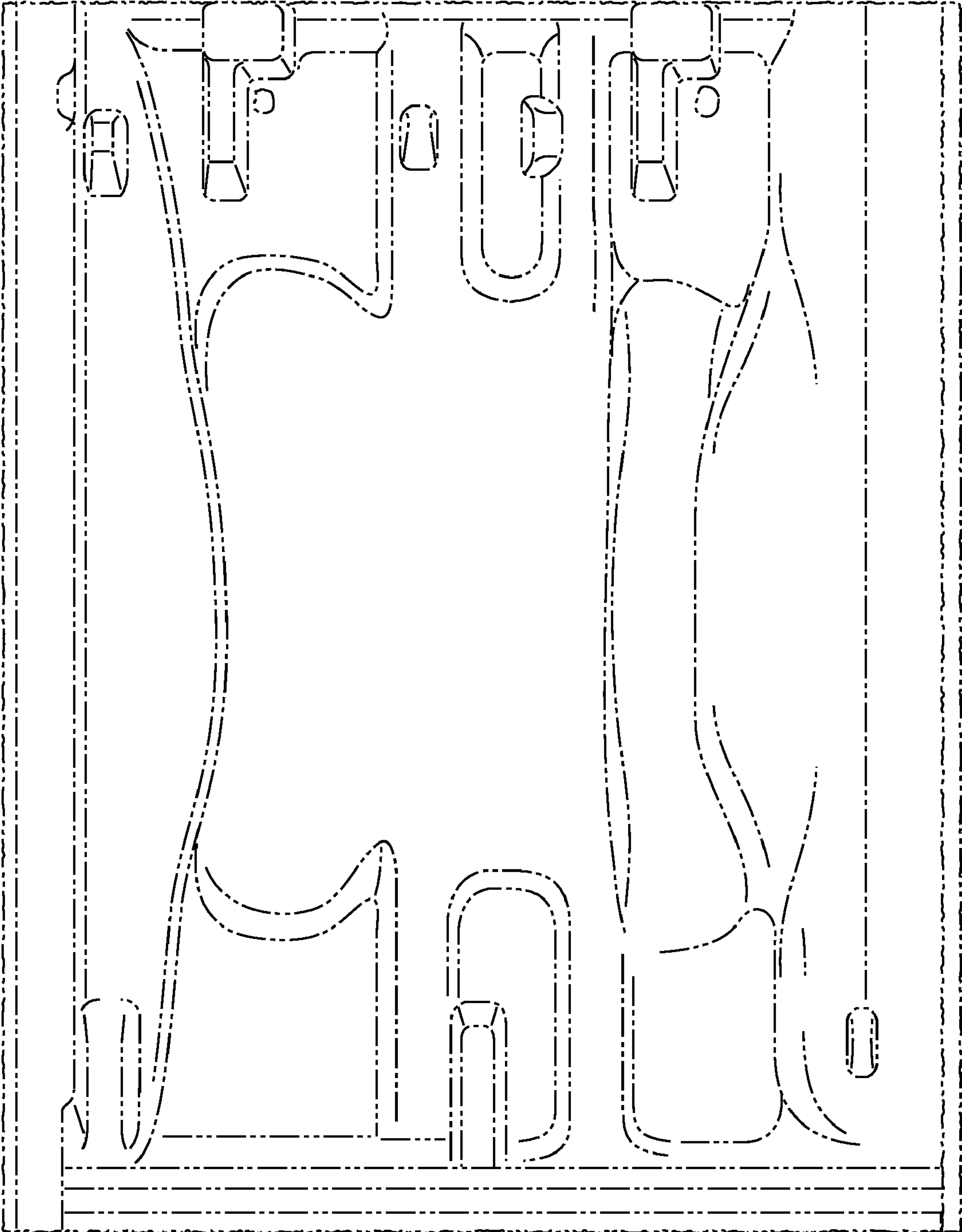

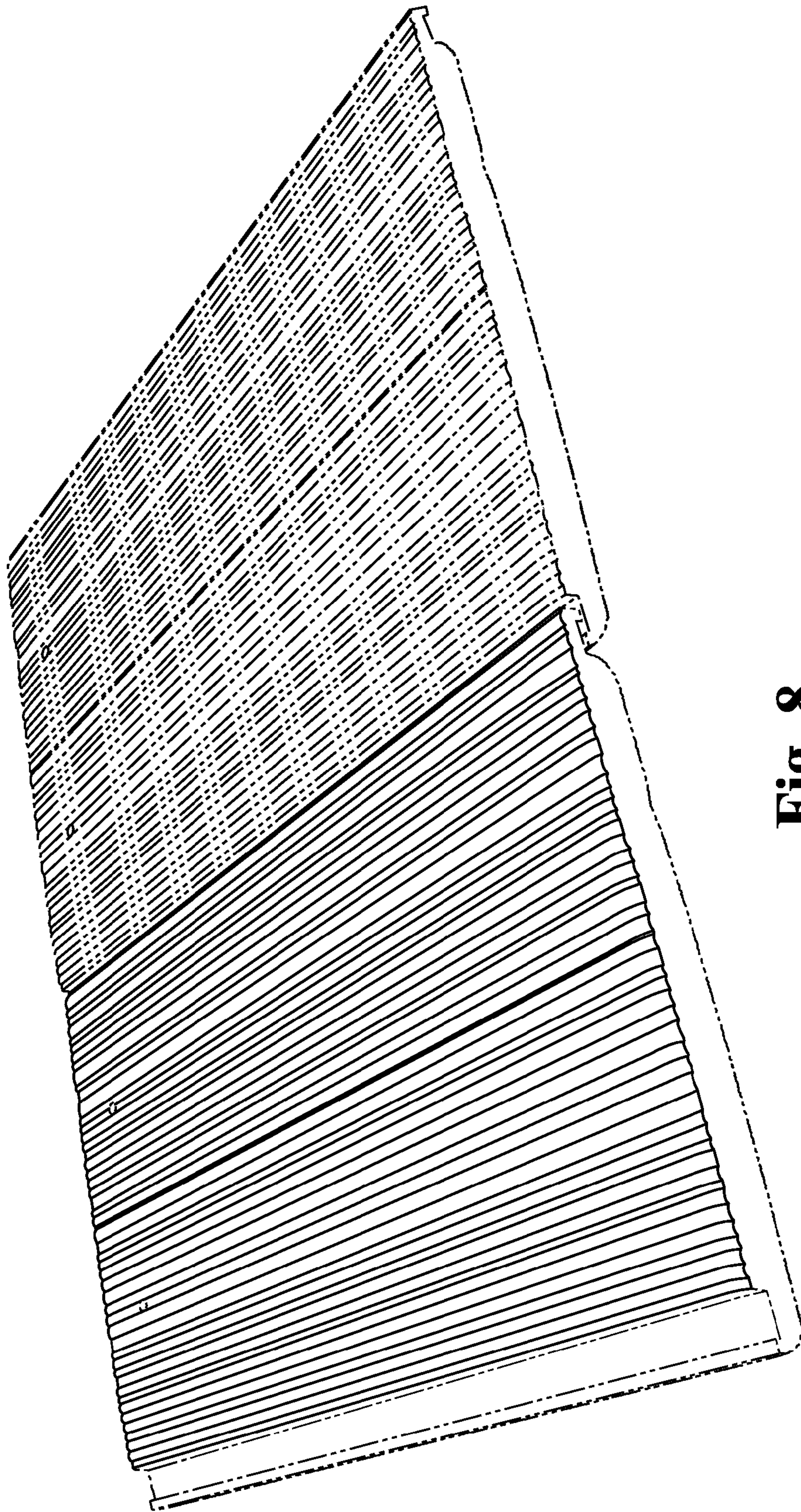
