FIG. 8 is a top left perspective view of the product of this design with the crank extended from its at rest position to its ready for use position.

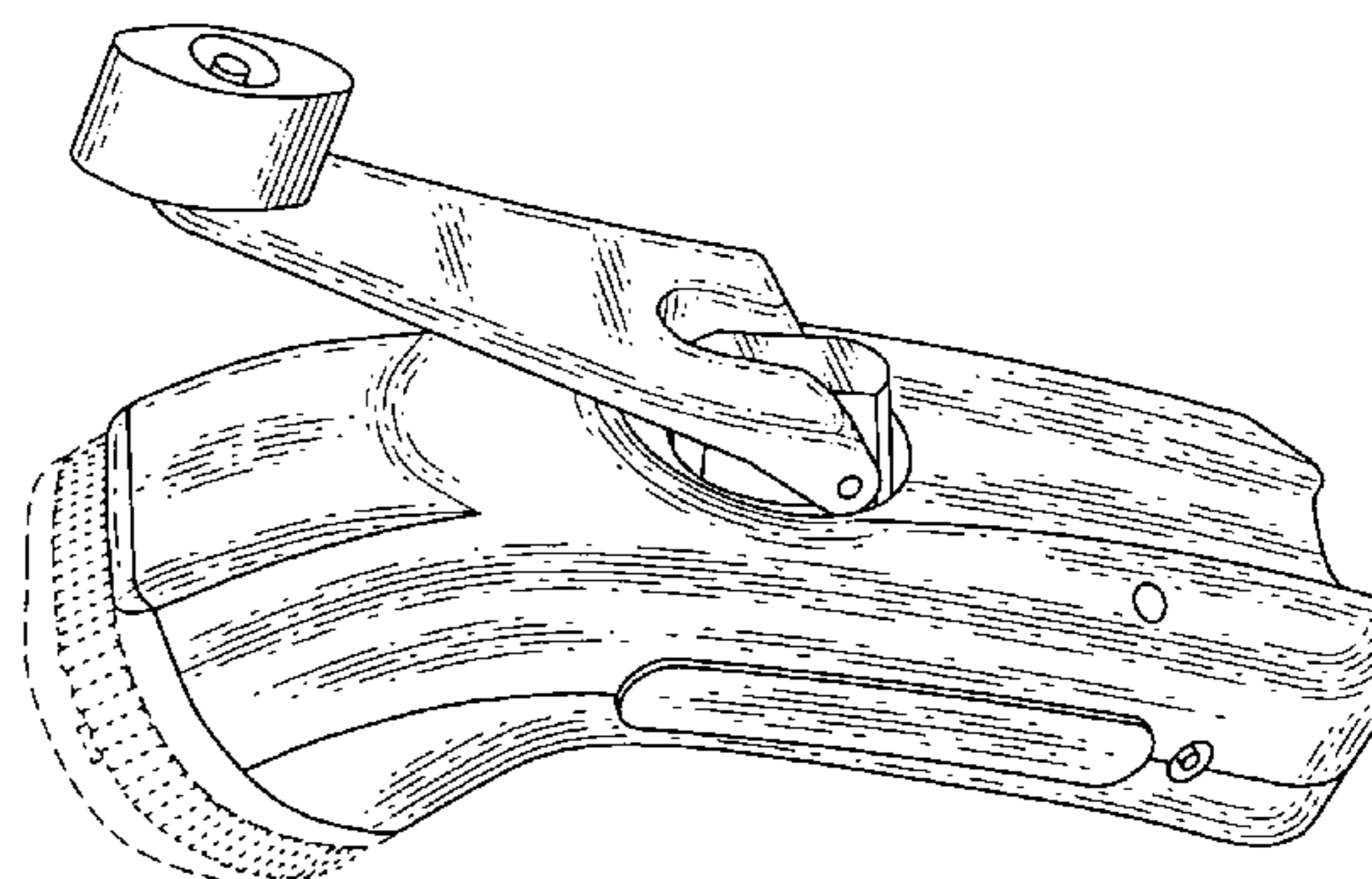
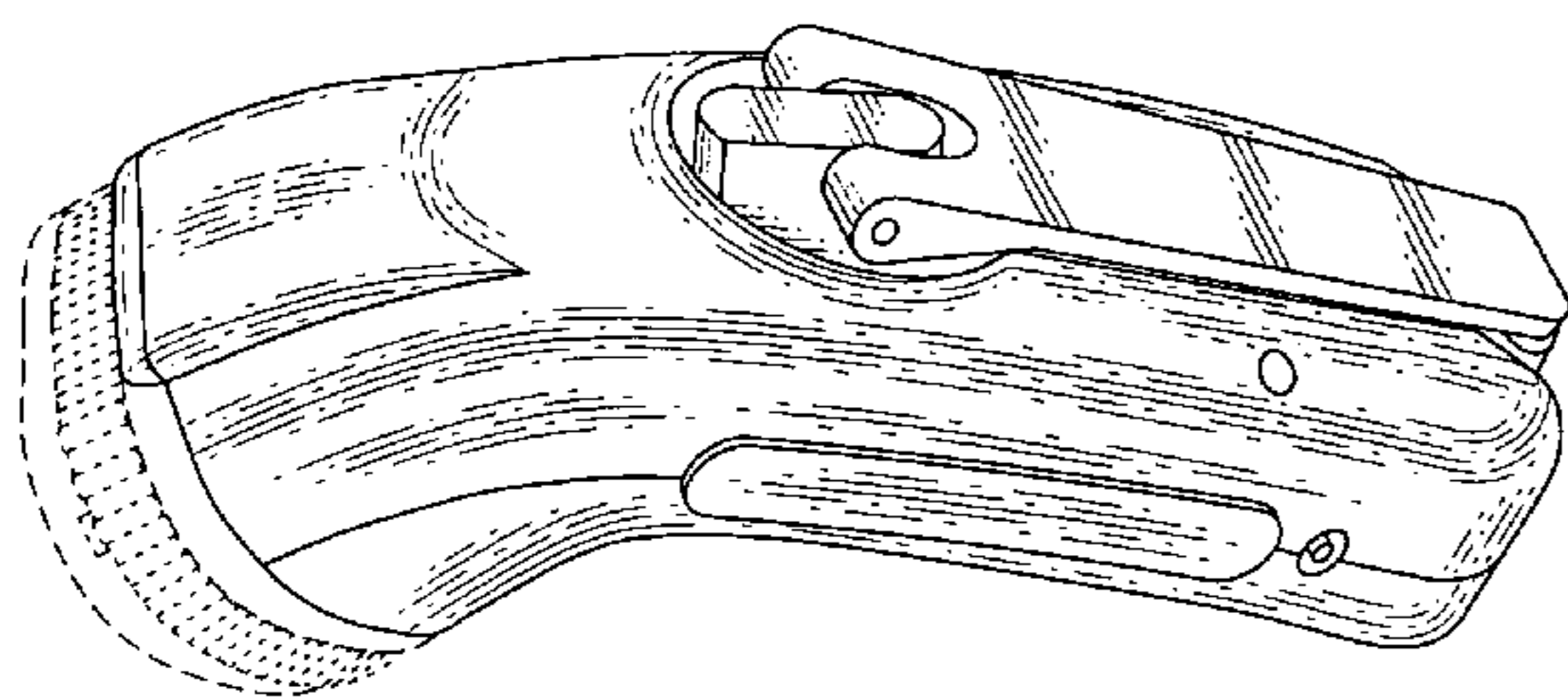

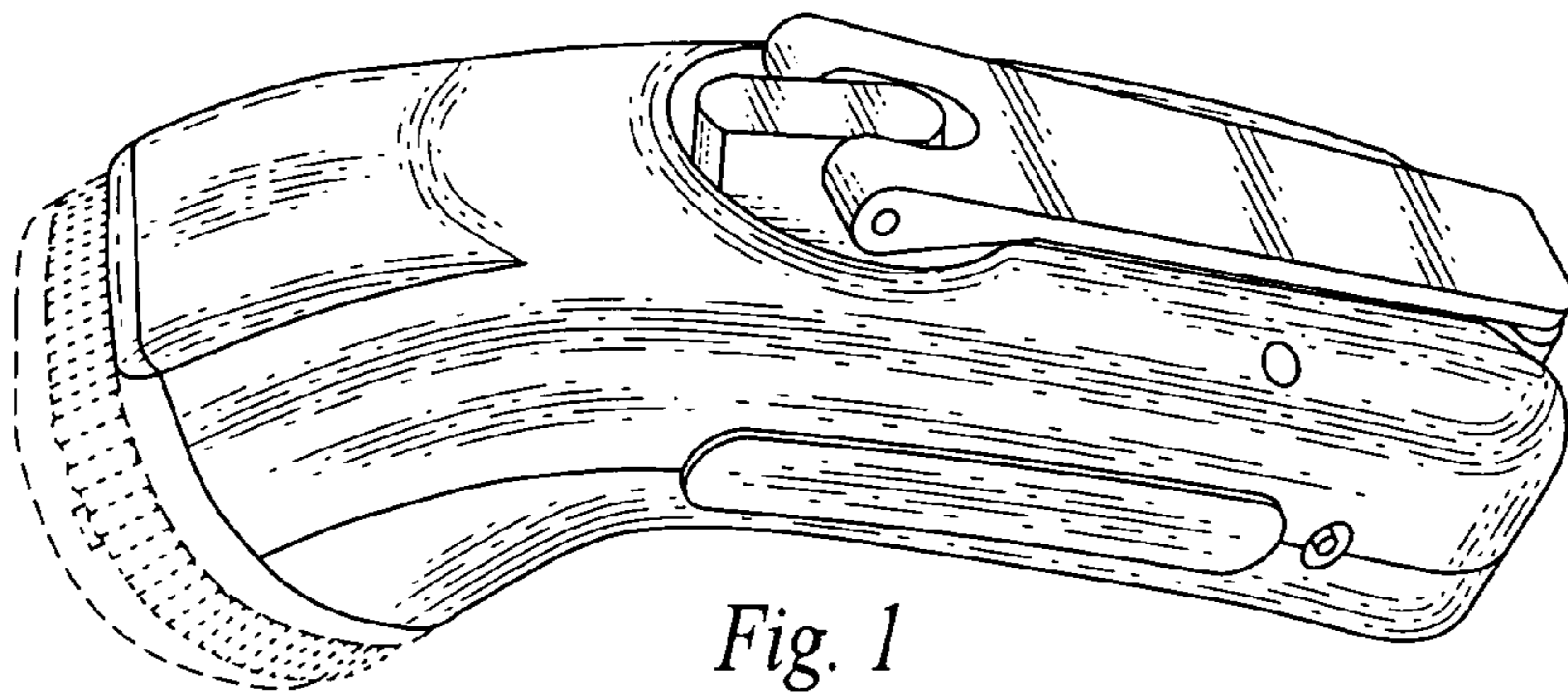

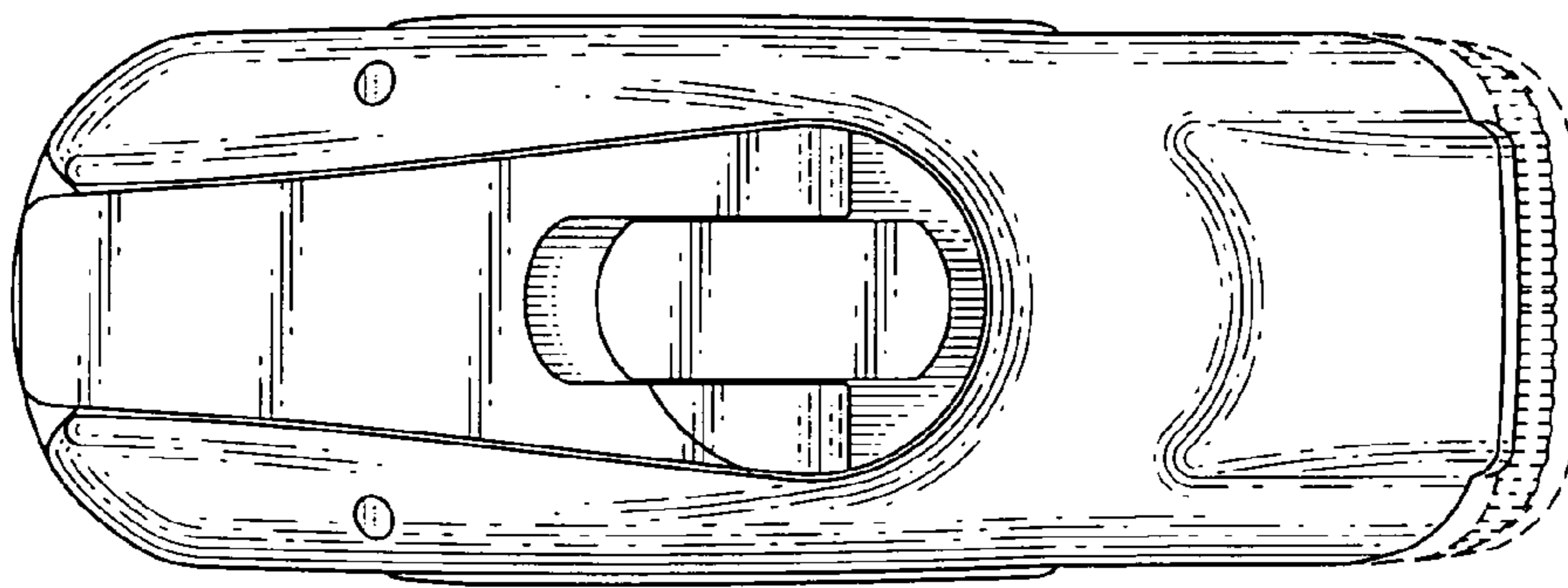

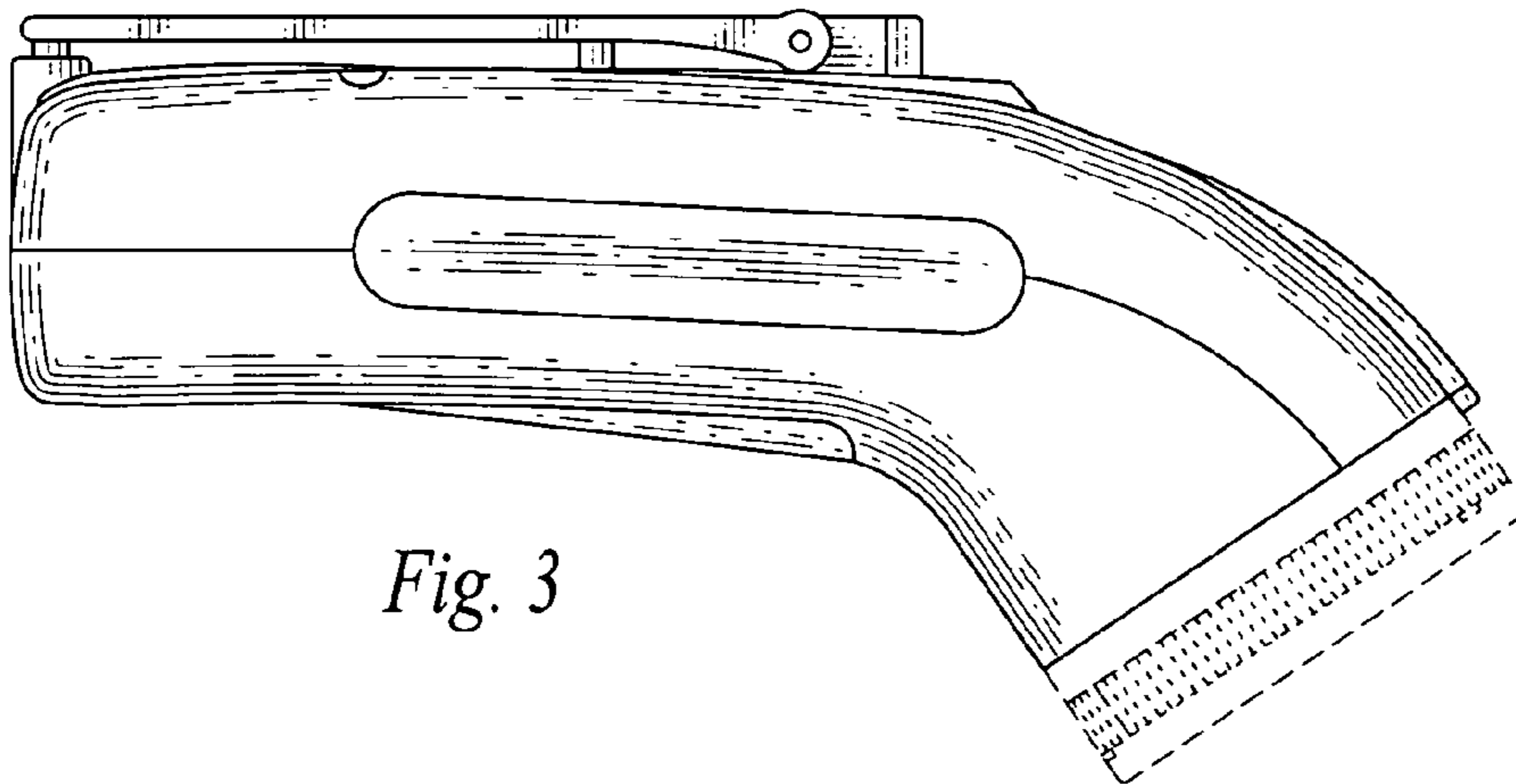




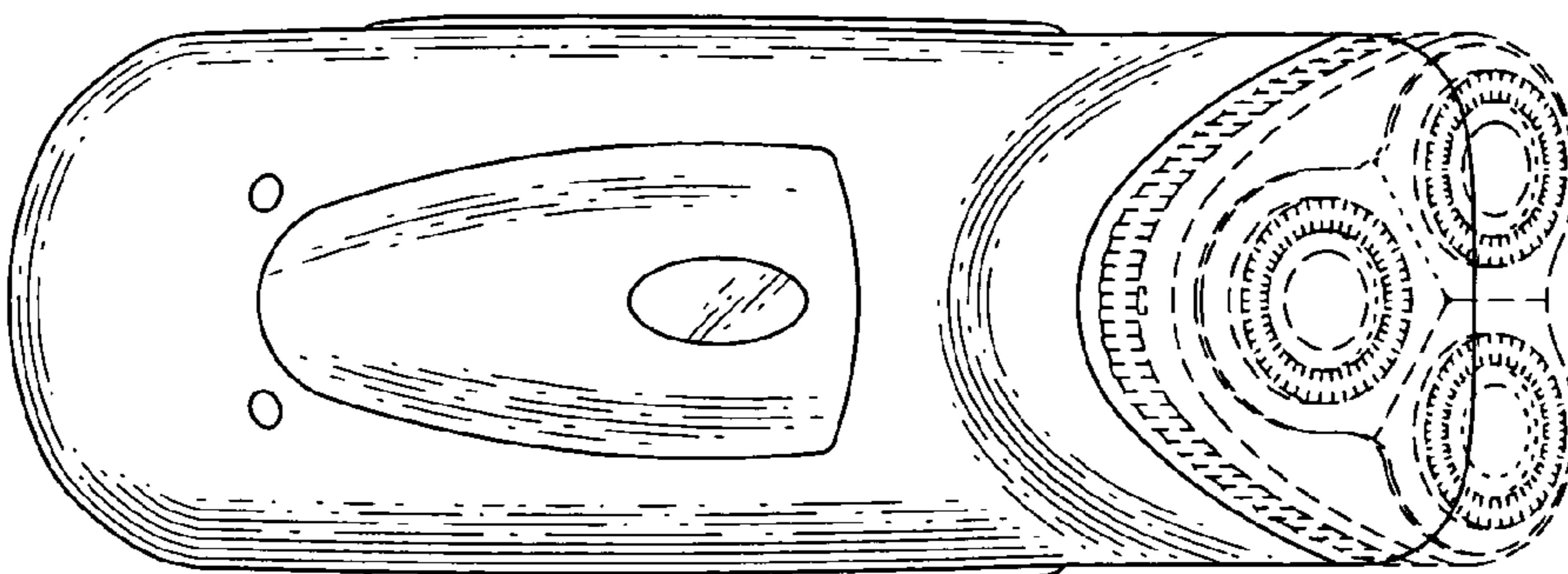

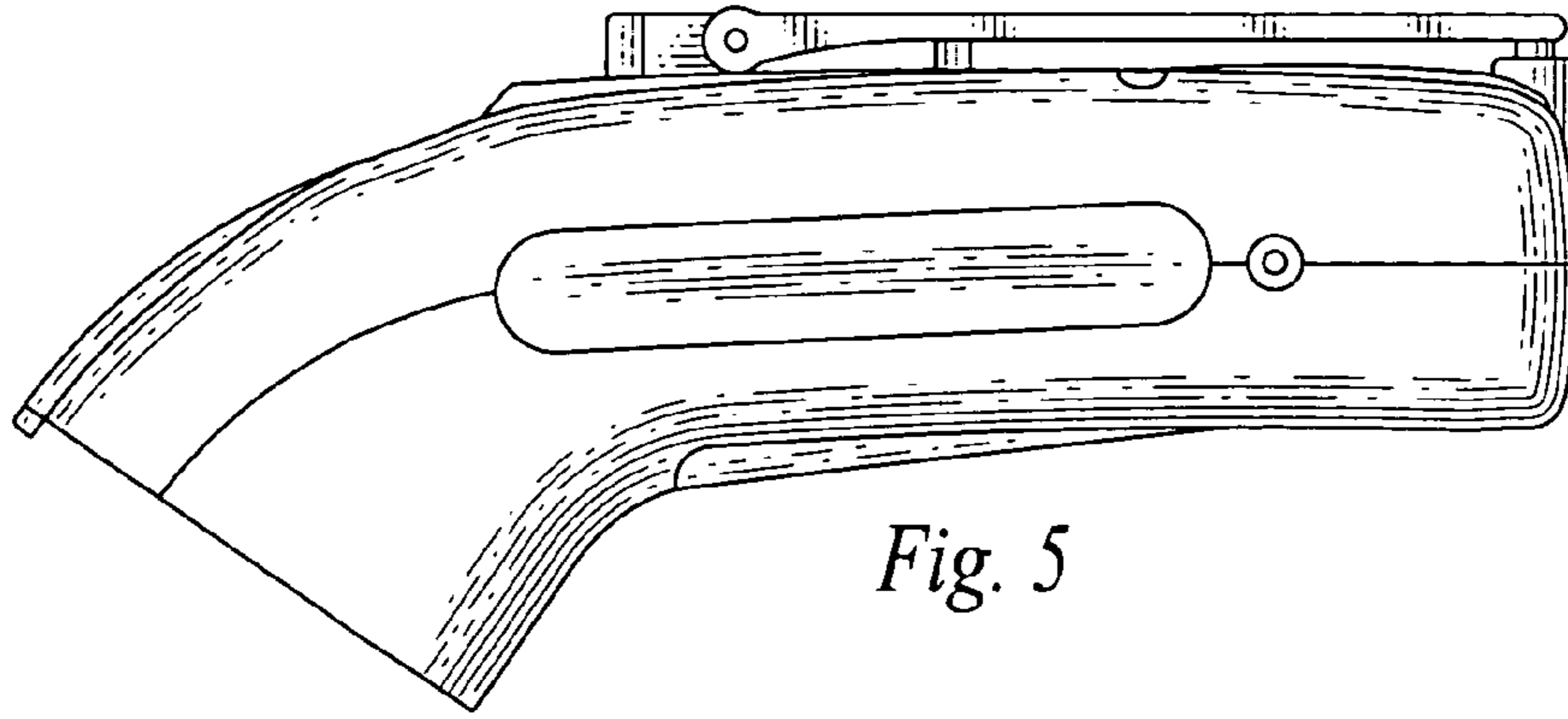

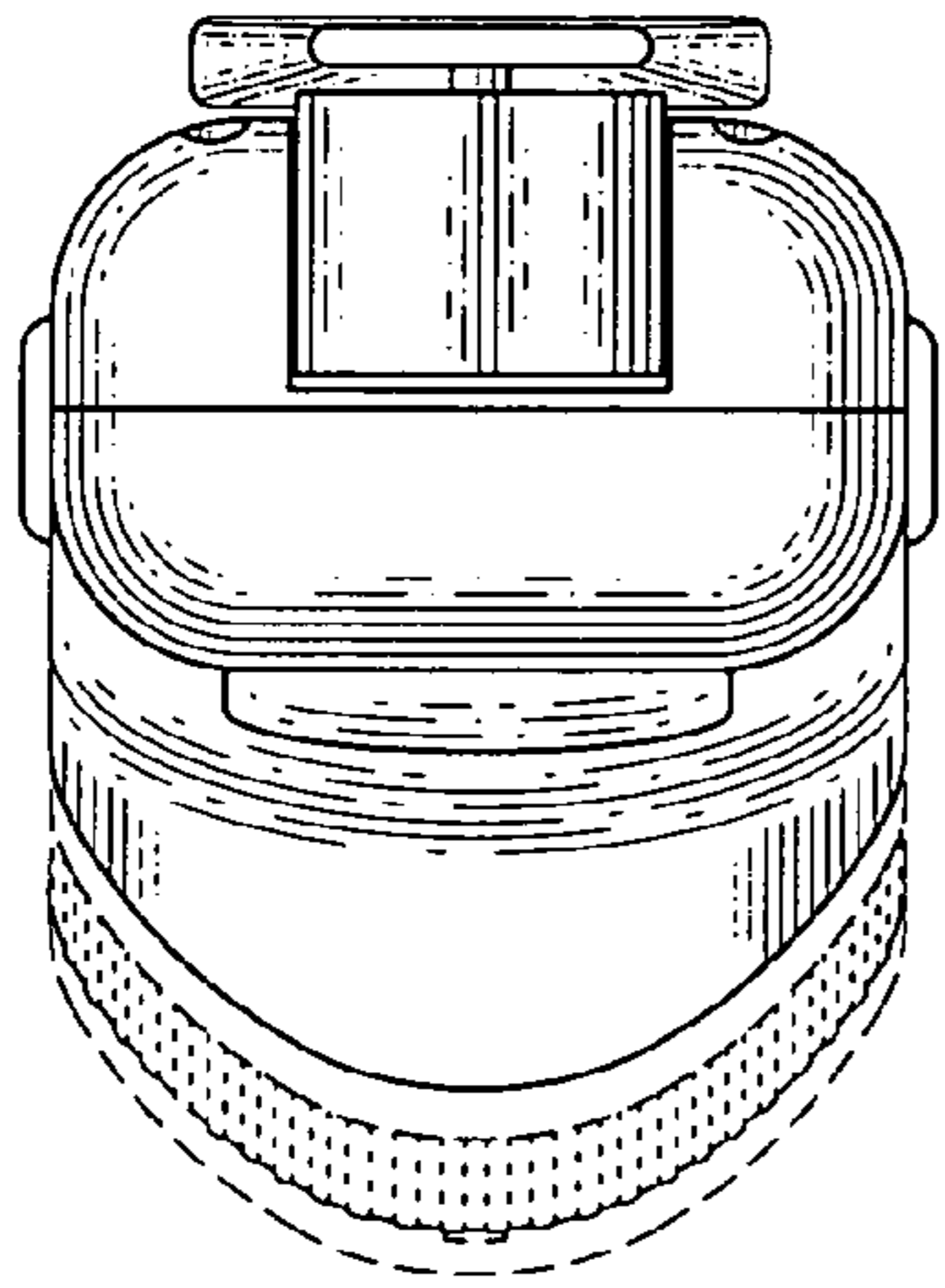

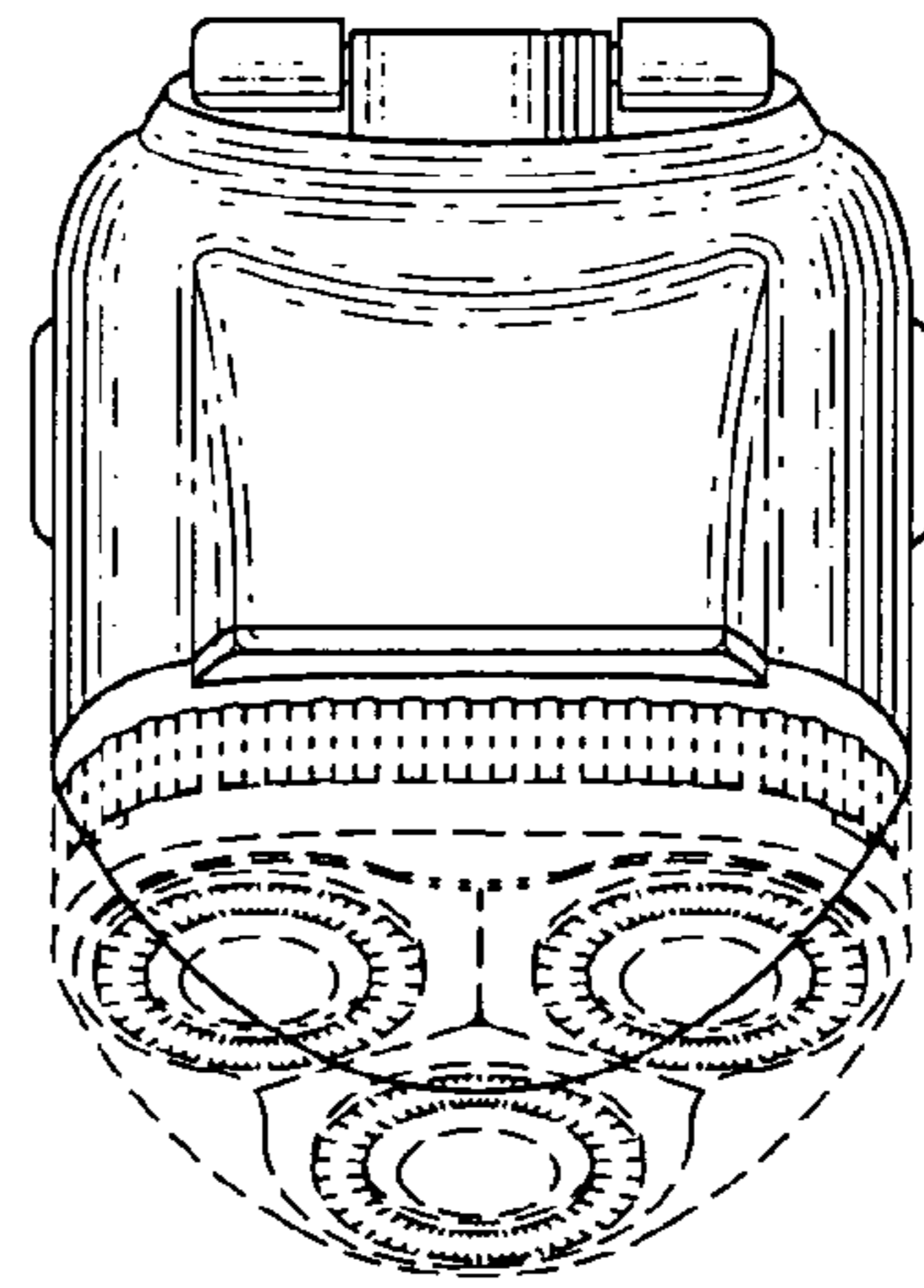

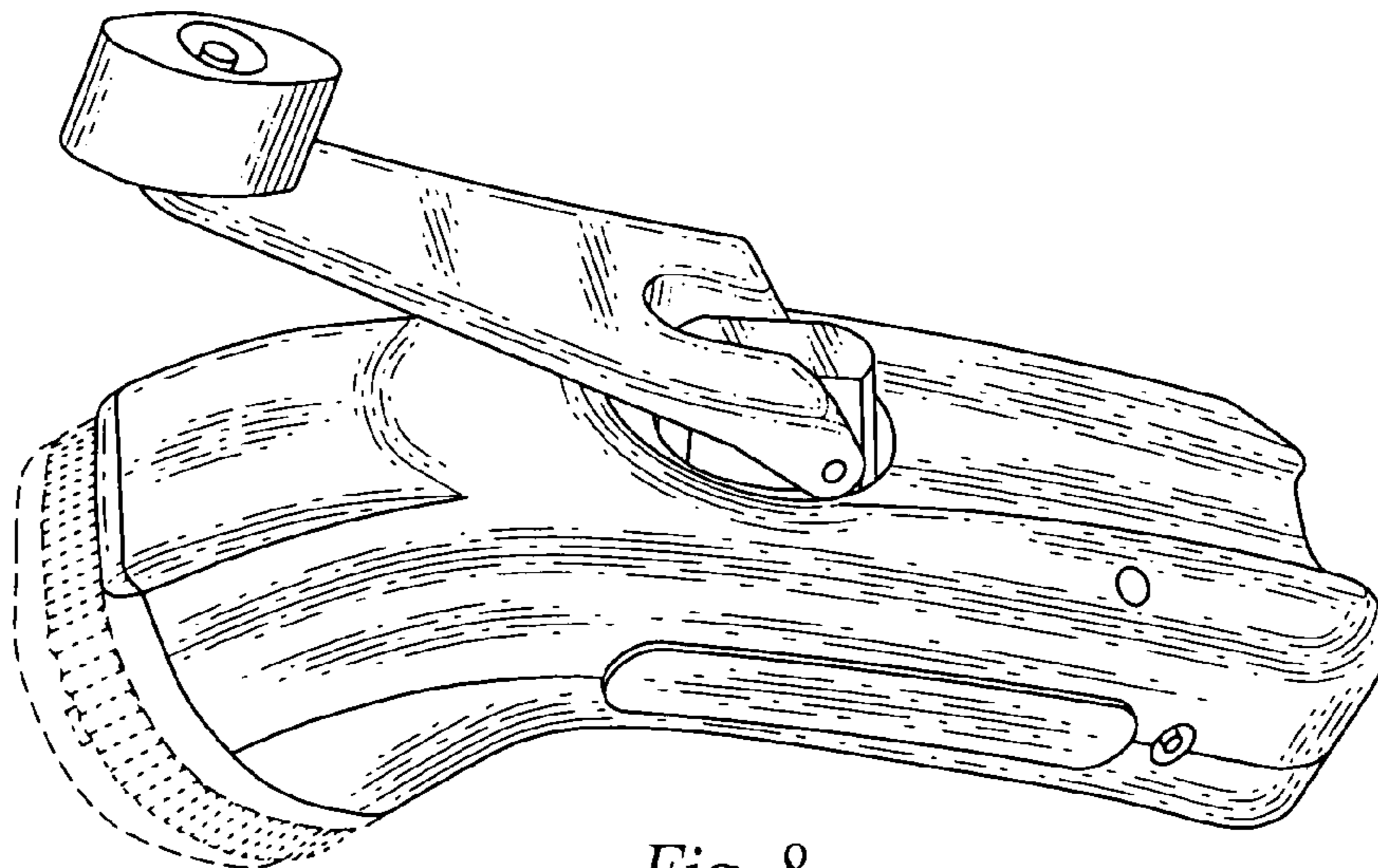
