**DESCRIPTION**

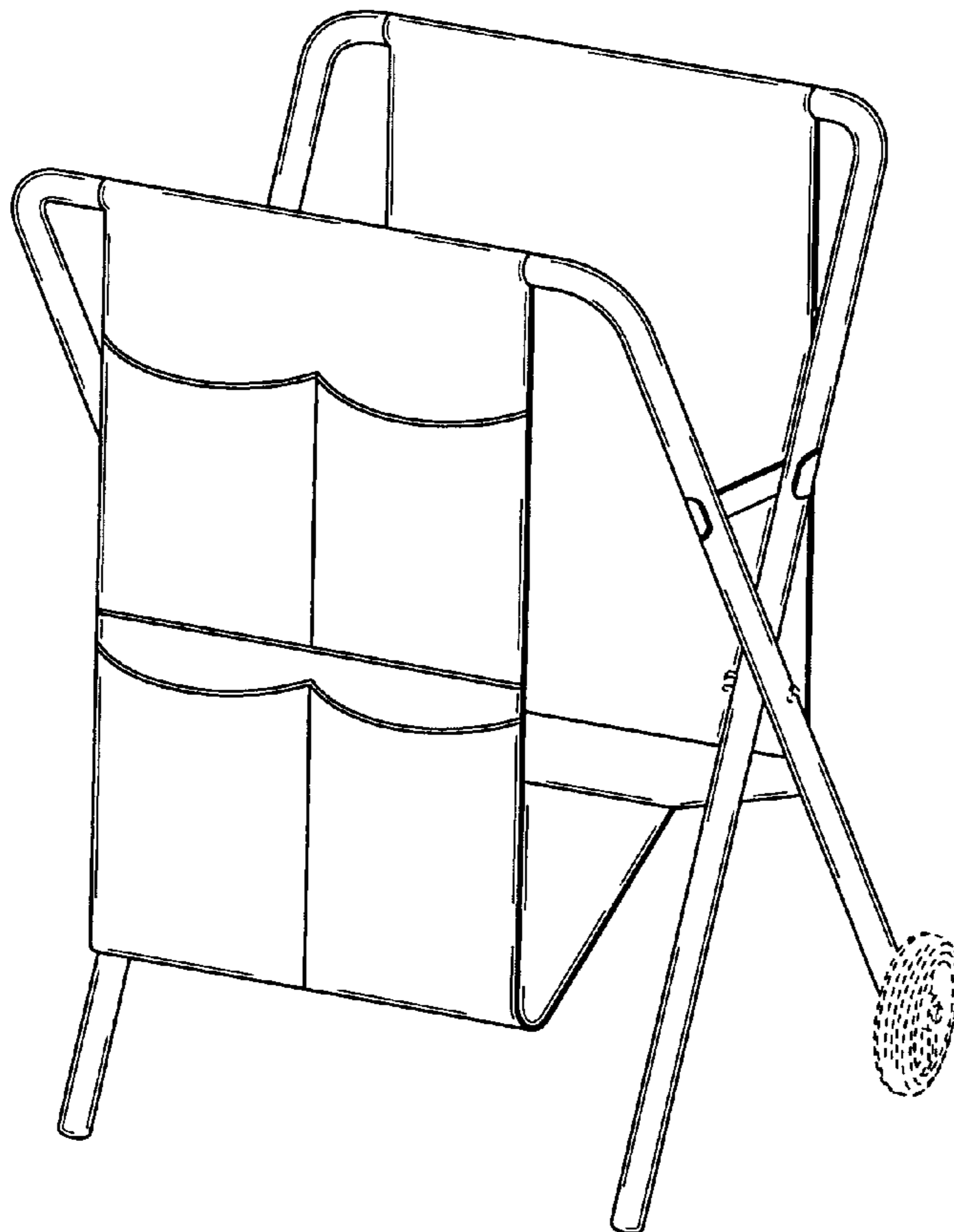
FIG. 1 is a front perspective view of a wheeled support for a refuse sack;

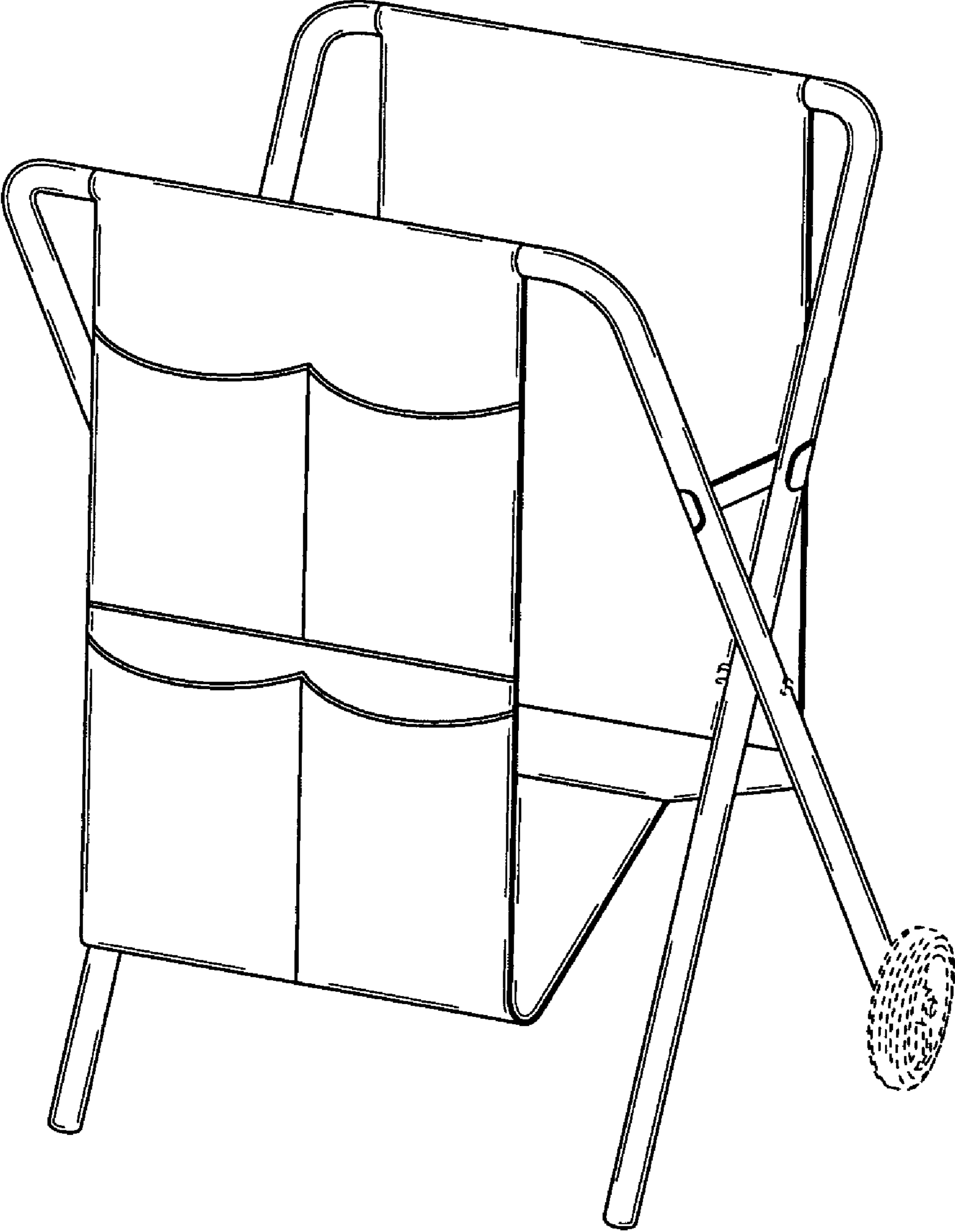
FIG. 2 is a rear perspective view thereof; and,

FIG. 3 is another front perspective view thereof.

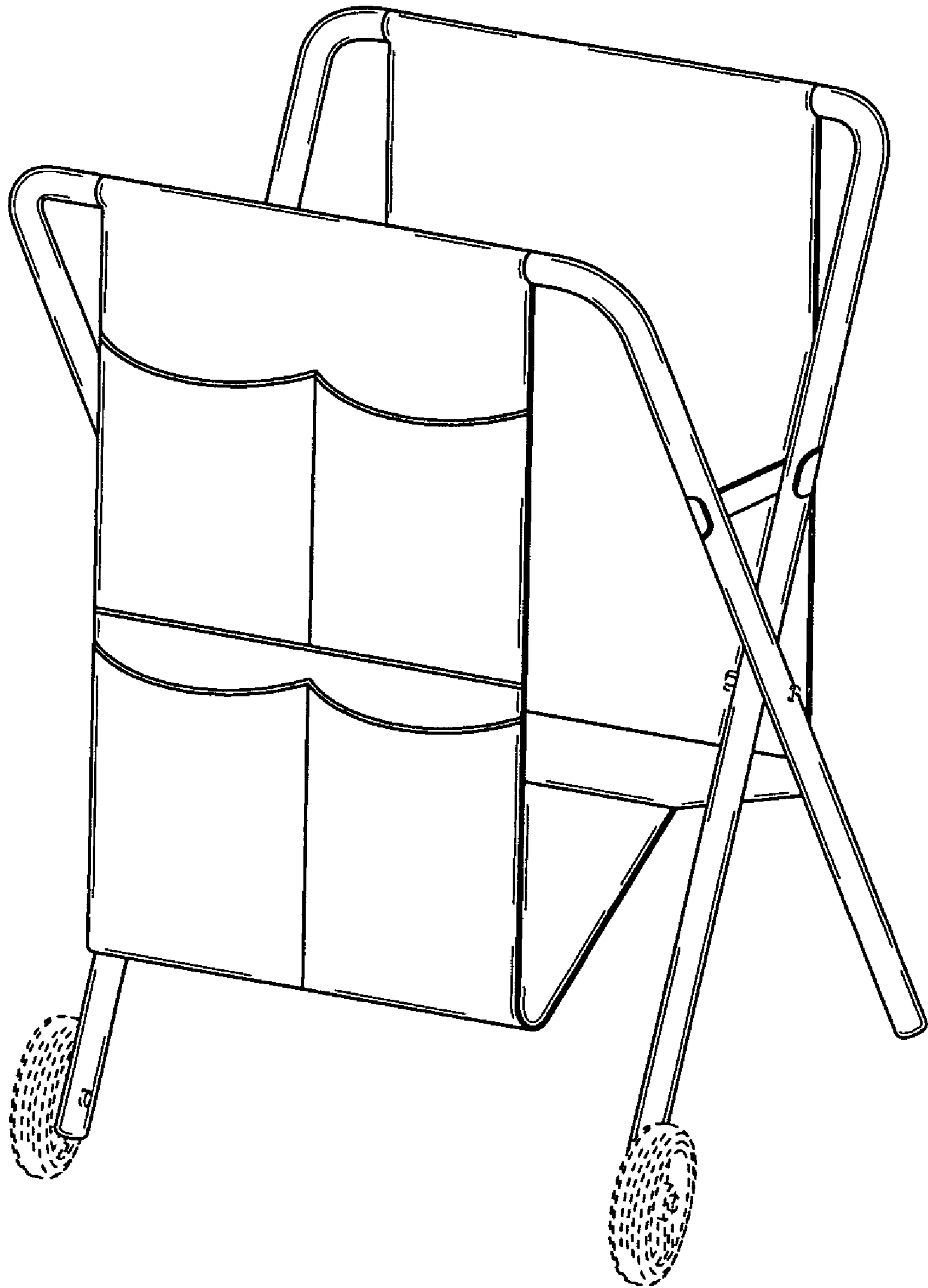
The broken line showing of the wheels and bolts is included for the purpose of illustrating environment and forms no part of the claimed design.

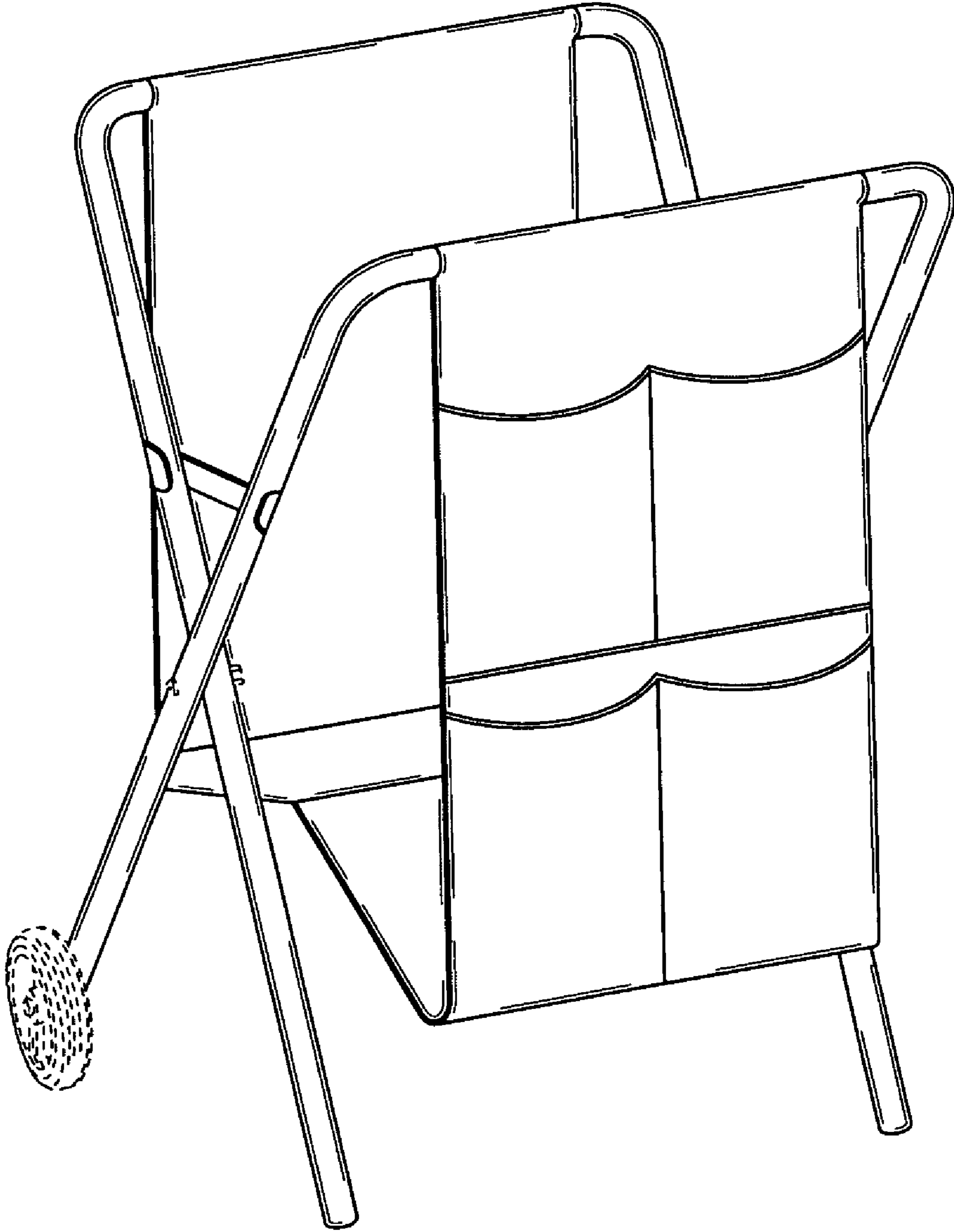
