The dashed lines shown directly on the surface of the claimed article, throughout the views, are understood to represent stitching.

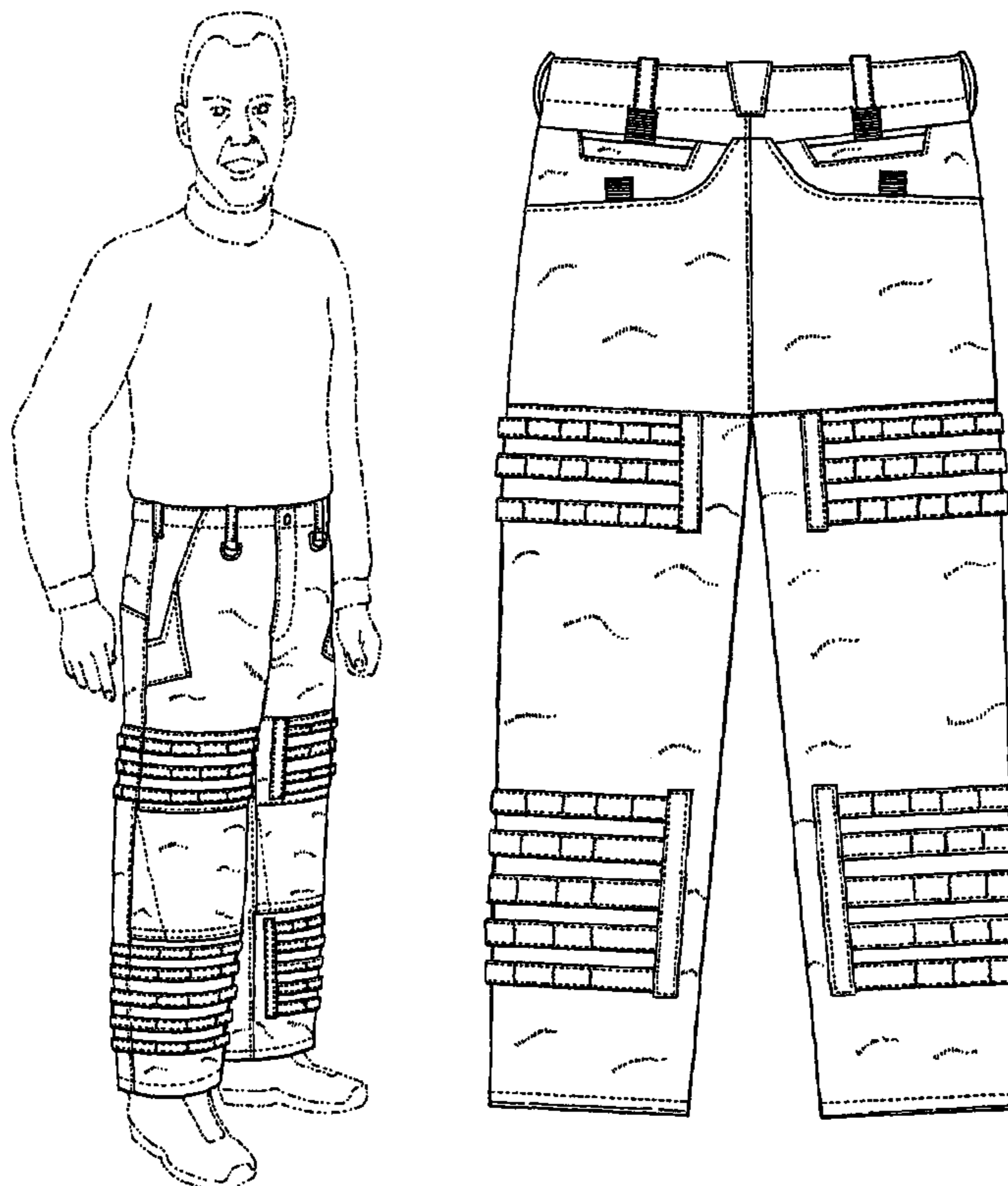
The broken lines showing a human figure wearing shoes of FIG. 1 are for environmental purposes only and form no part of the claimed design.

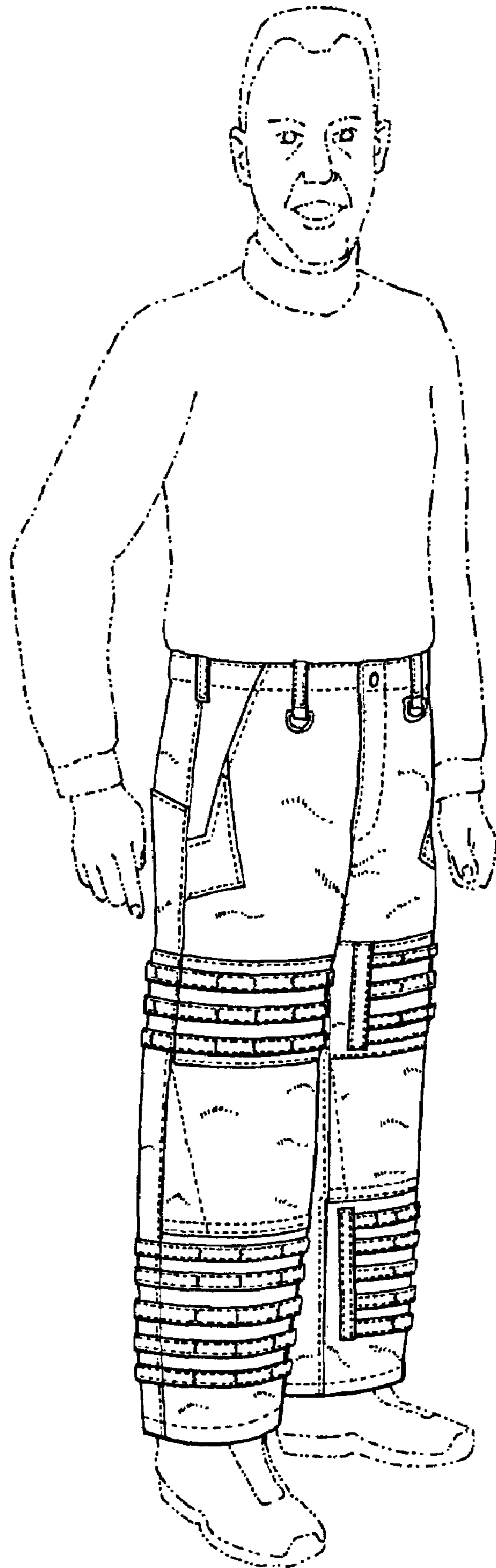

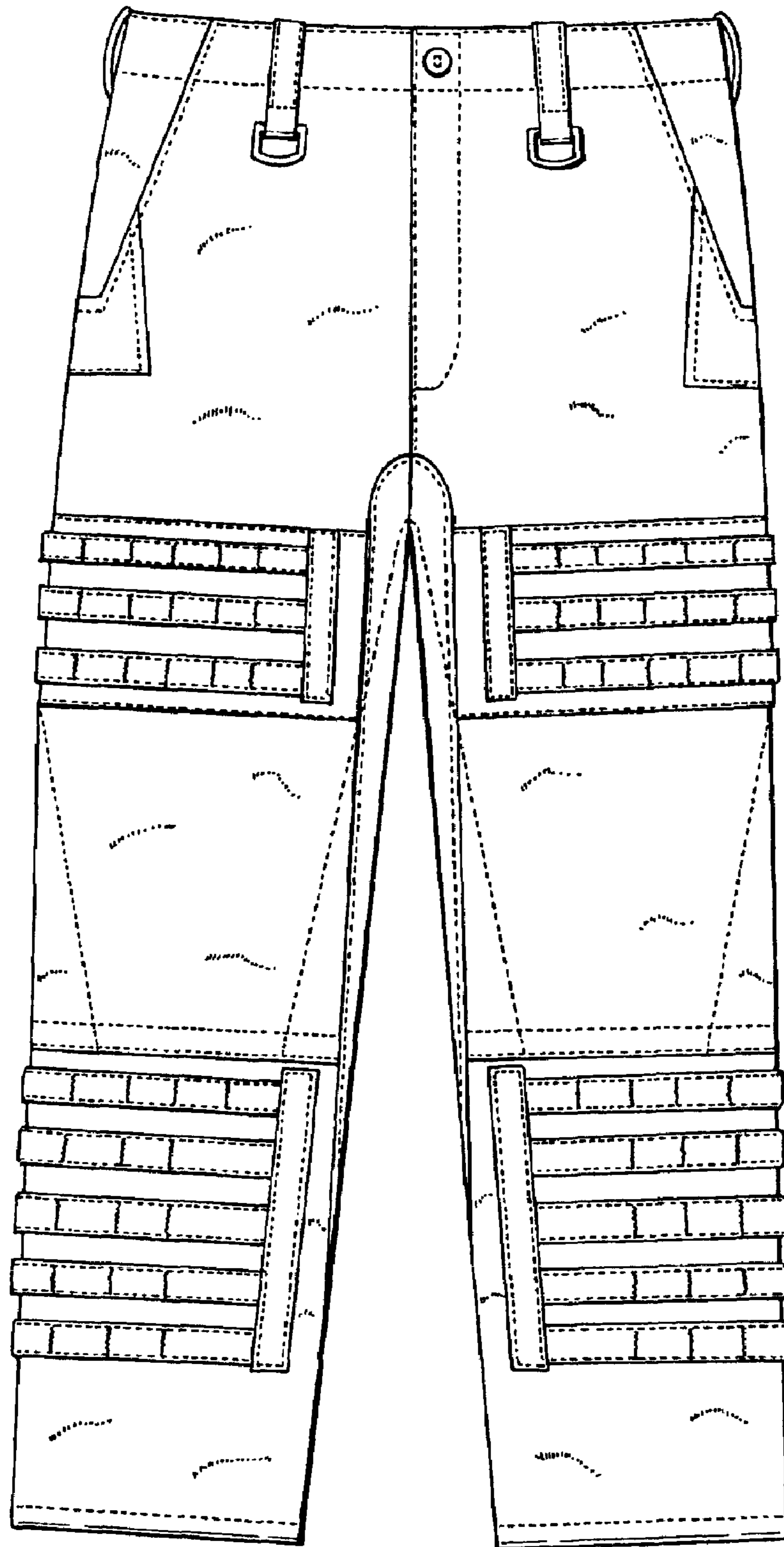

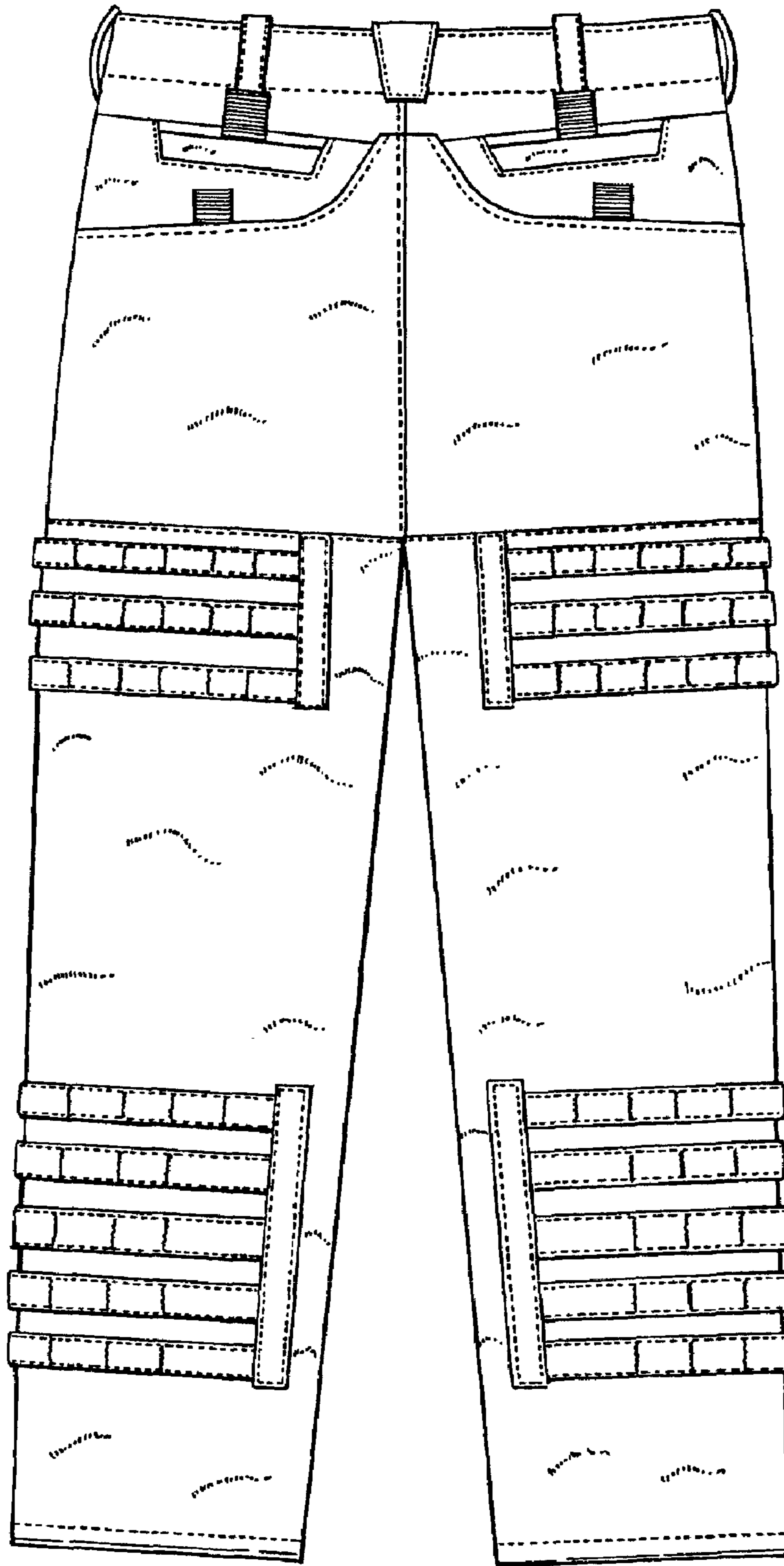

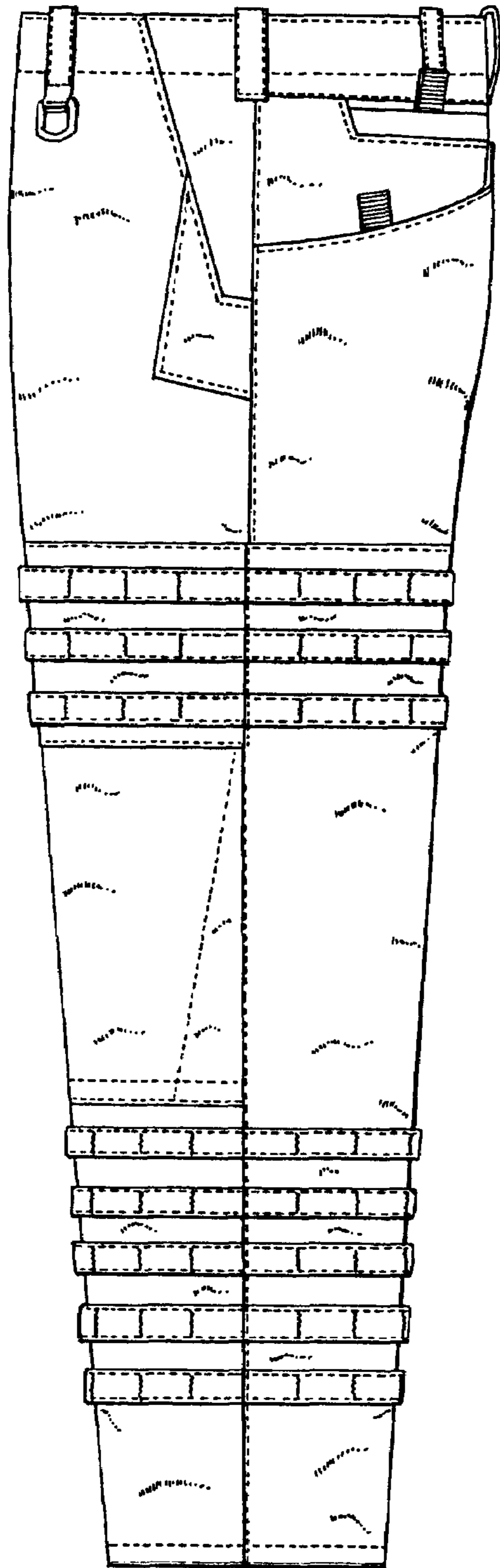

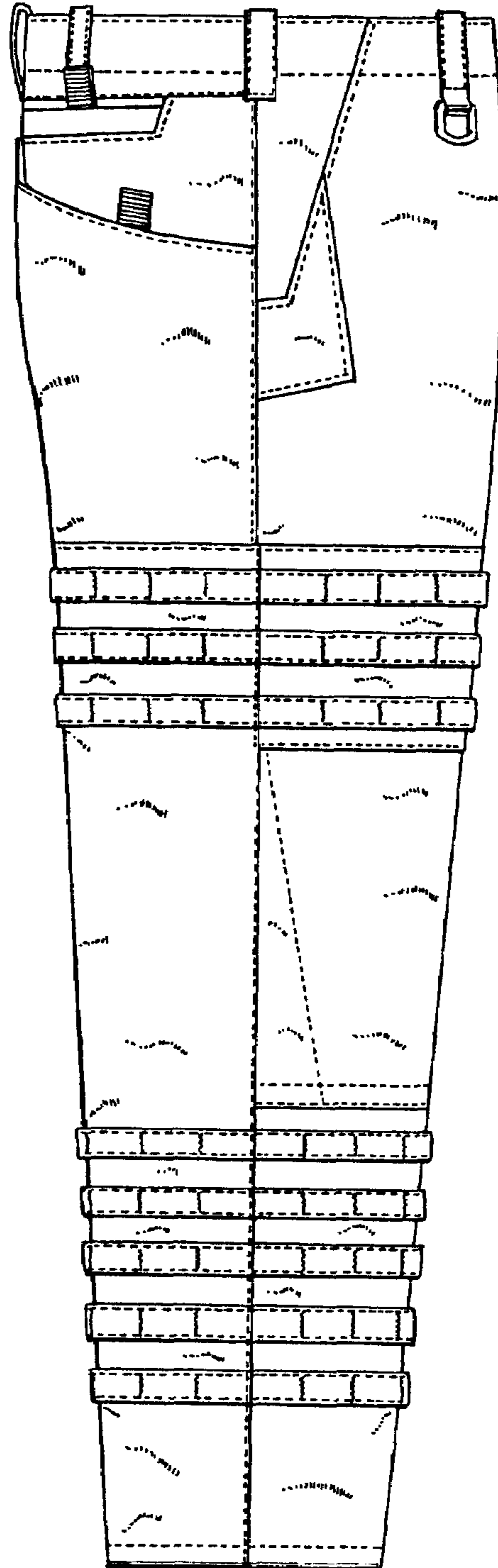

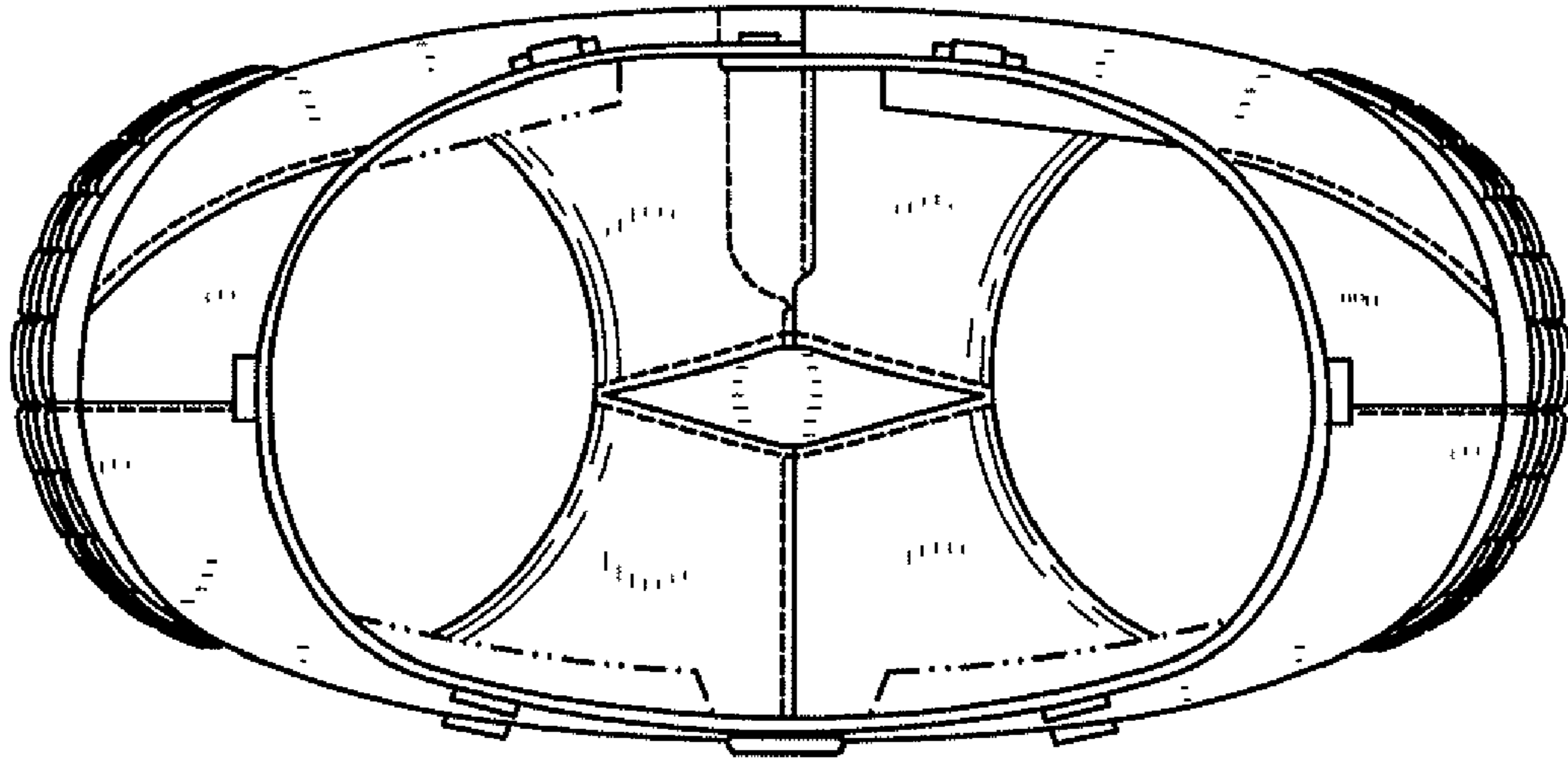

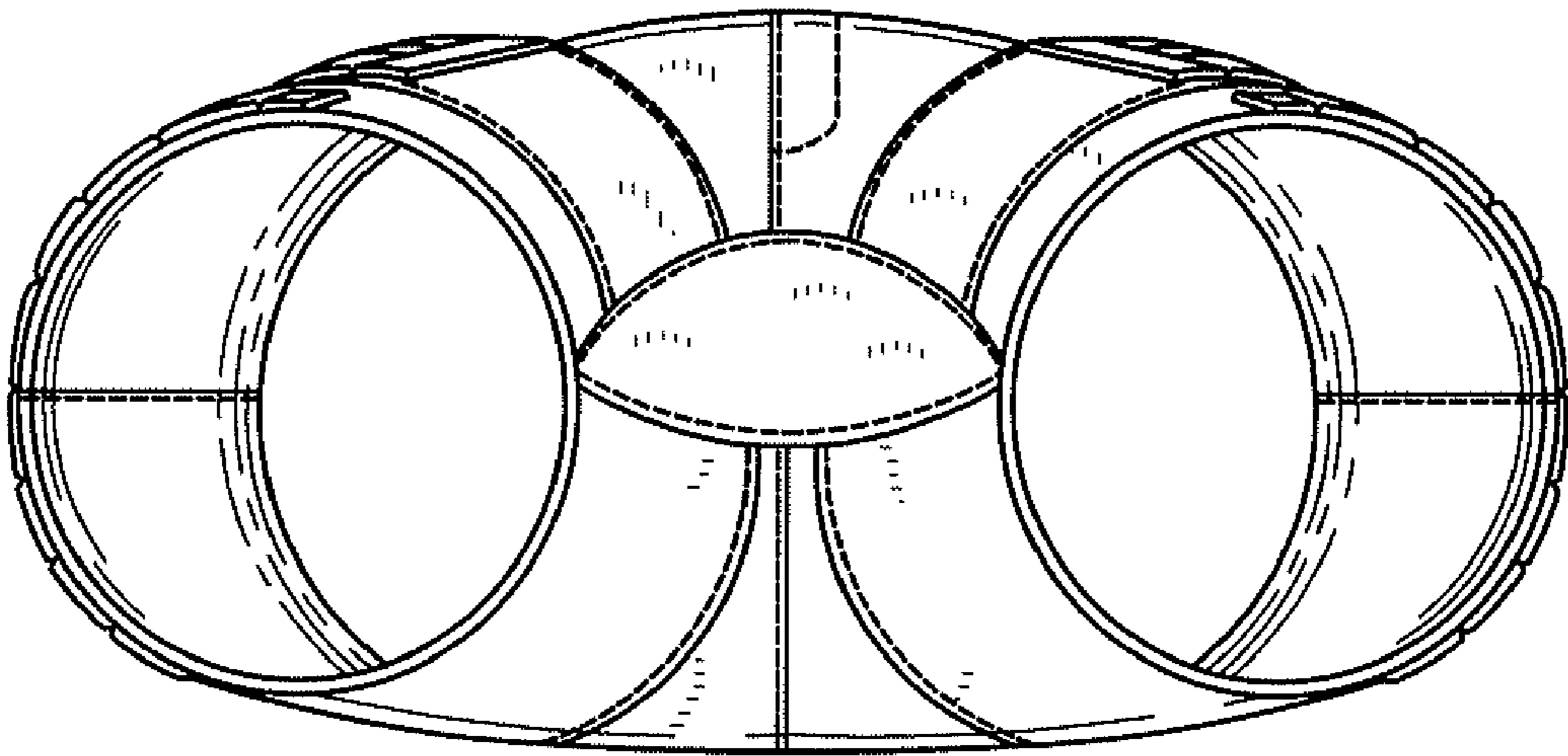
