(57) **CLAIM**

The ornamental design for a storage unit with a TV lift mechanism, as shown and described.

DESCRIPTION

This case is related to U.S. Pat. Ser. Nos. D470,333 and D464,500 and co-pending U.S. Pat. Application Ser. No. 29/265,486.

FIG. 1 is a front/left/top isometric view of a storage unit with a TV lift mechanism showing my new design;

FIG. 2 is a left side elevational view thereof; the right side elevational view being a mirror image thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

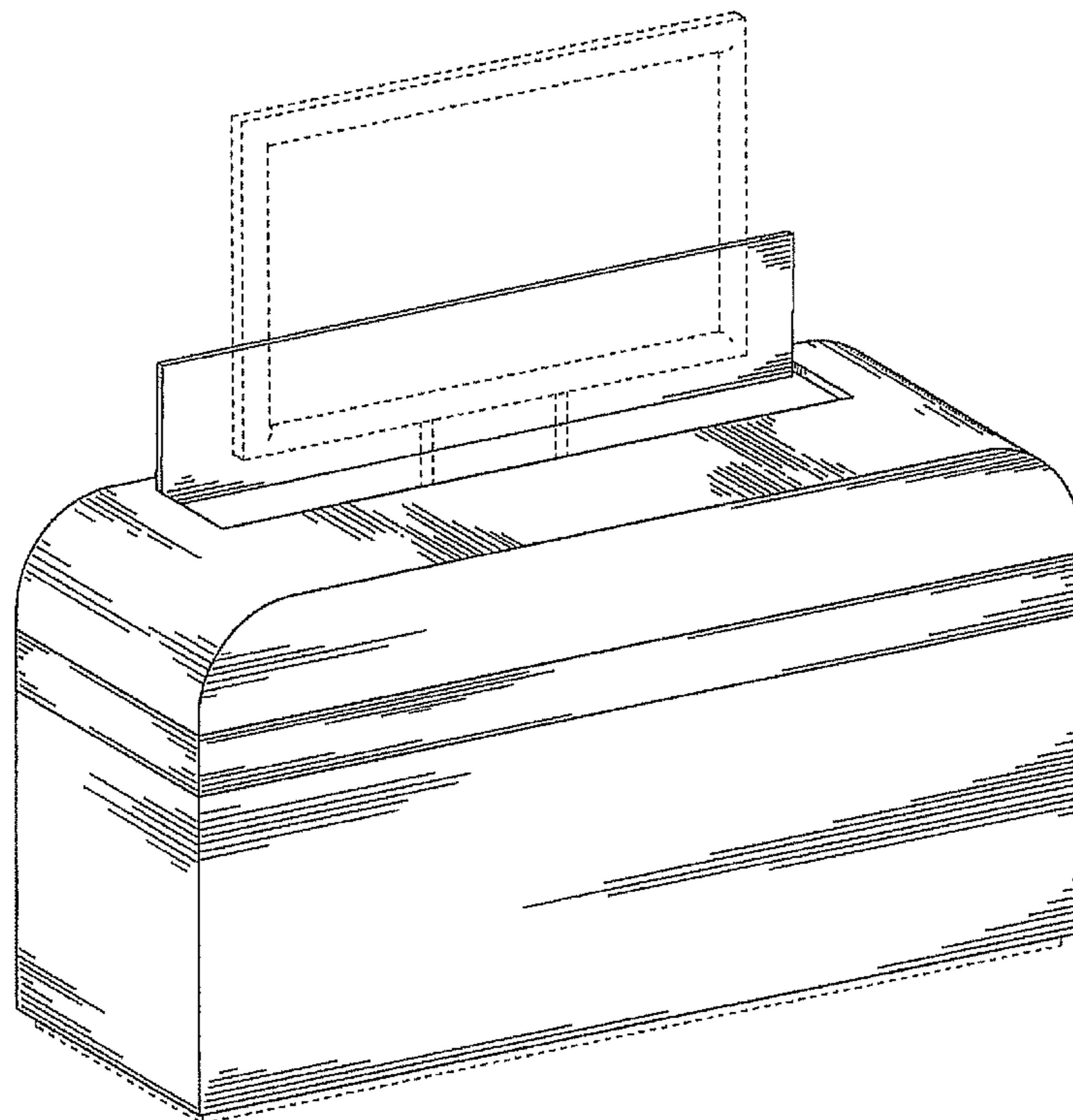
FIG. 5 is a top plan view thereof;

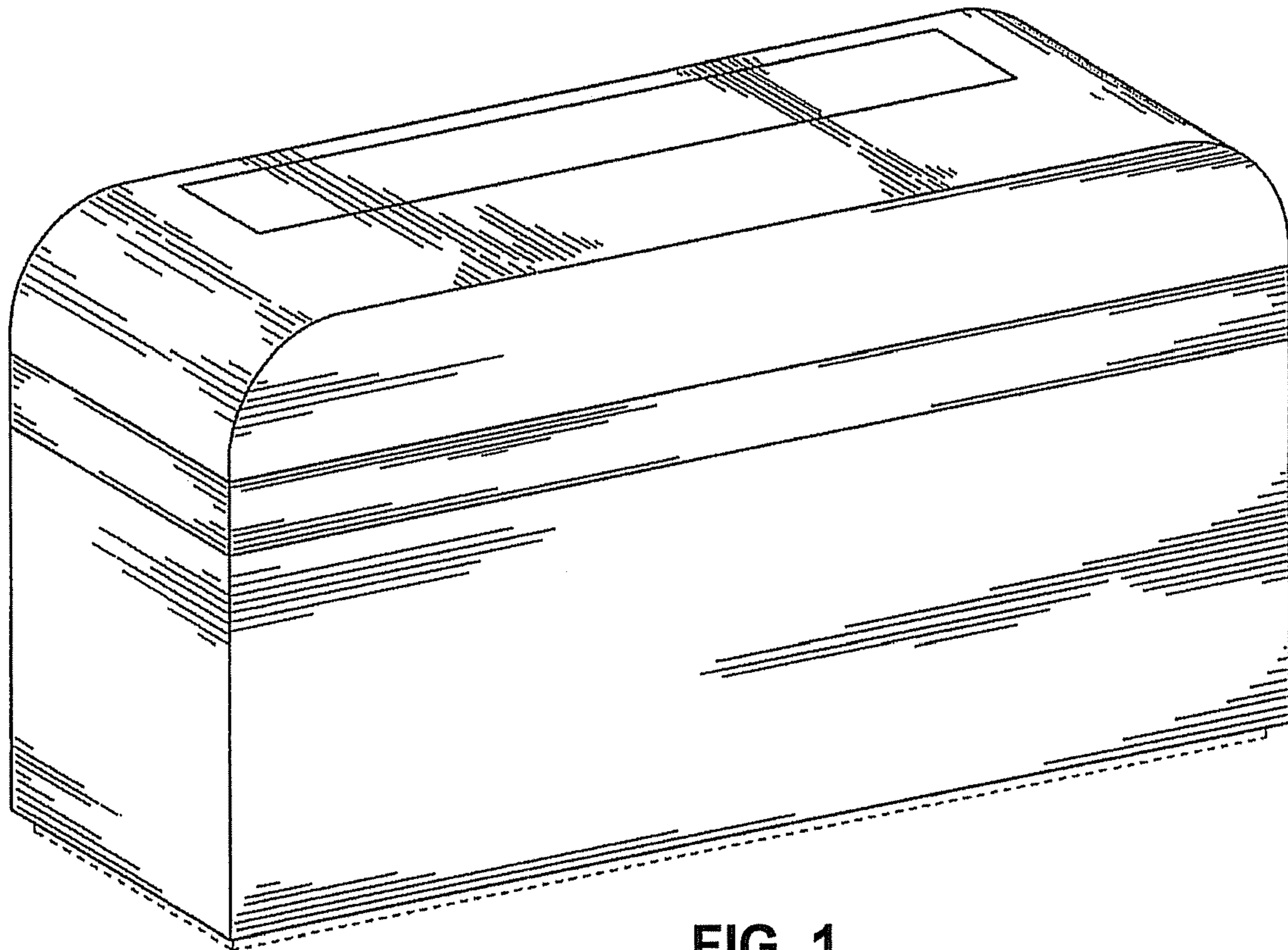

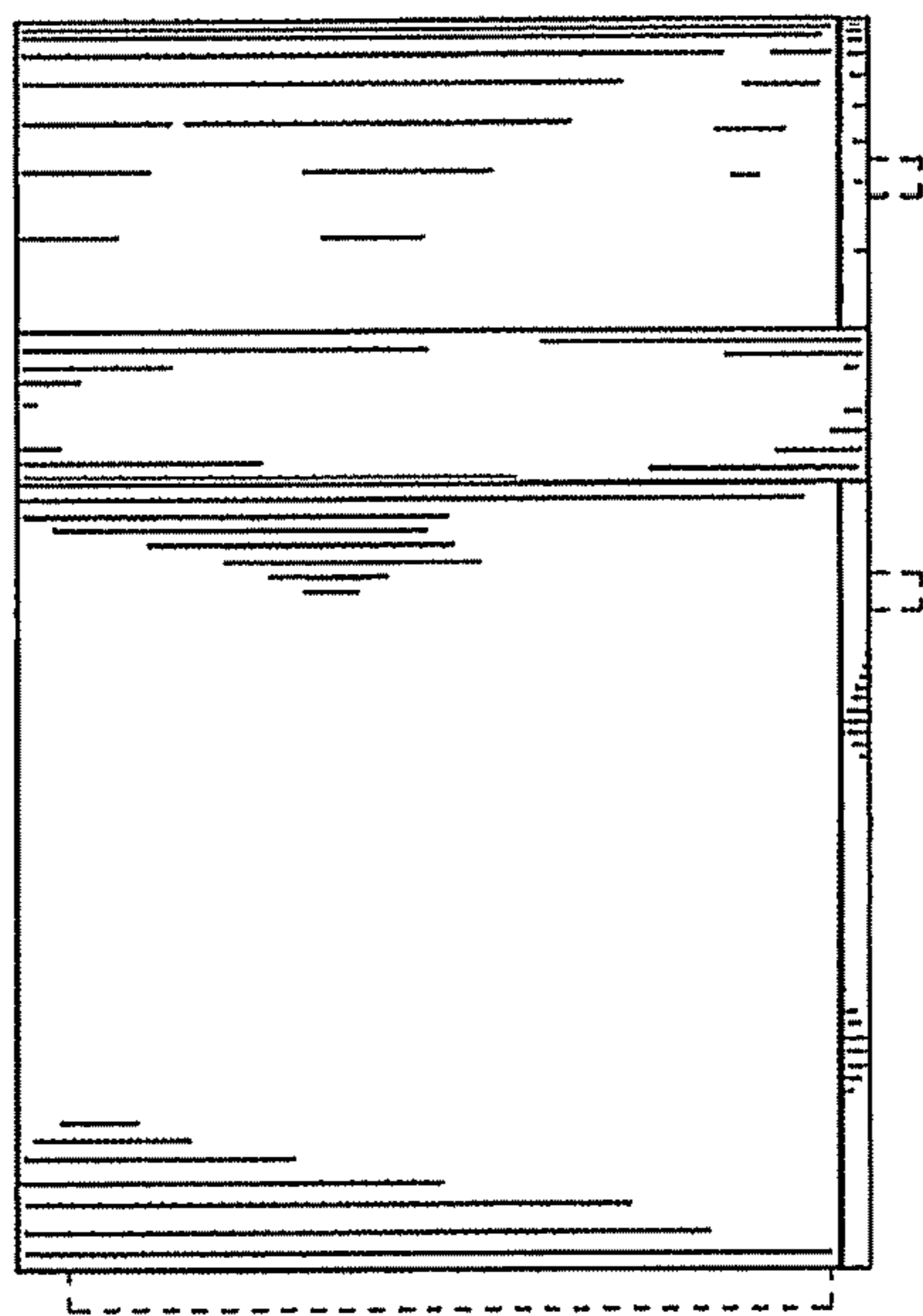

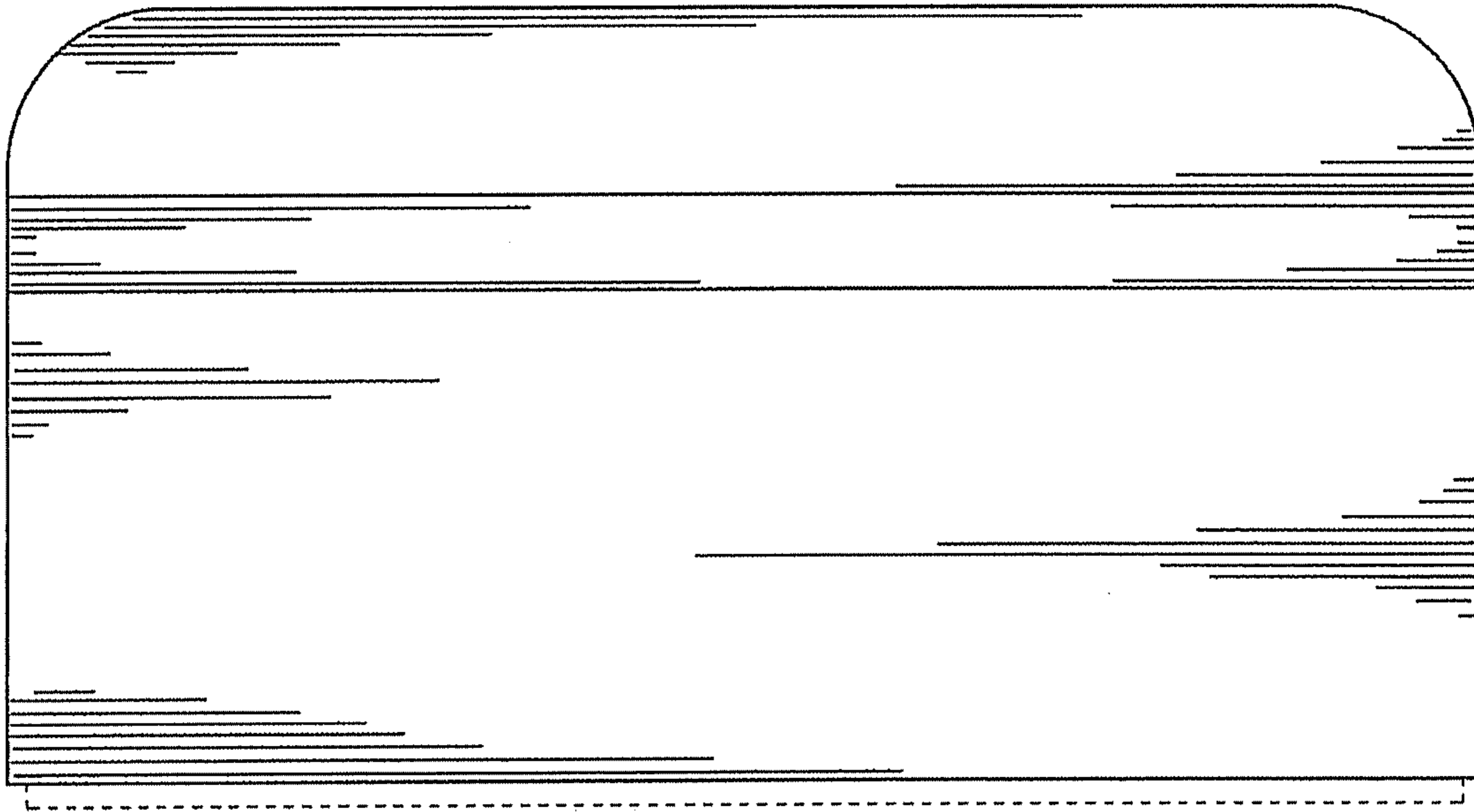

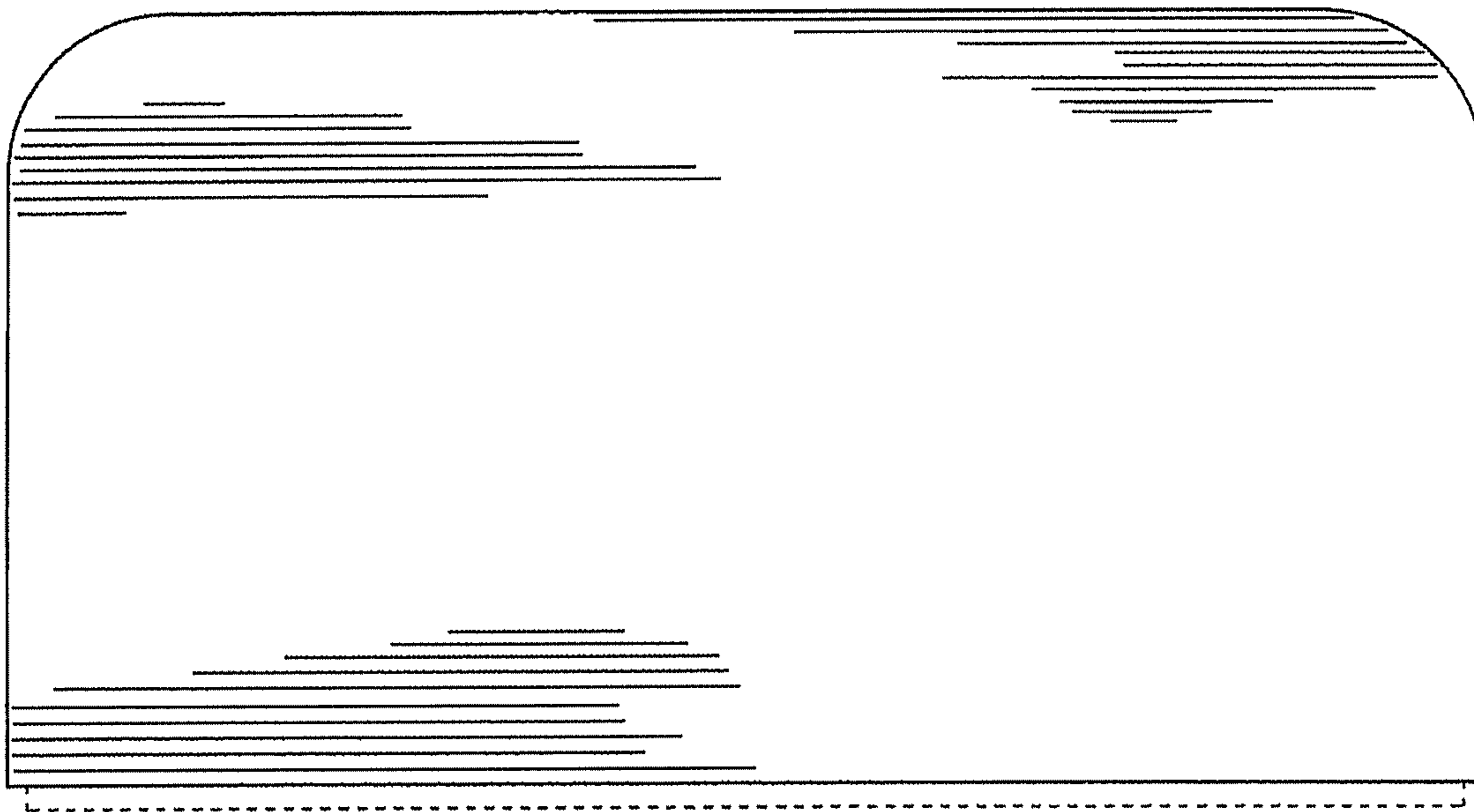

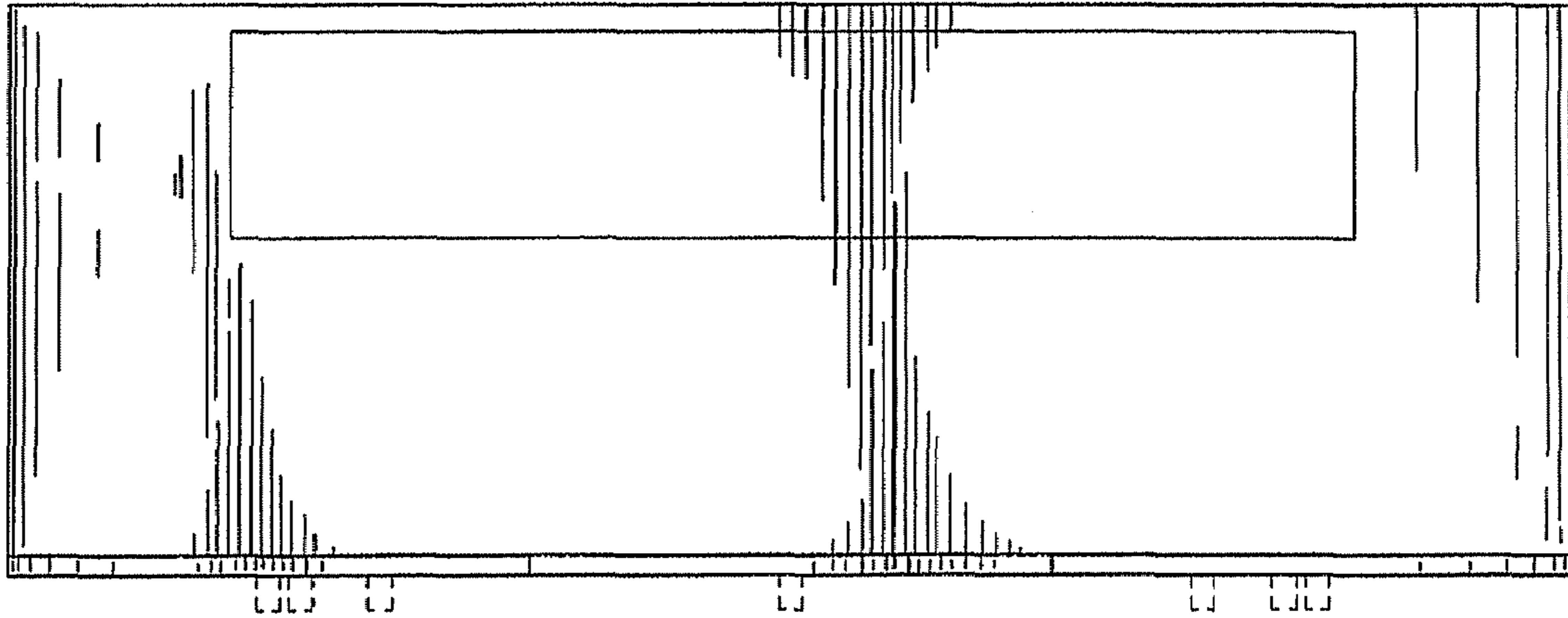

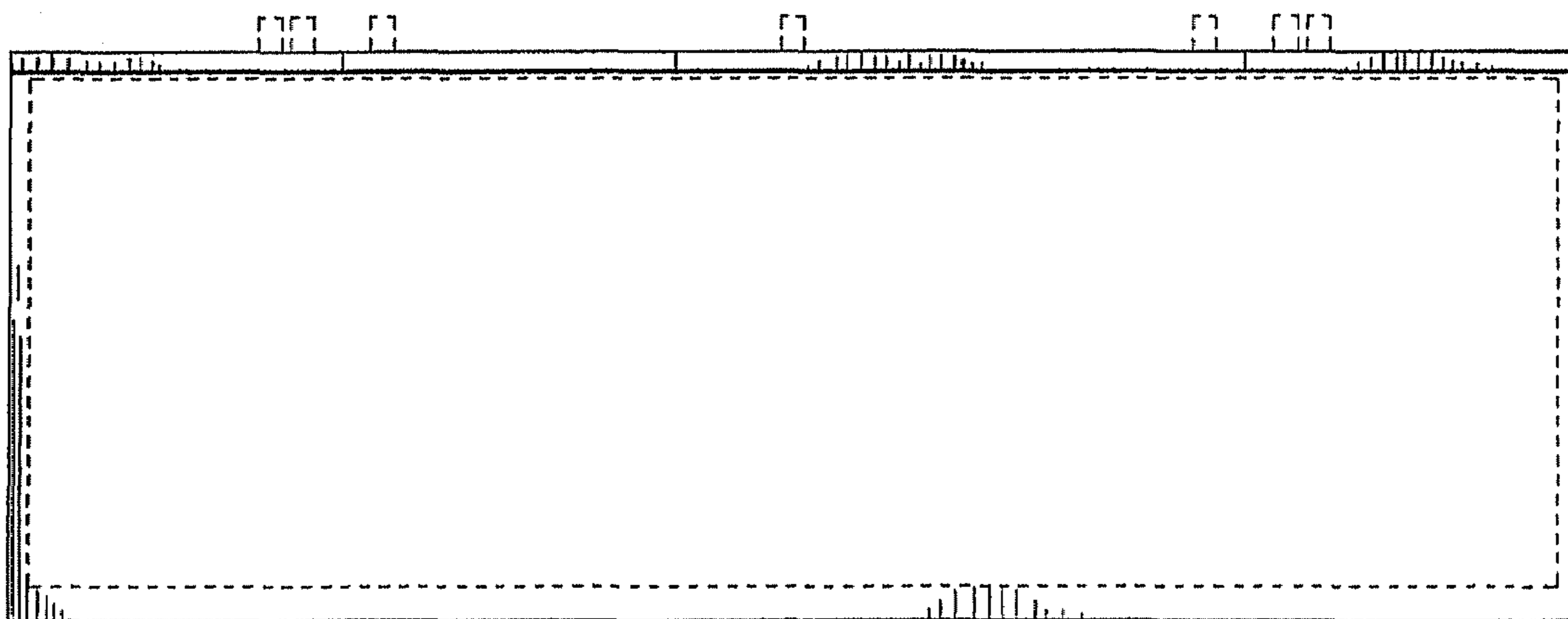

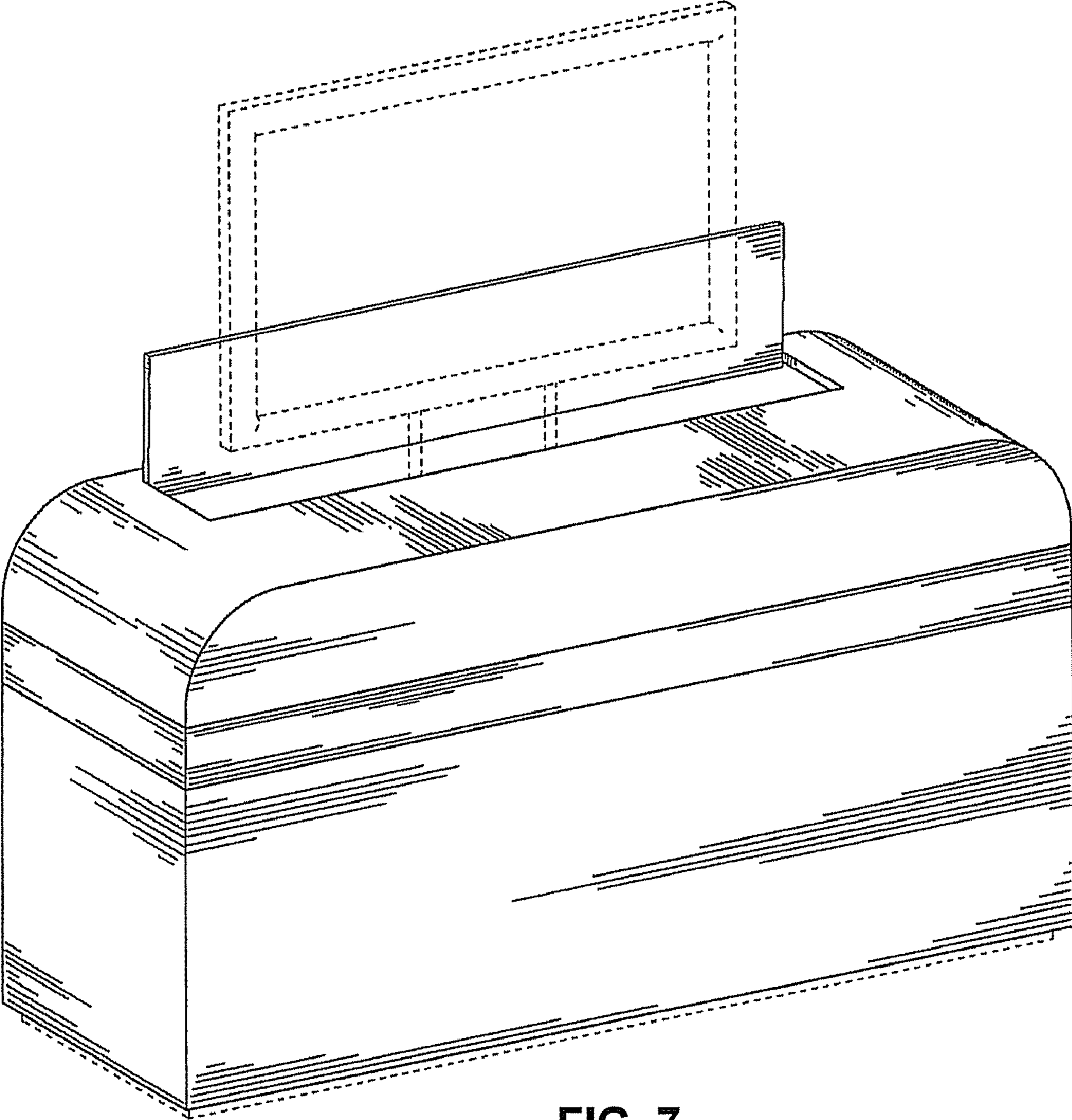
