FIG. 4 is a left side view of the soap dispenser/bottle;

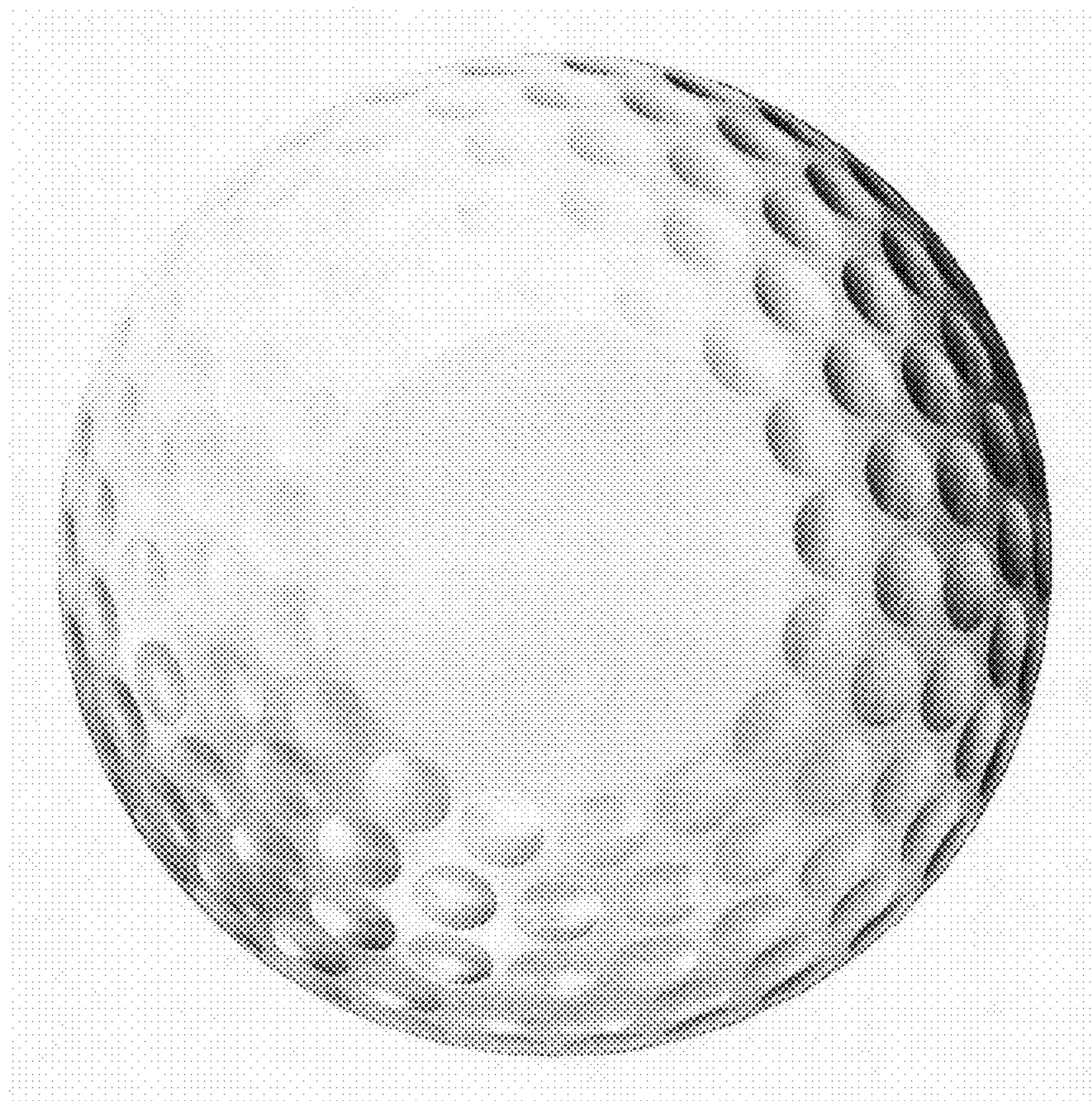
FIG. 5 is a bottom perspective view of the soap dispenser/bottle;

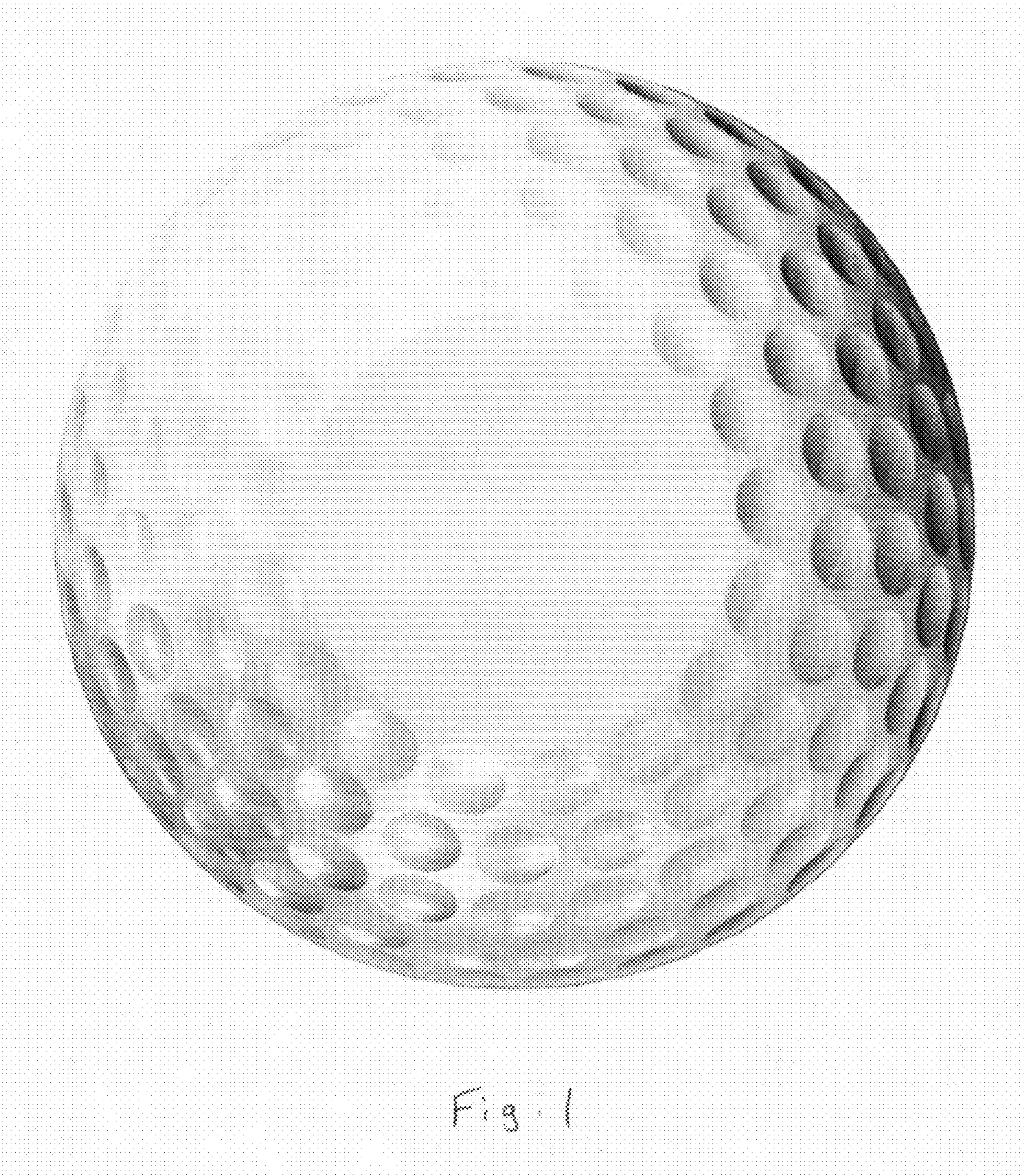

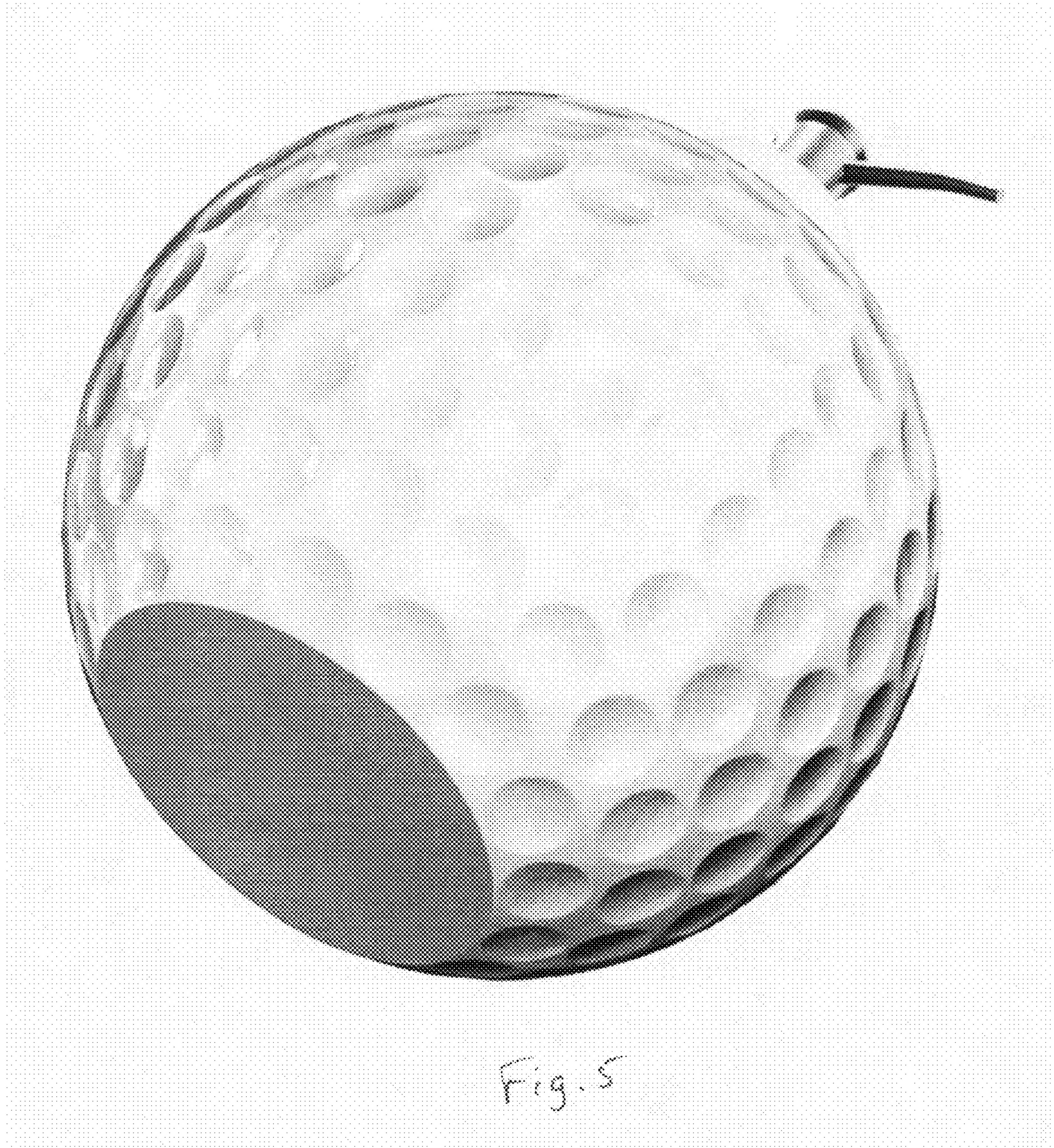

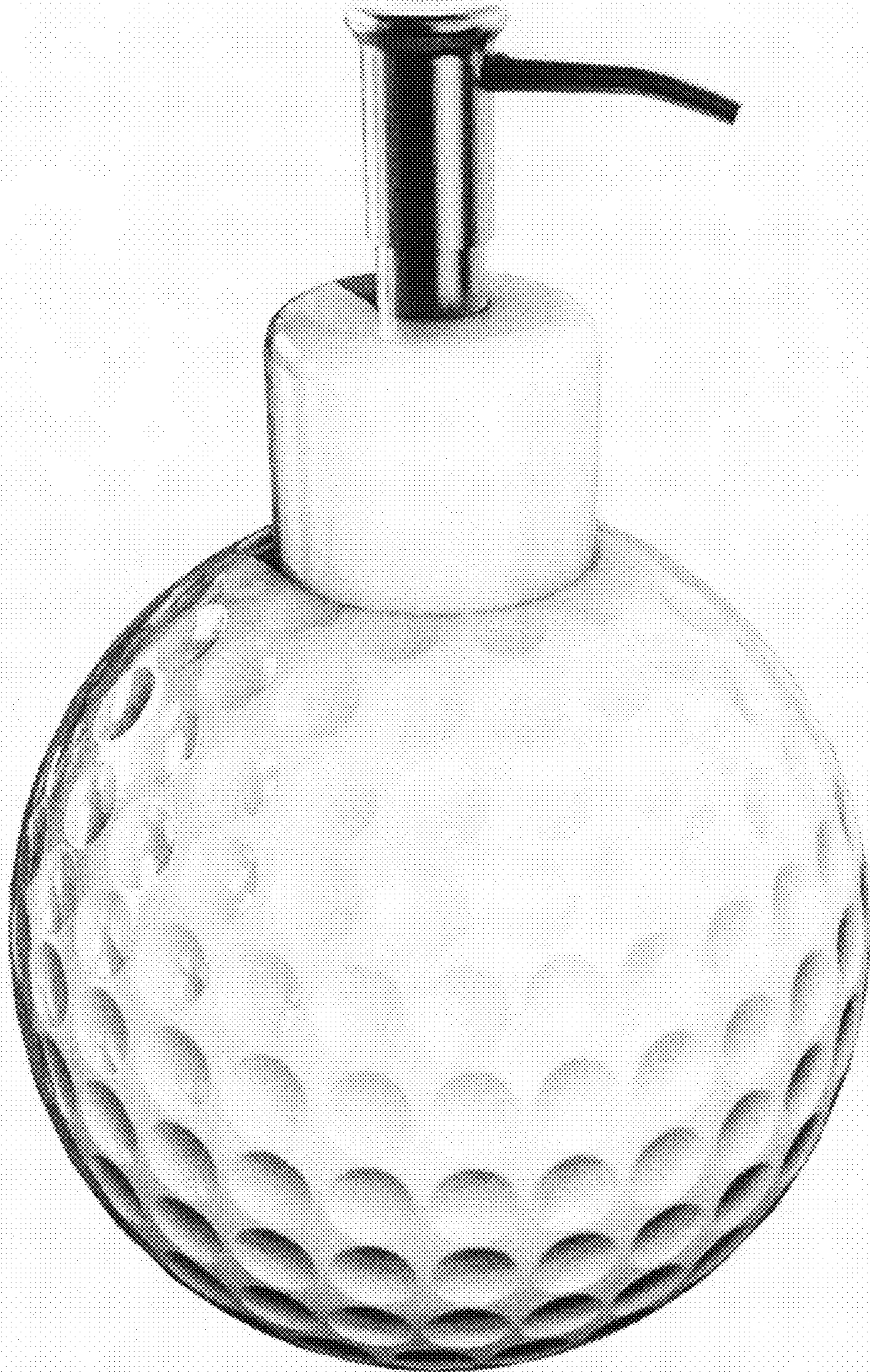

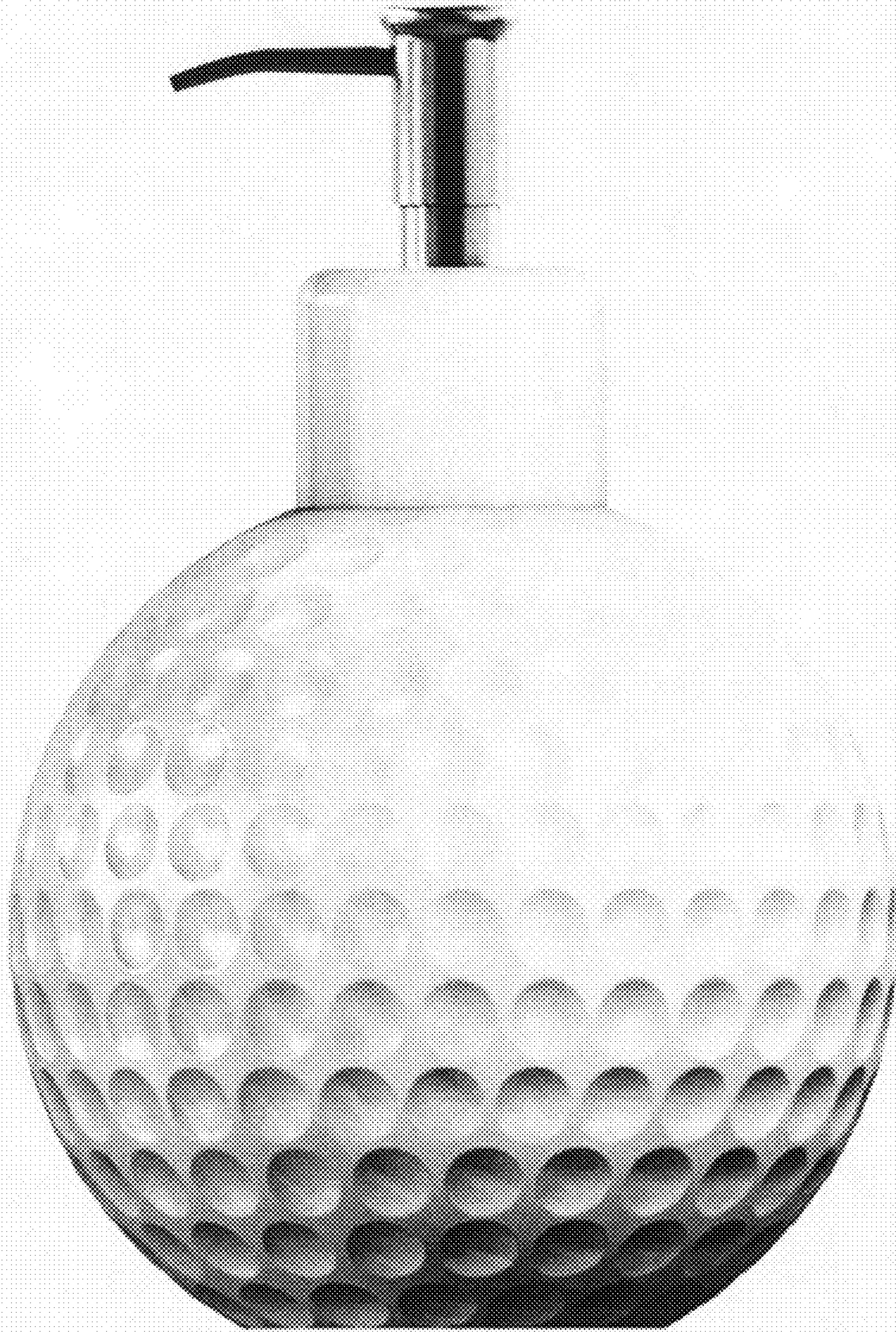
